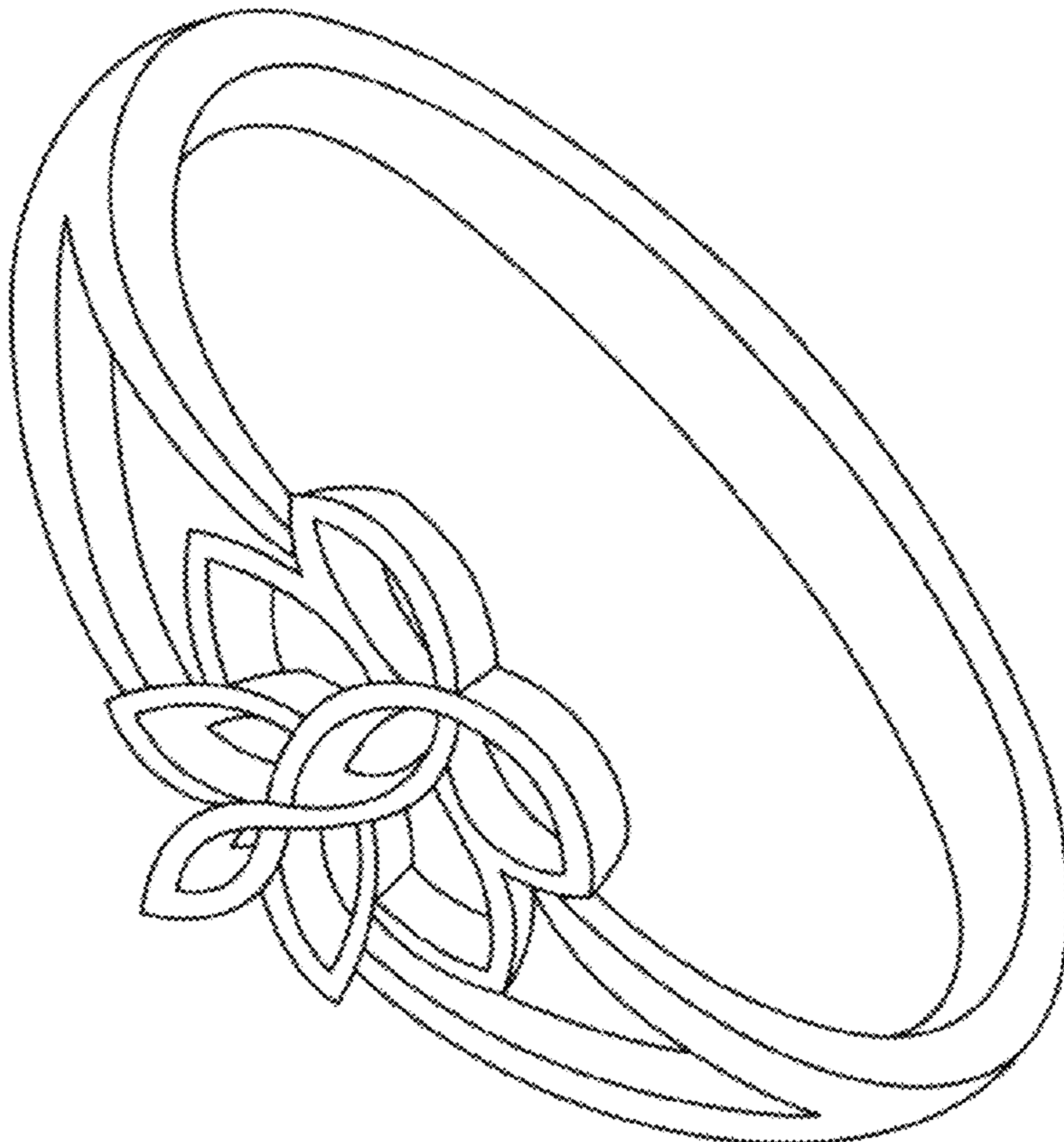
The ornamental design for a finger ring, as shown and described.

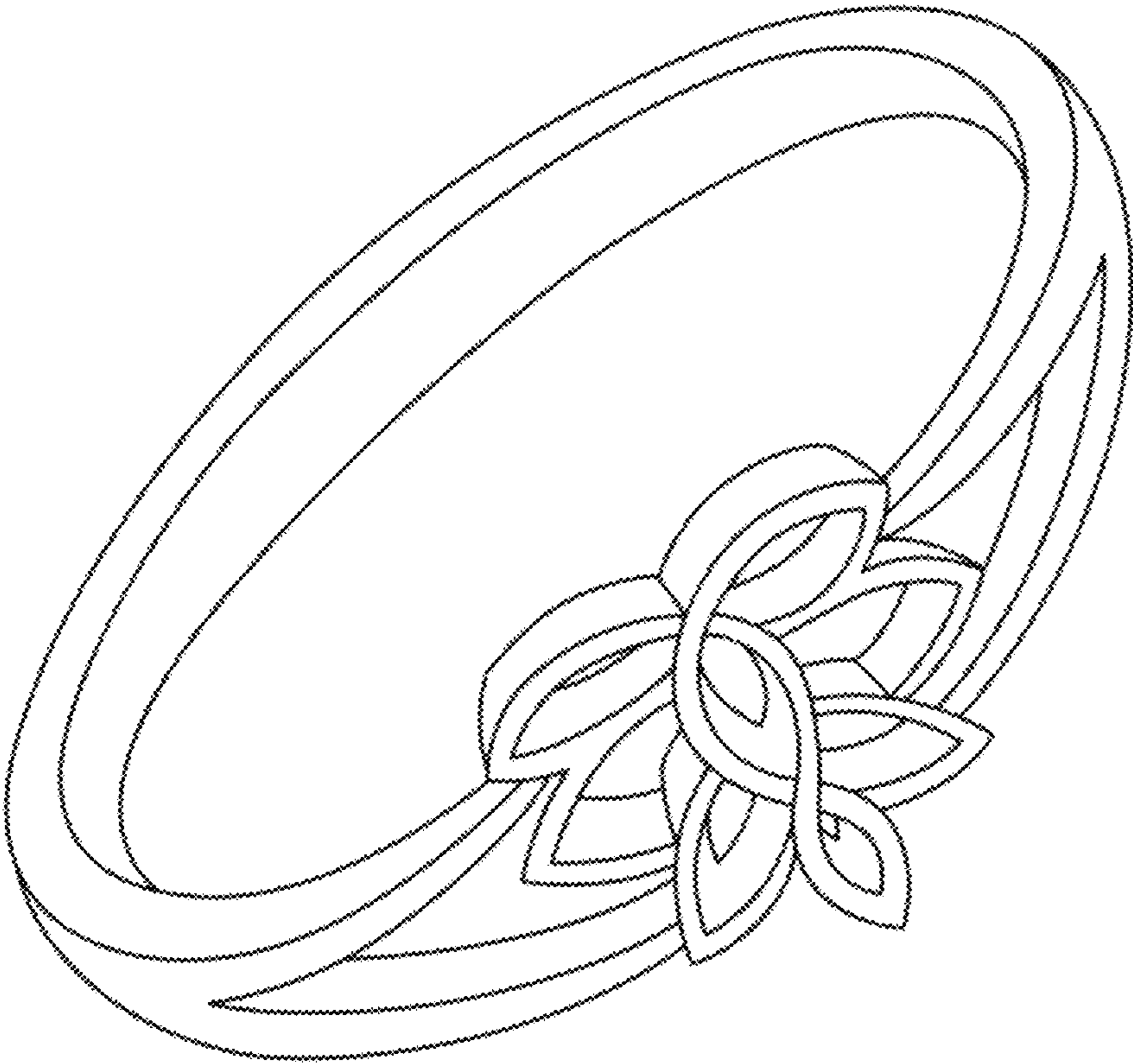

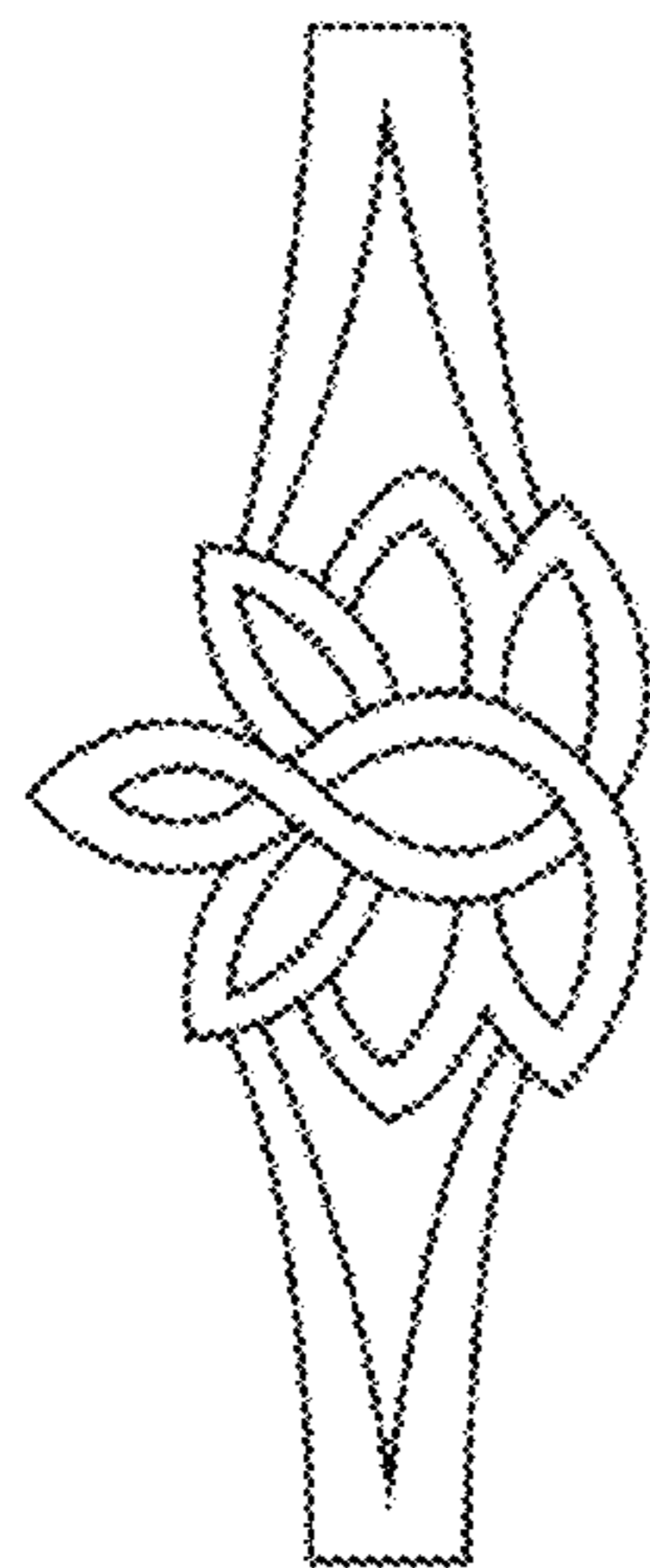

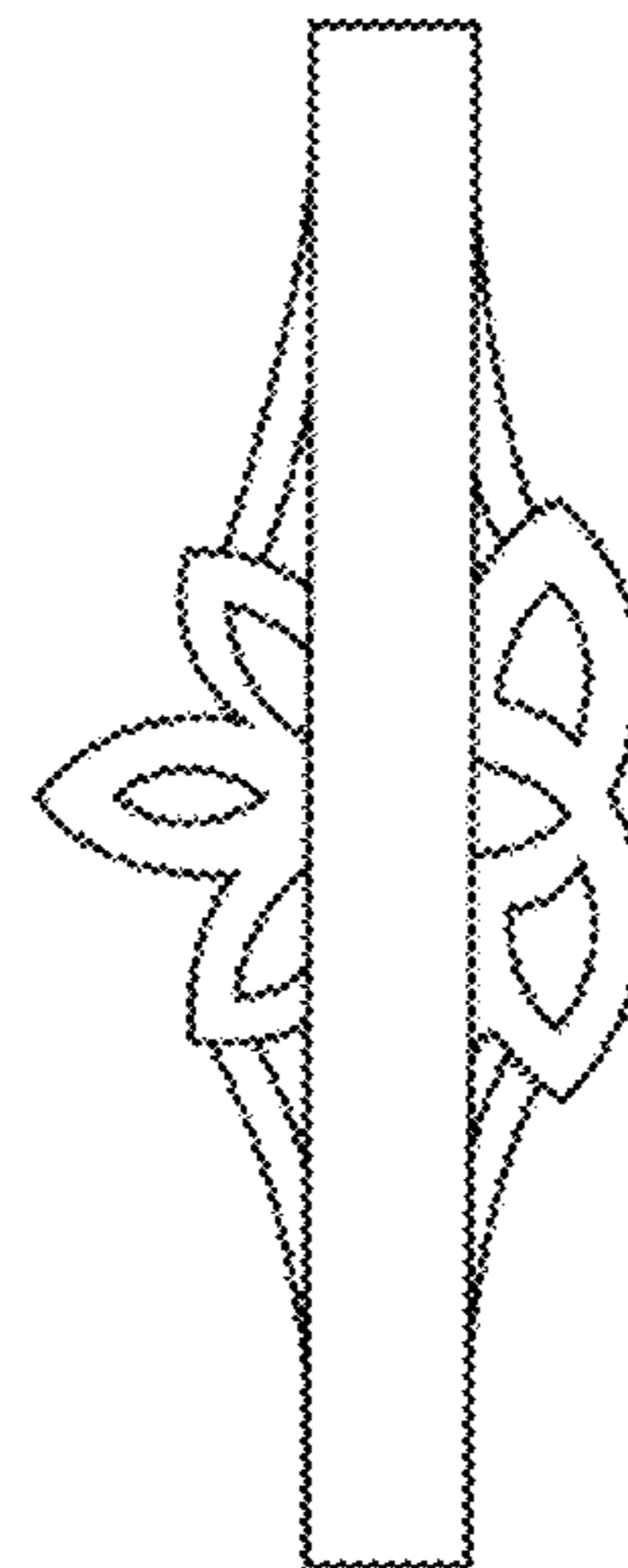

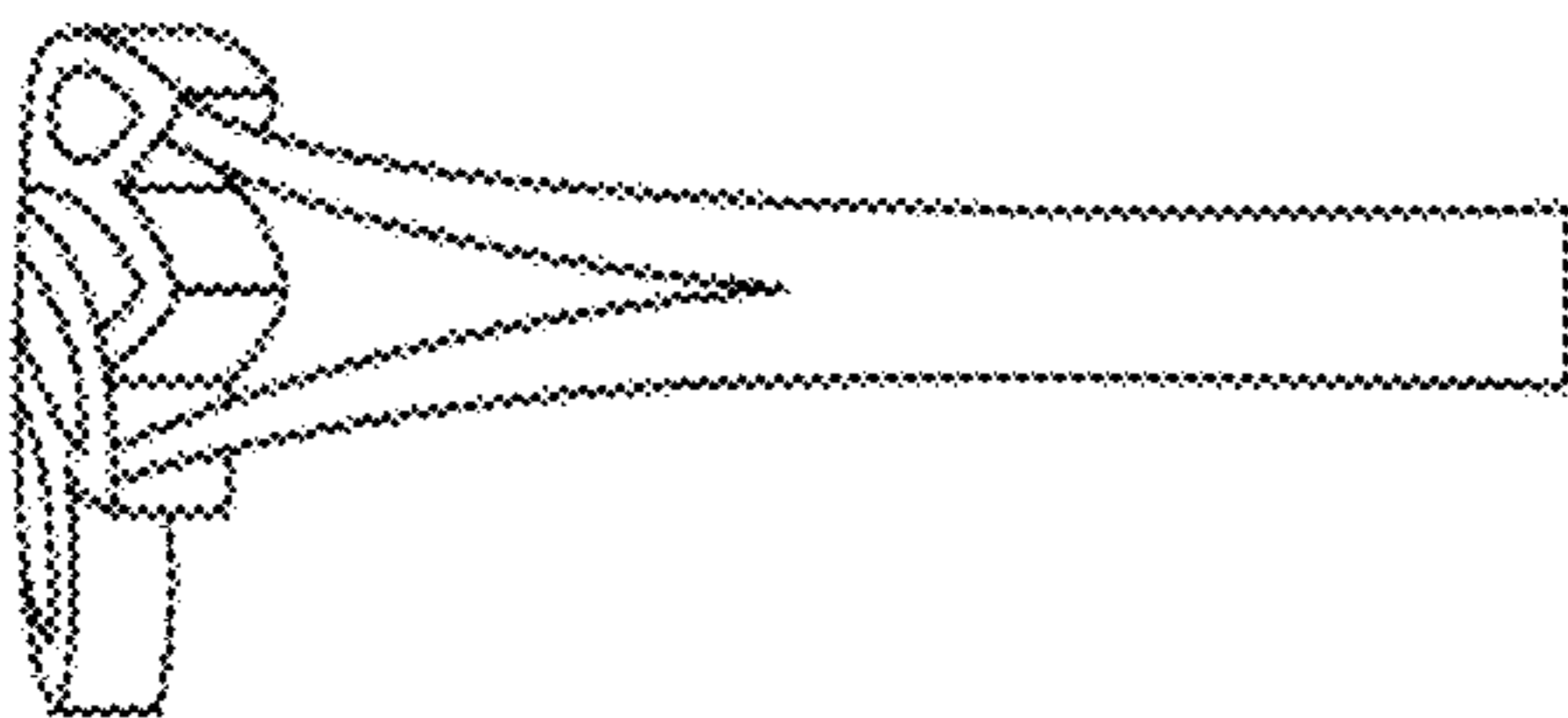

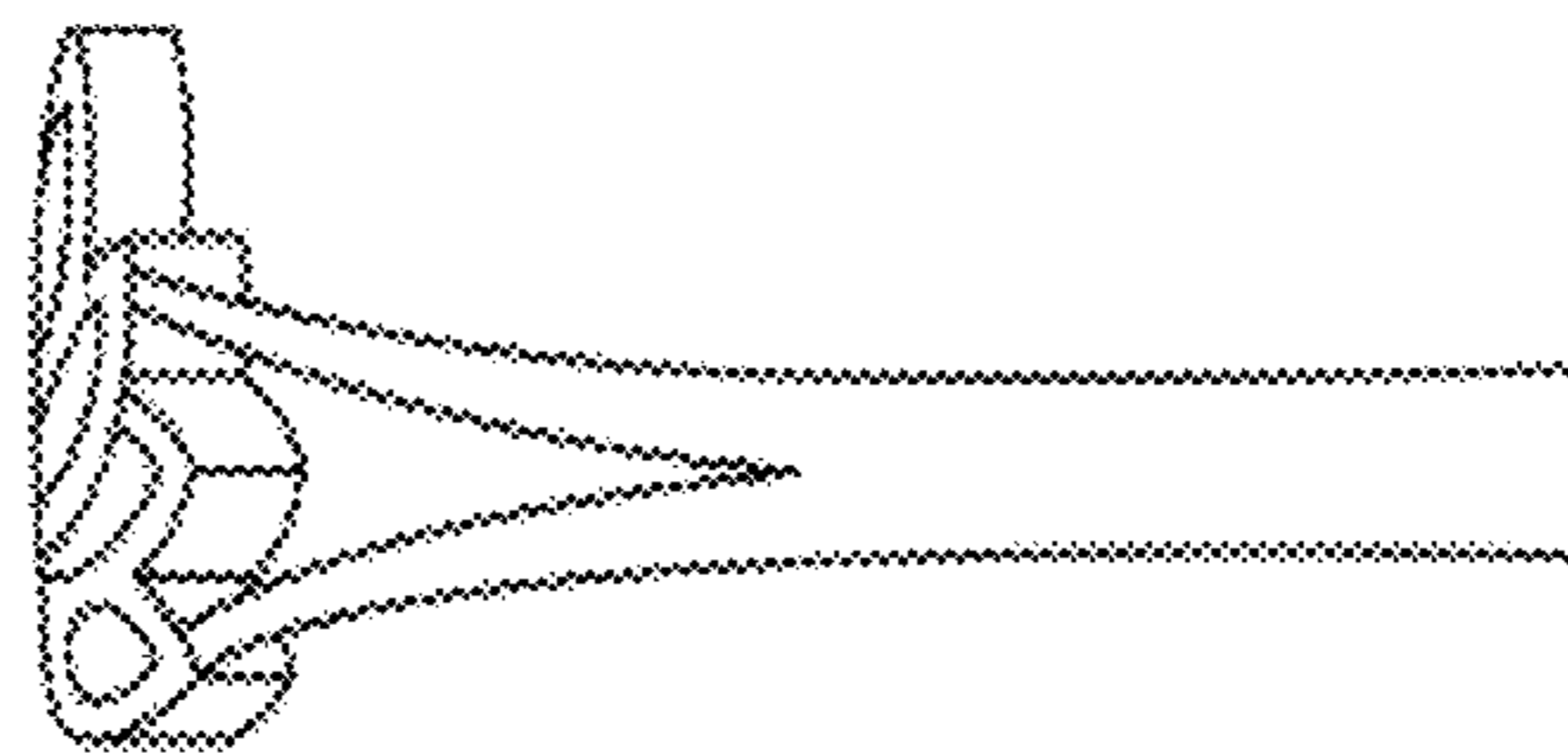

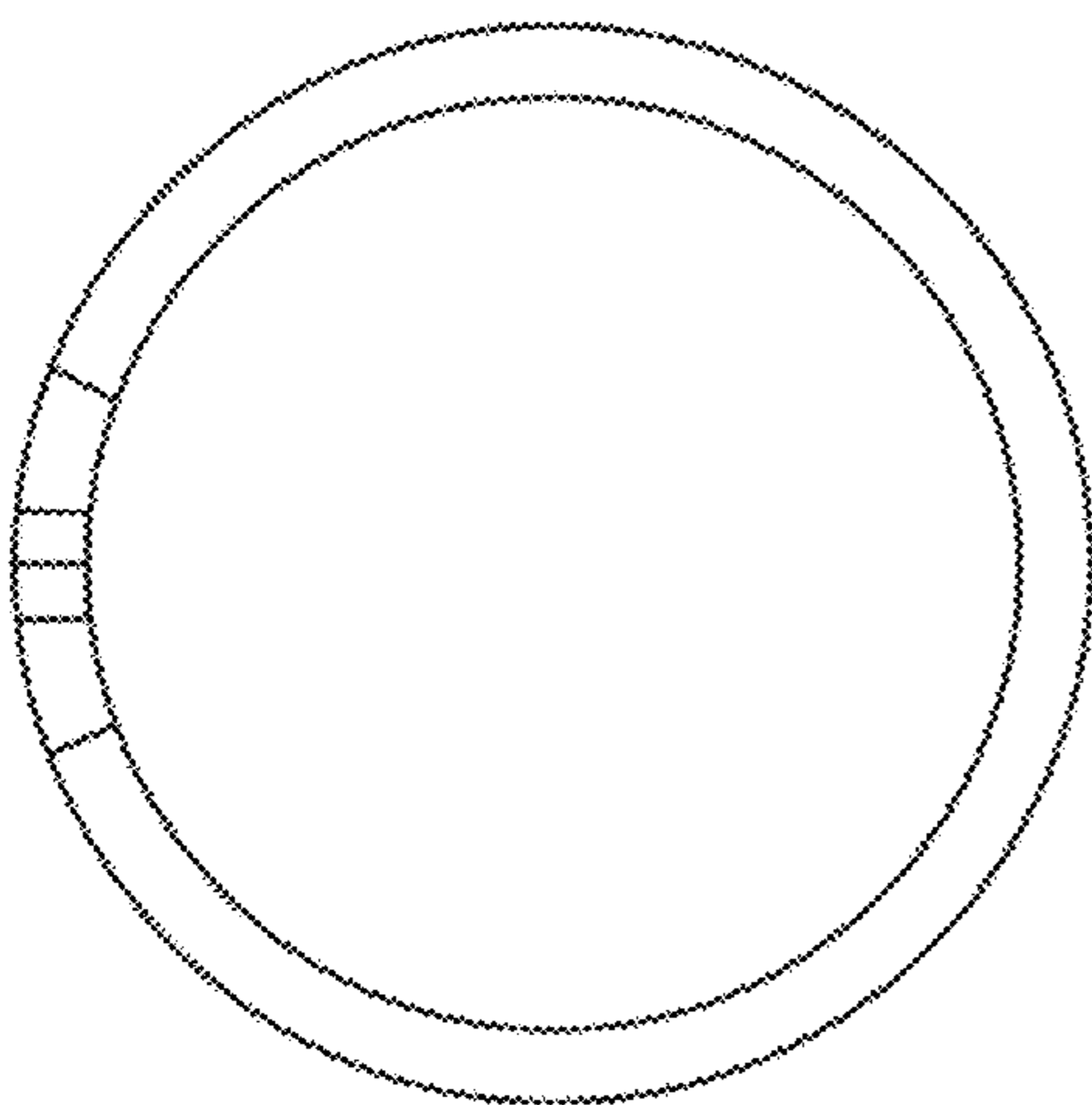
