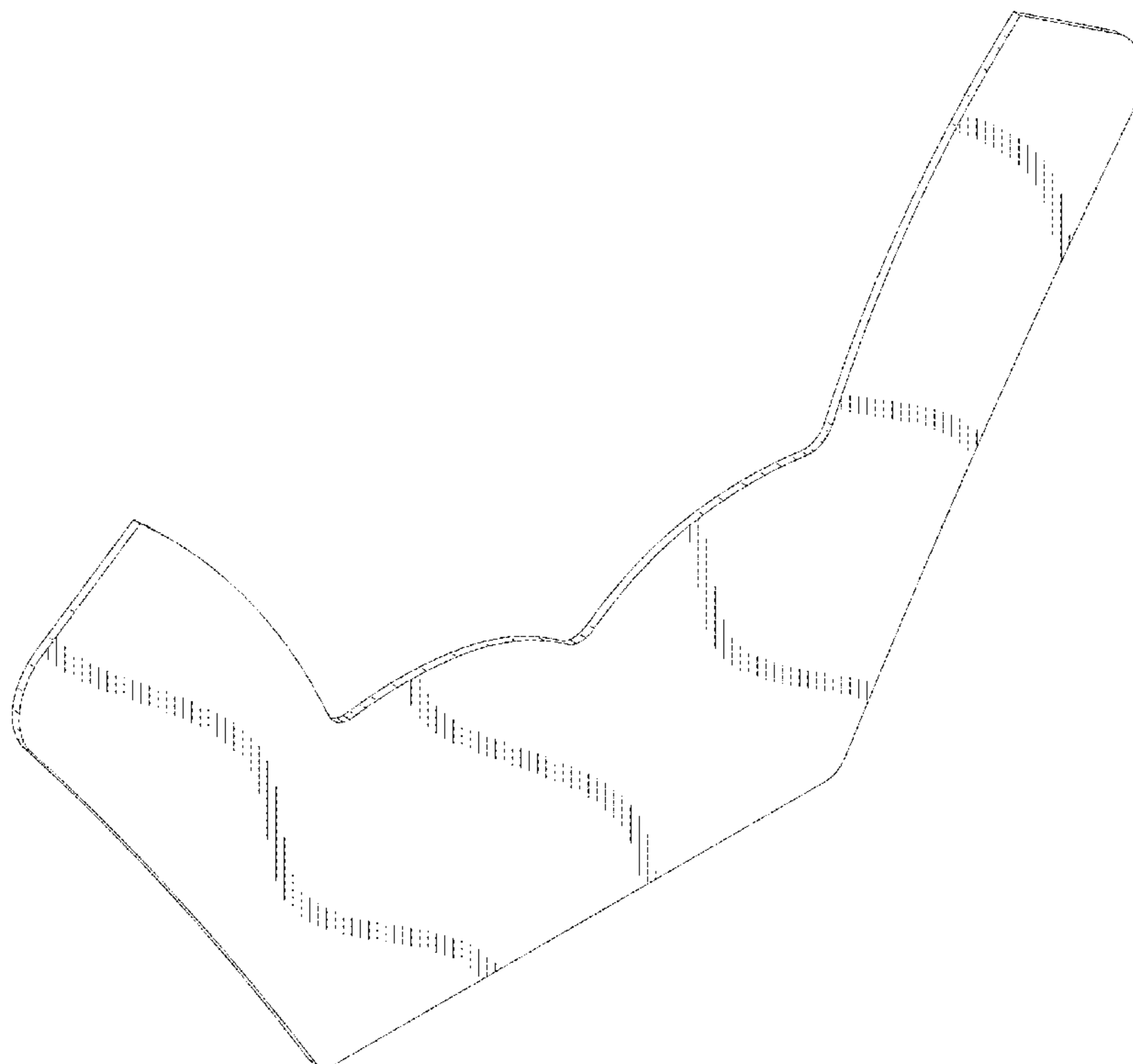
The ornamental design for a sunshade, as shown and described.

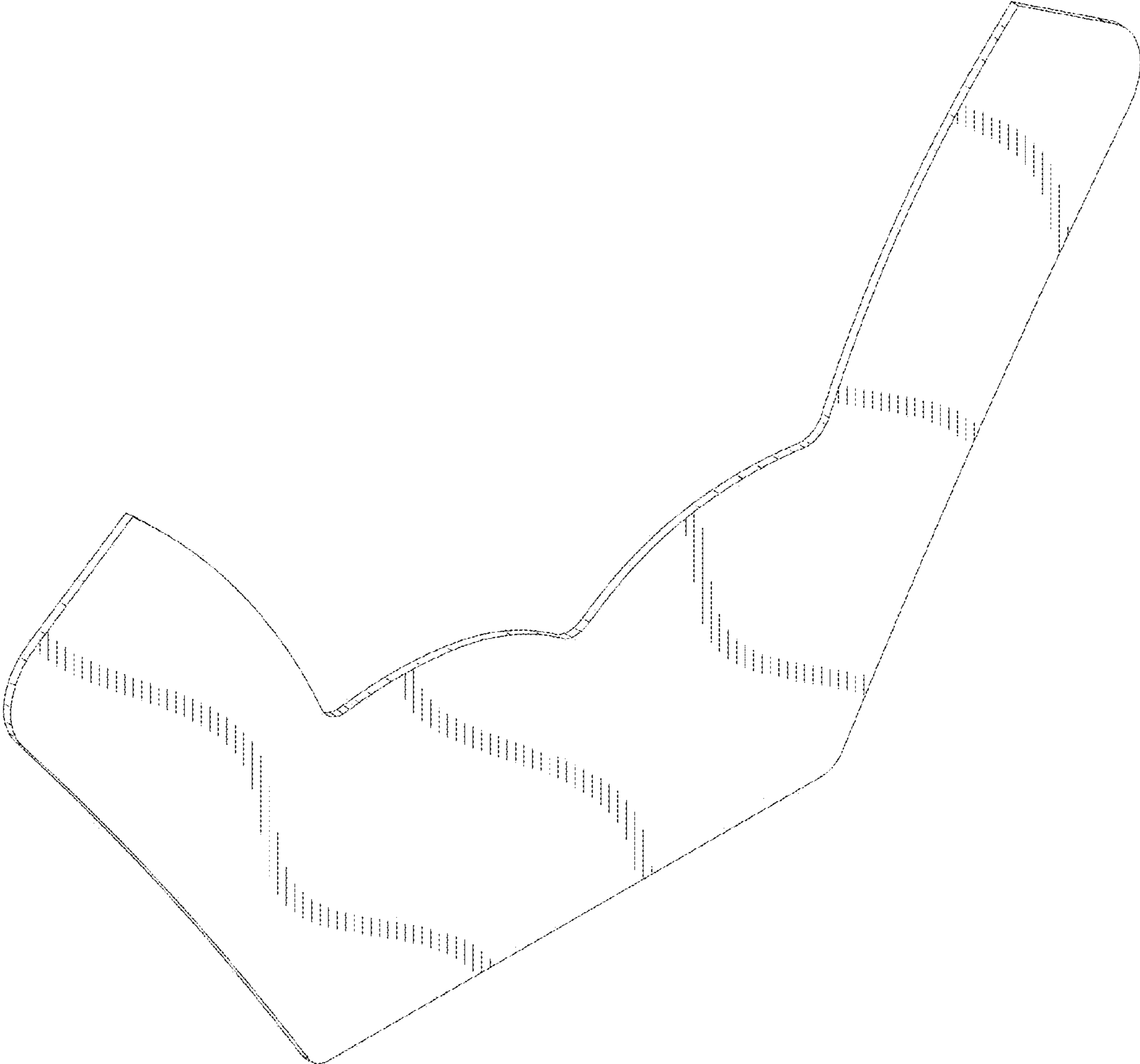

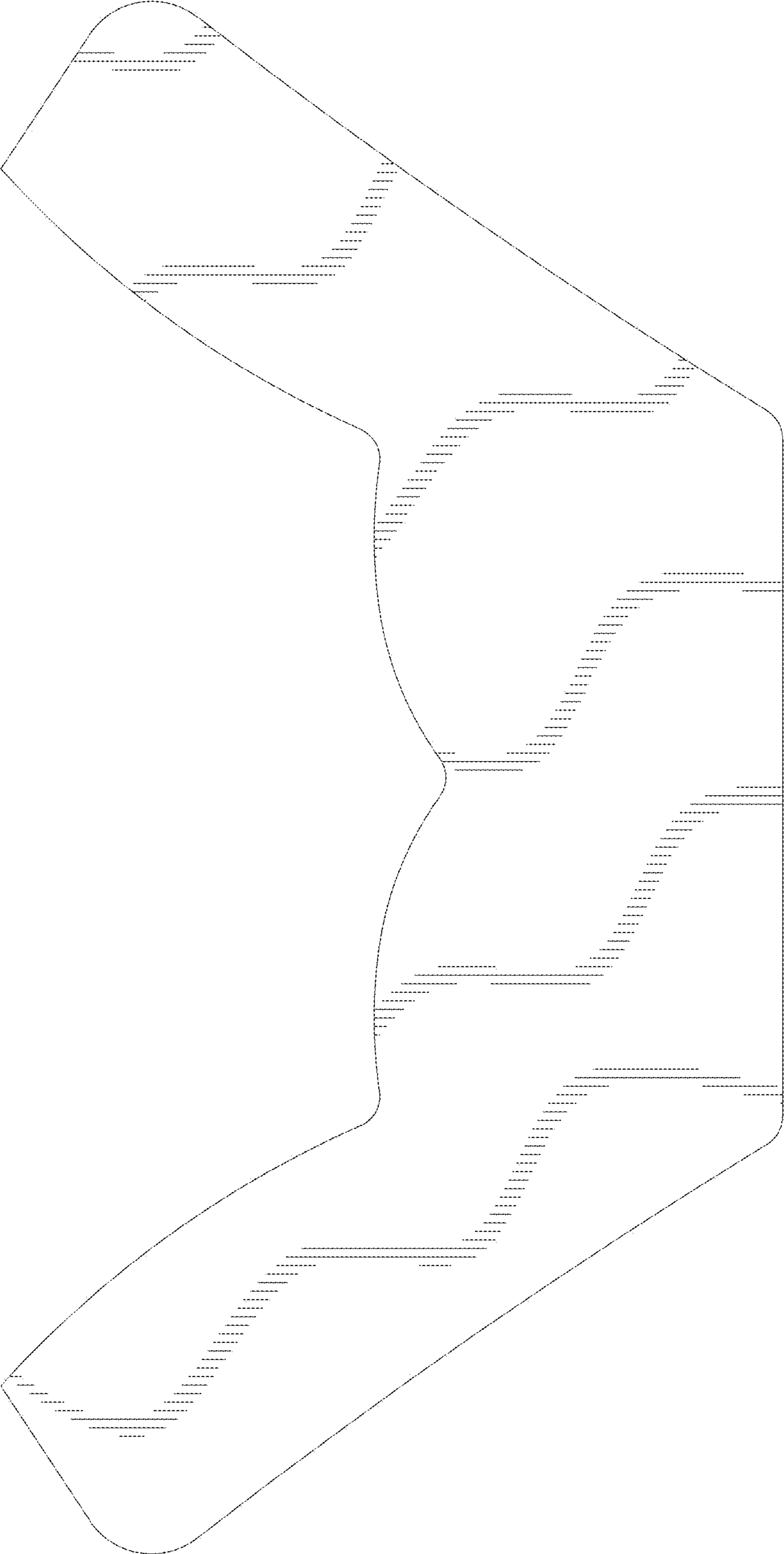

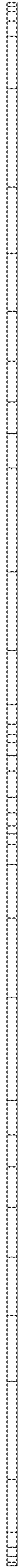

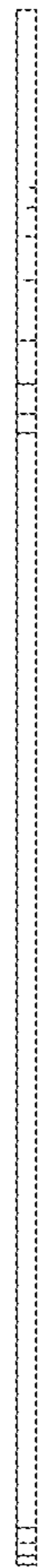
