DESCRIPTION

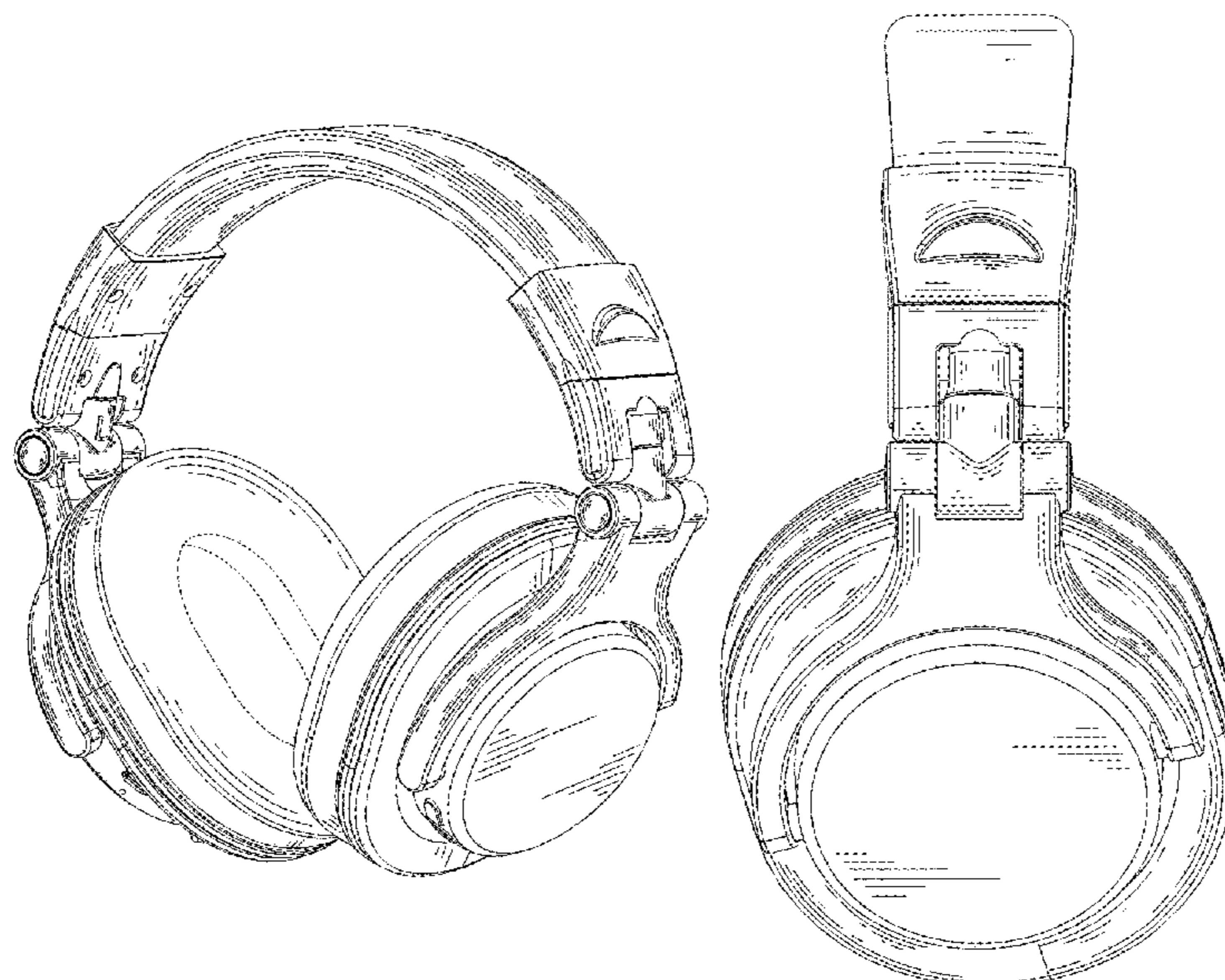
FIG. 1 is a perspective view of a headphone showing my new design;

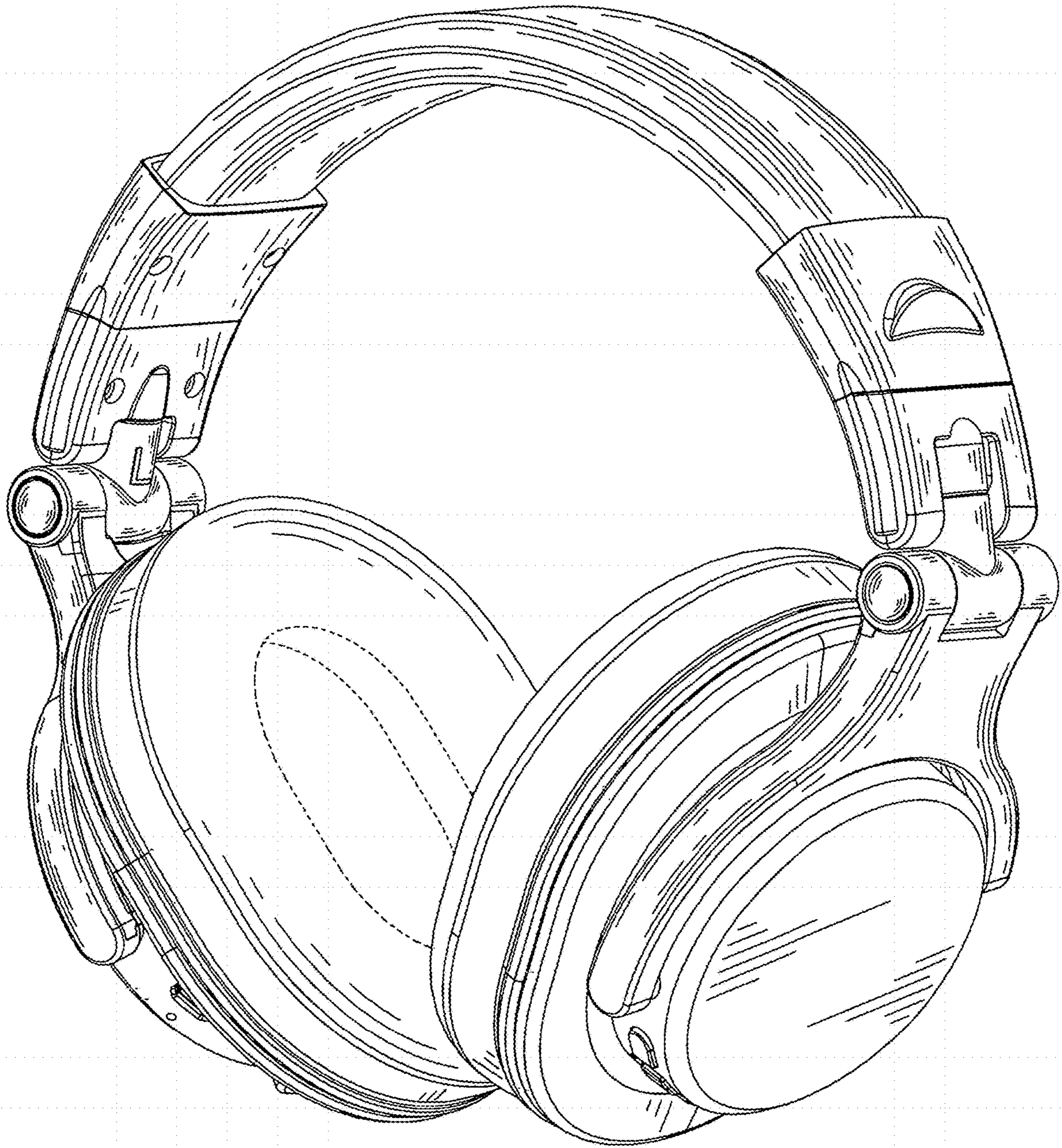

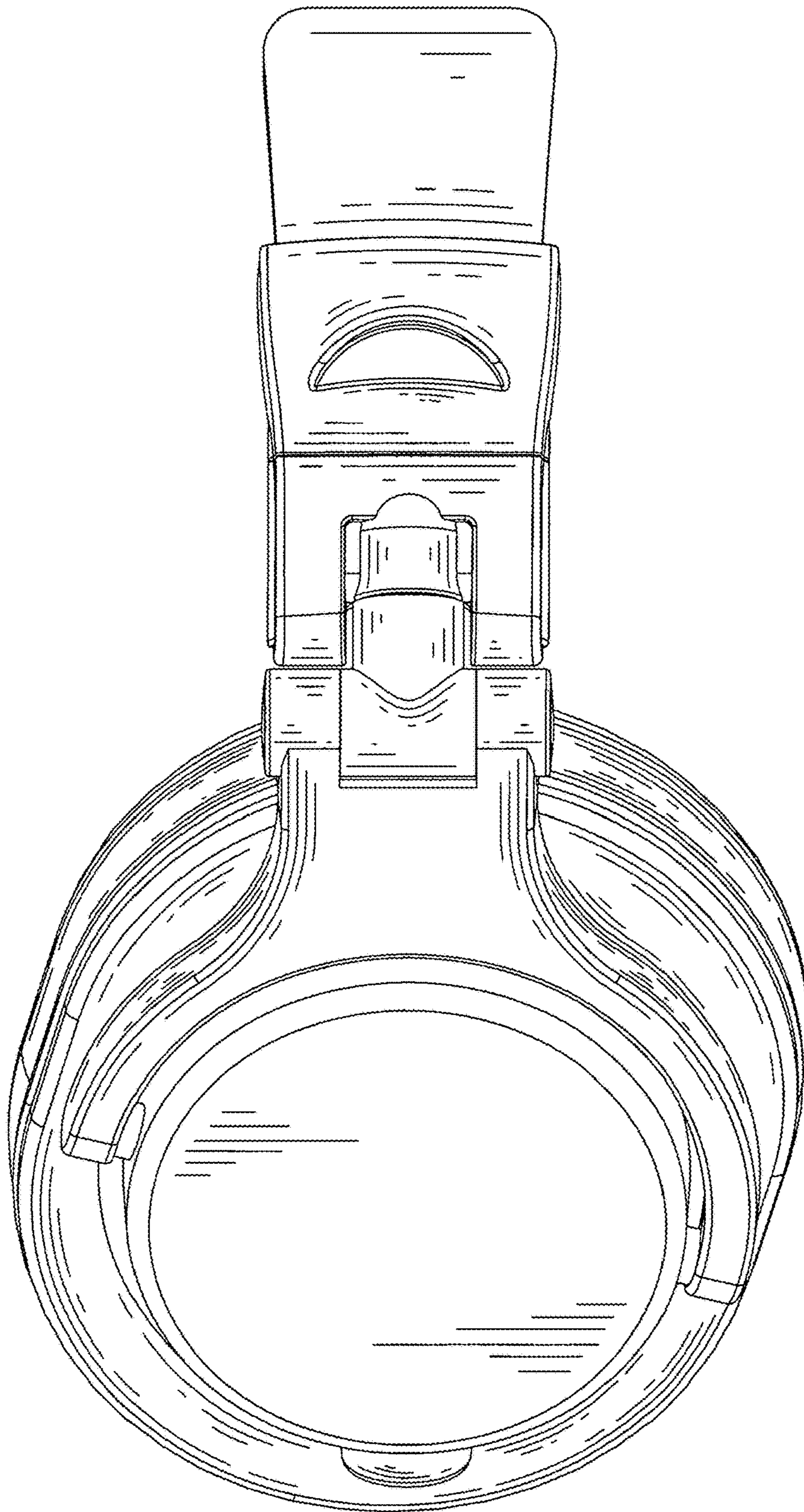

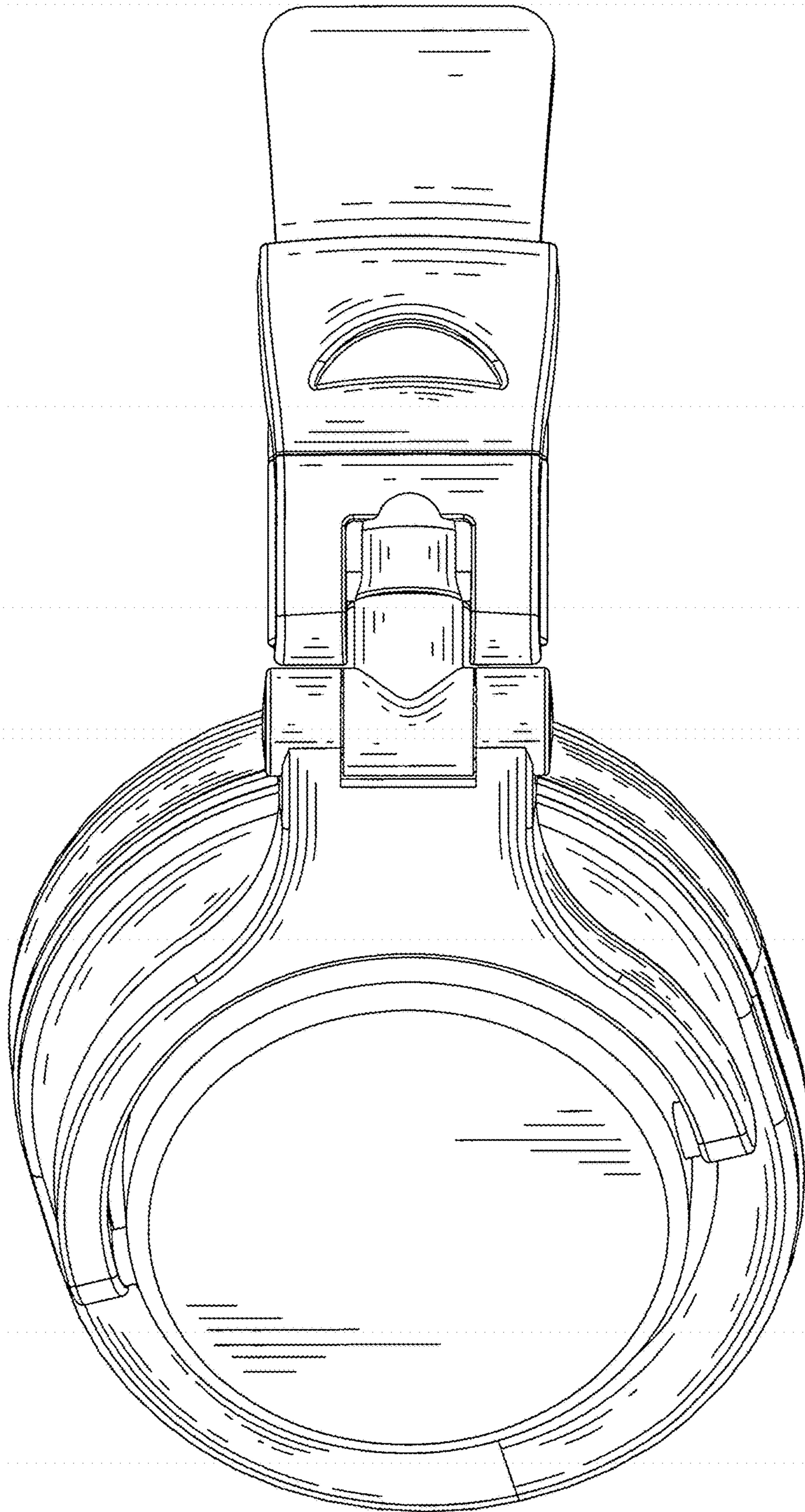

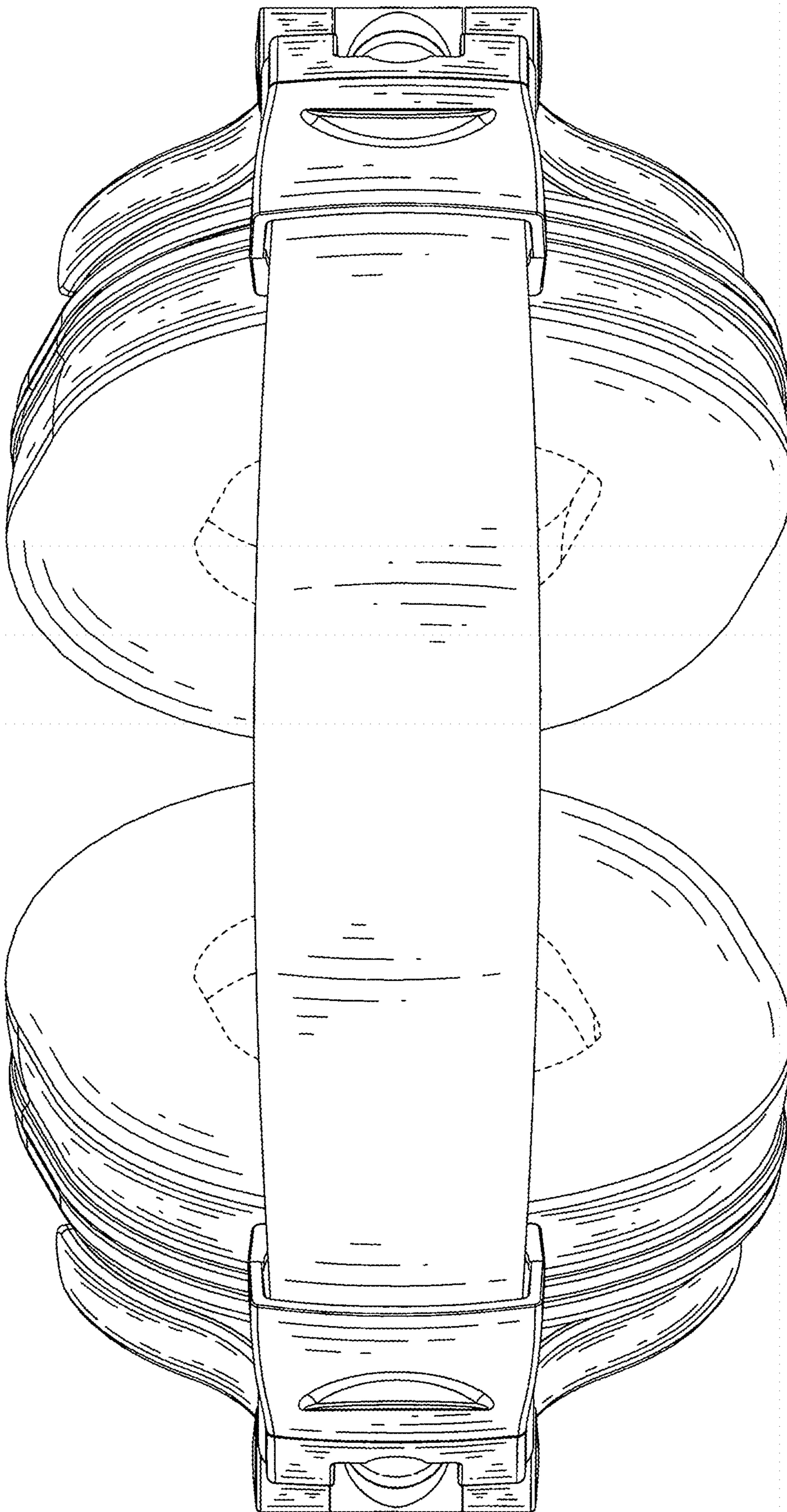

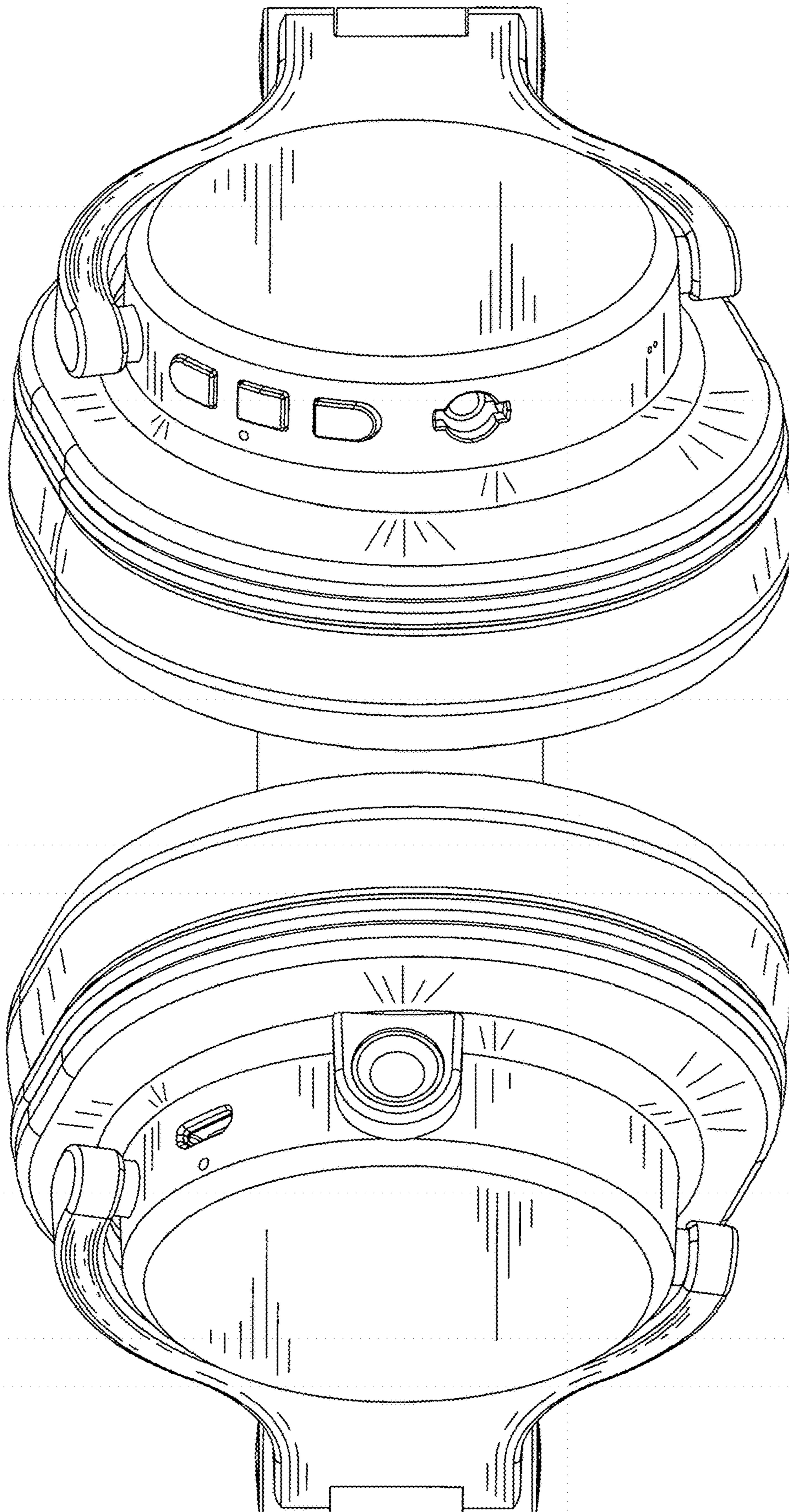
