FIG. 2 is a front view of a second embodiment of an electronic device with graphical user interface showing the claimed design;

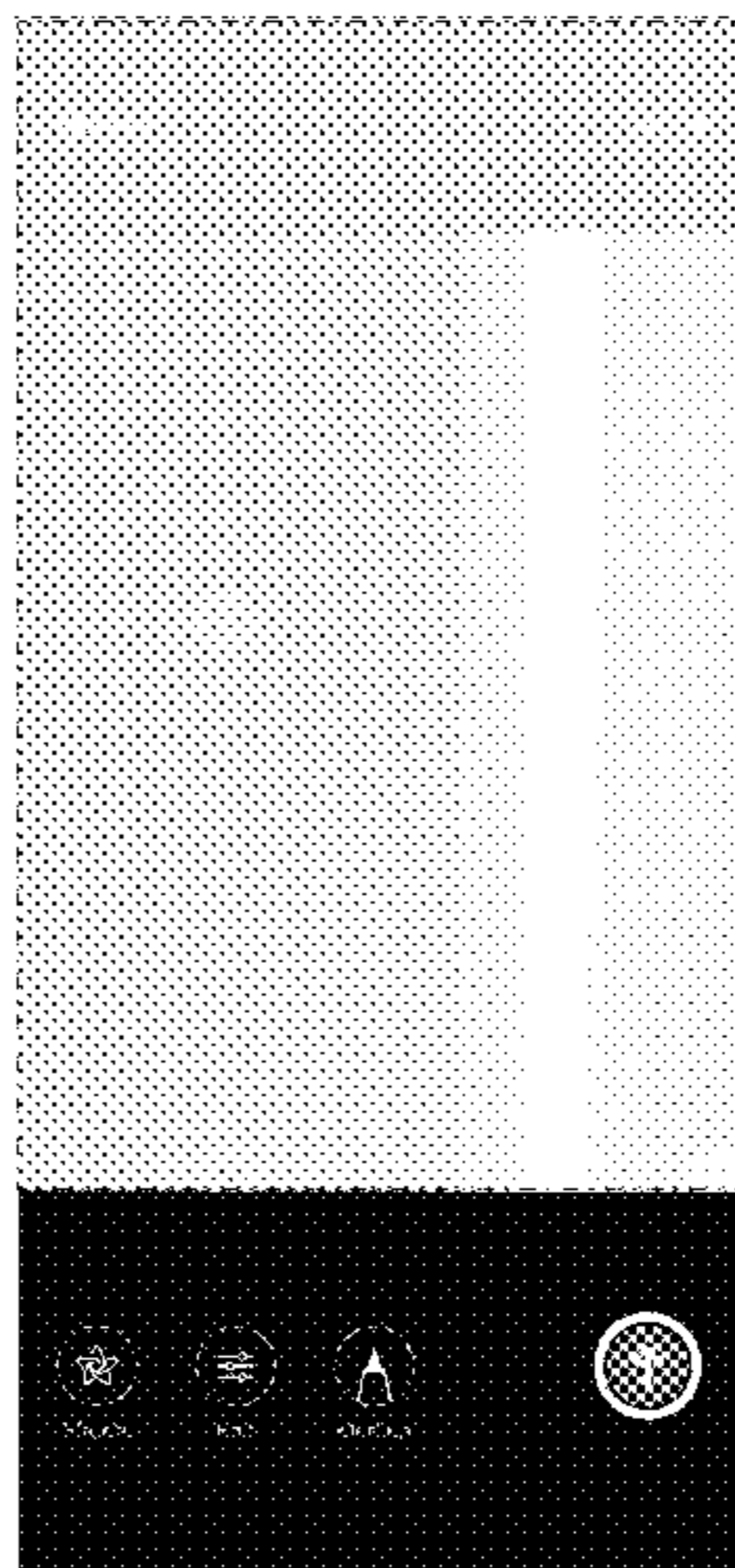
FIG. 3 is a front view of a third embodiment of an electronic device with graphical user interface showing the claimed design; and,

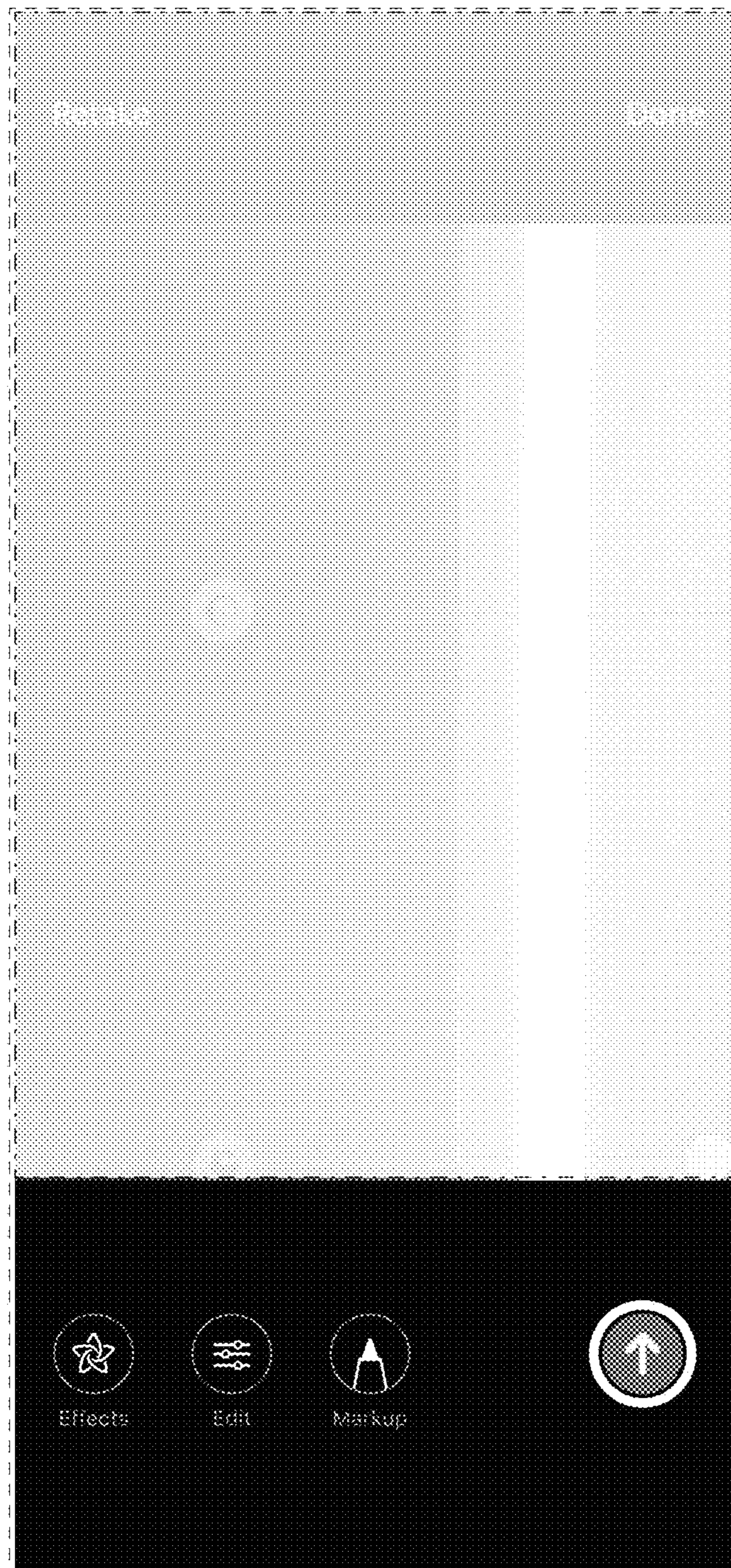

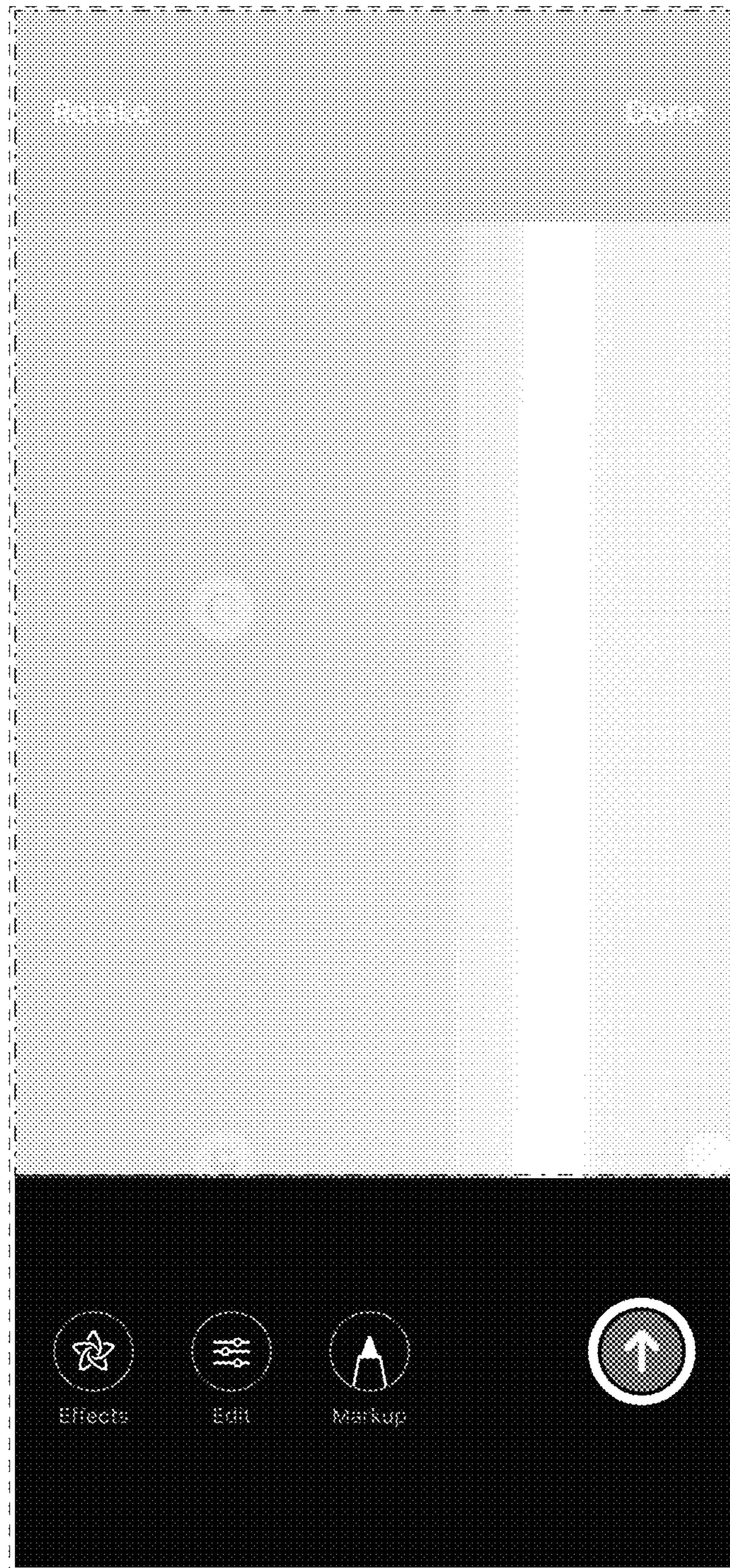

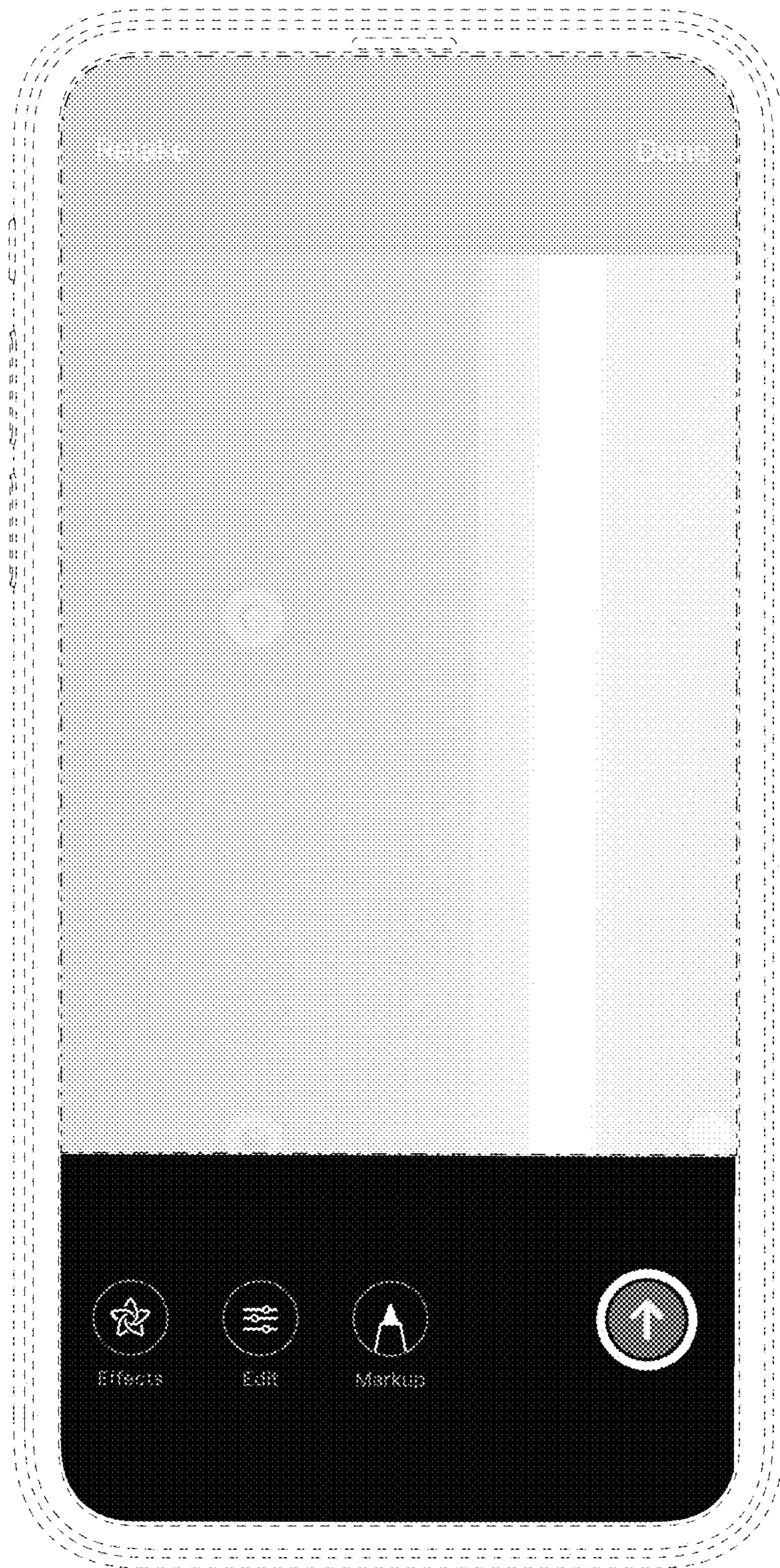

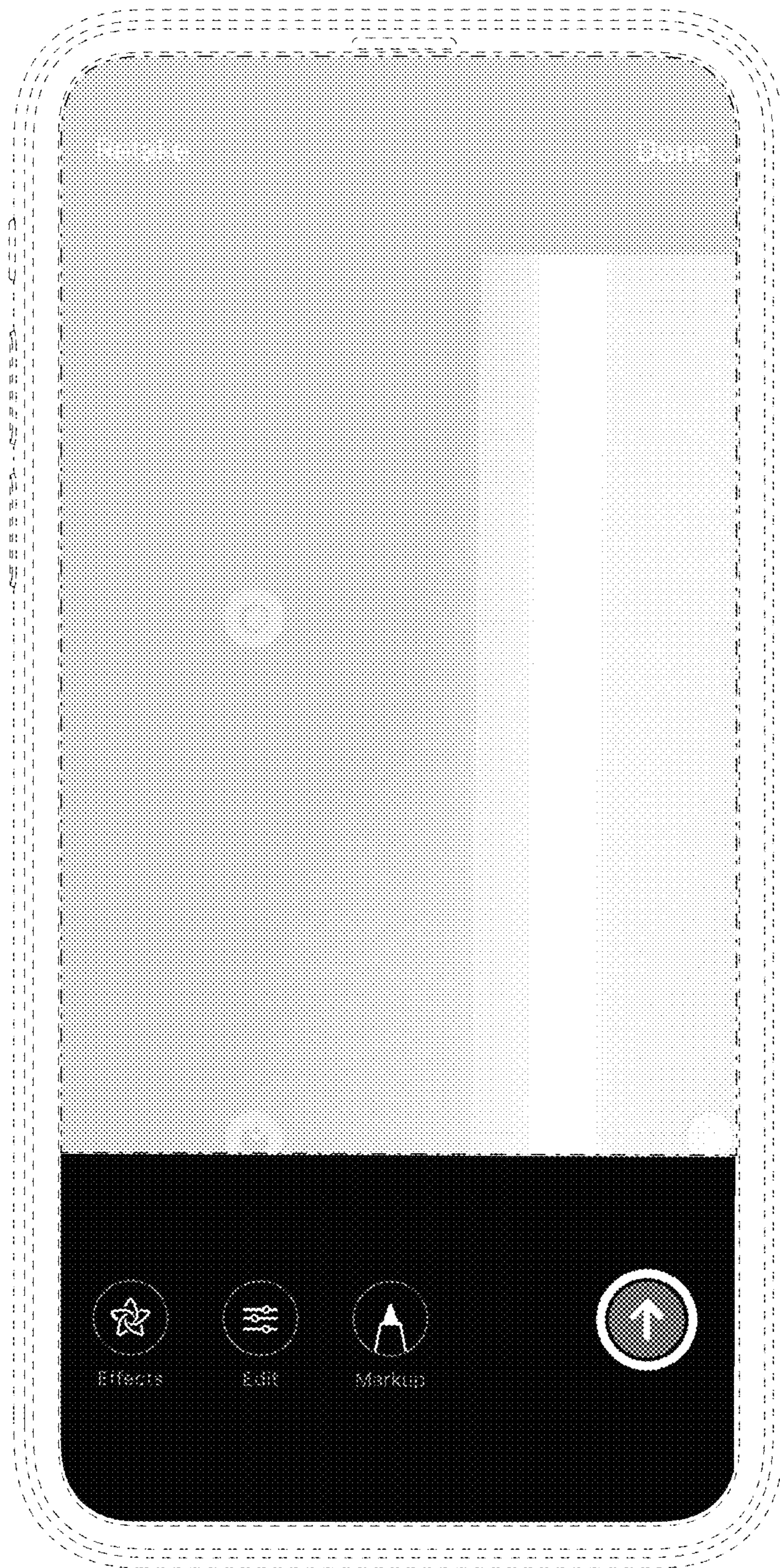
