FIG. 2 is a front view of the portions of the miter saw of FIG. 1.

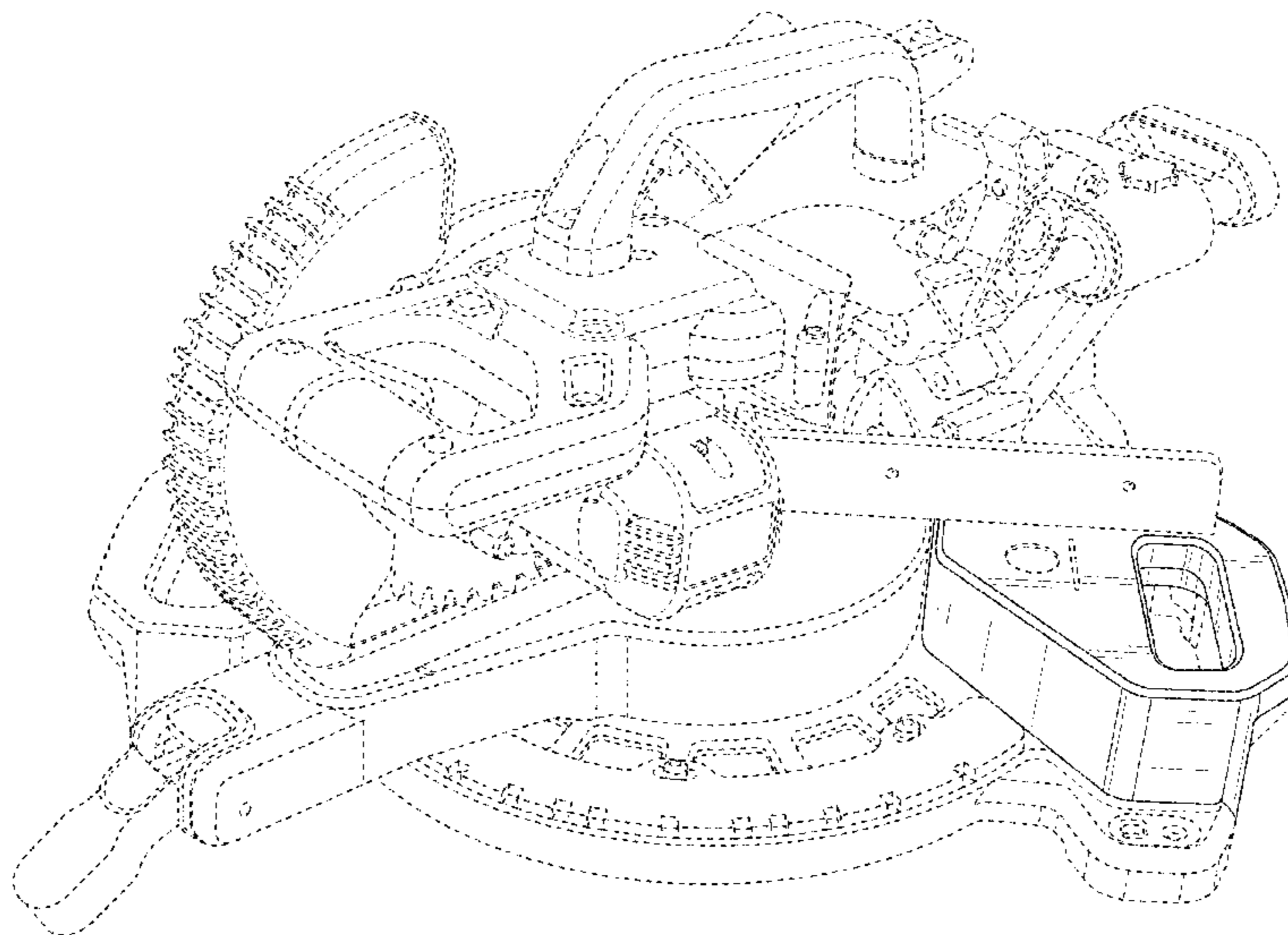
FIG. 3 is a rear view of the portions of the miter saw of FIG. 1.

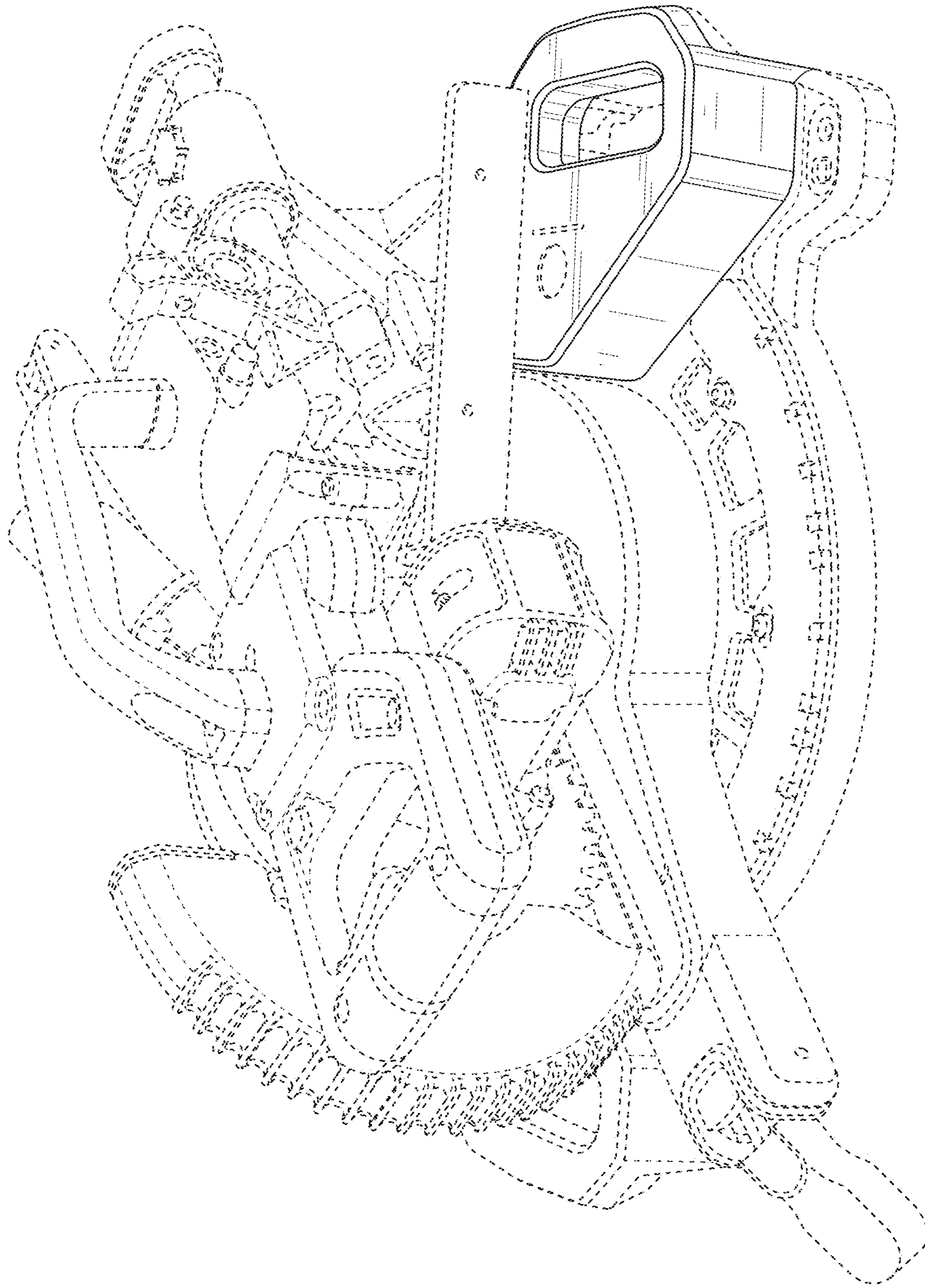

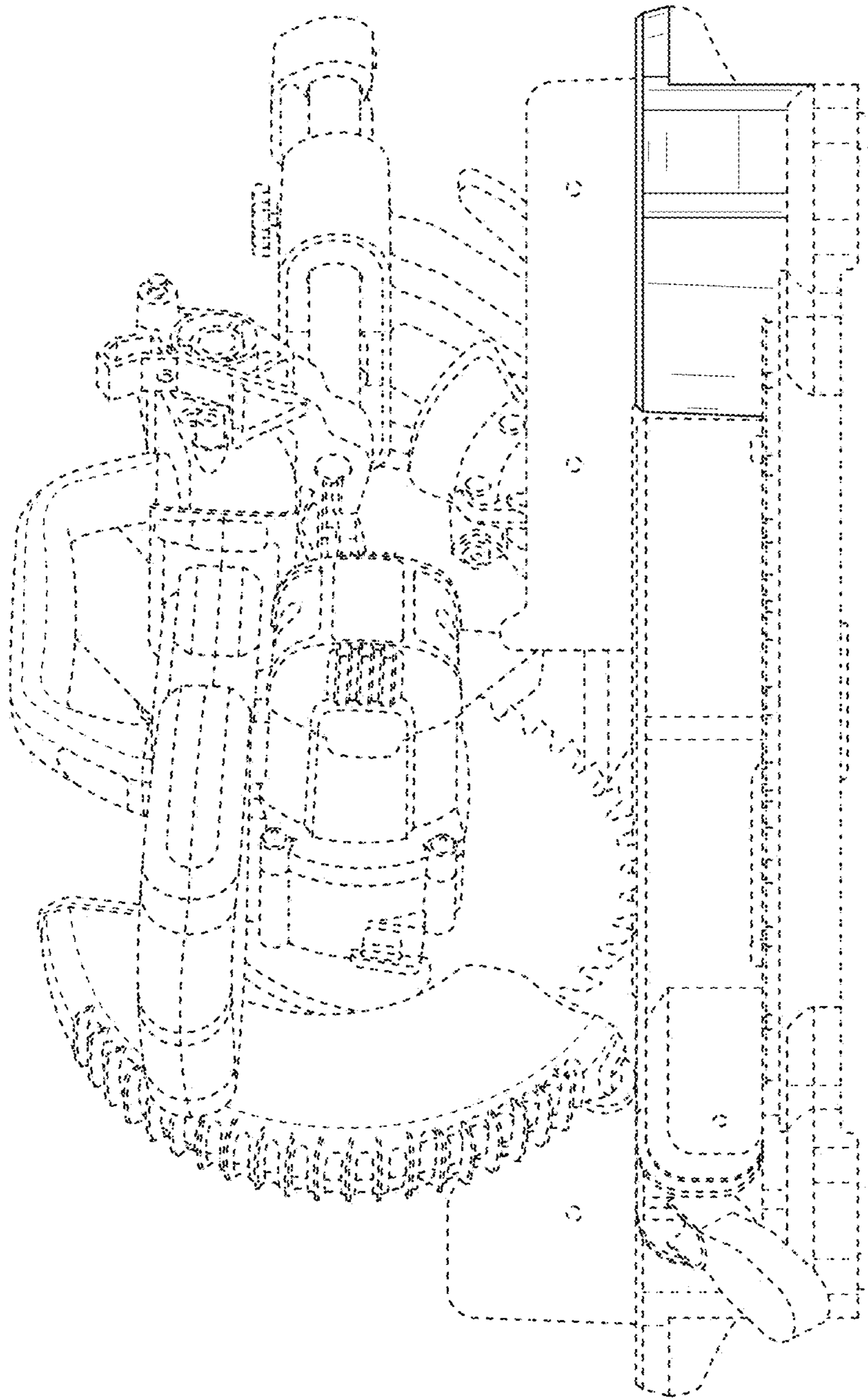

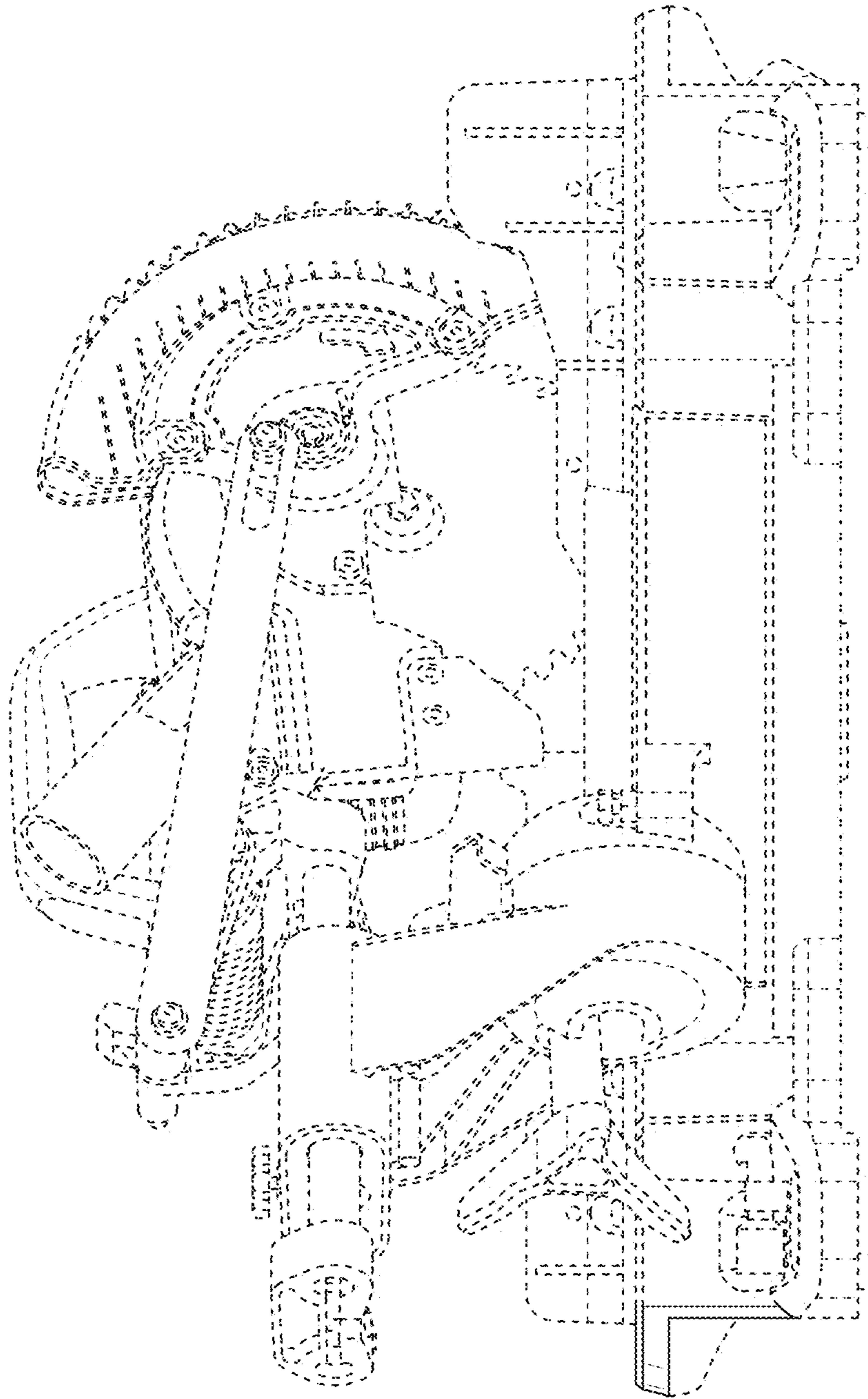

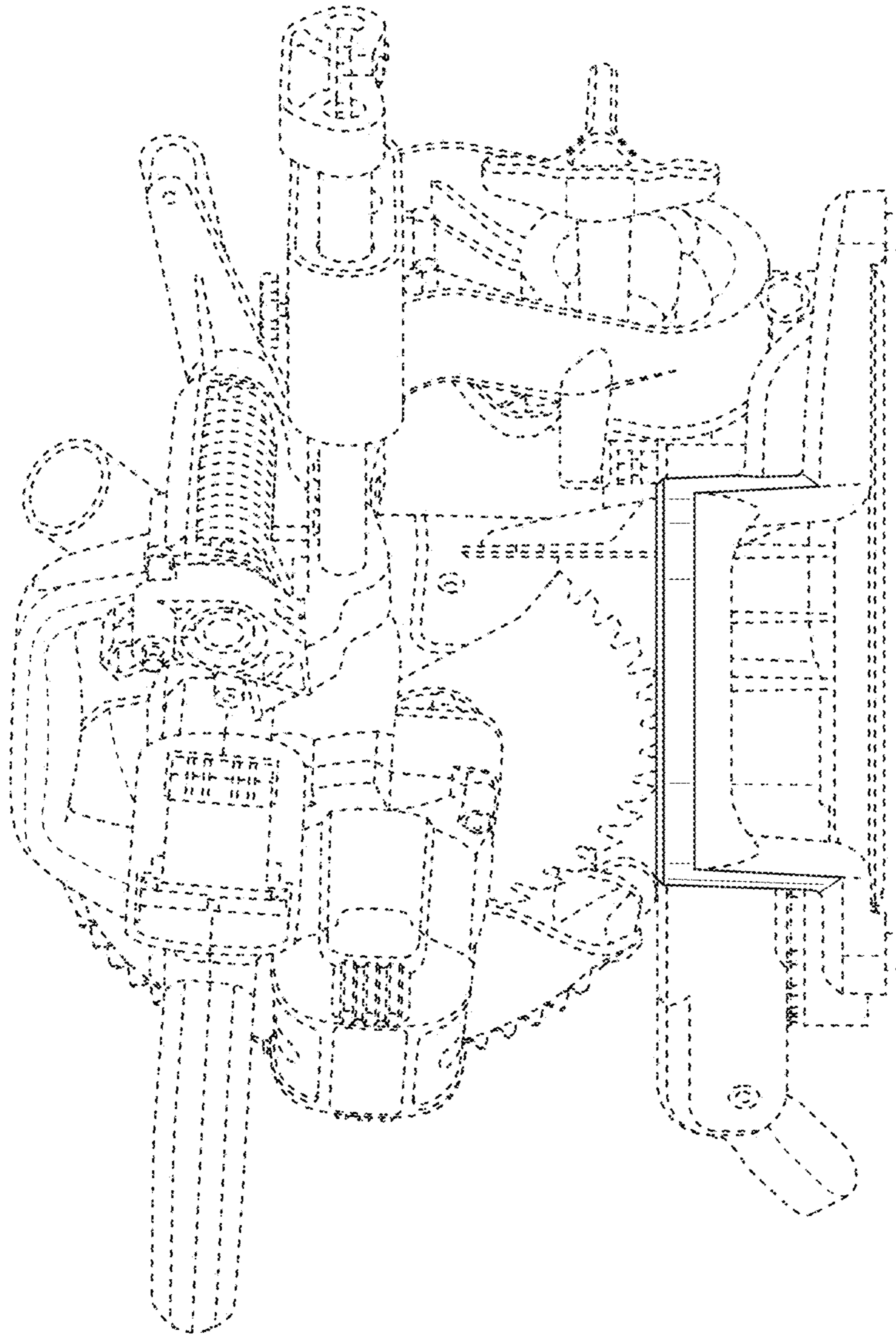

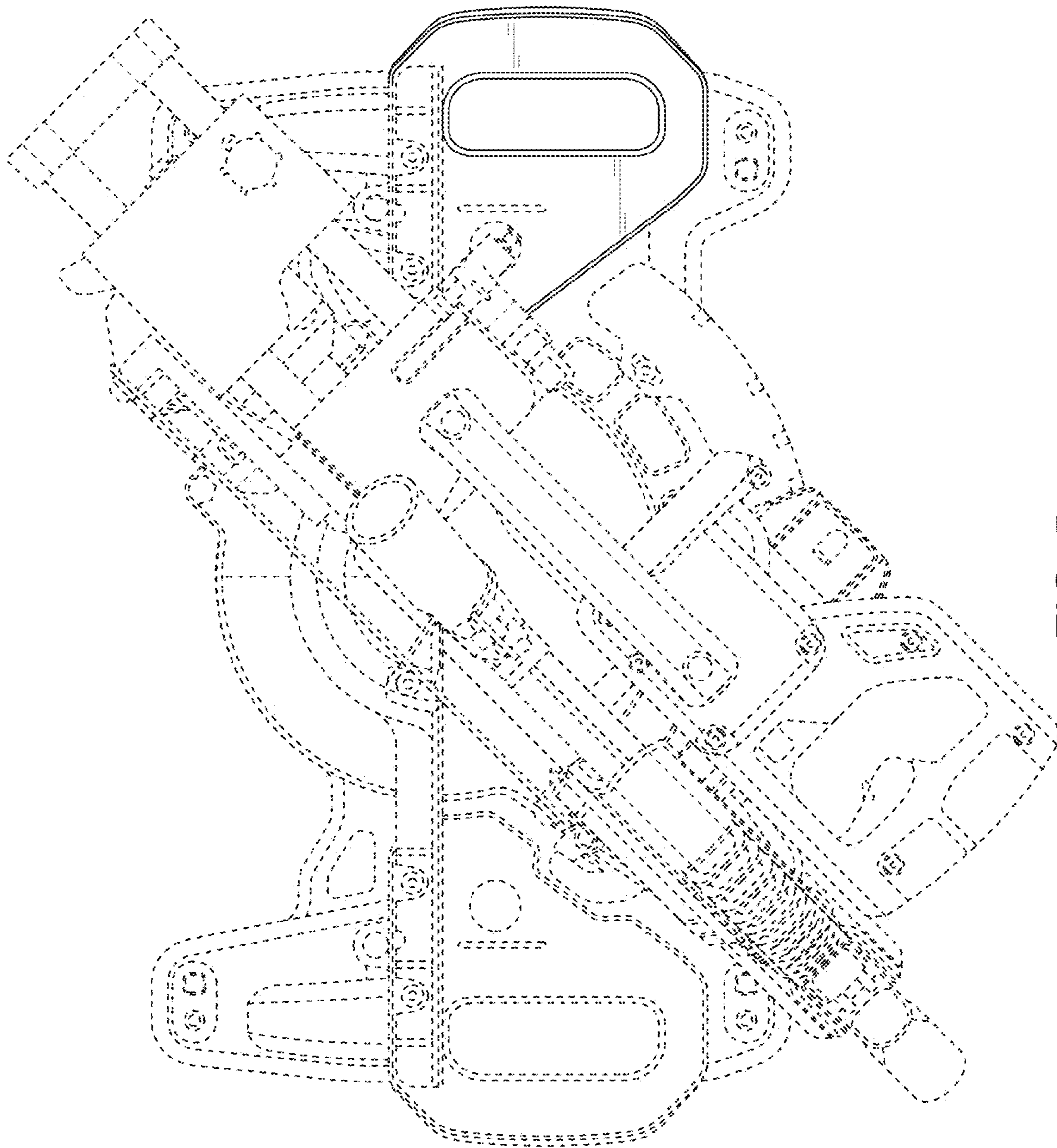
