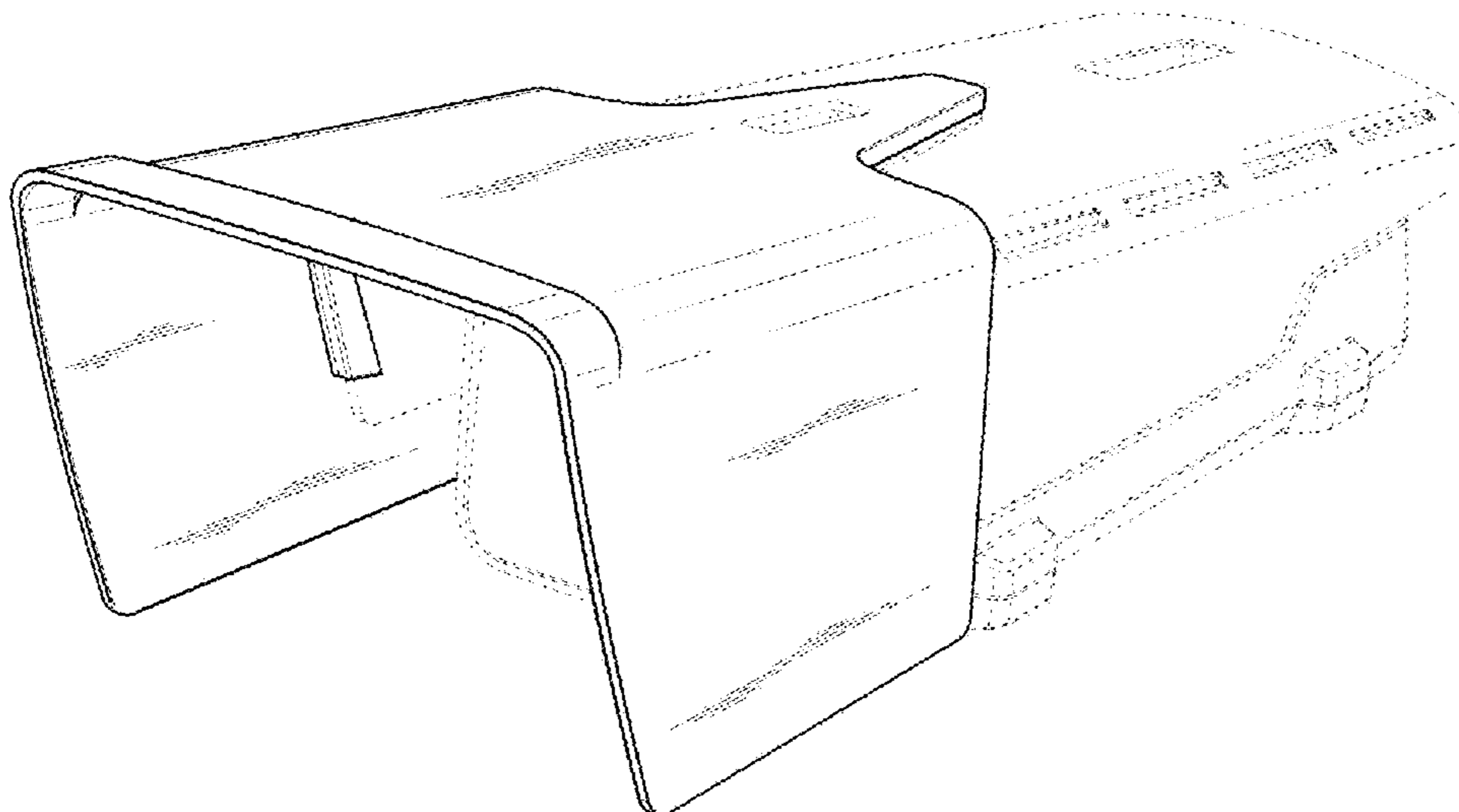
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front-left-top perspective view of a camera showing our new design;

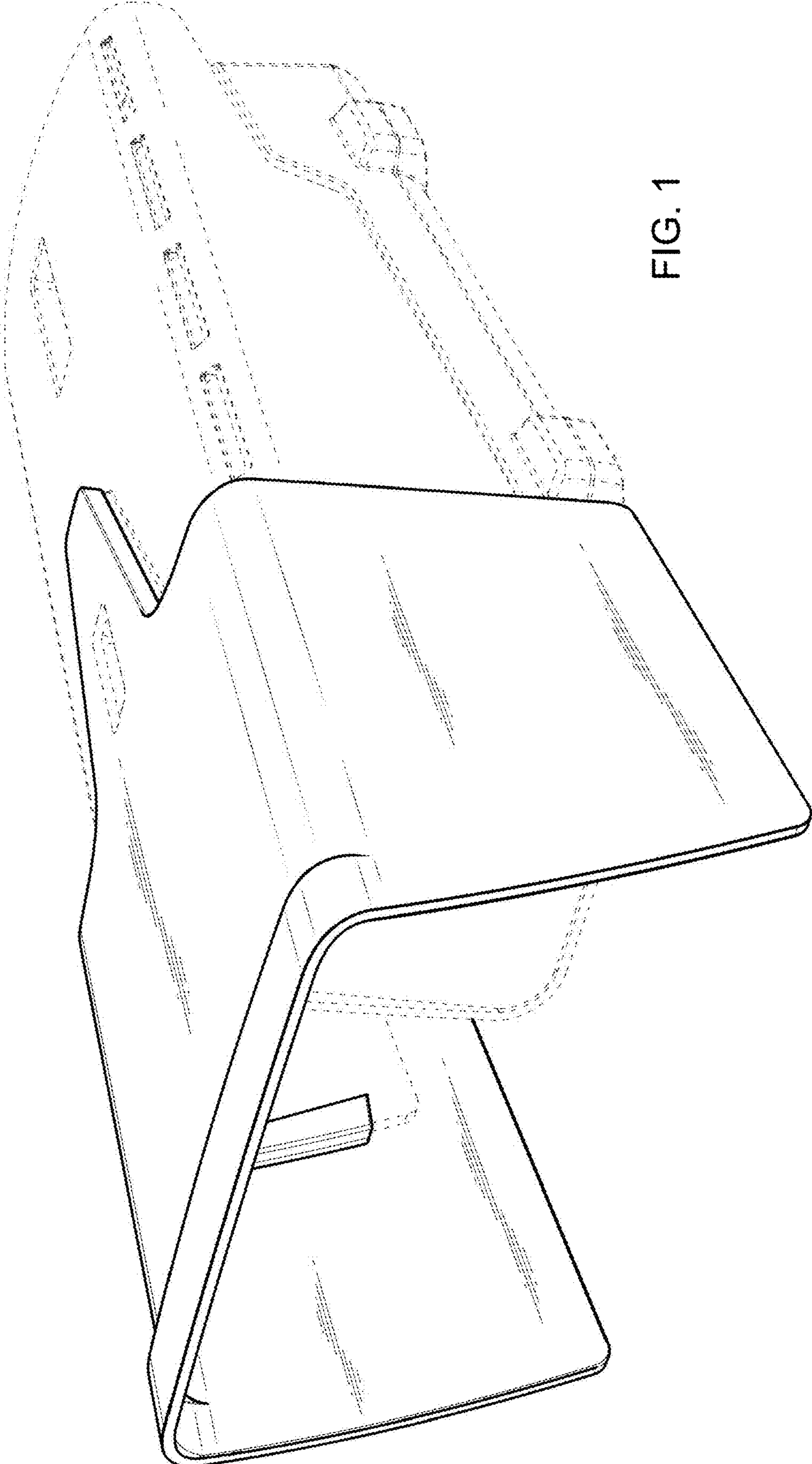

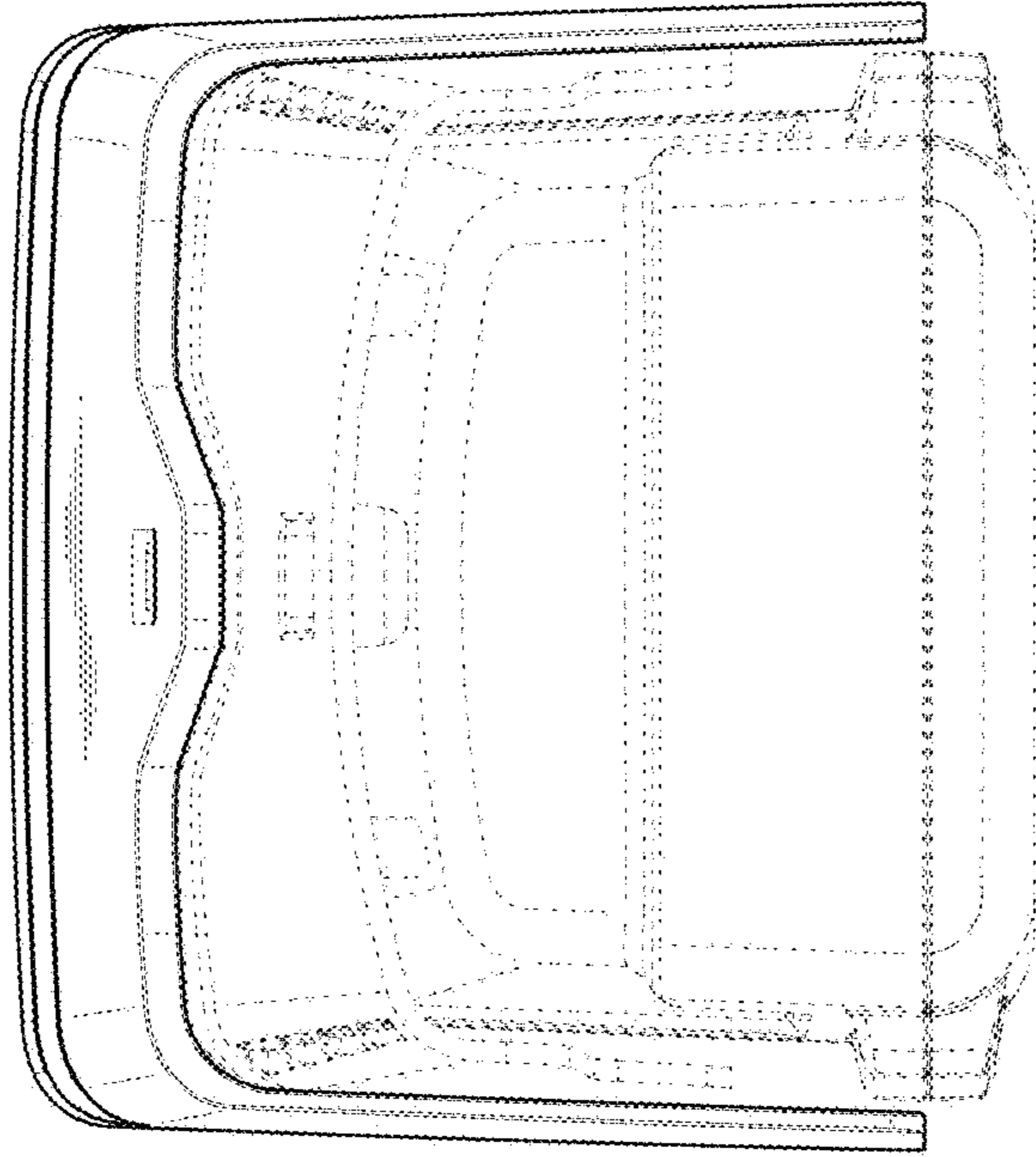

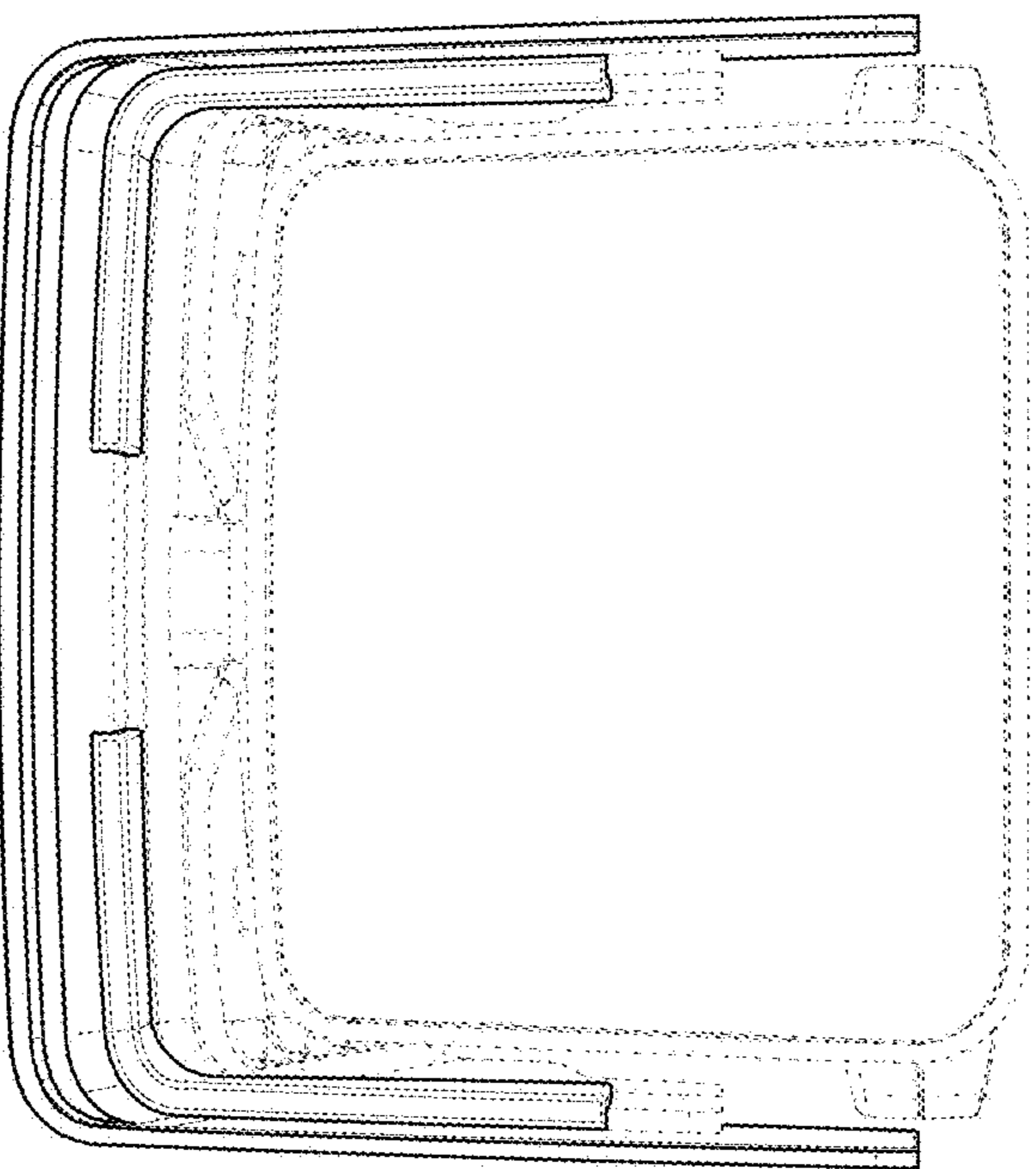

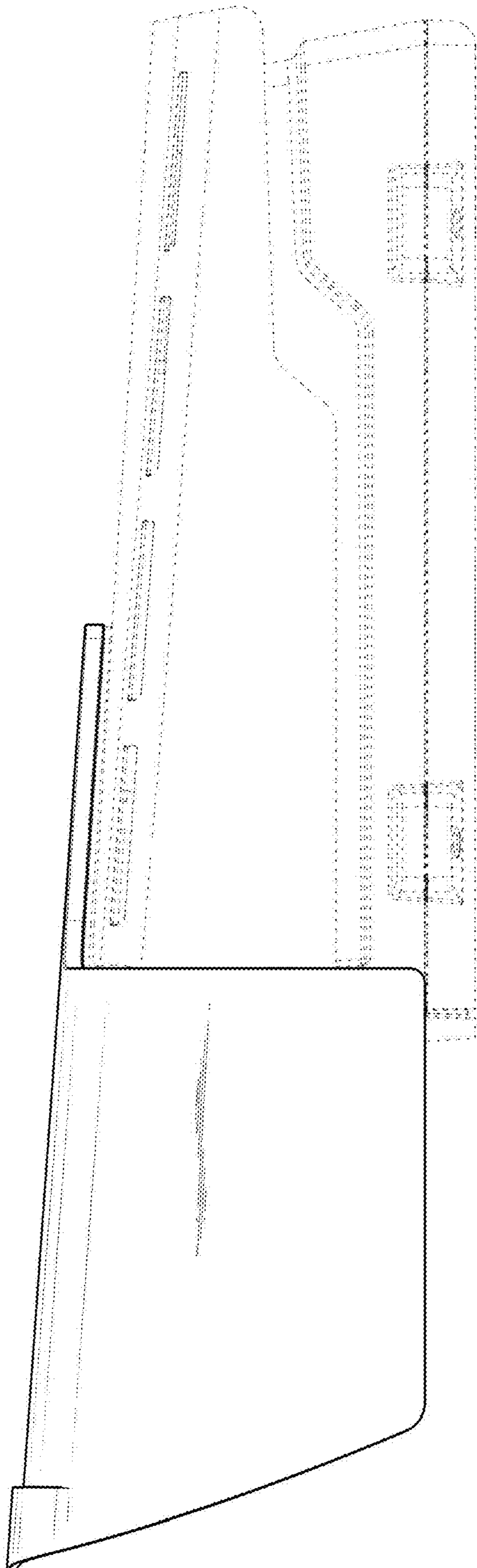

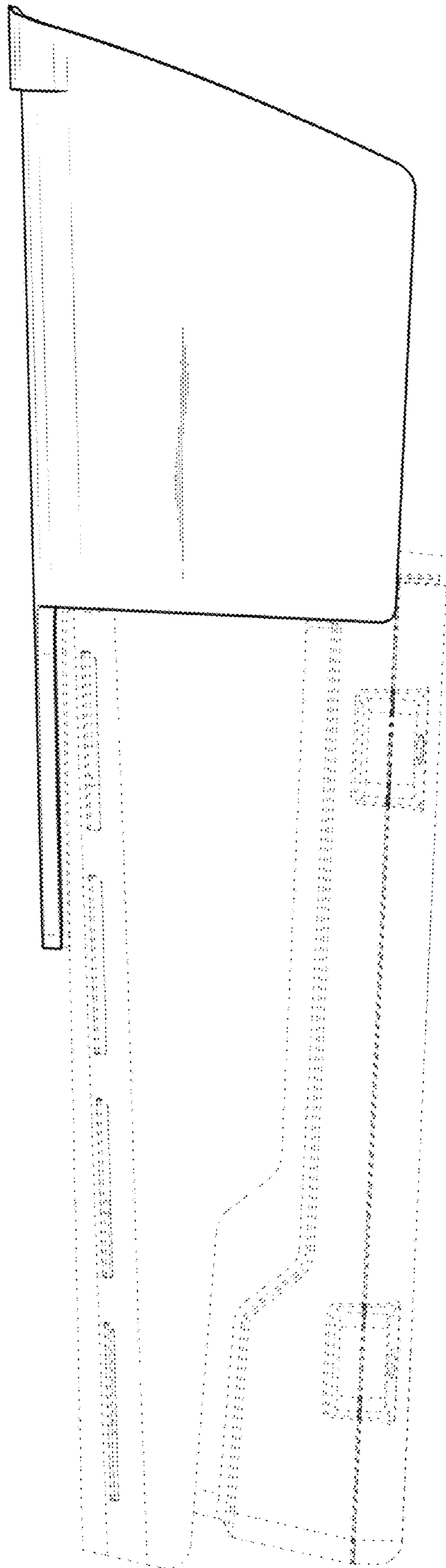

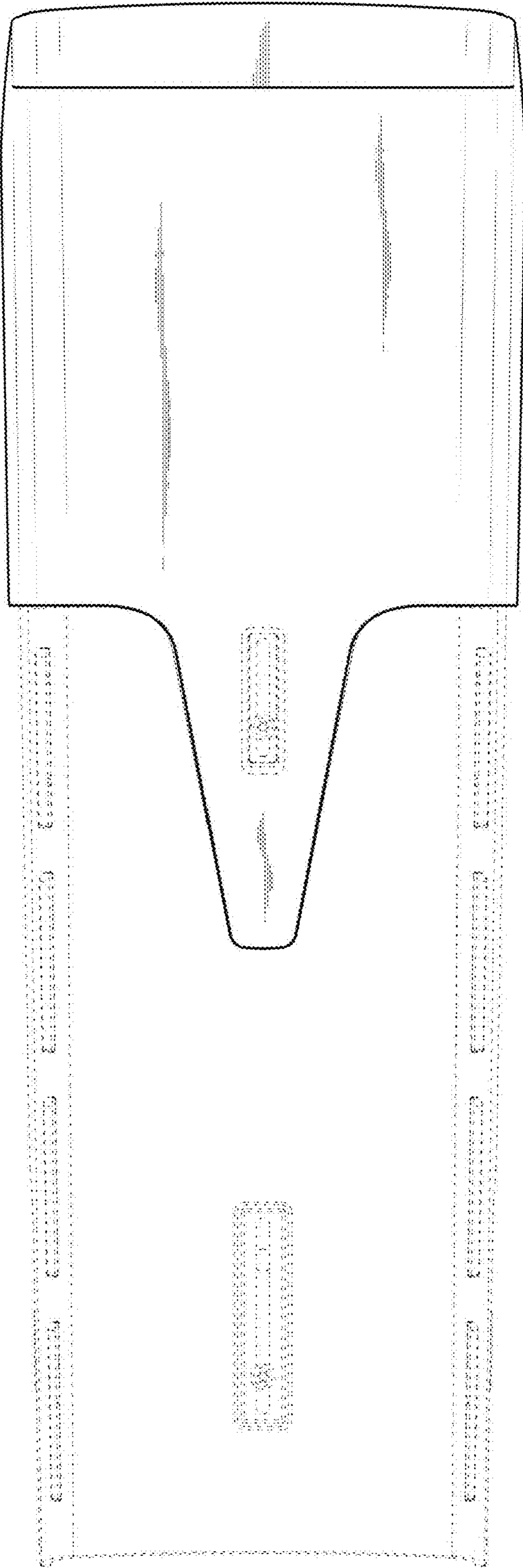

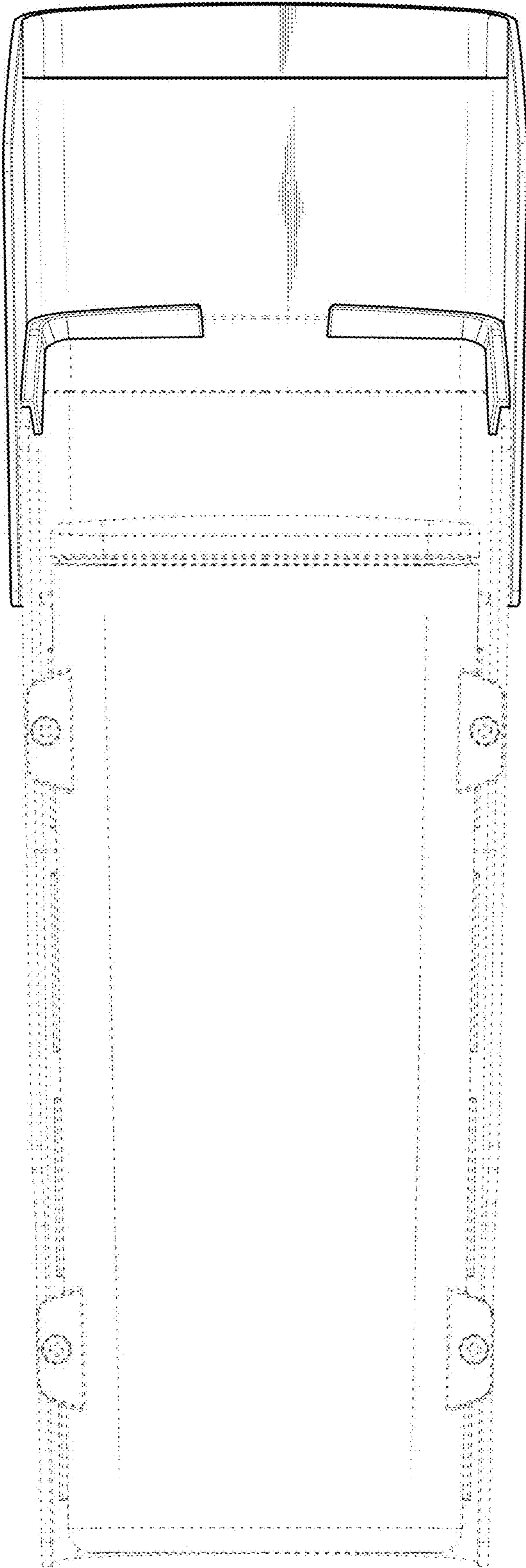
