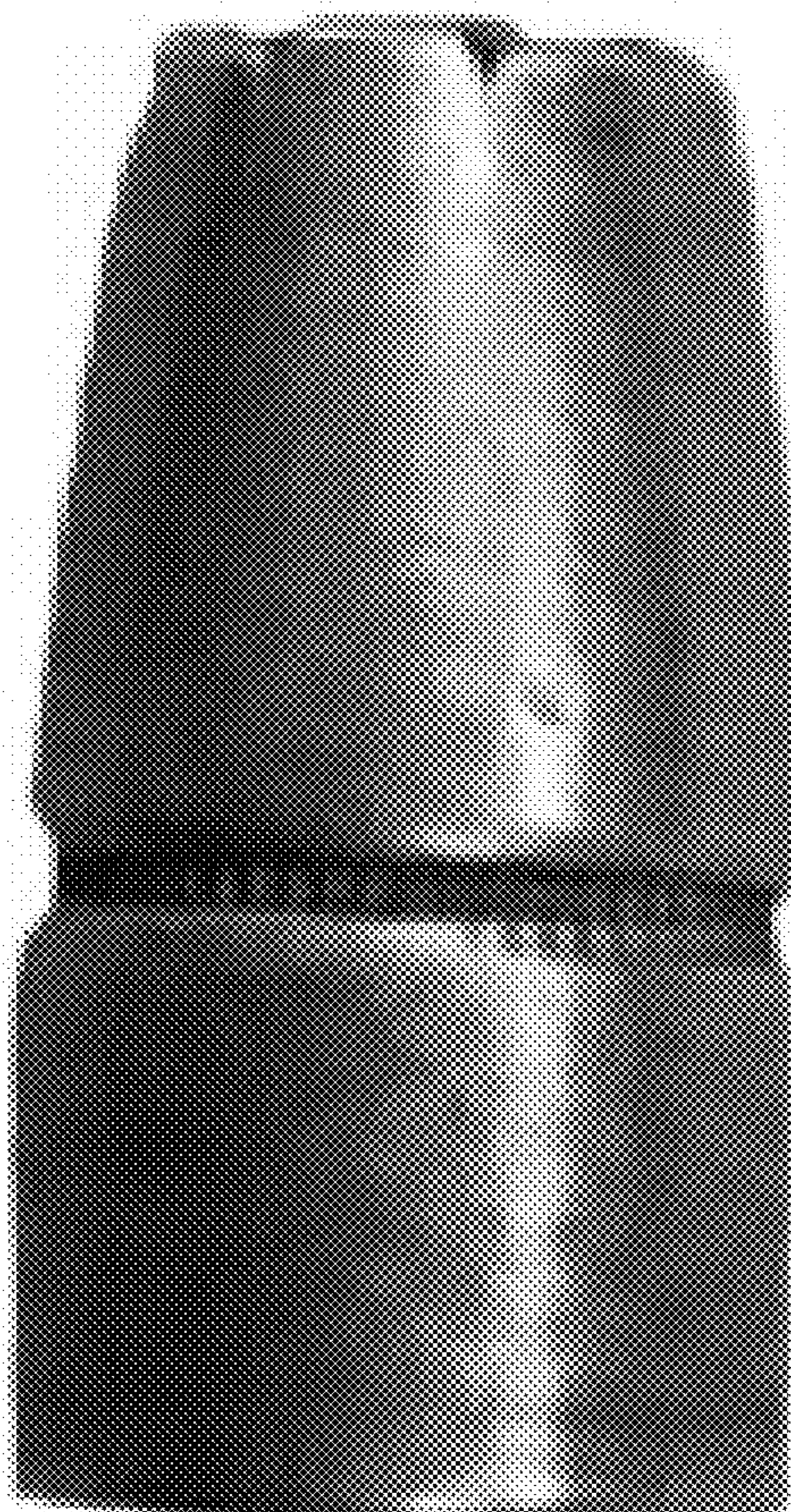
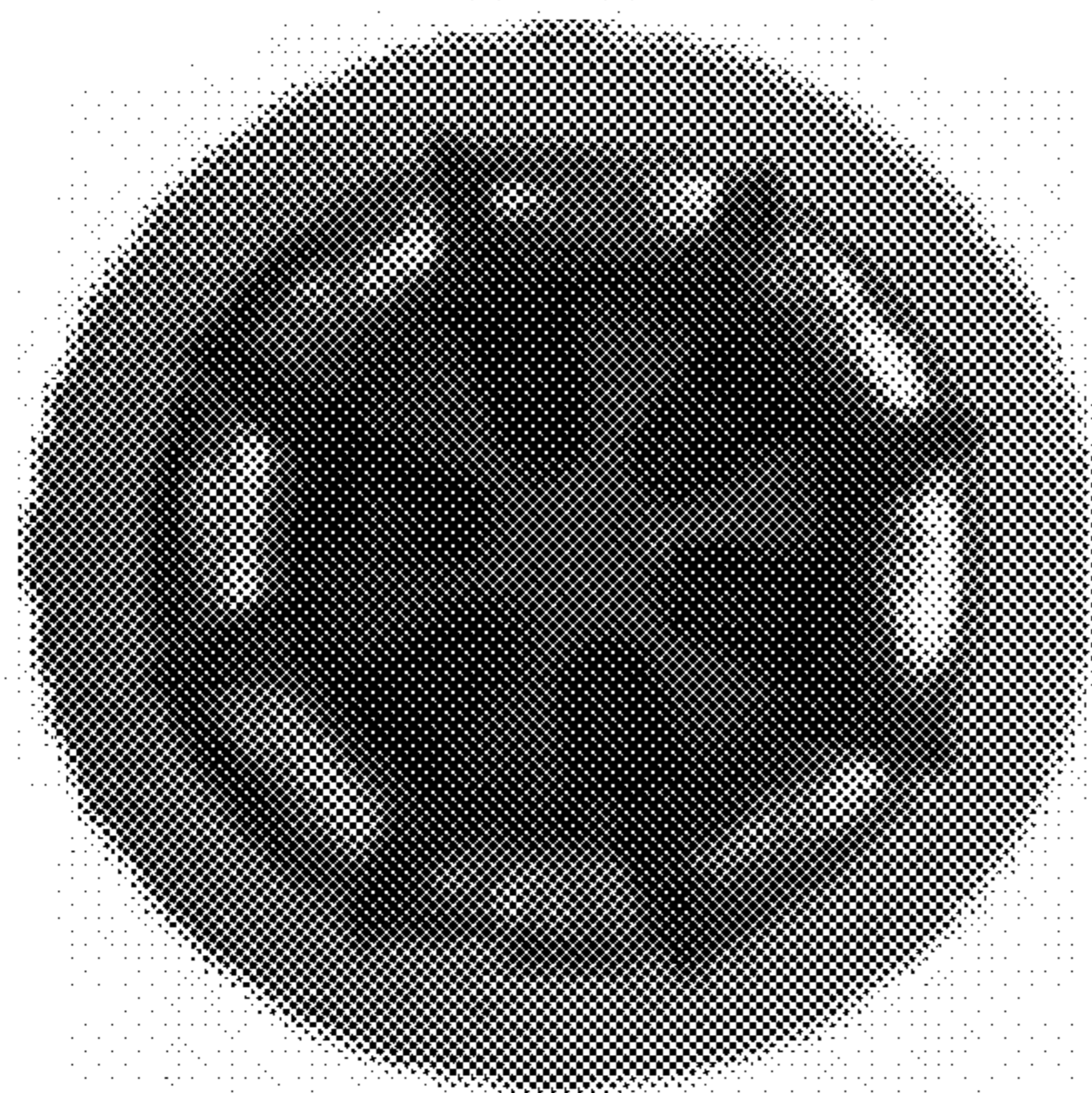
The ornamental design for a bullet, as shown and described.

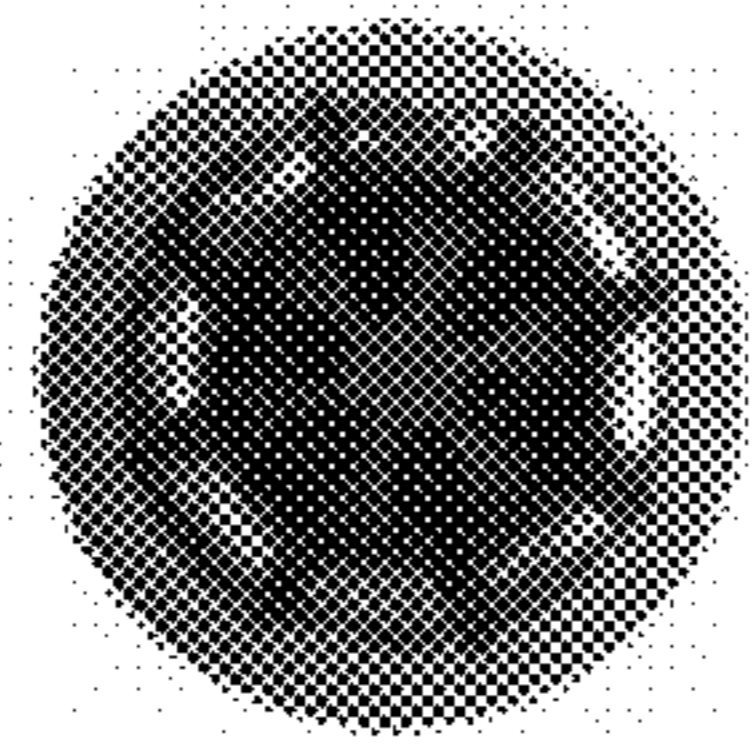

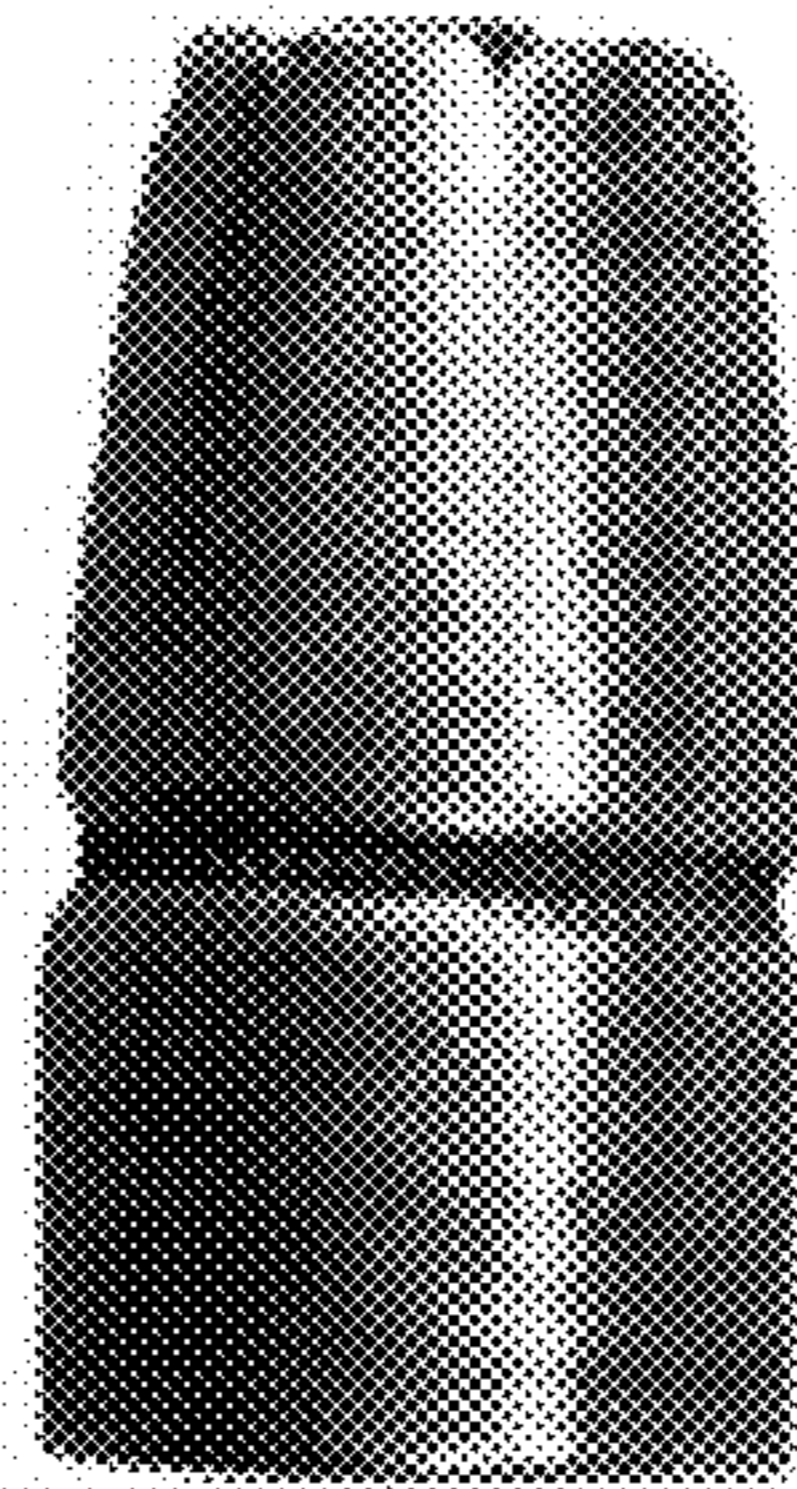

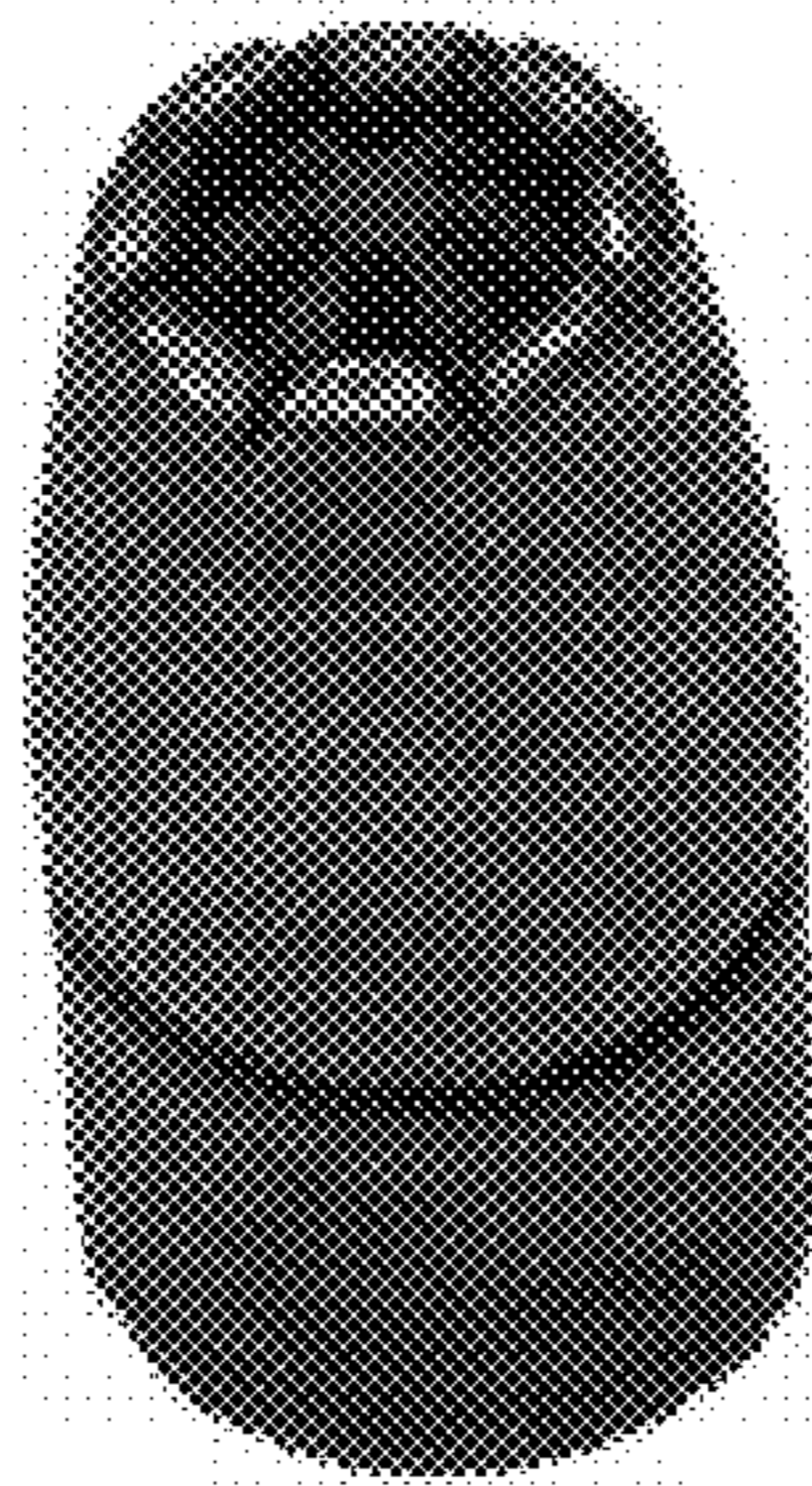
