(57) **CLAIM**

The ornamental design for a gutter guard assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a gutter guard assembly; FIG. 2 is an enlarged detail view of area 2 taken from FIG. 1;

FIG. 3 is a top plan view of the gutter guard assembly of FIG. 1;

FIG. 4 is a bottom plan view of the gutter guard assembly of FIG. 1;

FIG. 5 is a left-side elevation view of the gutter guard assembly of FIG. 1;

FIG. 6 is an enlarged detailed view of area 6 taken from FIG. 5, which is representative of the series of equivalent features illustrated in FIG. 5;

FIG. 7 is a right-side elevation view of the gutter guard assembly of FIG. 1;

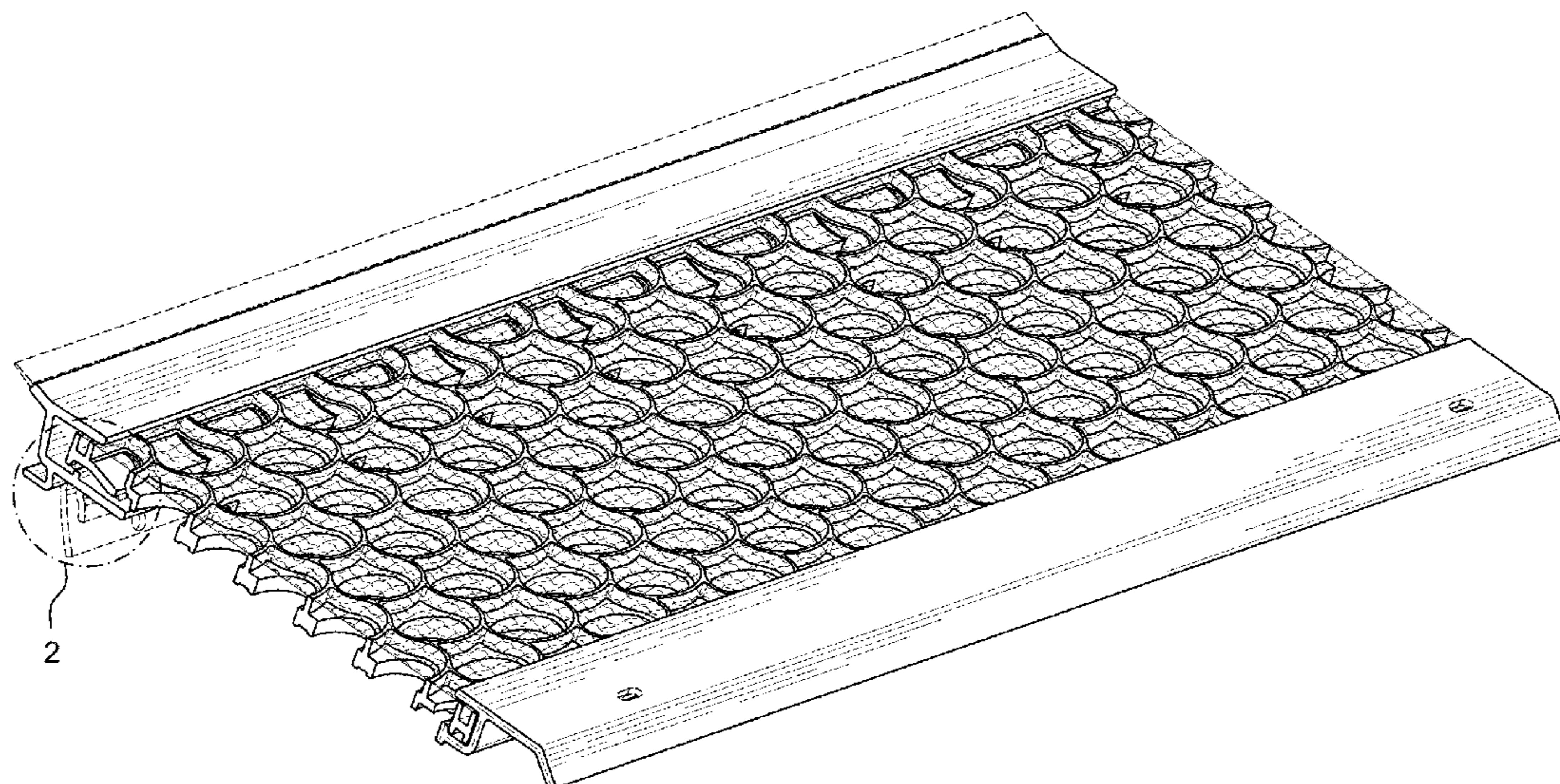
FIG. 8 is an enlarged detailed view of area 8 taken from FIG. 7, which is representative of the series of equivalent features illustrated in FIG. 7;

FIG. 9 is a front elevation view of the gutter guard assembly of FIG. 1; and,

FIG. 10 is a rear elevation view of the gutter guard assembly of FIG. 1.

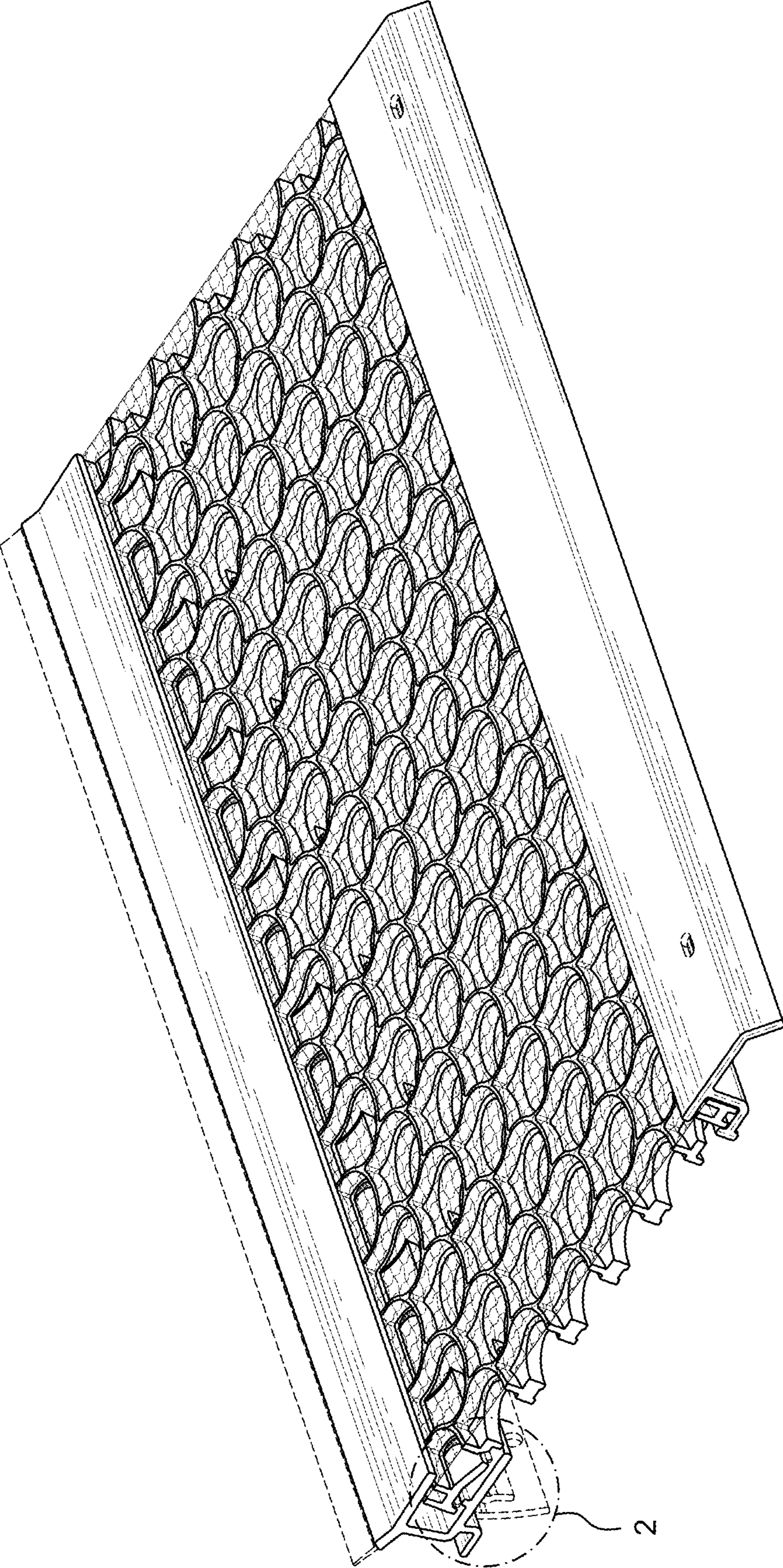

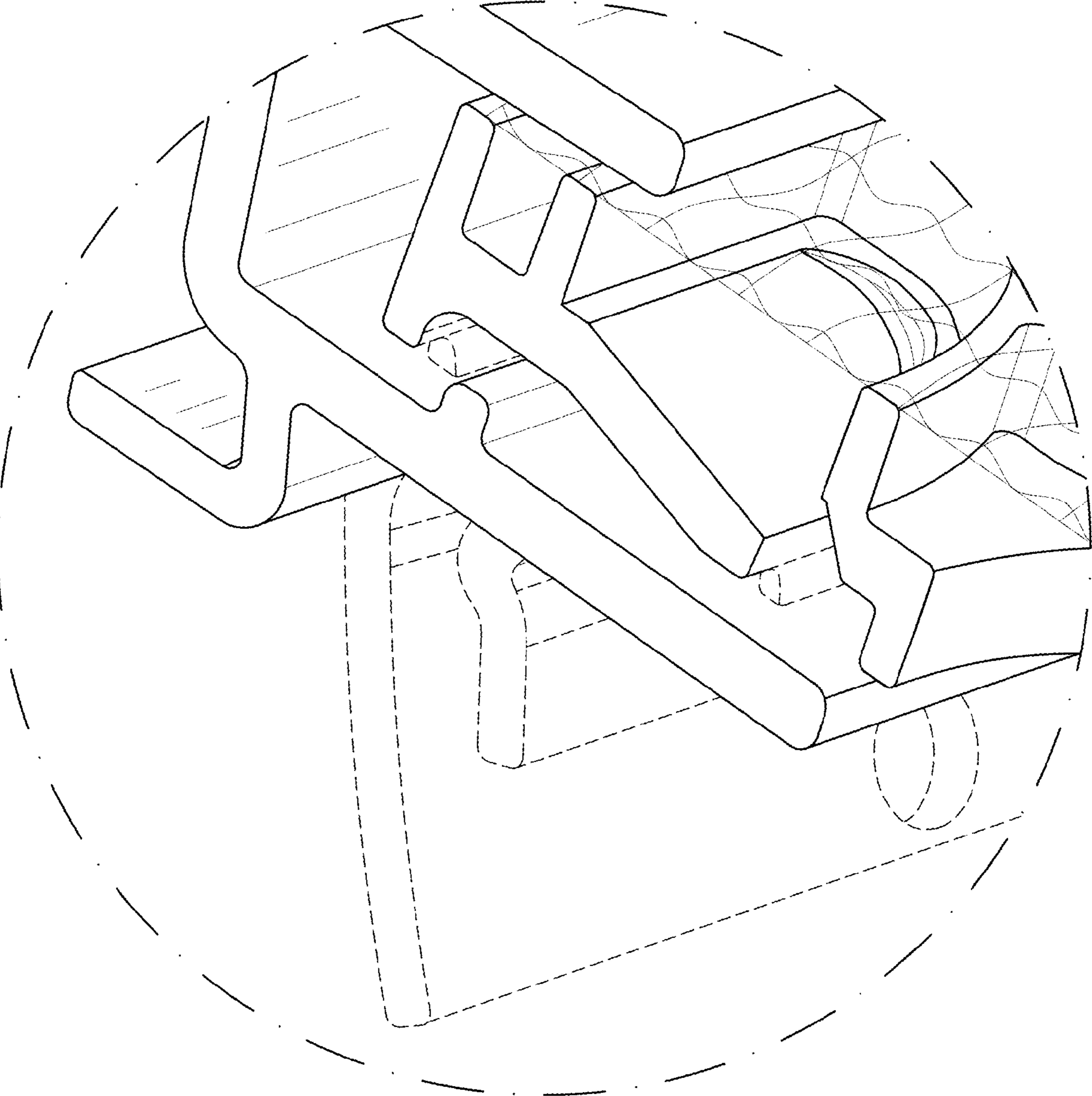

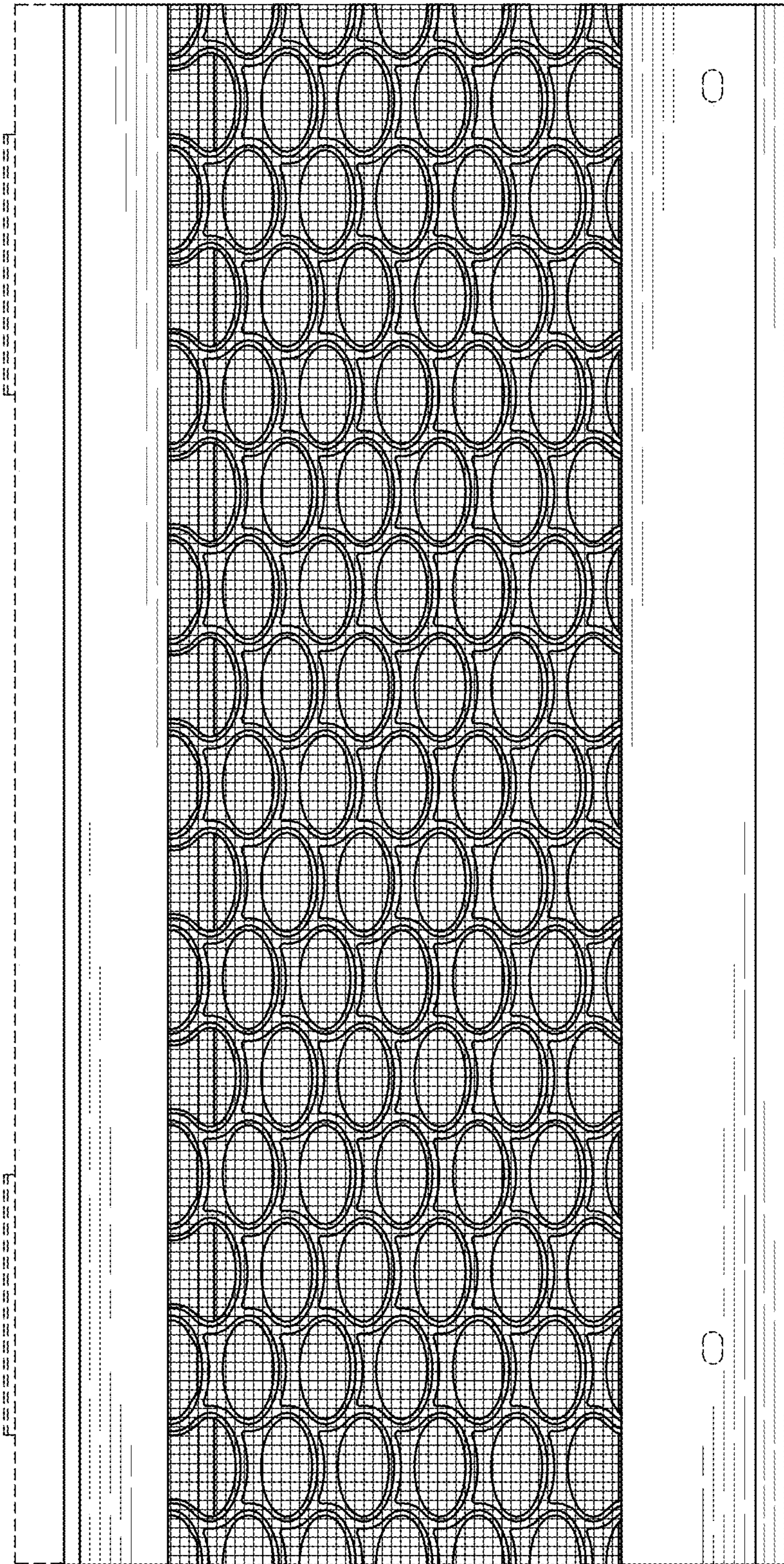

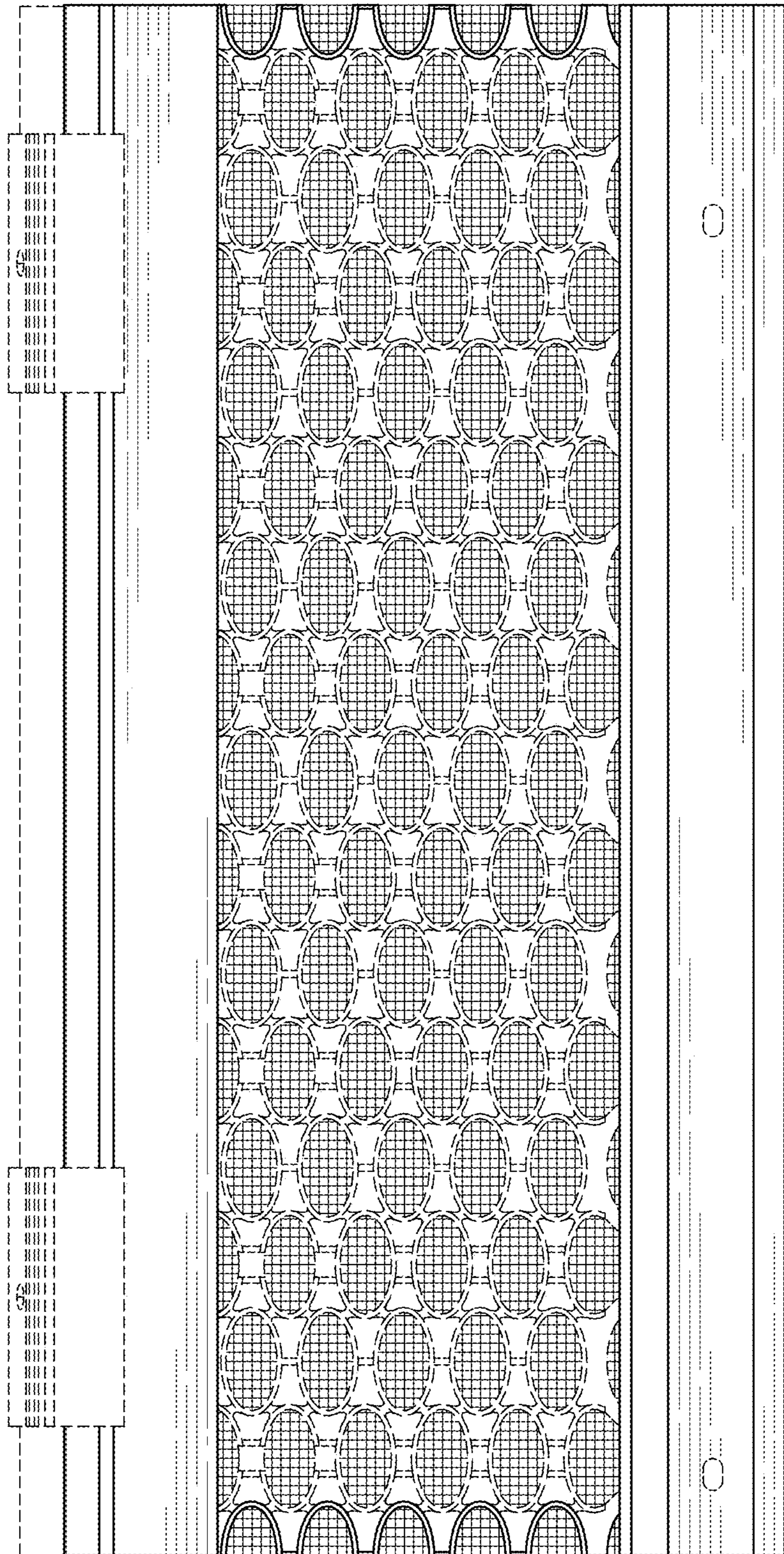

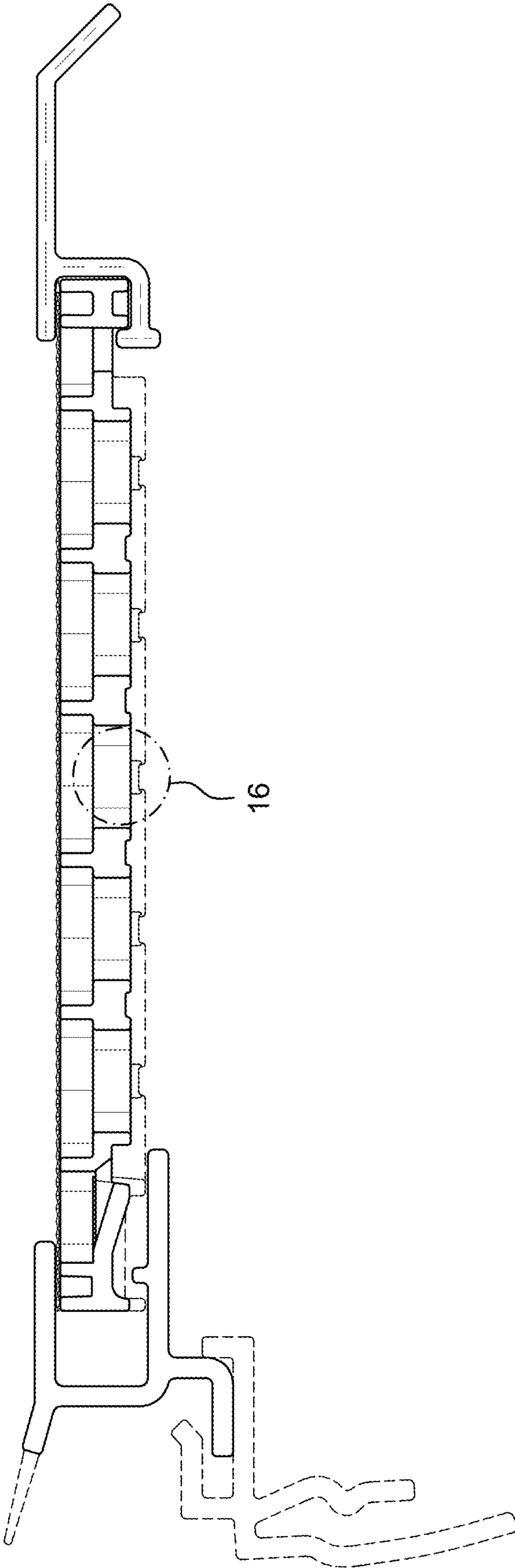

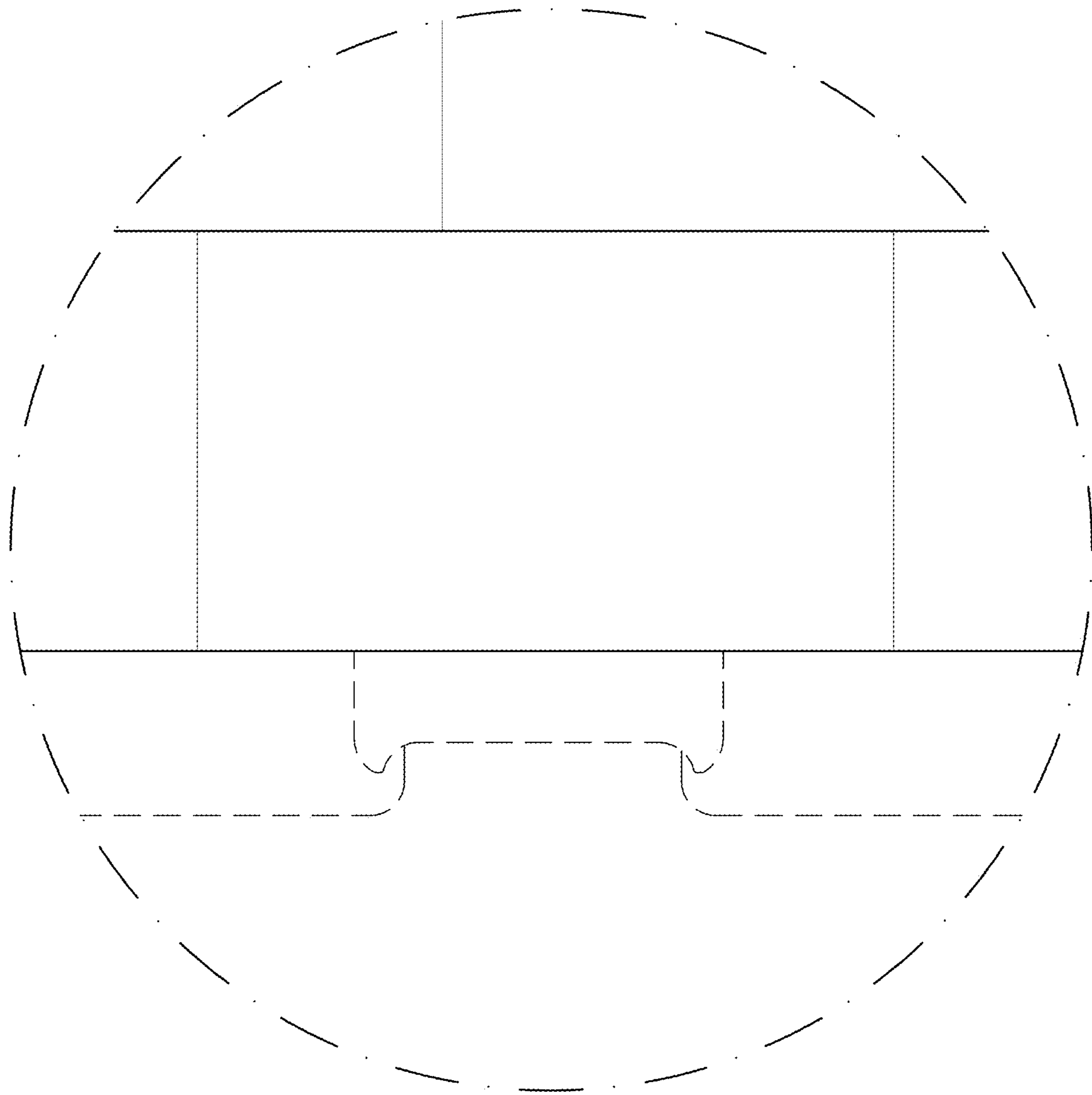

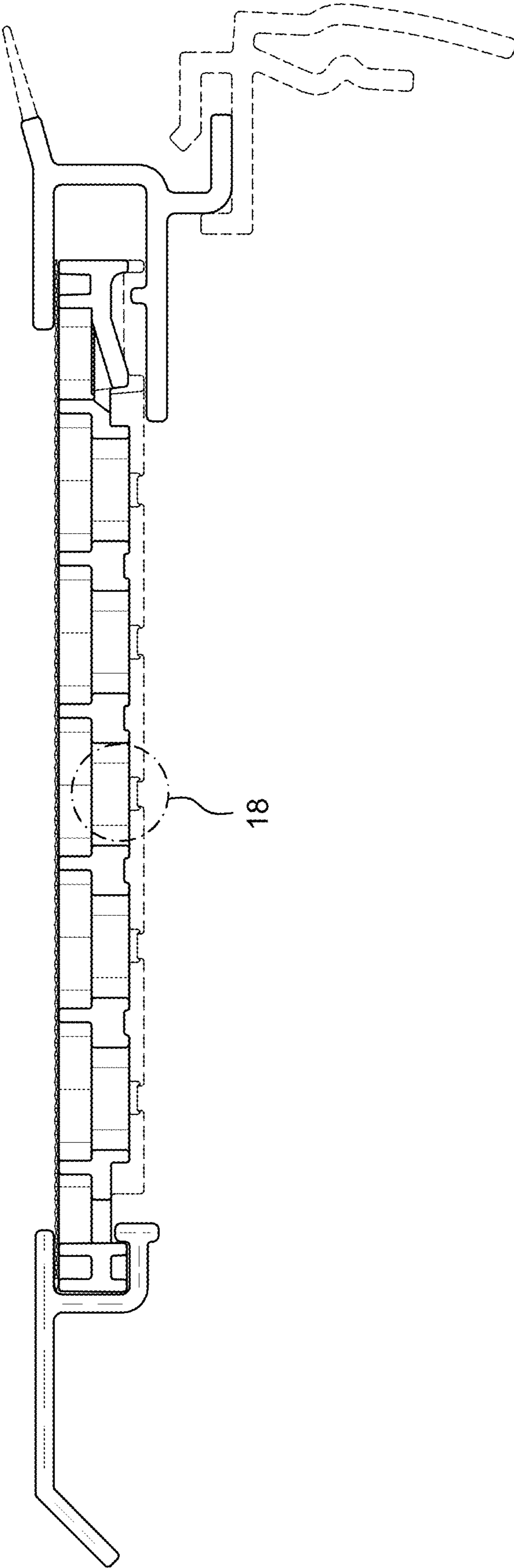

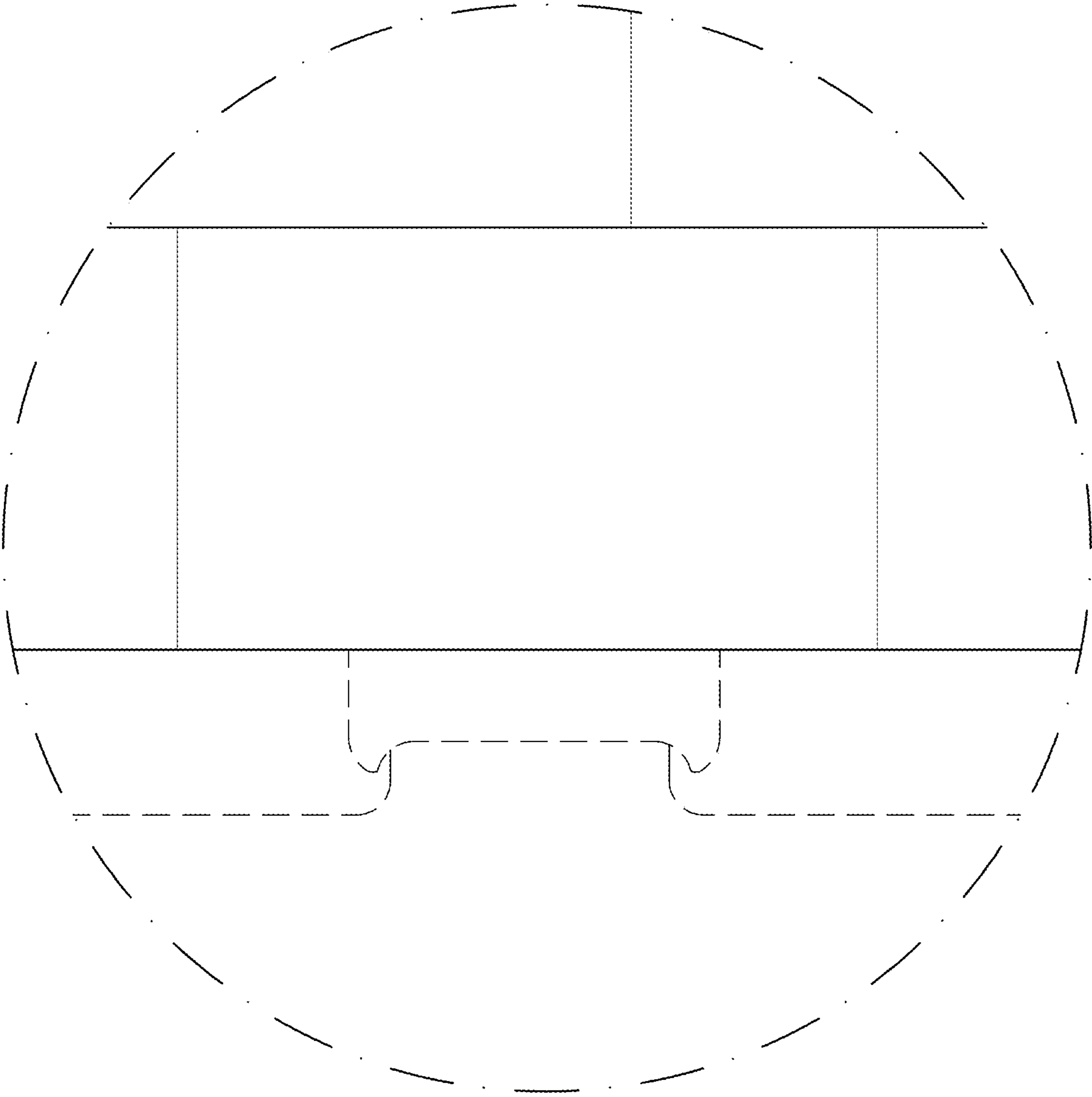

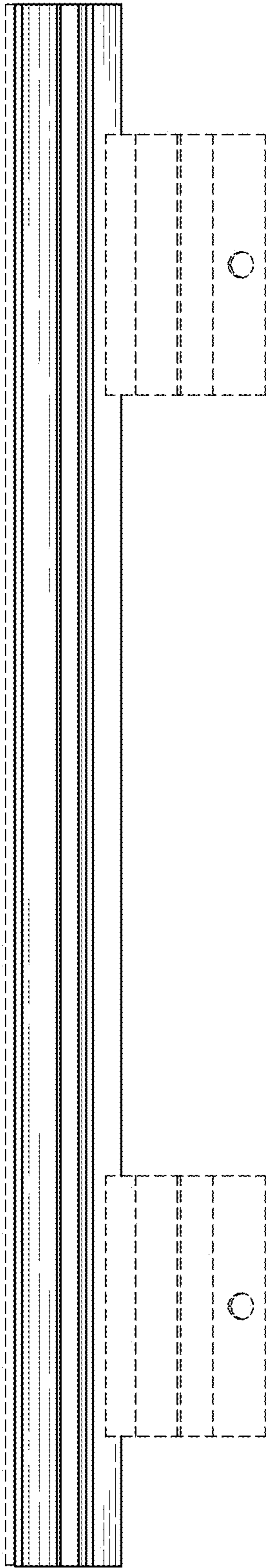

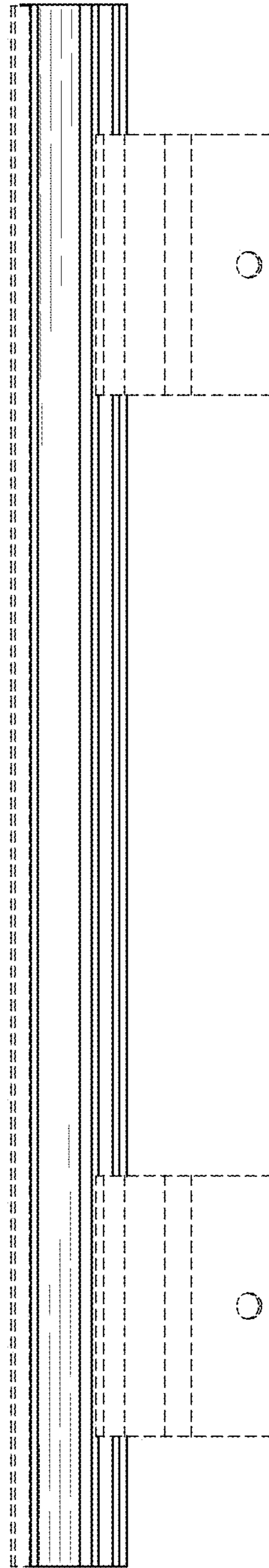
