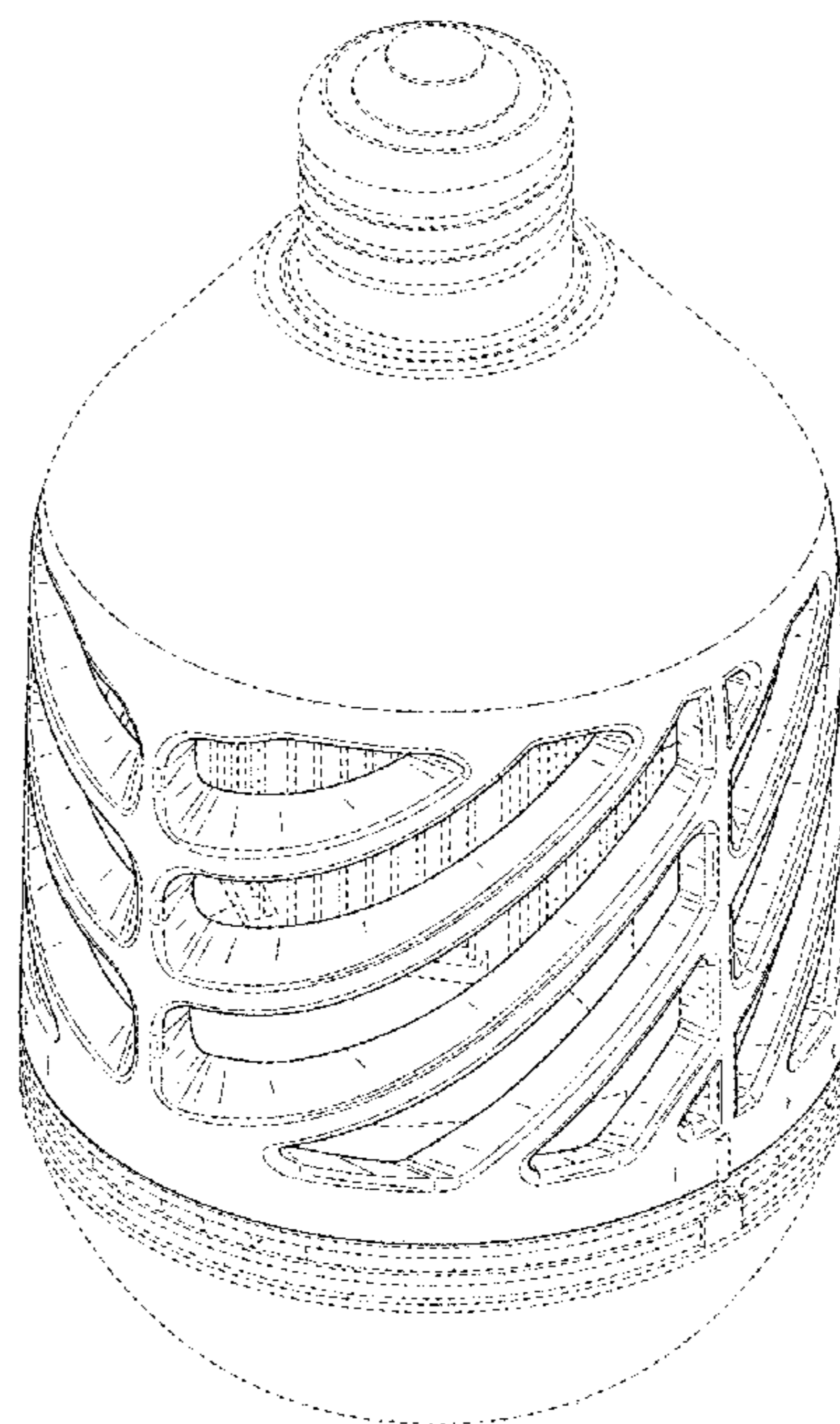
FIG. 1 is a top, rear, left perspective view of an insect killing light bulb showing my new design;

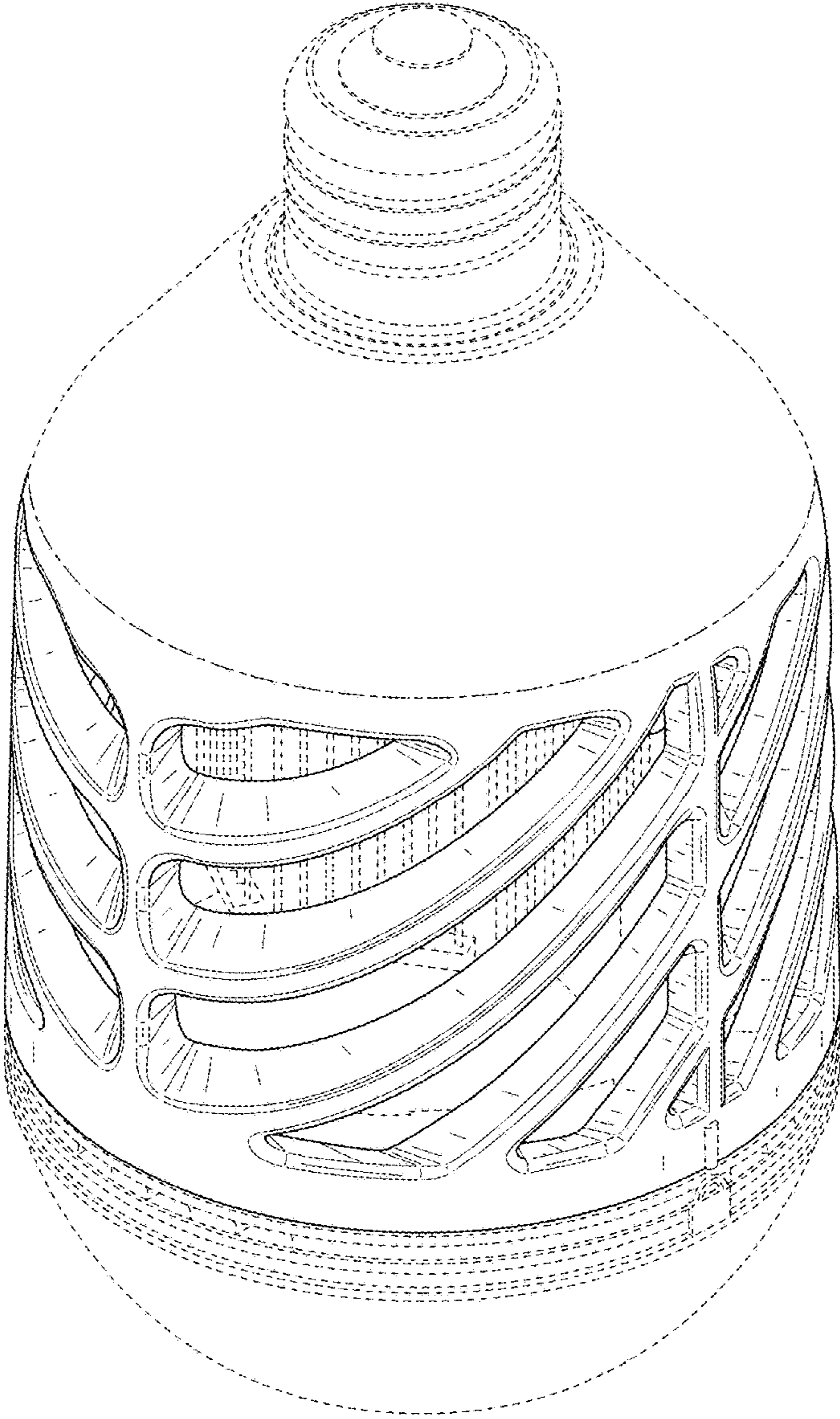

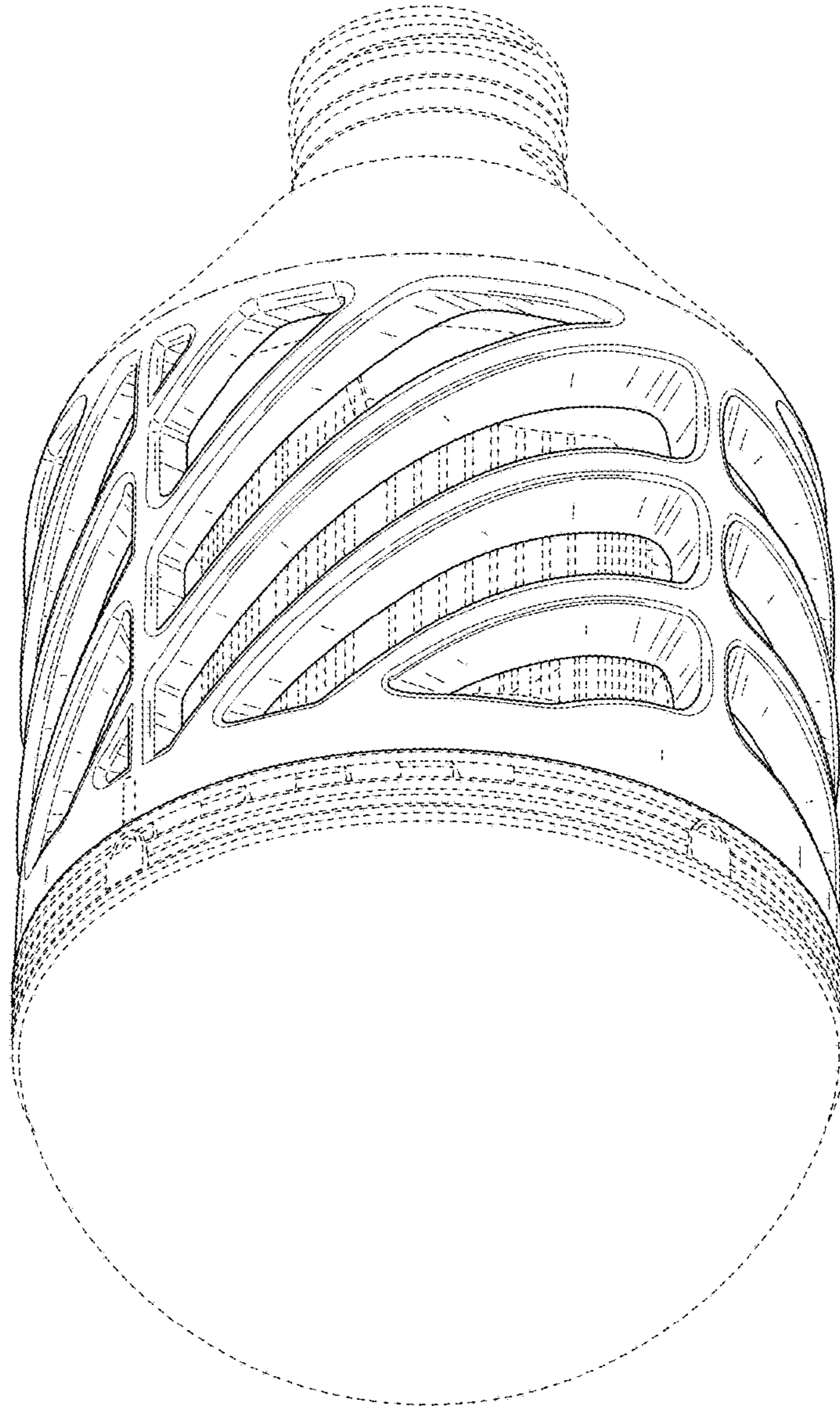

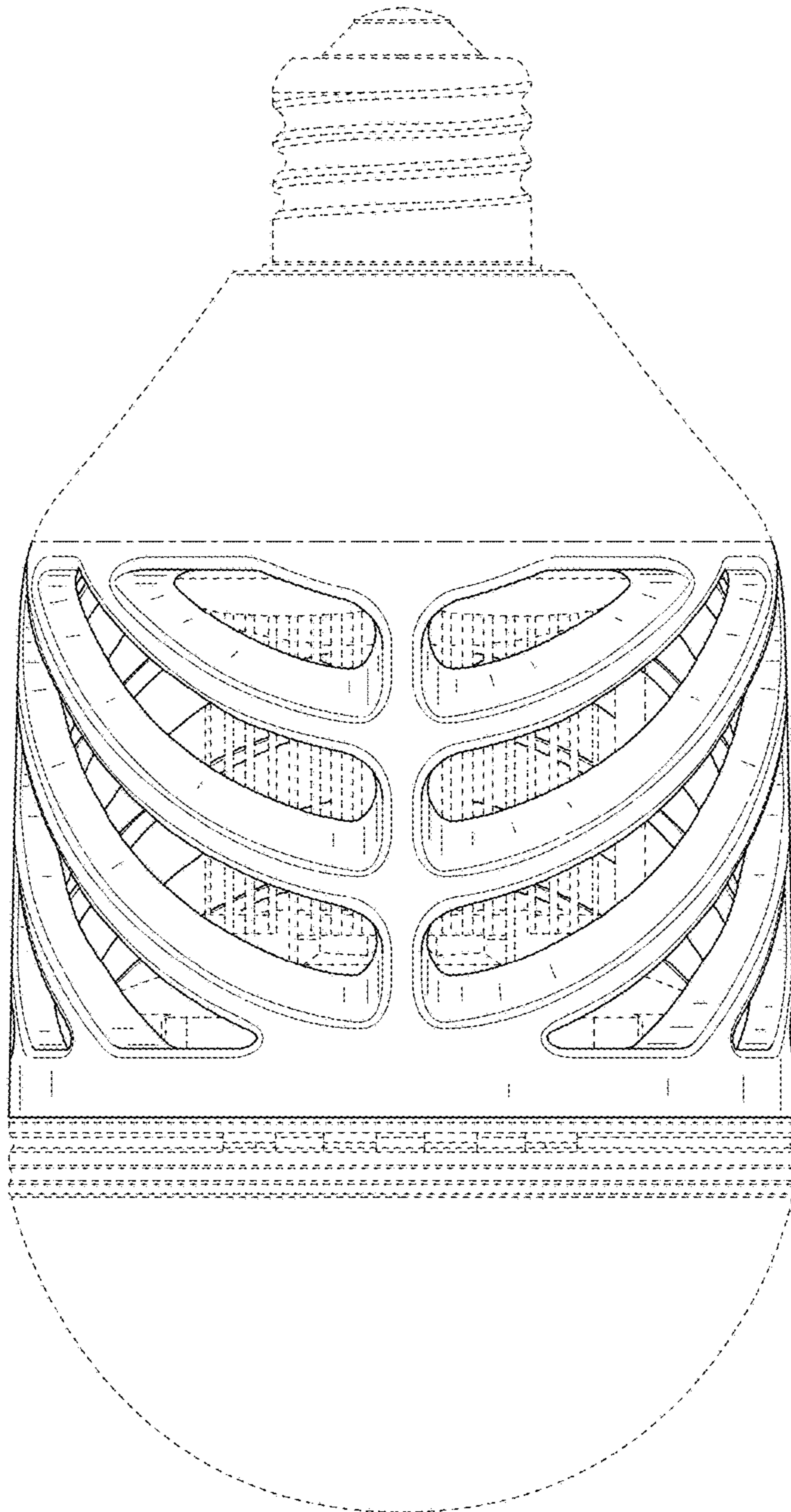

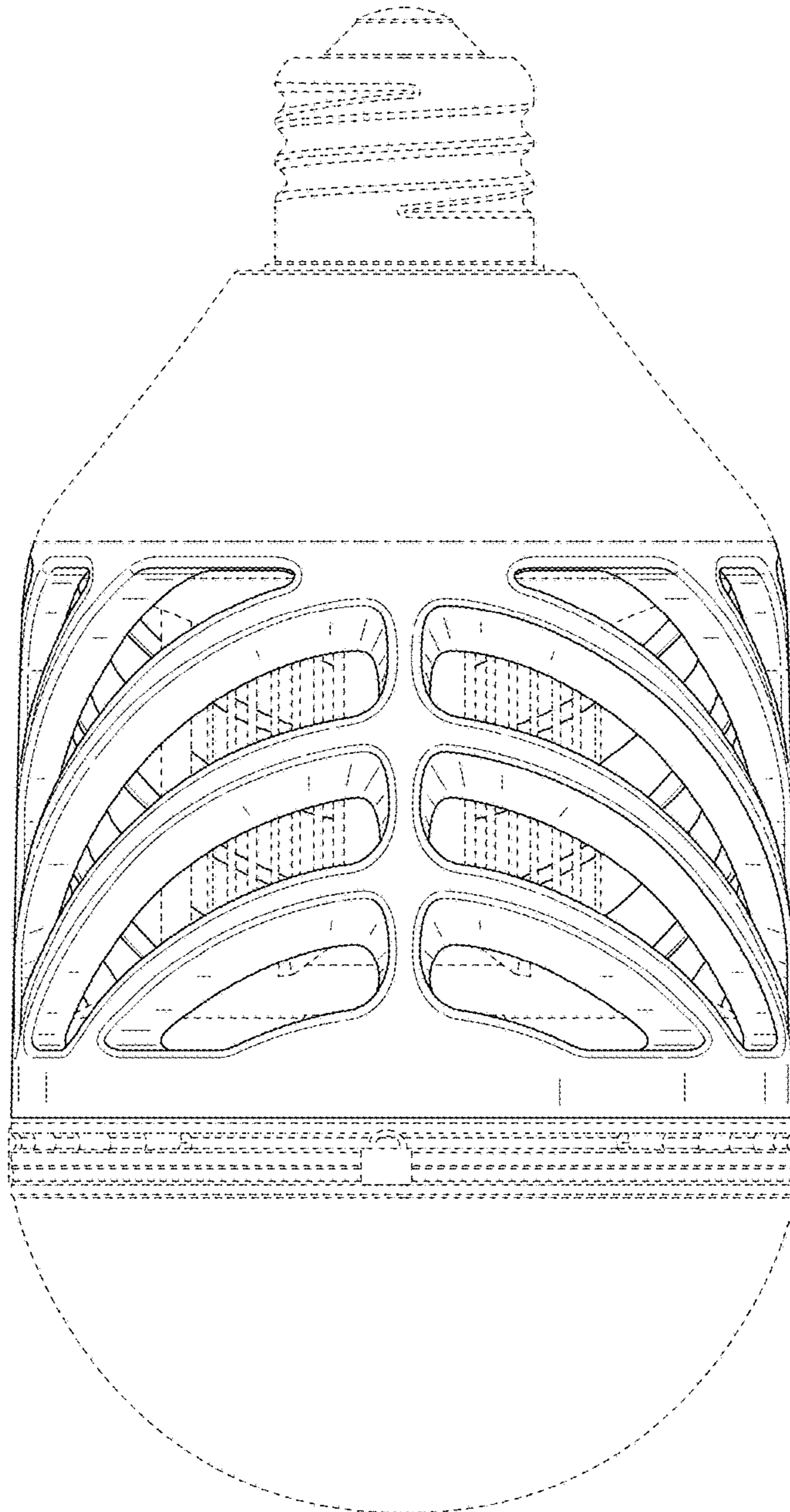

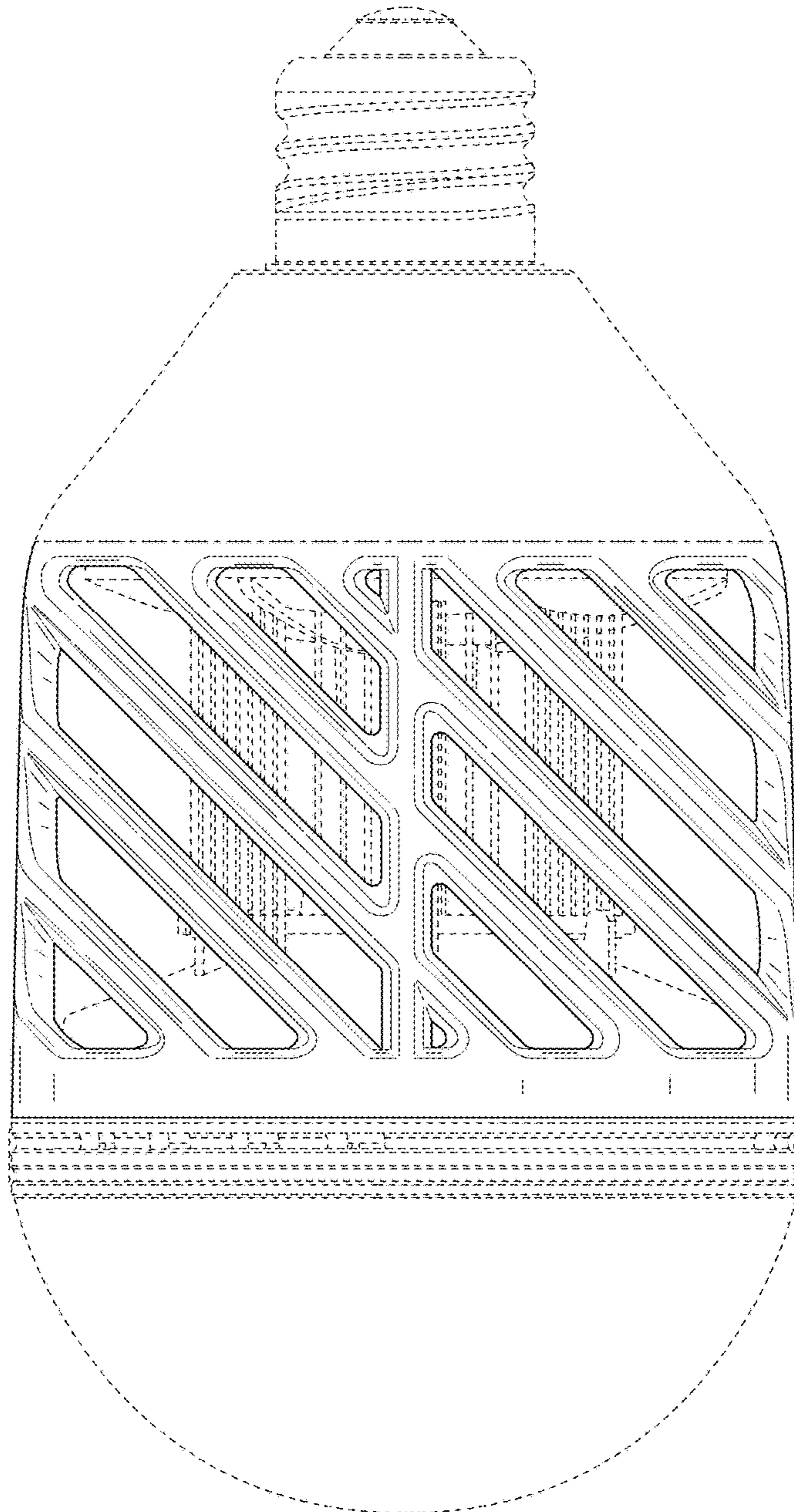

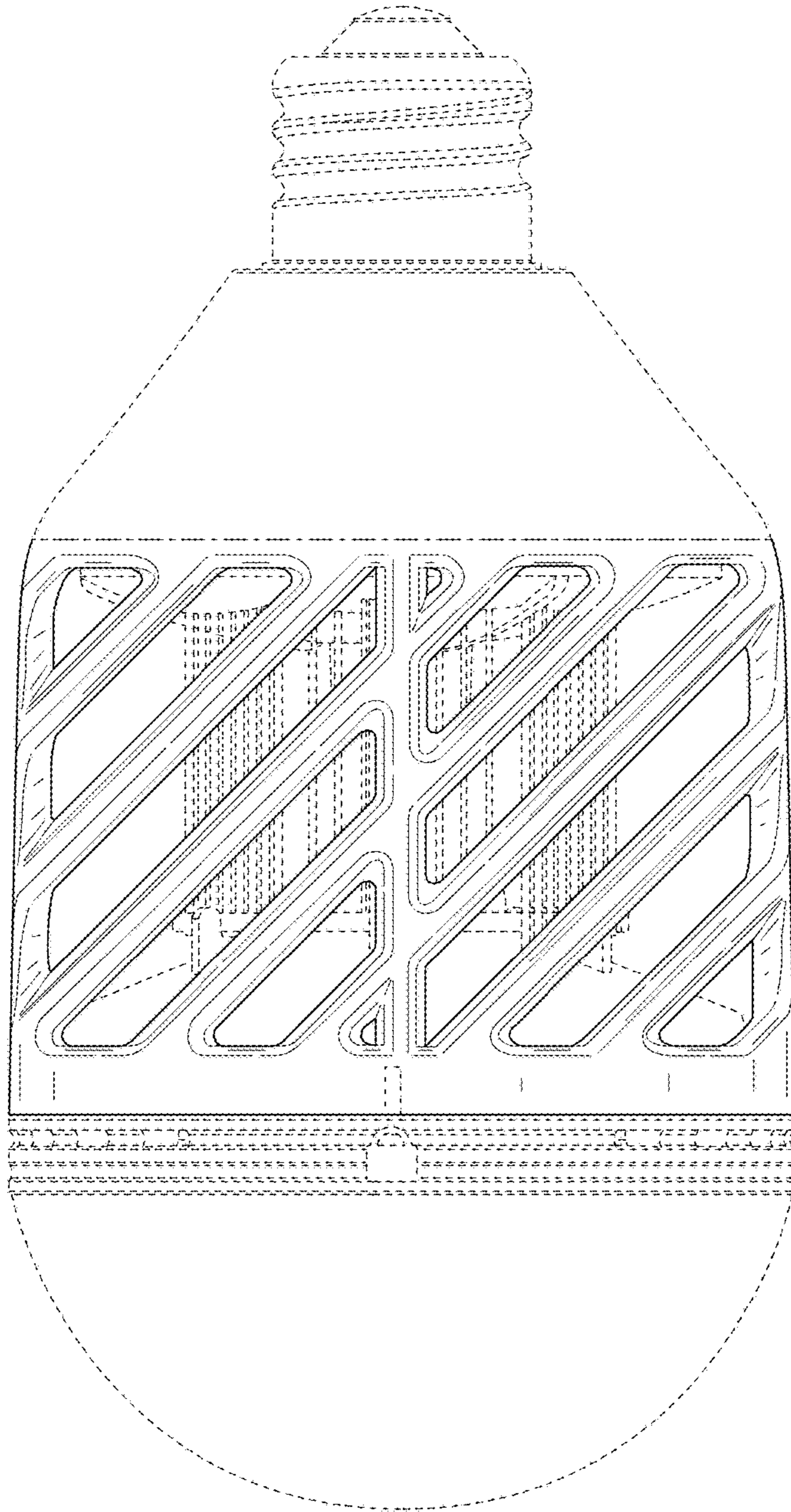

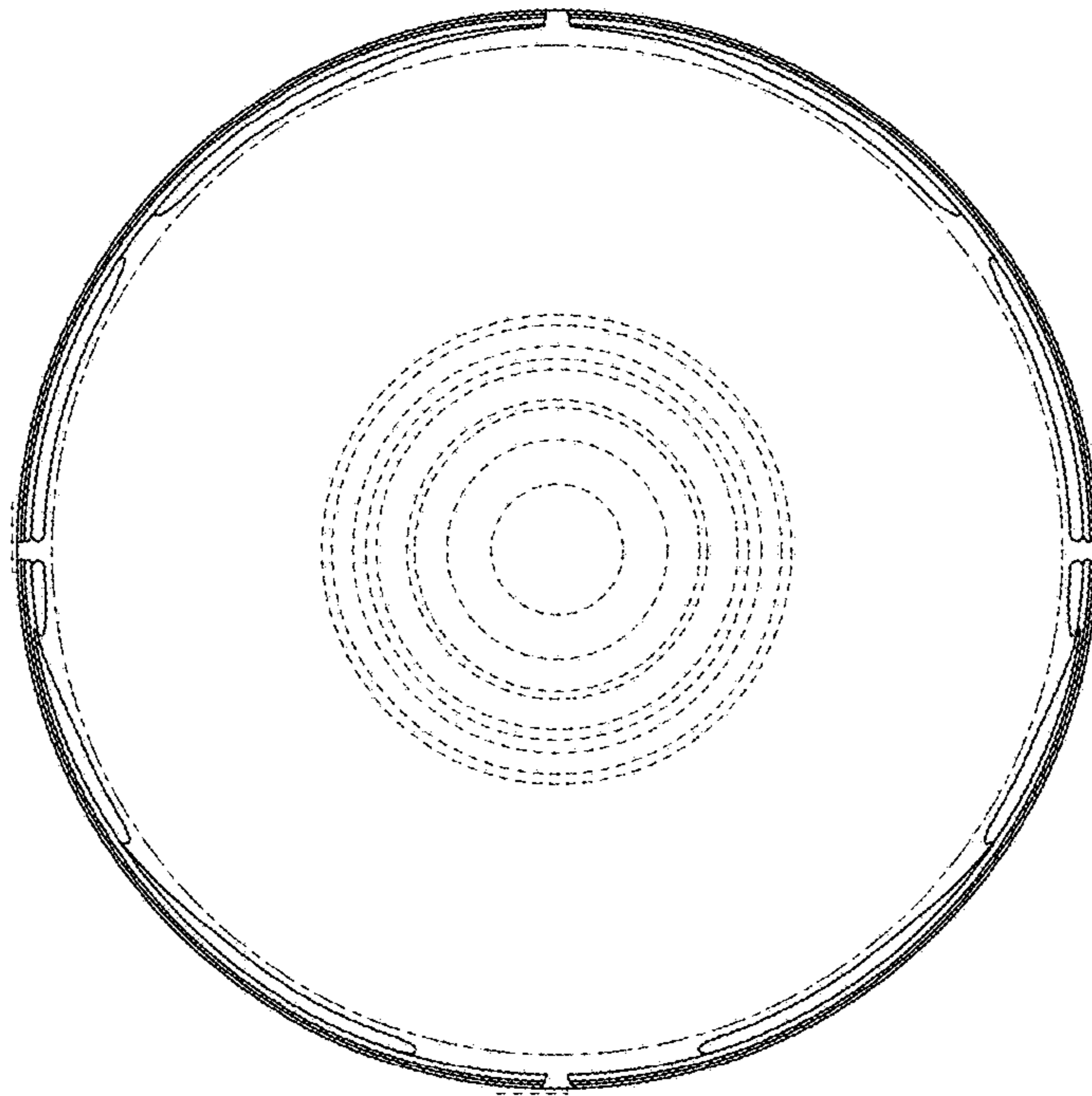

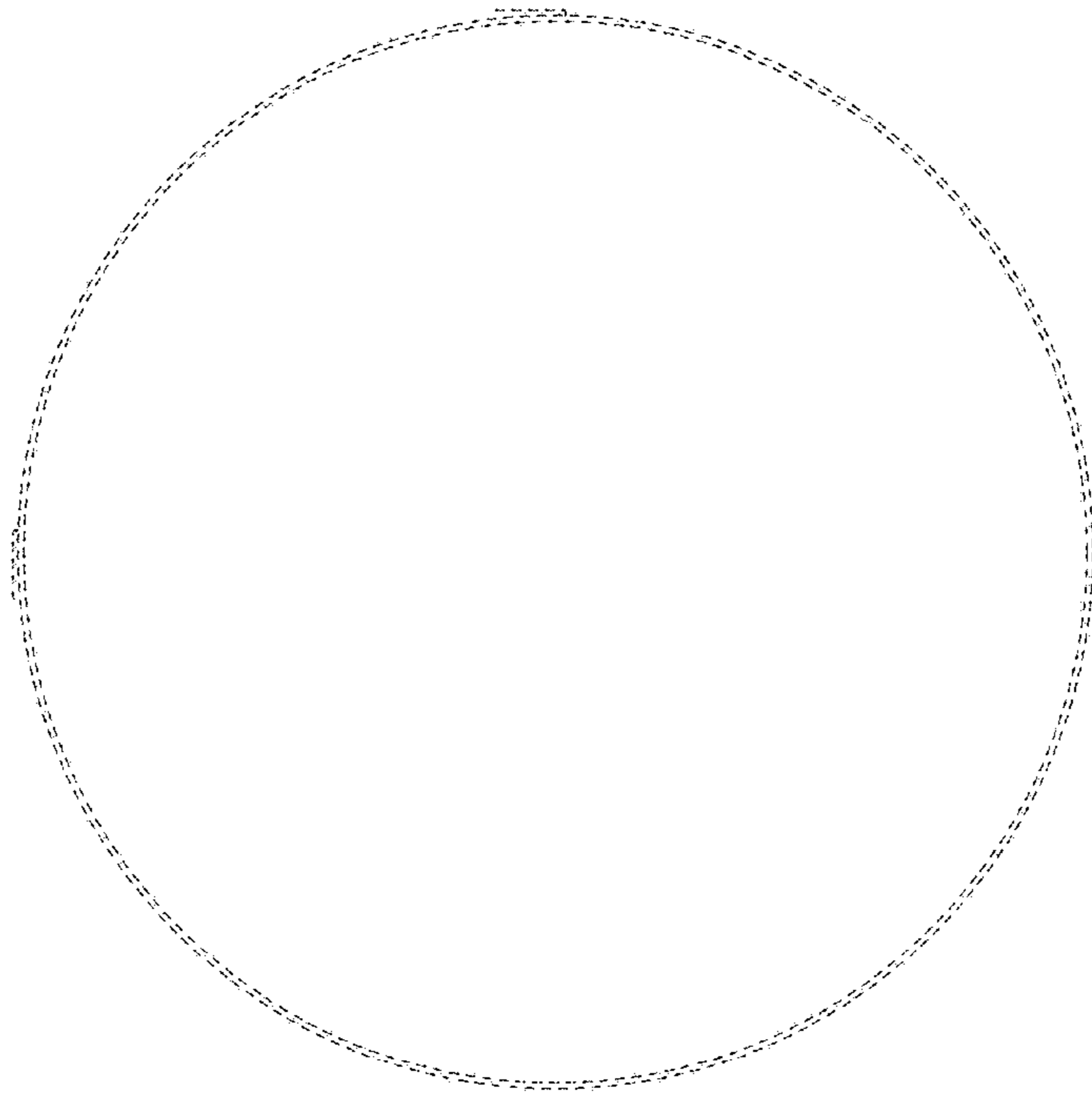
