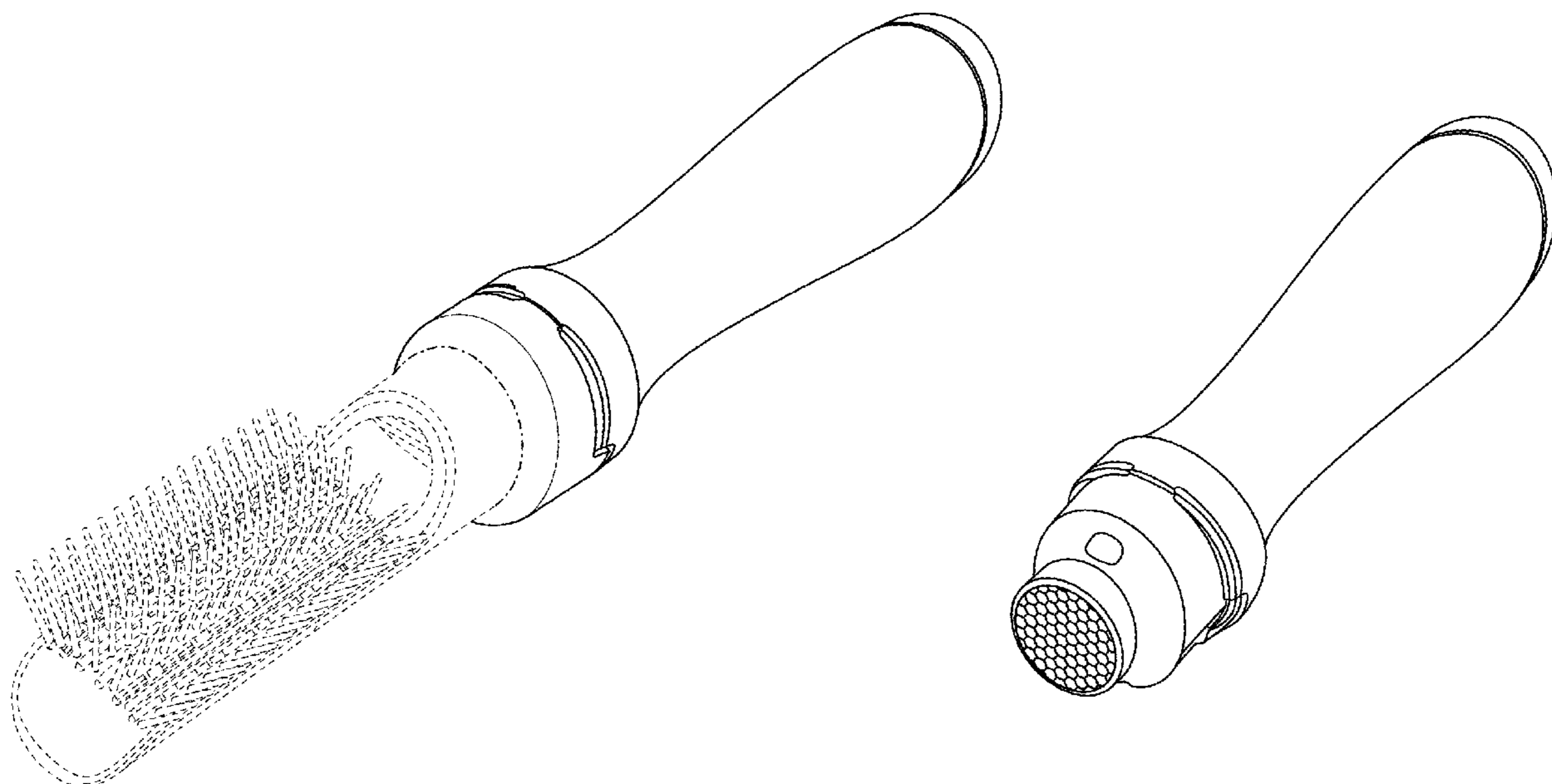
The ornamental design for an hair dryer with hair iron, as shown and described.

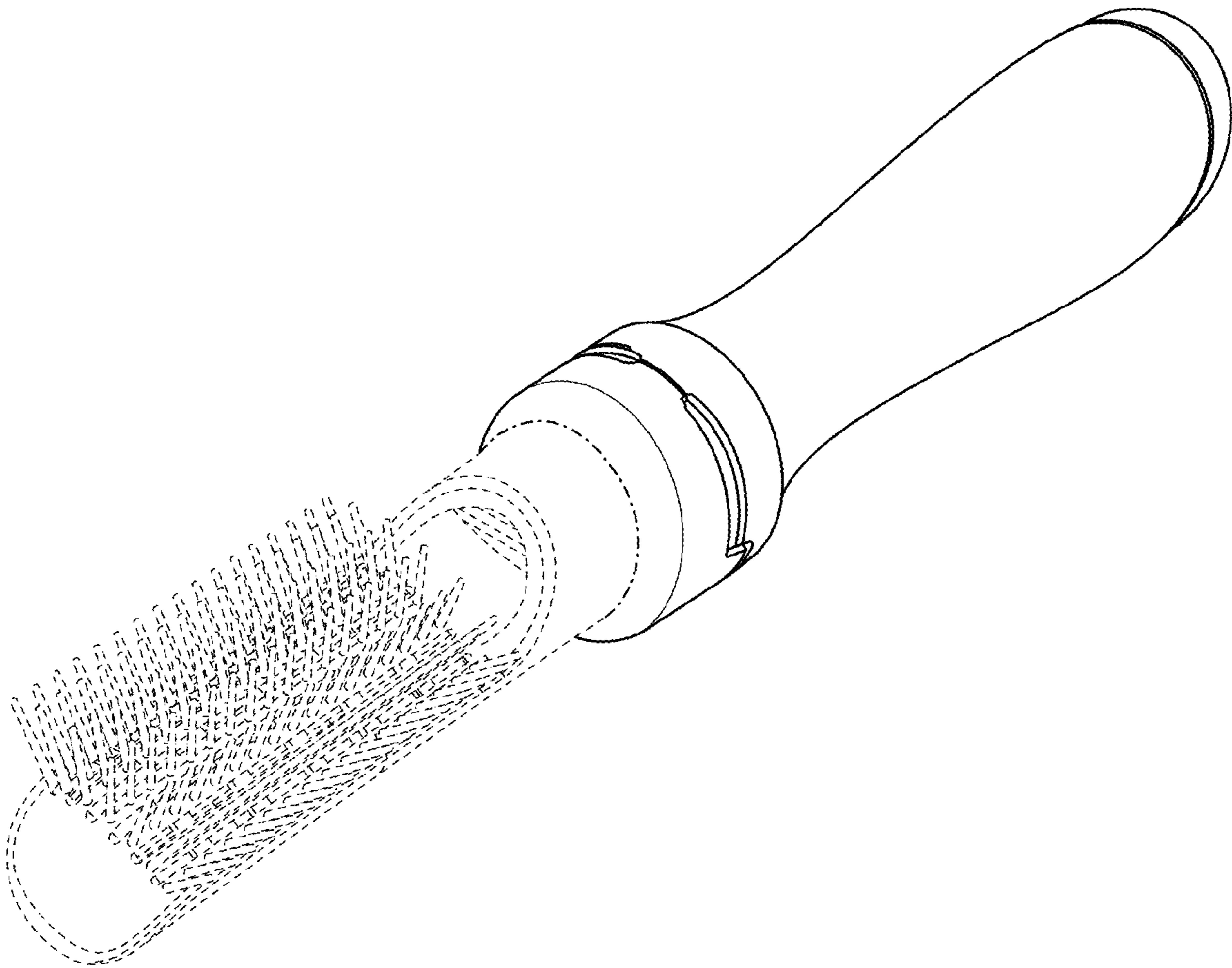

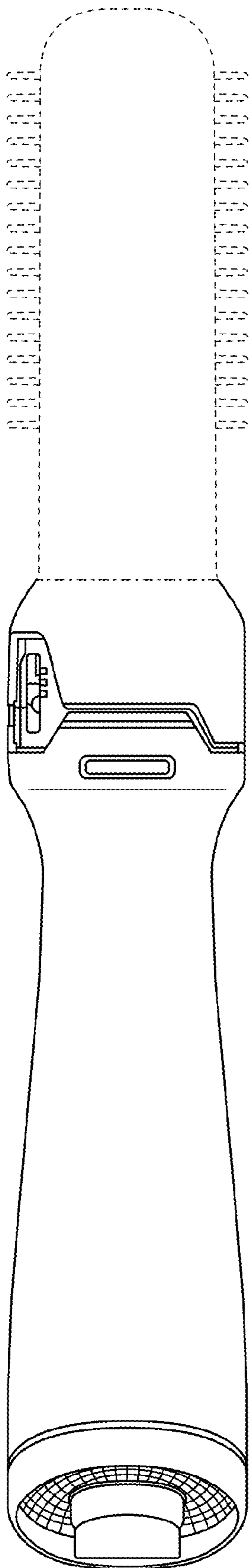

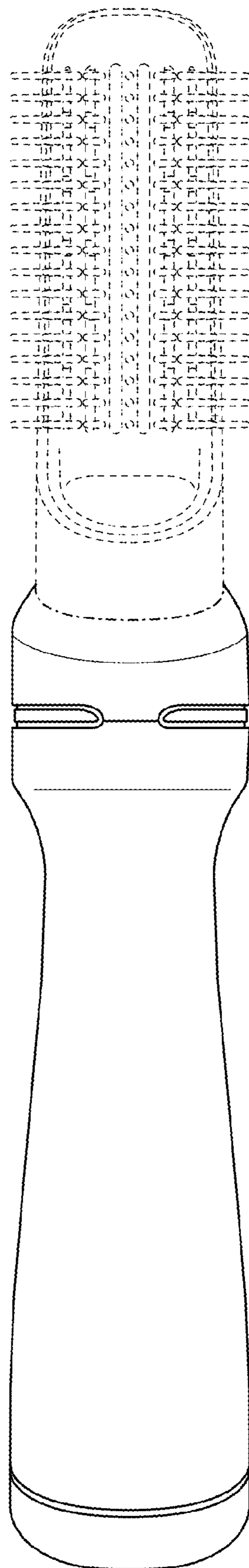

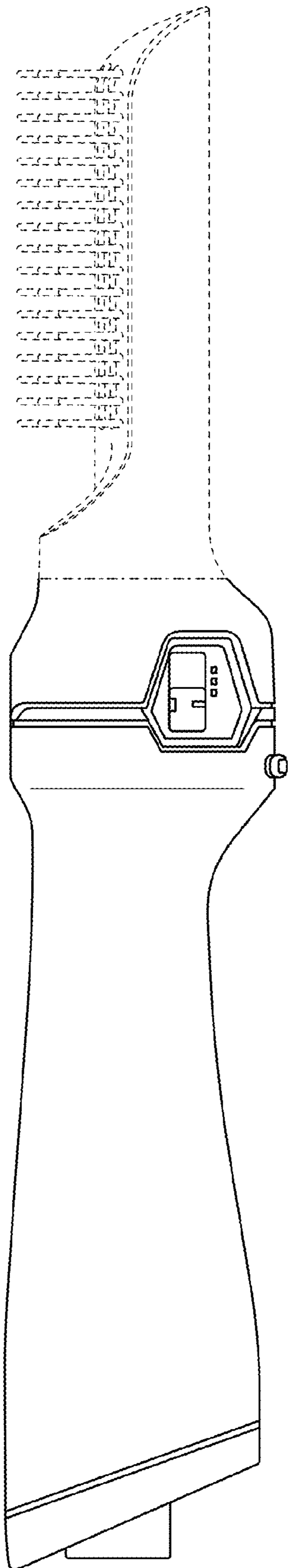

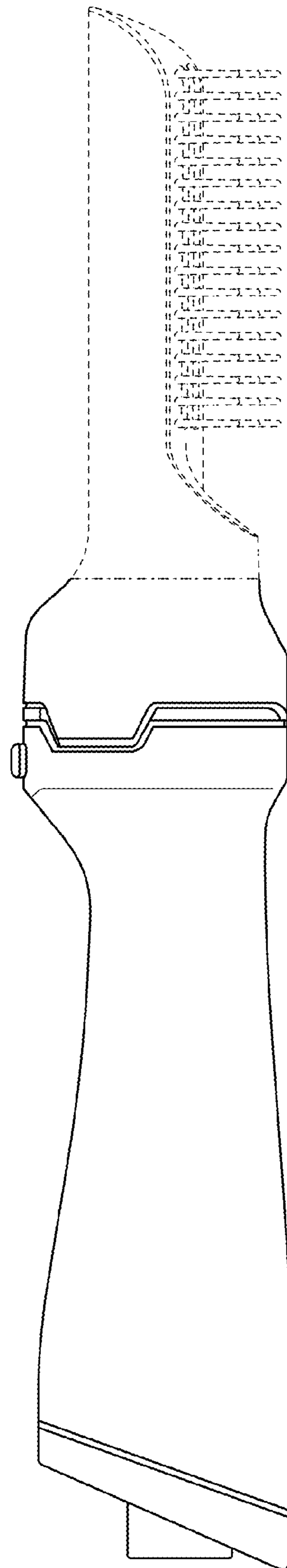

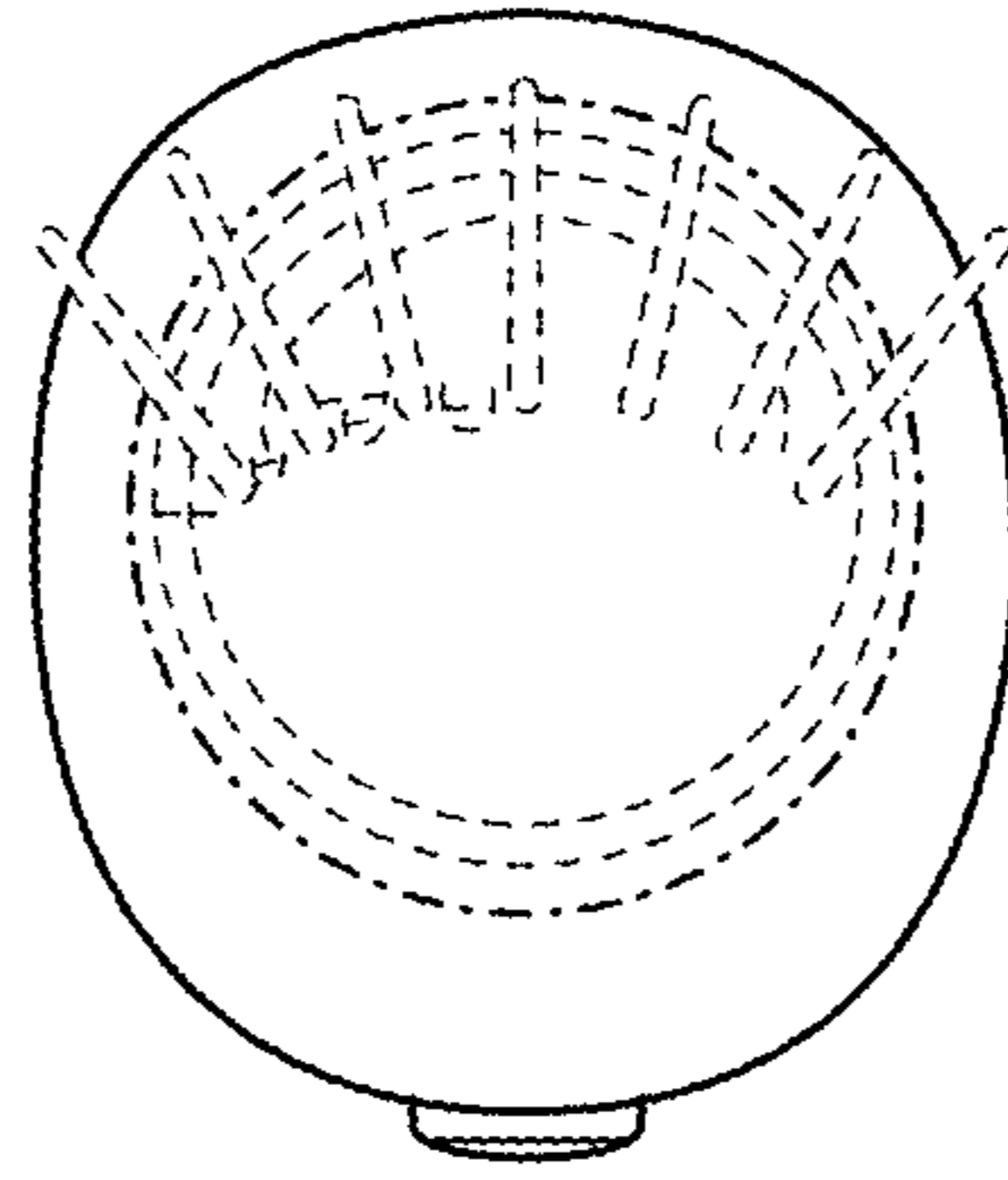

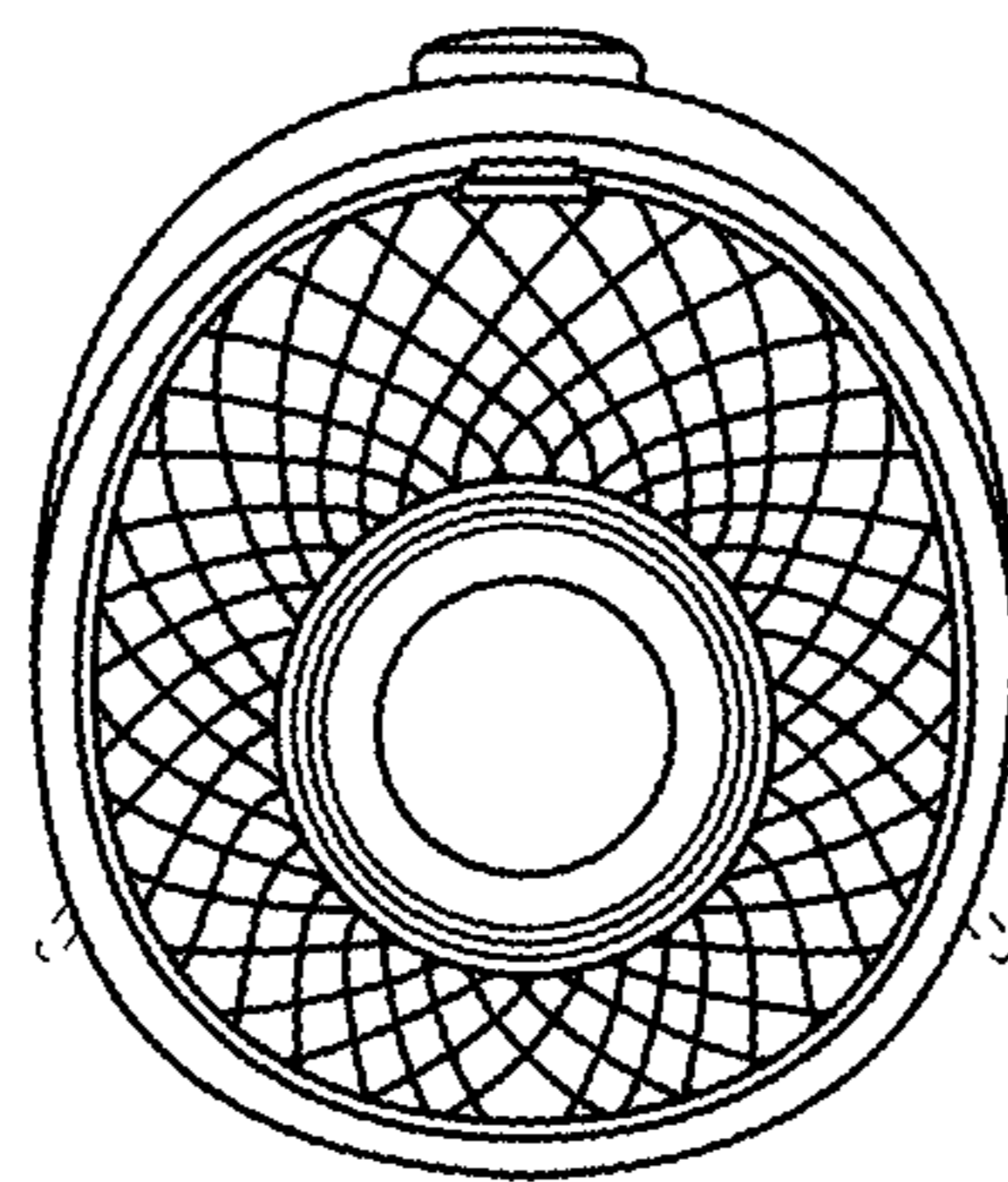

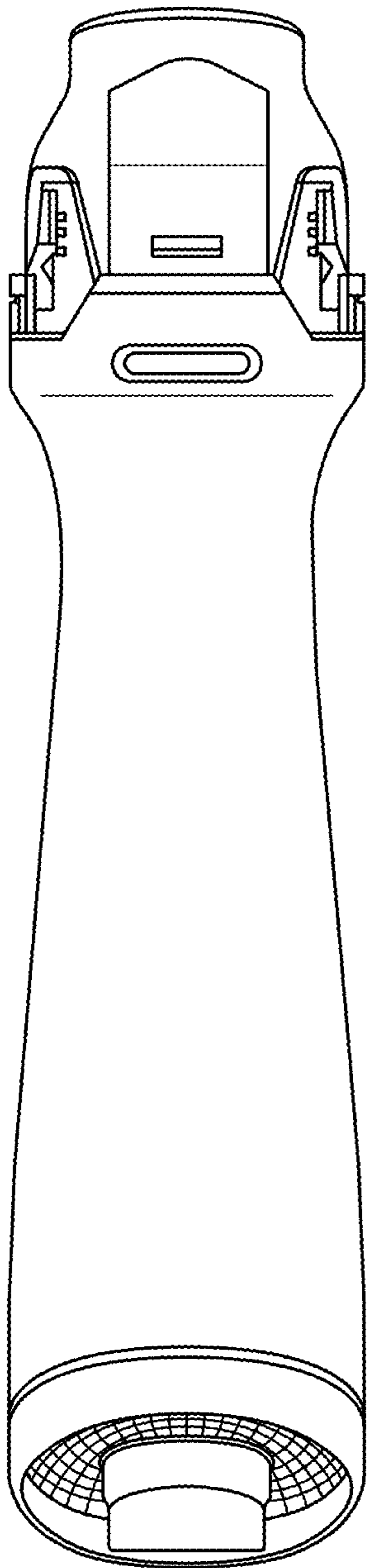

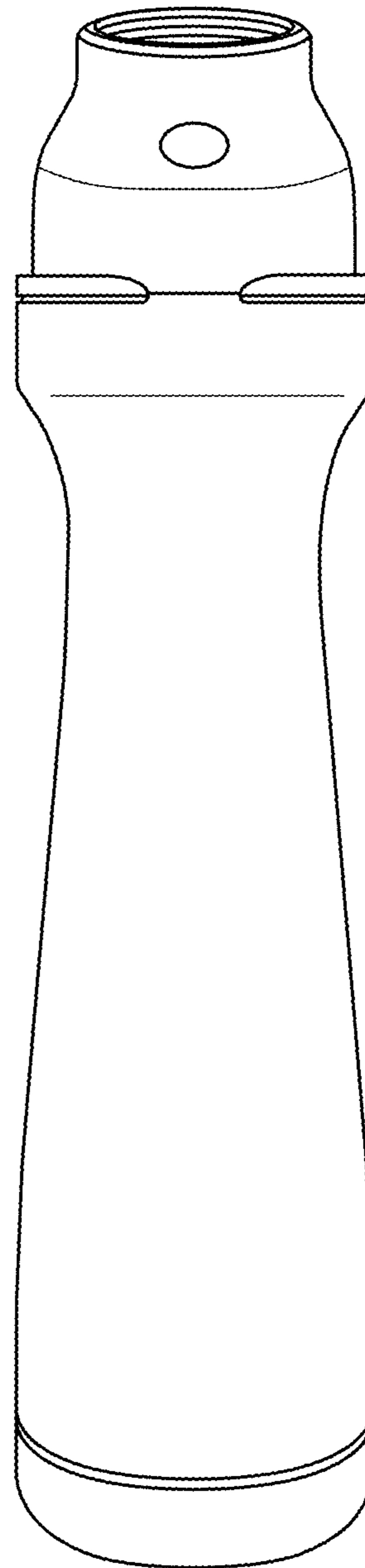

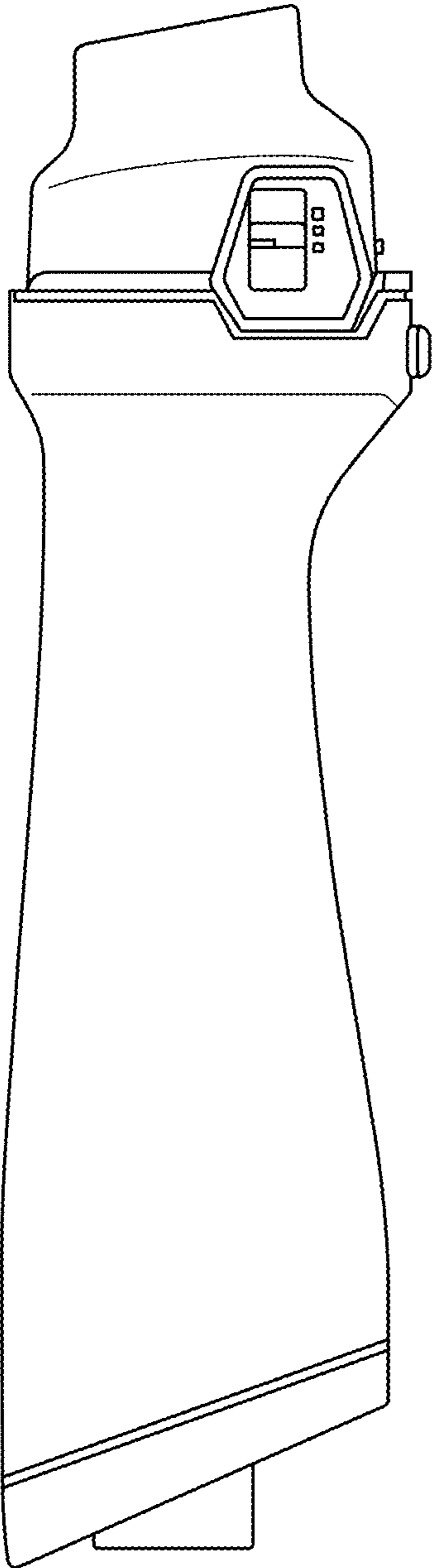

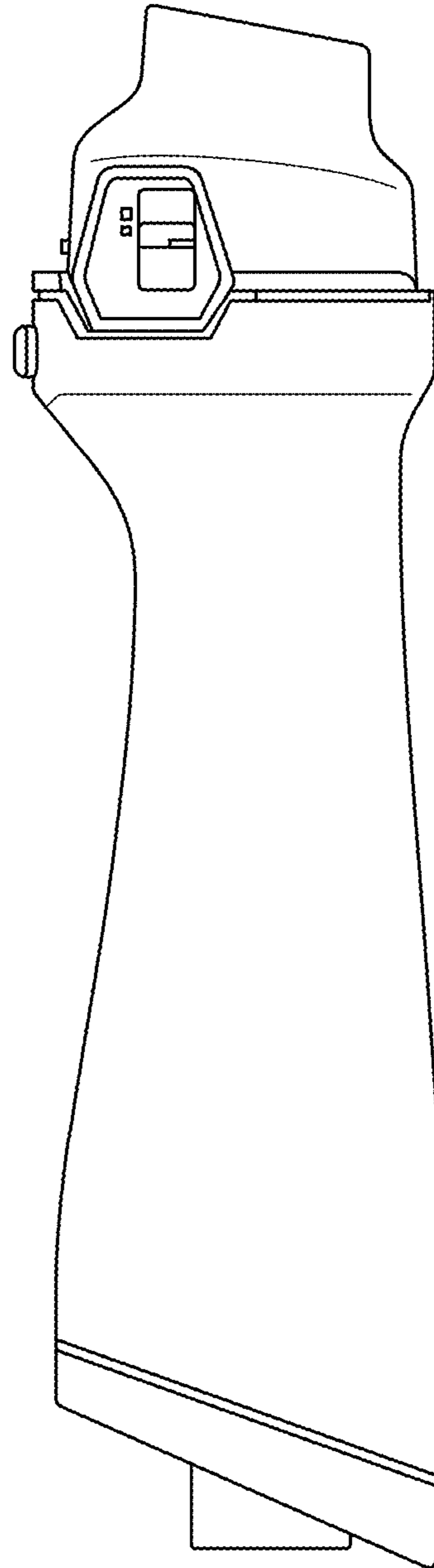

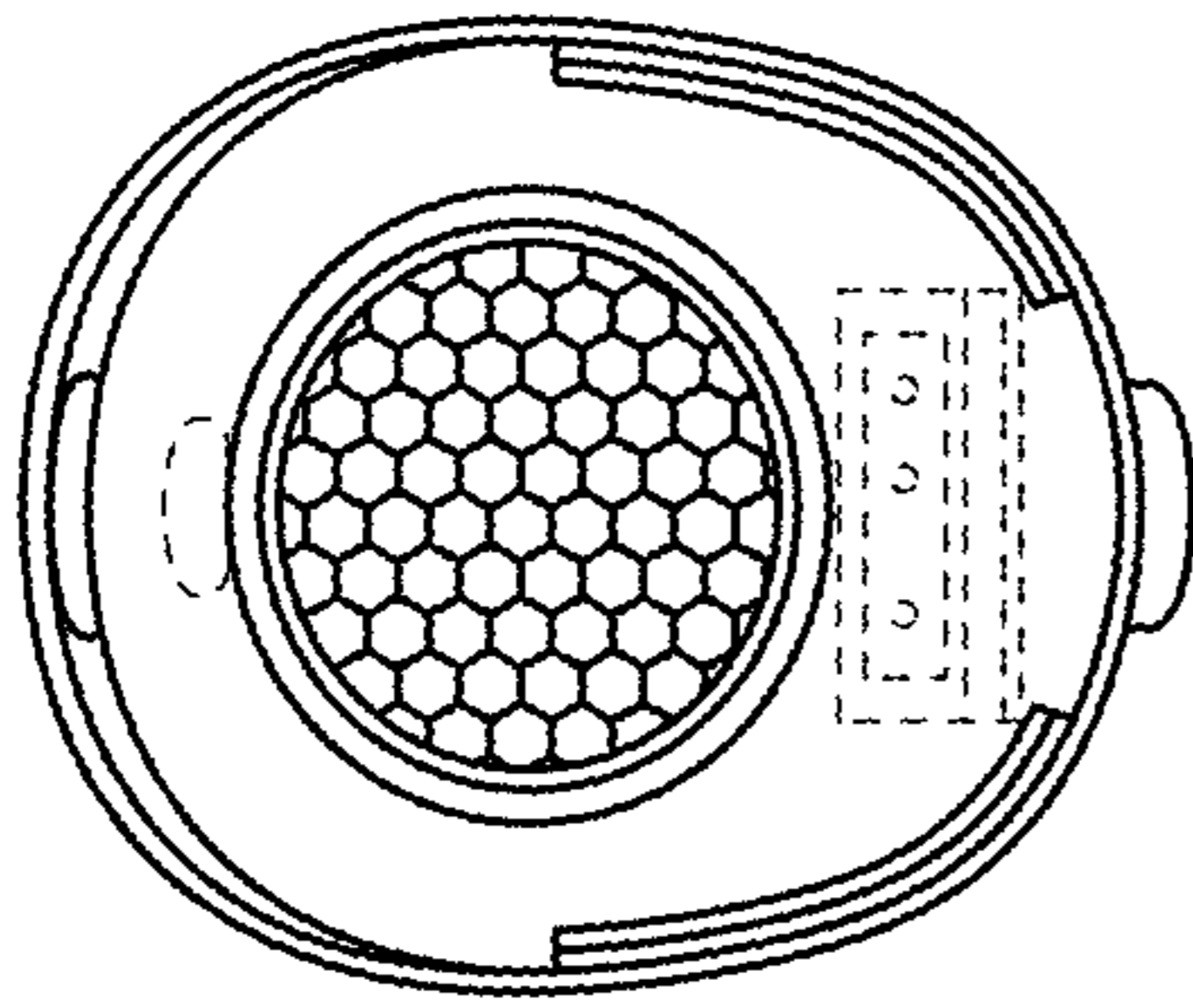

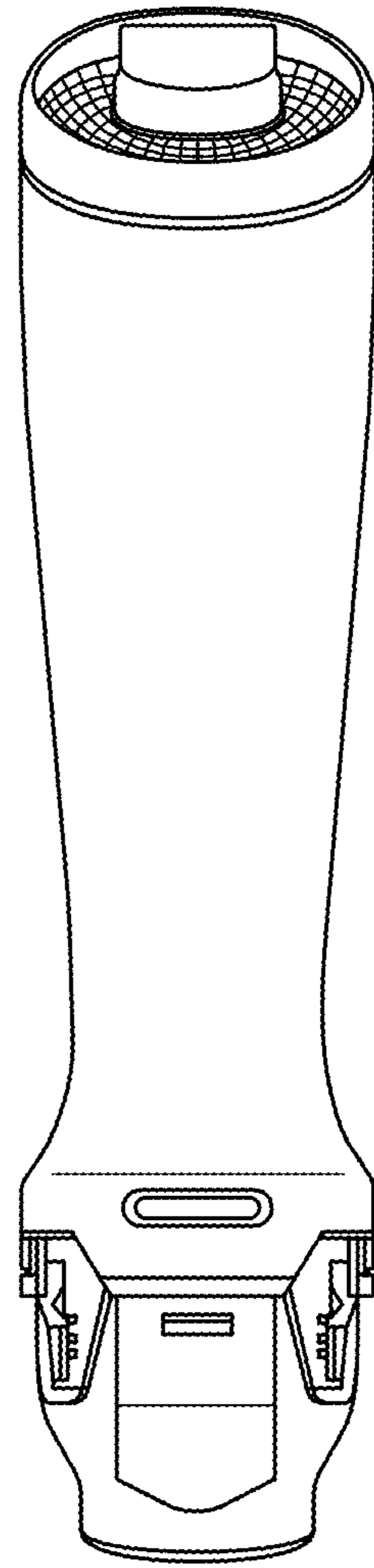
