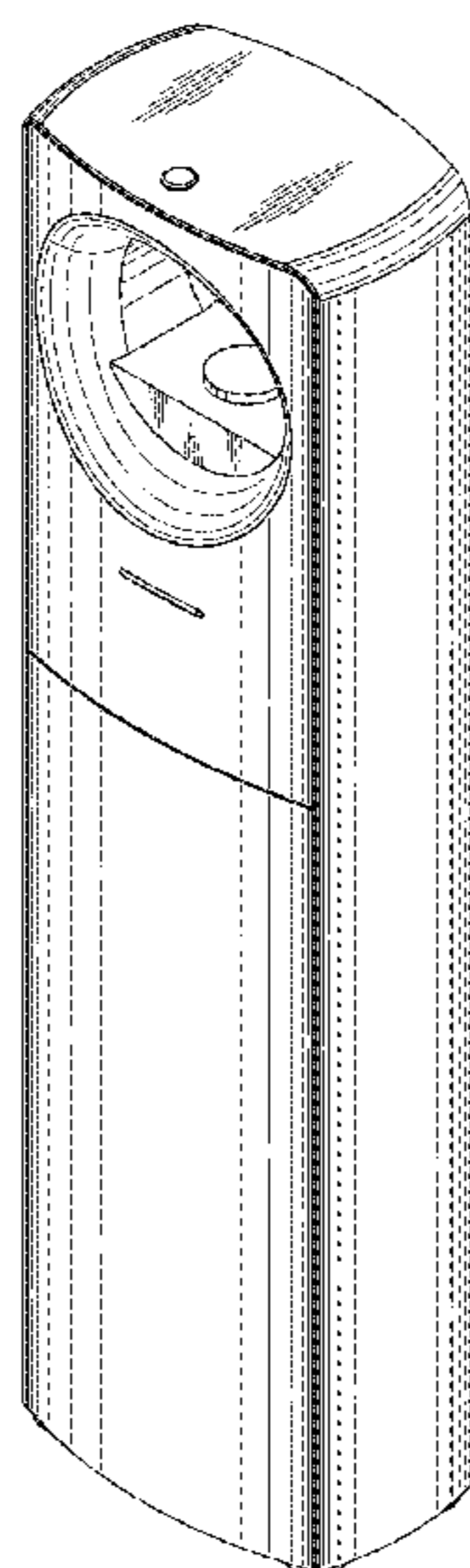
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a mixing and dispensing device embodying the new design;

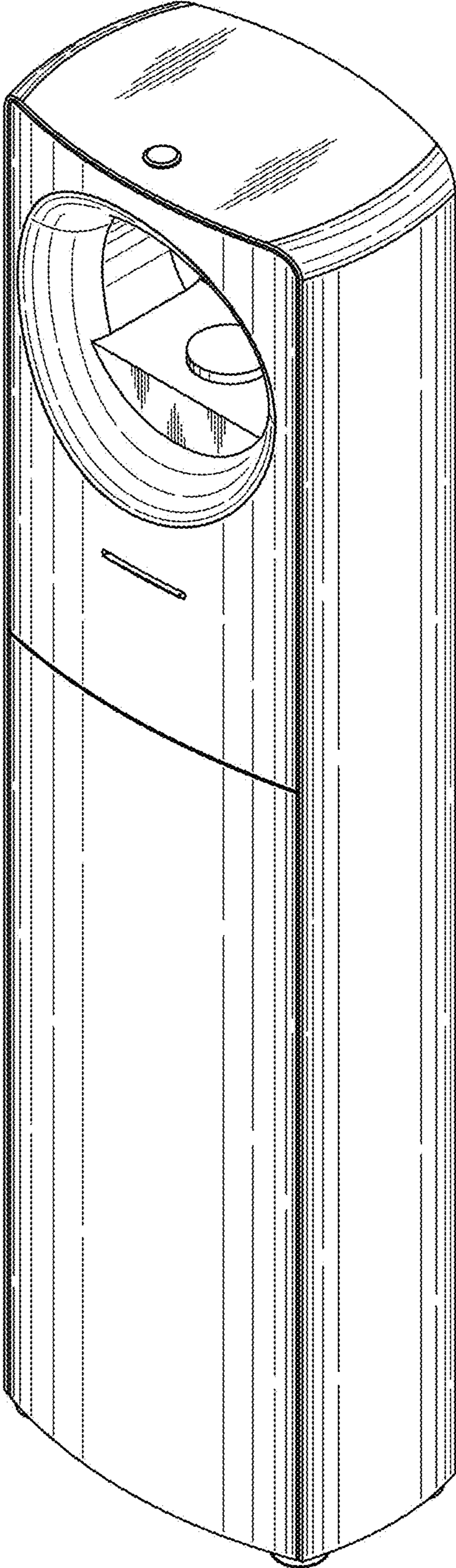

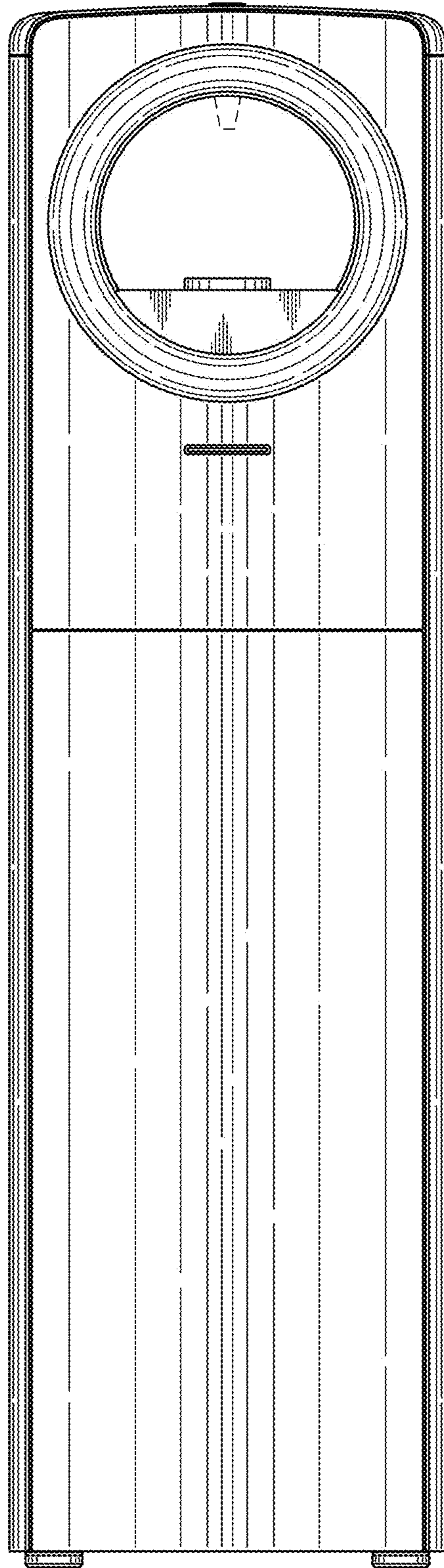

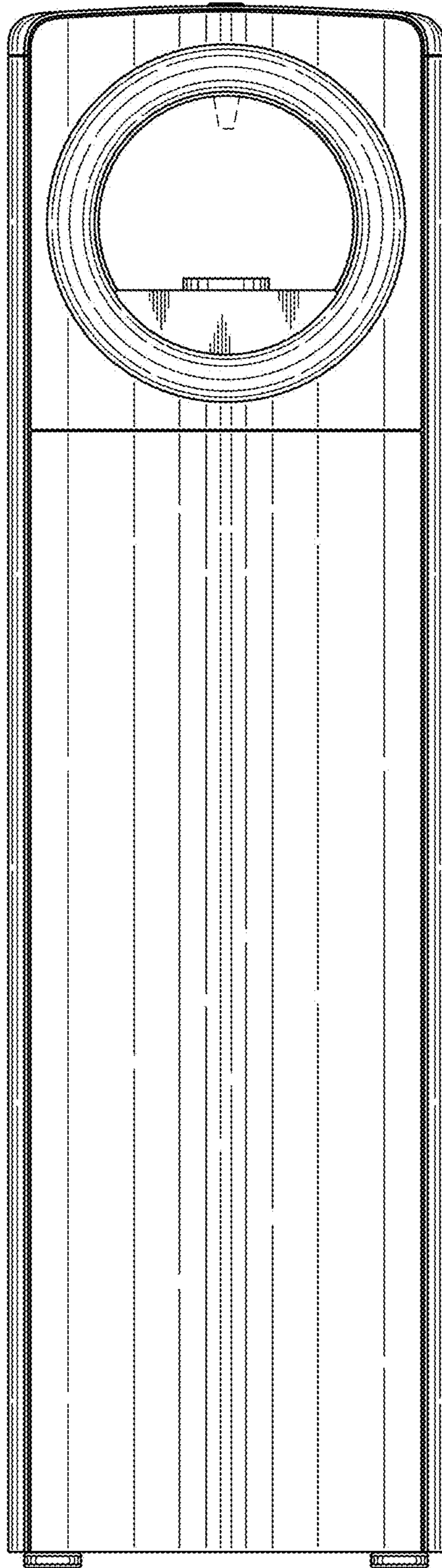

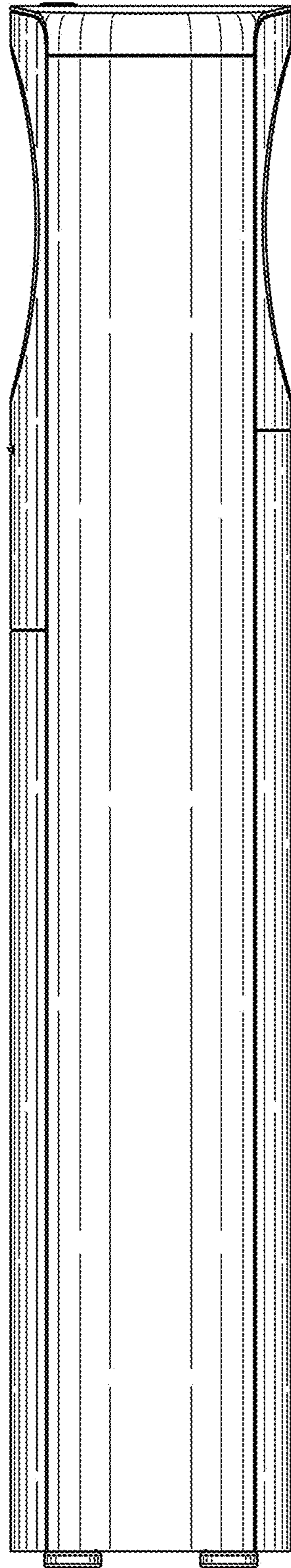

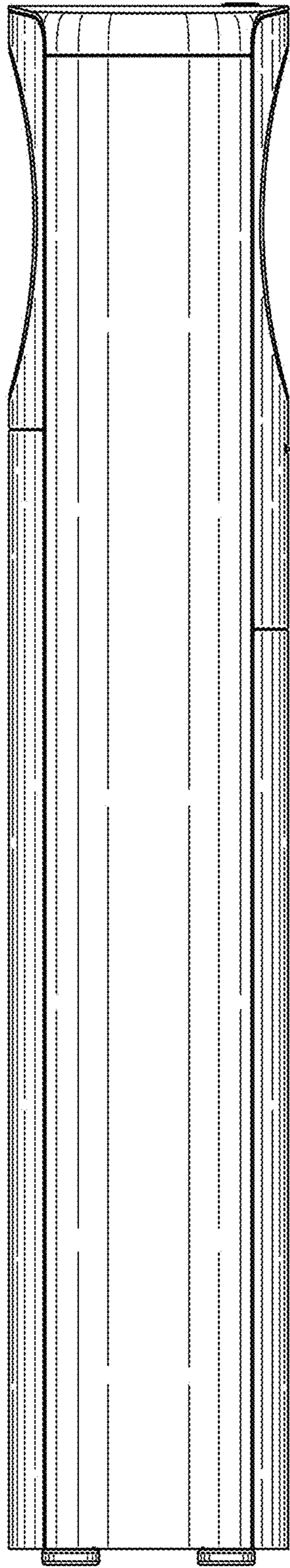

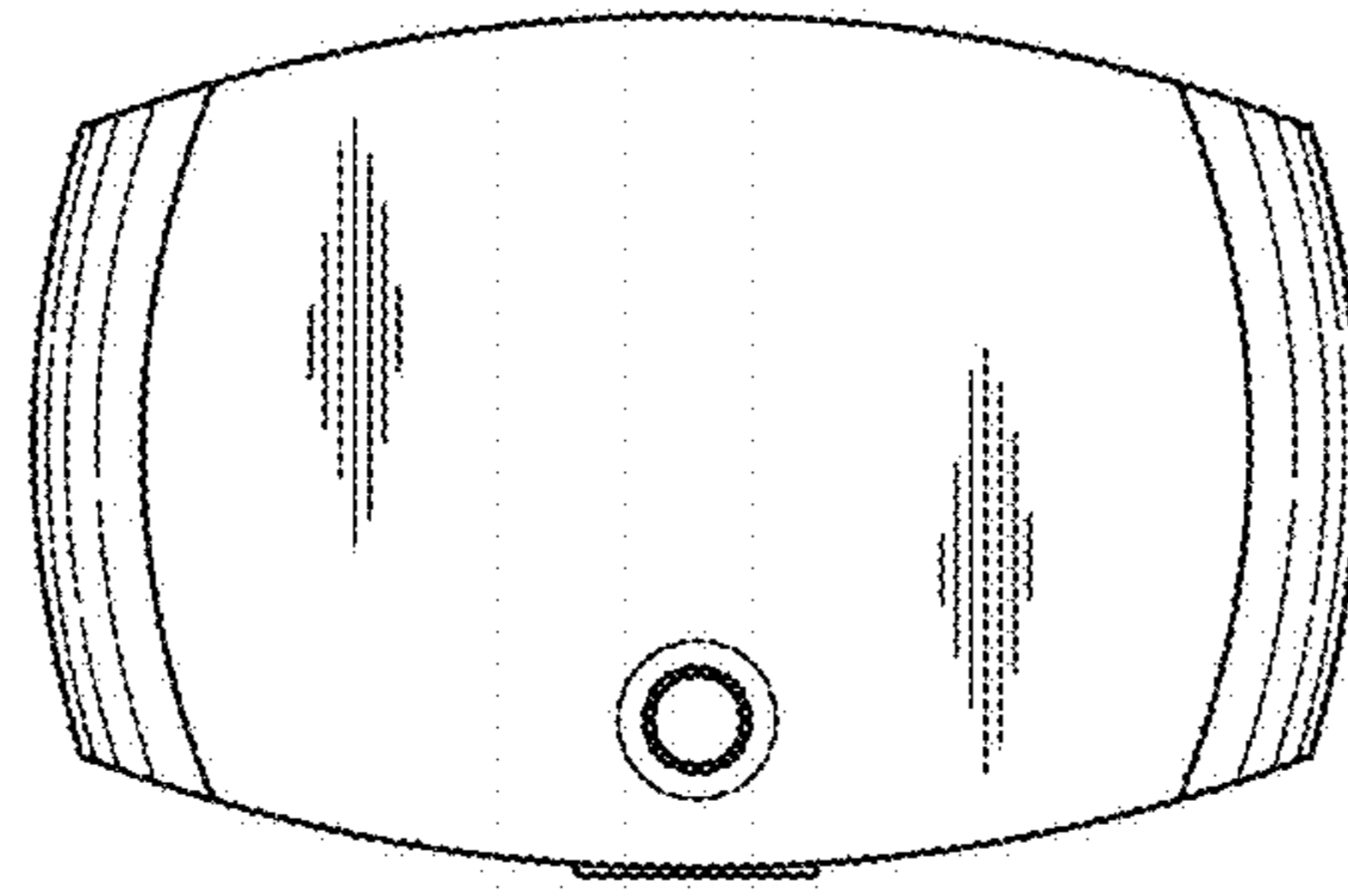

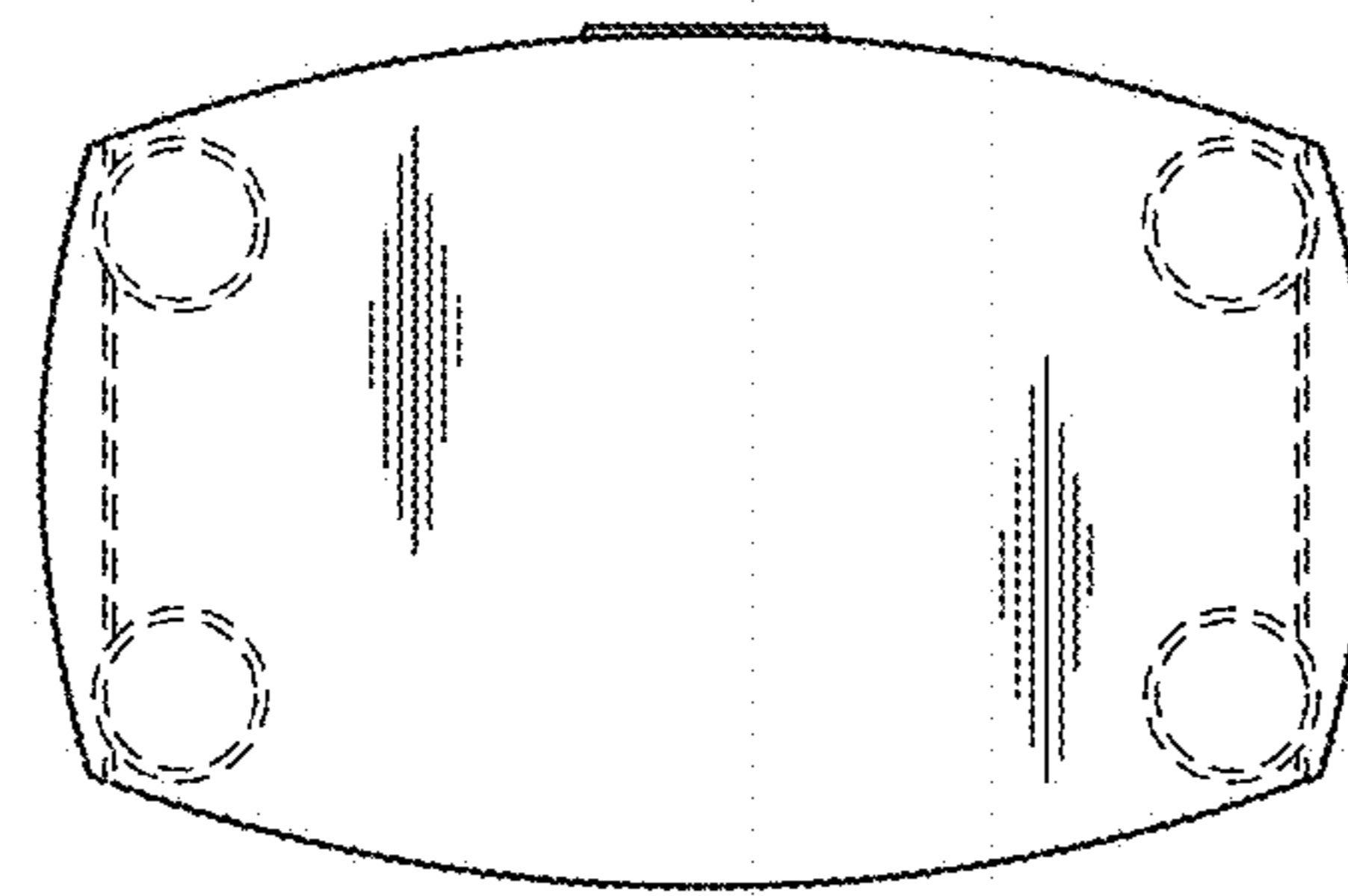
