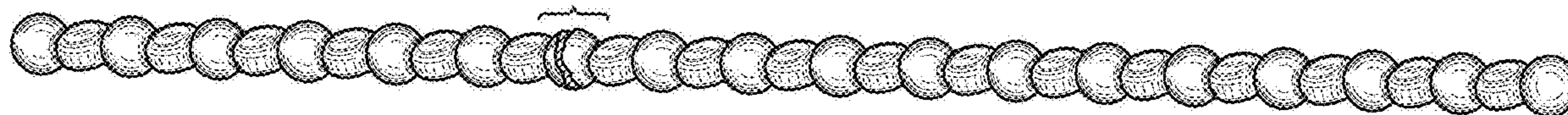
(57) **CLAIM**

The ornamental design for a hair tie or fashion accessory element, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the hair tie or accessory element;
 FIG. 2 is a left side view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a front view thereof;
 FIG. 5 is a top view thereof;
 FIG. 6 is a rear view thereof;
 FIG. 7 is a bottom view thereof; and,
 FIG. 8 is a perspective view of the hair tie or accessory element in the assembled hair tie or accessory.
 A separation and bracket in certain views indicates that of the claimed hair tie or fashion accessory element is of indeterminate length.
 Elements shown using broken lines are not part of the claimed design.

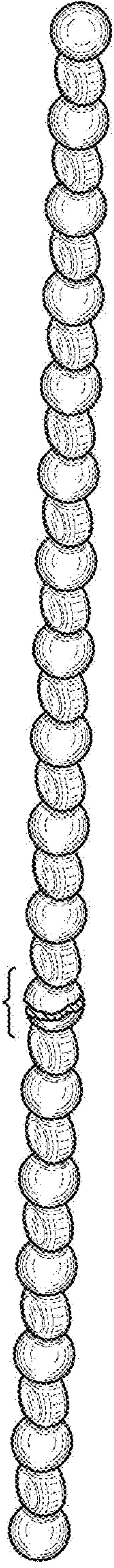

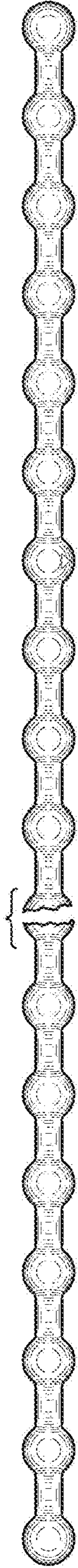

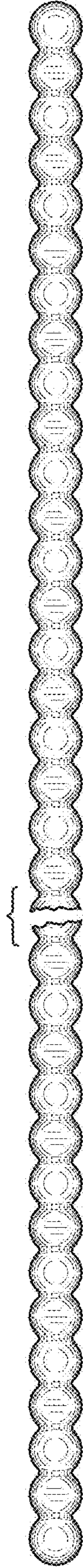

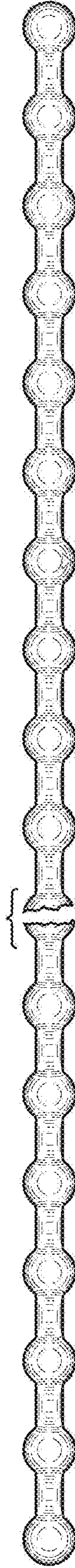

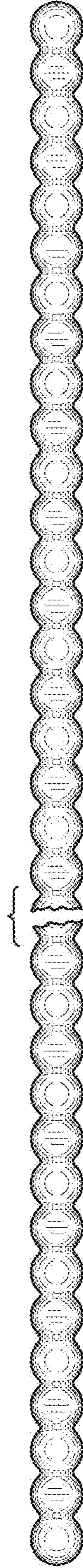
