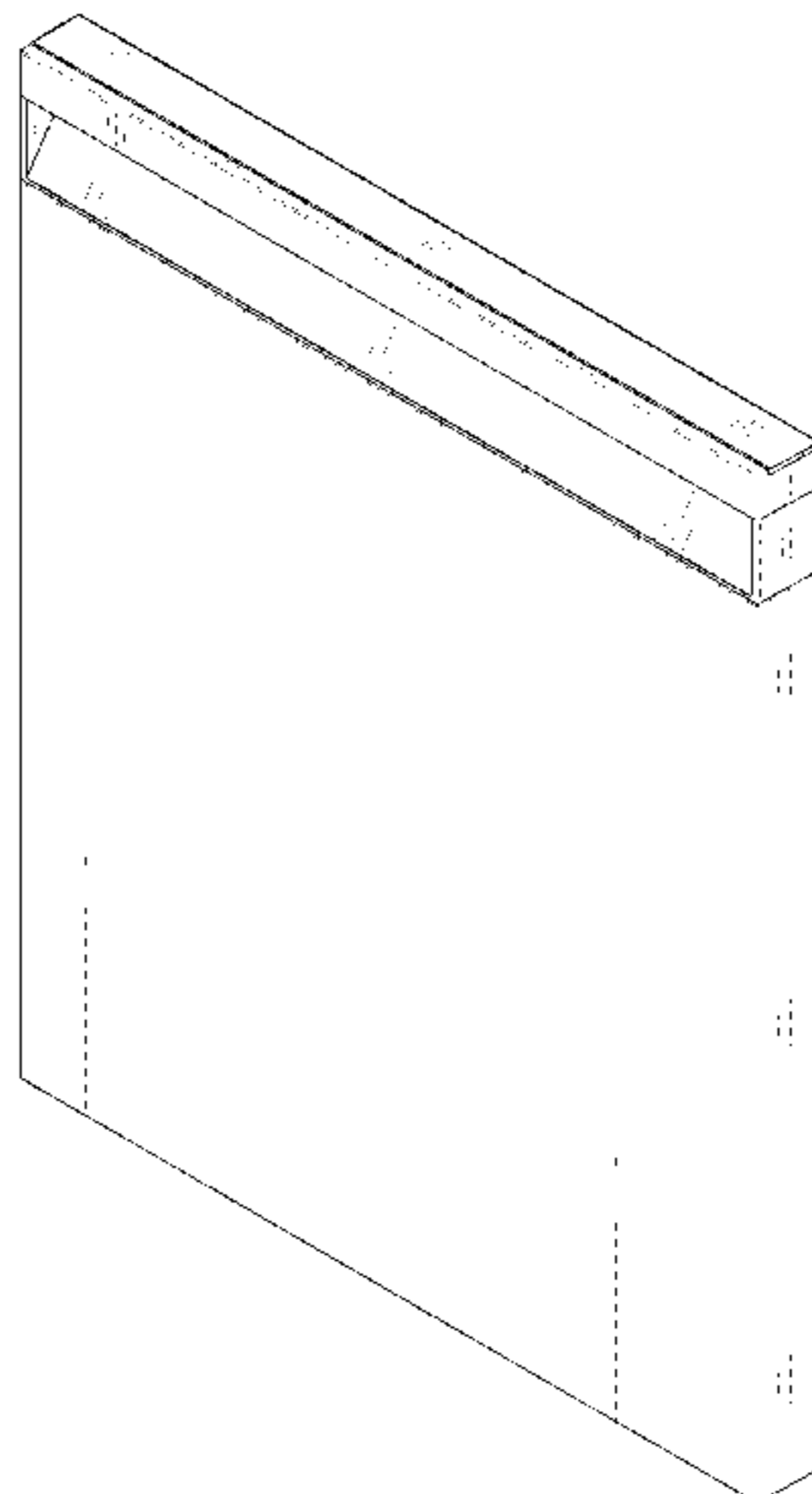


FIG. 36 is a front perspective view thereof shown in an example environment.

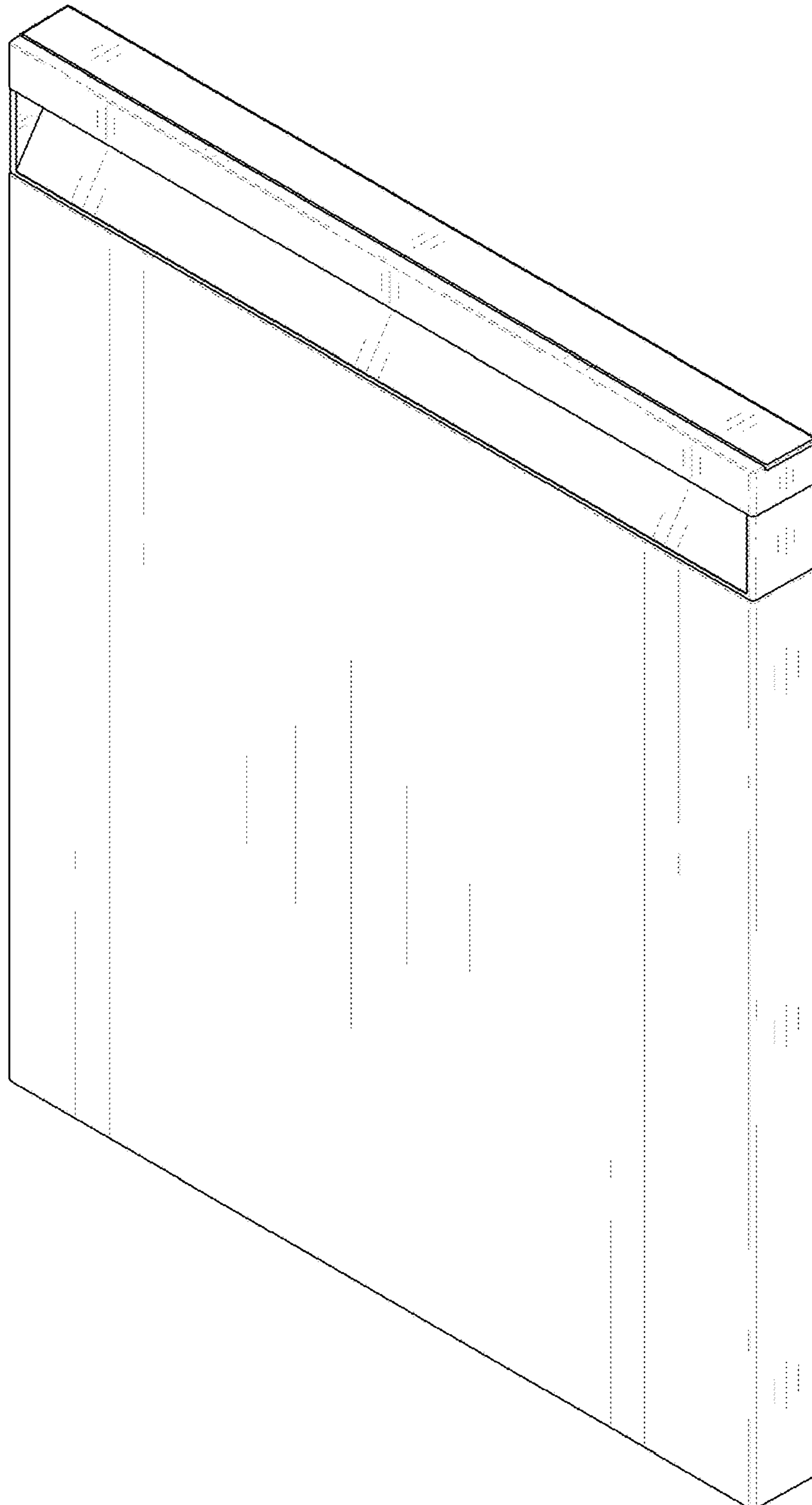

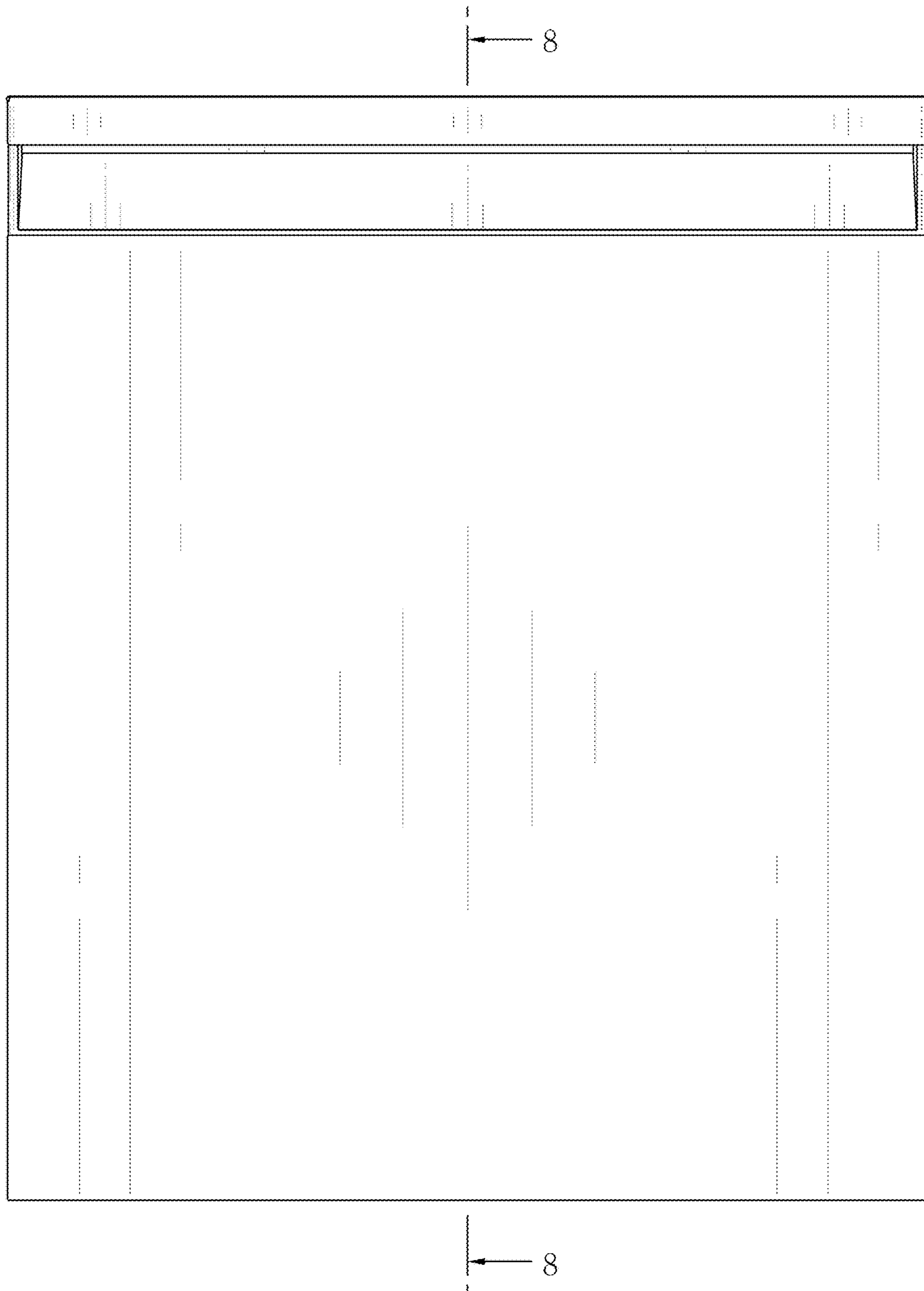

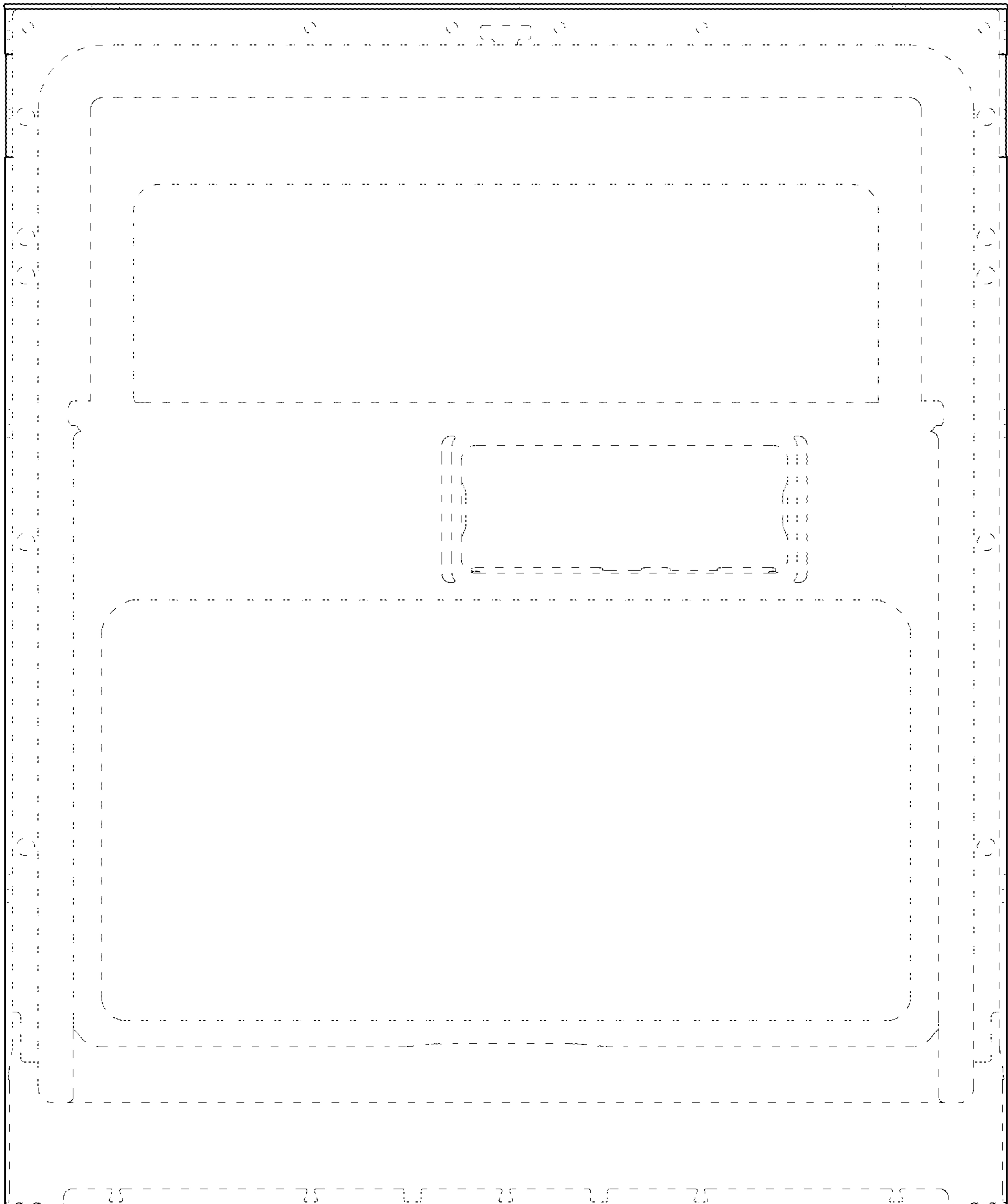

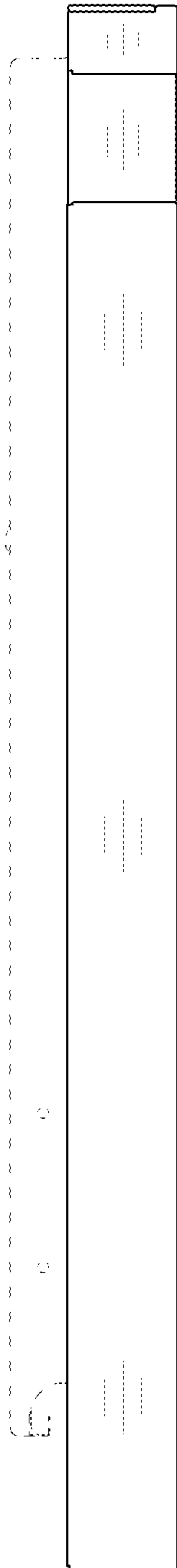

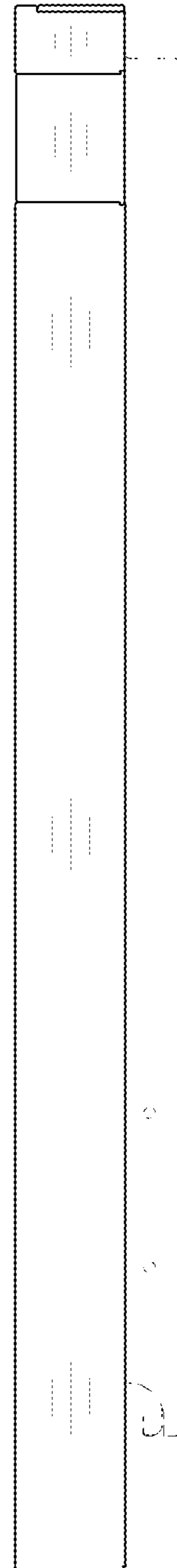

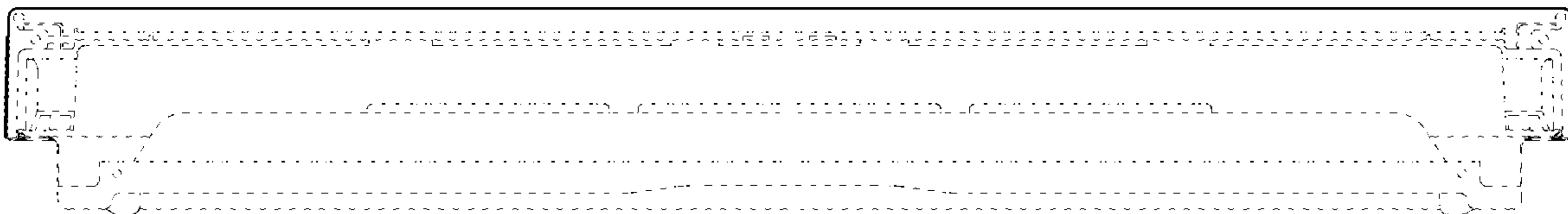

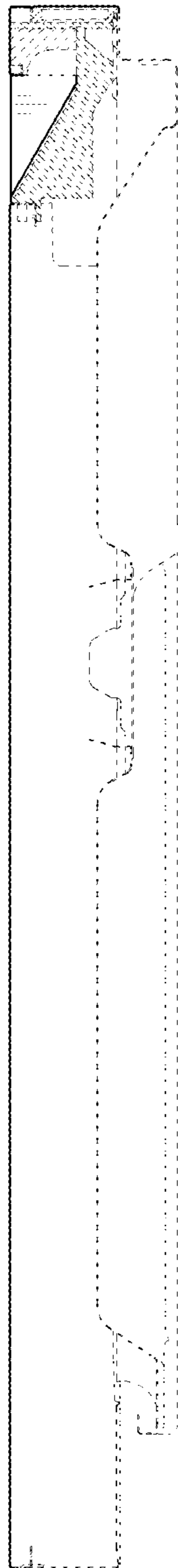

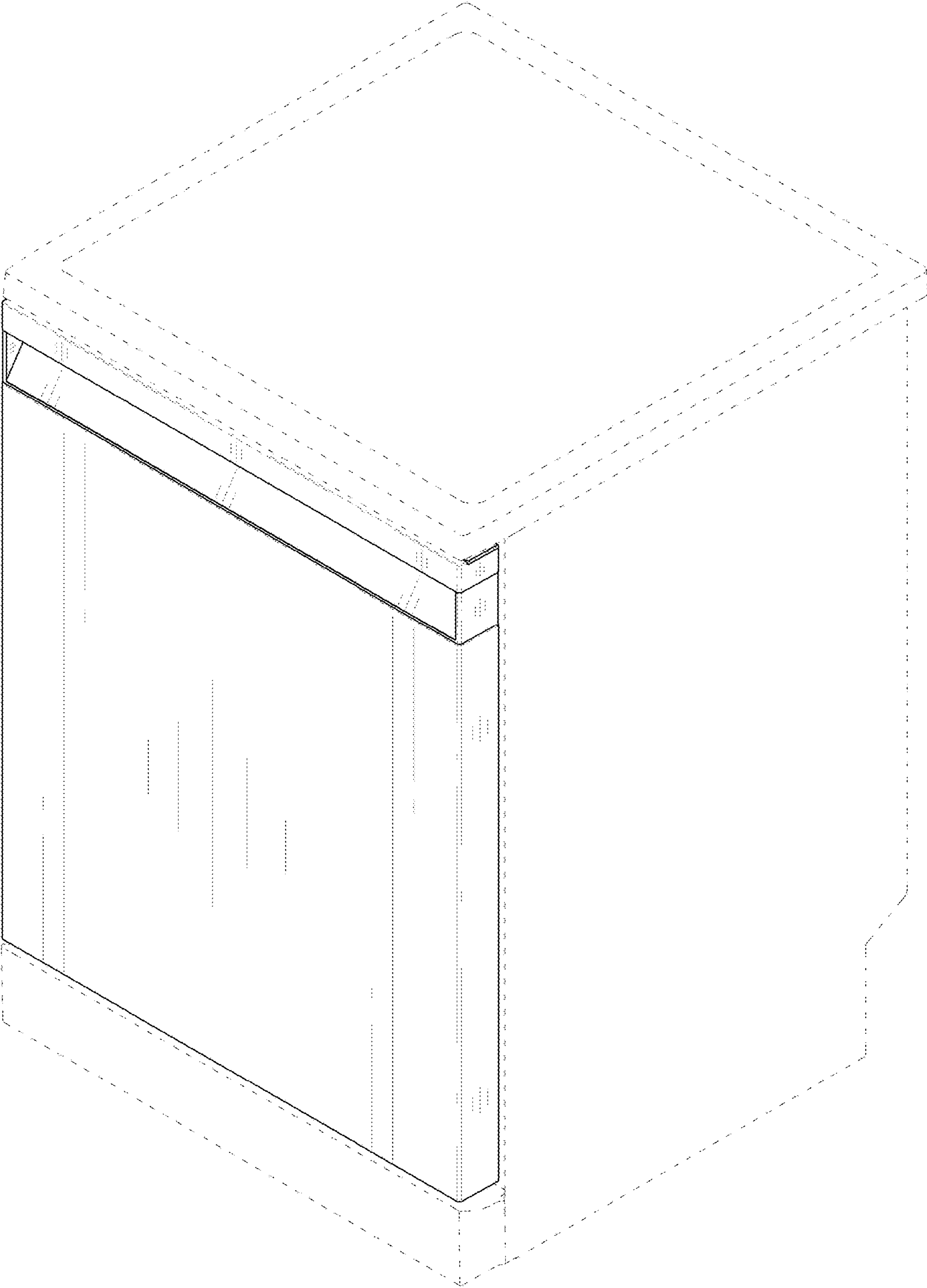

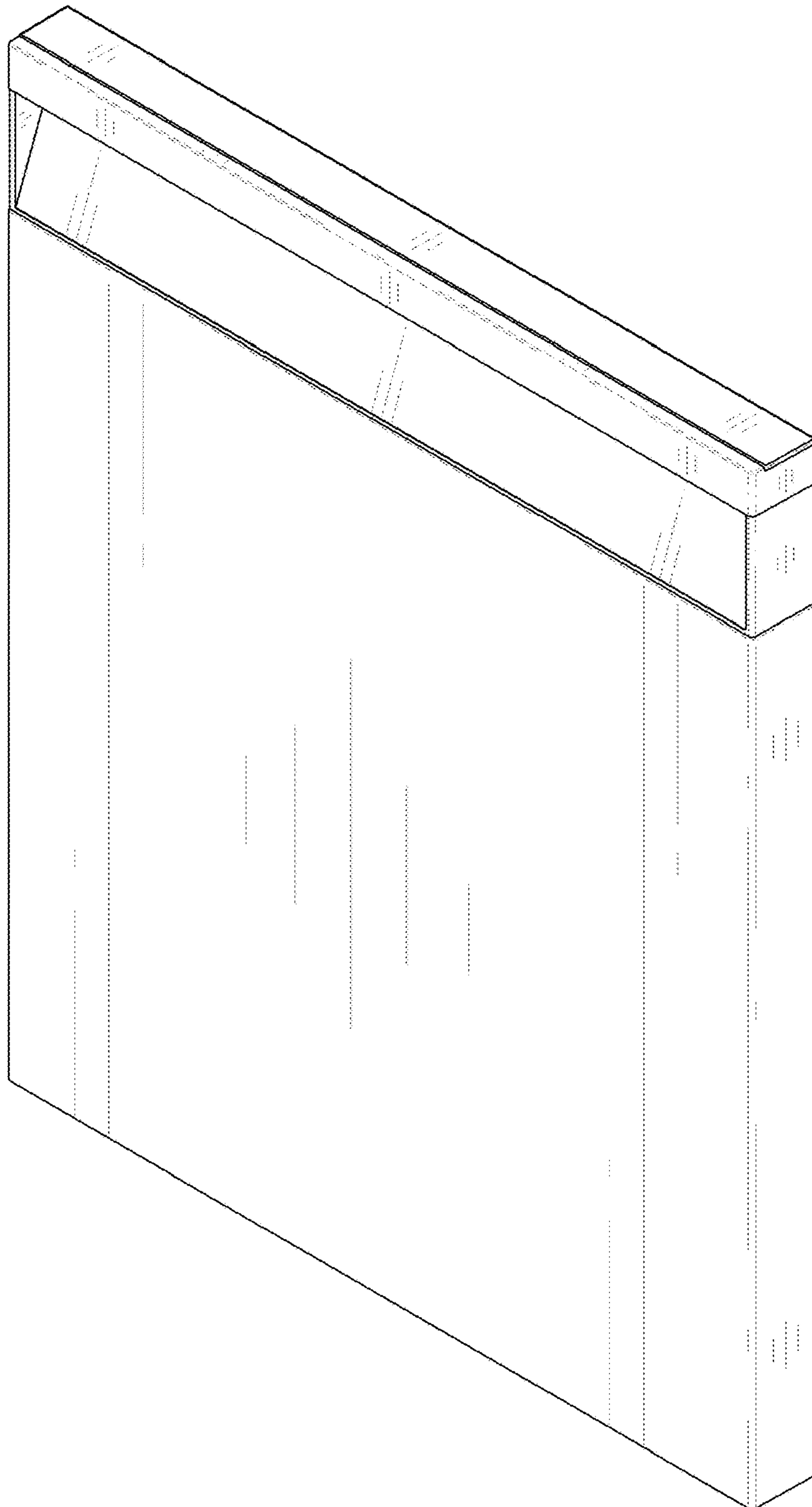

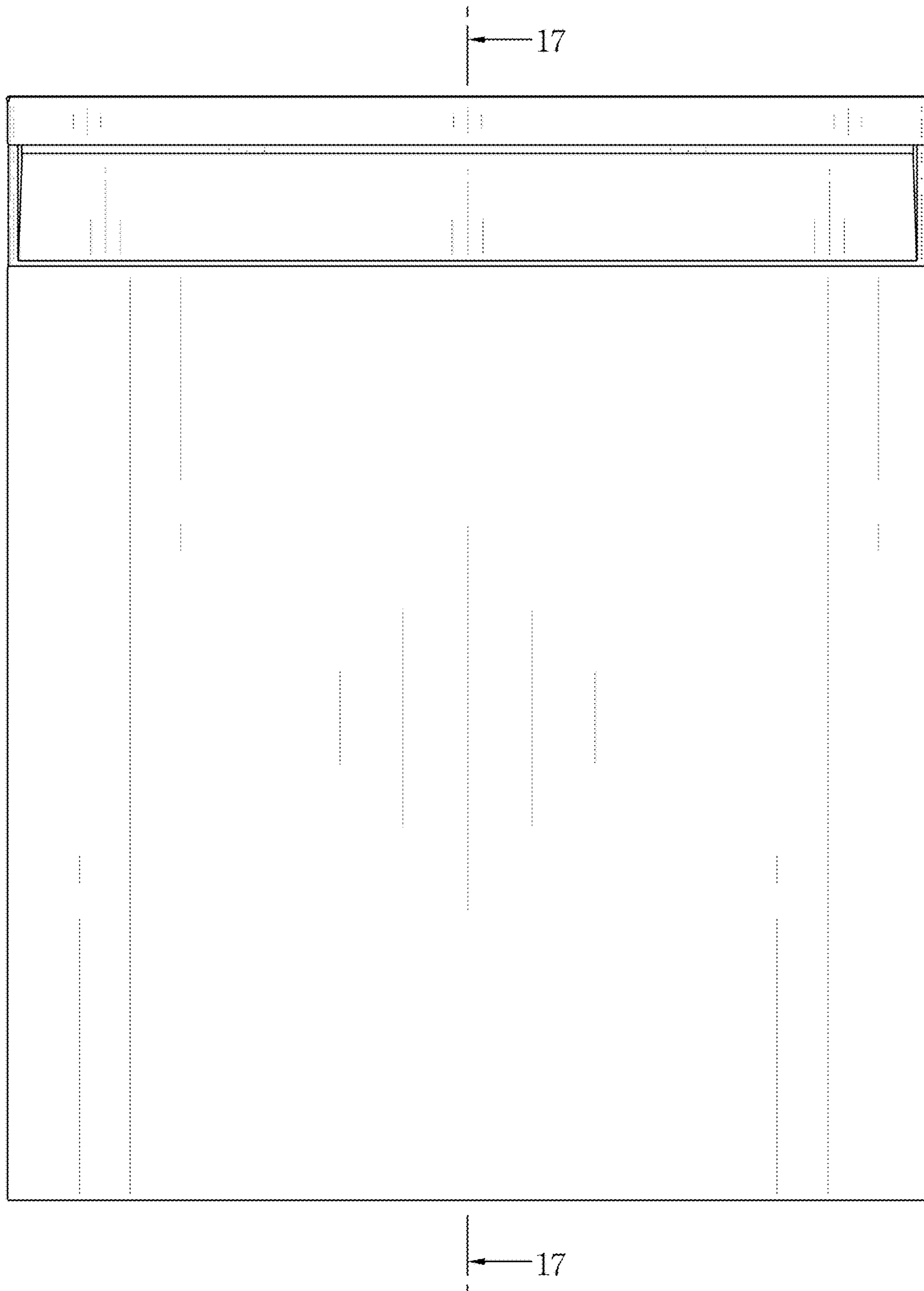

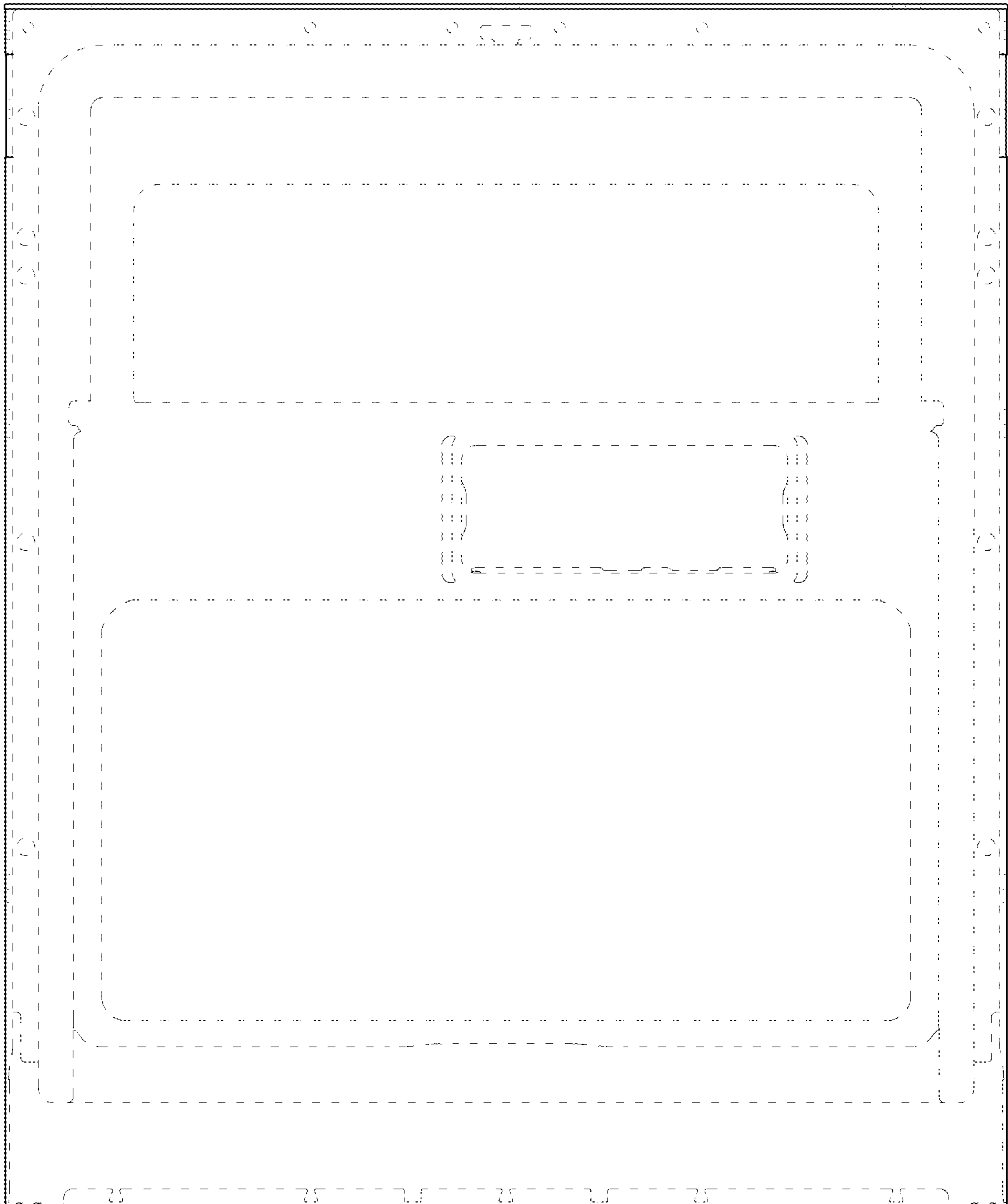

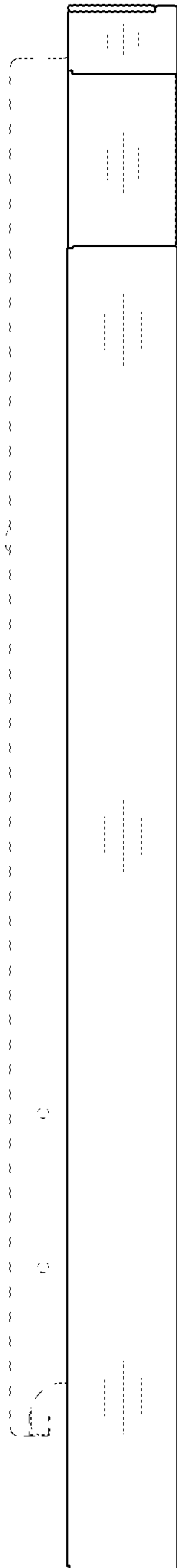

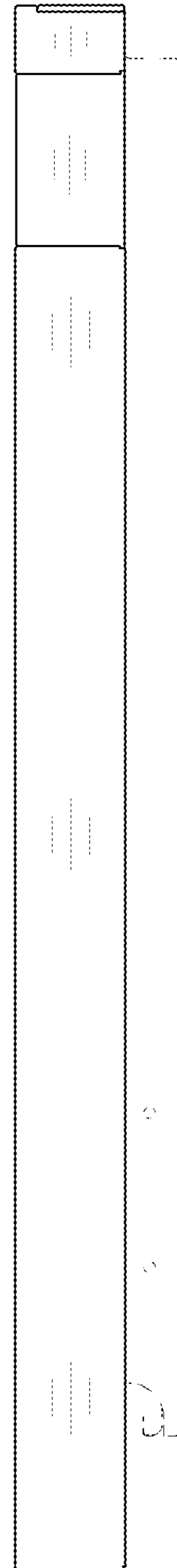

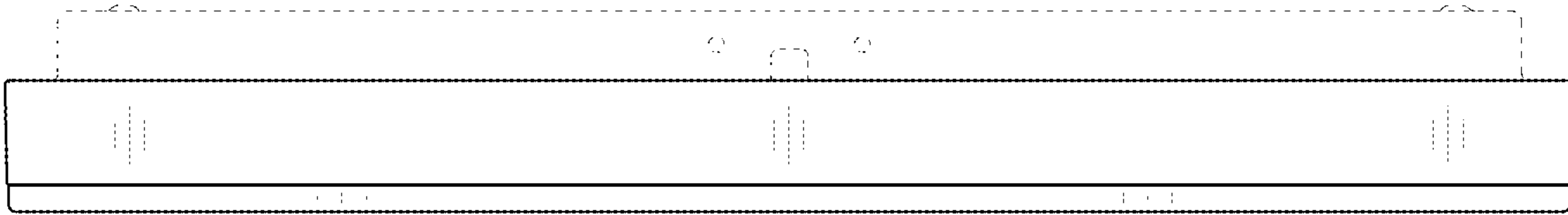

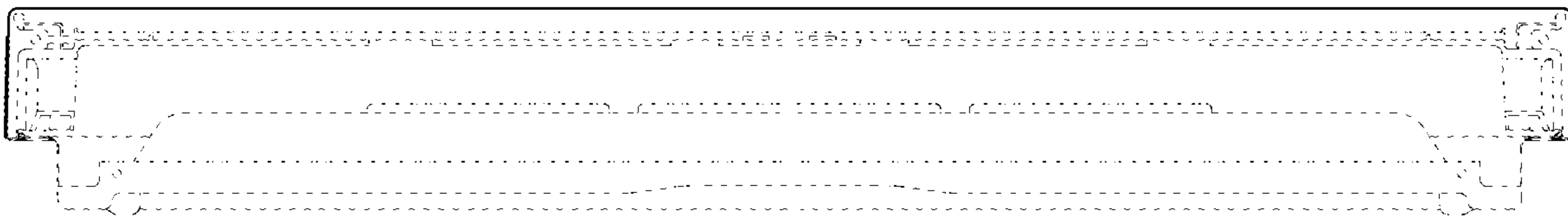

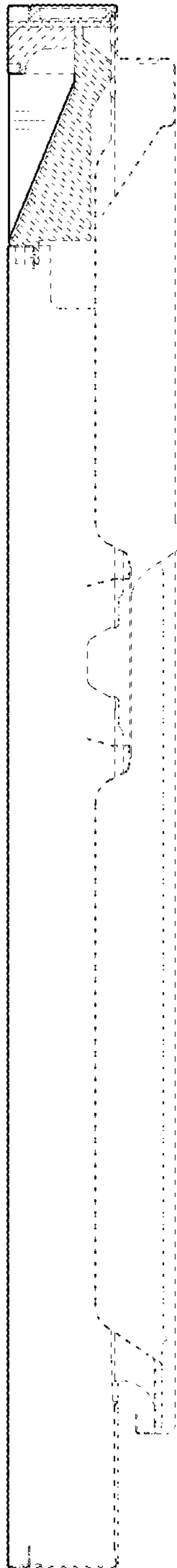

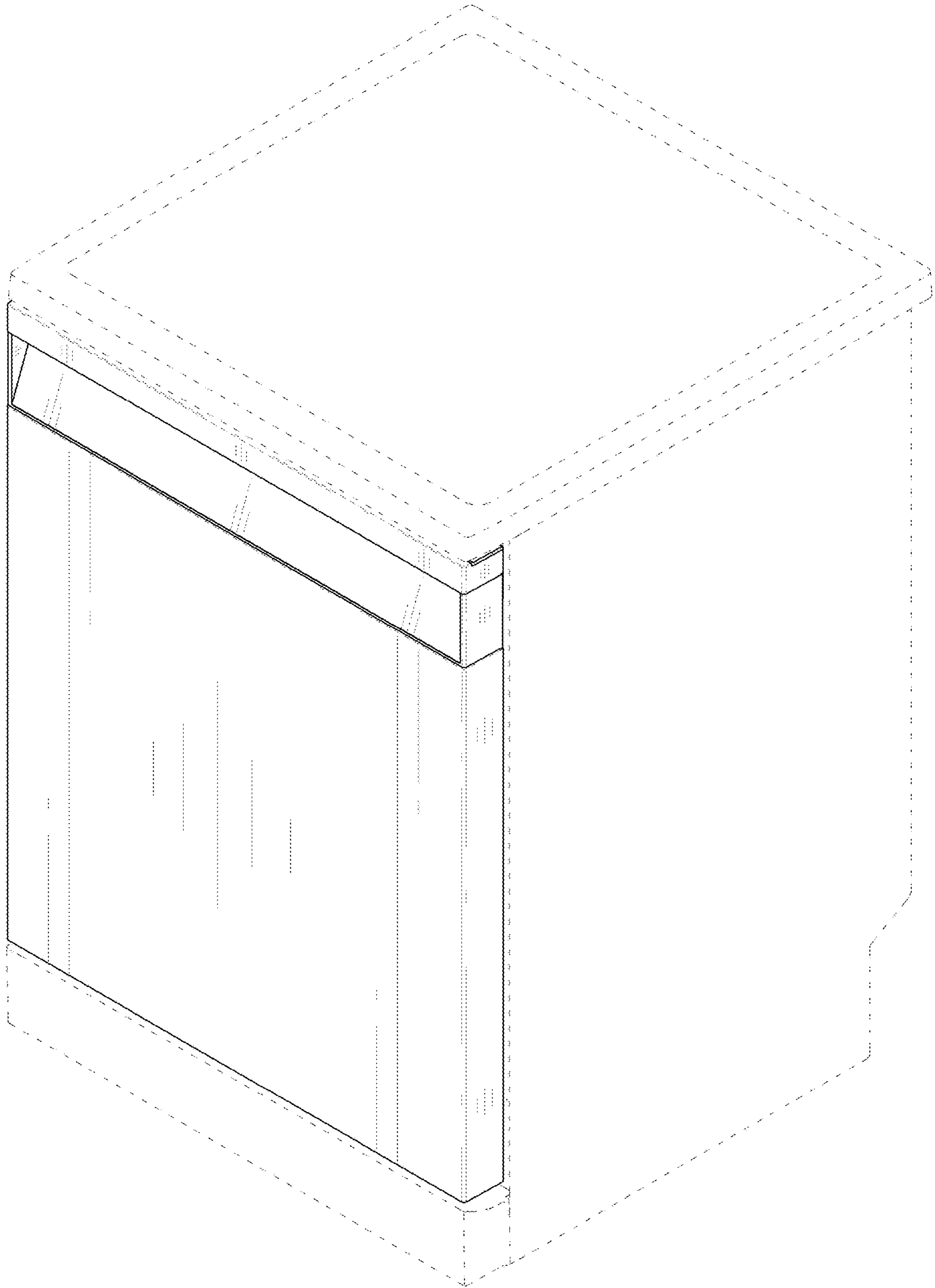

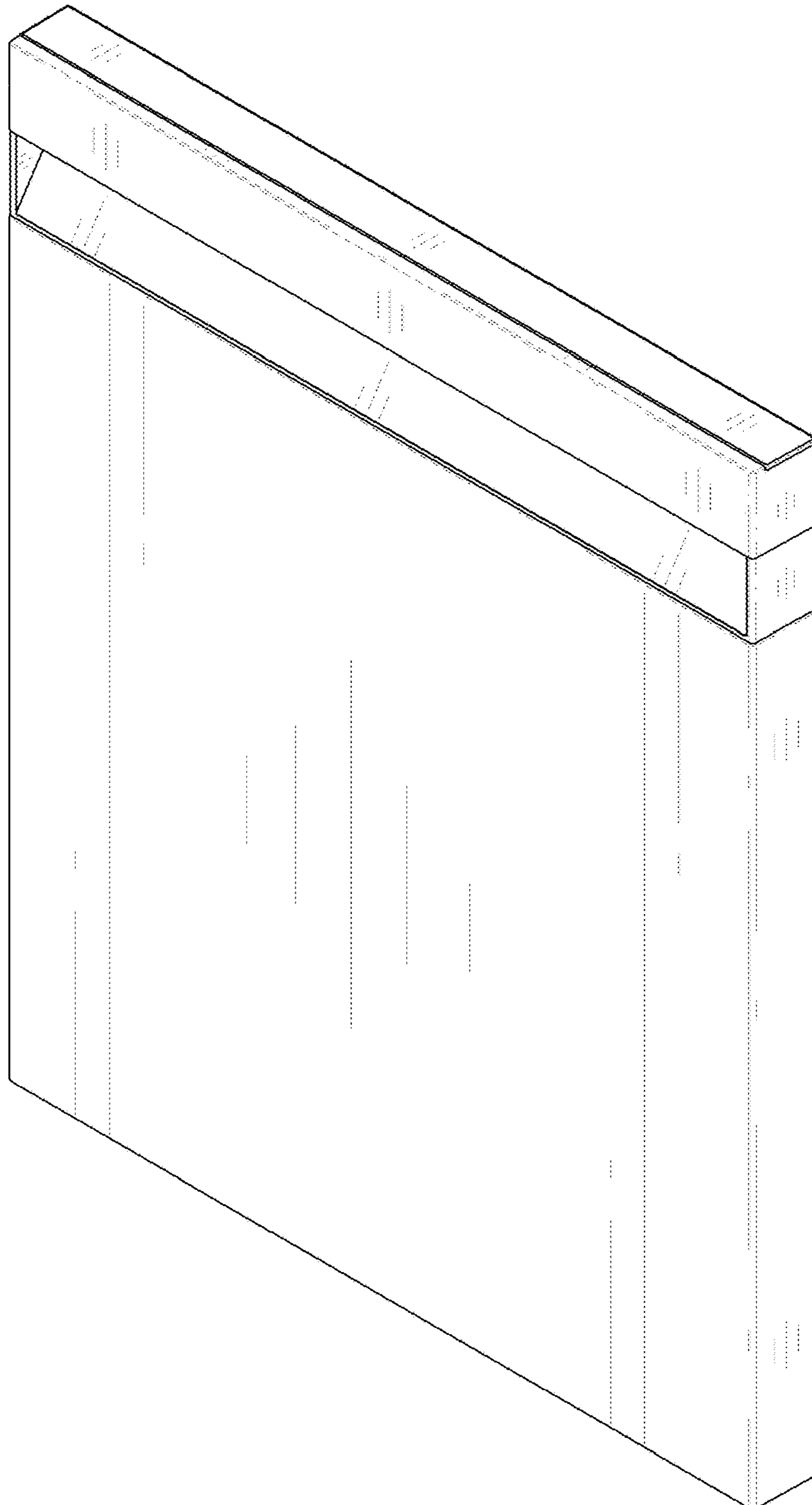

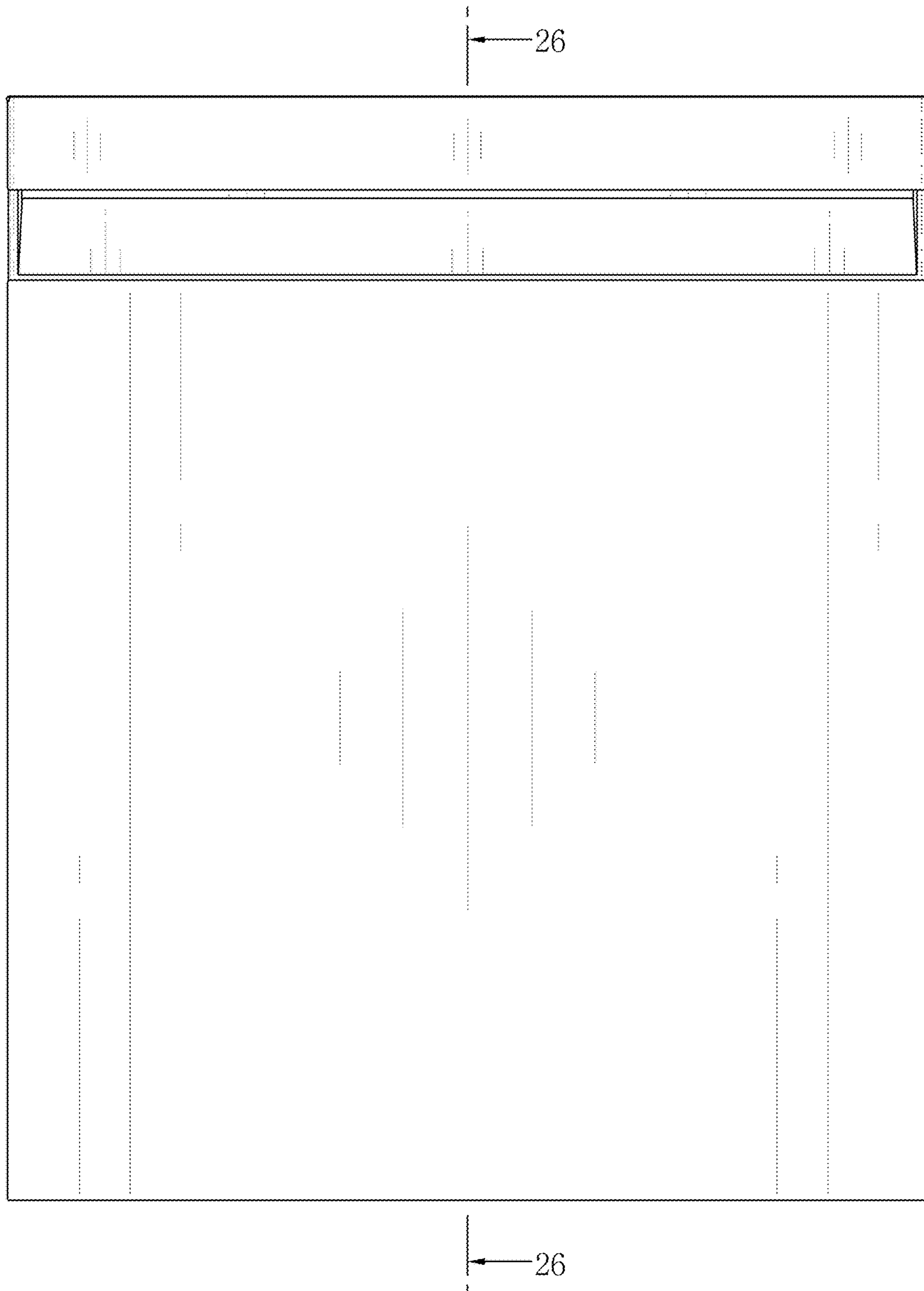

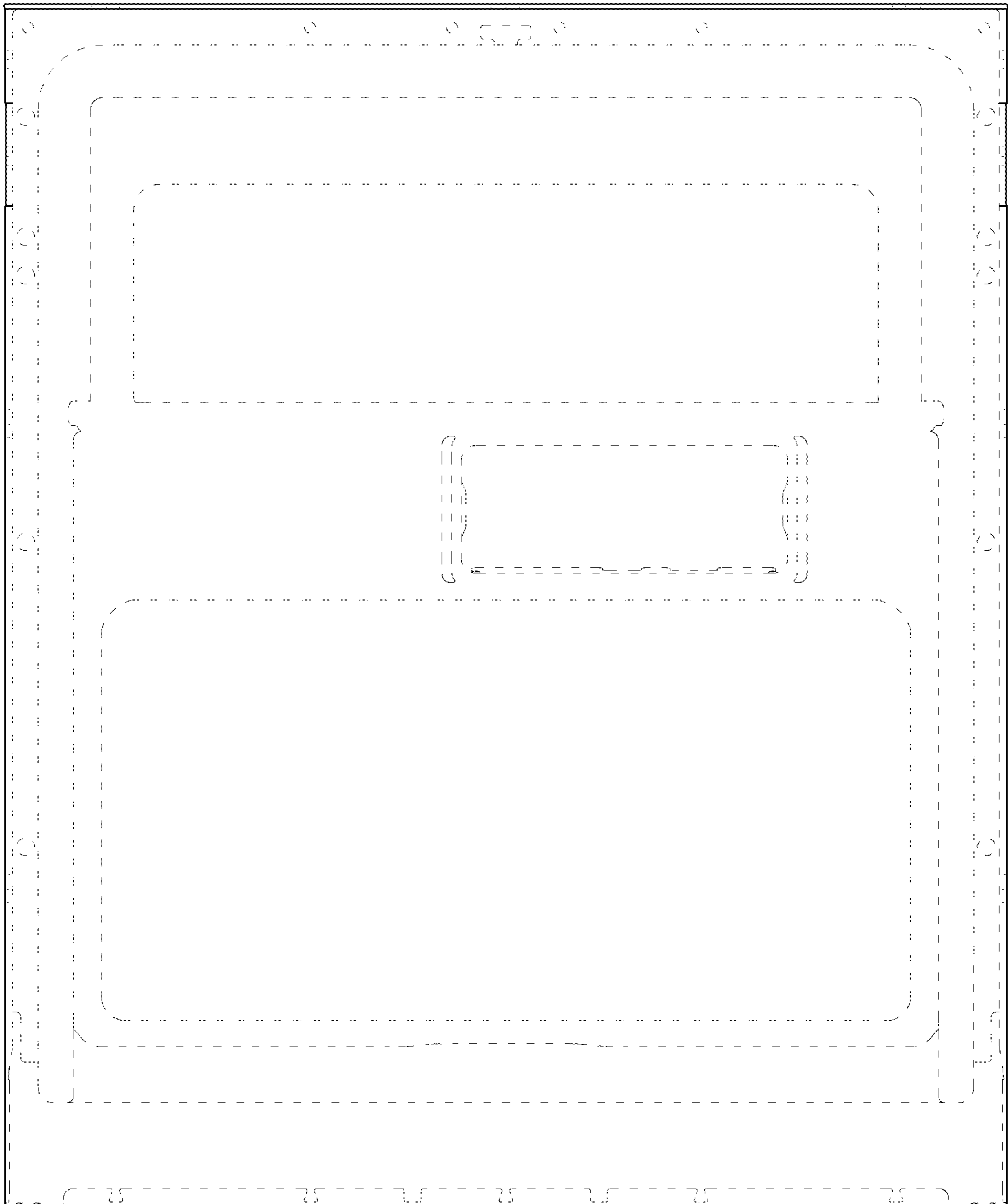

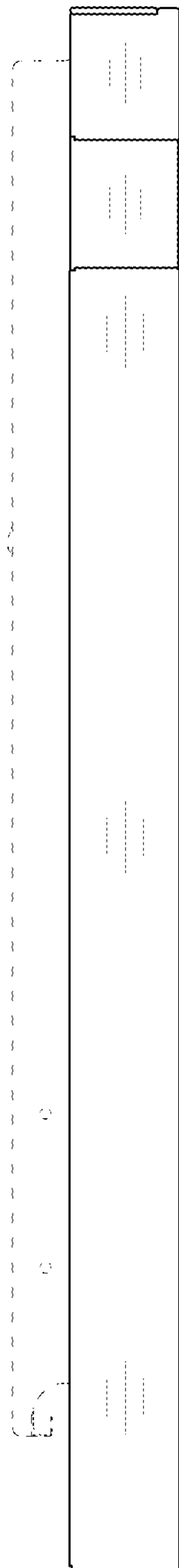

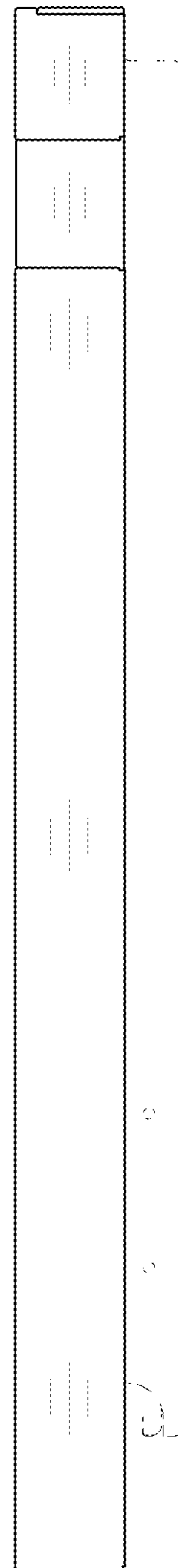

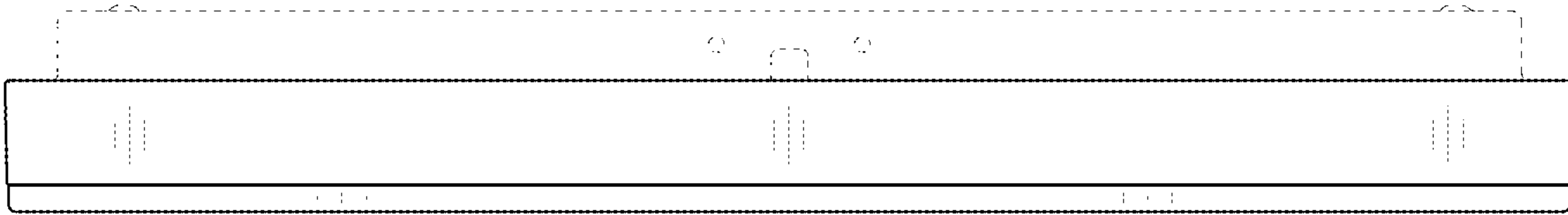

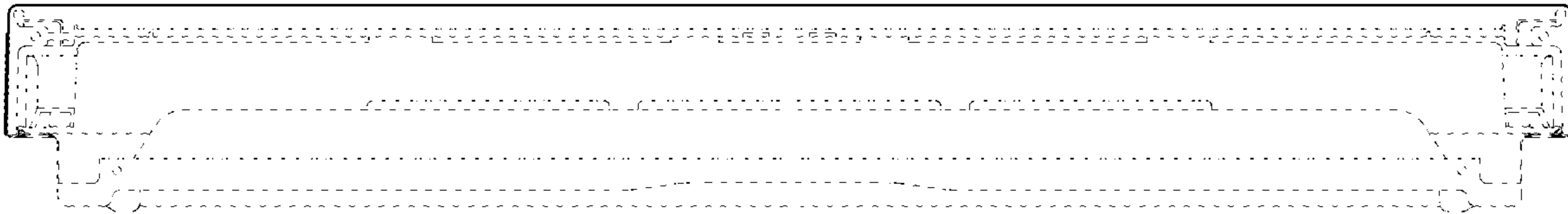

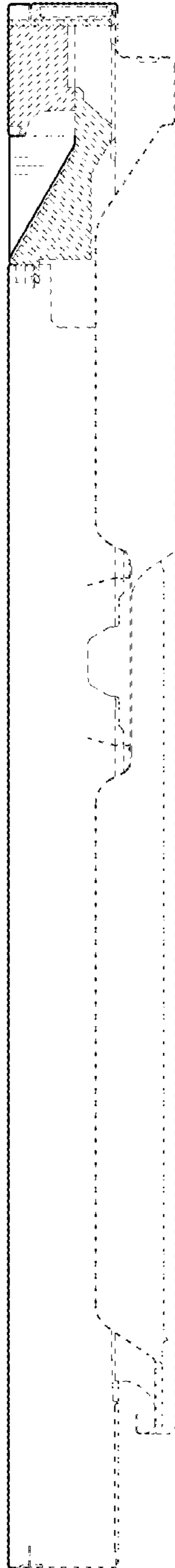

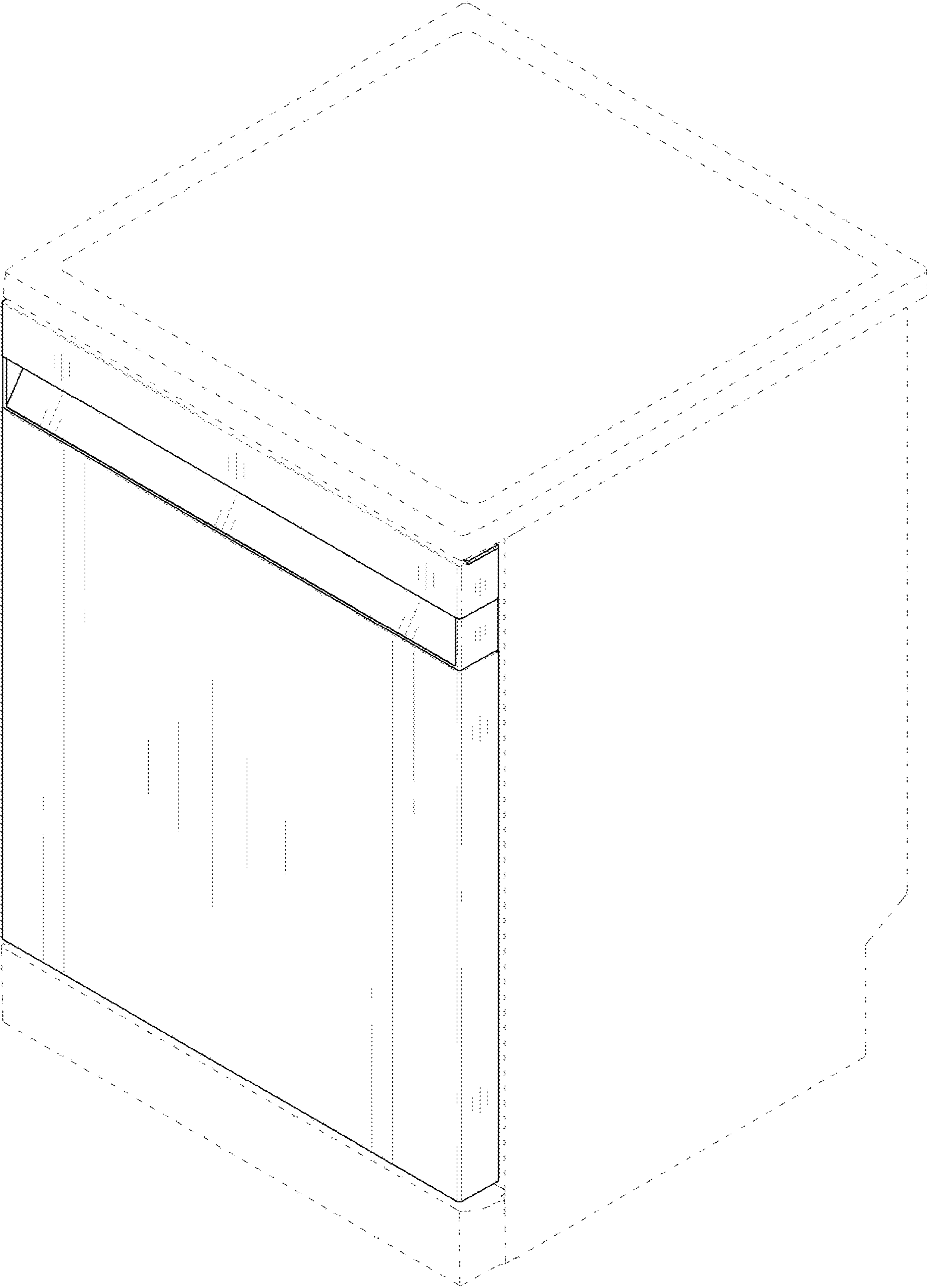

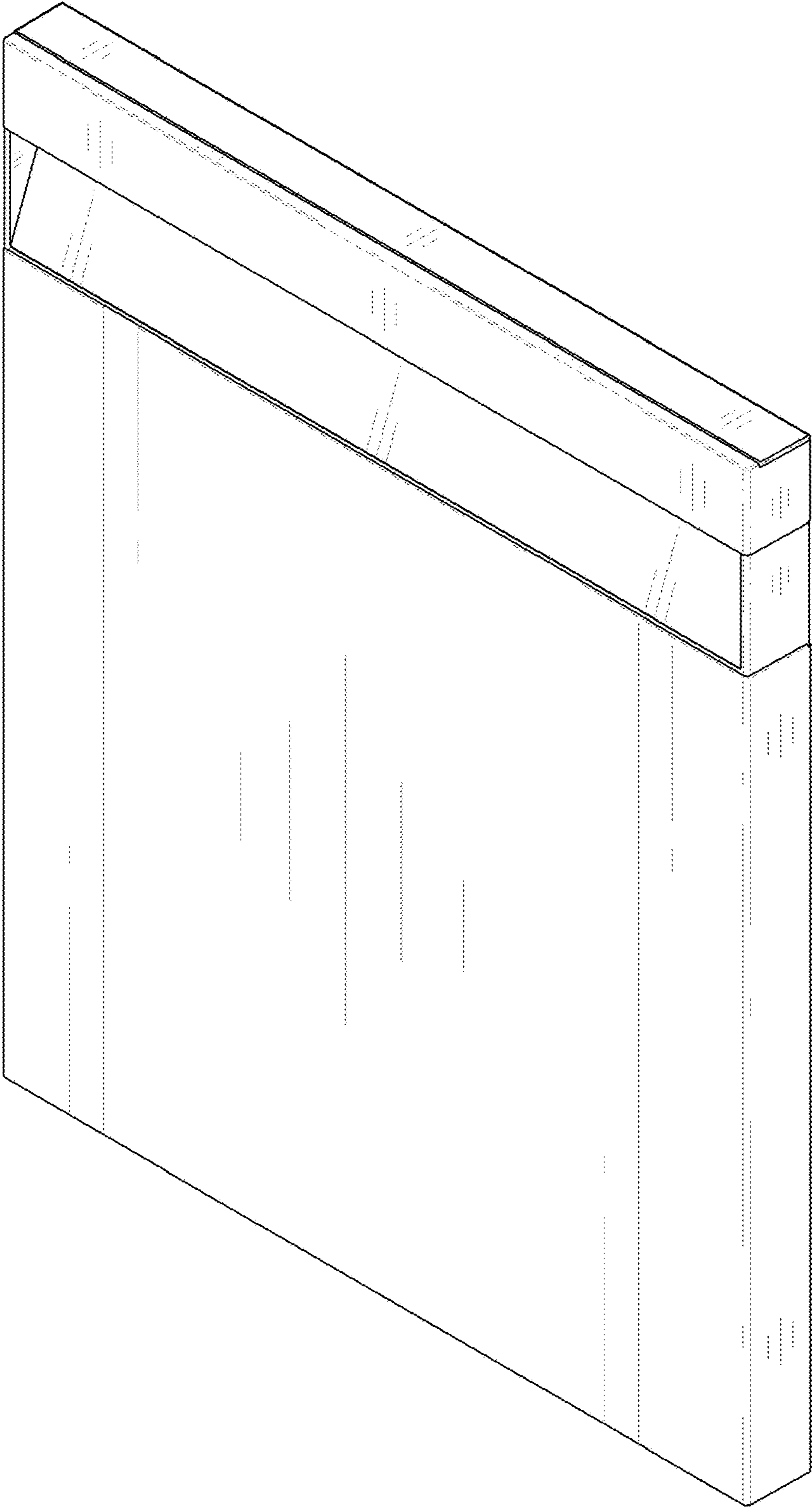

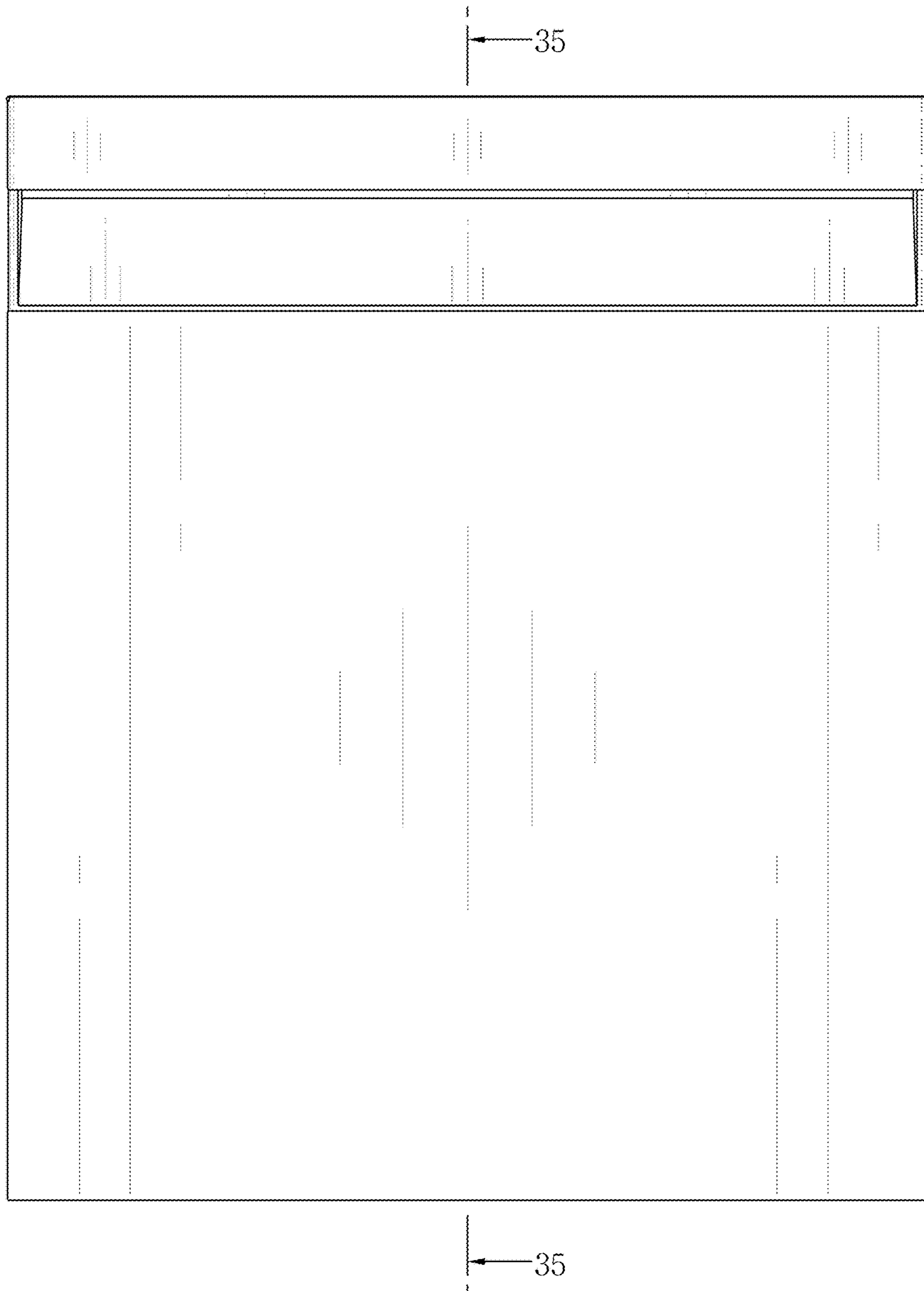

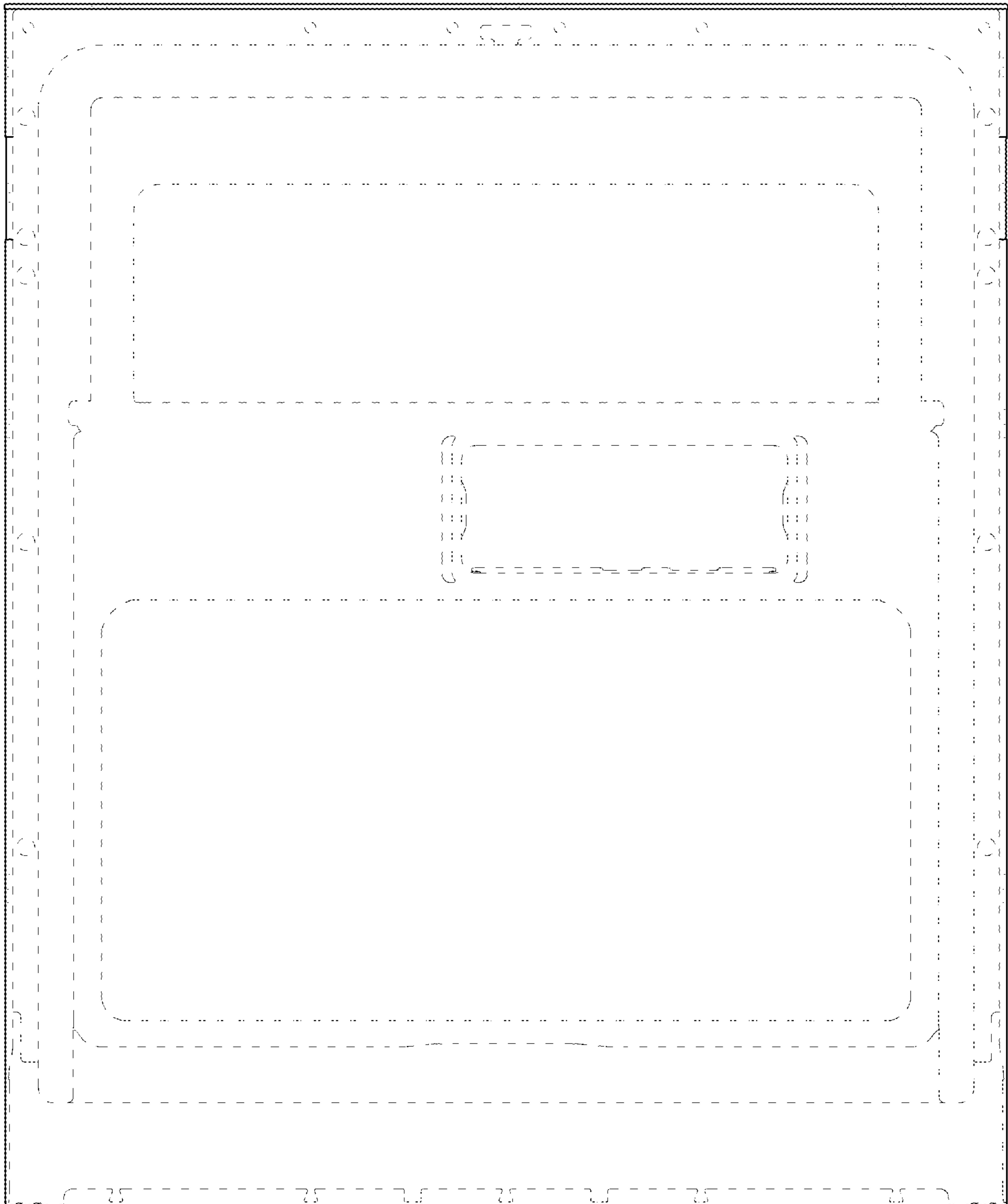

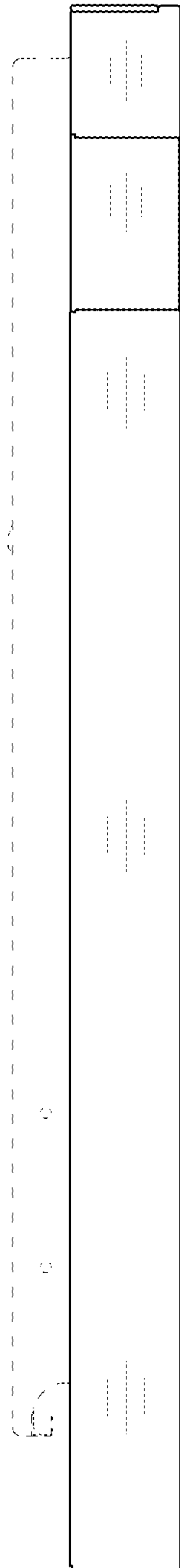

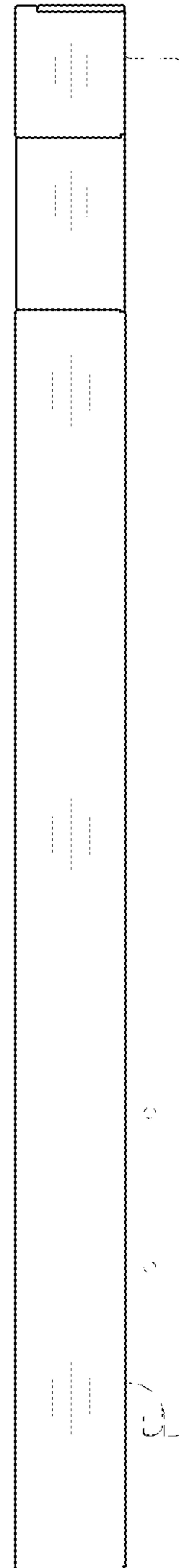

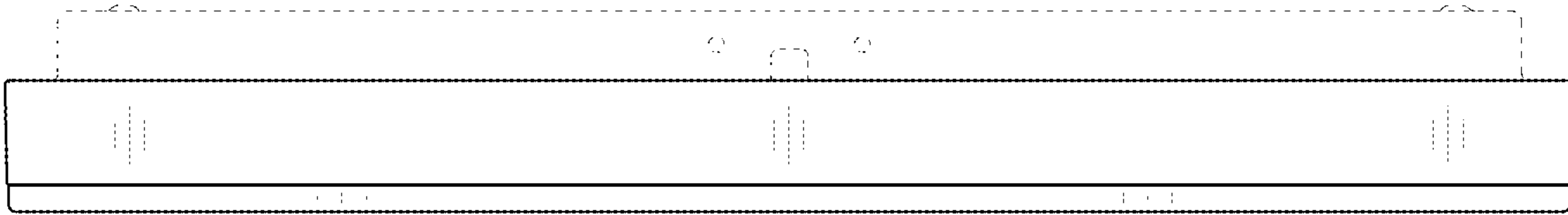

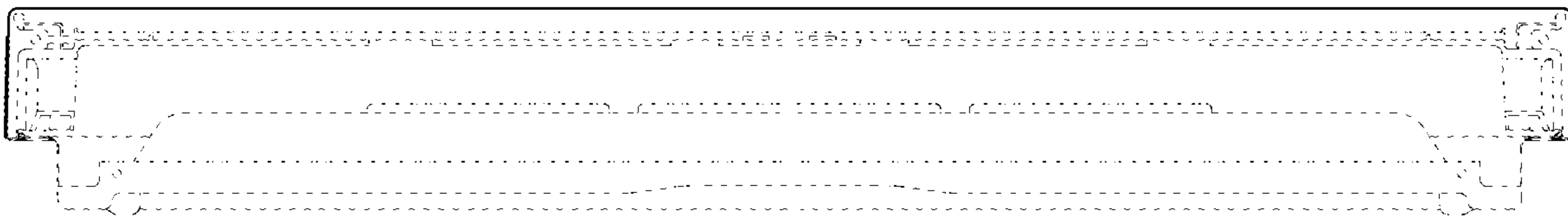

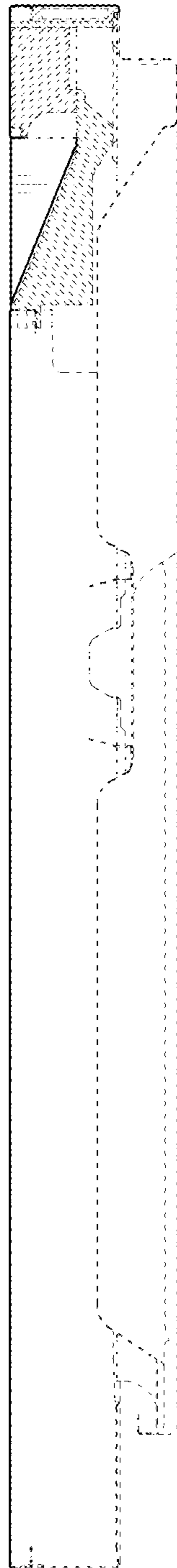
