The ornamental design for a toiletry bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom and front perspective view of a toiletry bag, showing my new design;

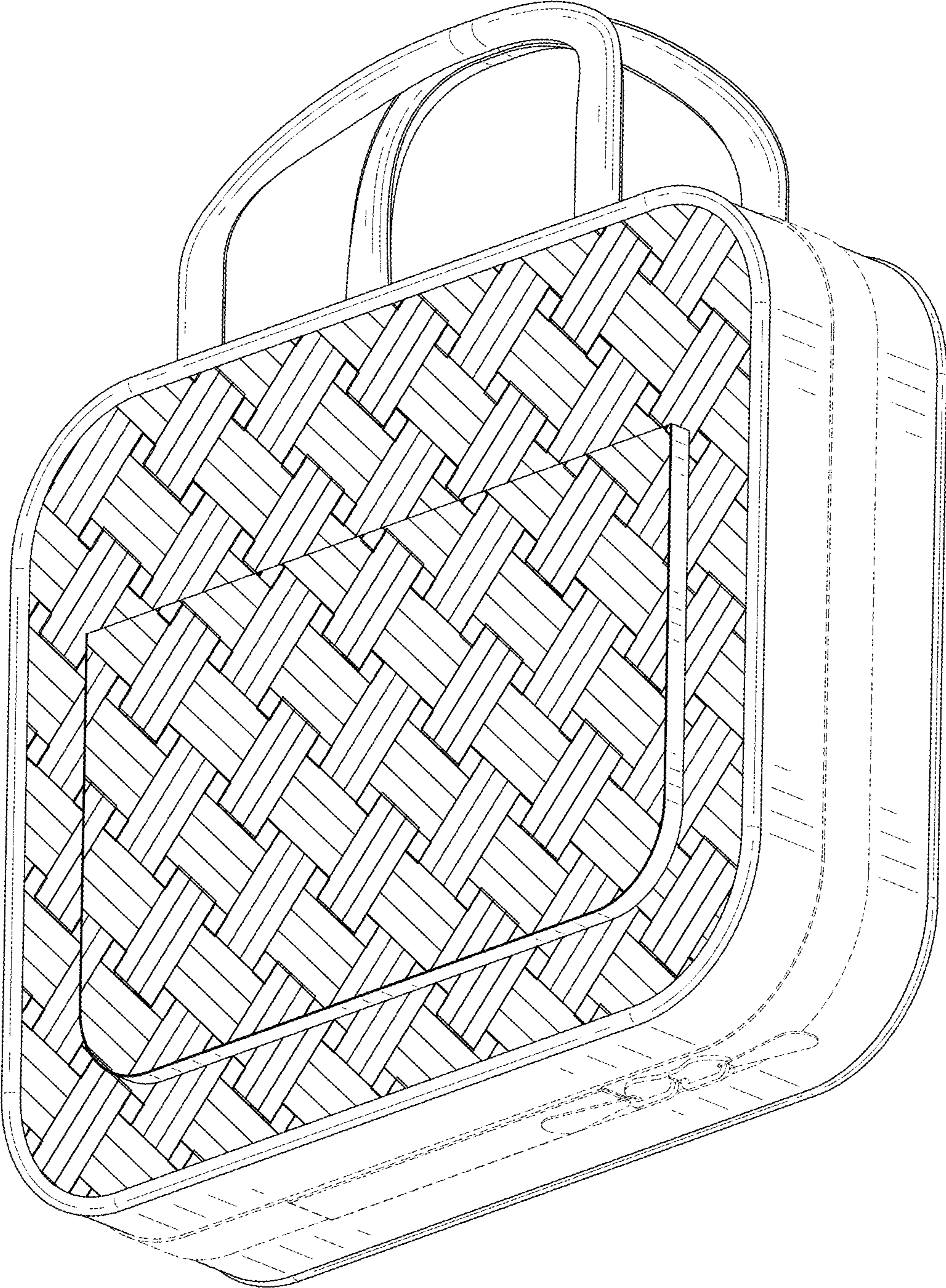

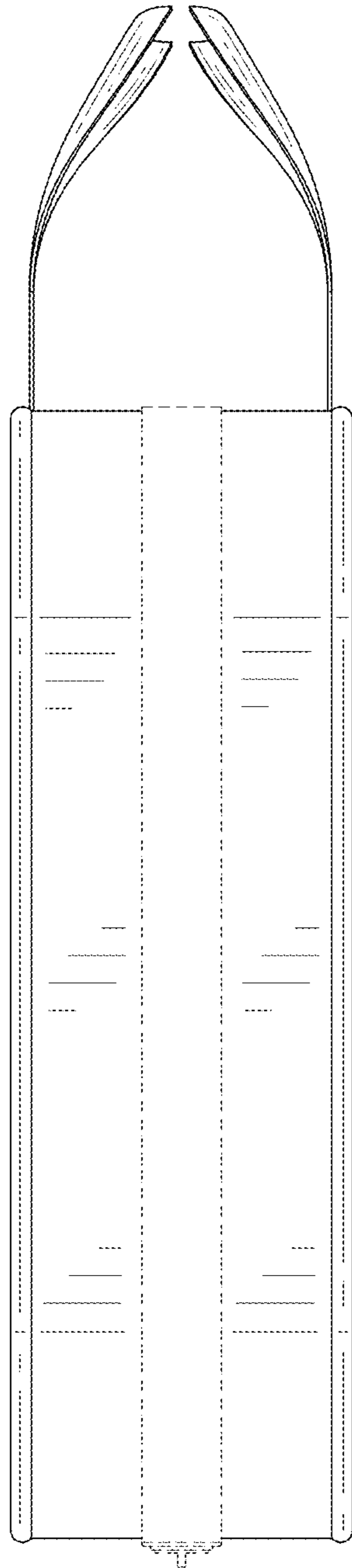

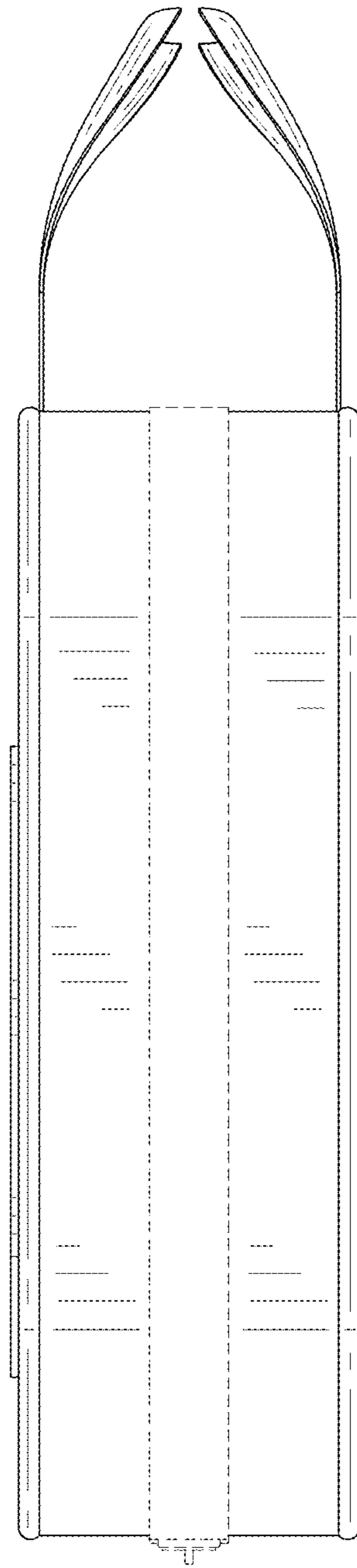

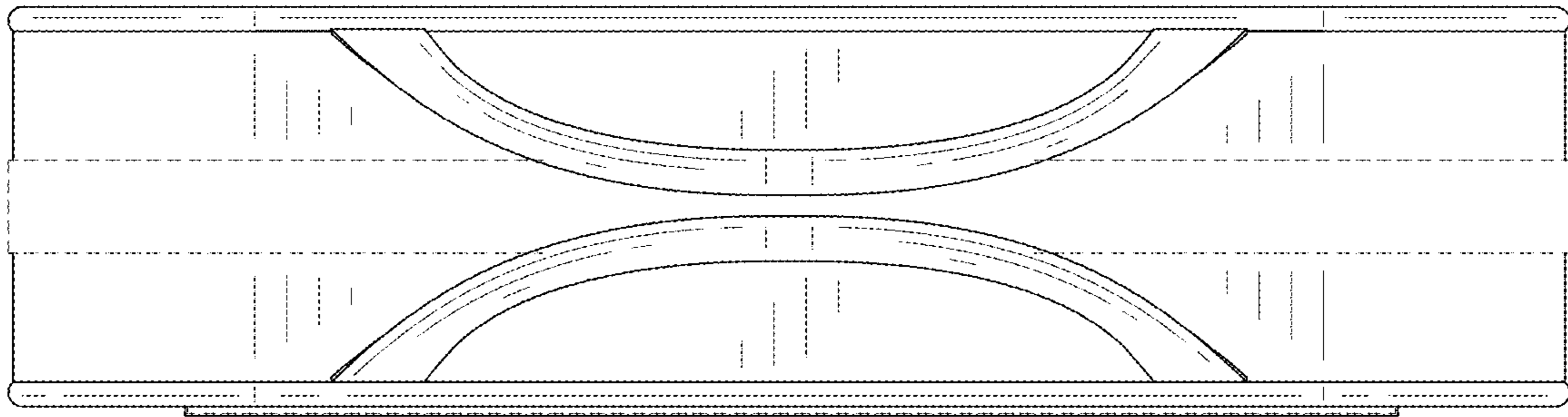

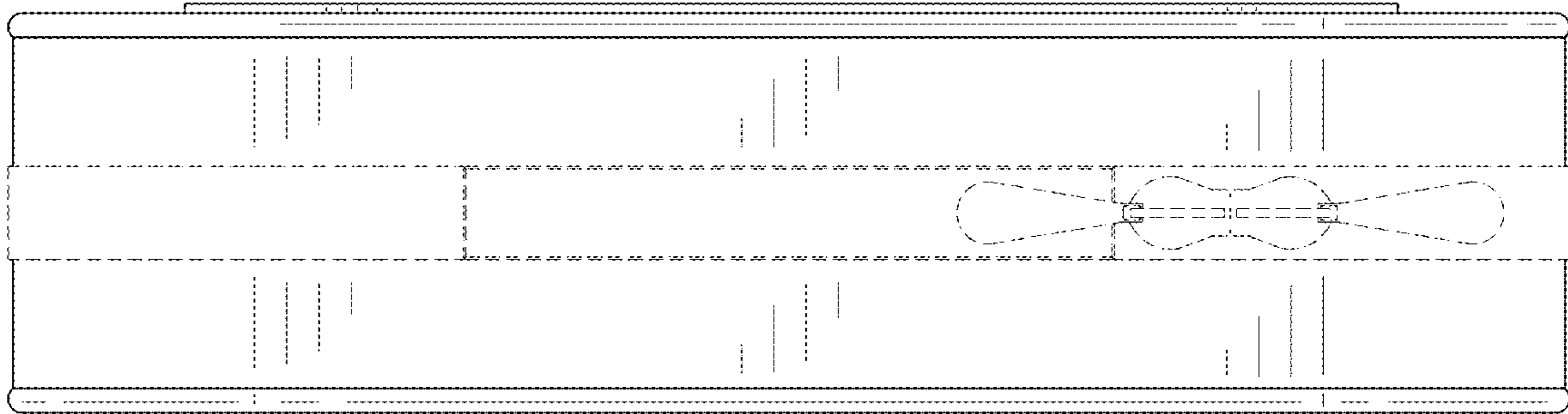
