(57) **CLAIM**

The ornamental design for a sports backpack, as shown and described.

DESCRIPTION

1. Sports backpack
 Figure 1.1 is a front perspective view of the sports backpack showing my new design;
 Figure 1.2 is a front view thereof;
 Figure 1.3 is a rear view thereof;
 Figure 1.4 is a right side view thereof;
 Figure 1.5 is a left side view thereof;
 Figure 1.6 is a top view thereof;
 Figure 1.7 is a bottom view thereof;
 Figure 1.8 is an enlarged perspective view thereof, with the lock mechanism shown in a closed condition of use;
 Figure 1.9 is an enlarged perspective view thereof, with the lock mechanism shown in a partially open condition of use;
 Figure 1.10 is another enlarged perspective view thereof, with the lock mechanism shown in a fully open condition of use; AND
 Figure 1.11 is another enlarged perspective view thereof.
 The dashed lines in the drawings depict thread stitching and forms part of the claimed design.

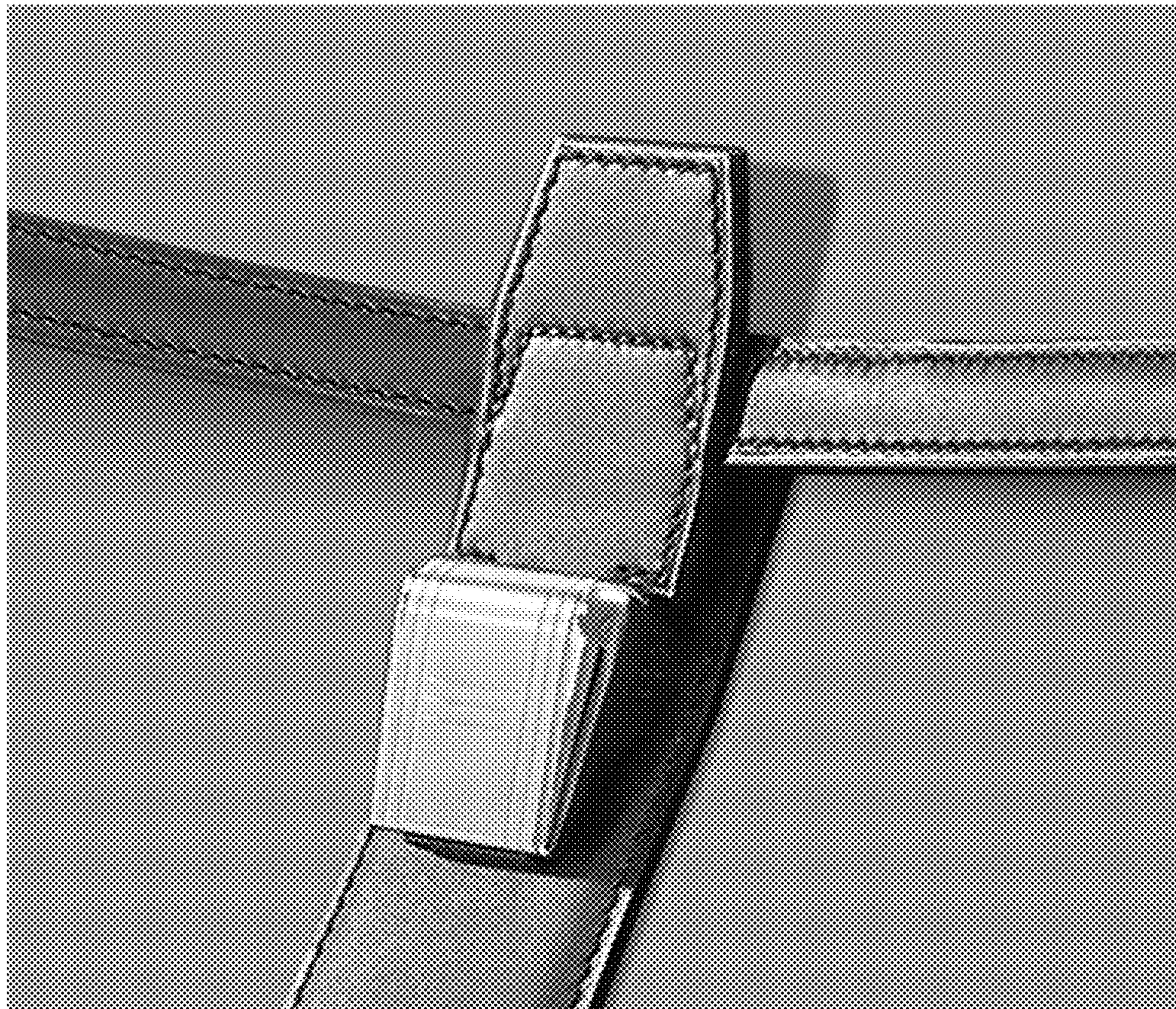

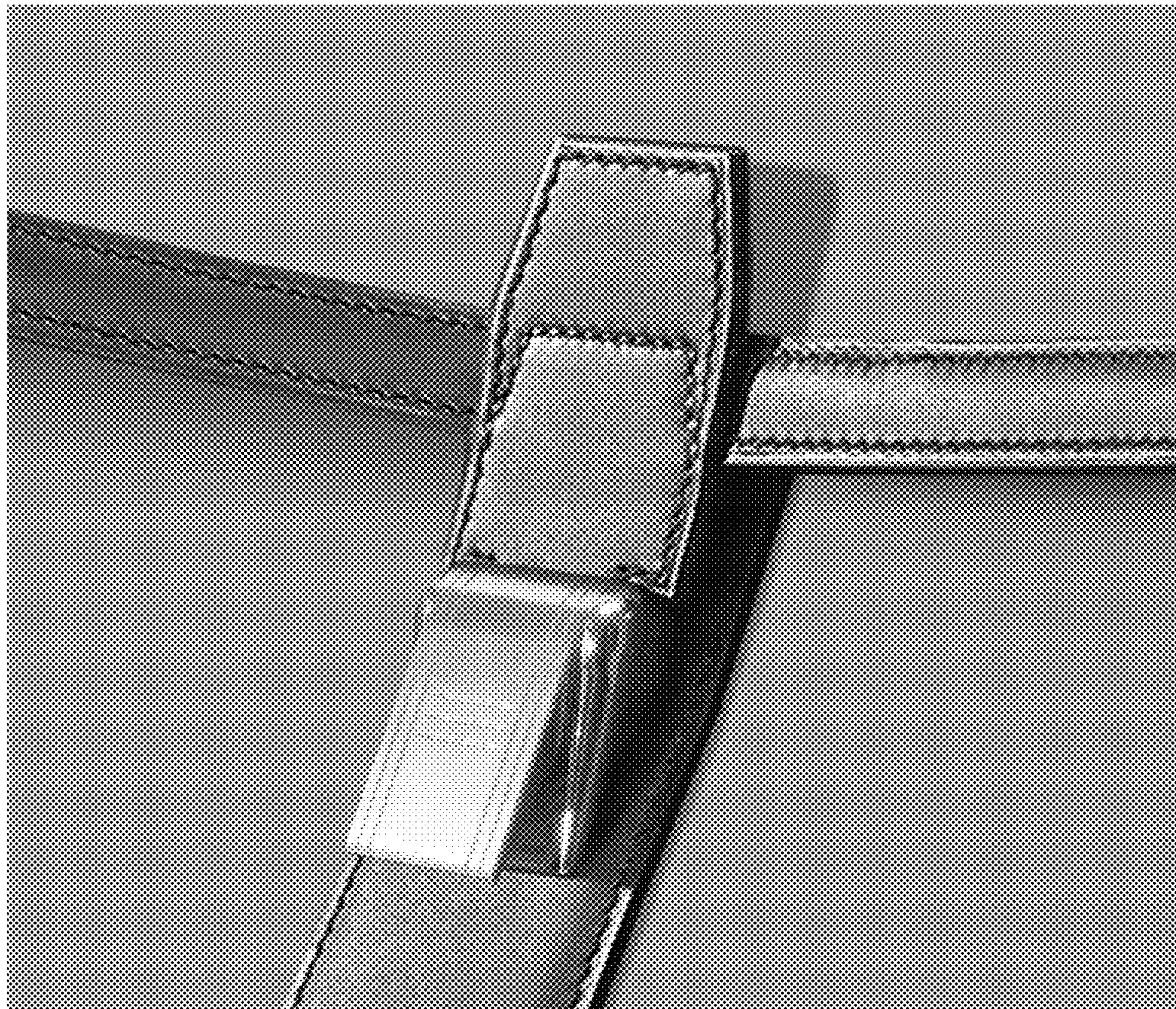
