(57) **CLAIM**

The ornamental design for a folded towel dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a top-quartering perspective view of a folded towel dispenser embodying the principles of the present invention; FIG. 2 is a front view of the folded towel dispenser seen in FIG. 1; FIG. 3 is a rear view of the folded towel dispenser seen in FIG. 1; FIG. 4 is a left side view of the folded towel dispenser seen in FIG. 1, the right side view being a mirror image of the same; FIG. 5 is a top view of the folded towel dispenser seen in FIG. 1; and, FIG. 6 is a bottom view of the folded towel dispenser seen in FIG. 1.

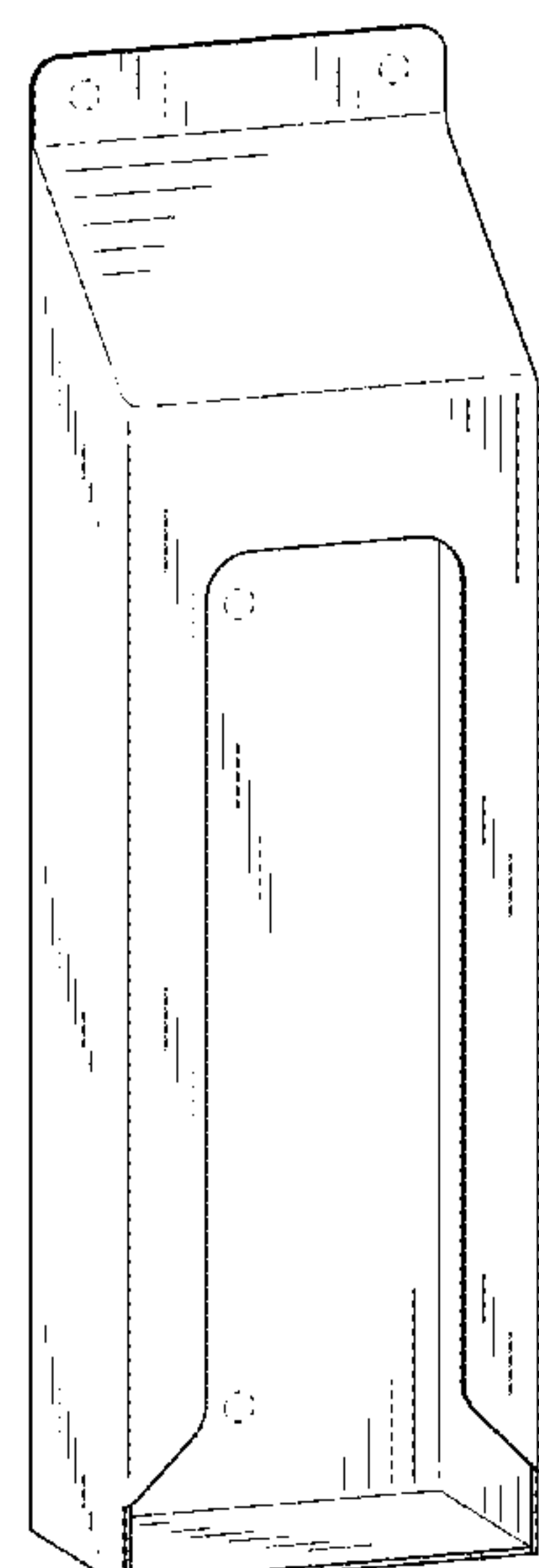

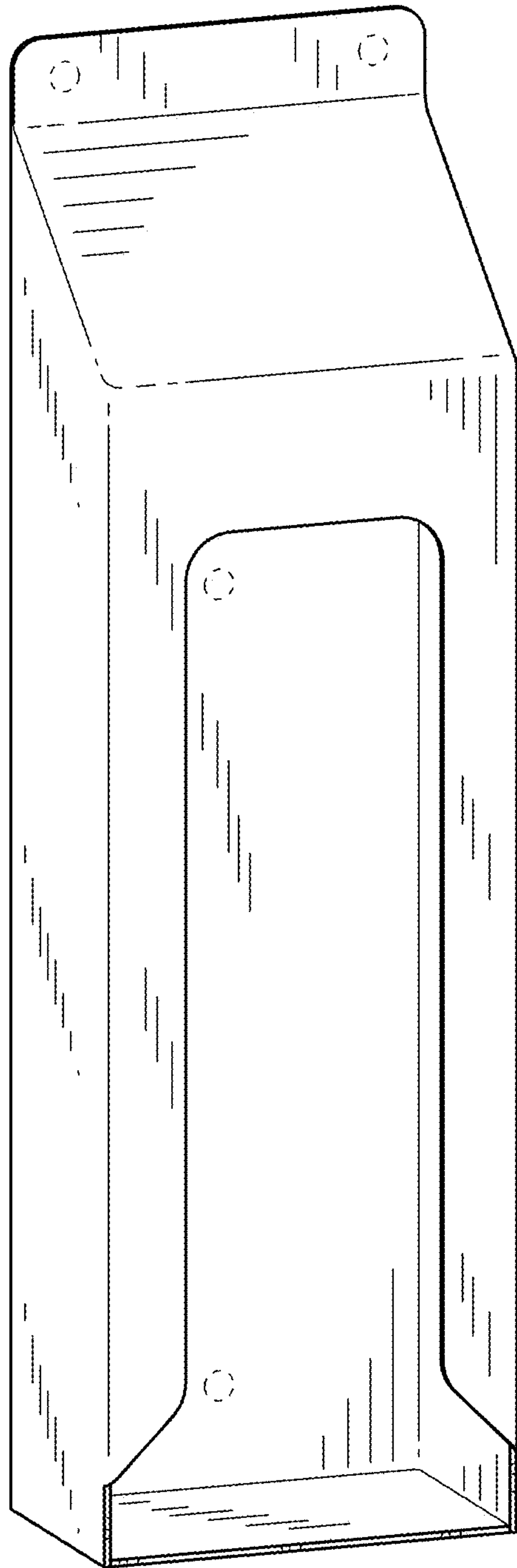

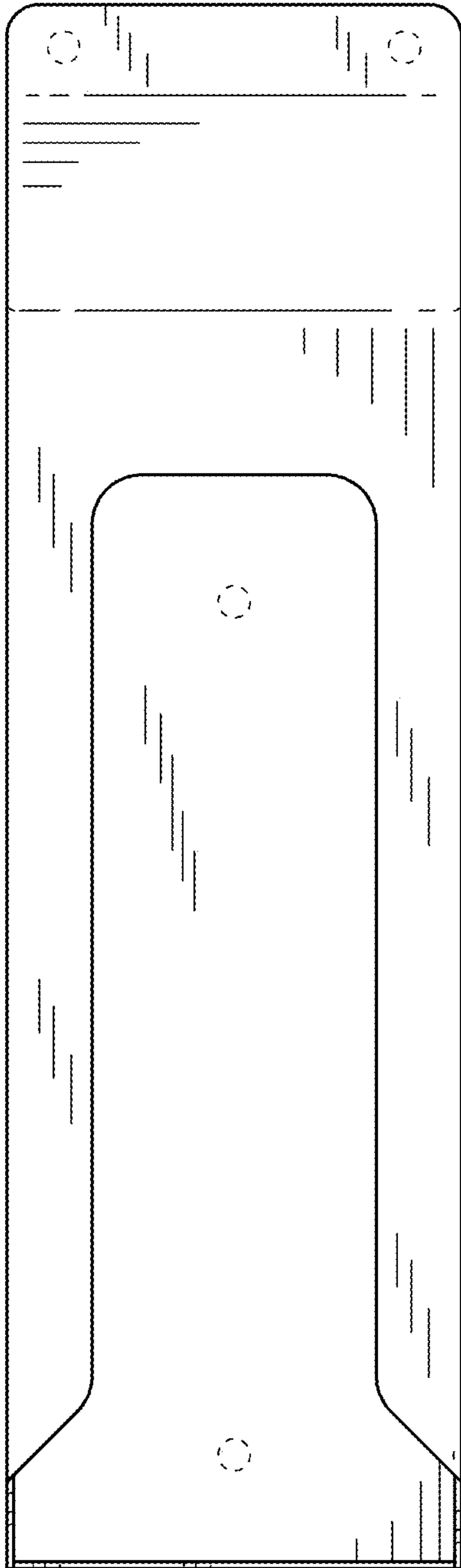

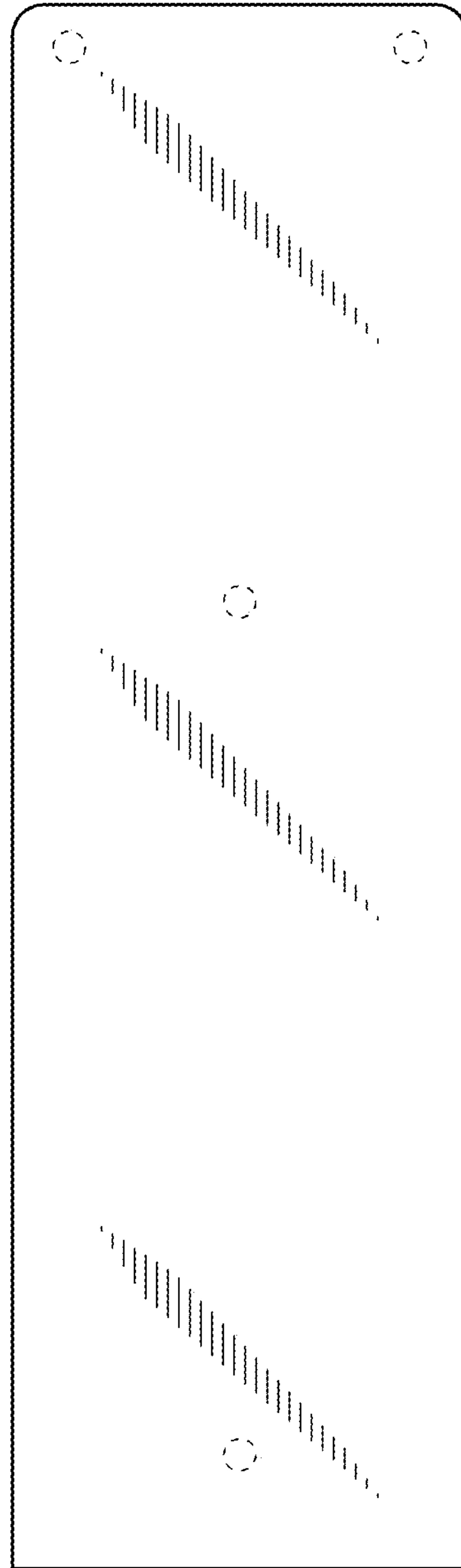

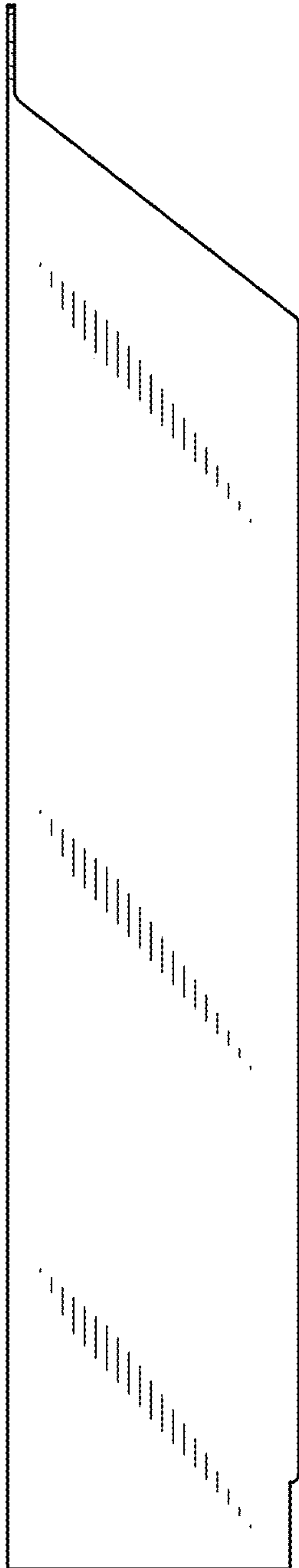

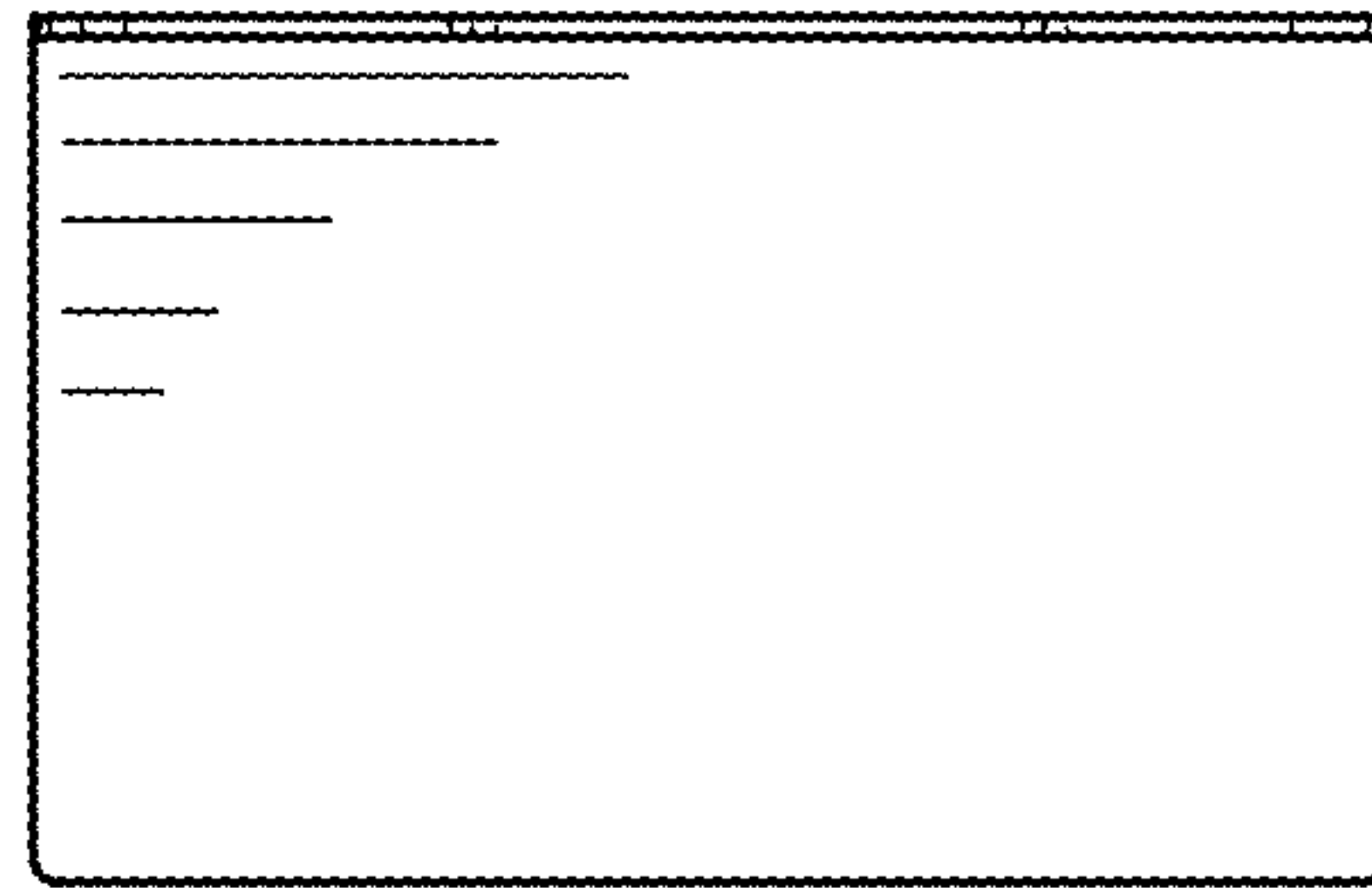

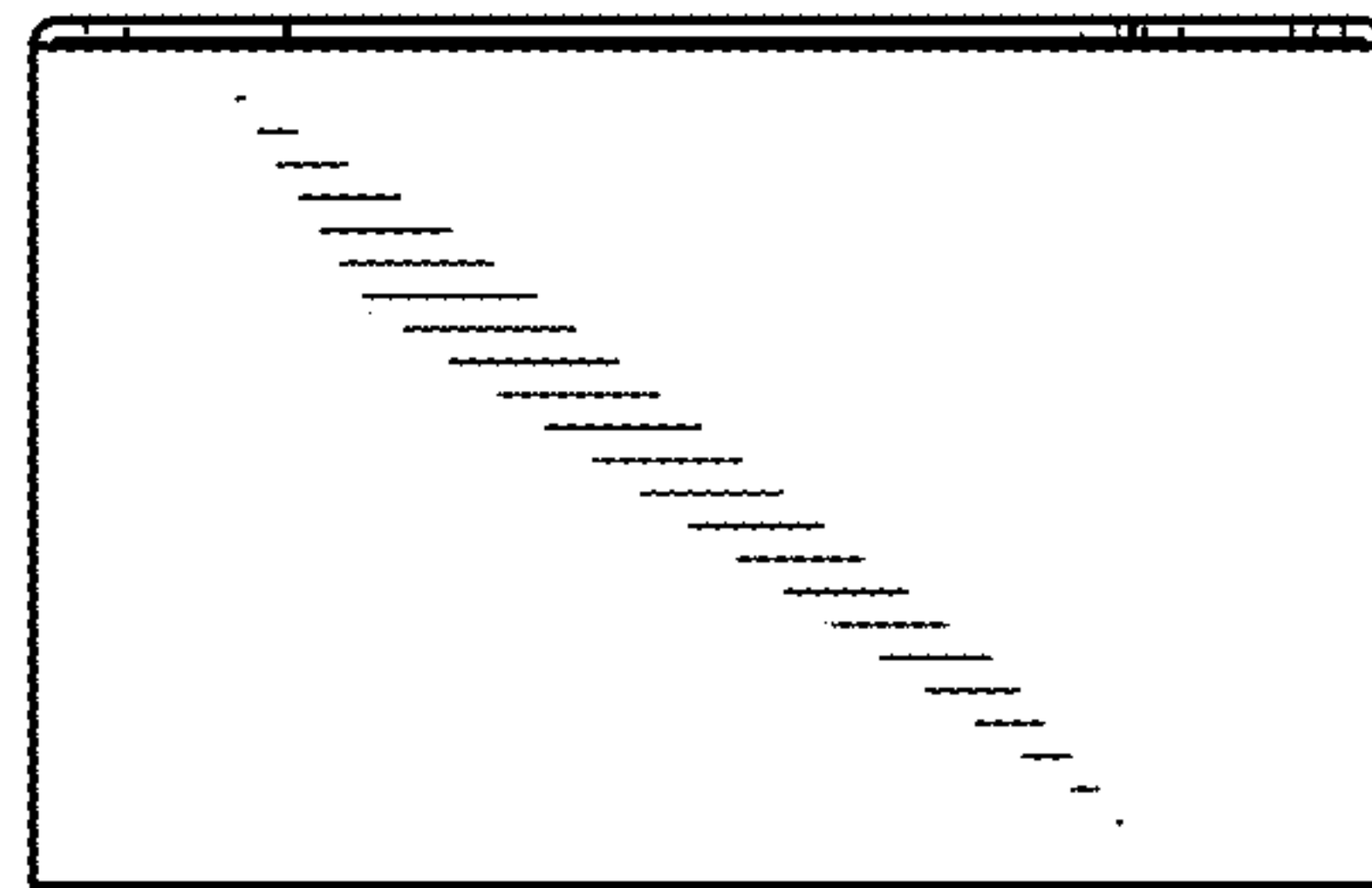
