The ornamental design for a protective sleeve for covering an 8-ounce regular mouth mason jar, as shown and described.

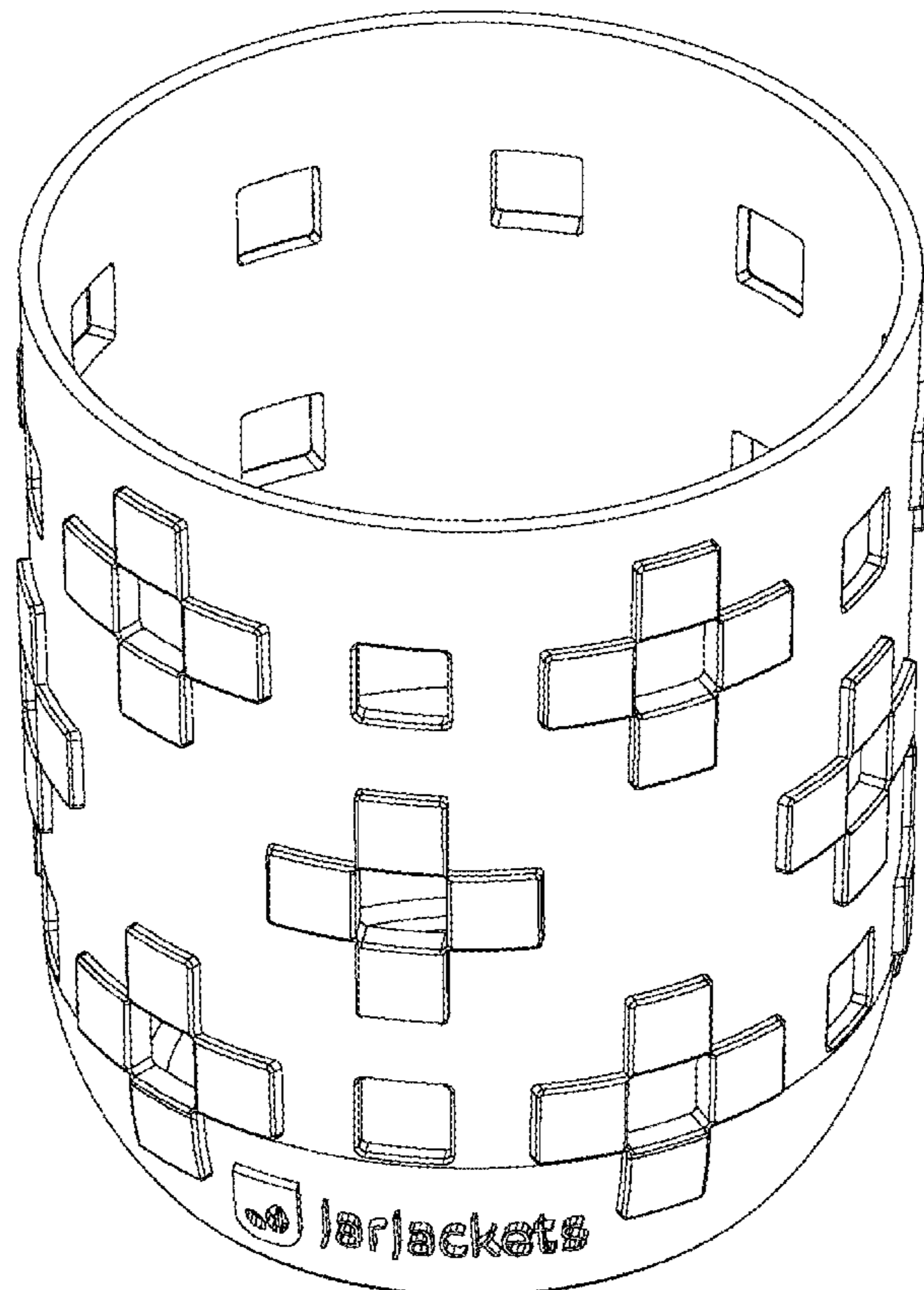

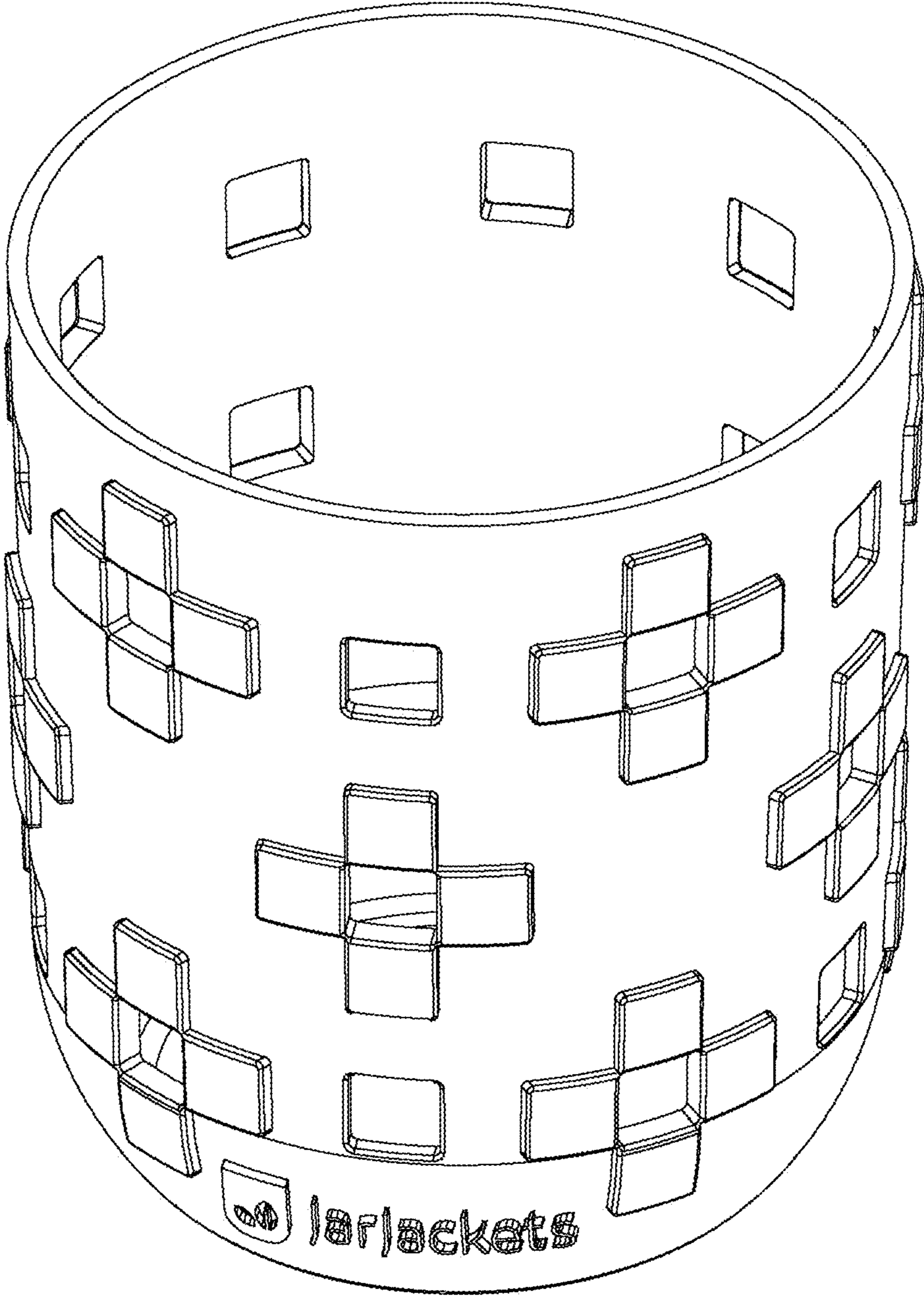

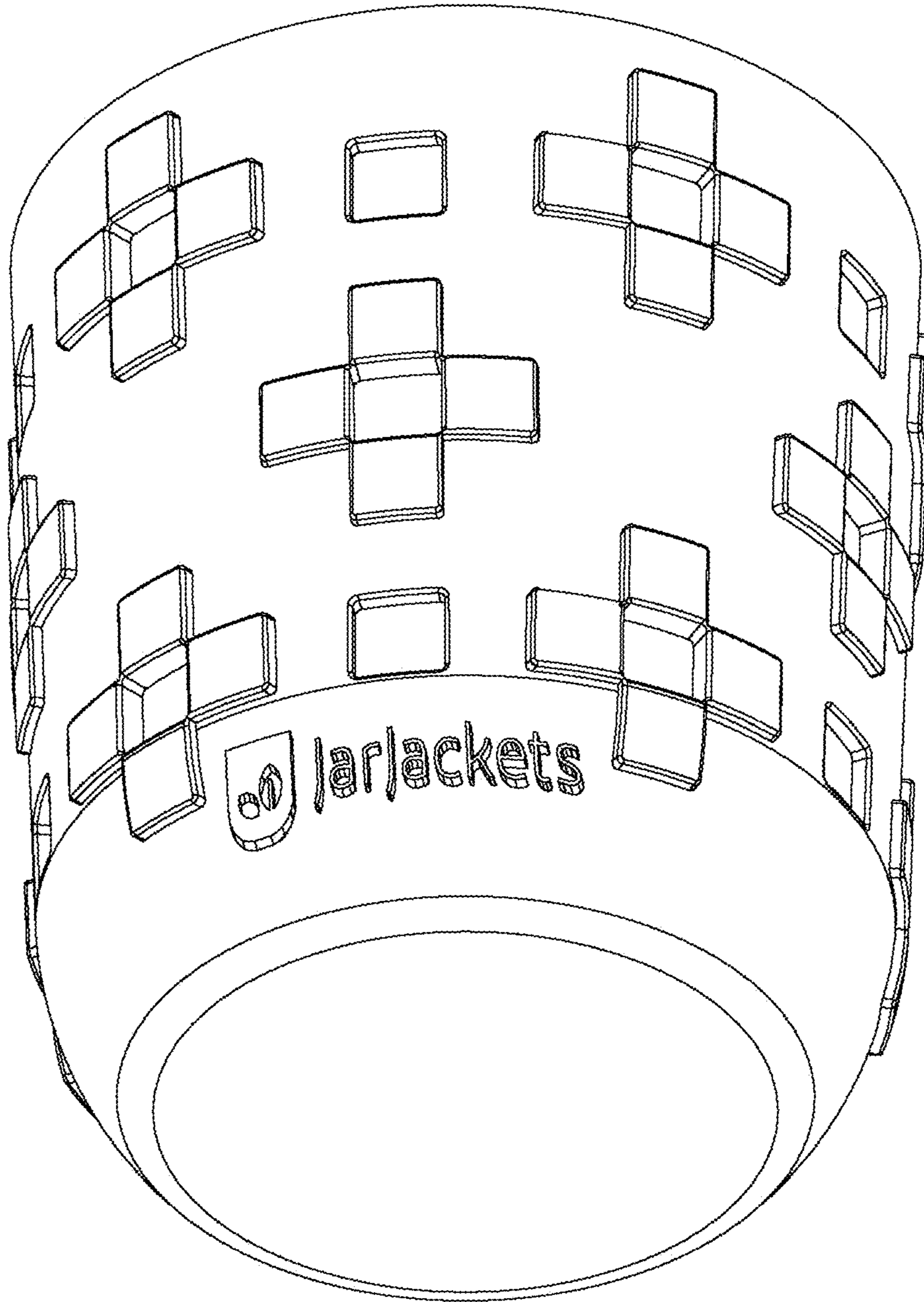

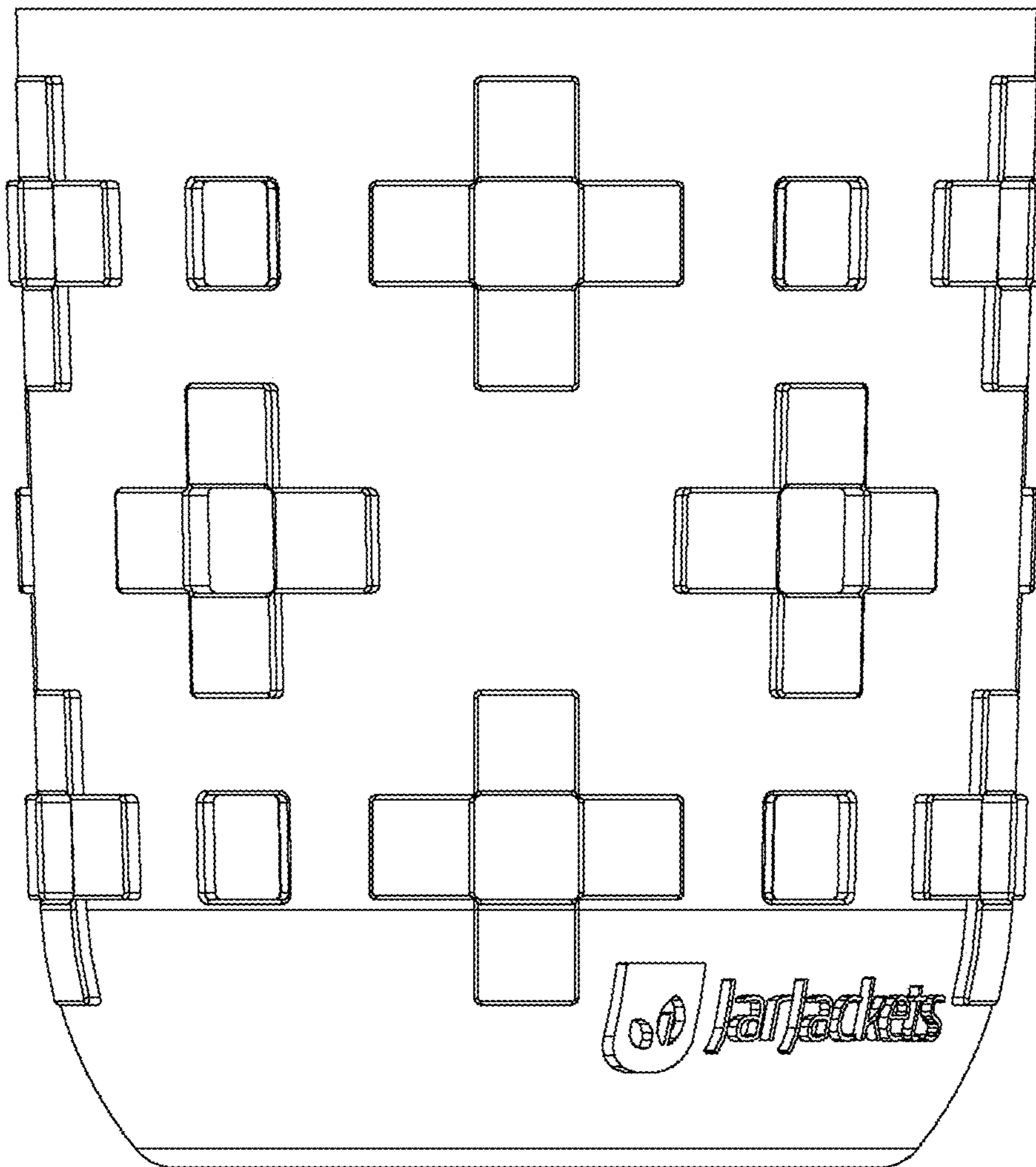

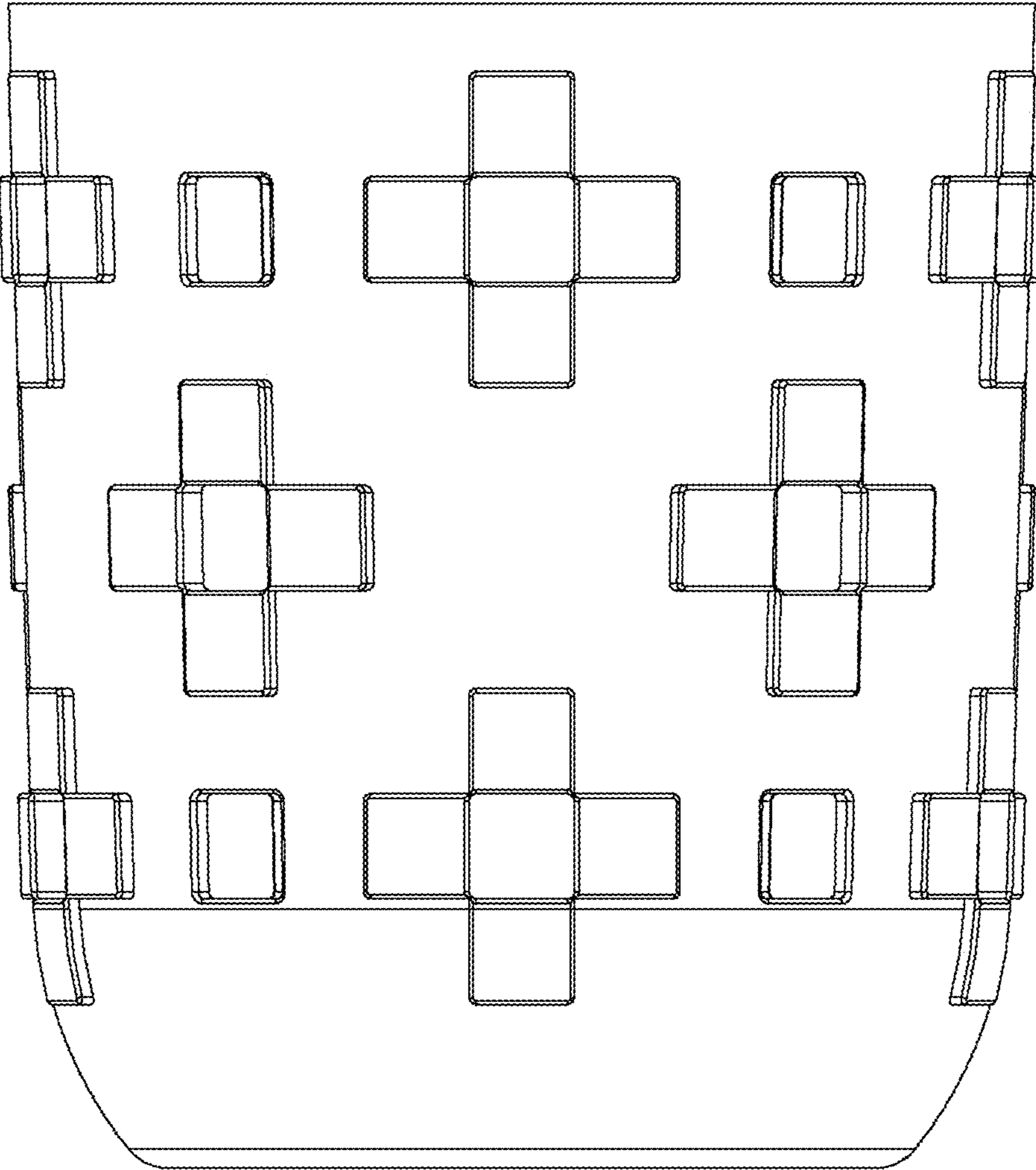

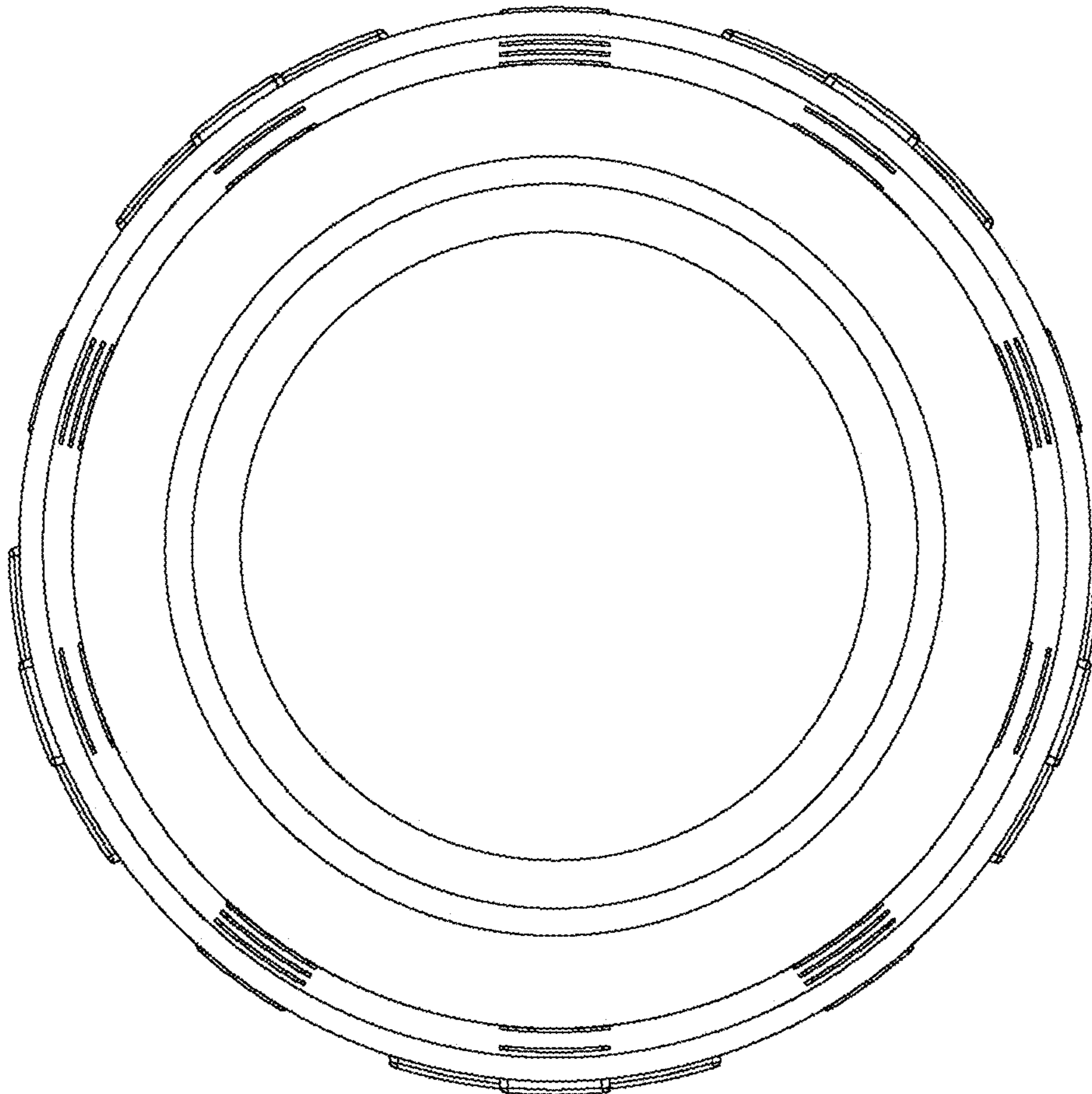
