DESCRIPTION

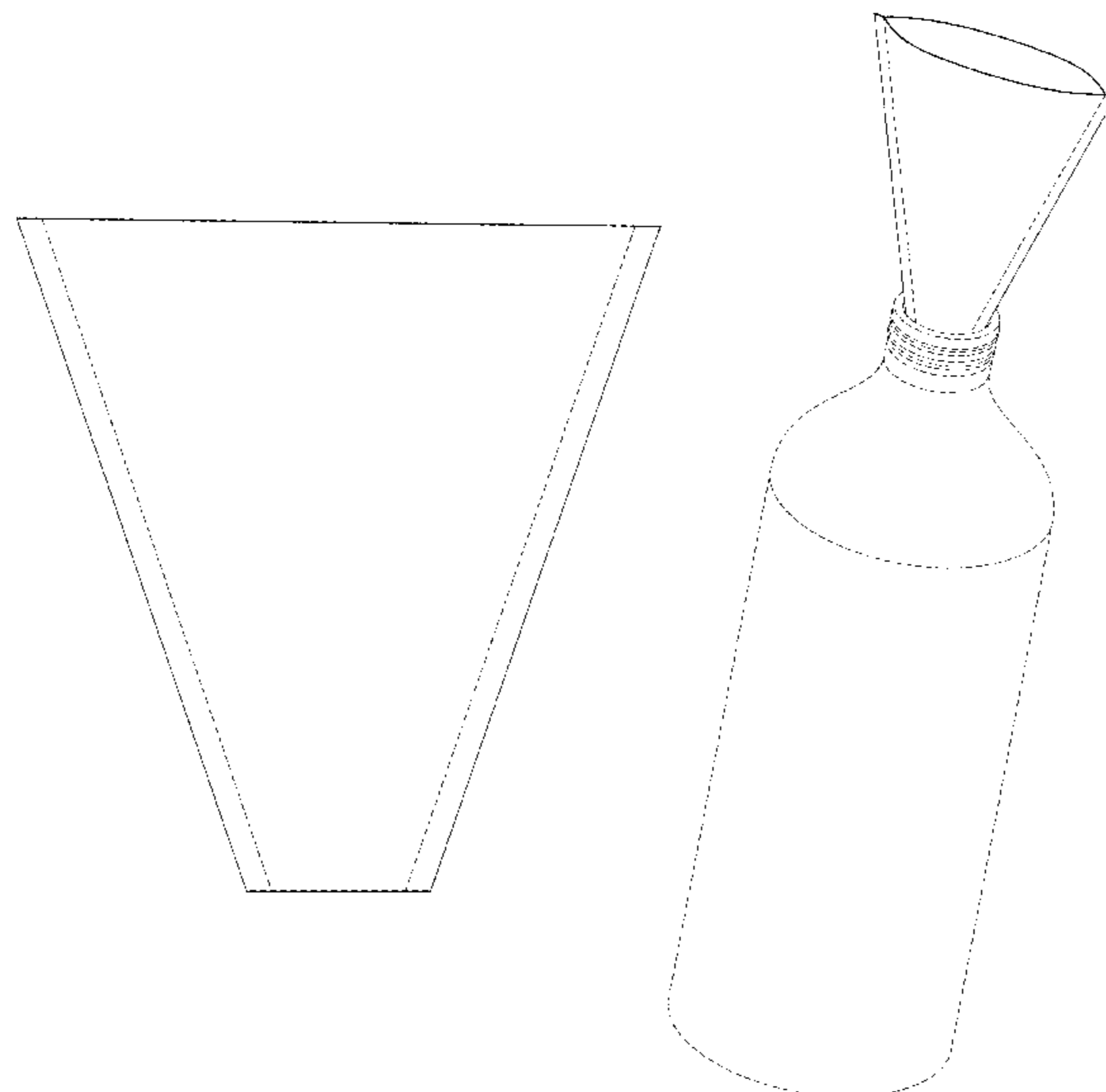
FIG. 1 is a front view of portable funnel showing new design;

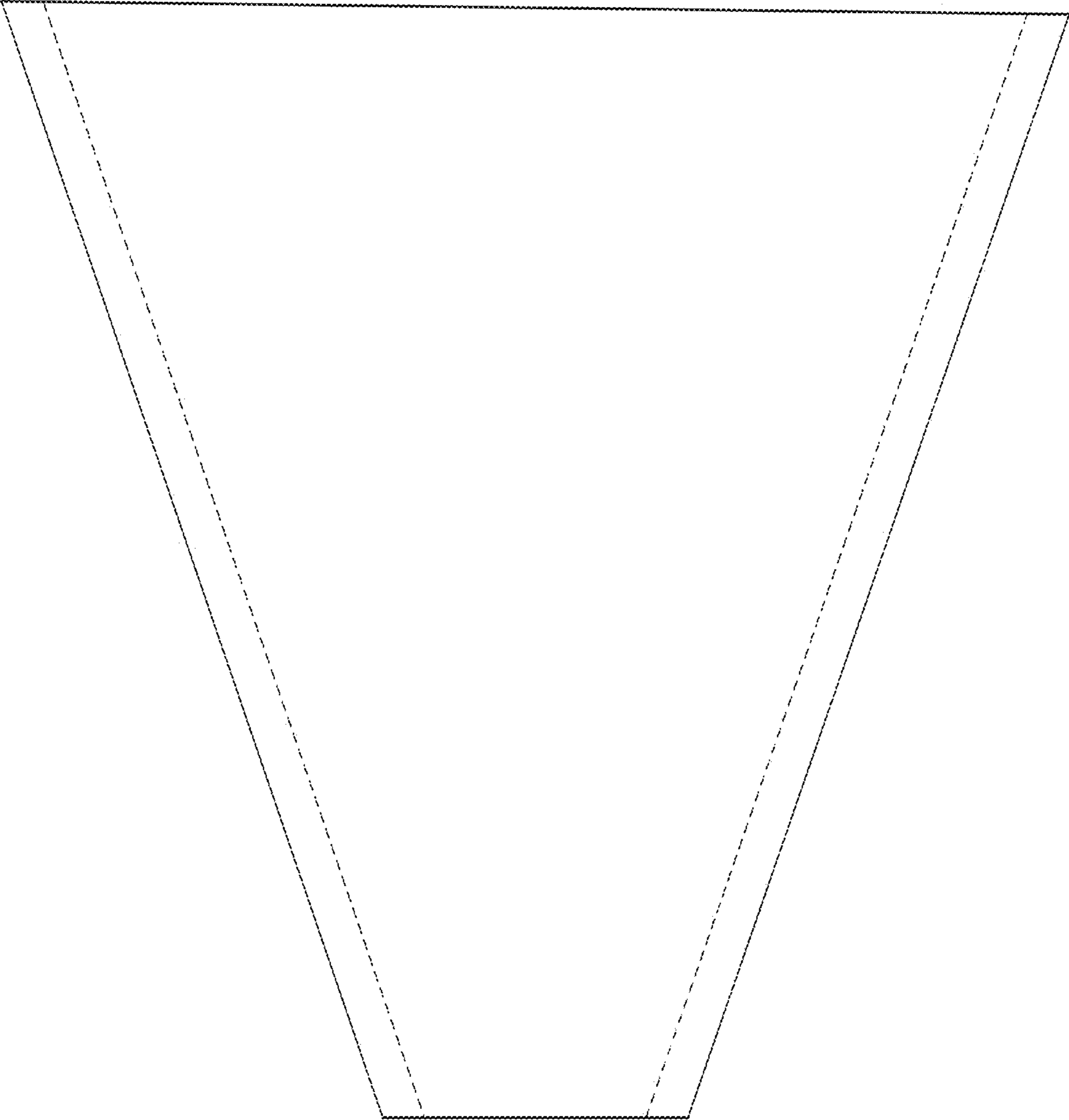

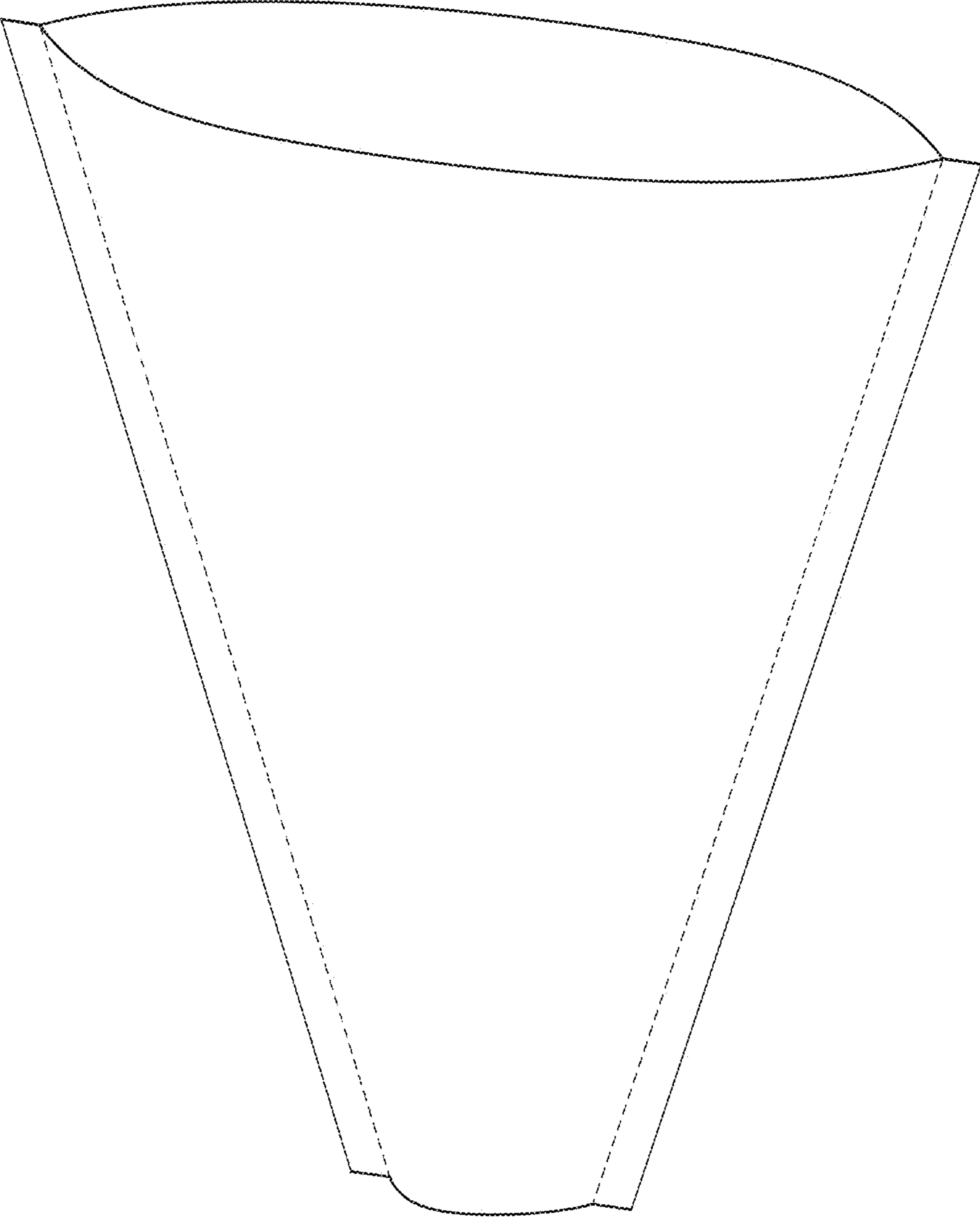

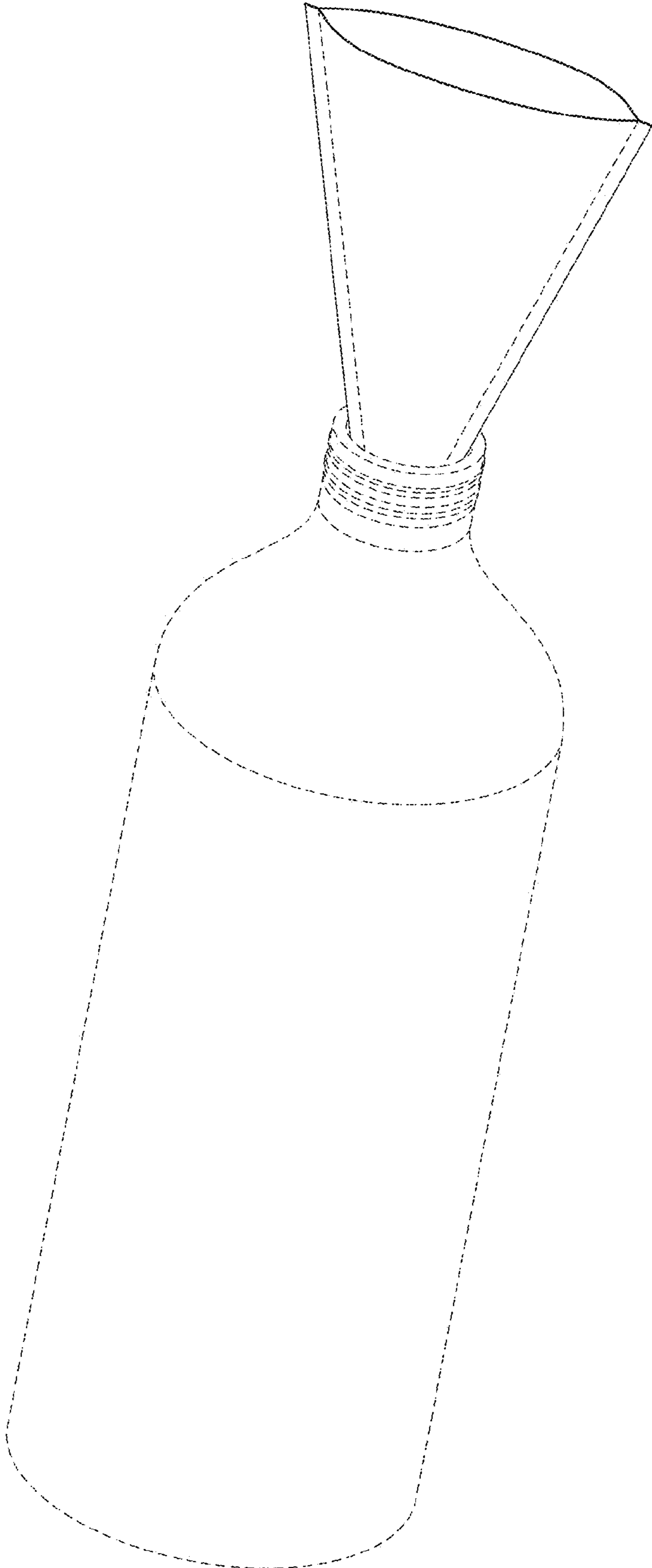
