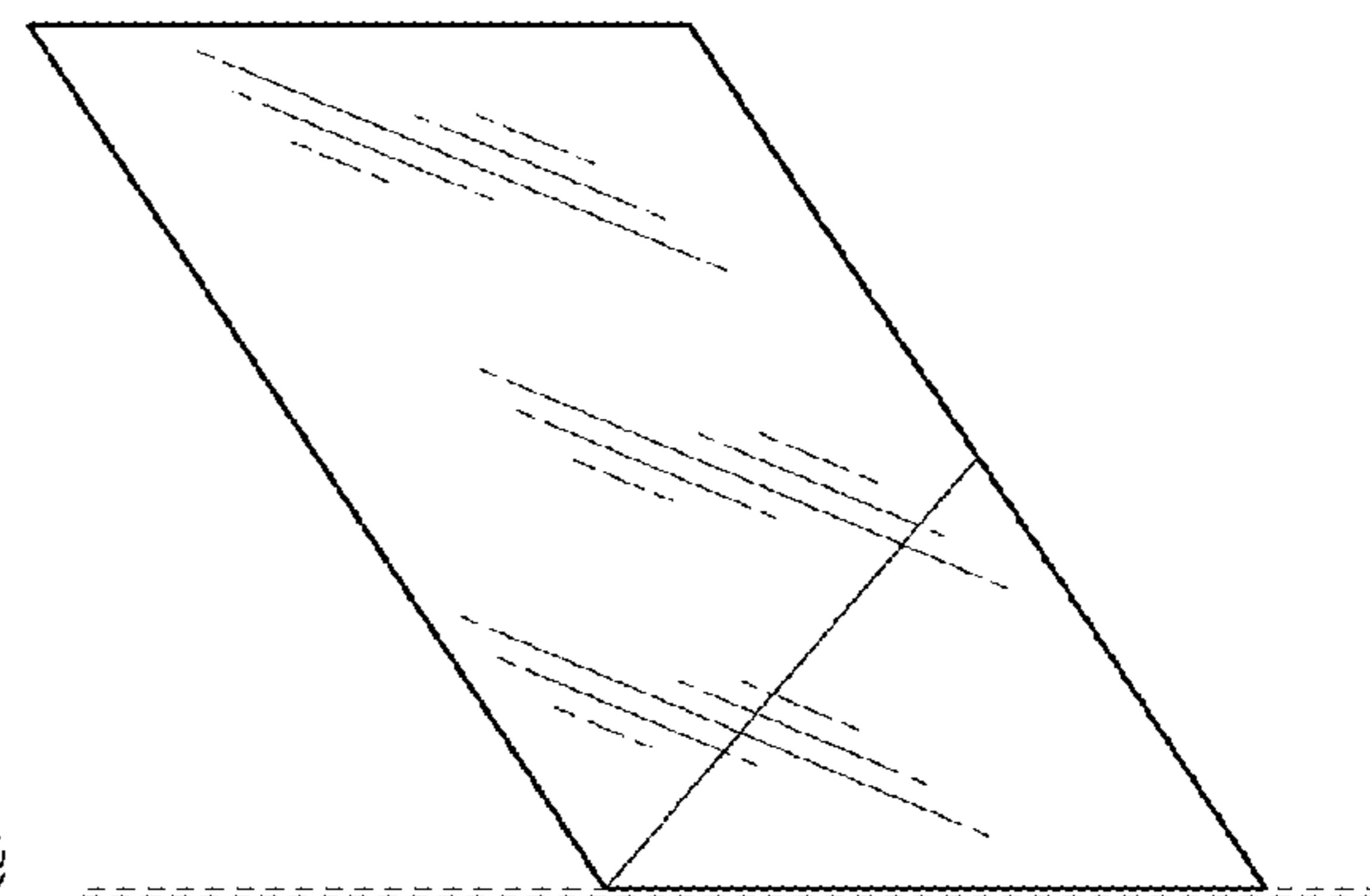
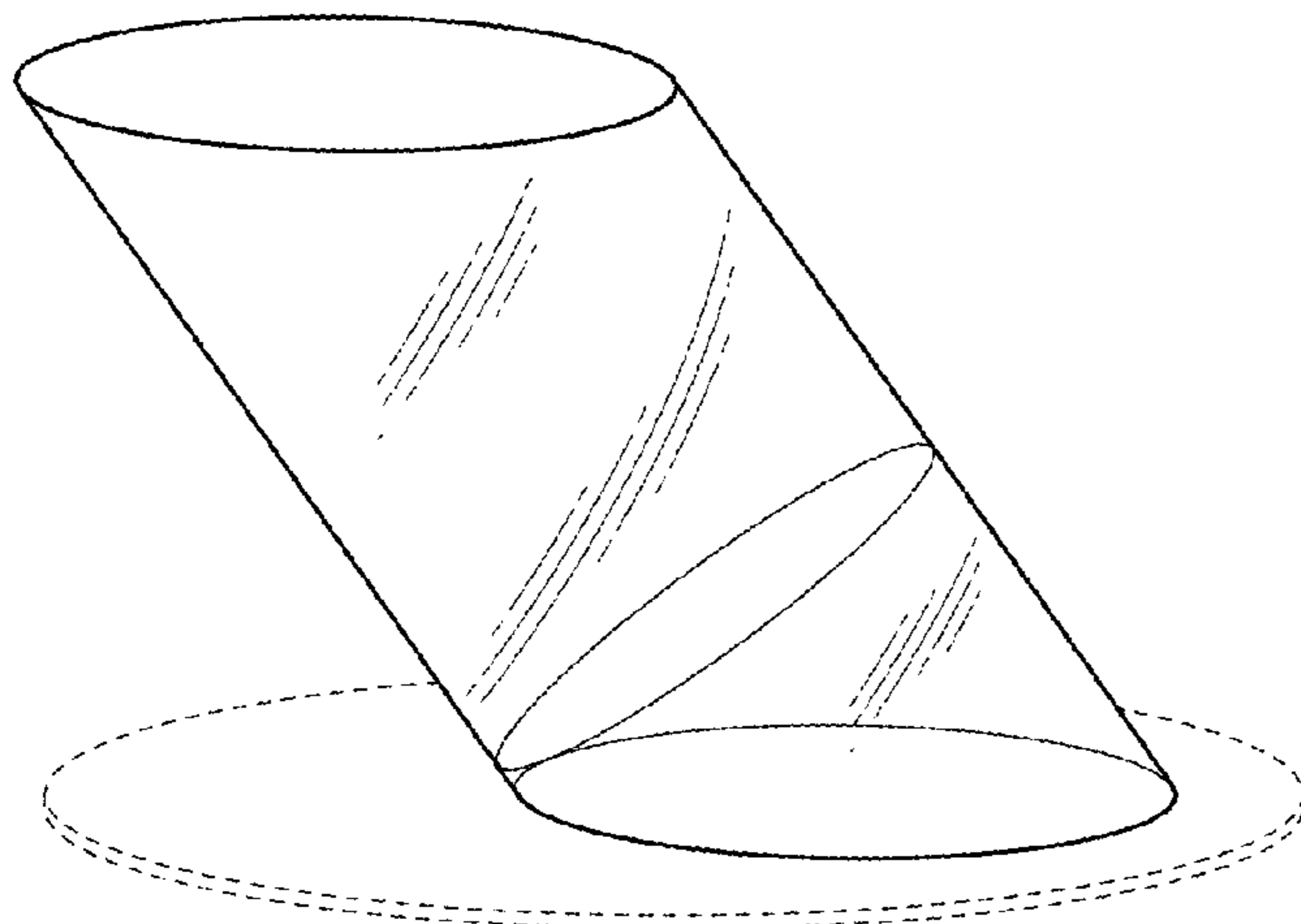
(57) **CLAIM**

The ornamental design for a tattoo ink cap, substantially as shown and described.

DESCRIPTION

FIG. 1 is a right perspective view of a tattoo ink cap, showing my new design;

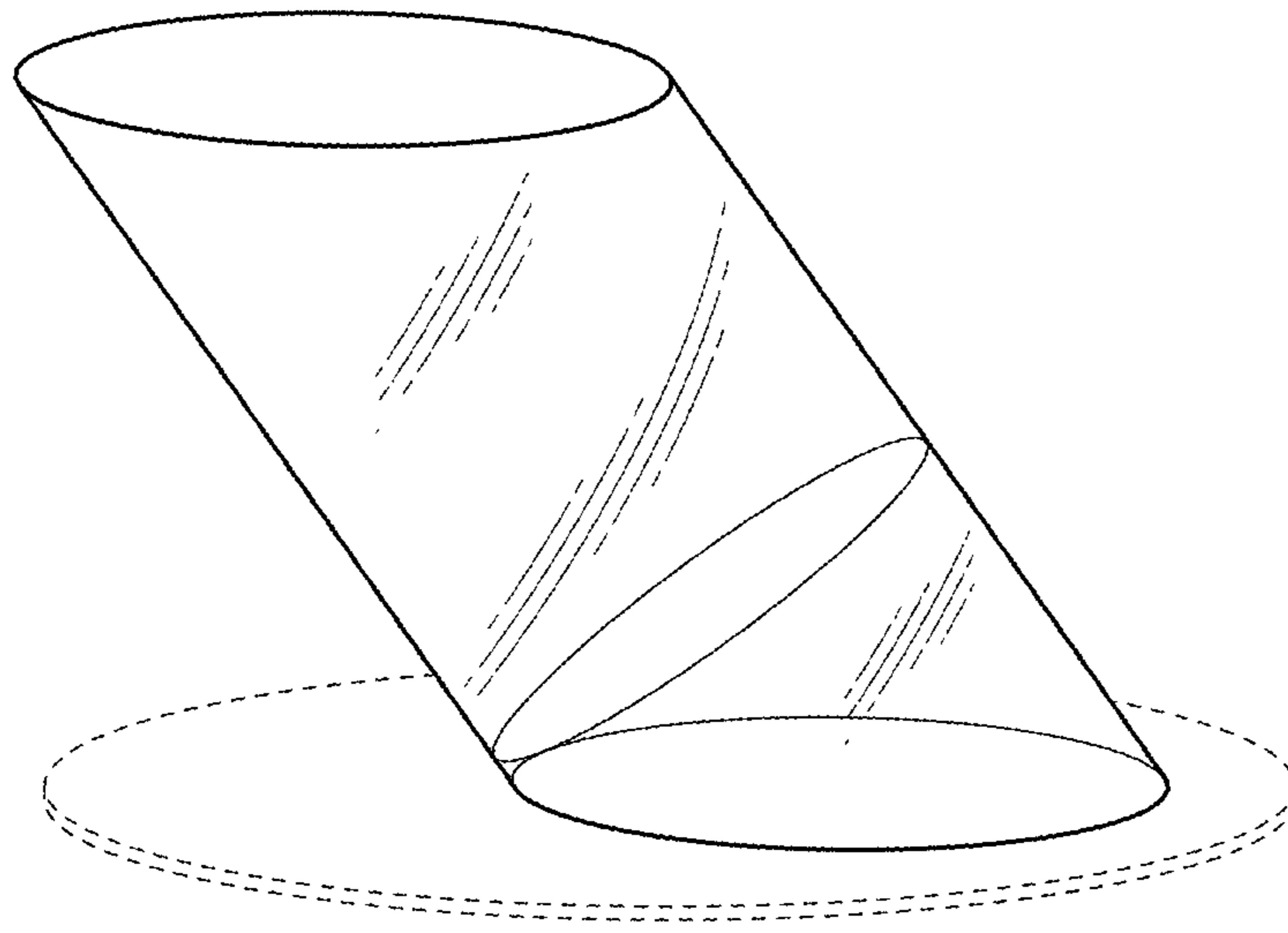

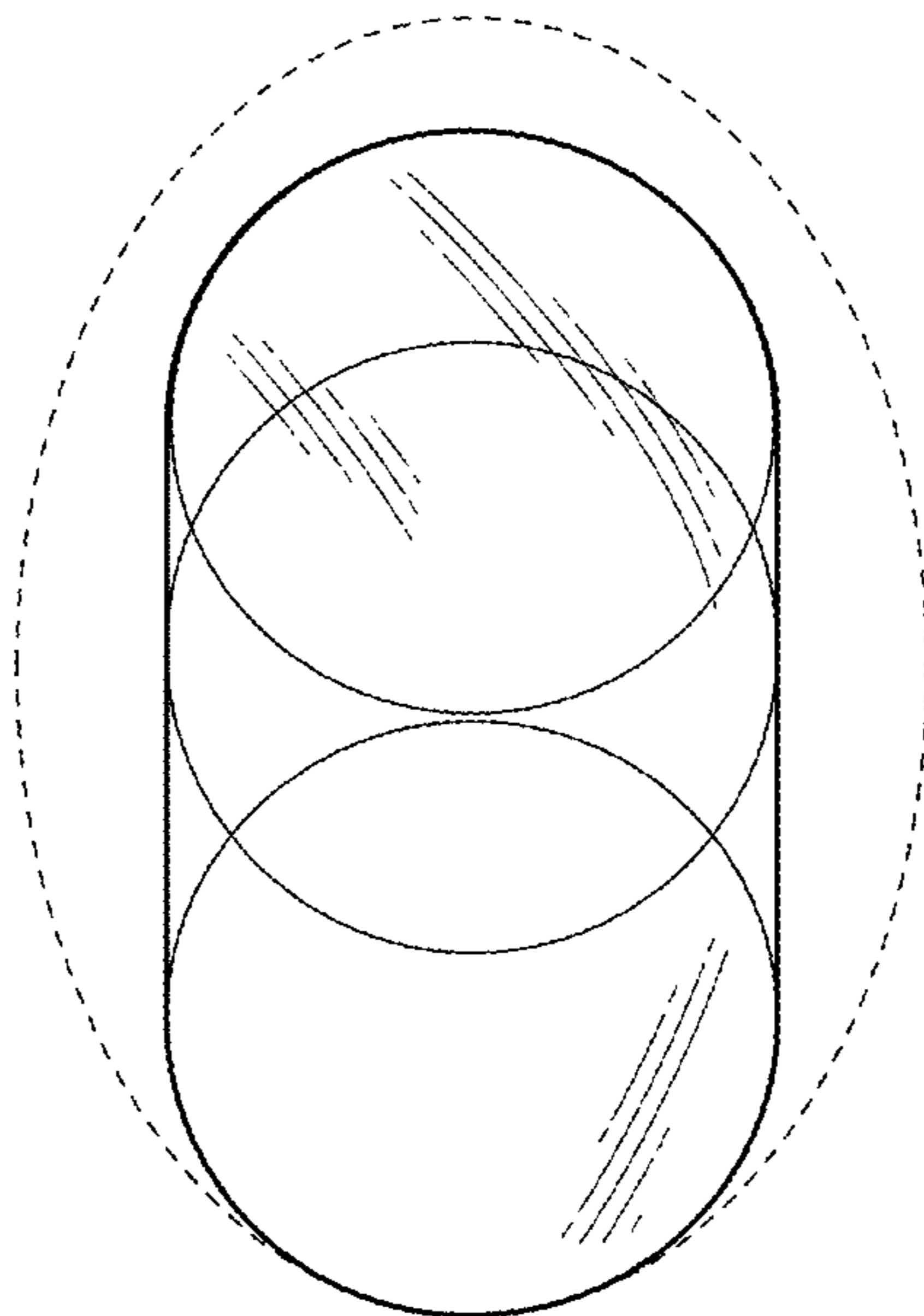

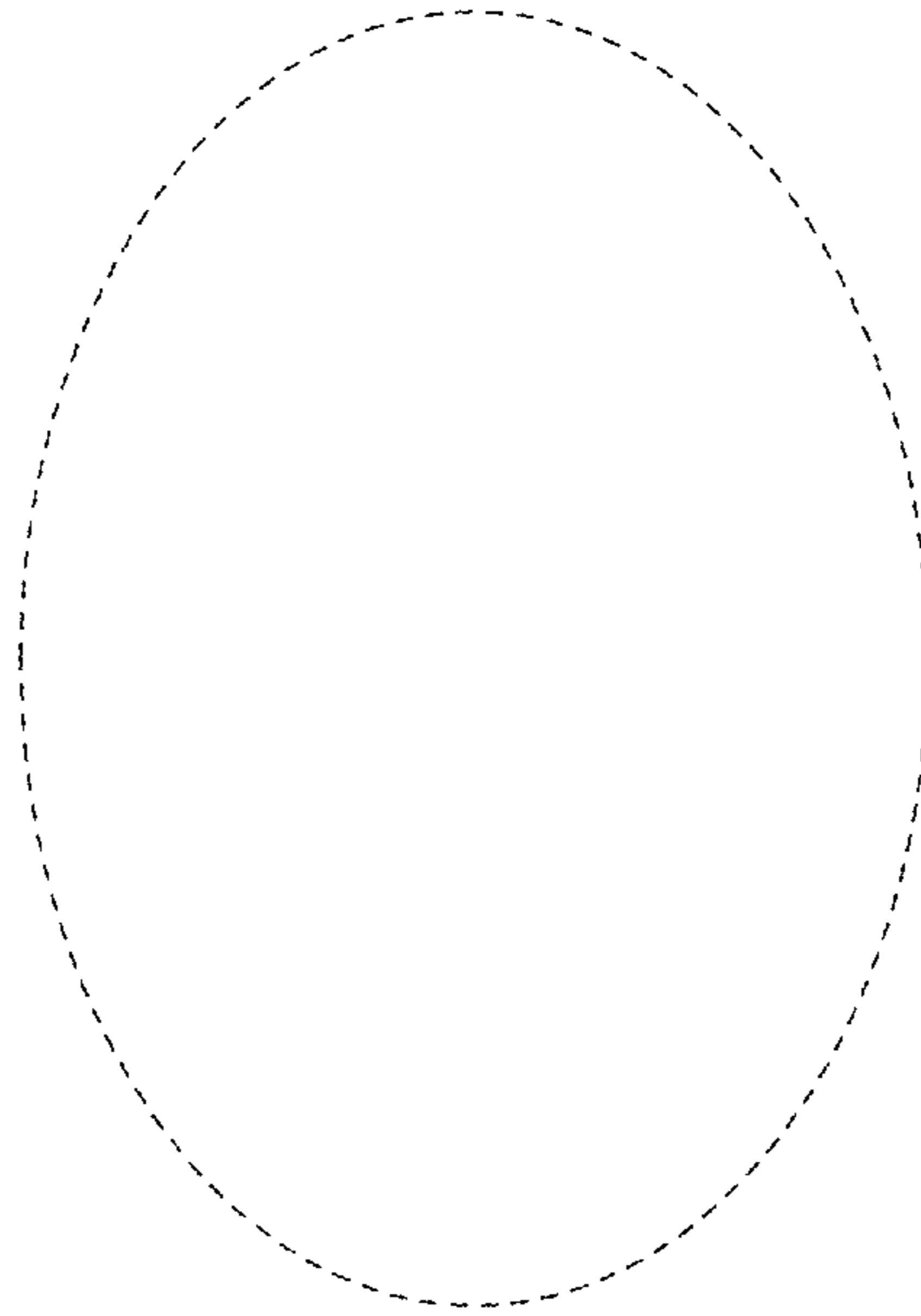

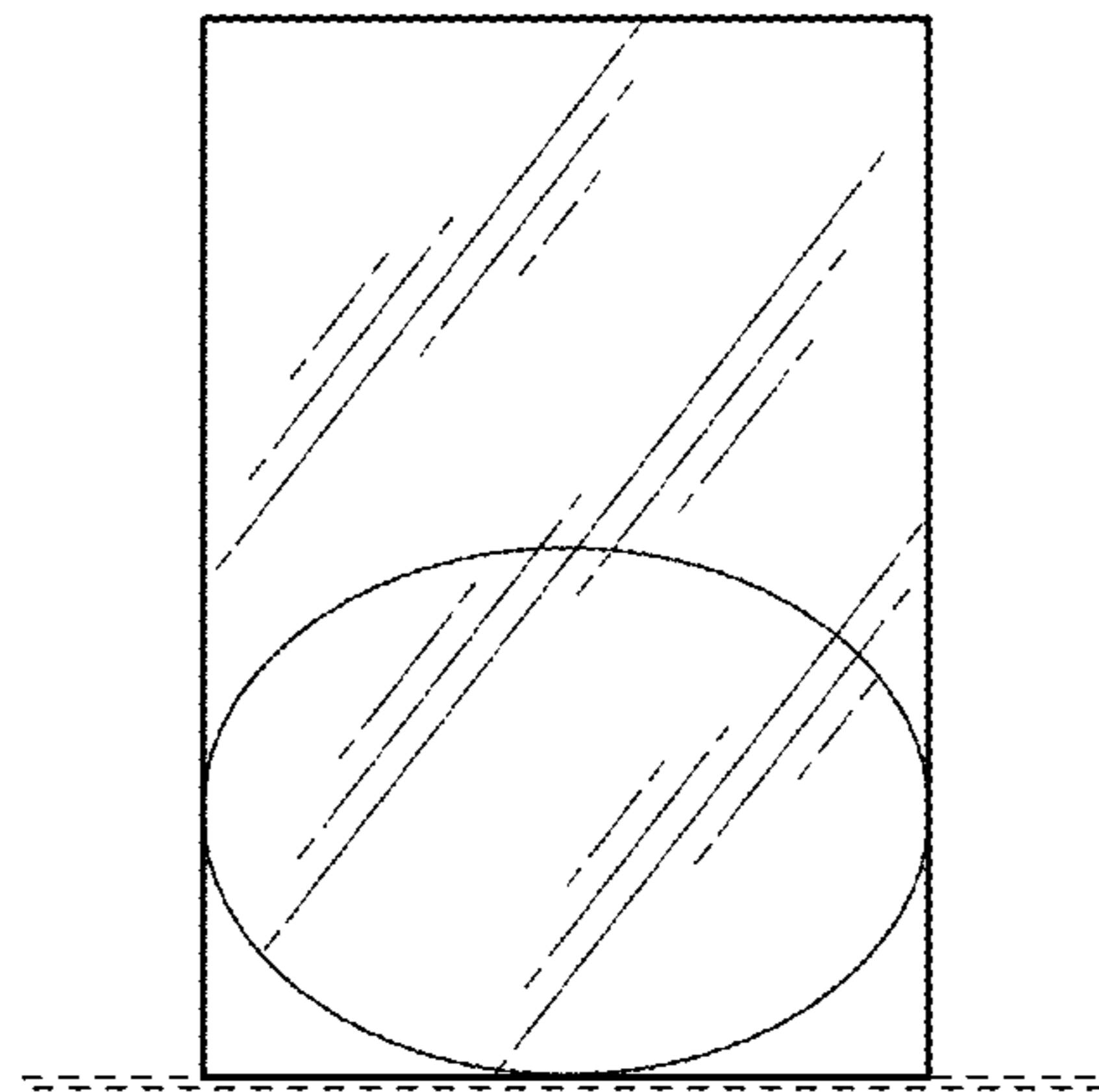

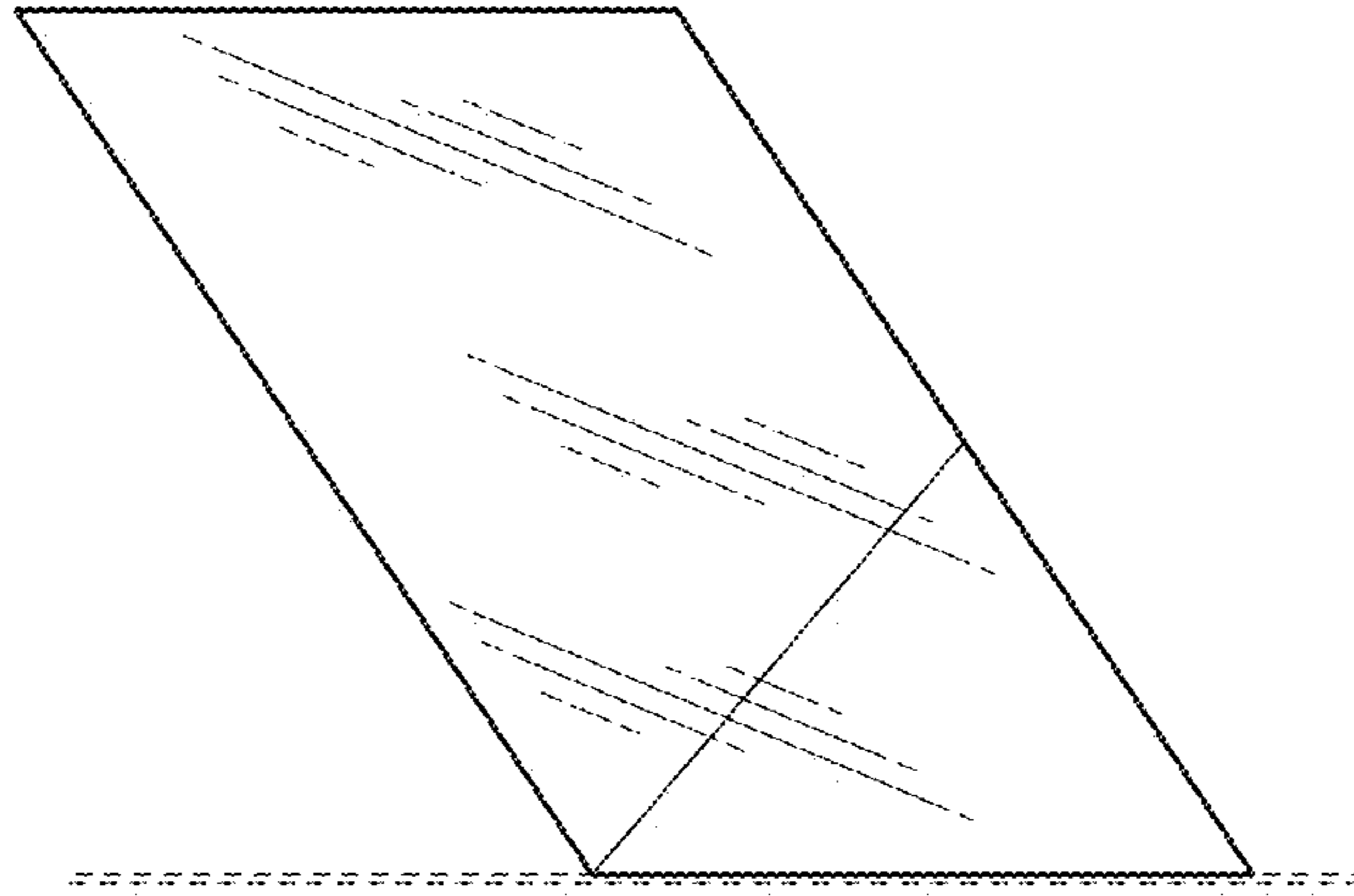

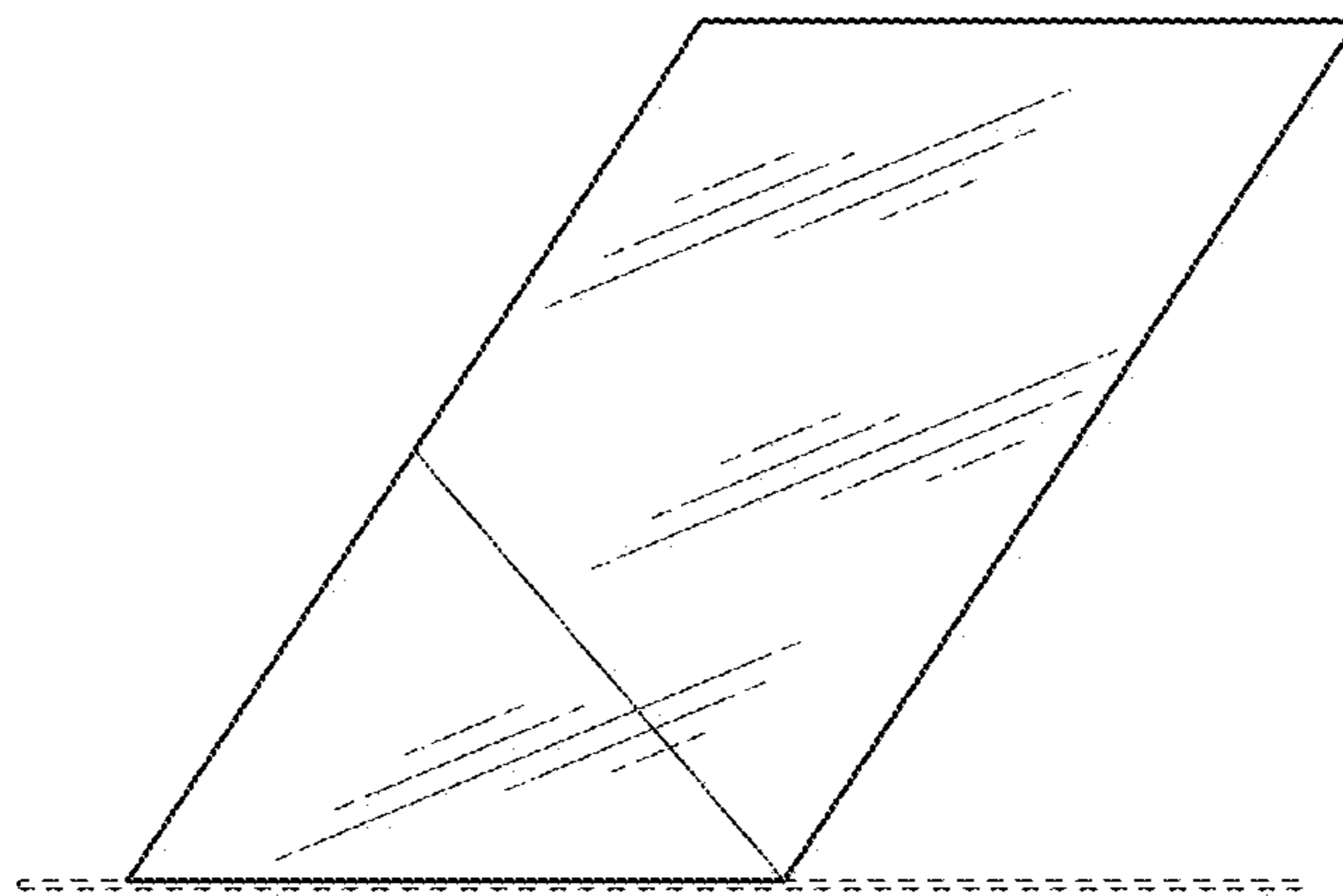
