FIG. 7 is a top view of FIG. 6;

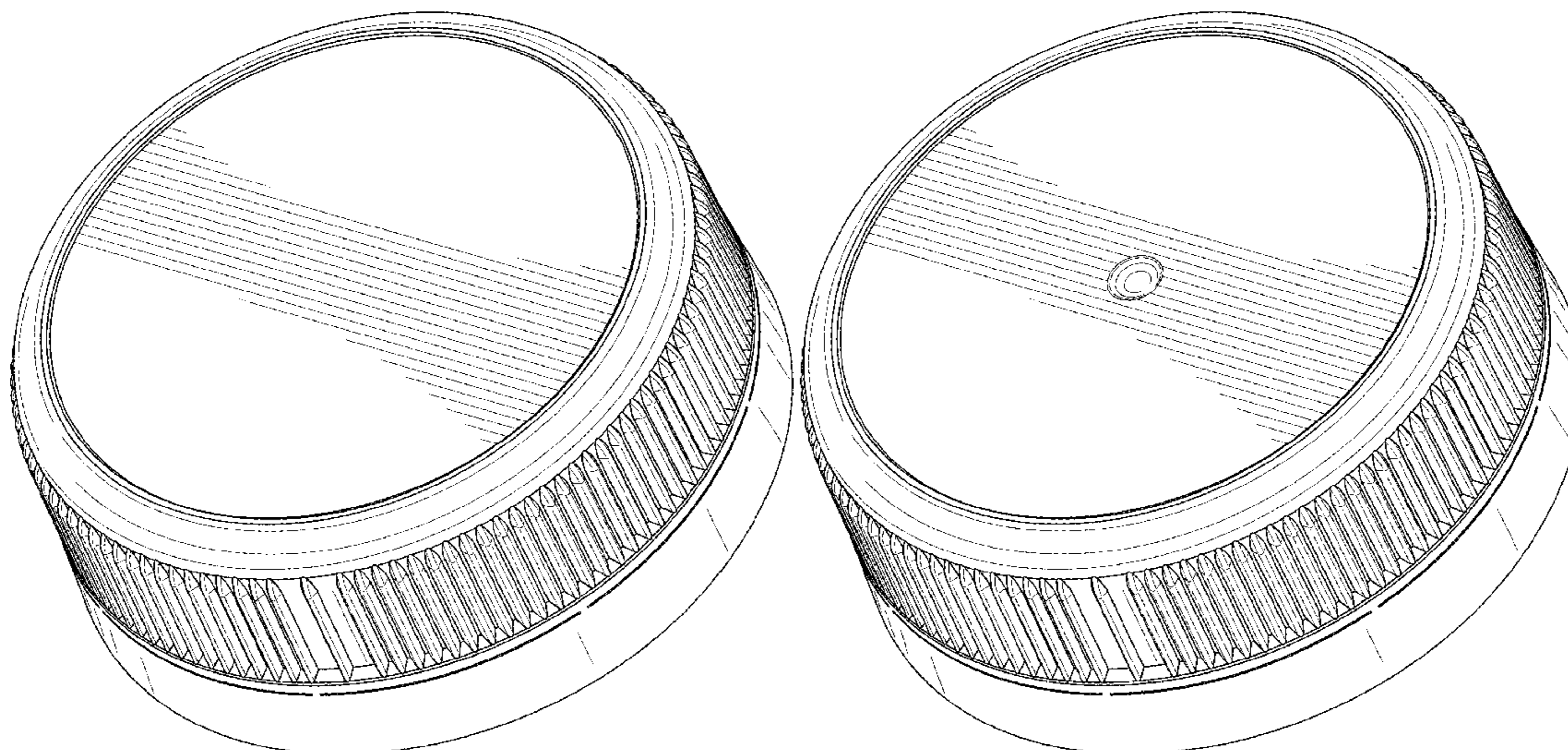
FIG. 8 is a bottom view of FIG. 6;

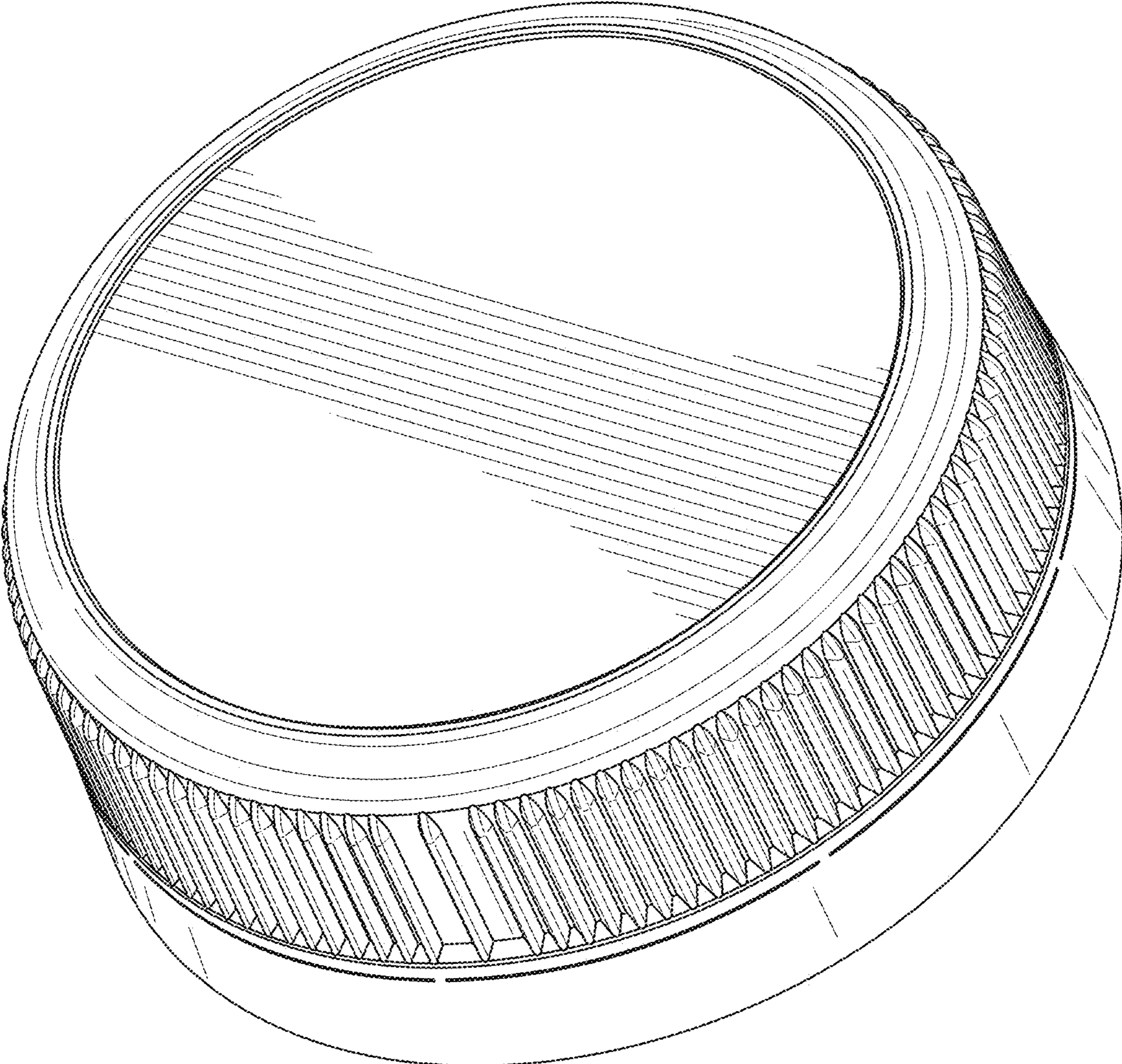

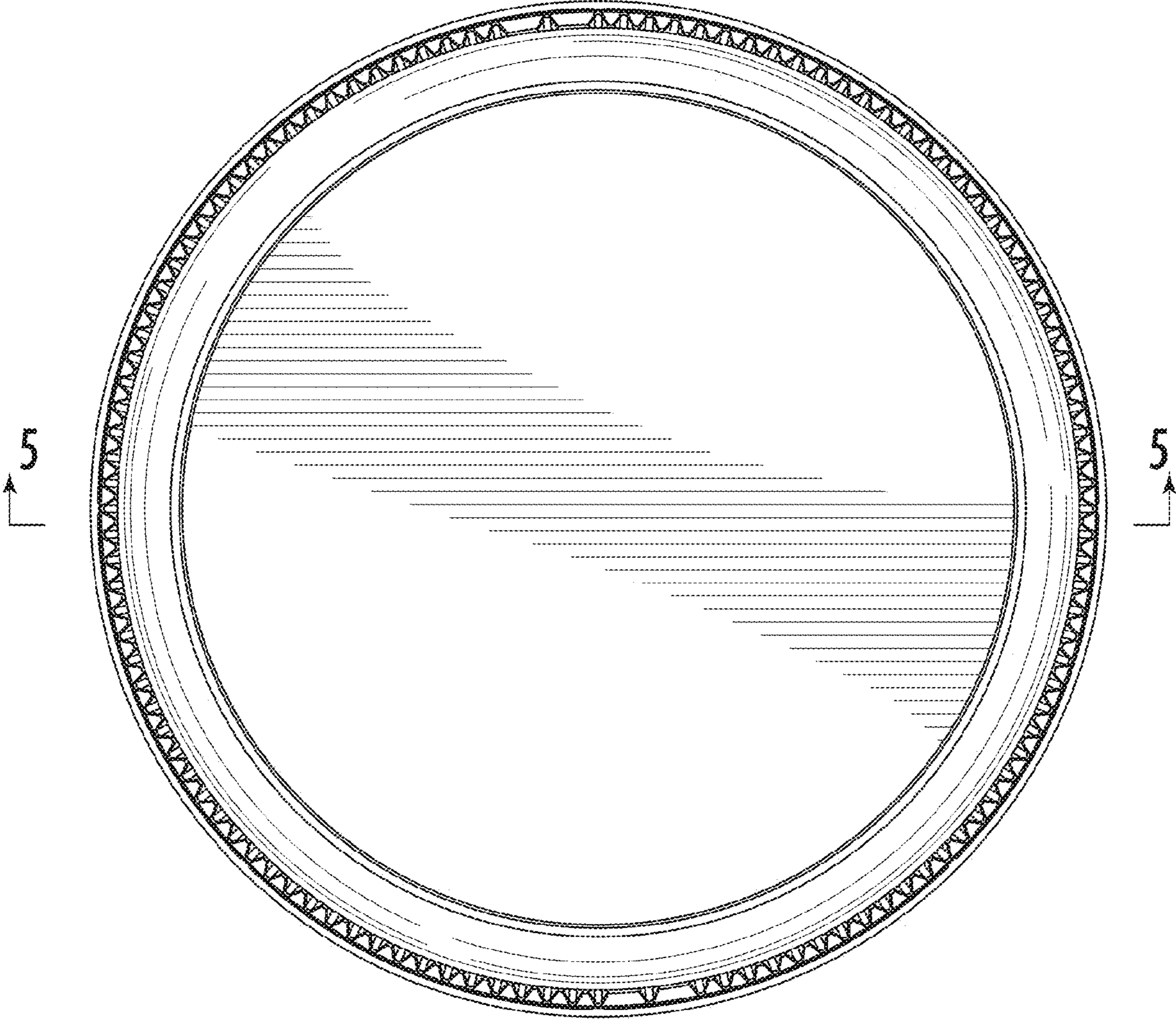

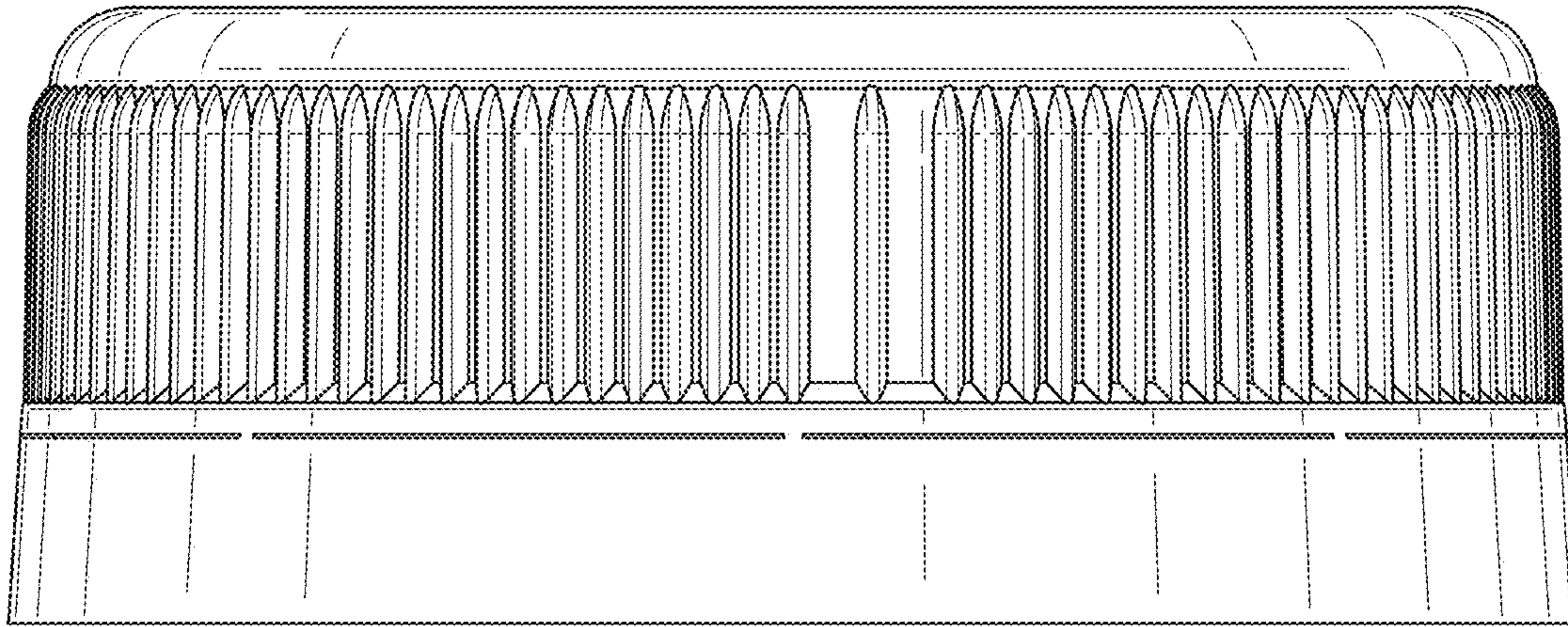

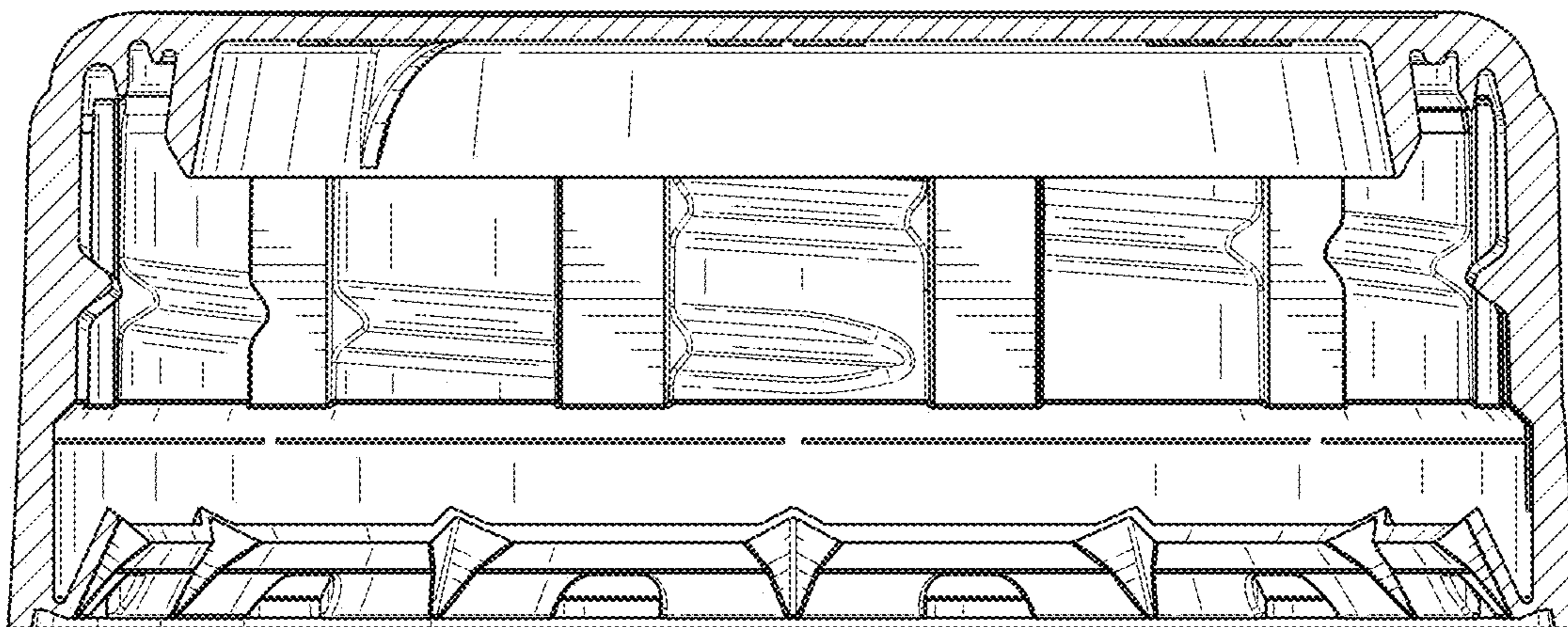

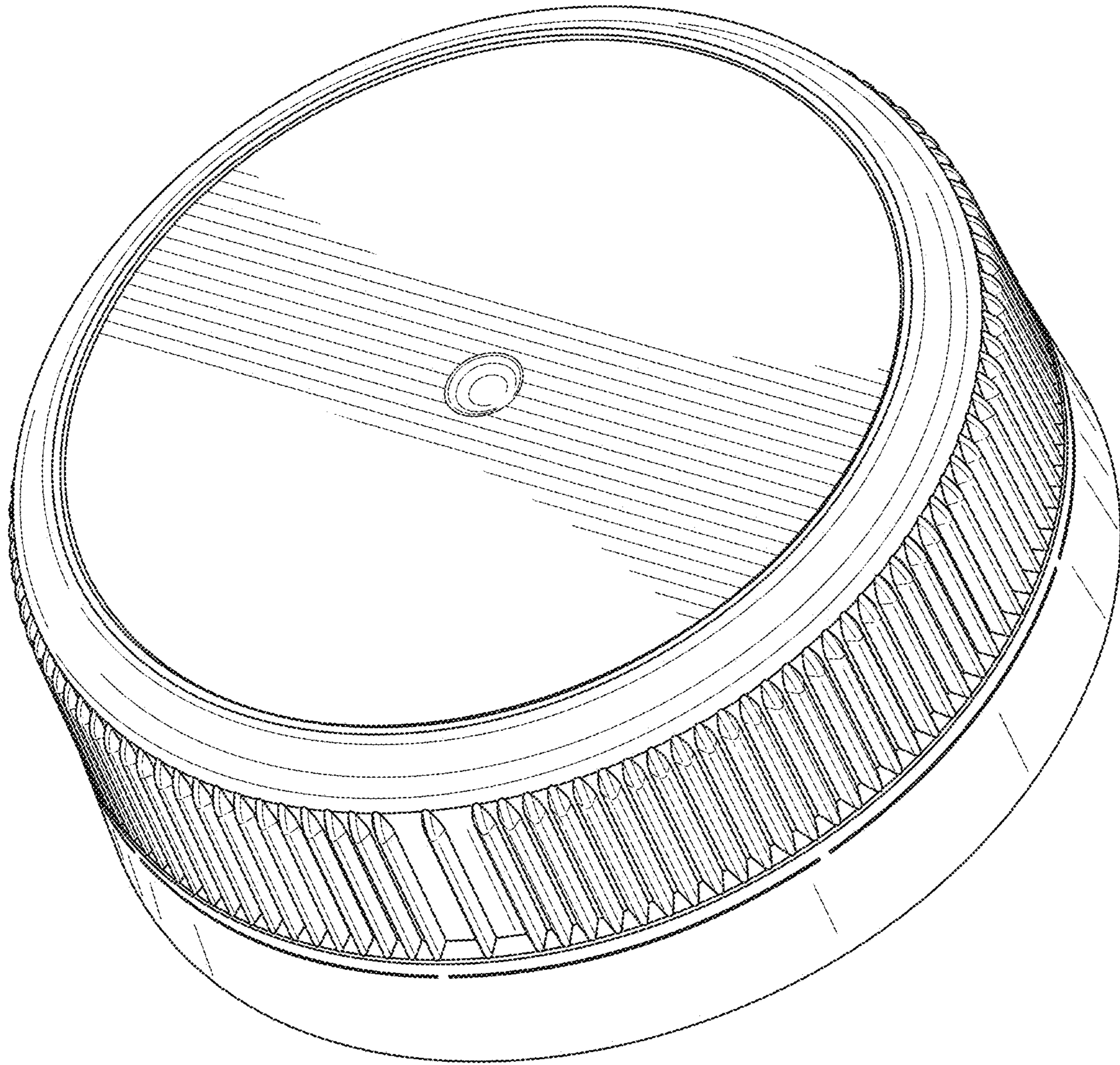

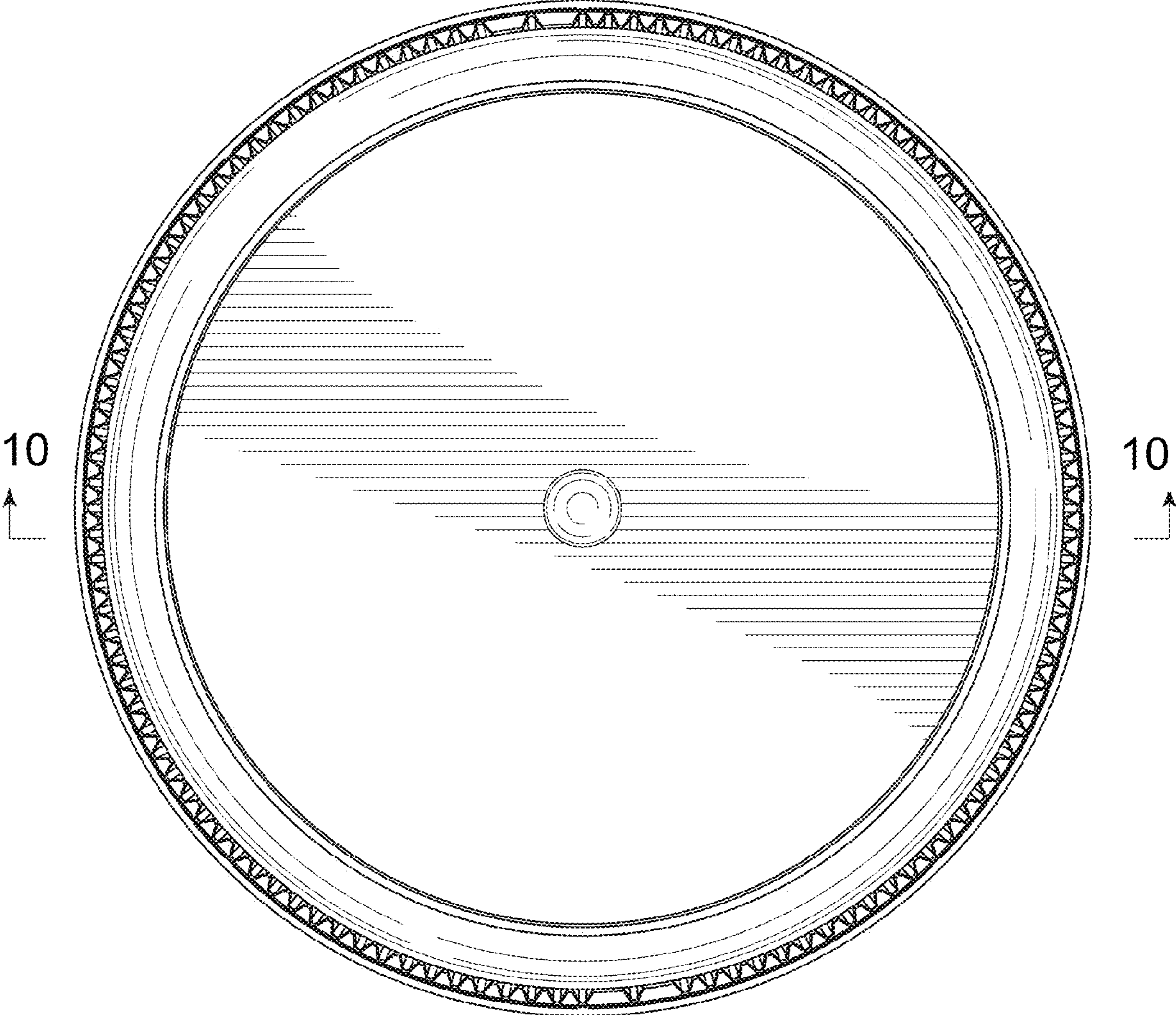

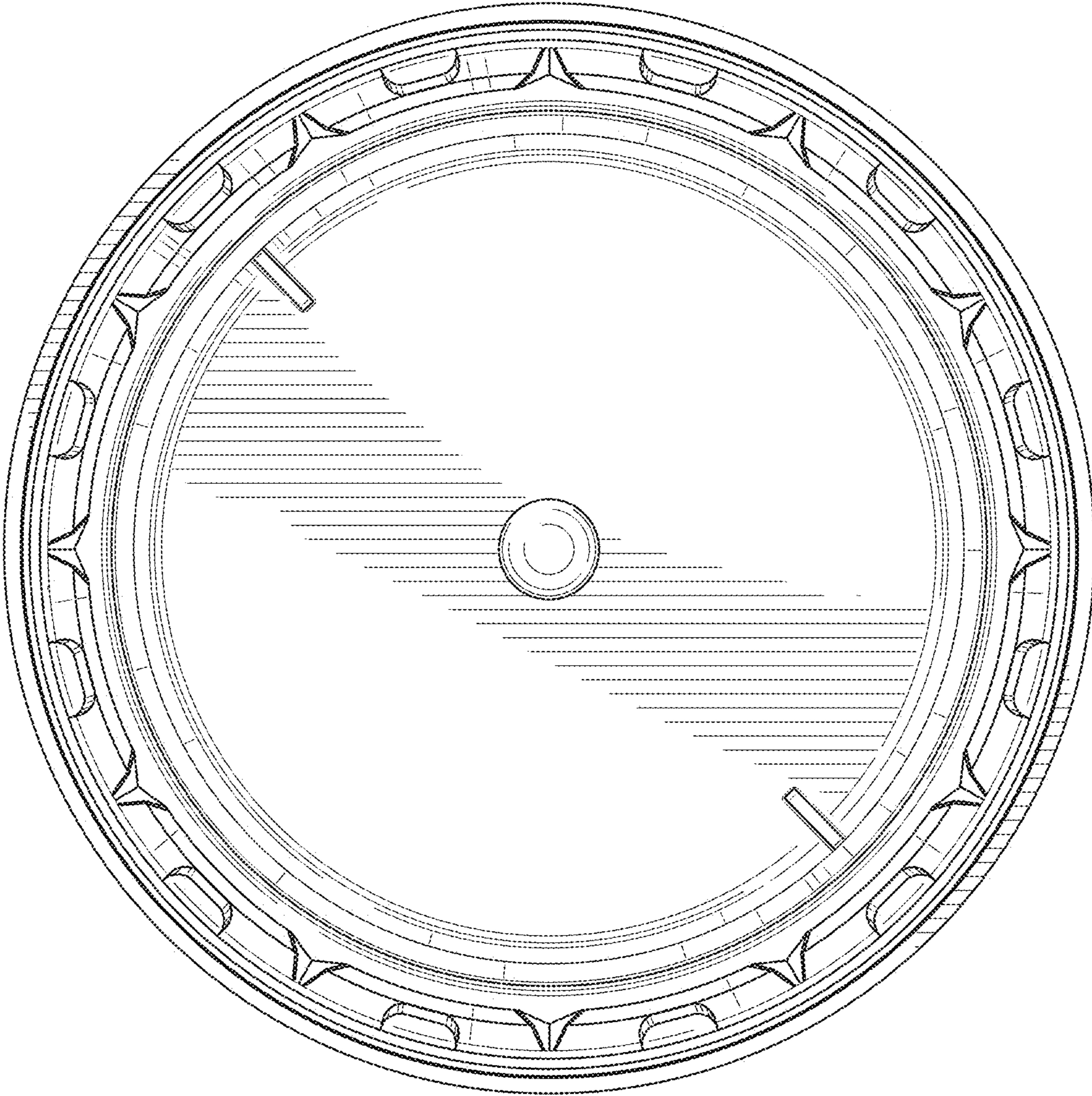

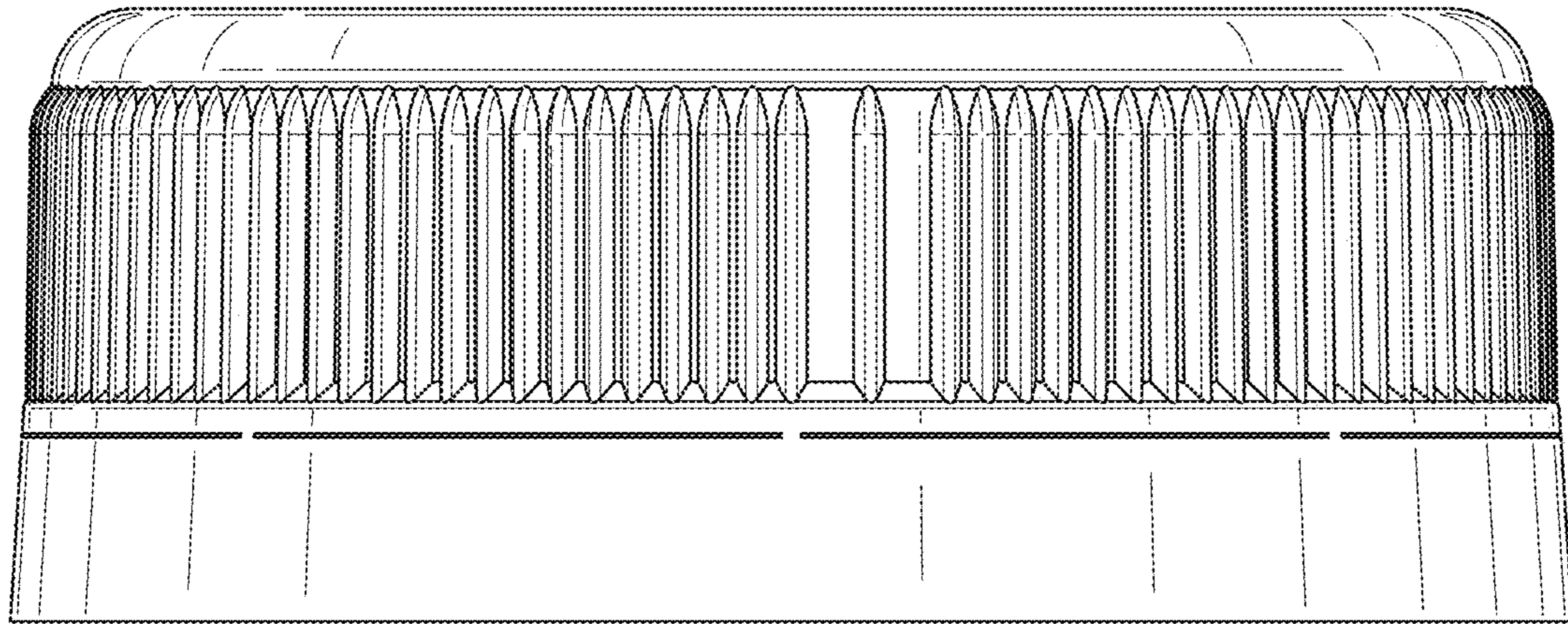

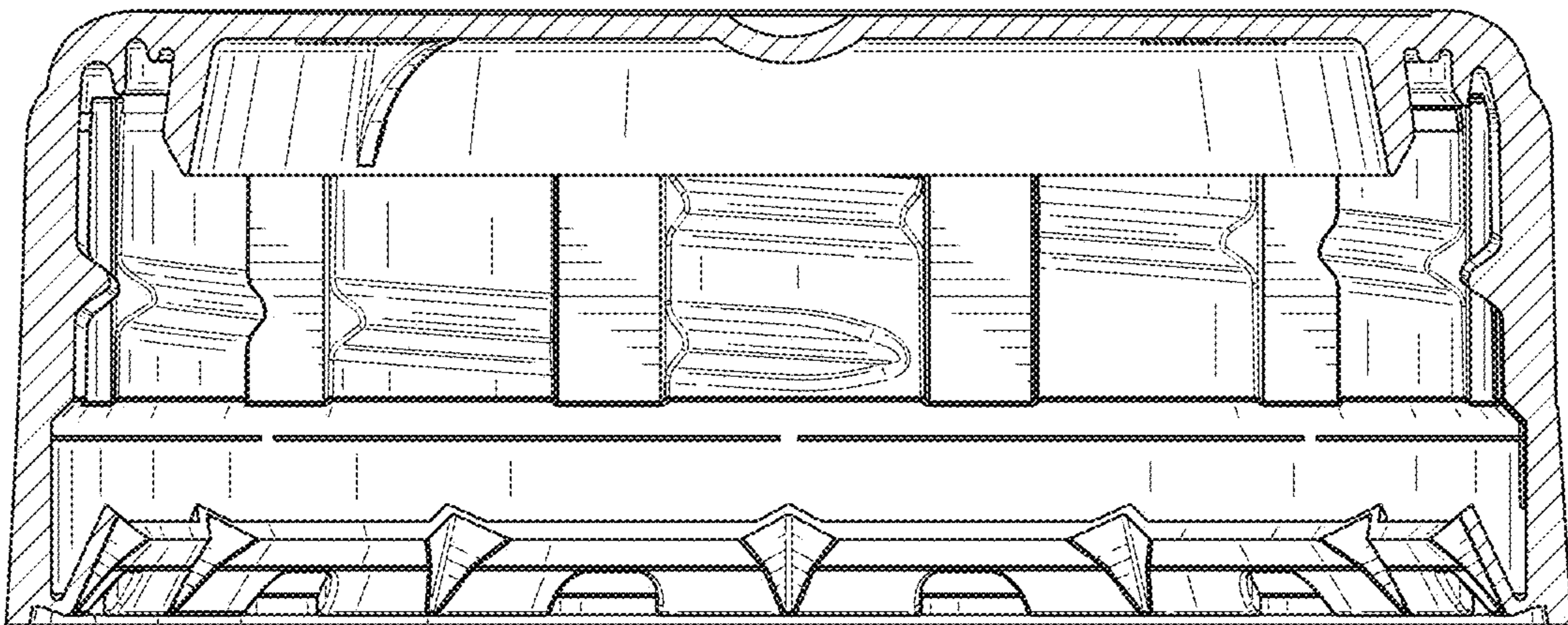
