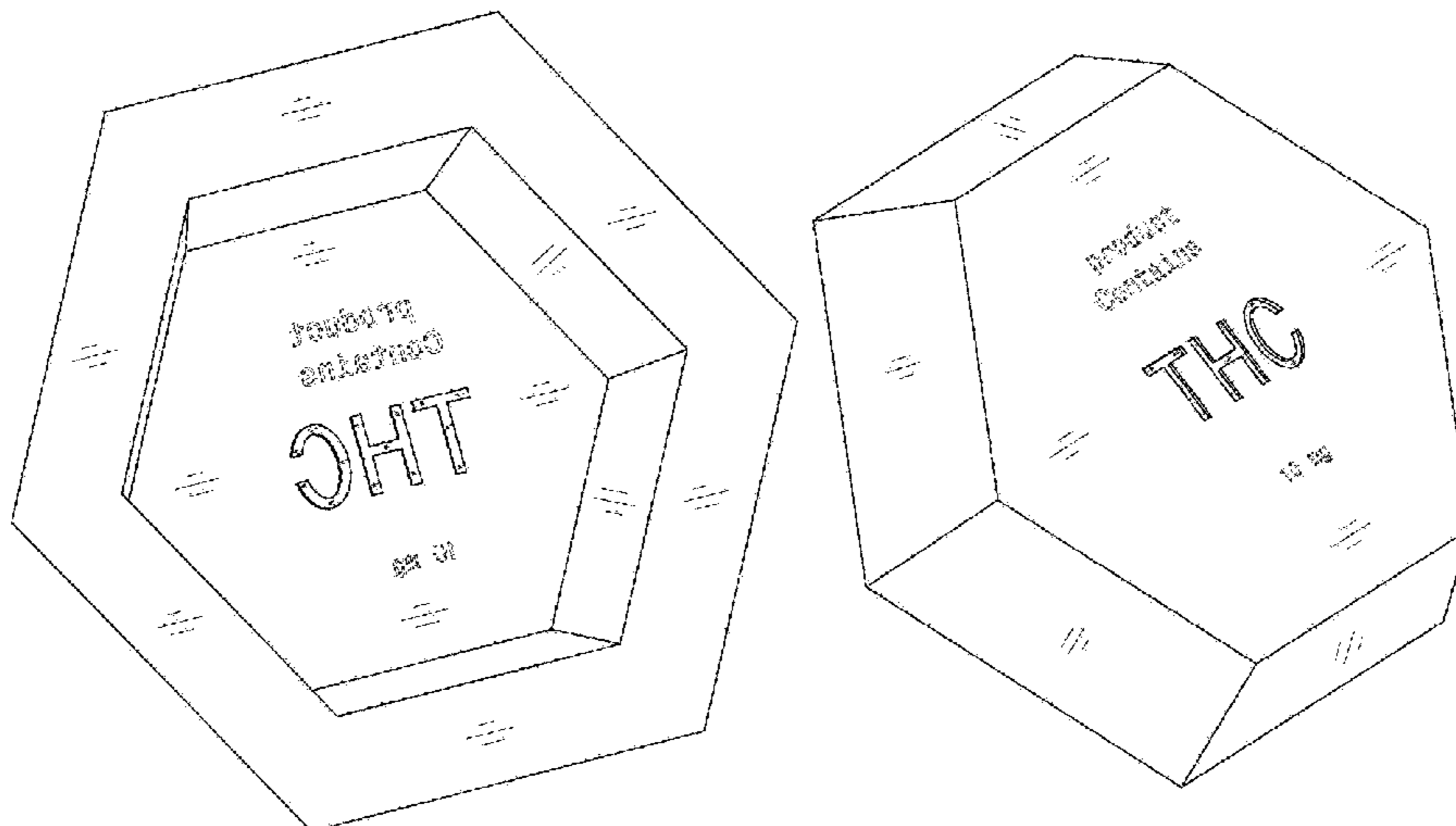
(57) **CLAIM**

The ornamental design for a tray mold, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the tray mold showing my new design;
FIG. 2 is a top view of FIG. 1;
FIG. 3 is a front side view of FIG. 1;
FIG. 4 is a bottom perspective view of FIG. 1; and,
FIG. 5 is a bottom view of FIG. 1.

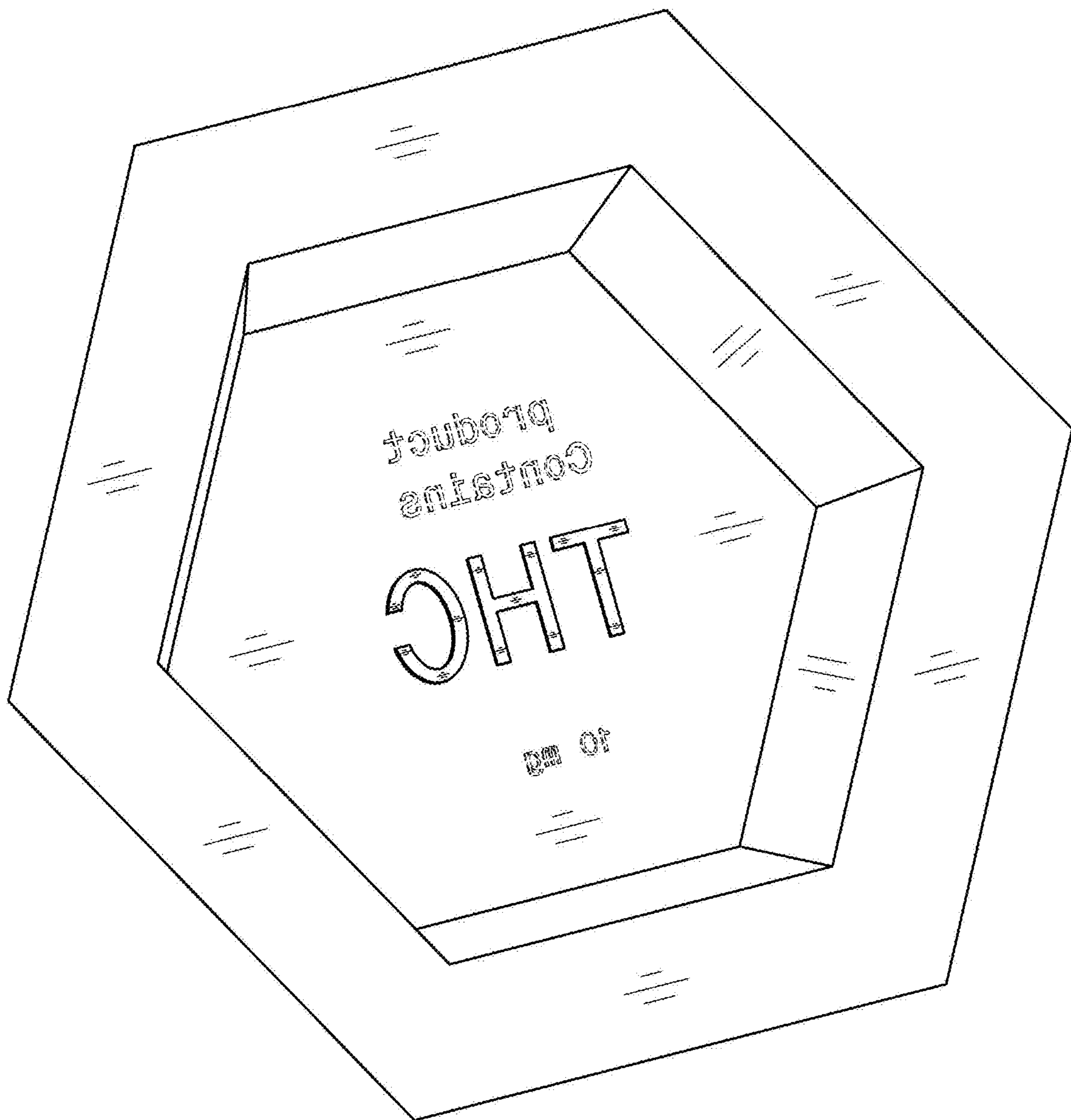

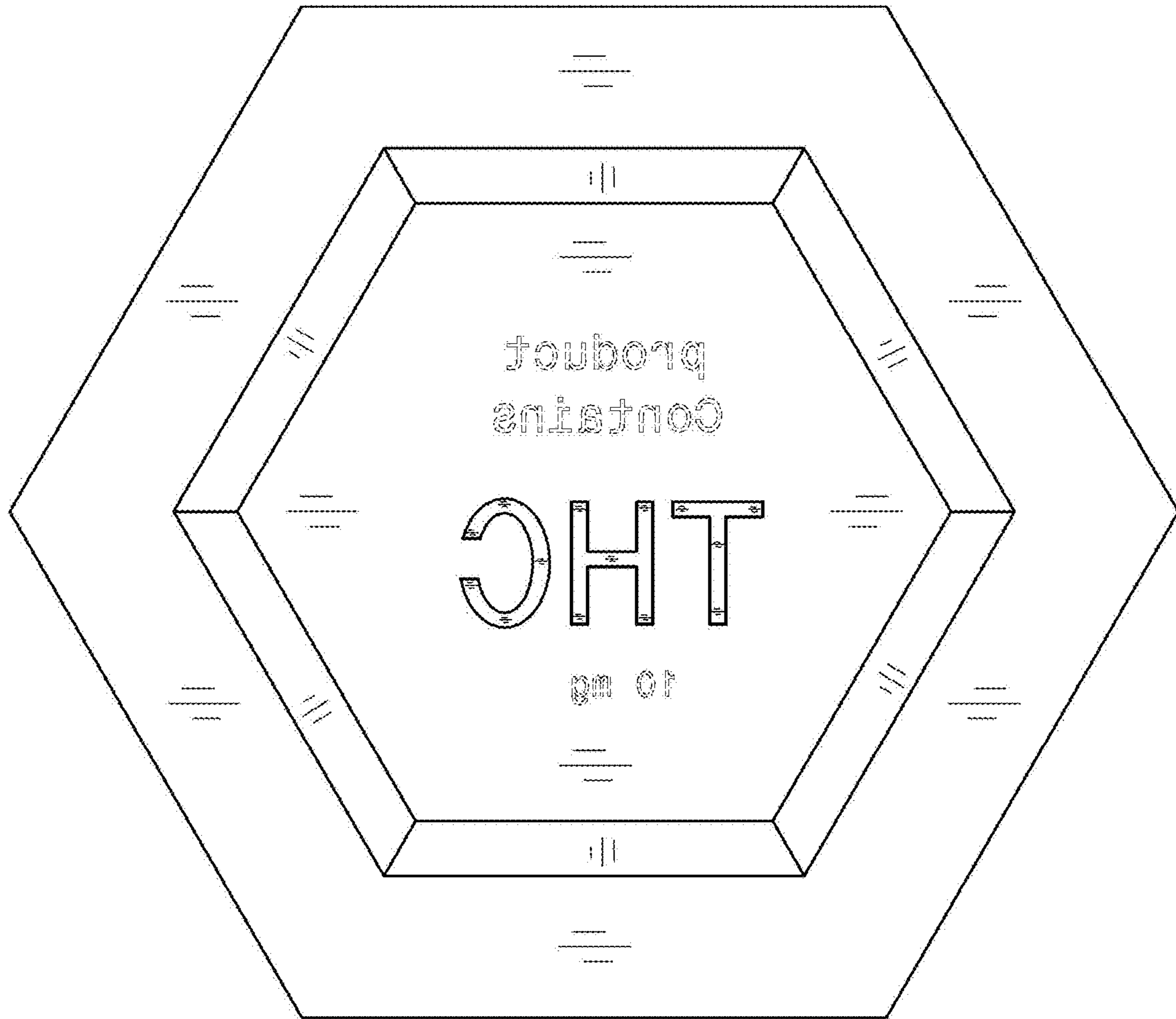

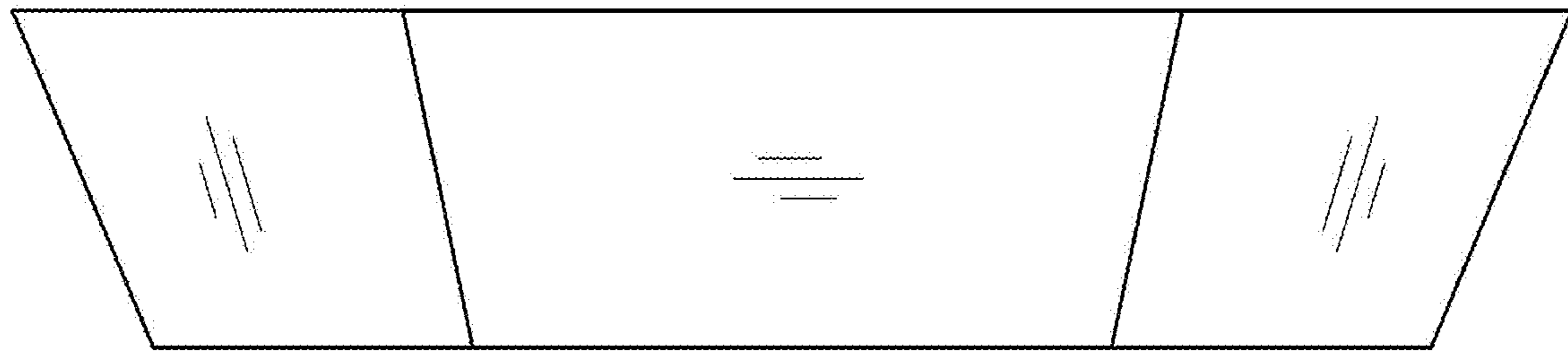

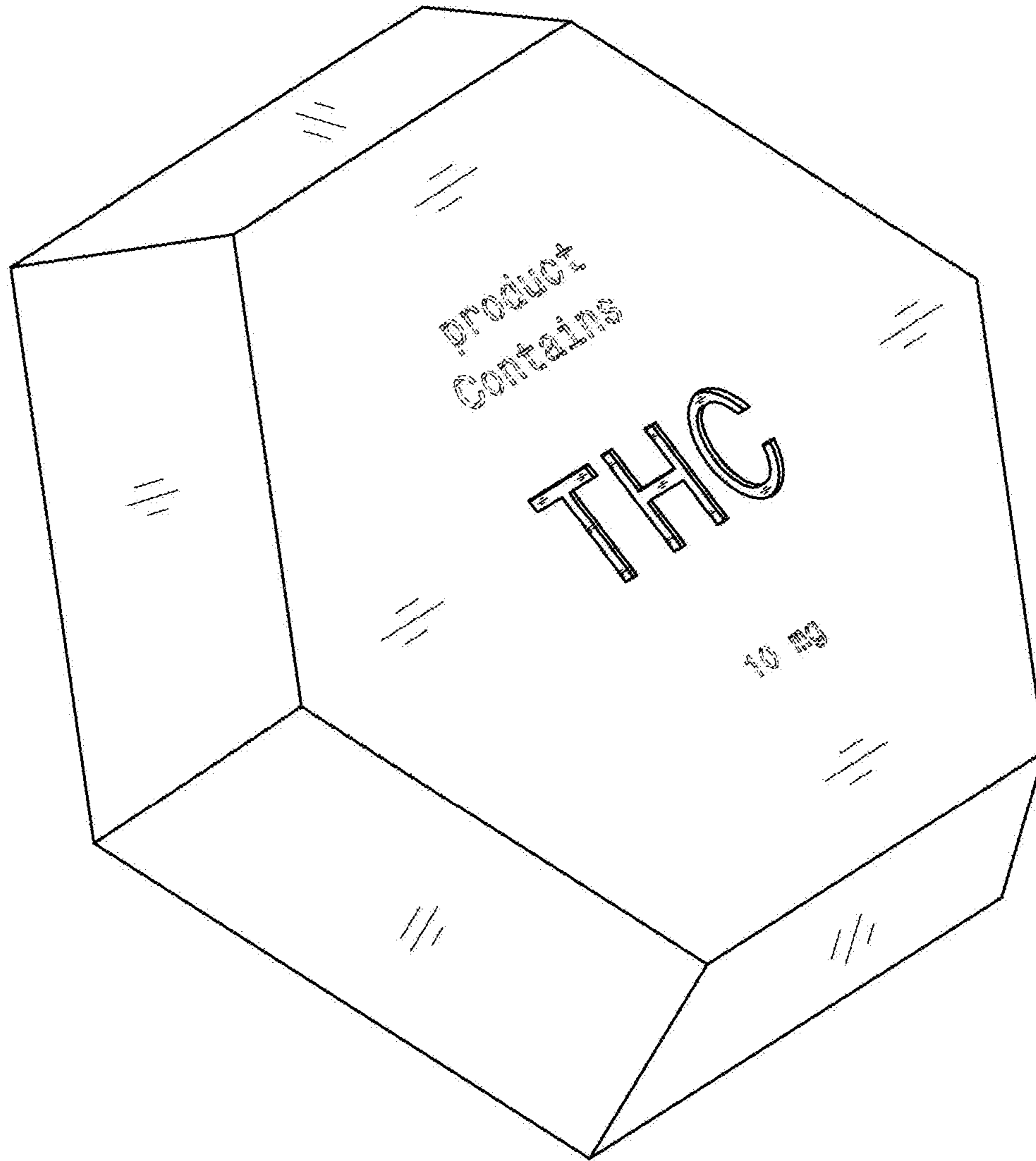

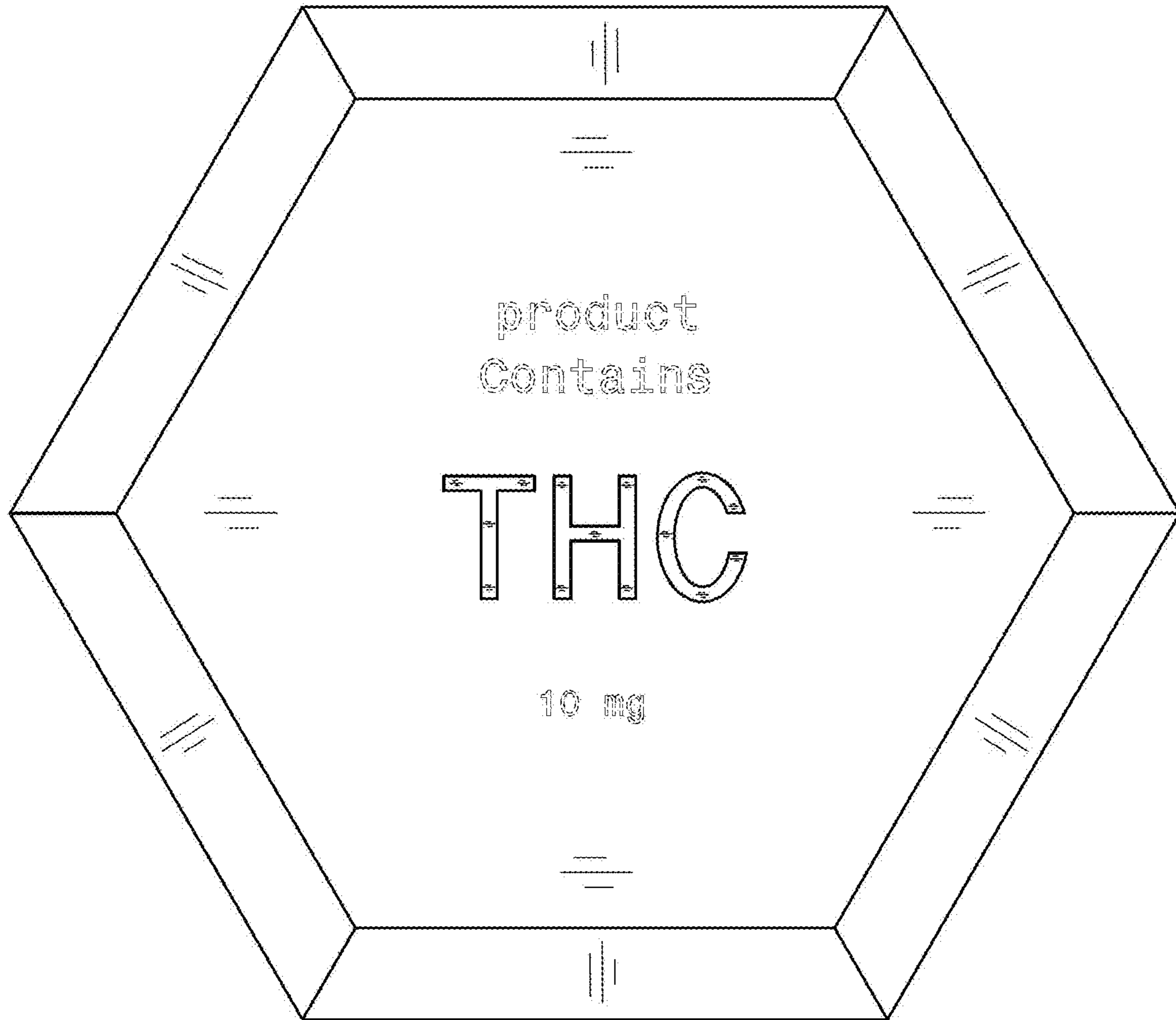
