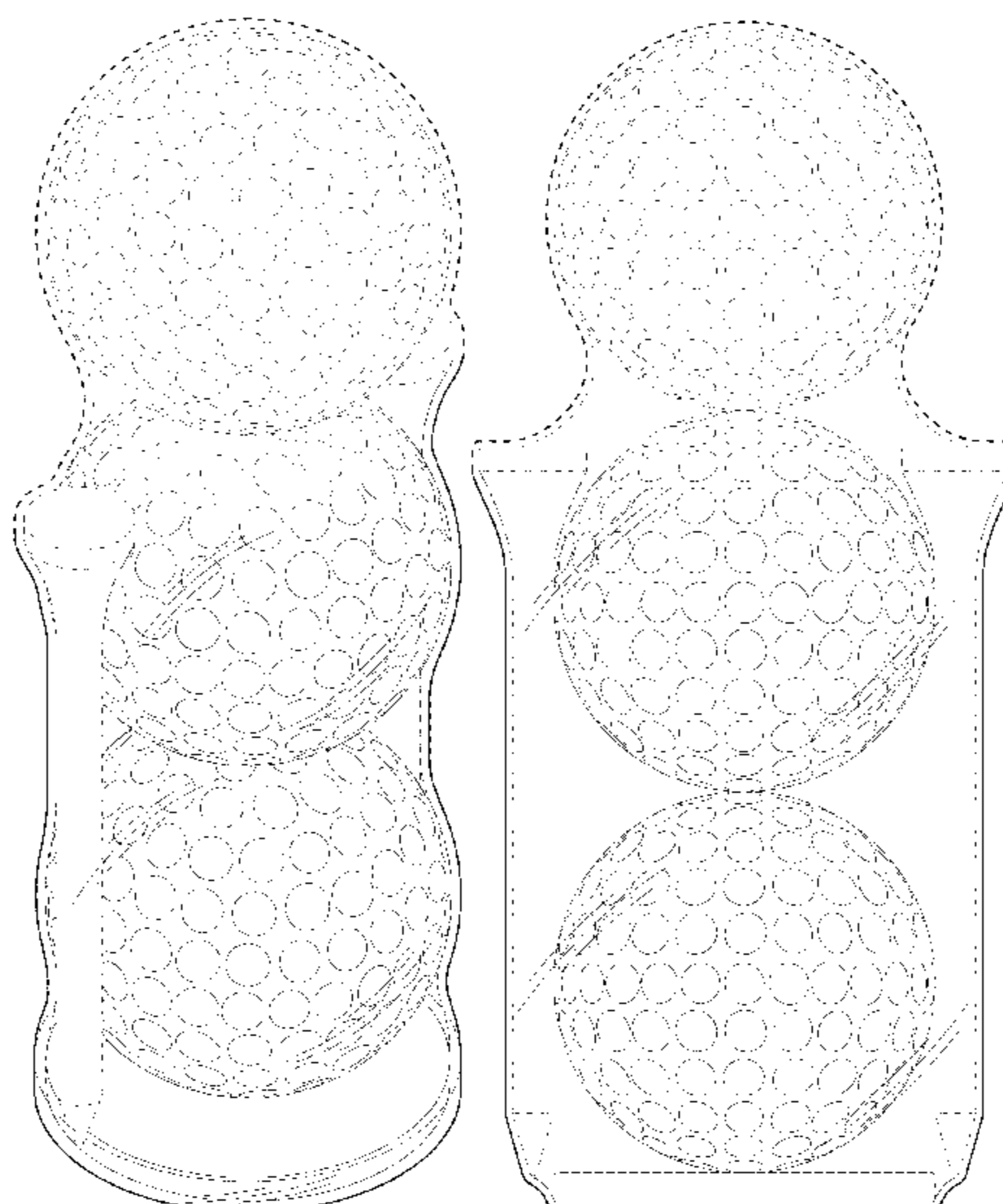
(57) **CLAIM**

I claim the ornamental design for stacked golf balls and golf tees secured by transparent film to a flat base, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of stacked golf balls and golf tees secured by transparent film to a flat base, showing the new design.

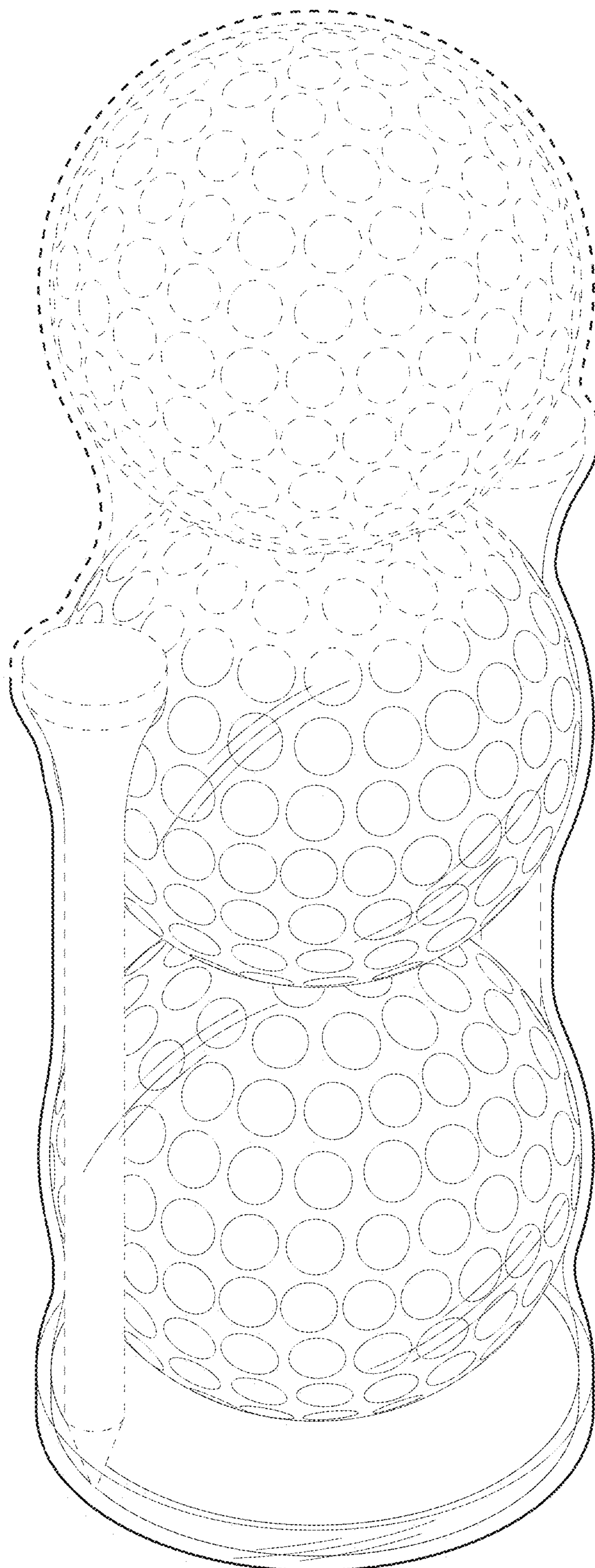

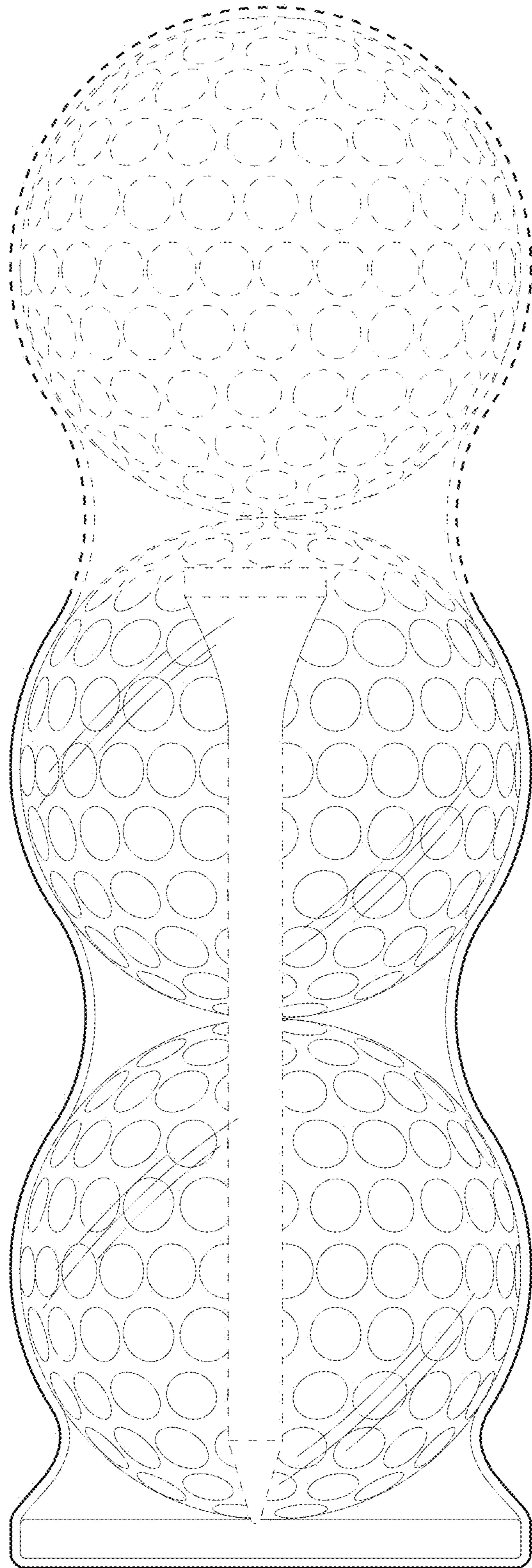

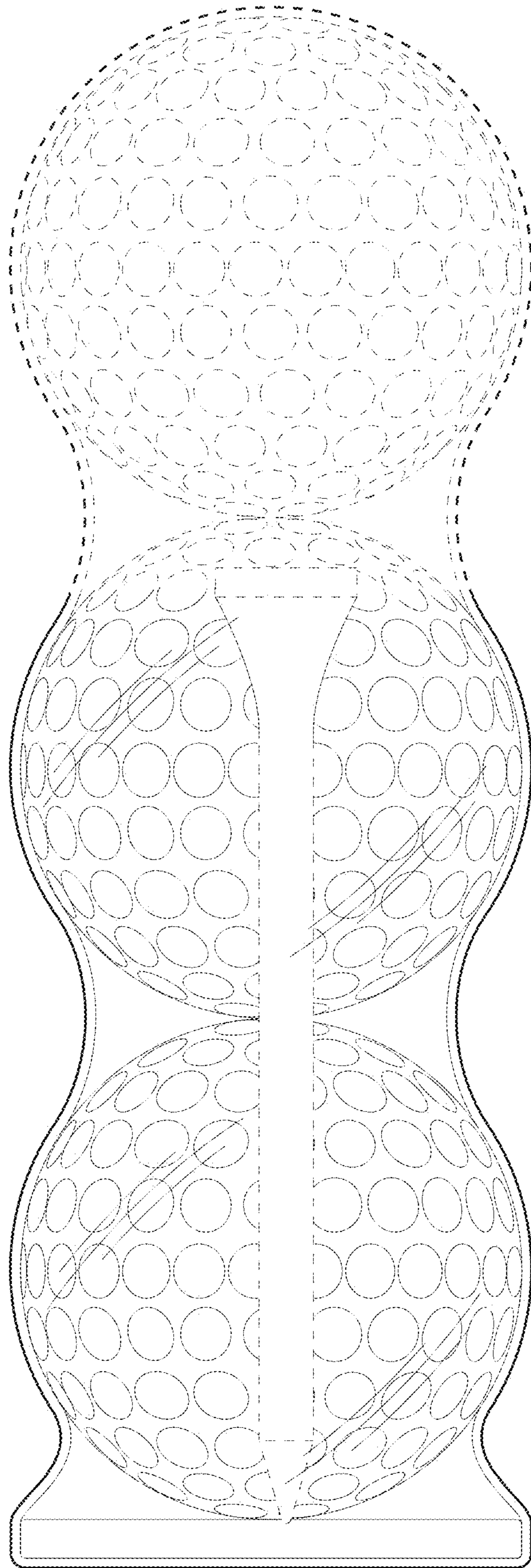

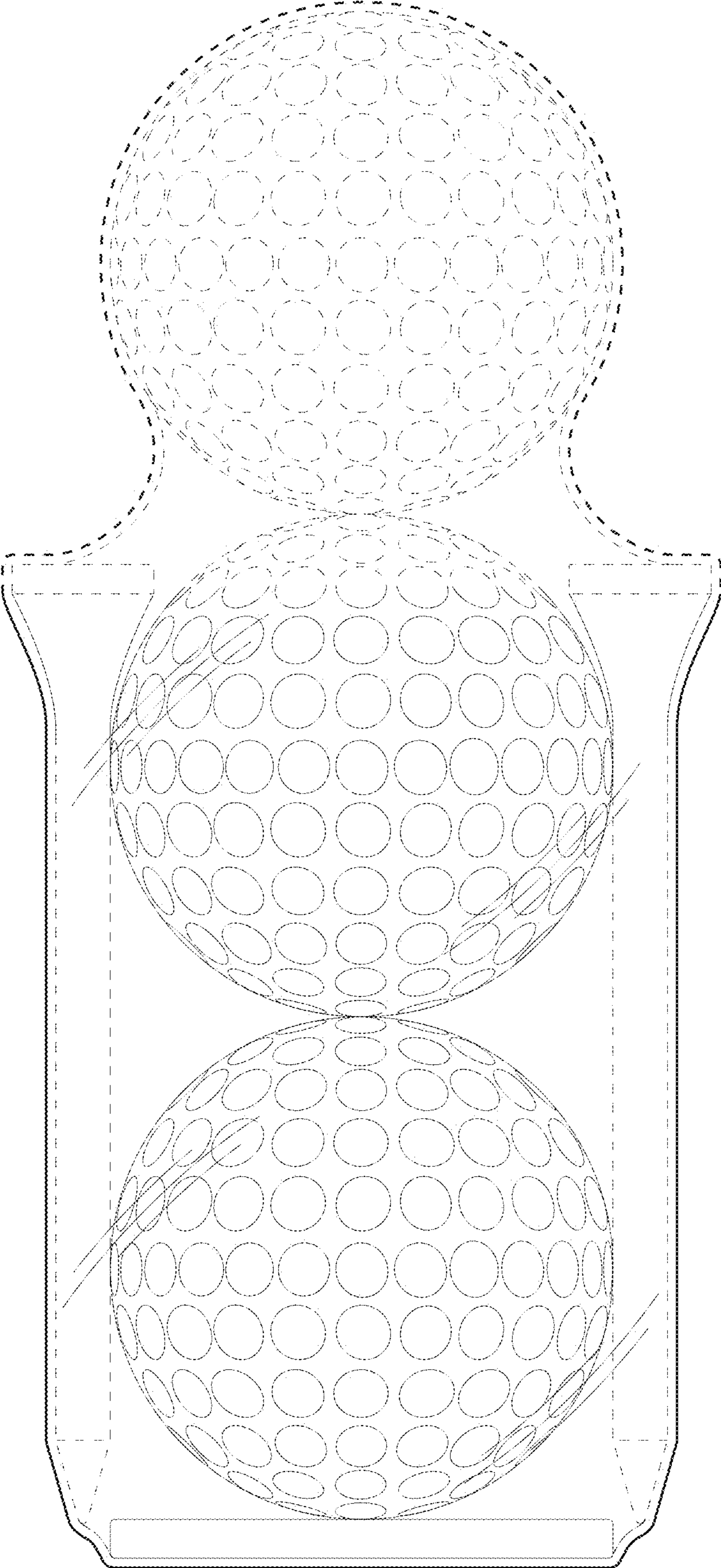

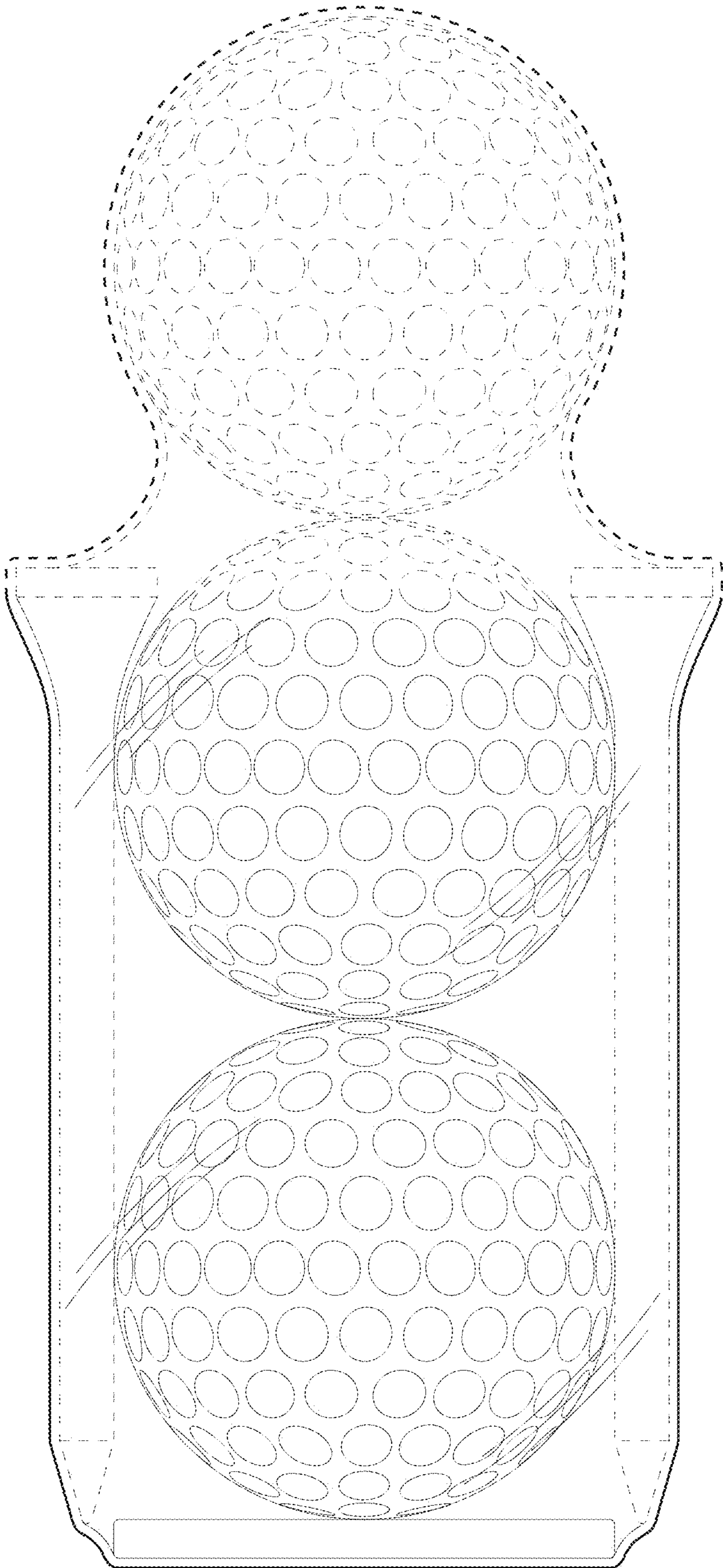

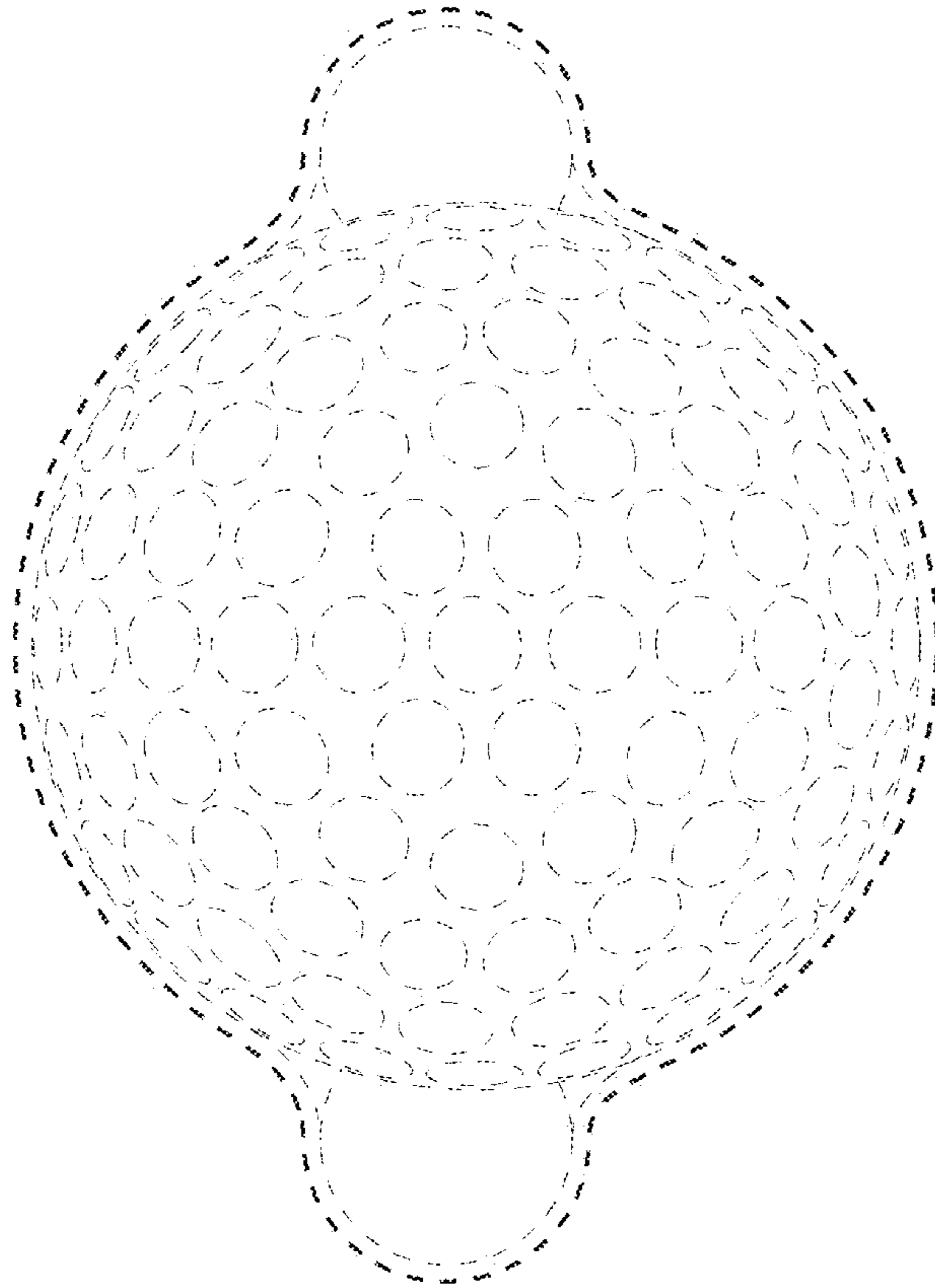

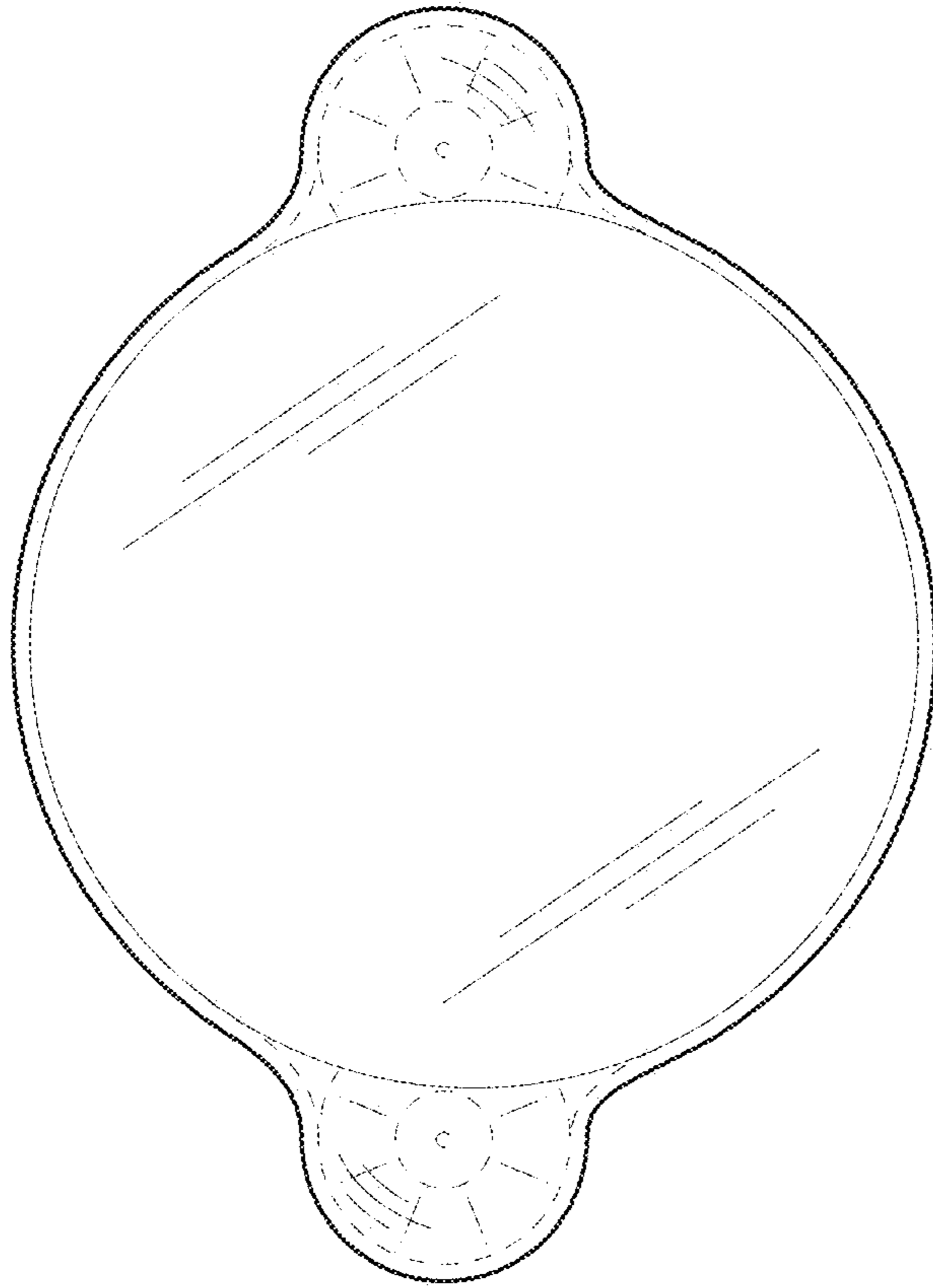

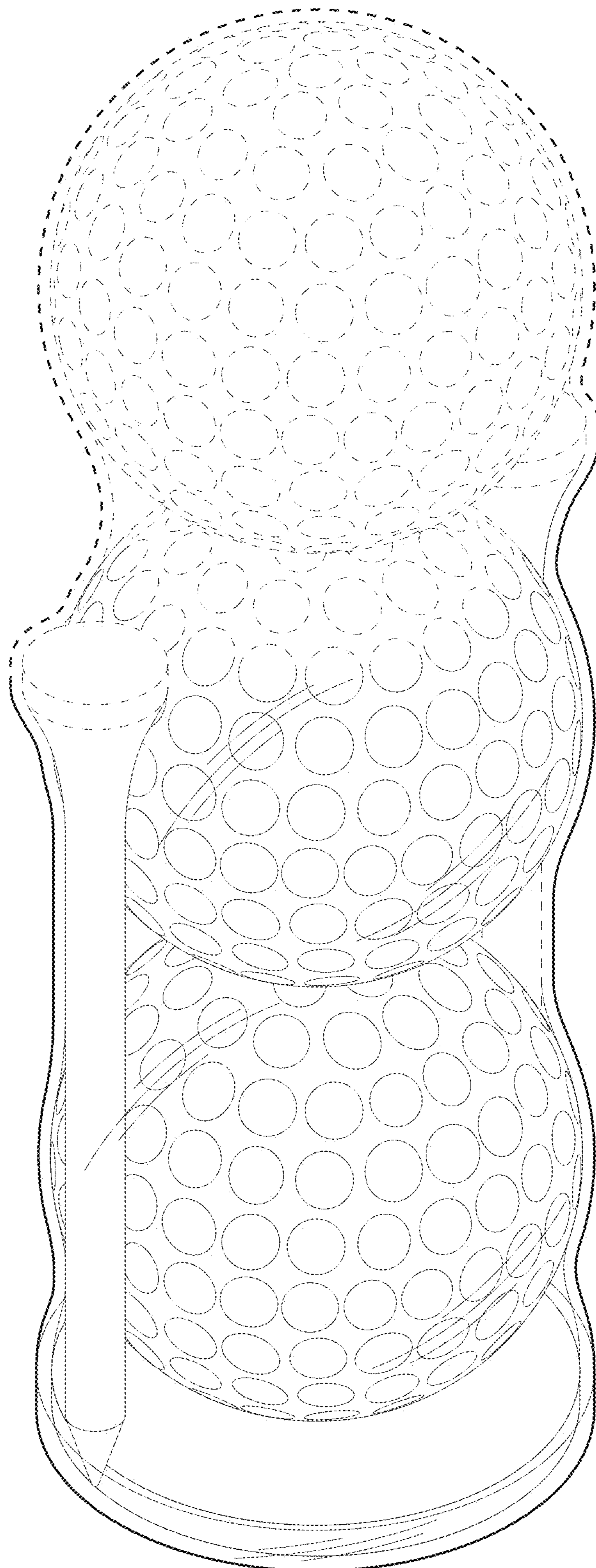

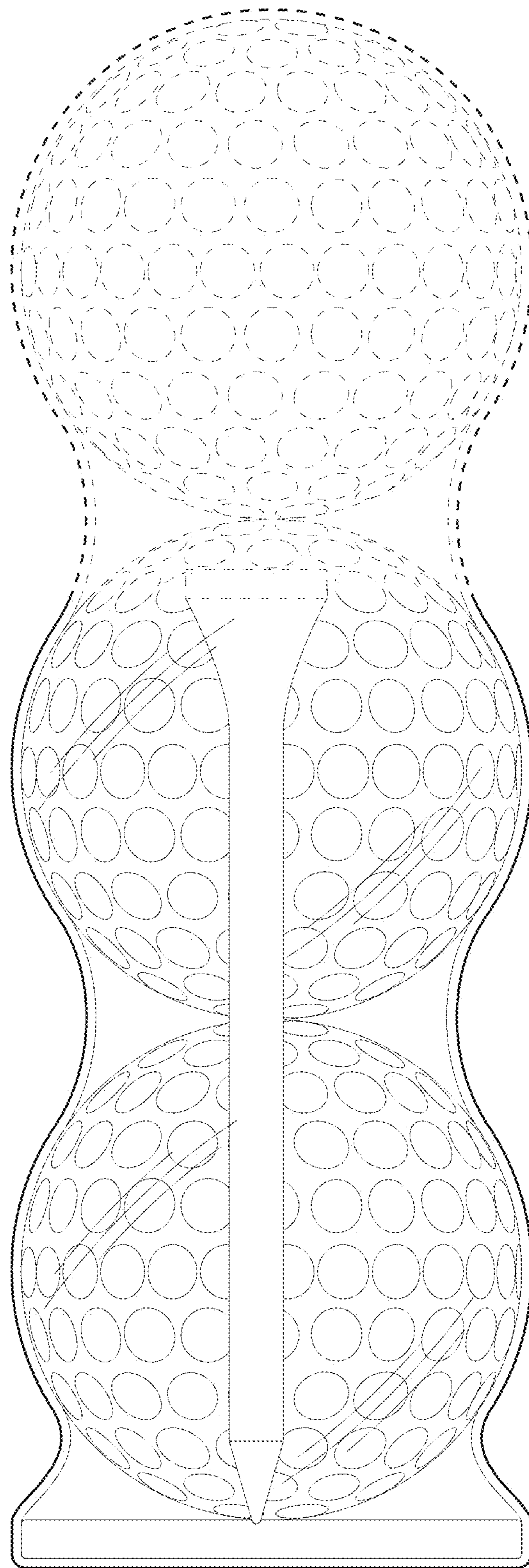




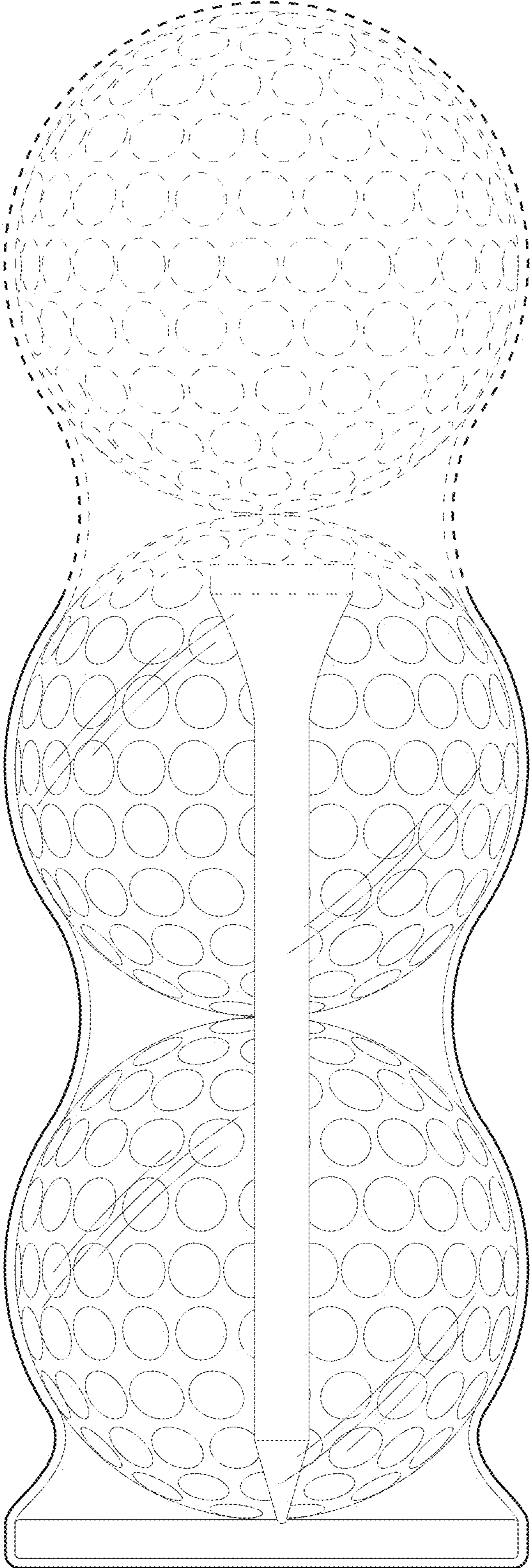

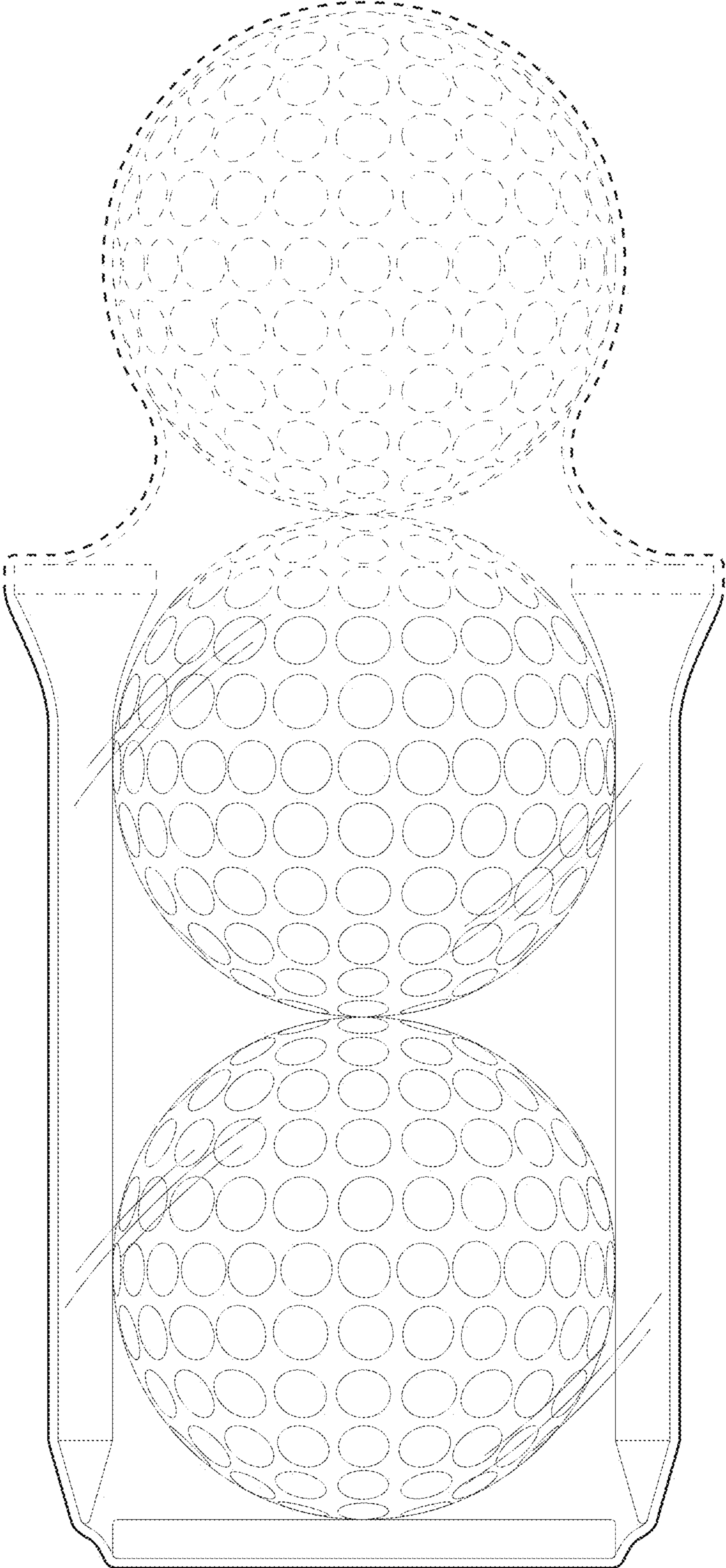

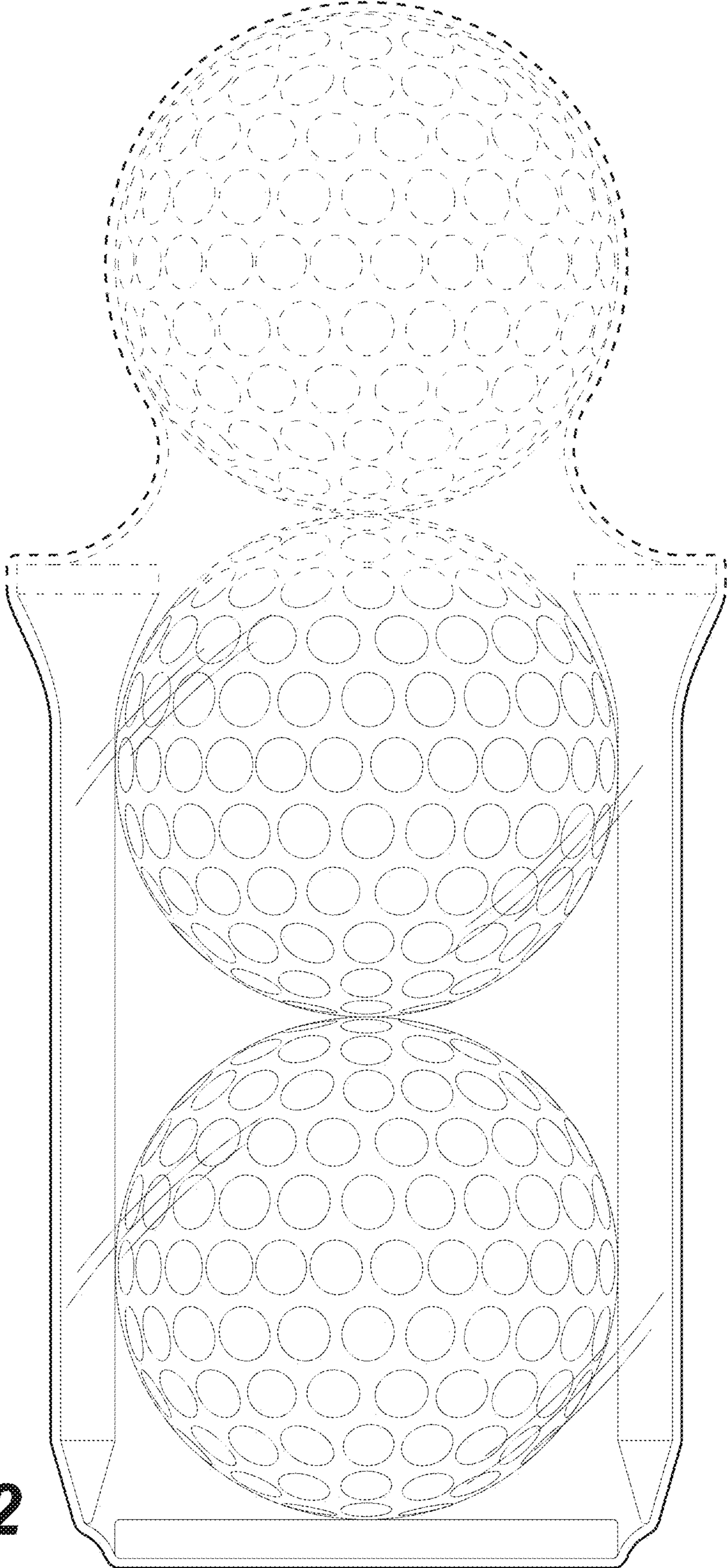

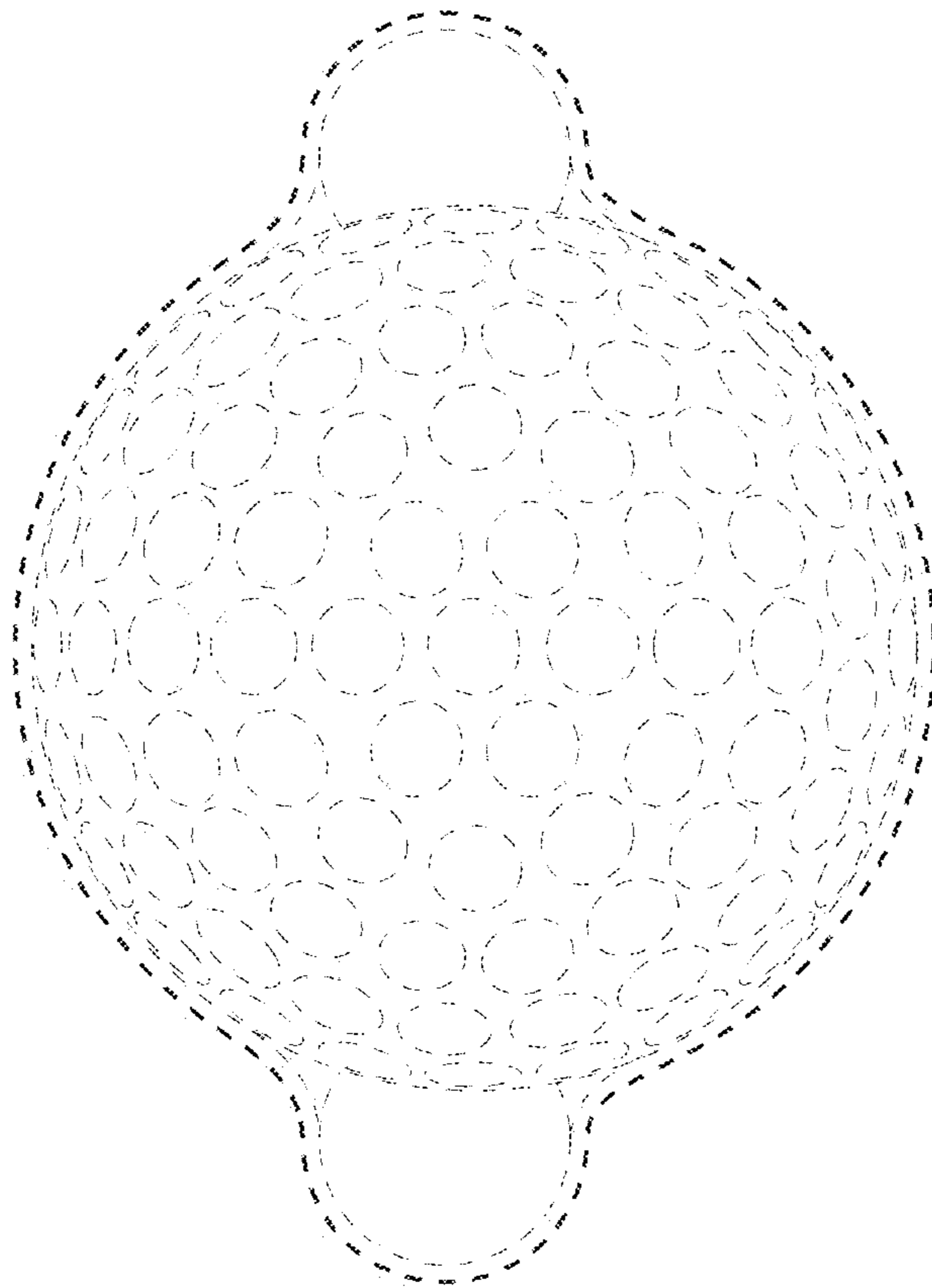

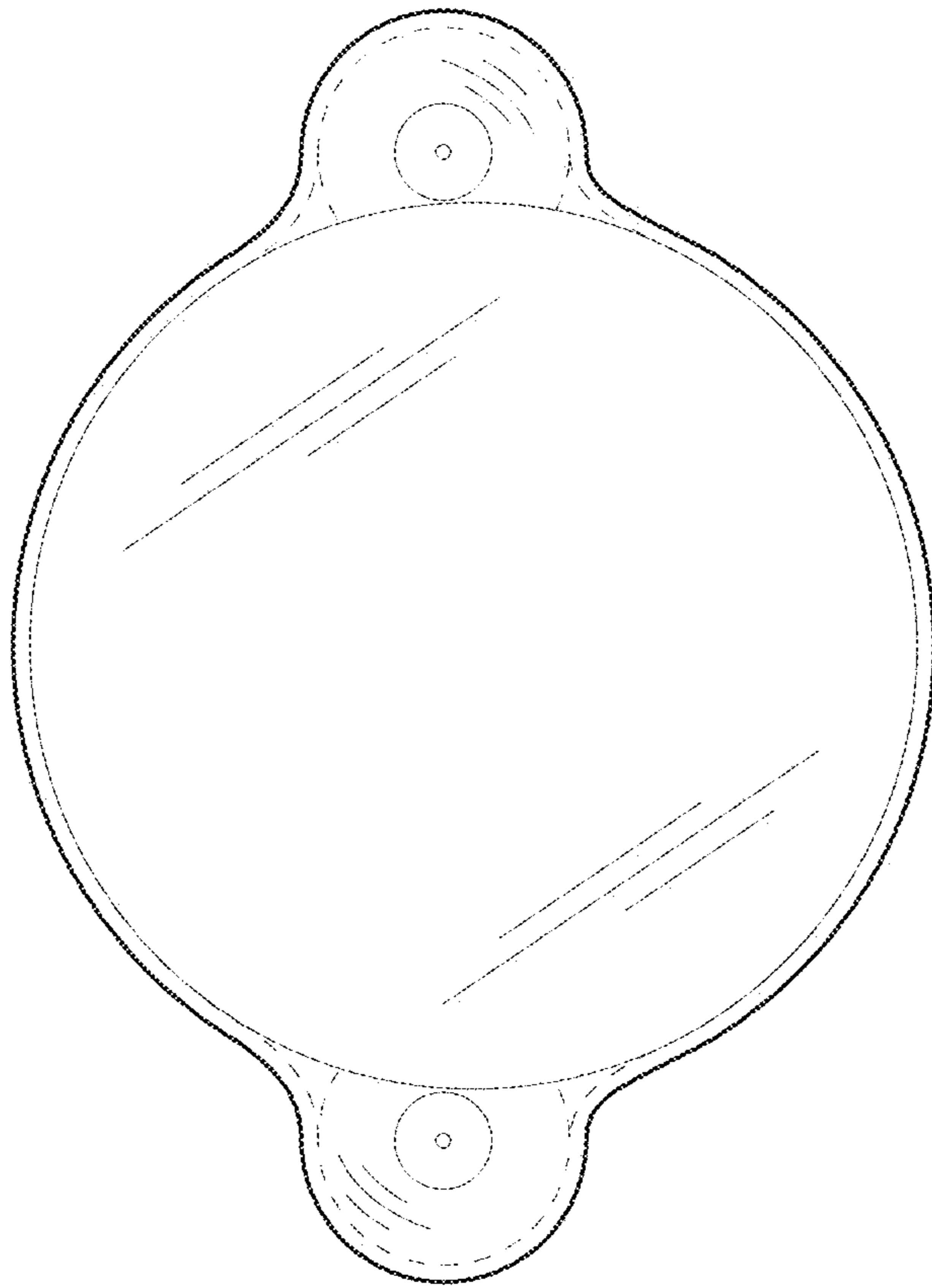
