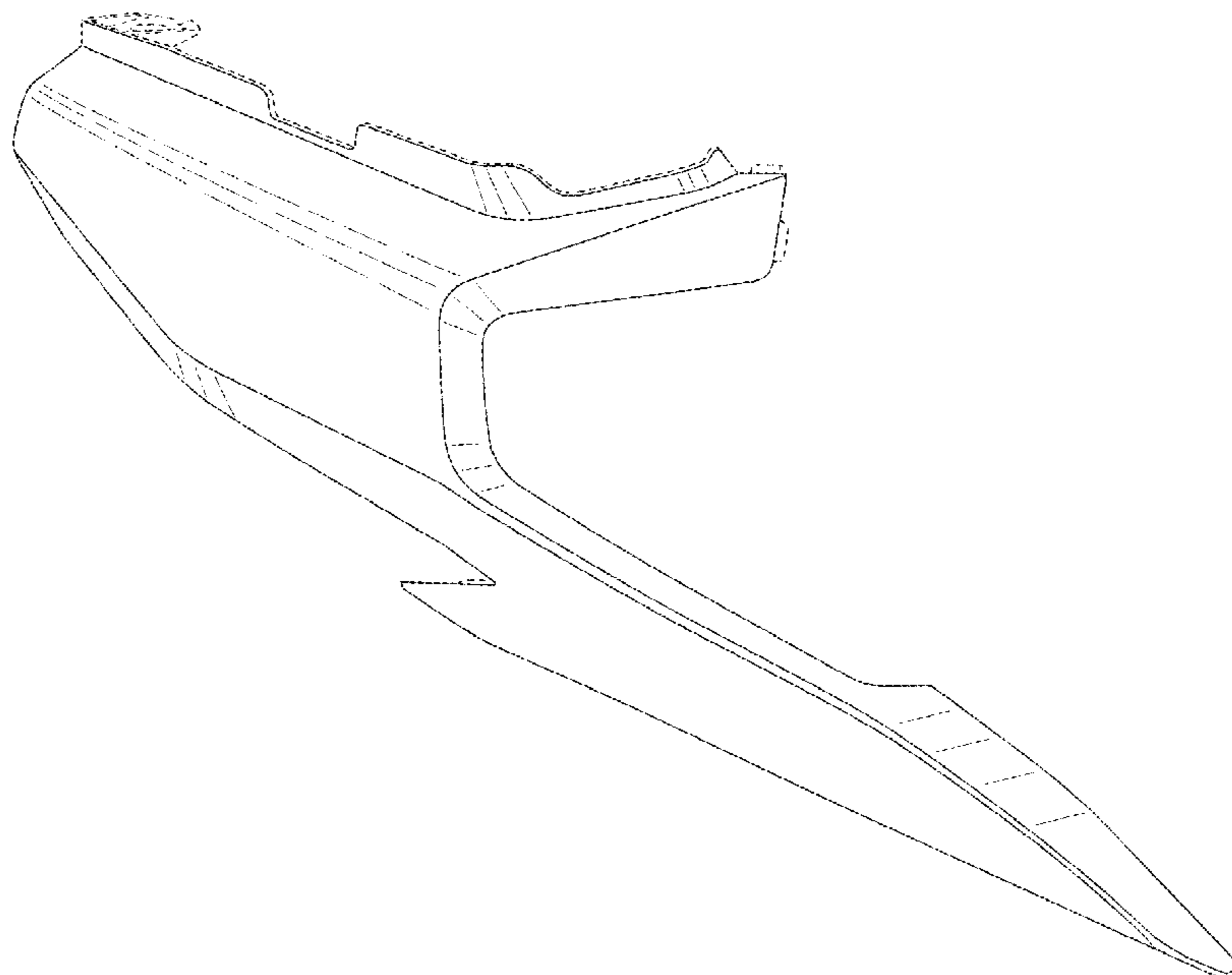
(57) **CLAIM**

The ornamental design for a rear cowl for a motorcycle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of a rear cowl for a motorcycle showing our new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a right side elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof;  
FIG. 7 is a front and left side perspective view thereof; and,  
FIG. 8 is a front elevation view thereof as installed on an exemplary motorcycle.  
The broken line showing portions of the cowl and an environmental motorcycle do not form part of the claimed design.

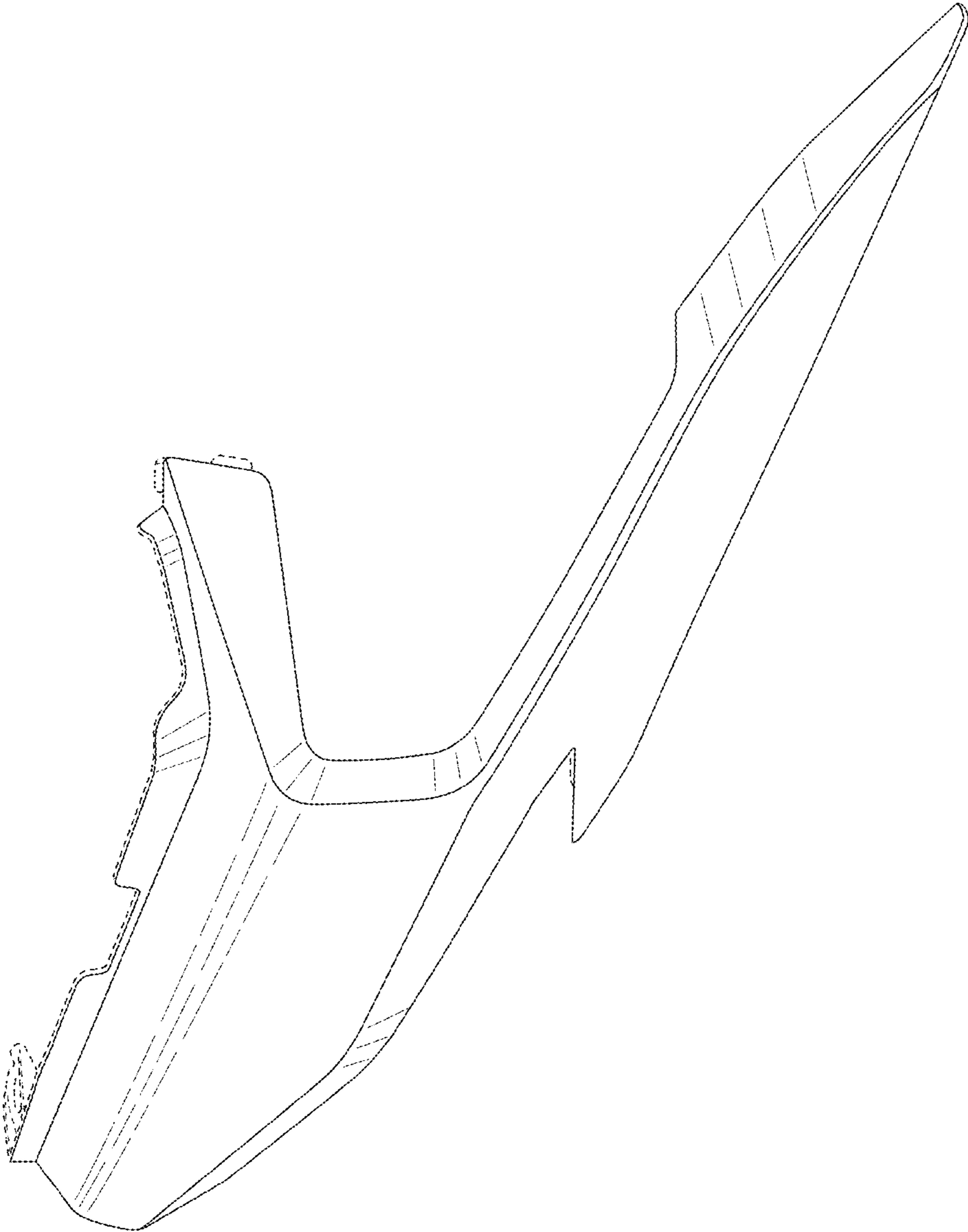

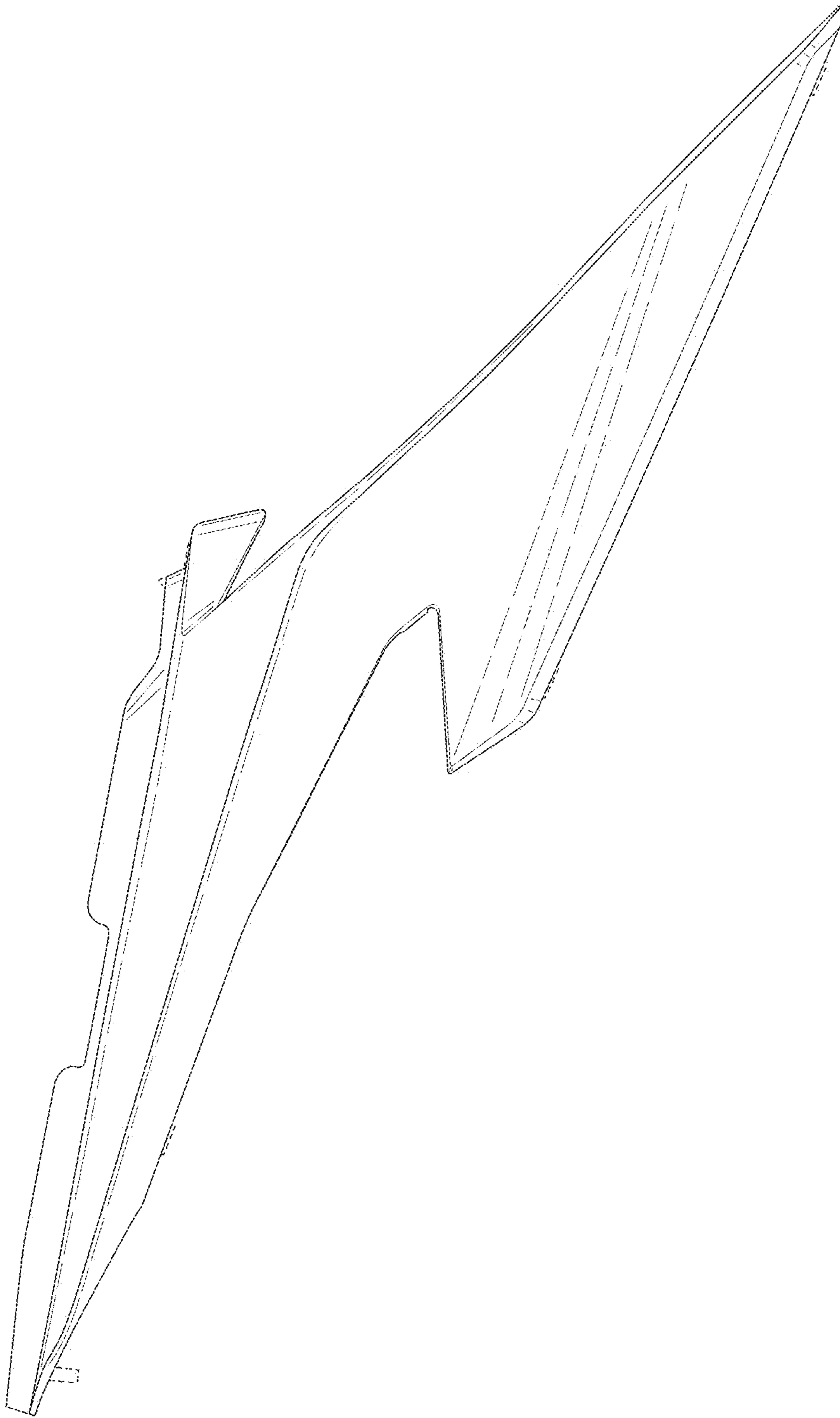

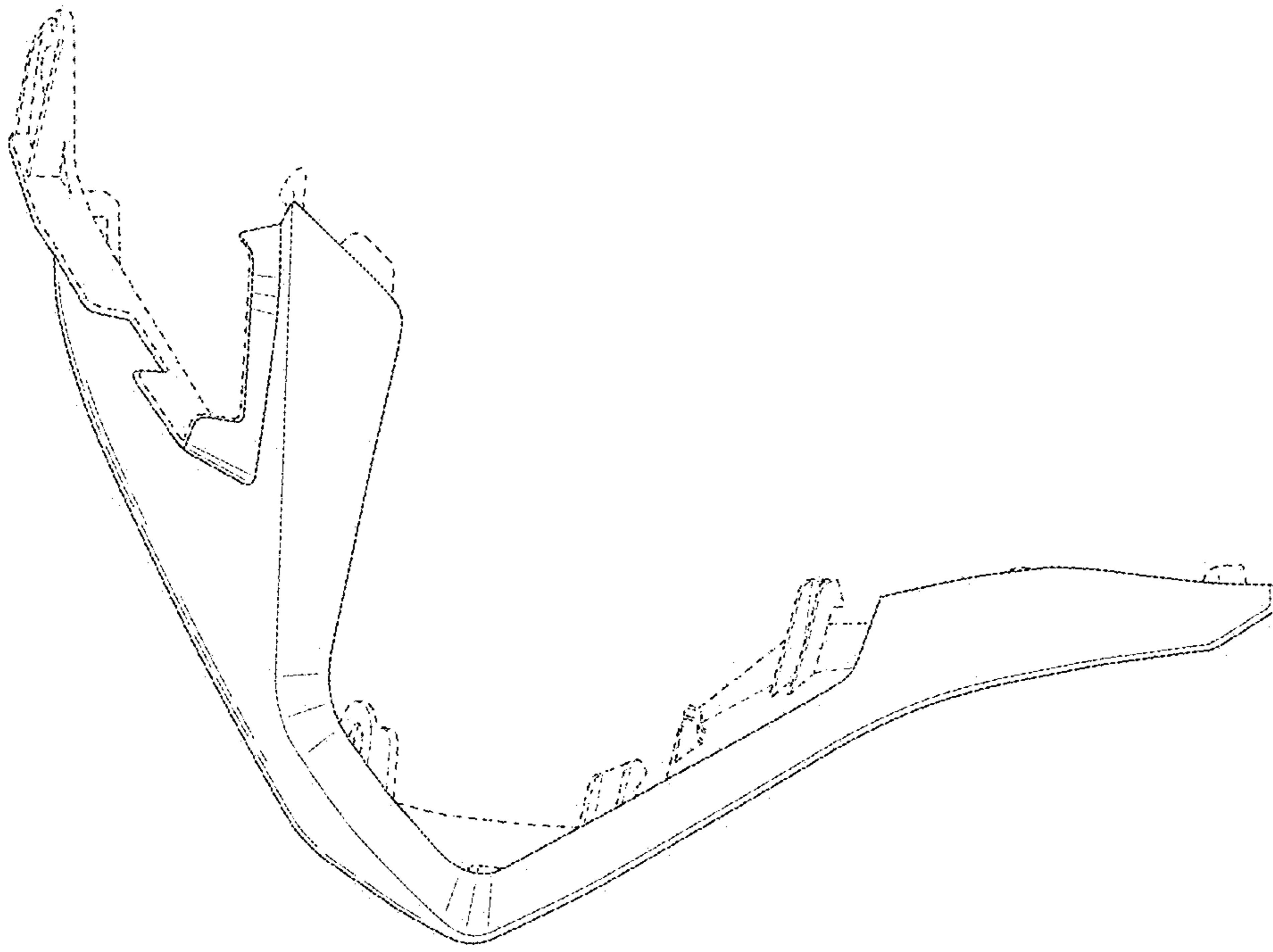

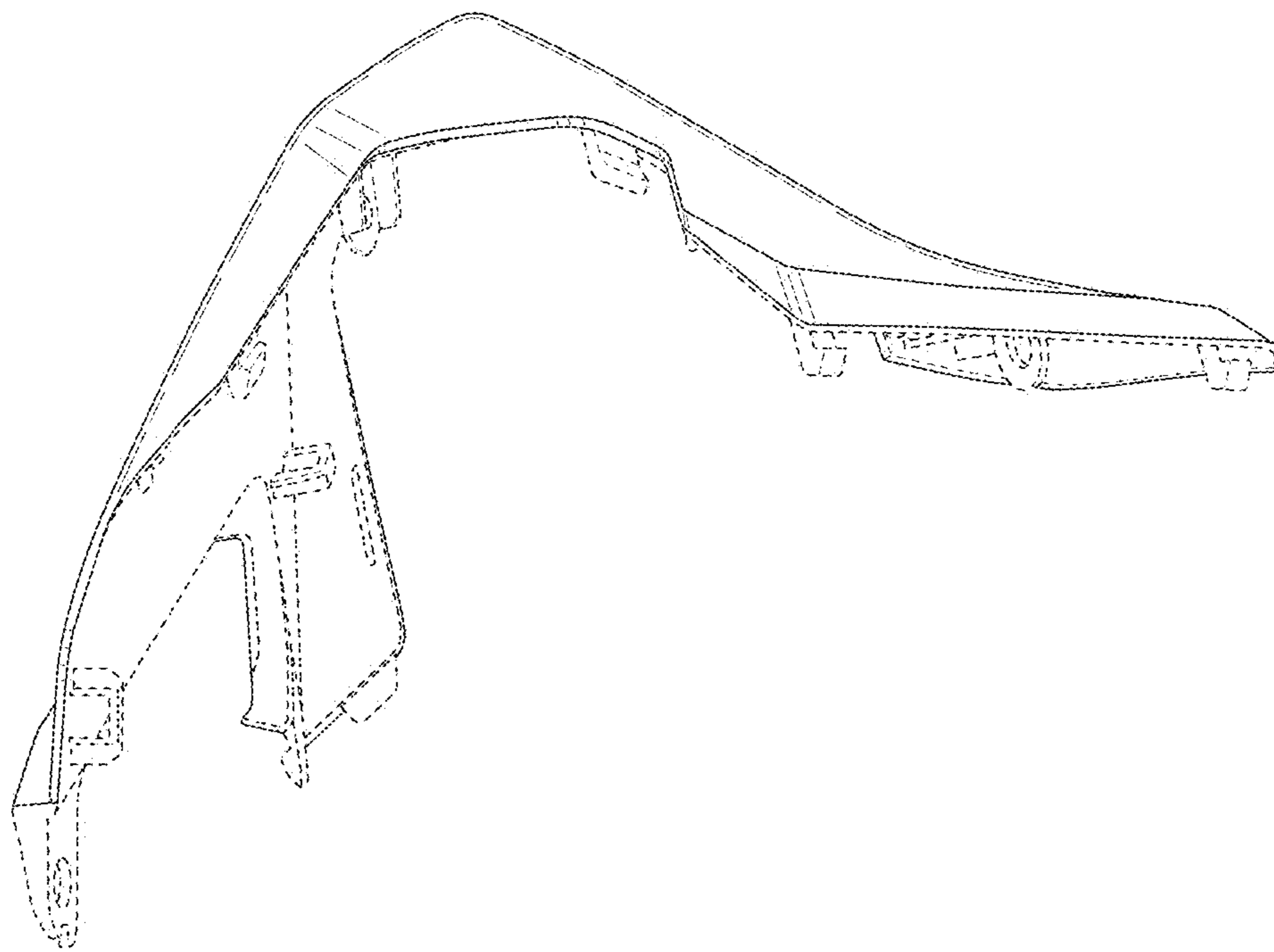

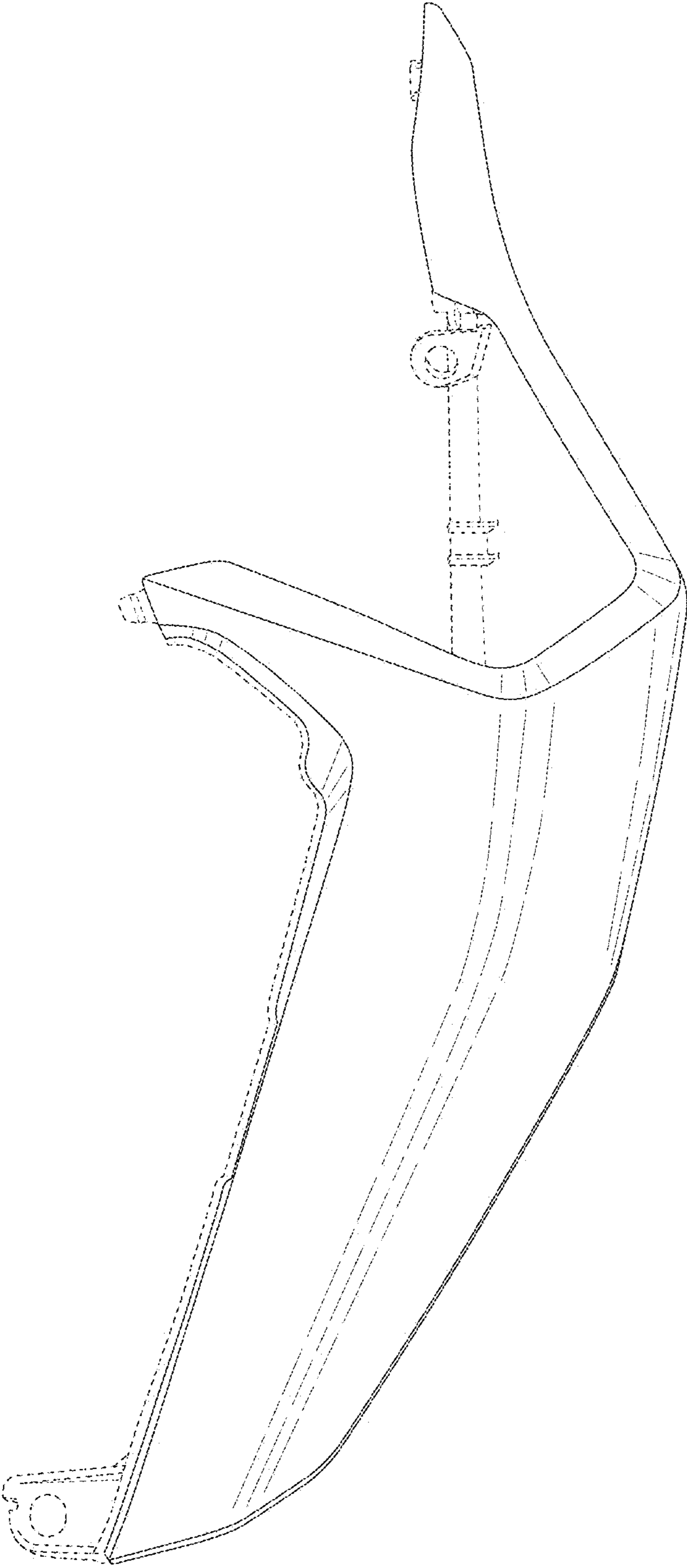

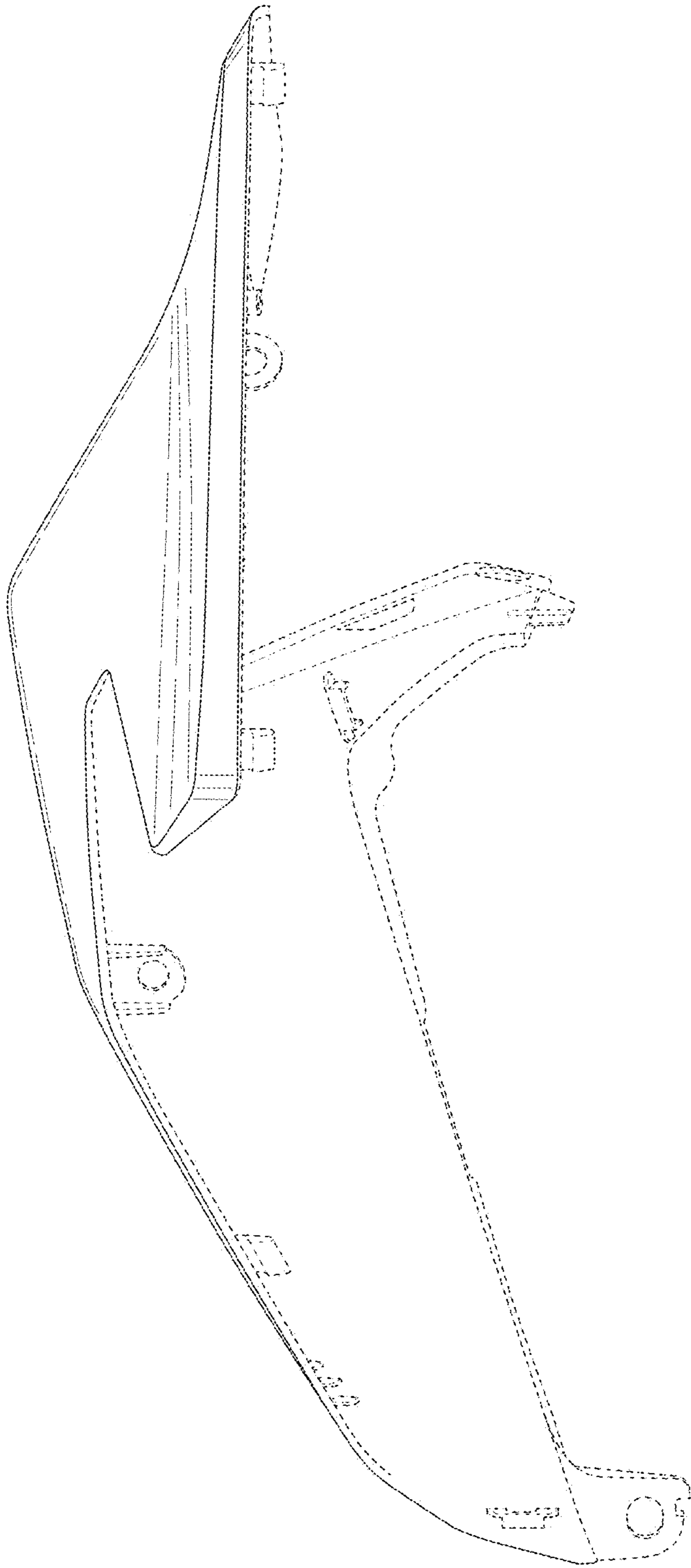

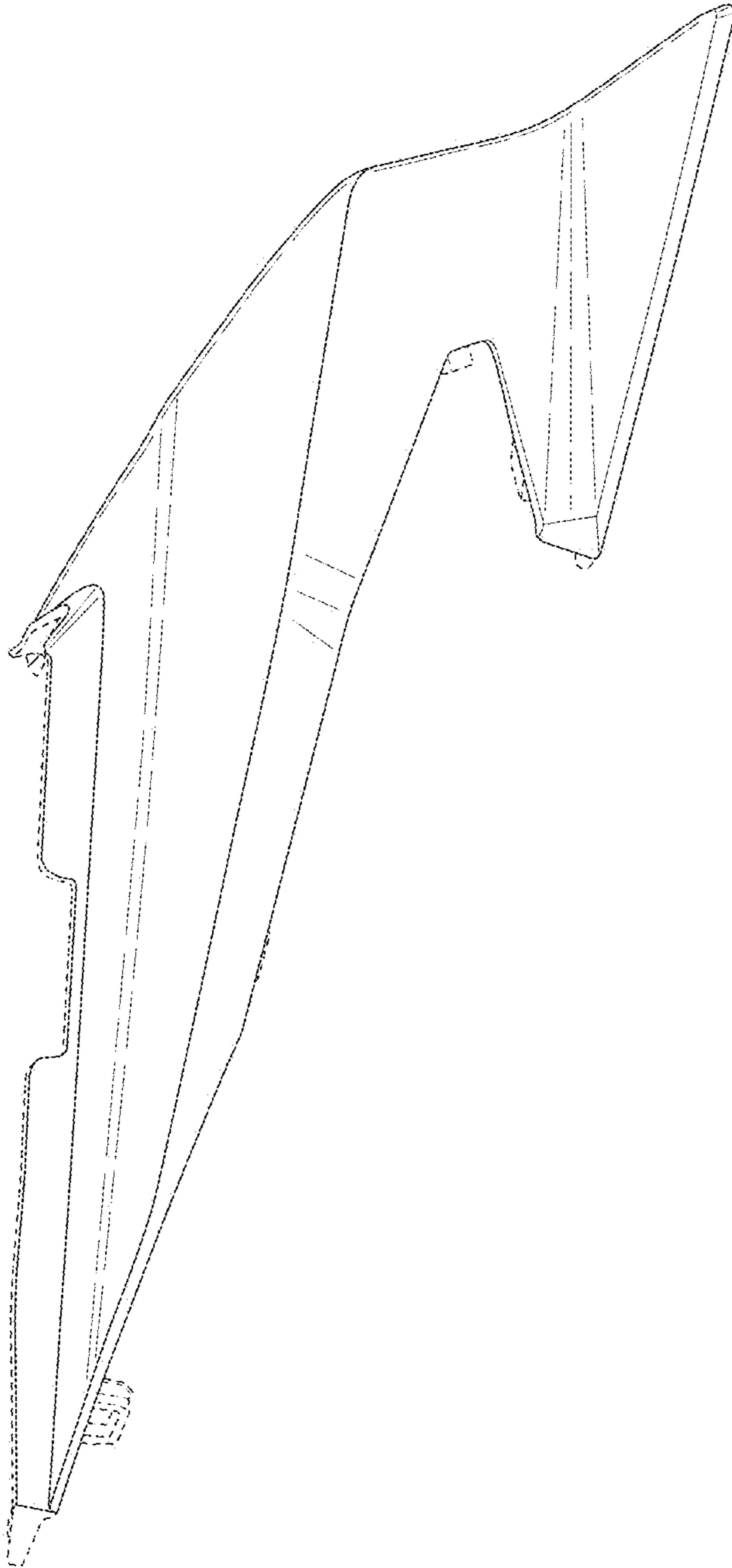

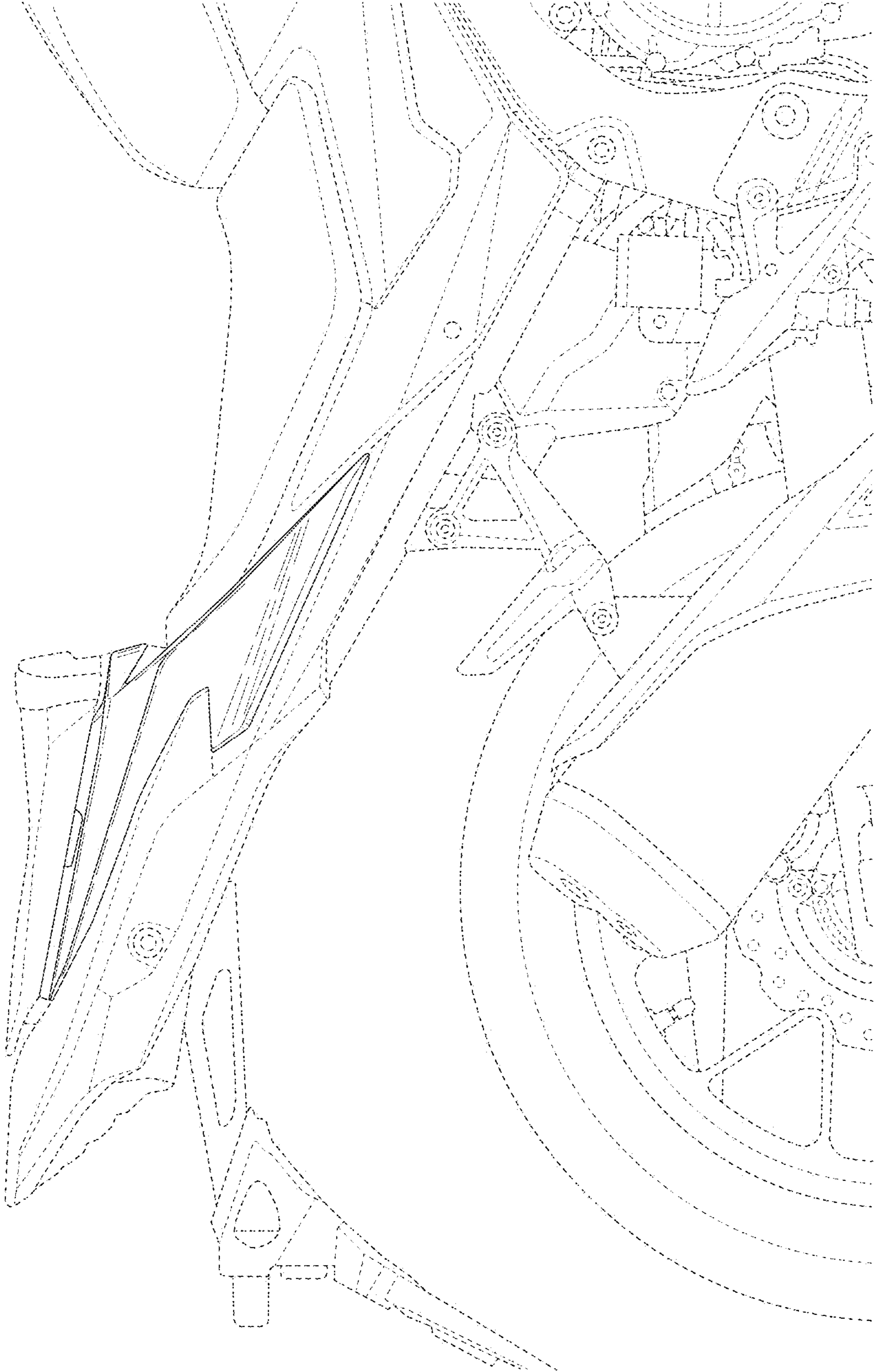
