(57) **CLAIM**

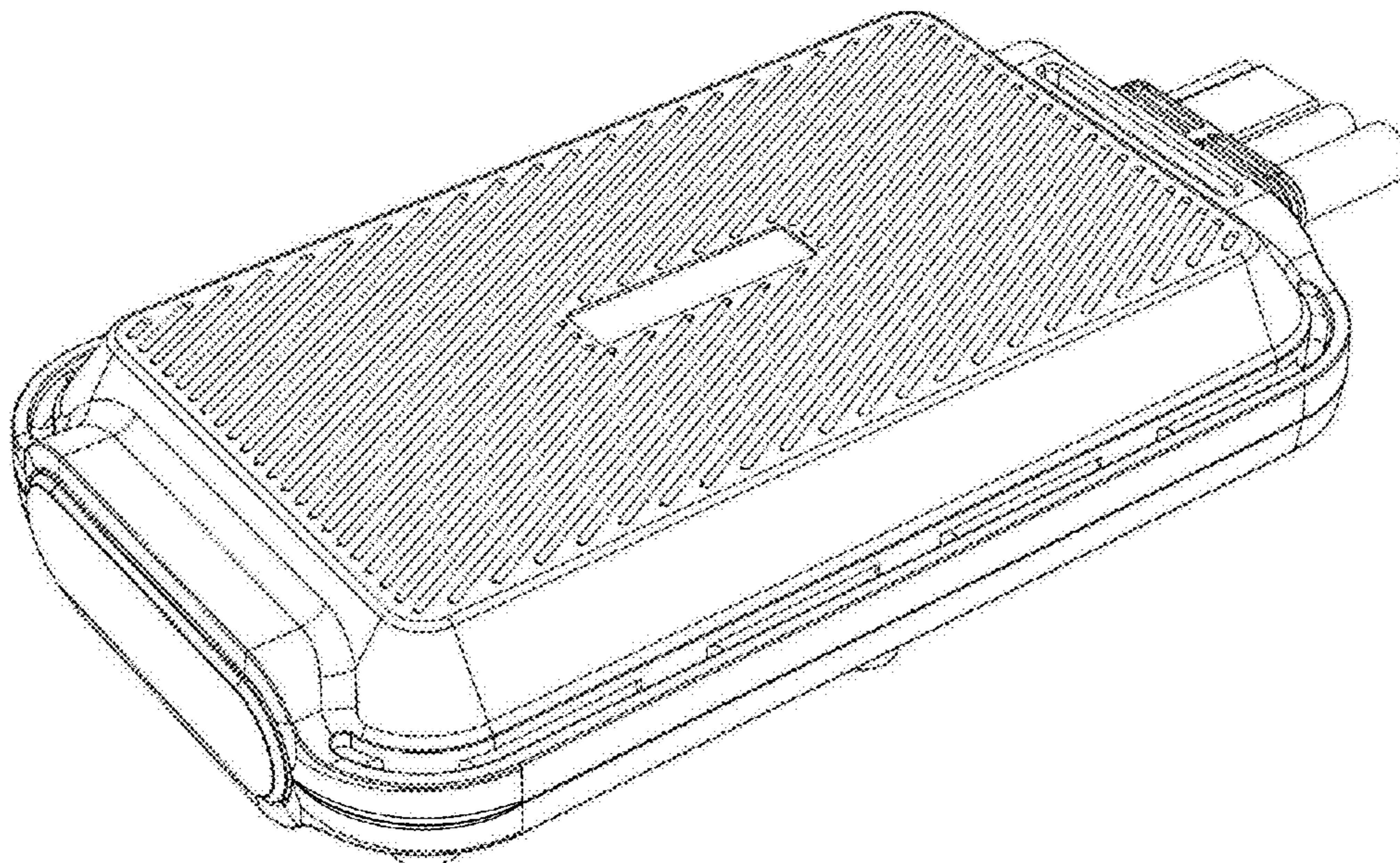
The ornamental design for a power unit for vehicle video recorder, as shown and described.

FIG. 7 is a bottom view thereof.

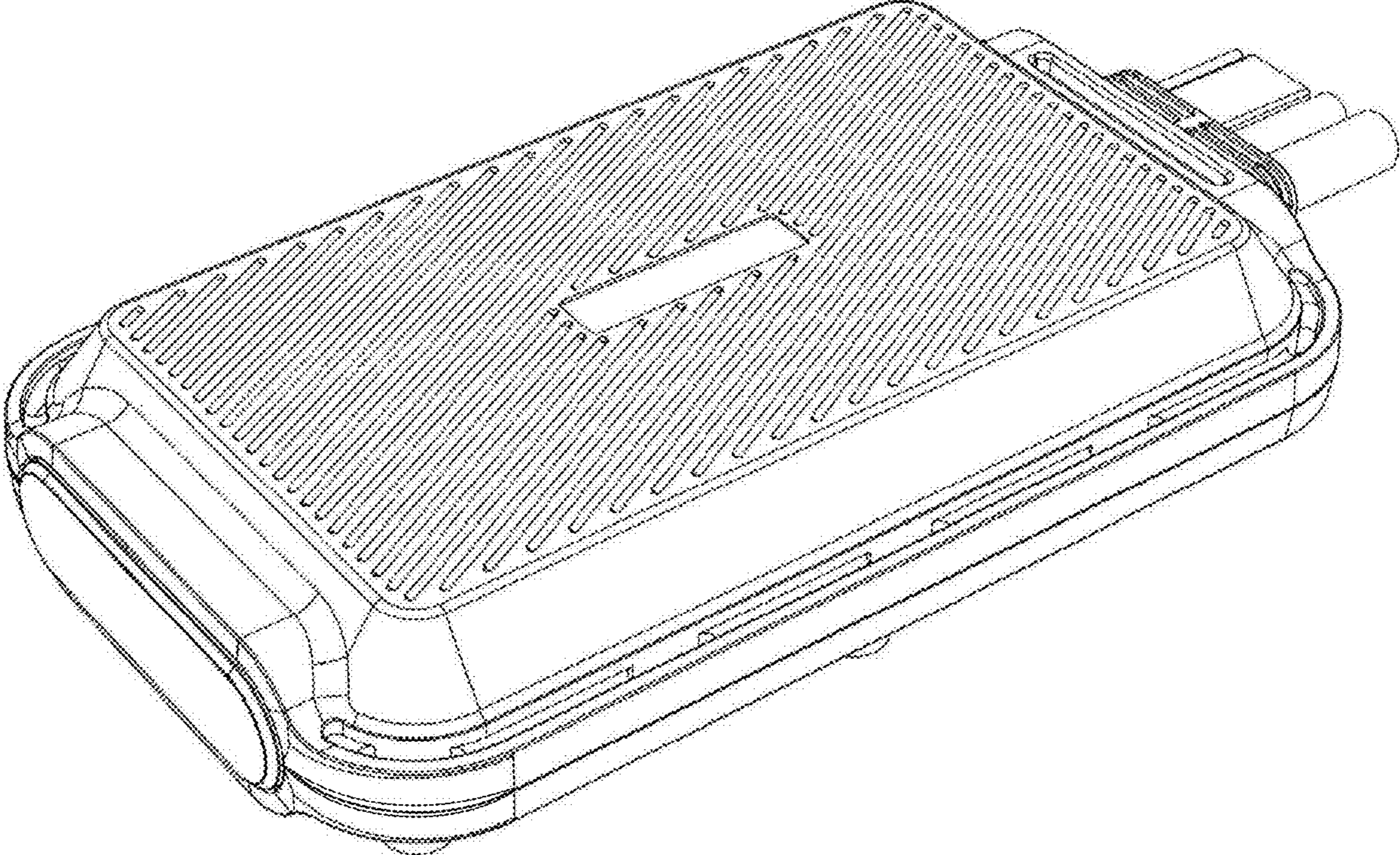
The broken lines in the drawings depict portions of the power unit for vehicle video recorder that form no part of the claimed design.

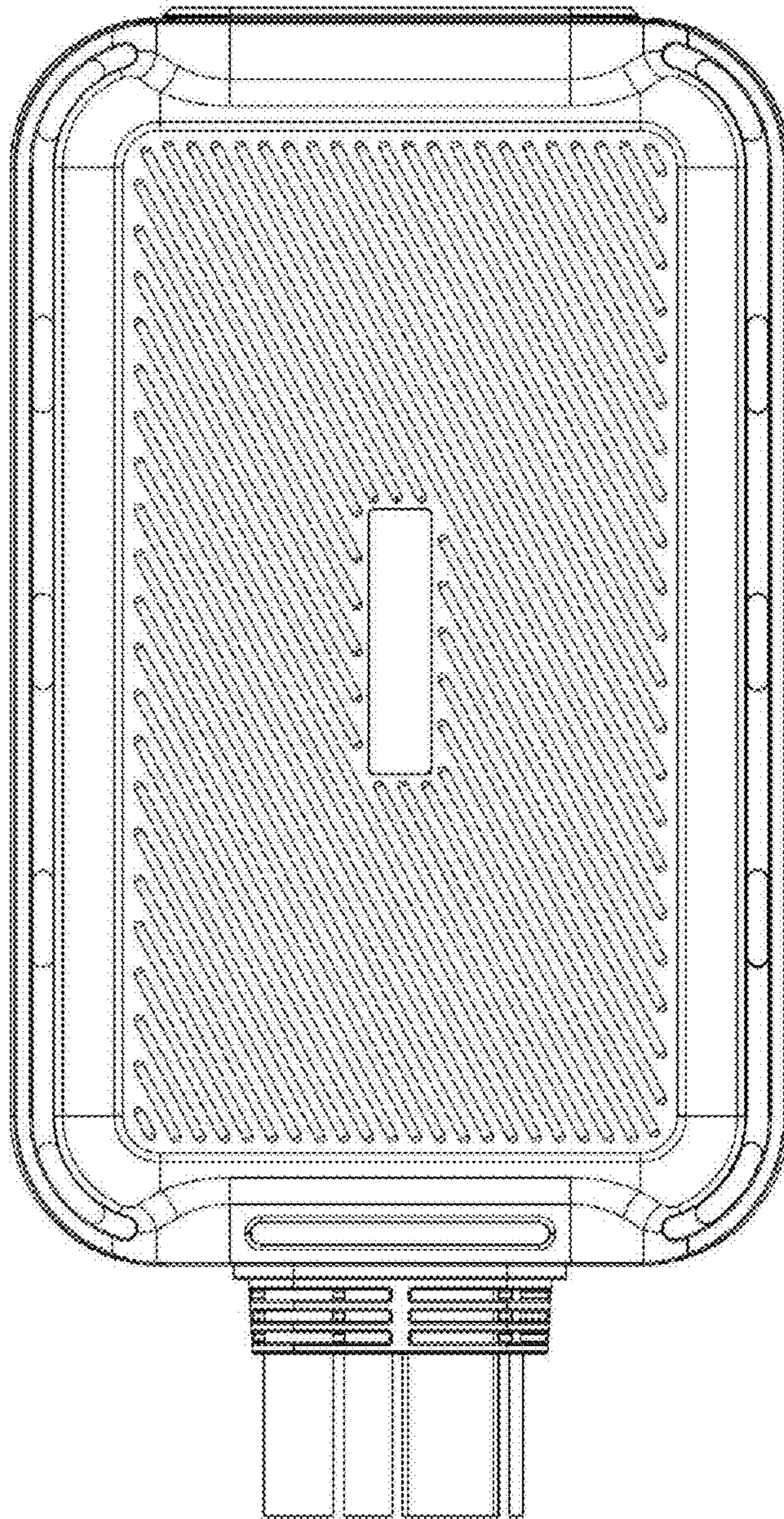

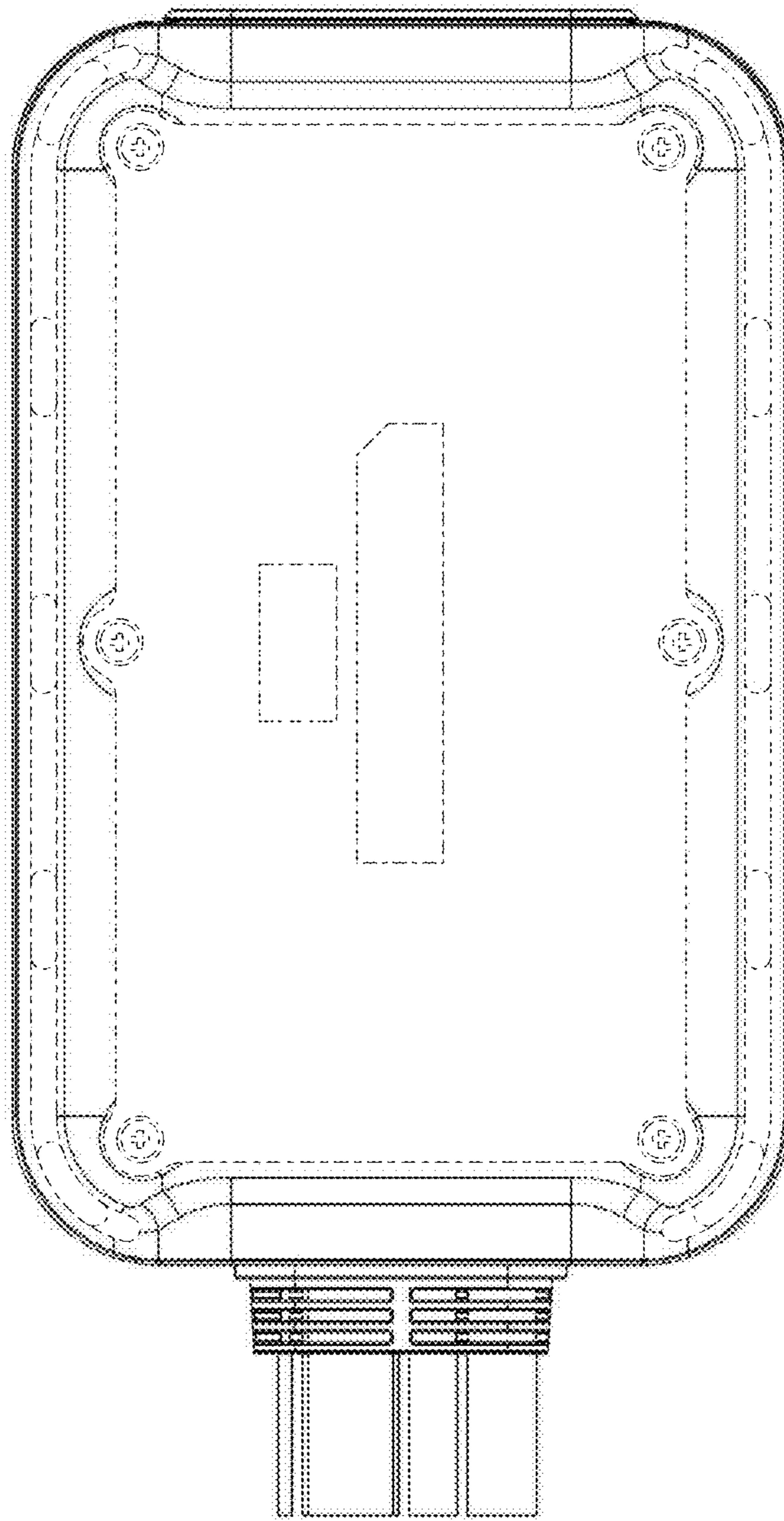




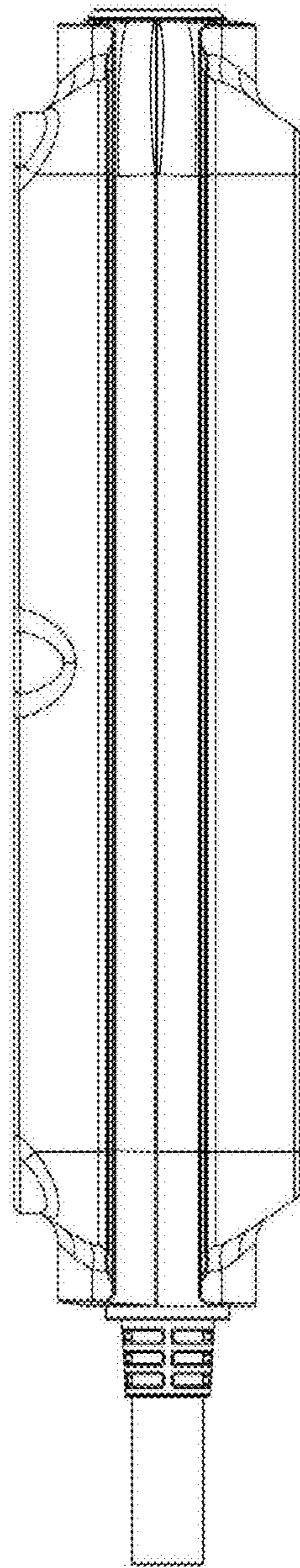

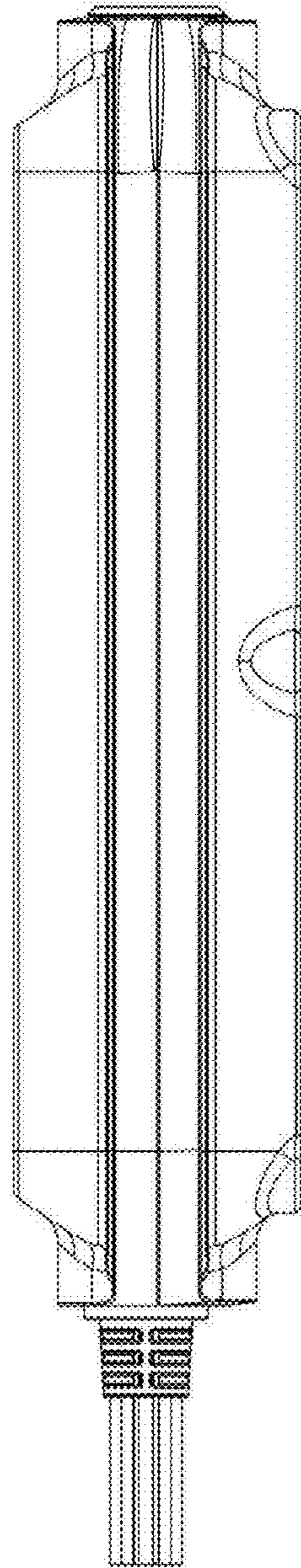

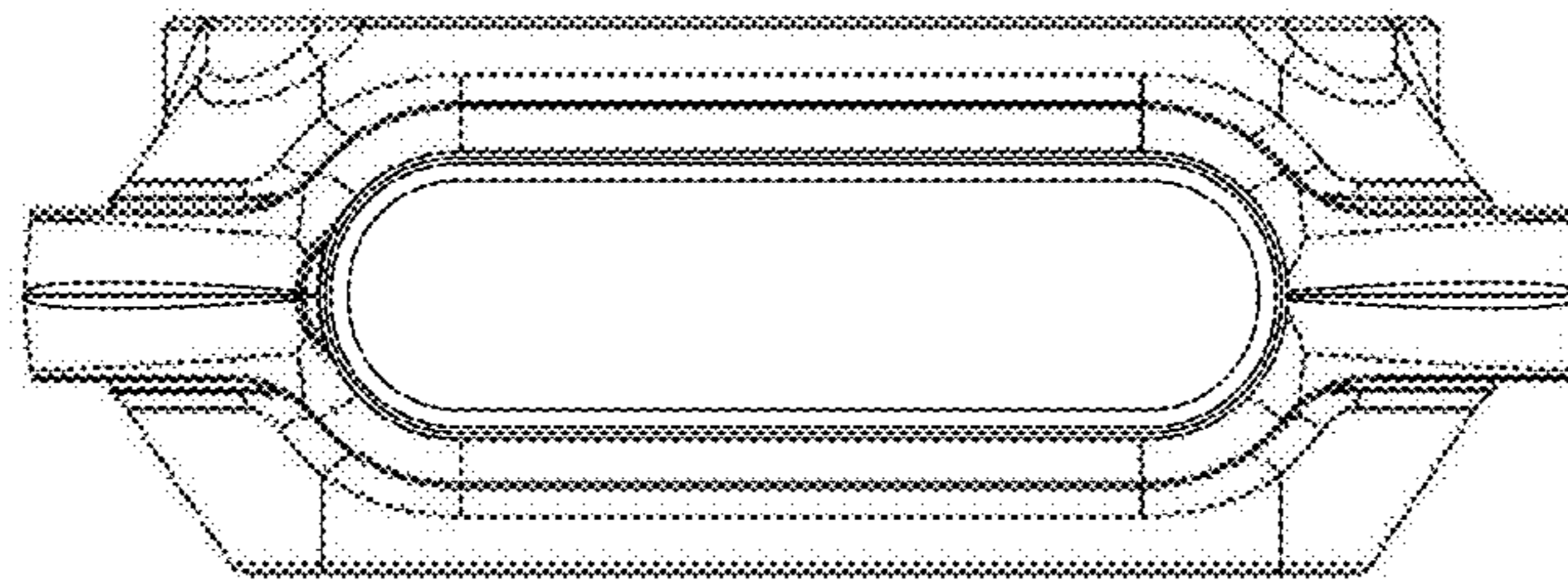
