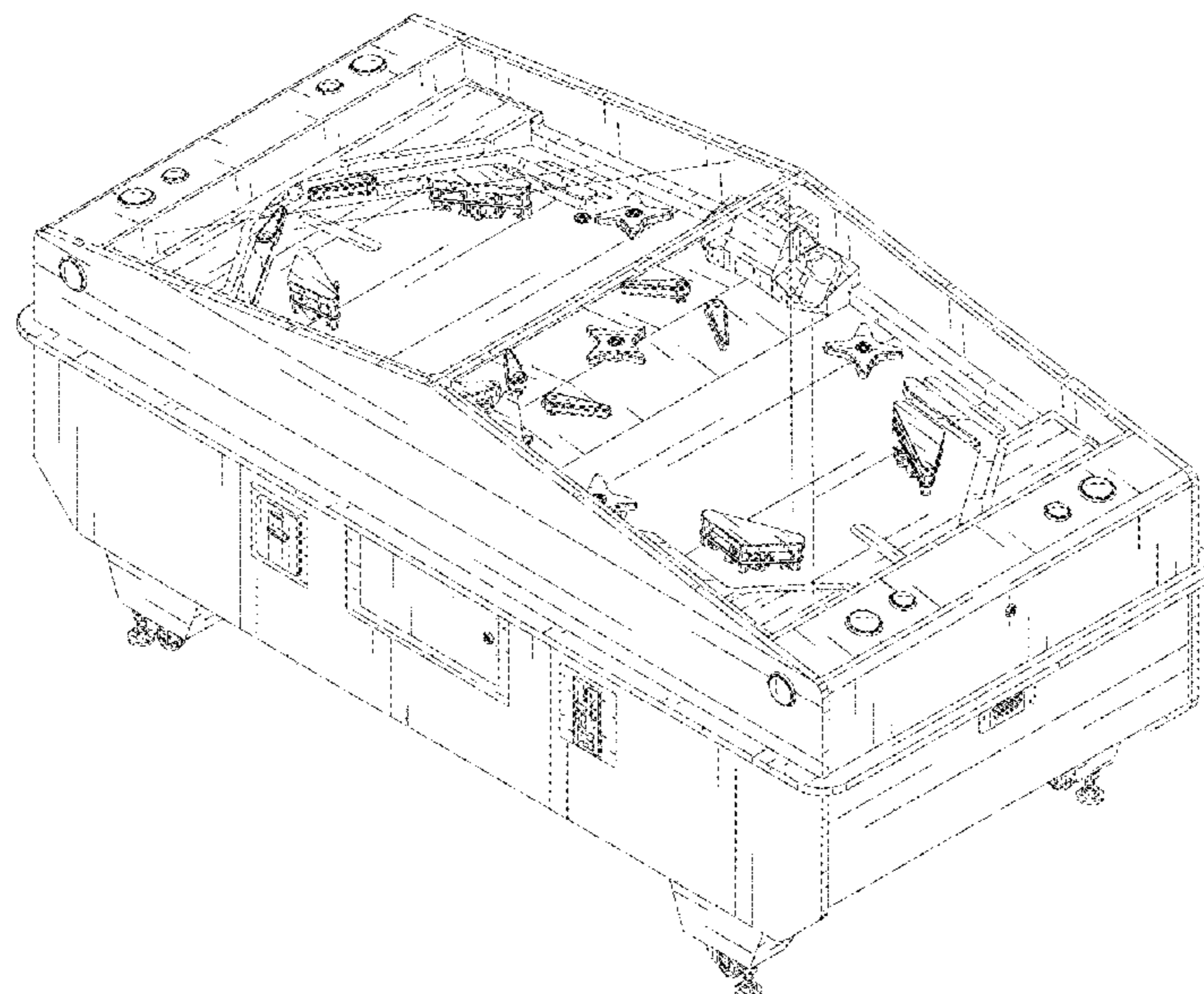
(57) **CLAIM**

The ornamental design for a two player pinball machine, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a two player pinball machine showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side perspective view thereof; FIG. 5 is a right side perspective view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a rear perspective view thereof. The broken lines shown represent portions of the two player pinball machine that form no part of the claimed design.

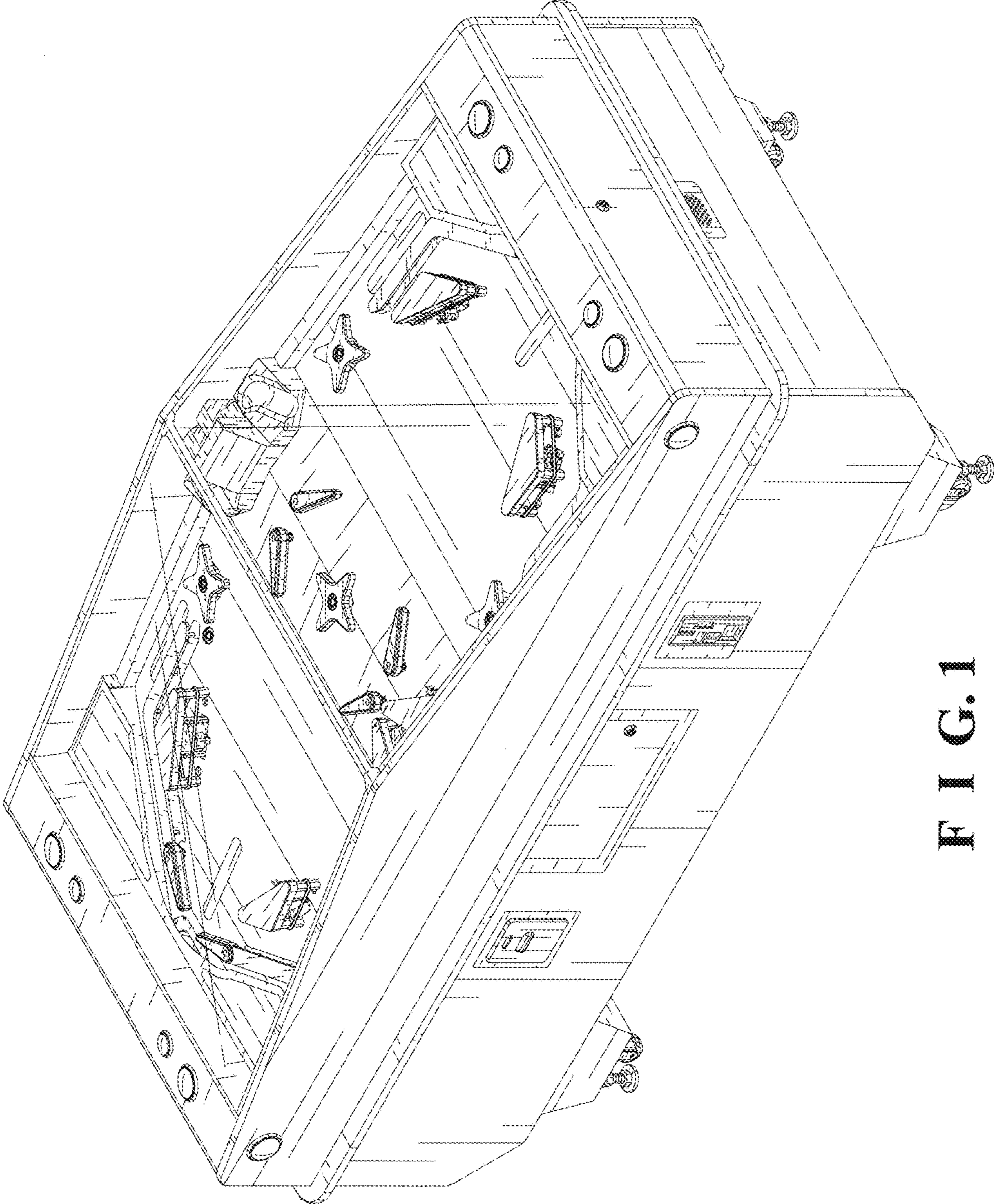

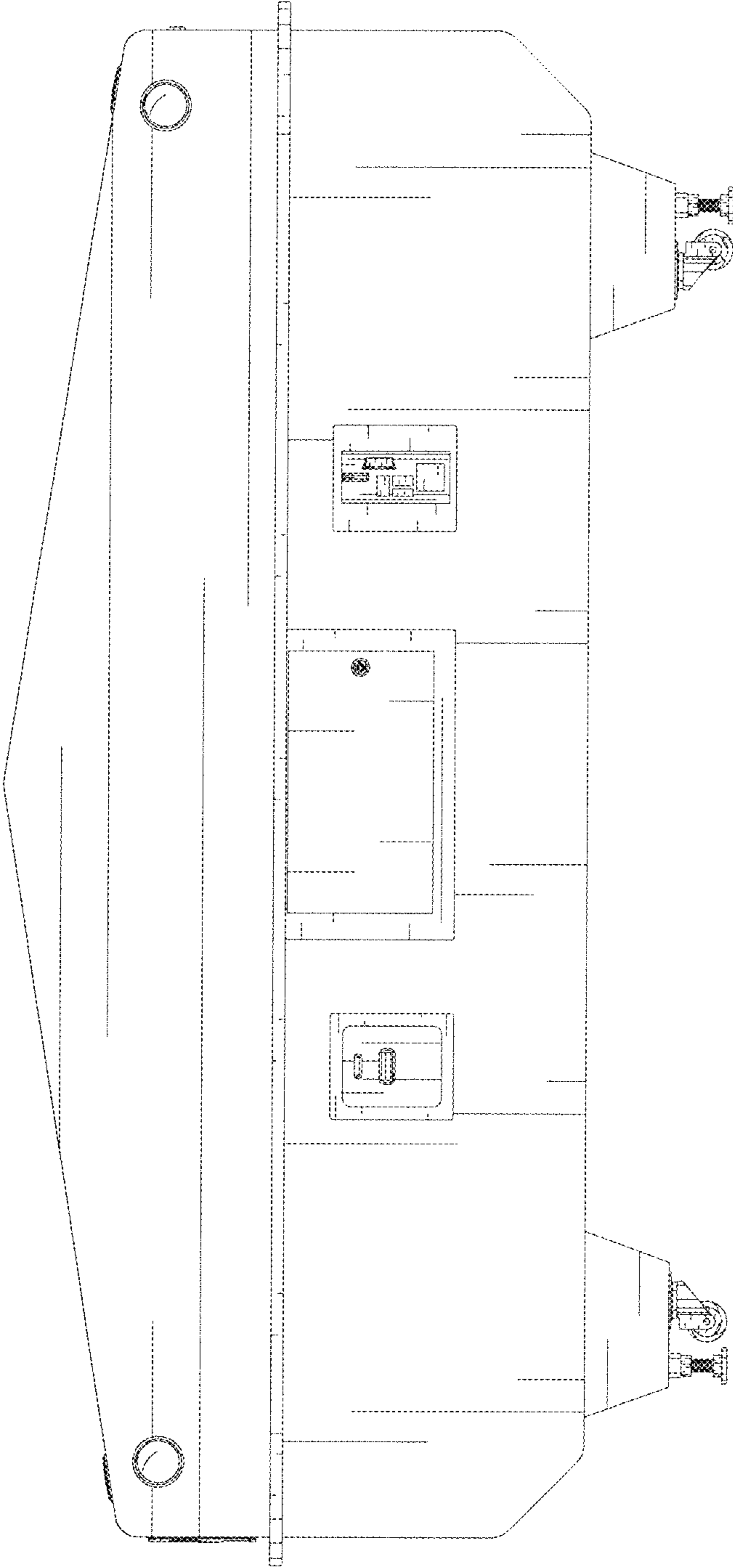

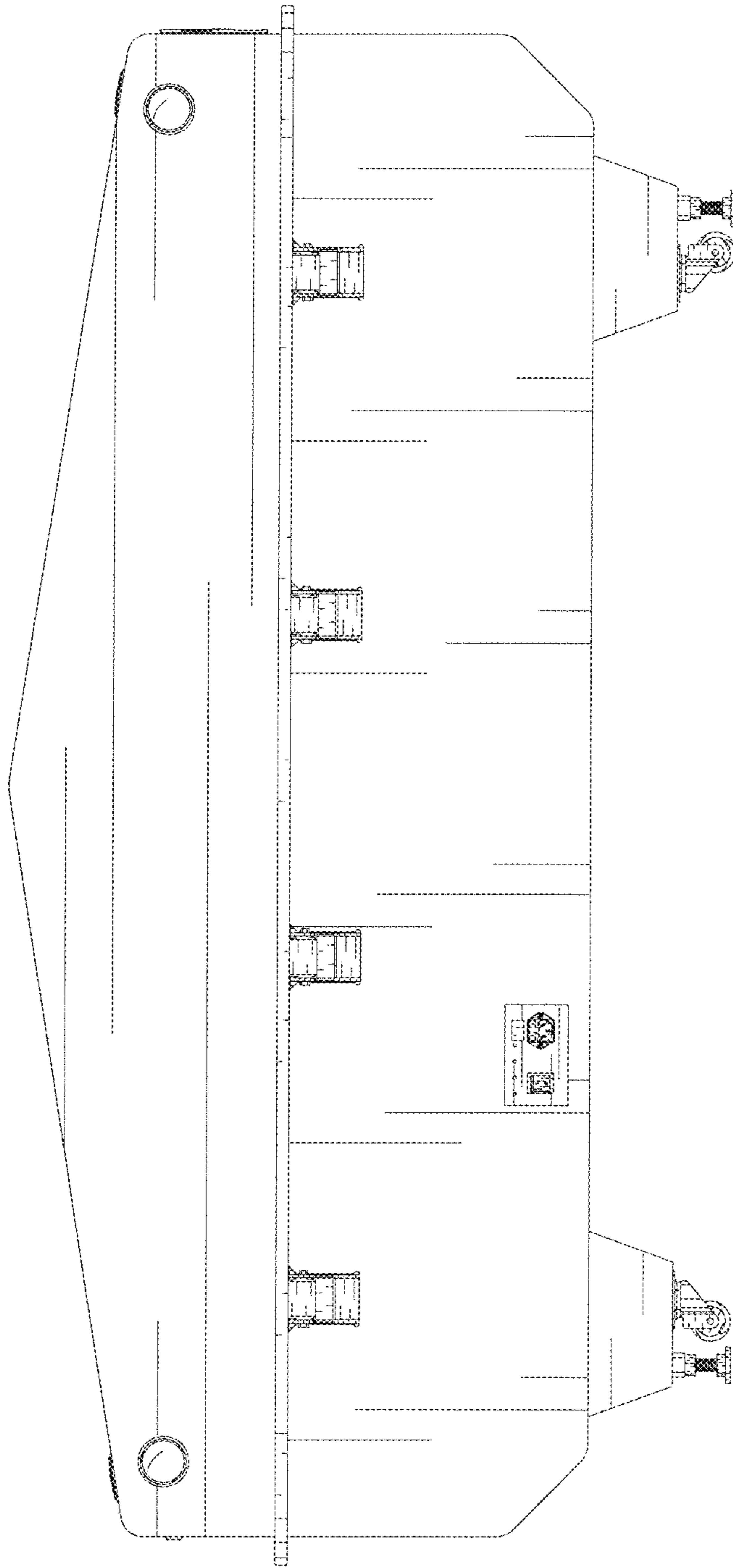

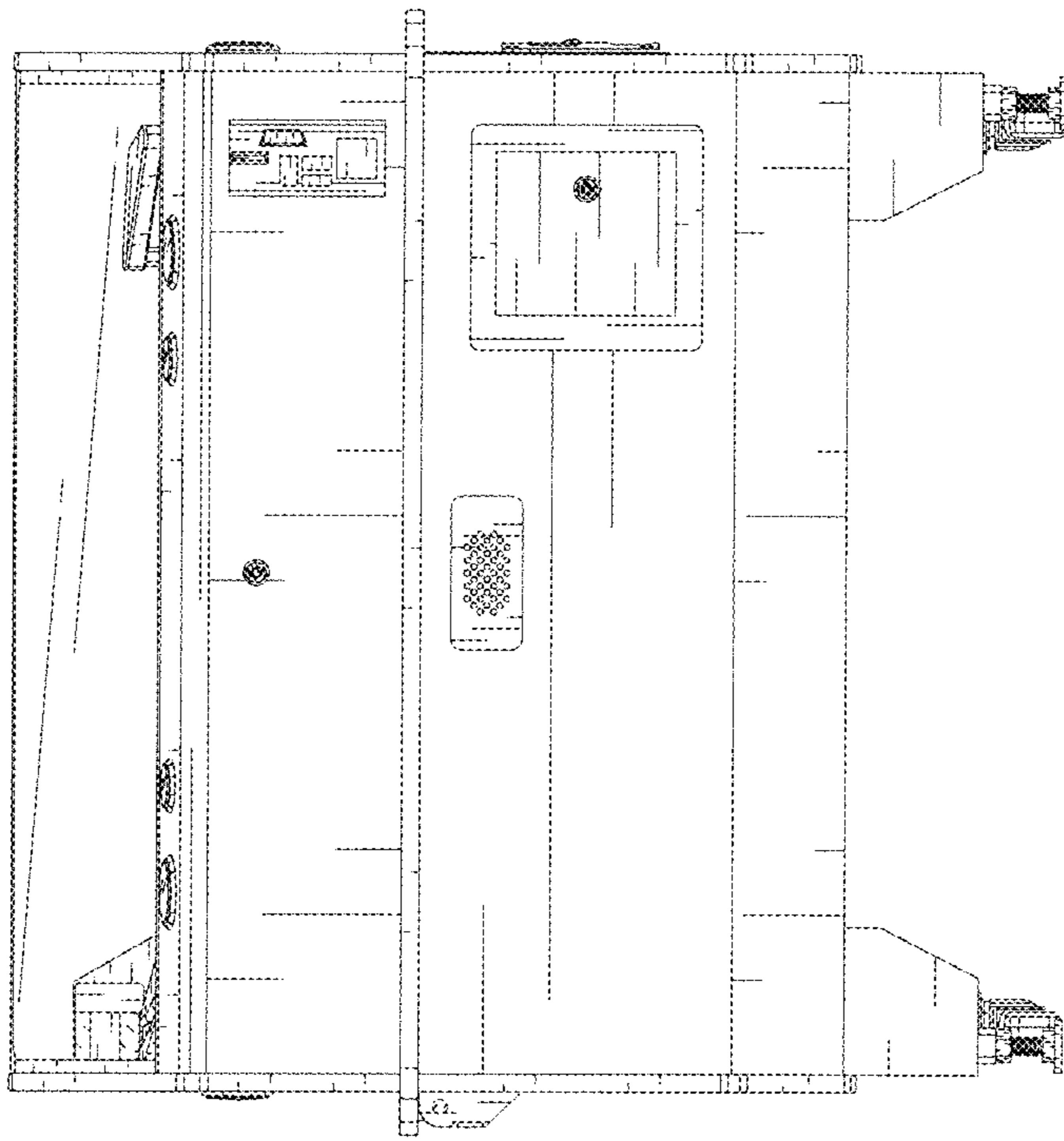

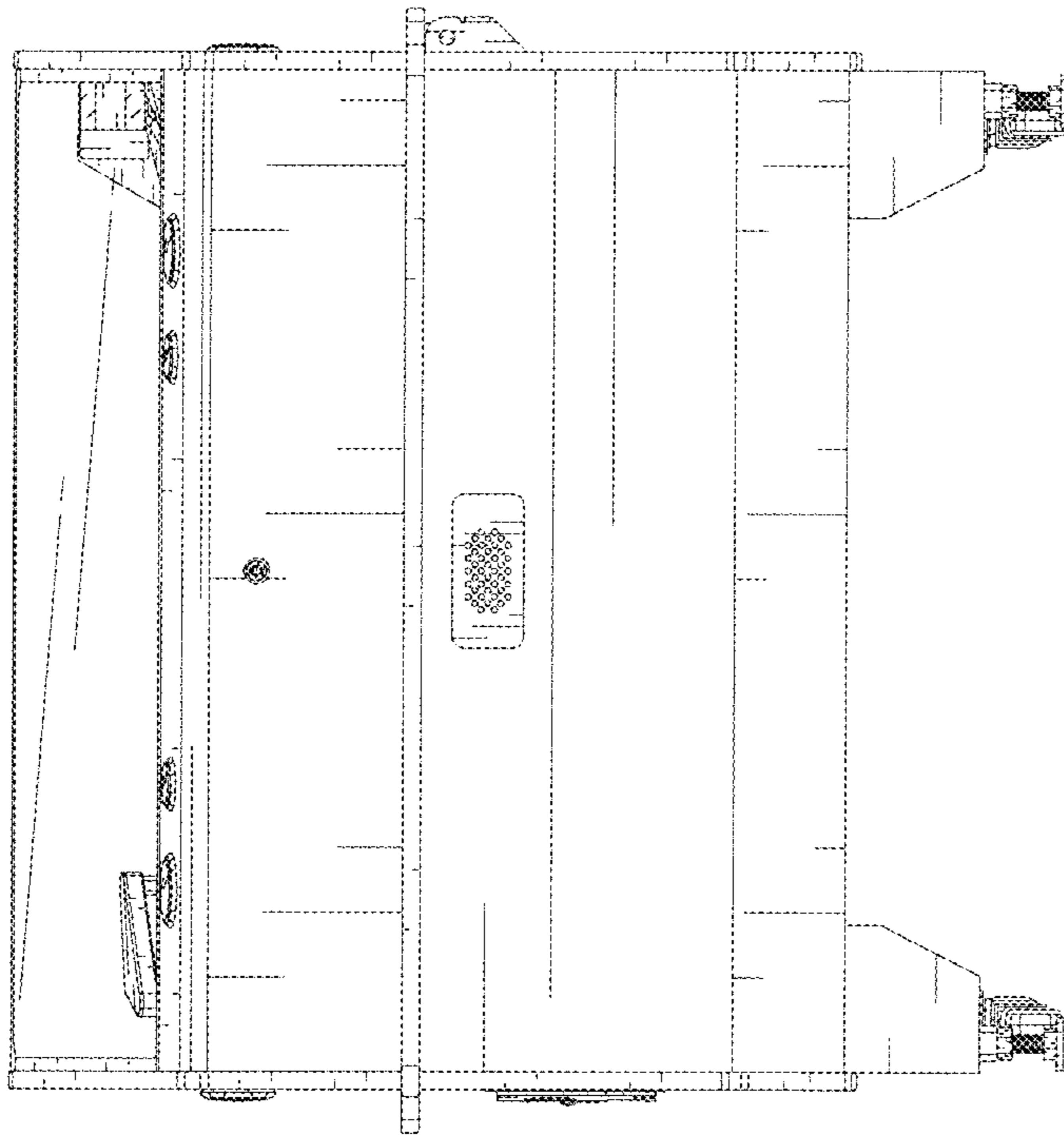

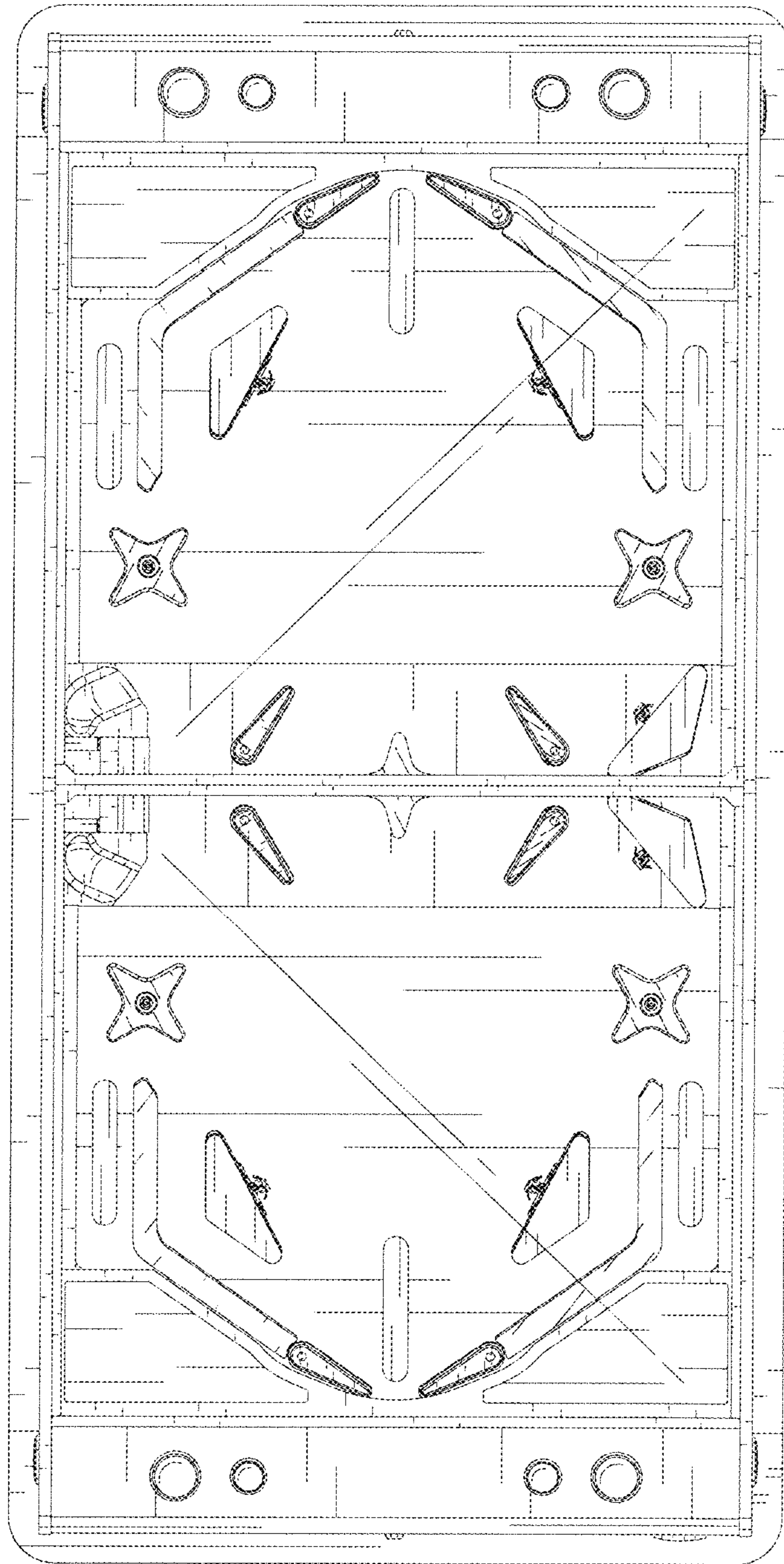

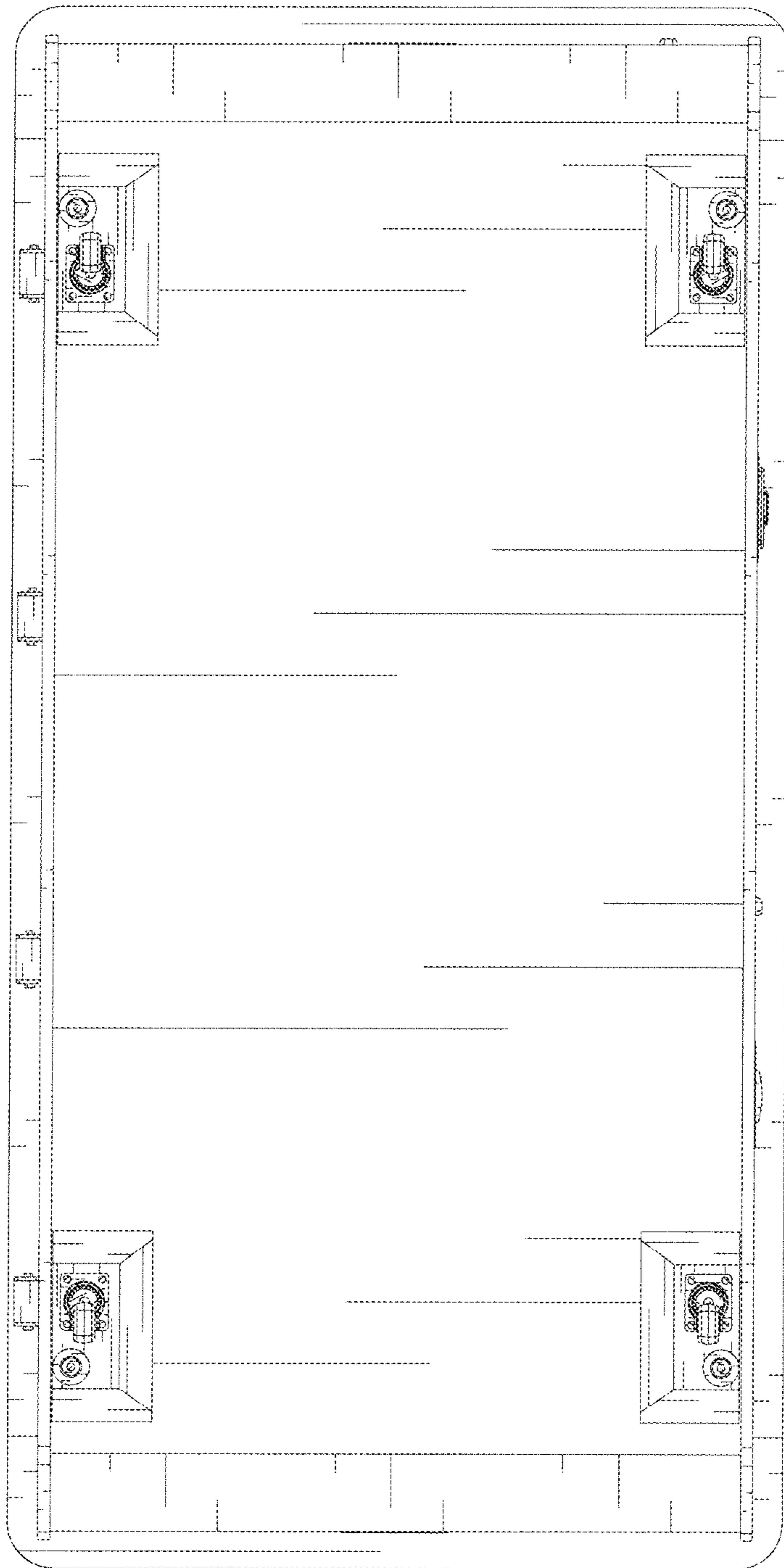

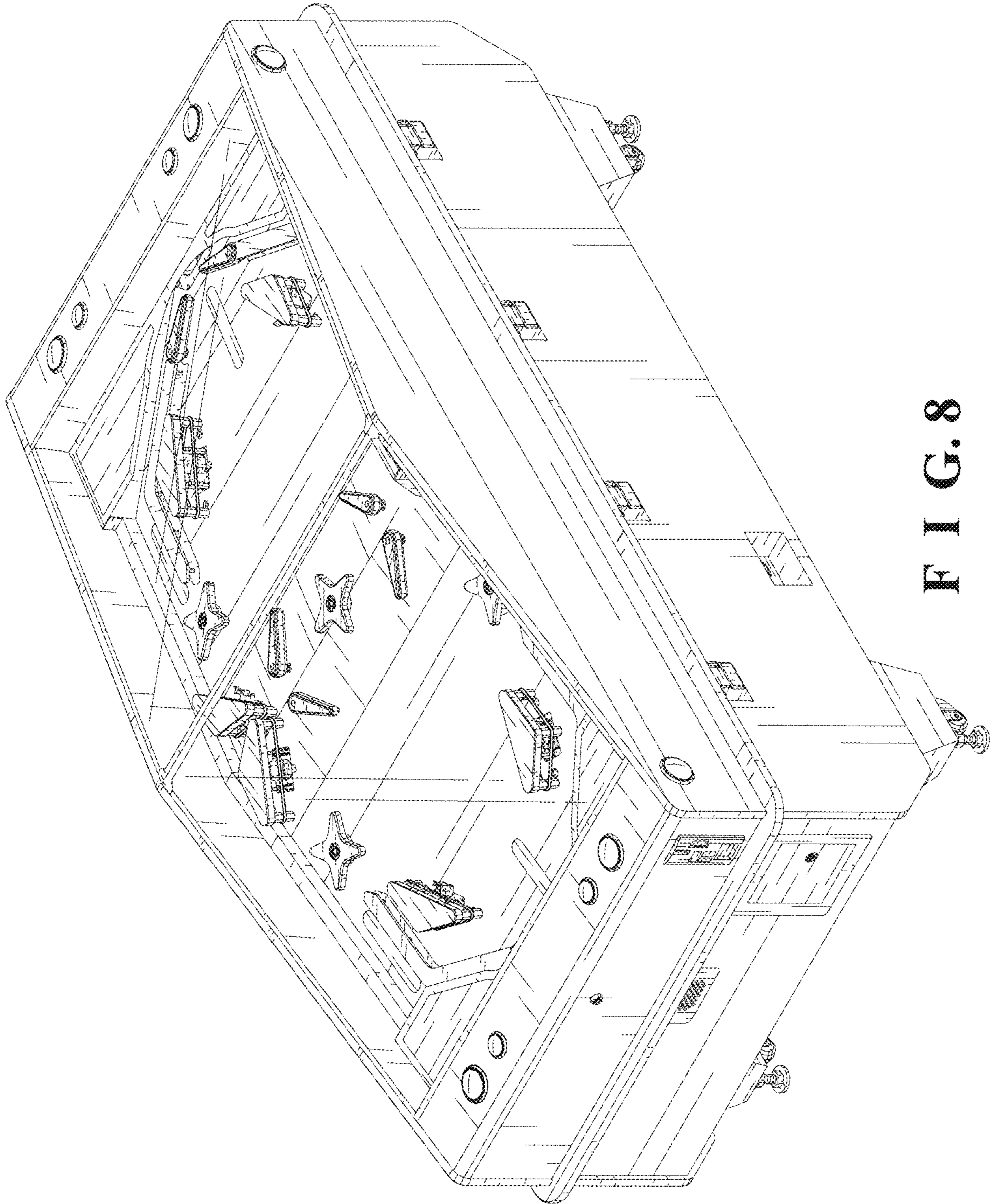
