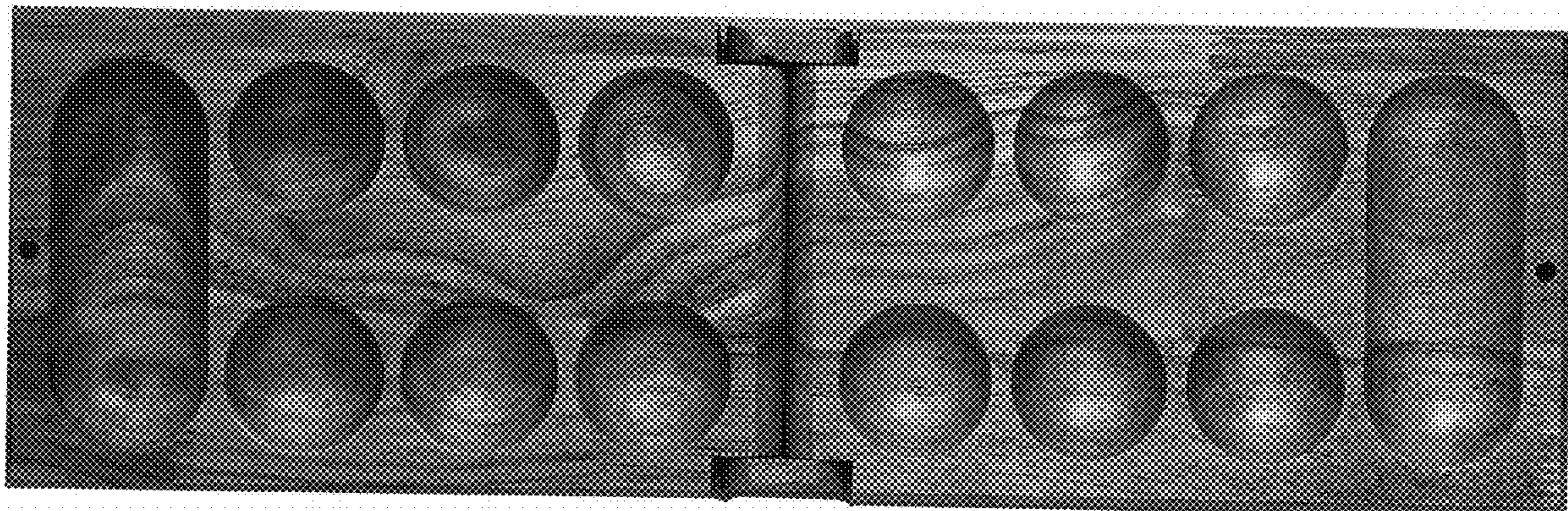
(57) **CLAIM**

The ornamental design for a mancala game set, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a mancala game set, shown in an open condition;  
FIG. 2 is a front, top surface perspective view thereof;  
FIG. 3 is a bottom view thereof;  
FIG. 4 is a front, bottom surface perspective of the mancala game set shown in a closed condition, the rear, bottom perspective view being a mirror image;  
FIG. 5 is a right side, bottom surface perspective view thereof; and,  
FIG. 6 is a left side, bottom surface perspective view thereof.

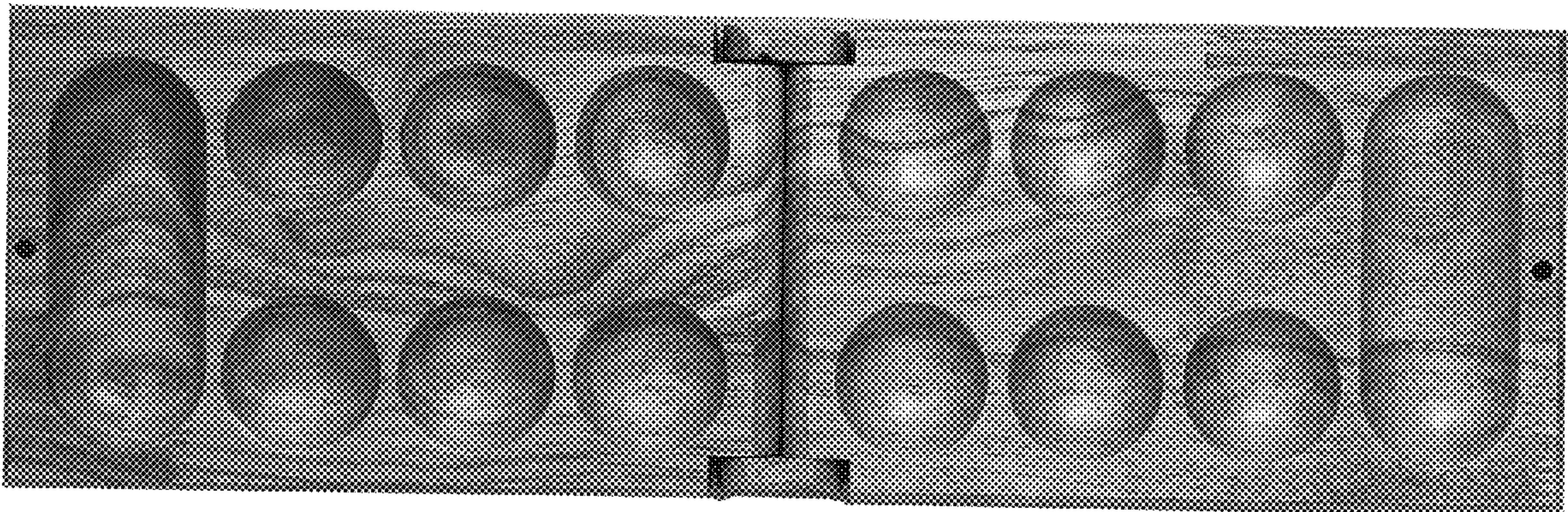

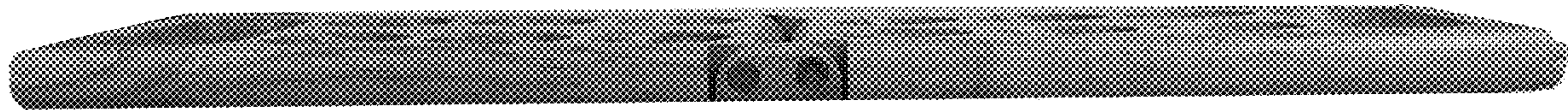

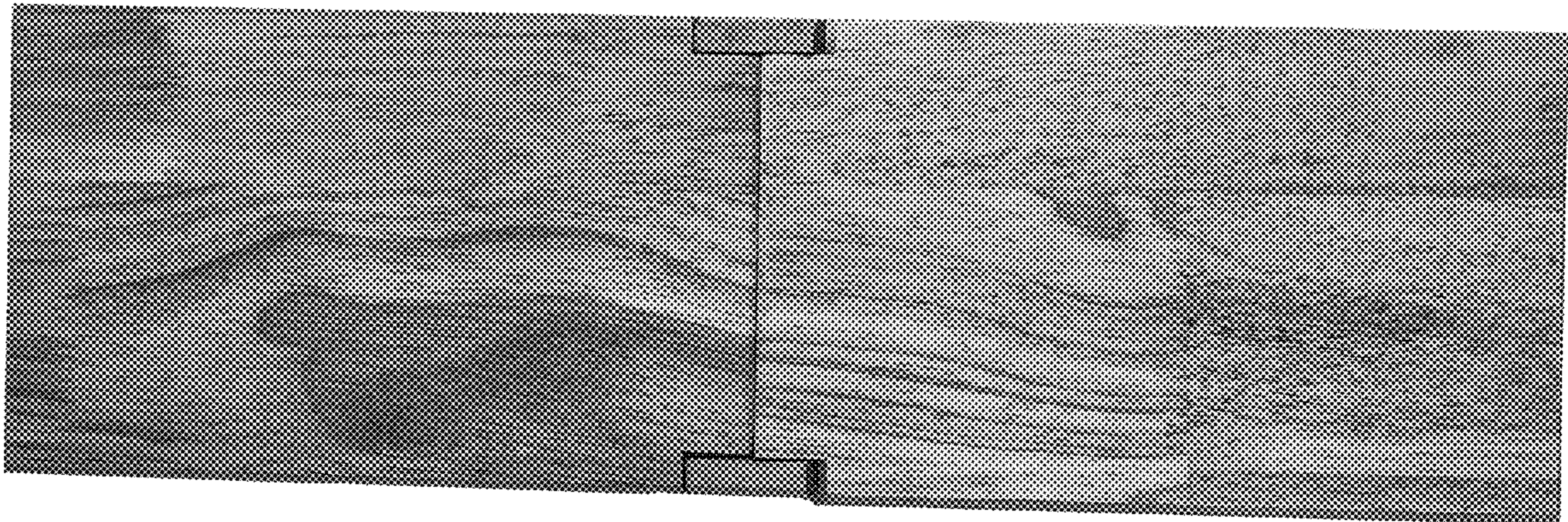

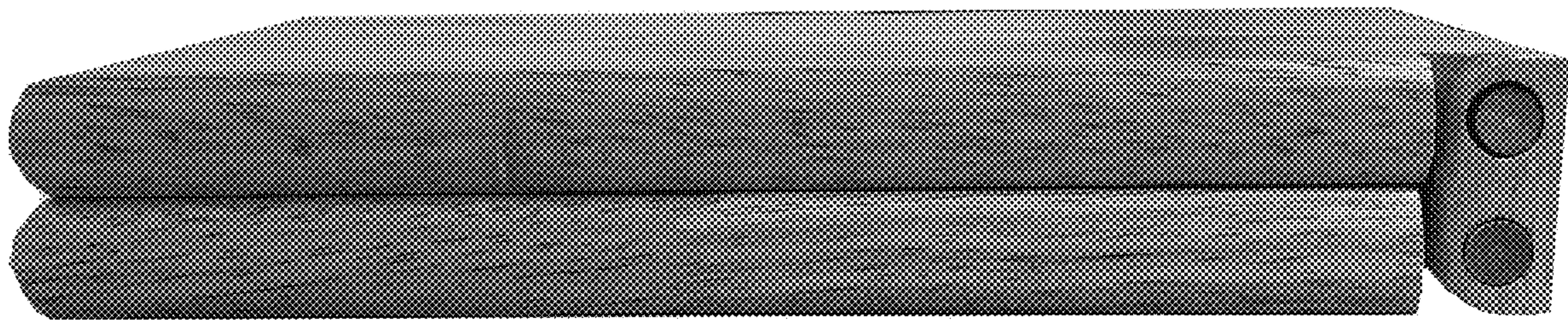

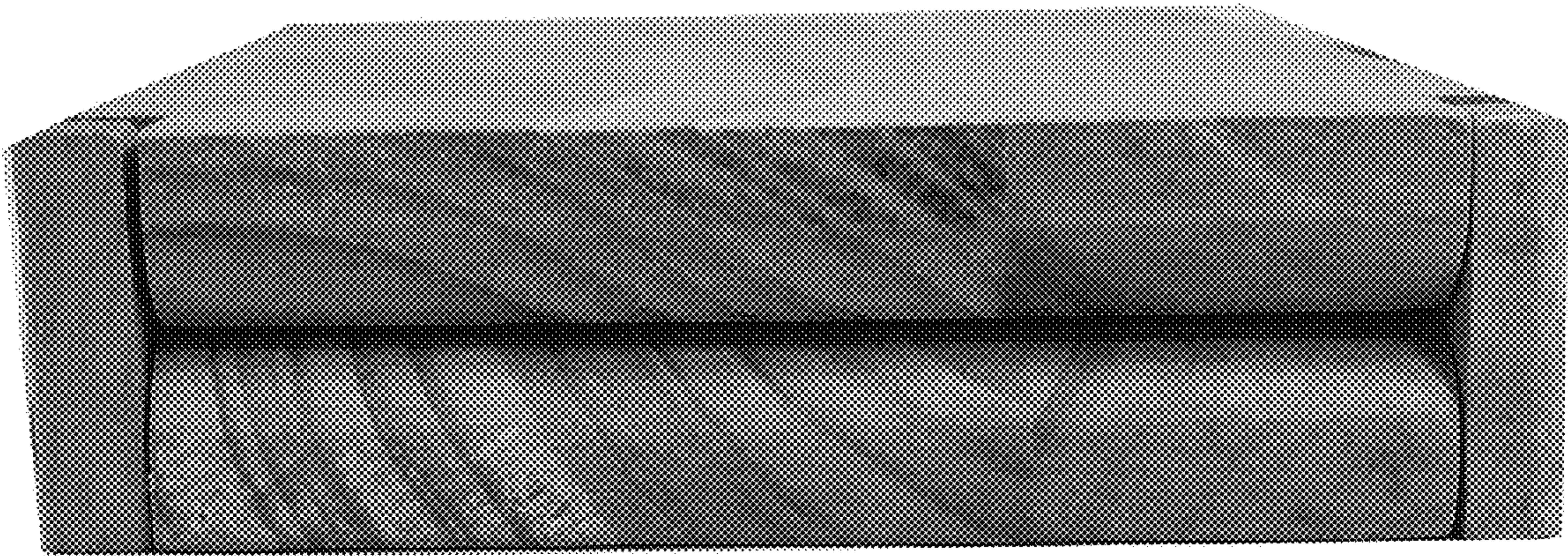
