(57) **CLAIM**

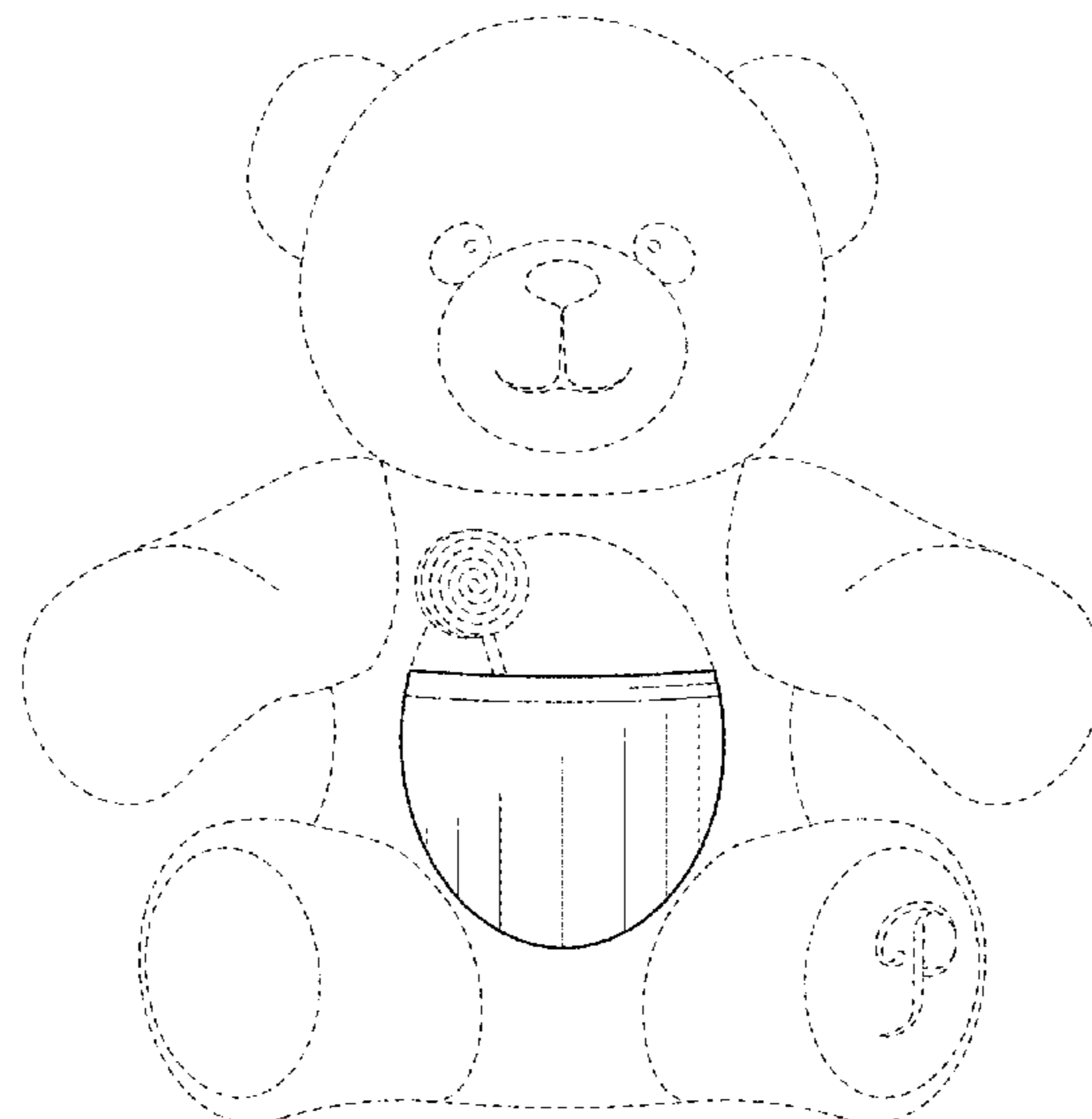
The ornamental design for a pocket for toy, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a pocket for toy showing the claimed design;
 FIG. 2 is a back view thereof;

 FIG. 4 is a bottom view thereof;
 FIG. 5 is a left side view thereof;
 FIG. 6 is a right side view thereof;
 FIG. 7 is a top perspective view thereof; and,
 FIG. 8 is a front view thereof holding environmental subject matter.
 The dashed broken lines in the figures show portions of the pocket for toy or environmental subject matter that form no part of the claimed design. The shade lines in the figures show contour and not surface ornamentation.

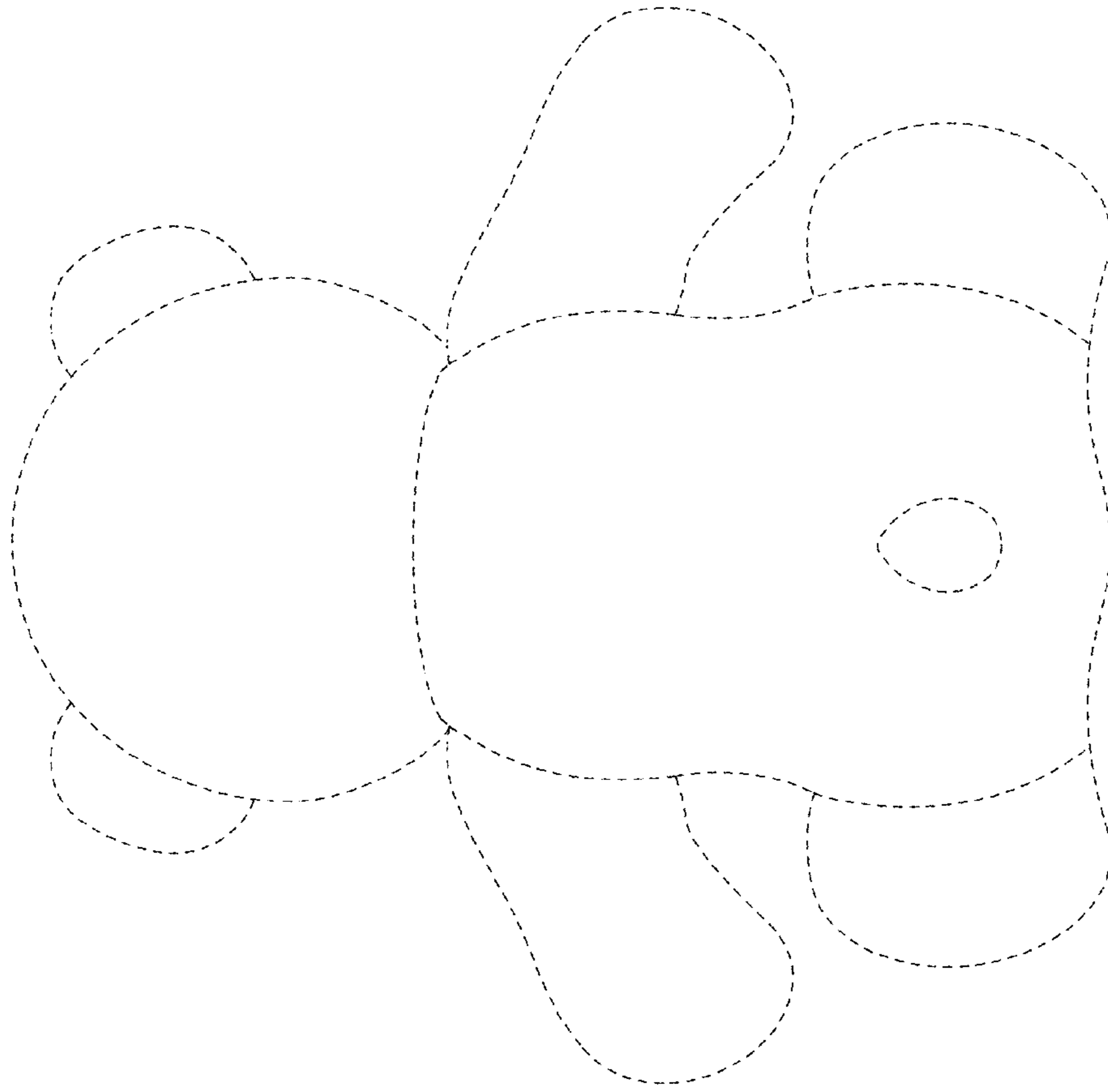

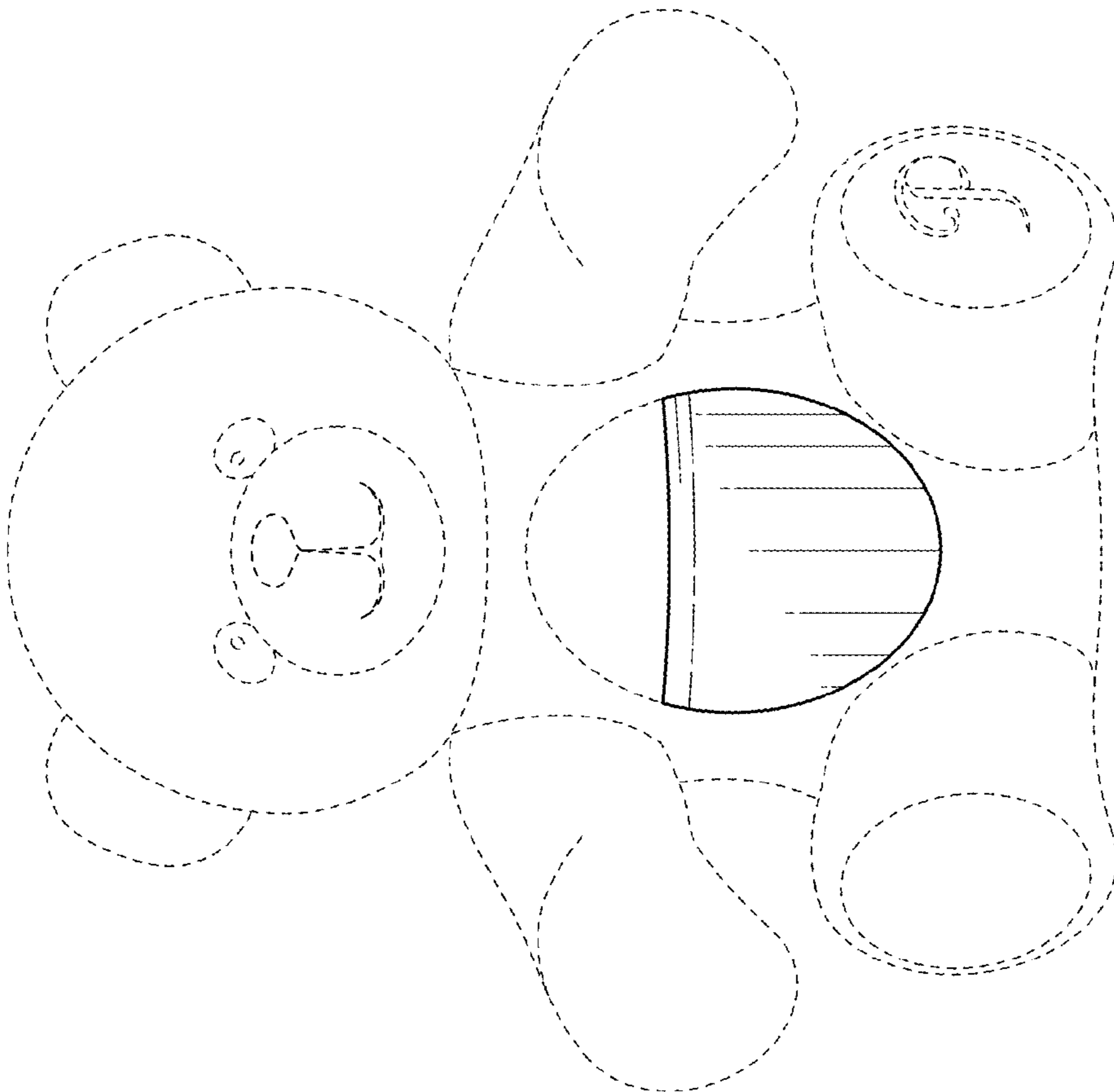

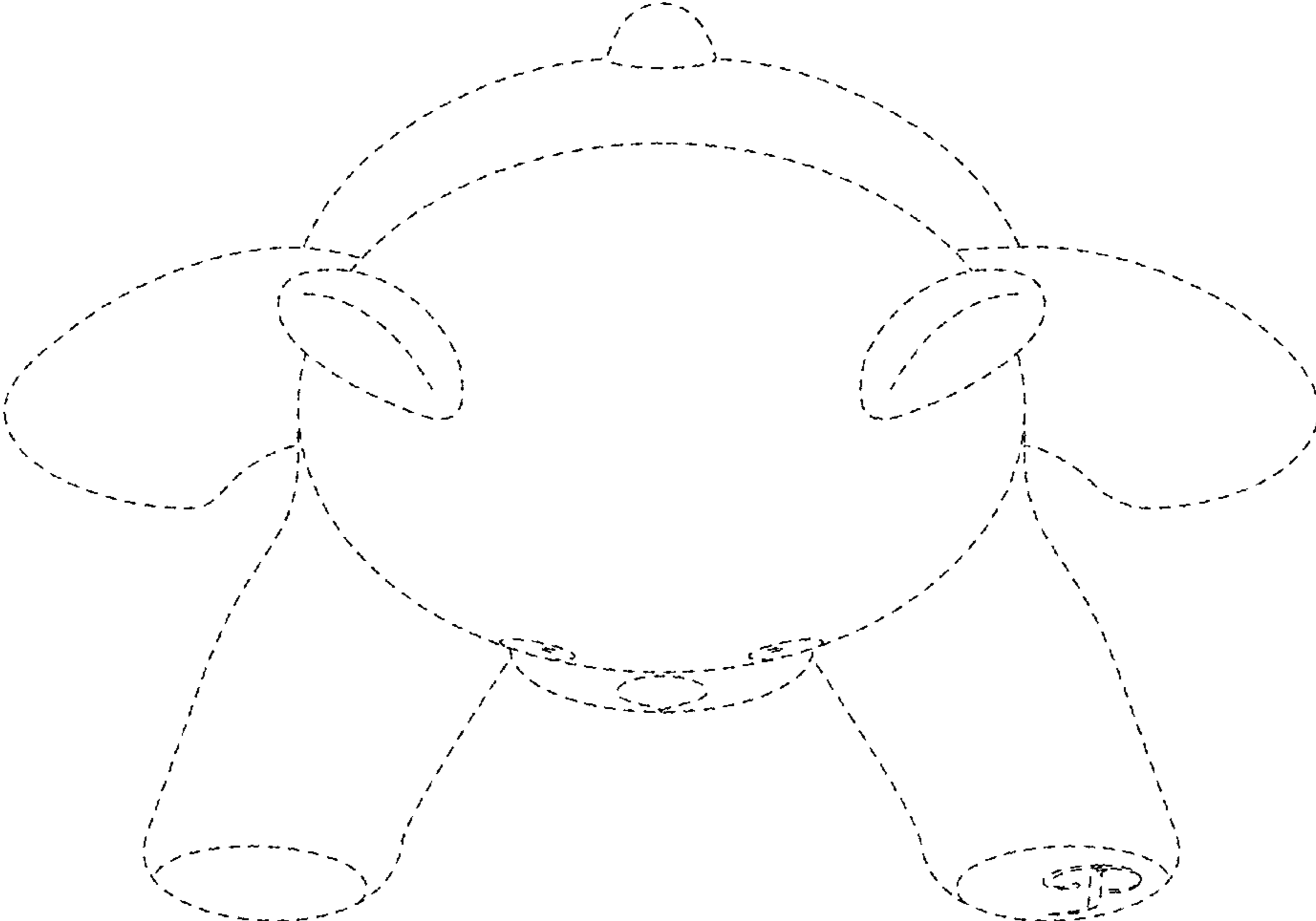

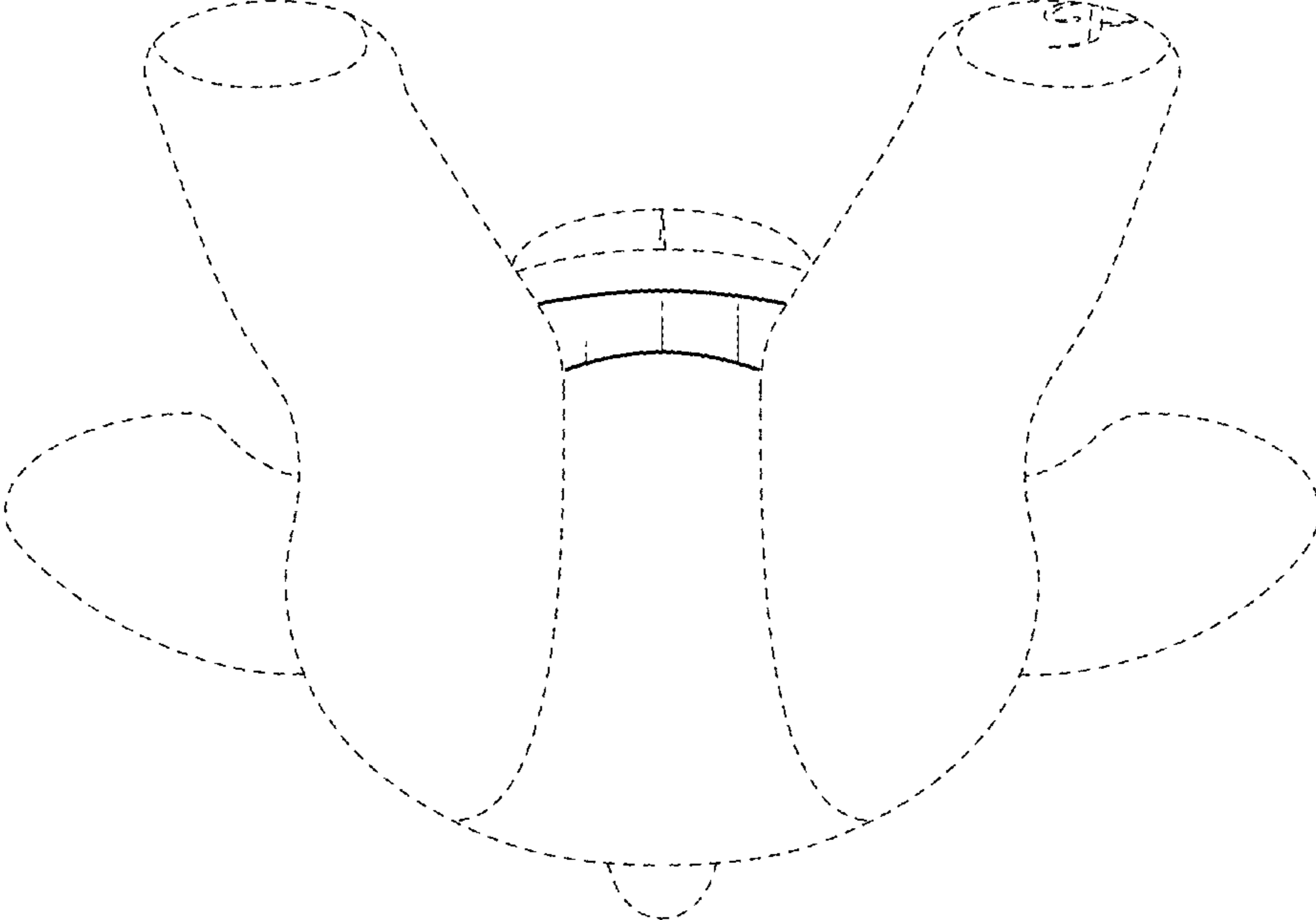

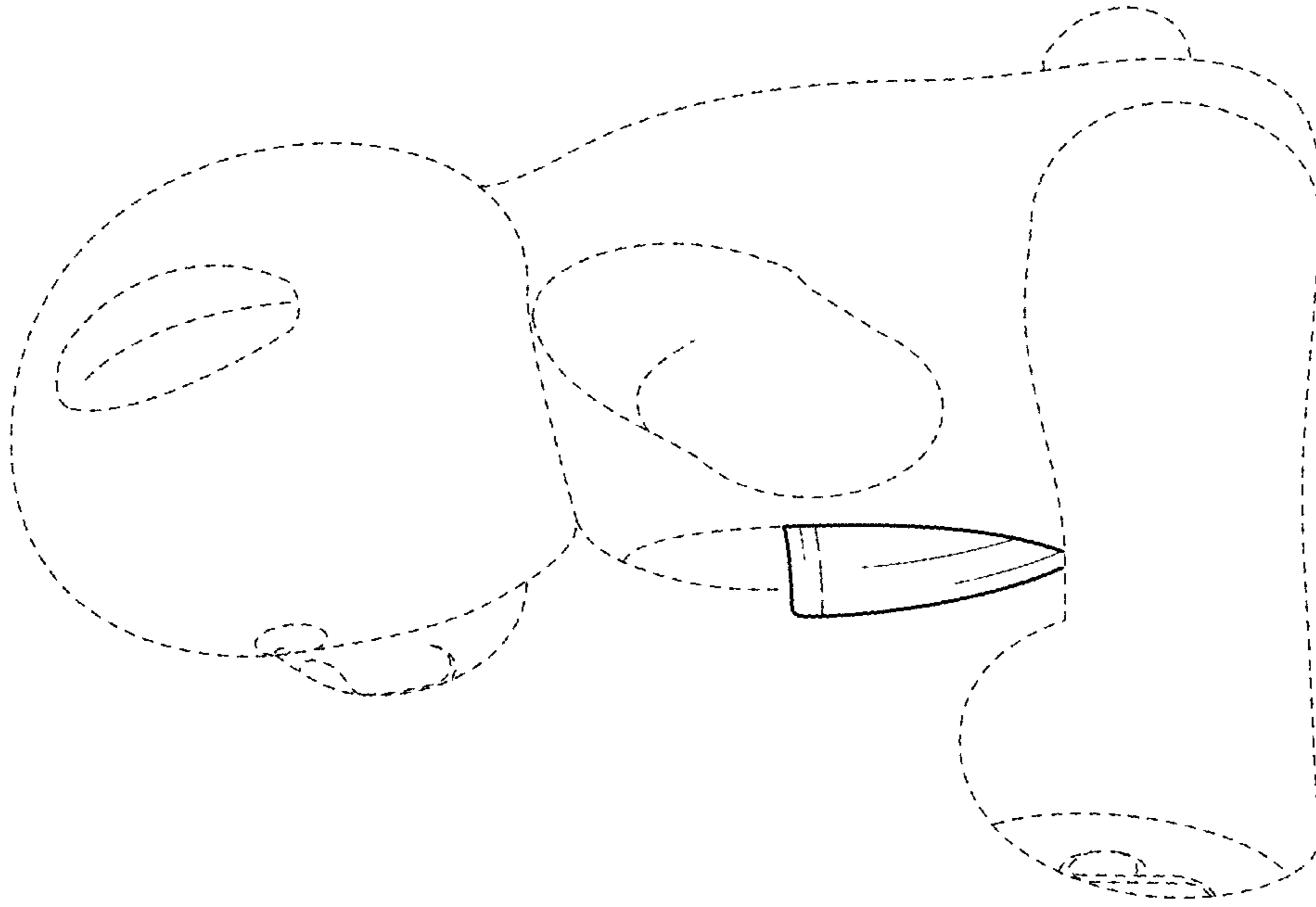

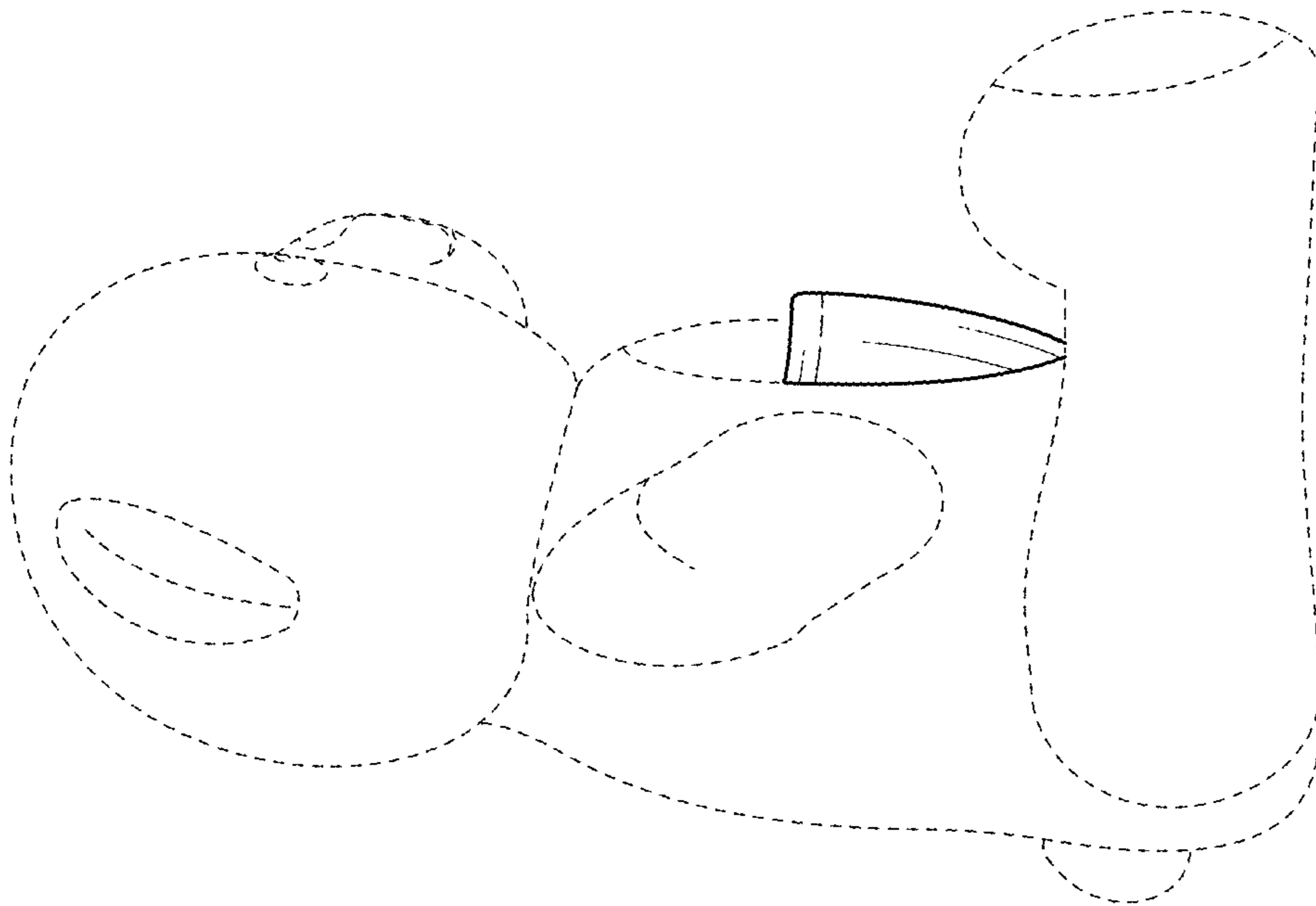

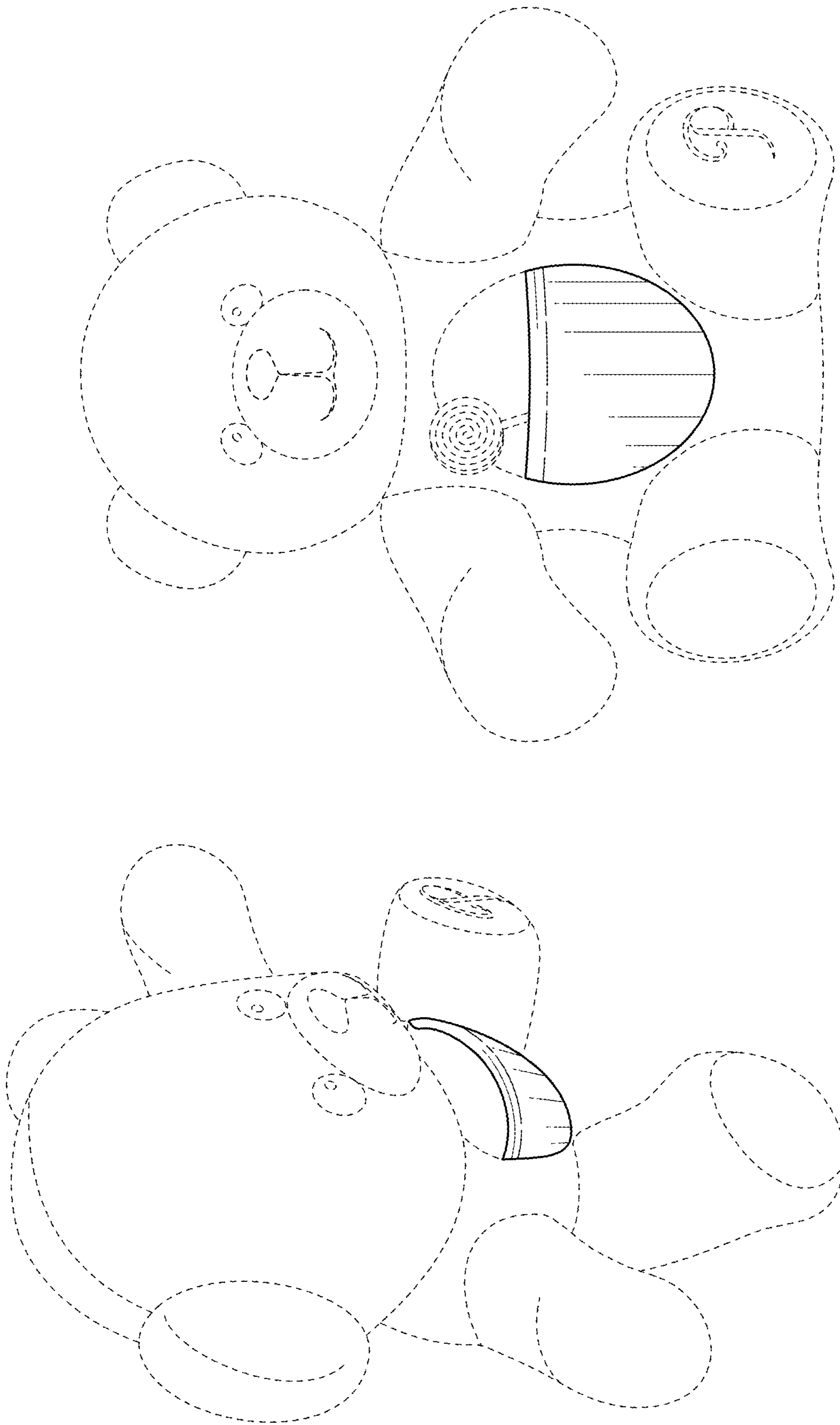
