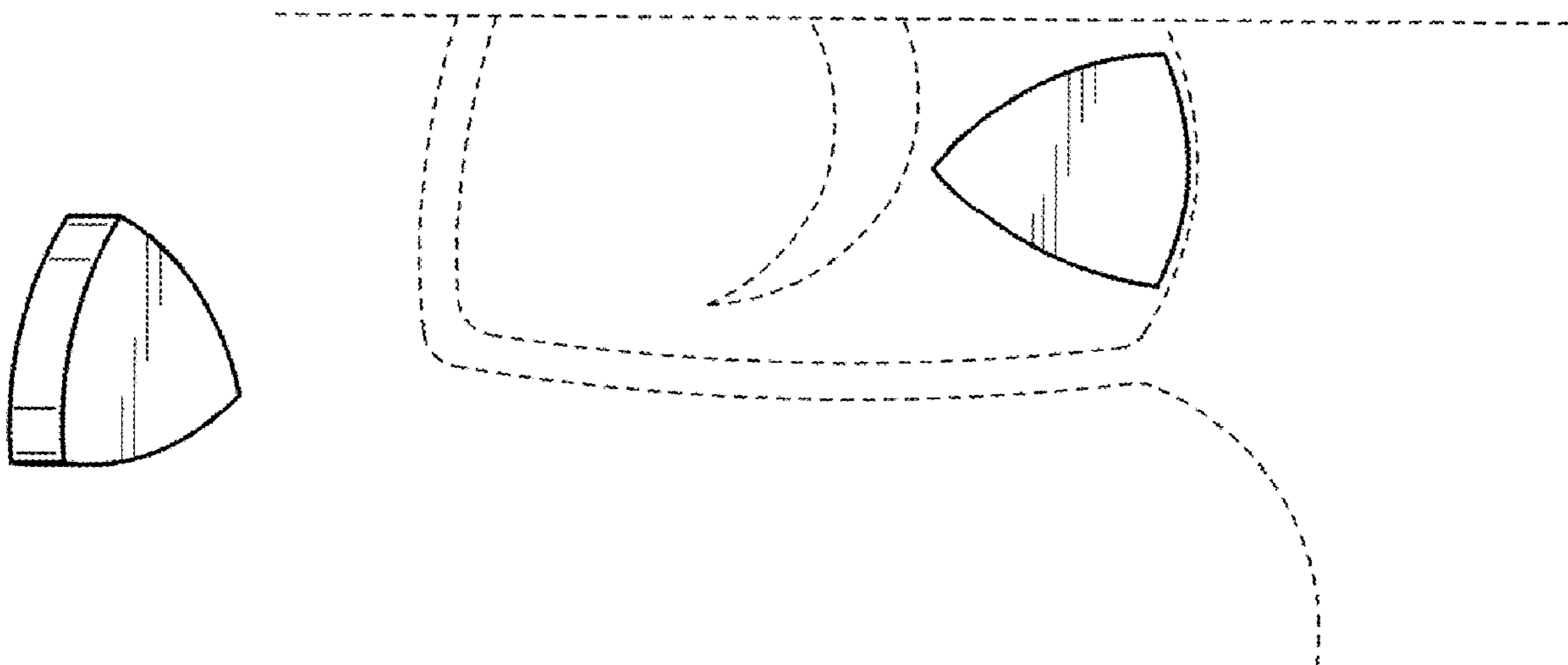

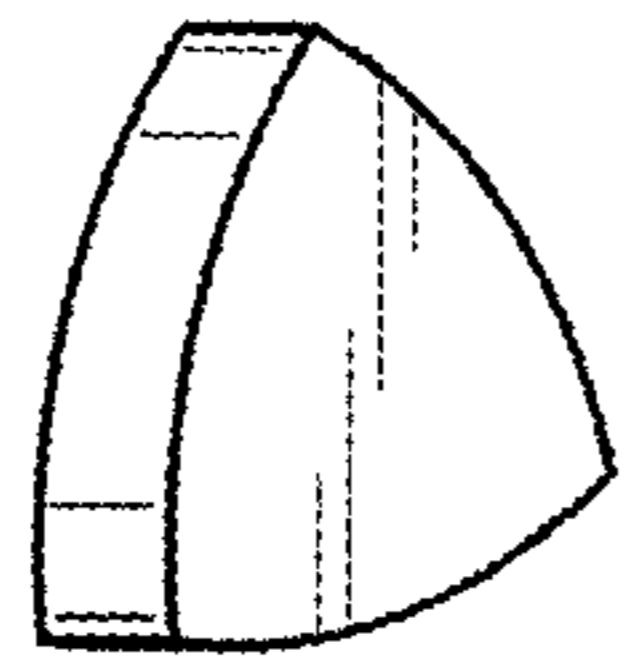
The ornamental design for an ovate trigger dampening absorber, as shown and described.

**DESCRIPTION**

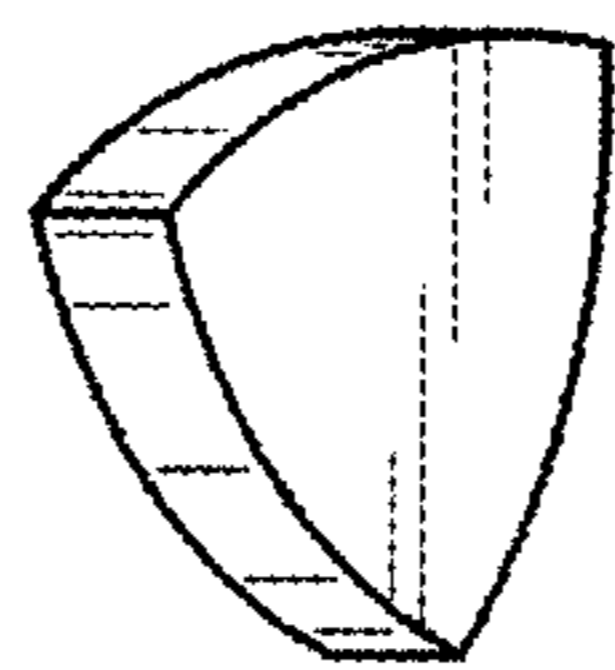
FIG. 1 is a perspective view of an ovate trigger dampening absorber showing our new design;

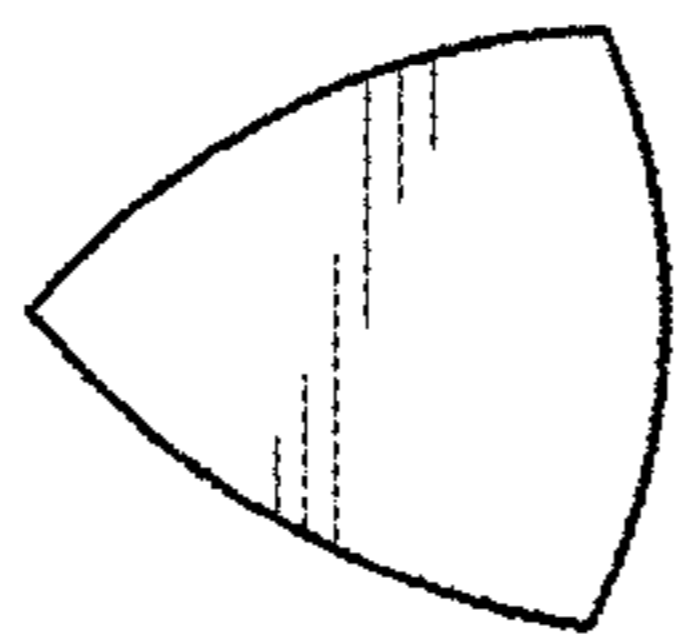

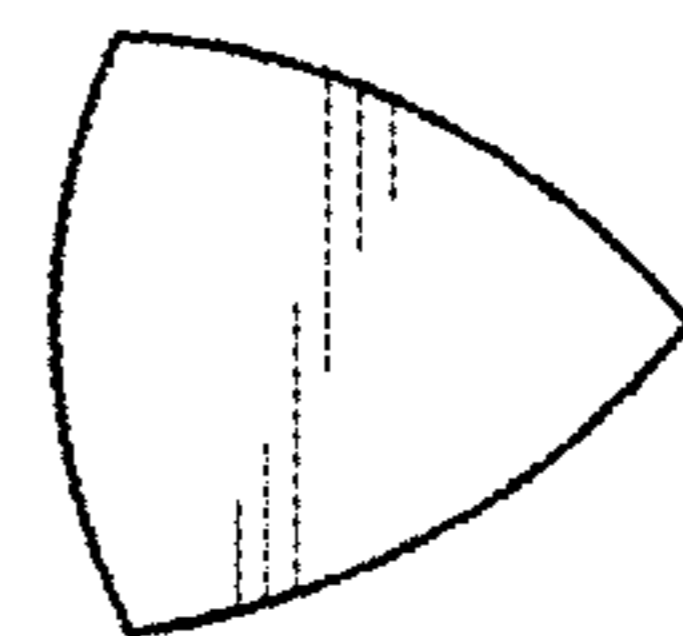

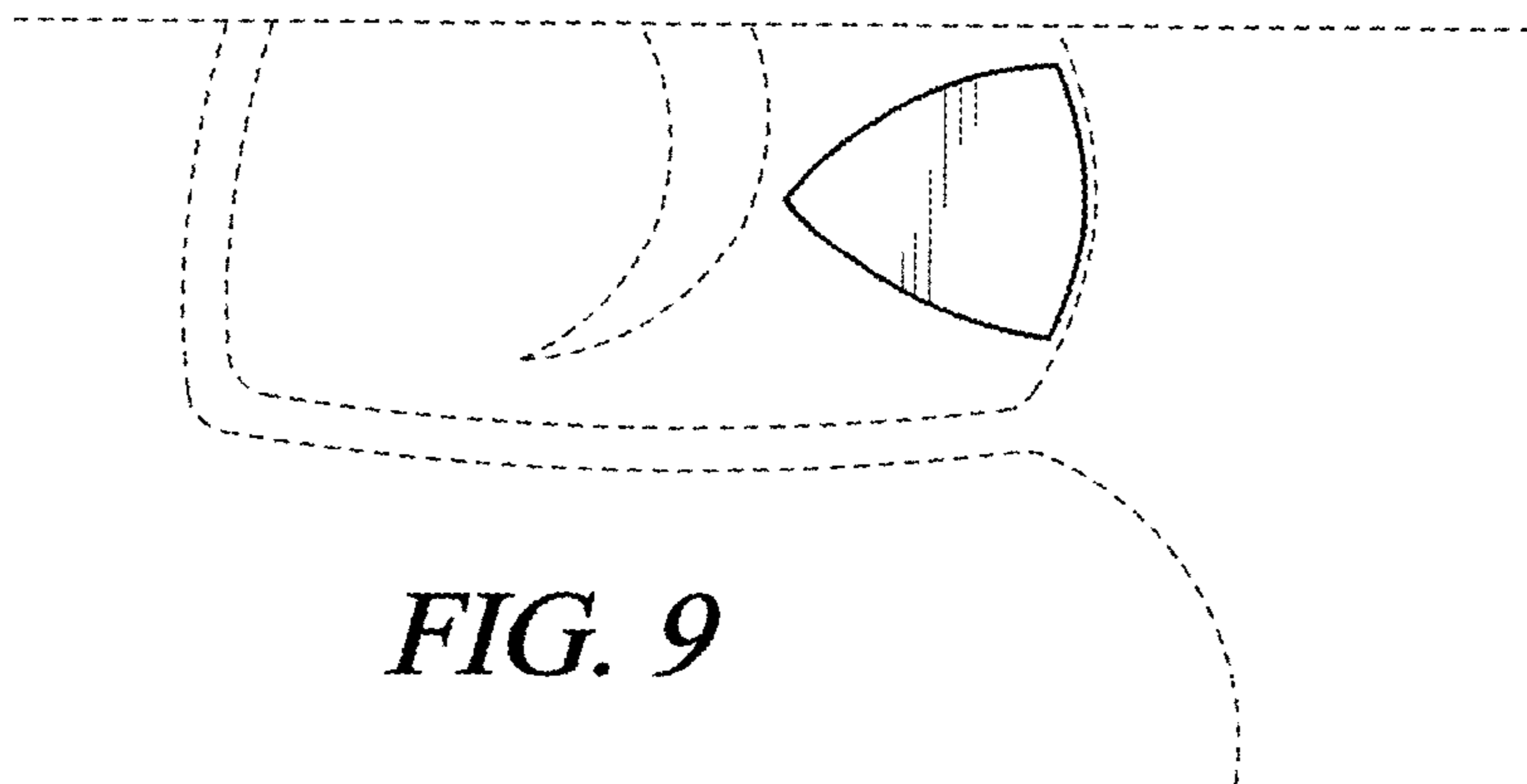
