DESCRIPTION

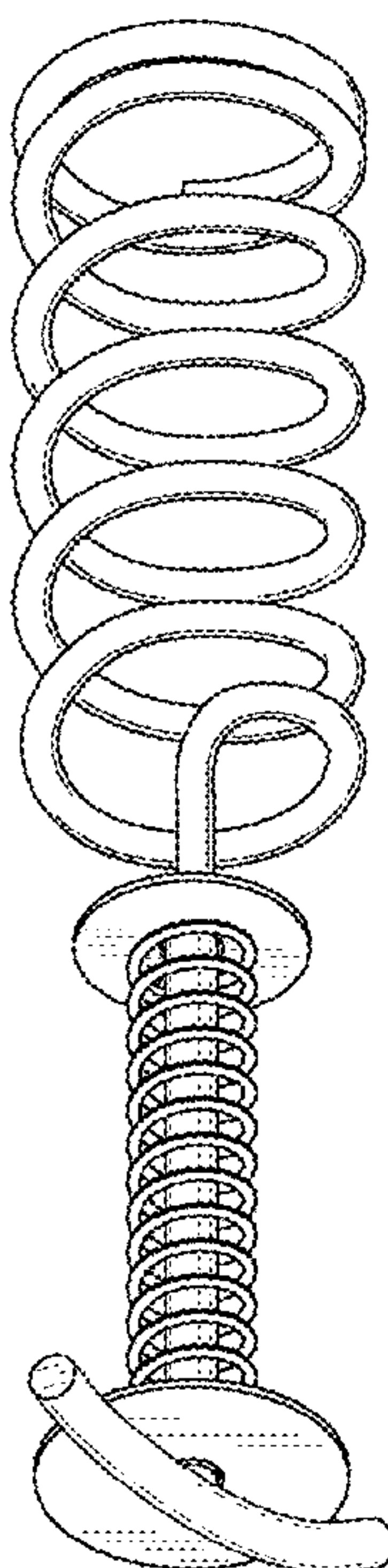

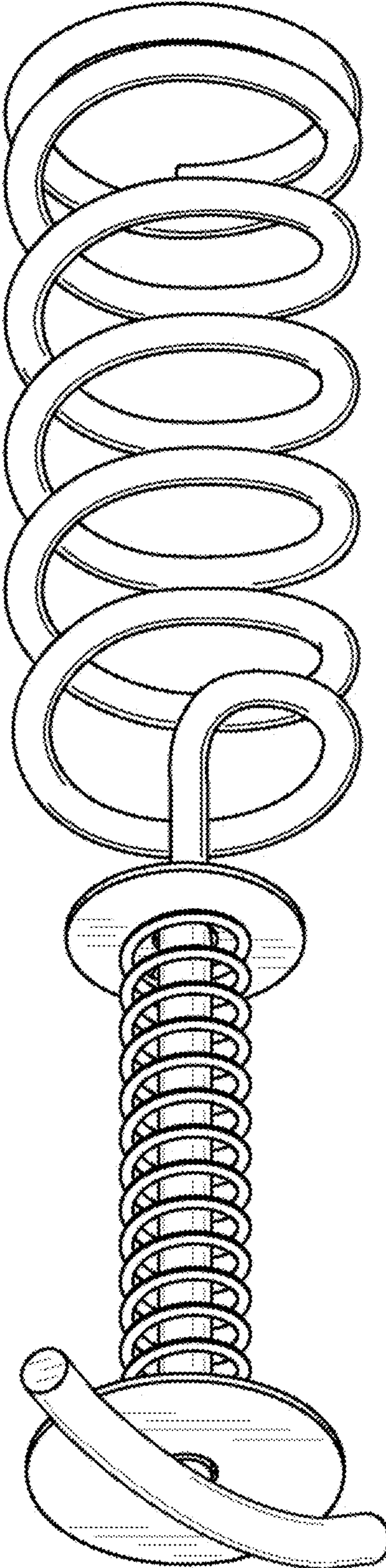

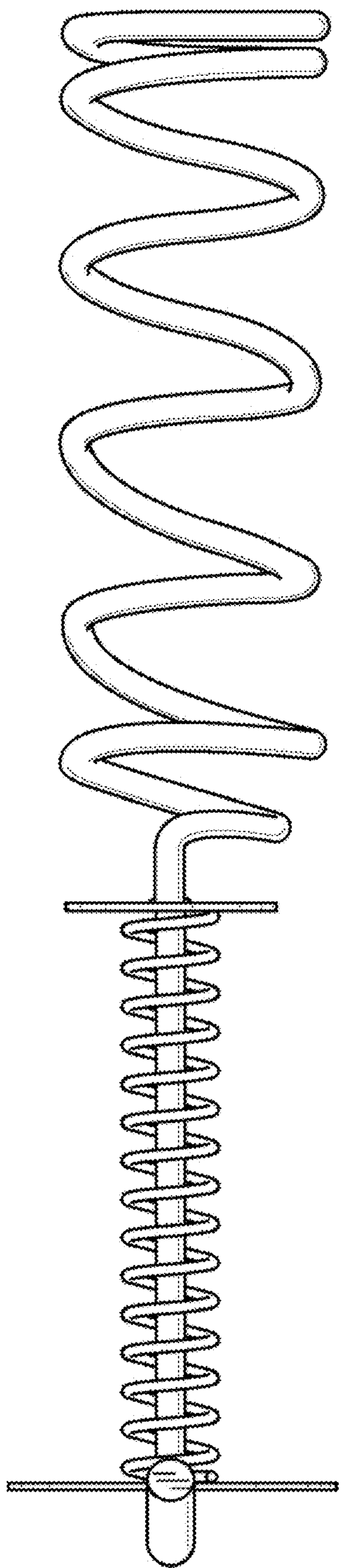

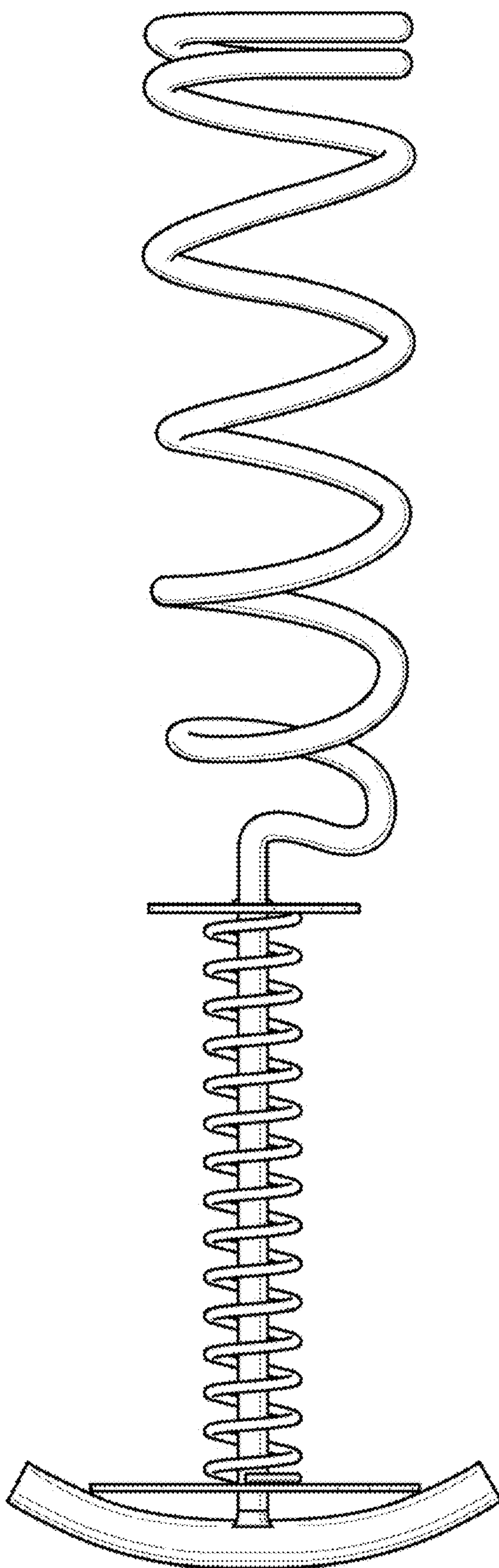

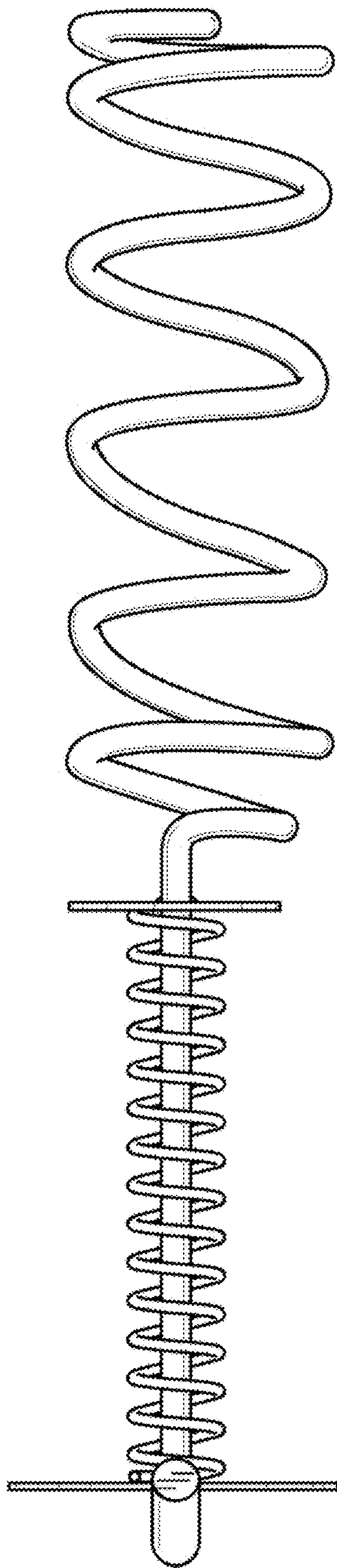

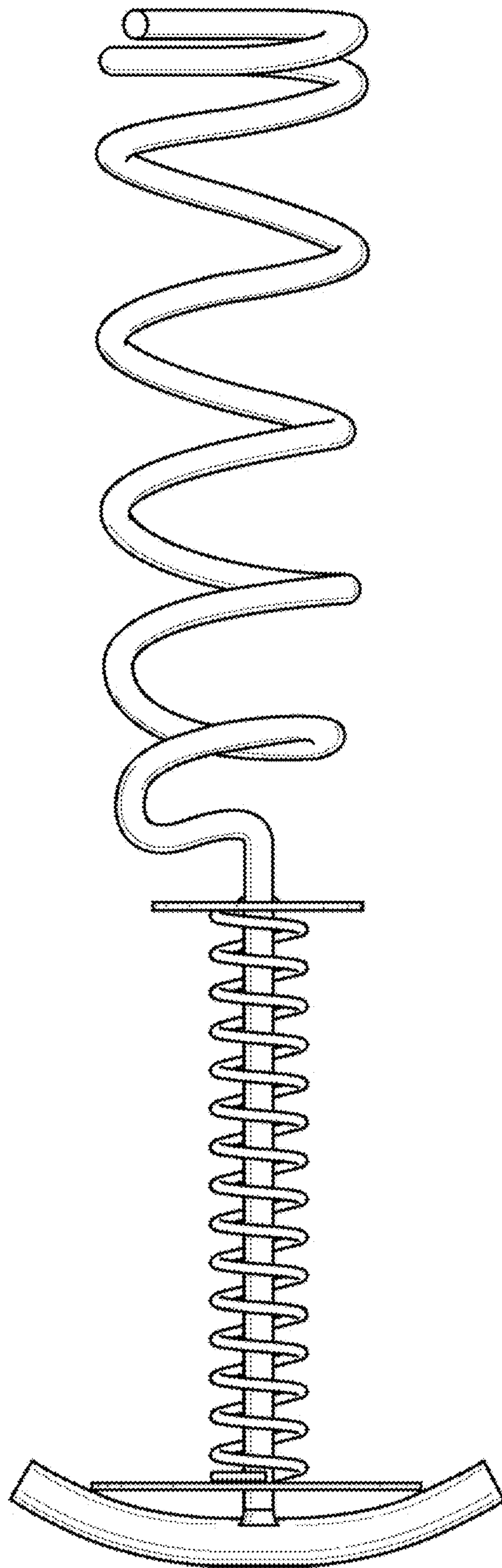

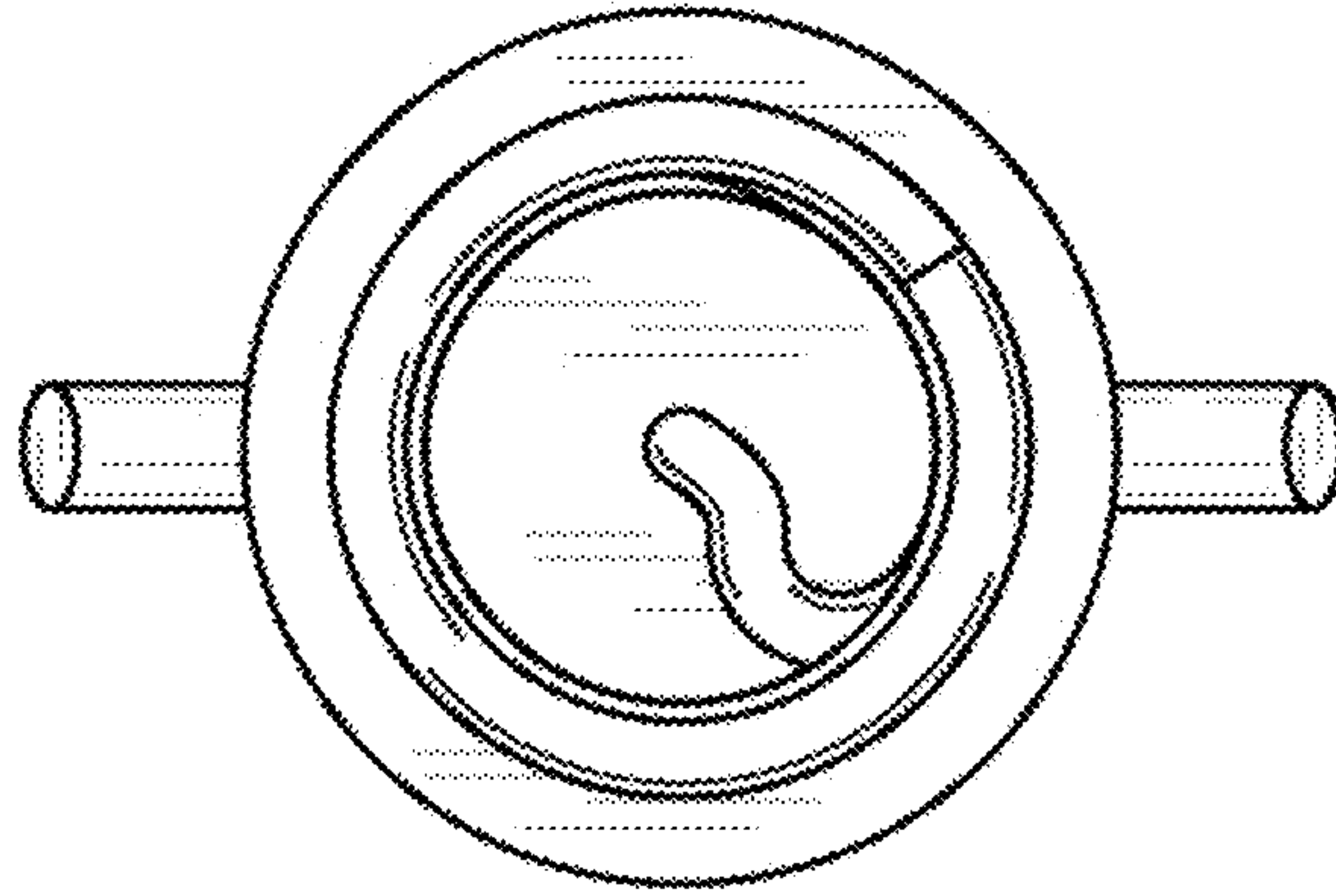

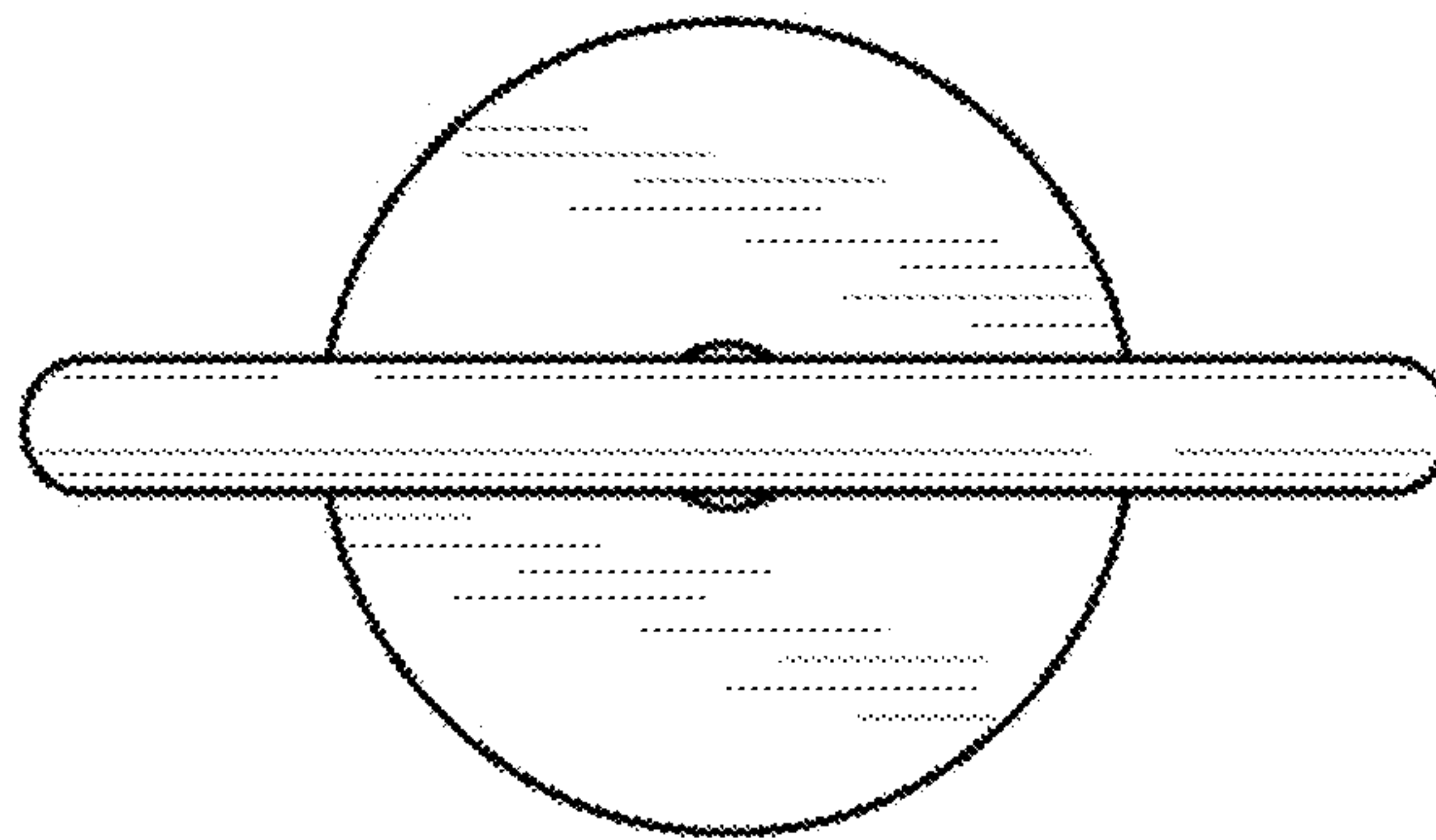

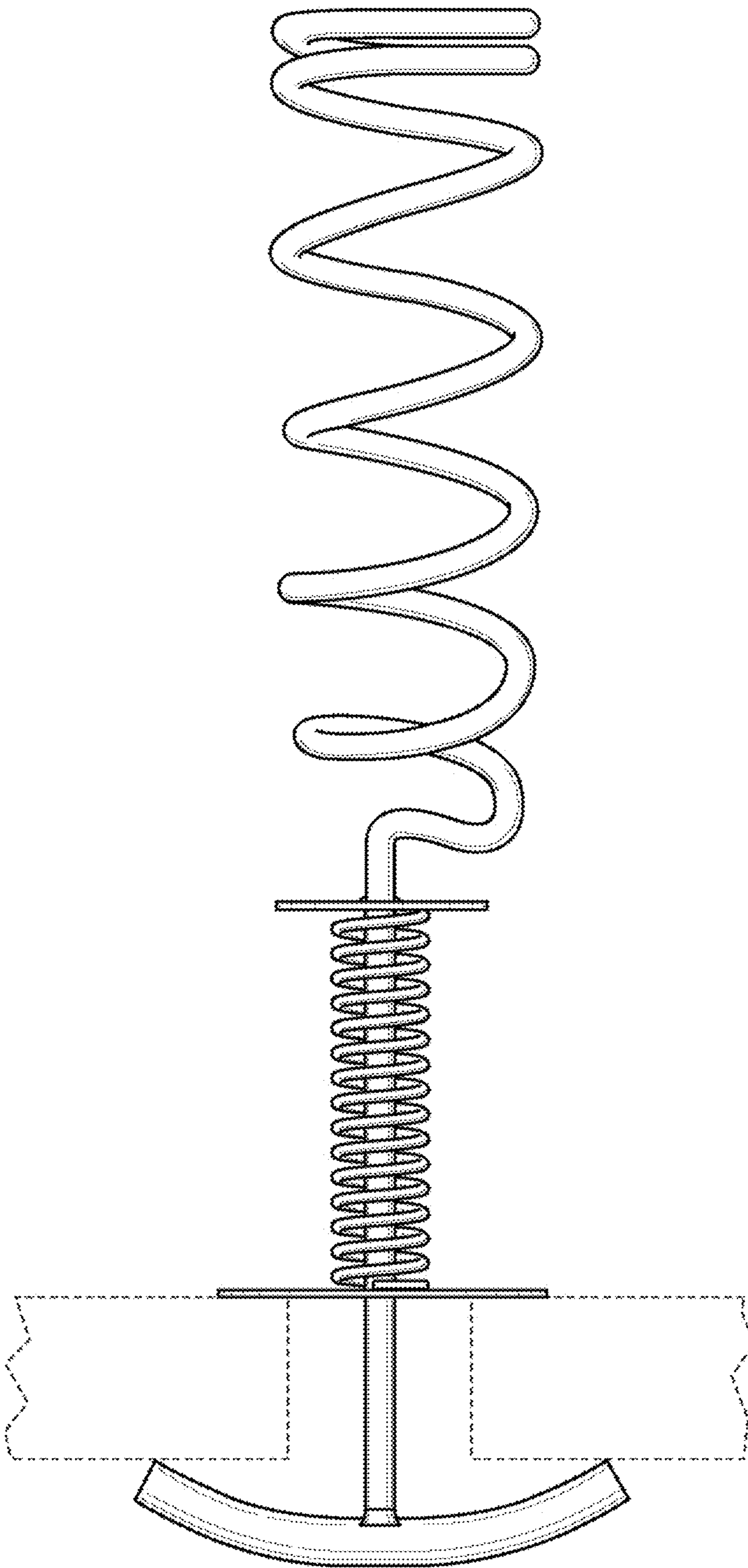

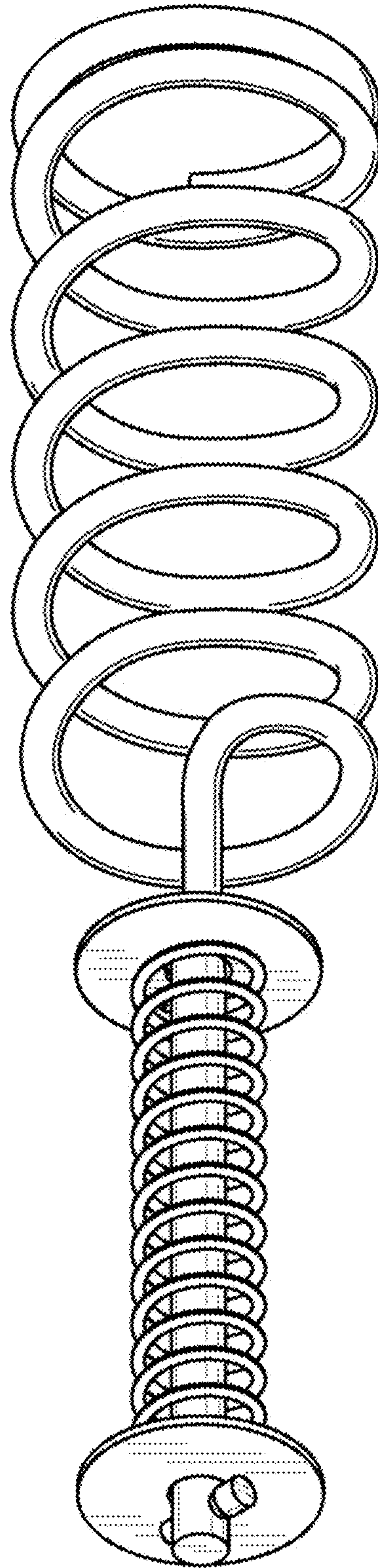

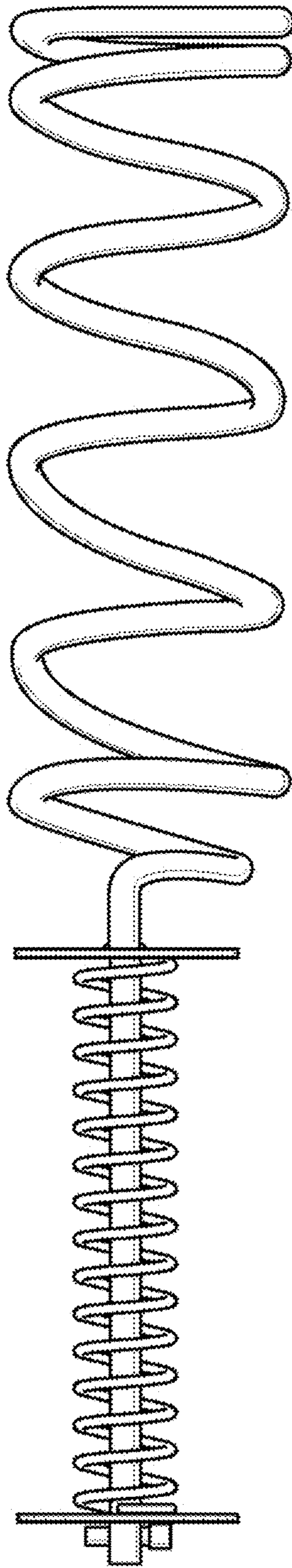

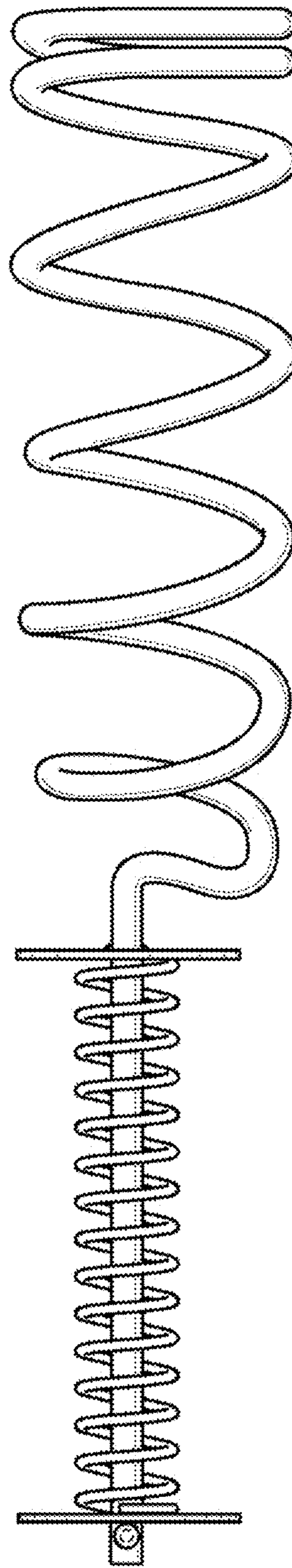

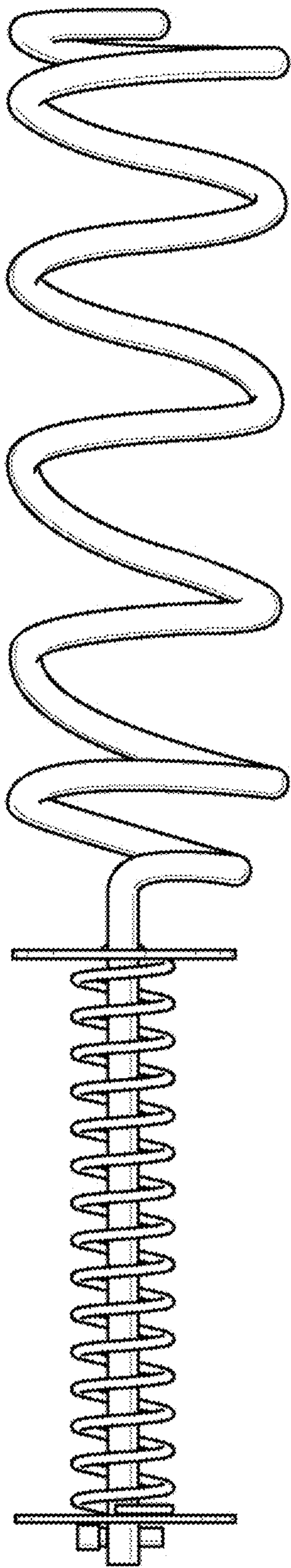

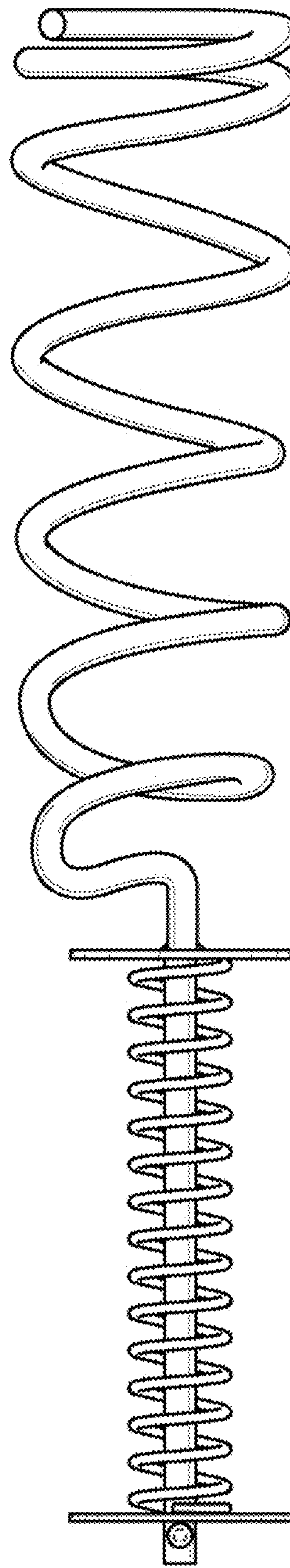

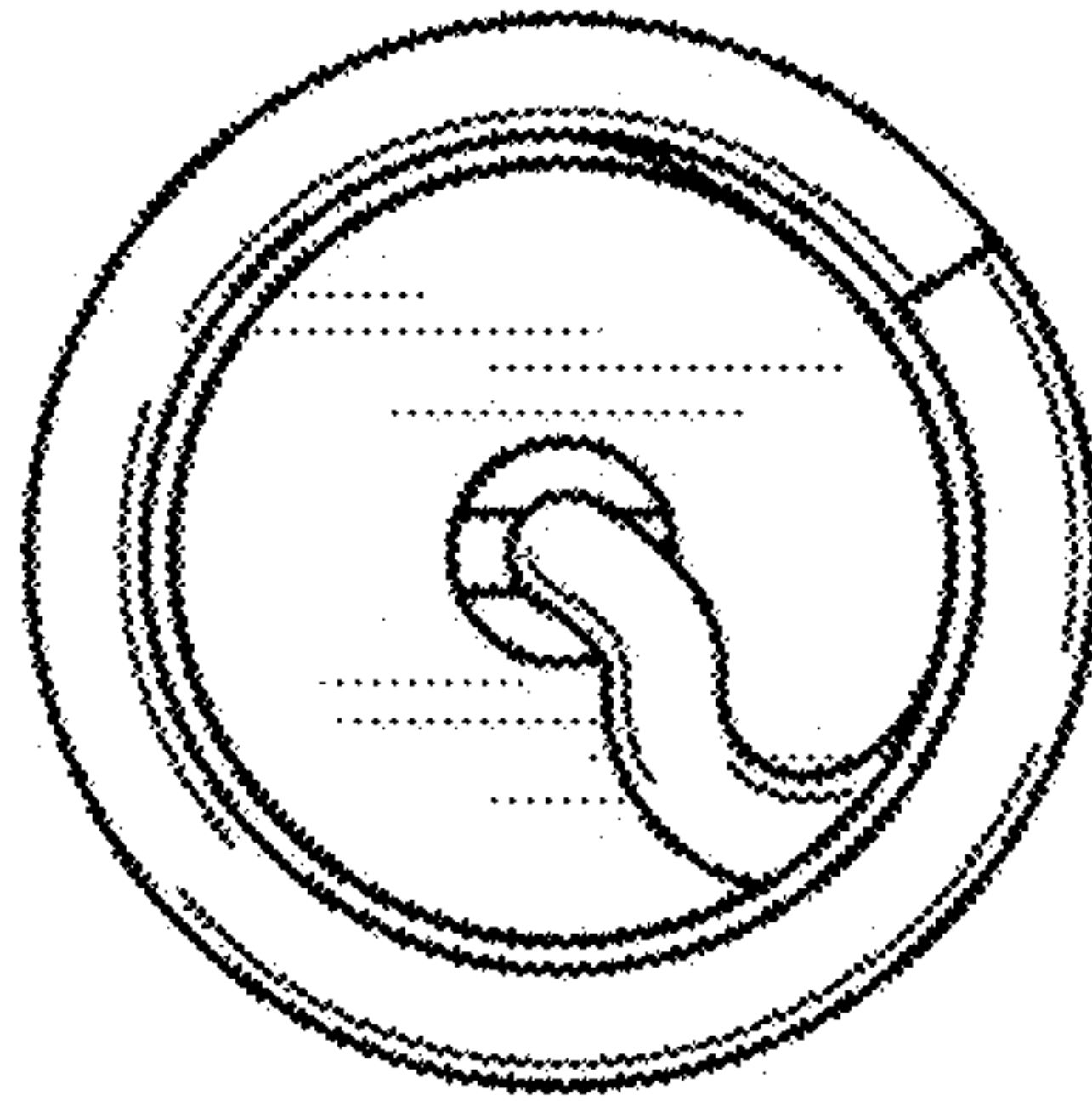

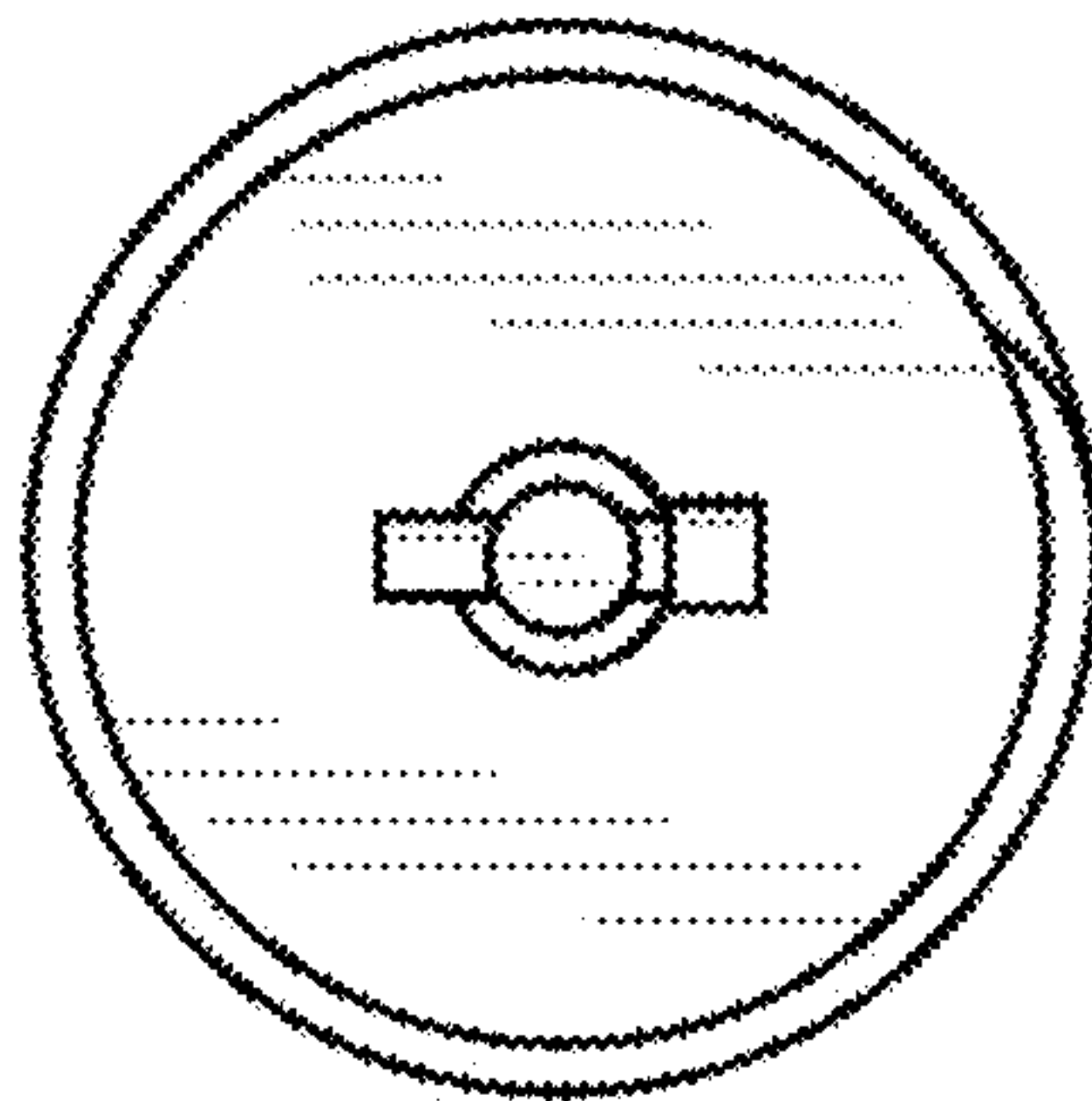

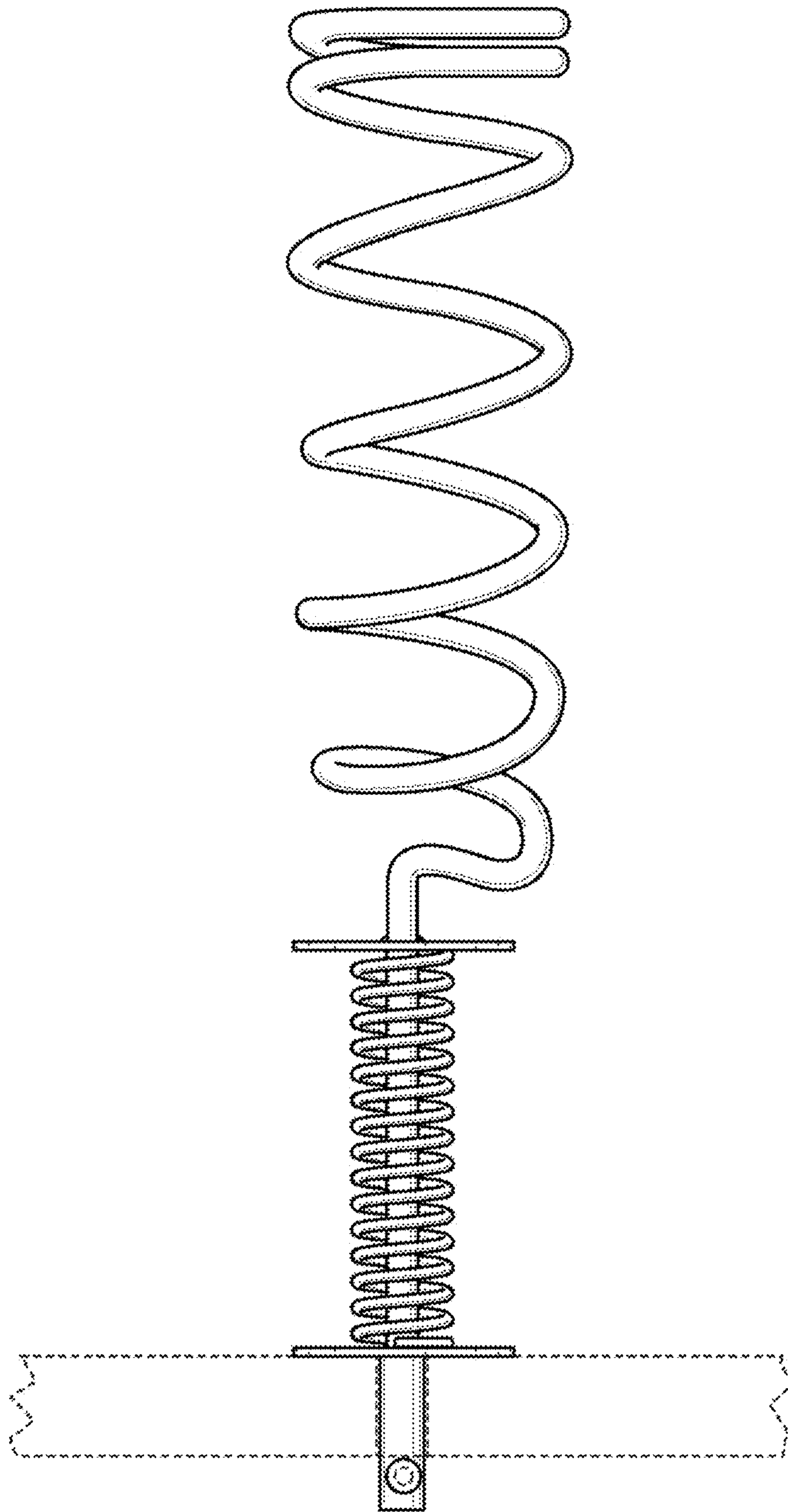
