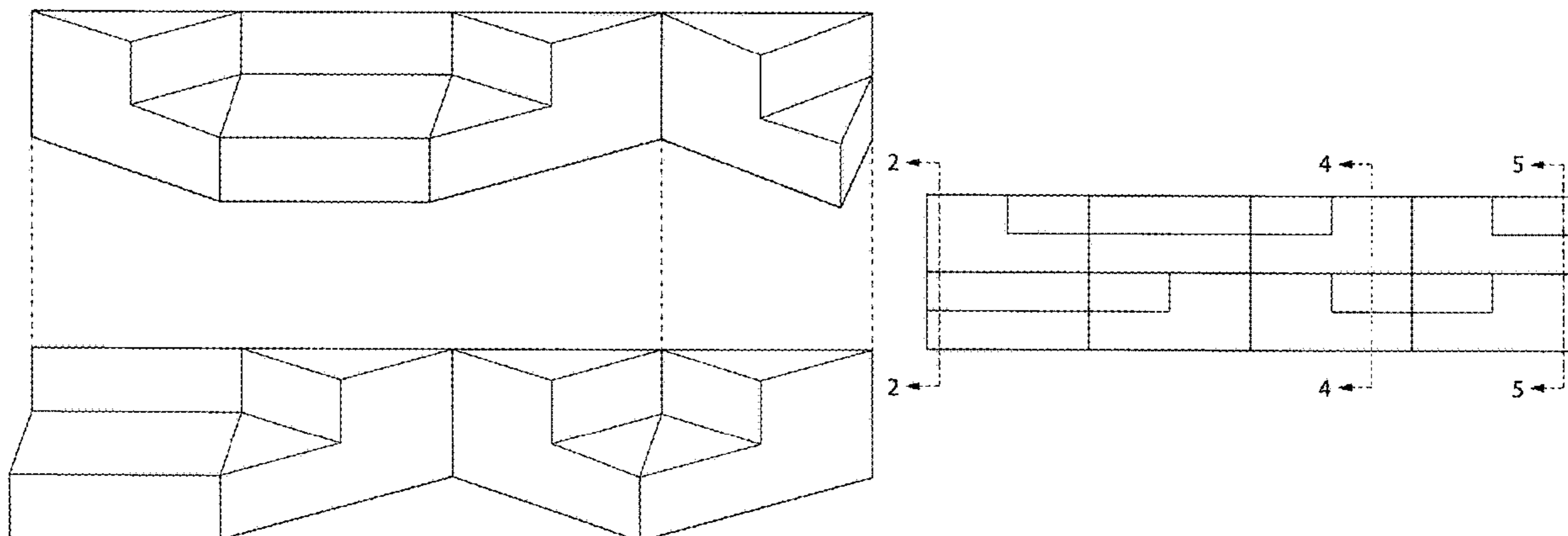
(57) **CLAIM**

The ornamental design for an architectural wall cladding, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged exploded isometric view of an architectural wall cladding showing my new design;
FIG. 2 is a cross-sectional view taken along line 2-2 in FIG. 3;
FIG. 3 is a front view of the design shown in FIG. 1;
FIG. 4 is a cross-sectional view taken along line 4-4 in FIG. 3; and,
FIG. 5 is a cross-sectional view taken along line 5-5 in FIG. 3.
The rear side of each embodiment of the architectural wall cladding is unornamented and is hidden from view.

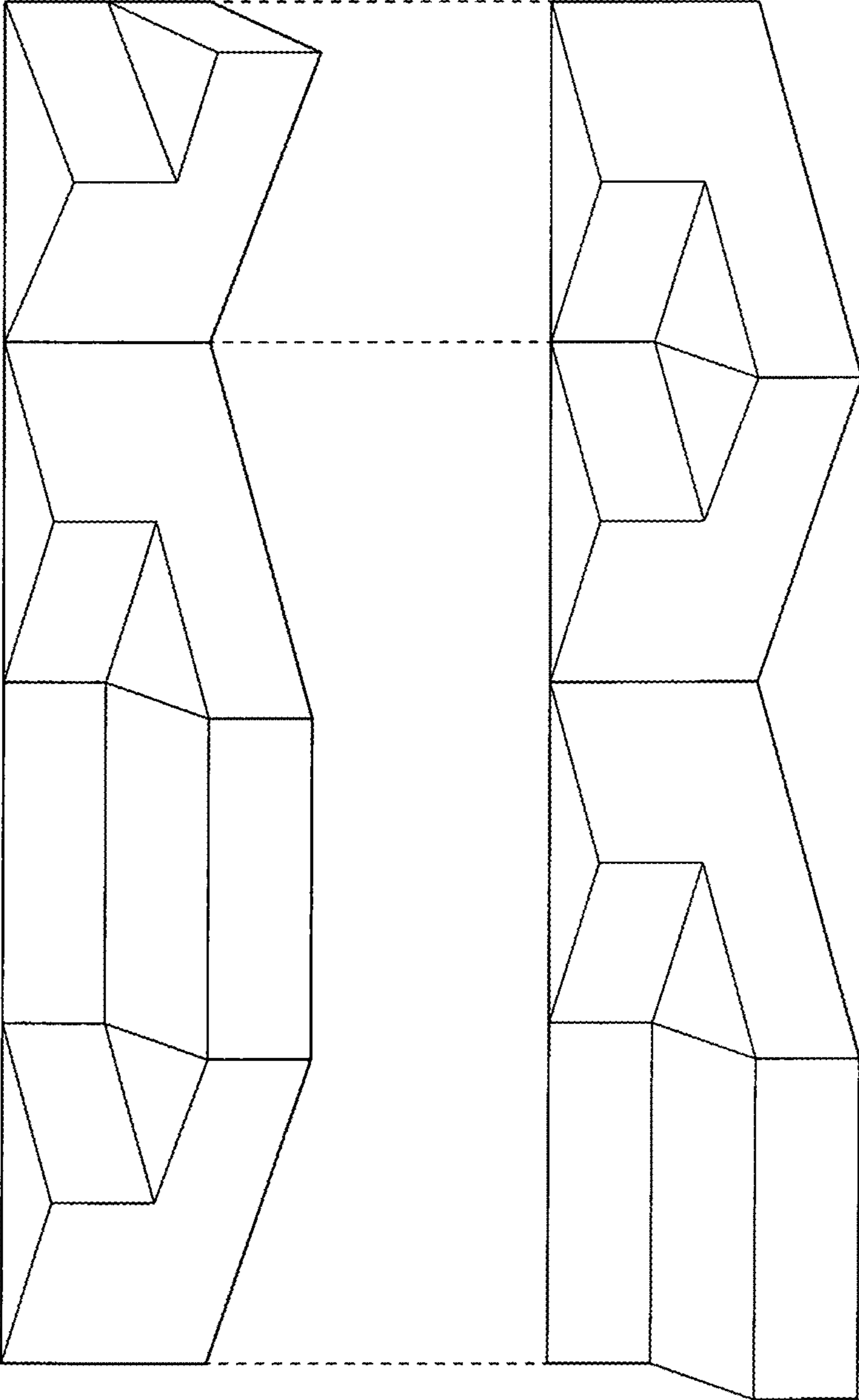

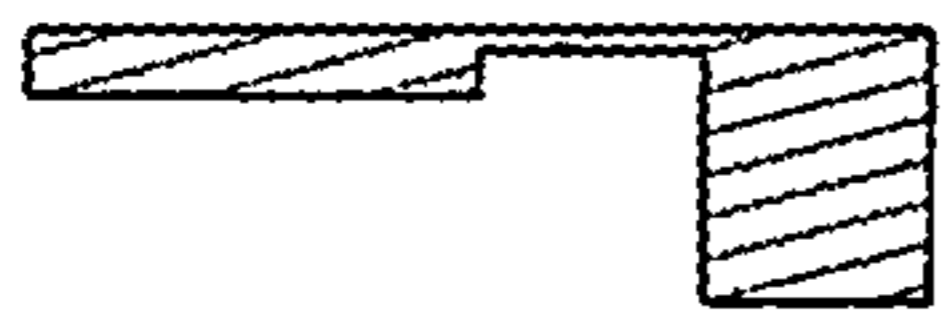

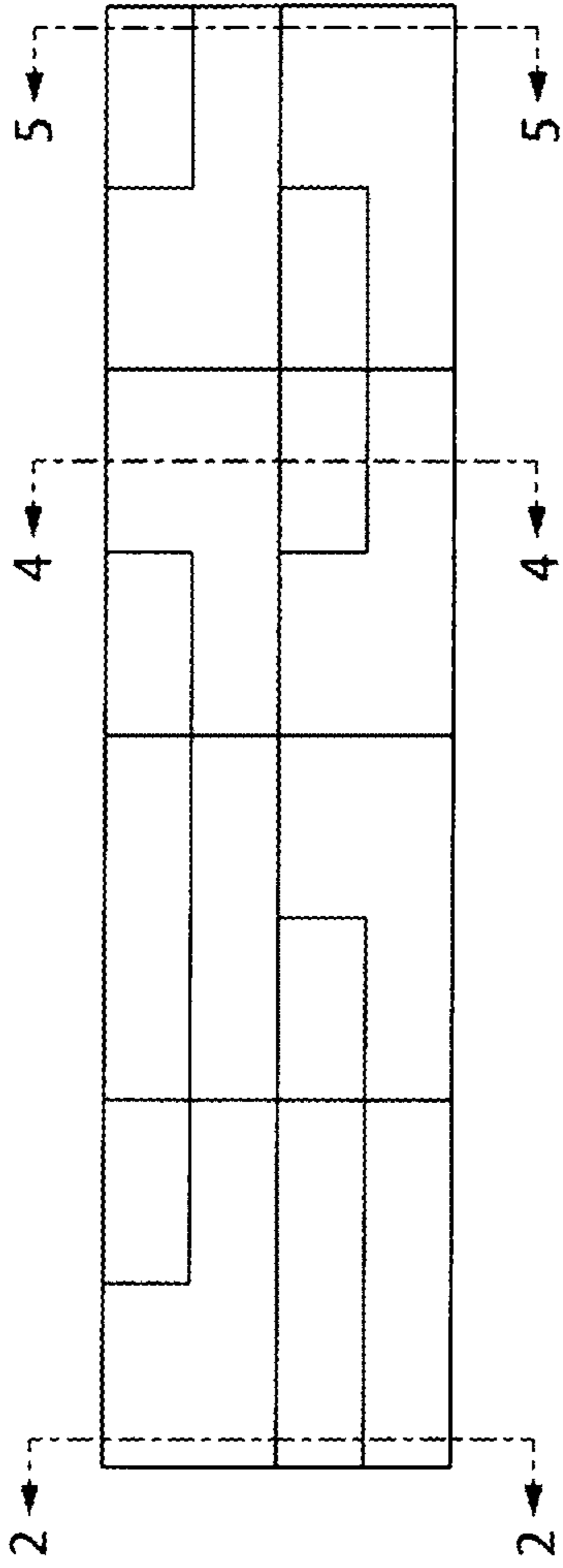
