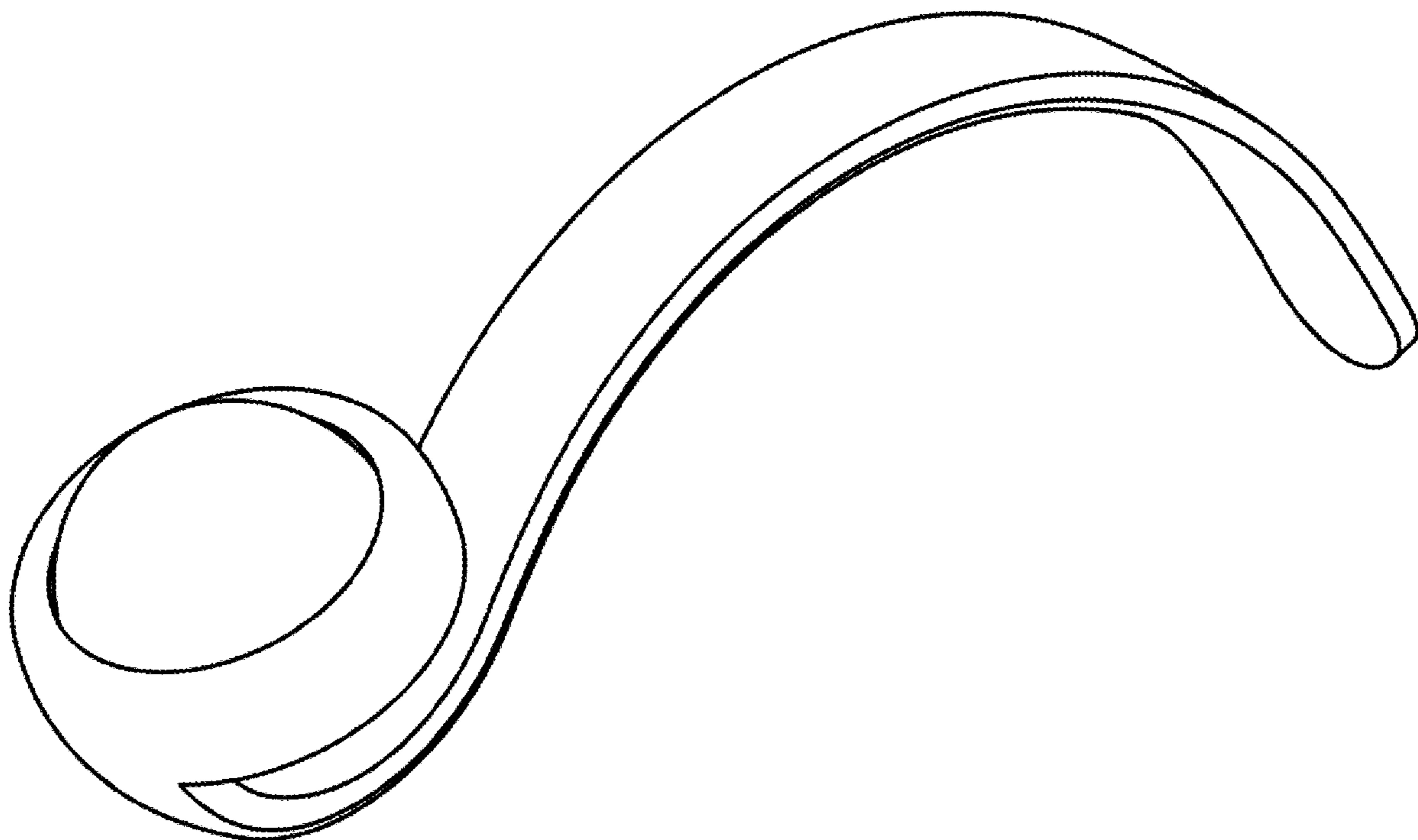
DESCRIPTION

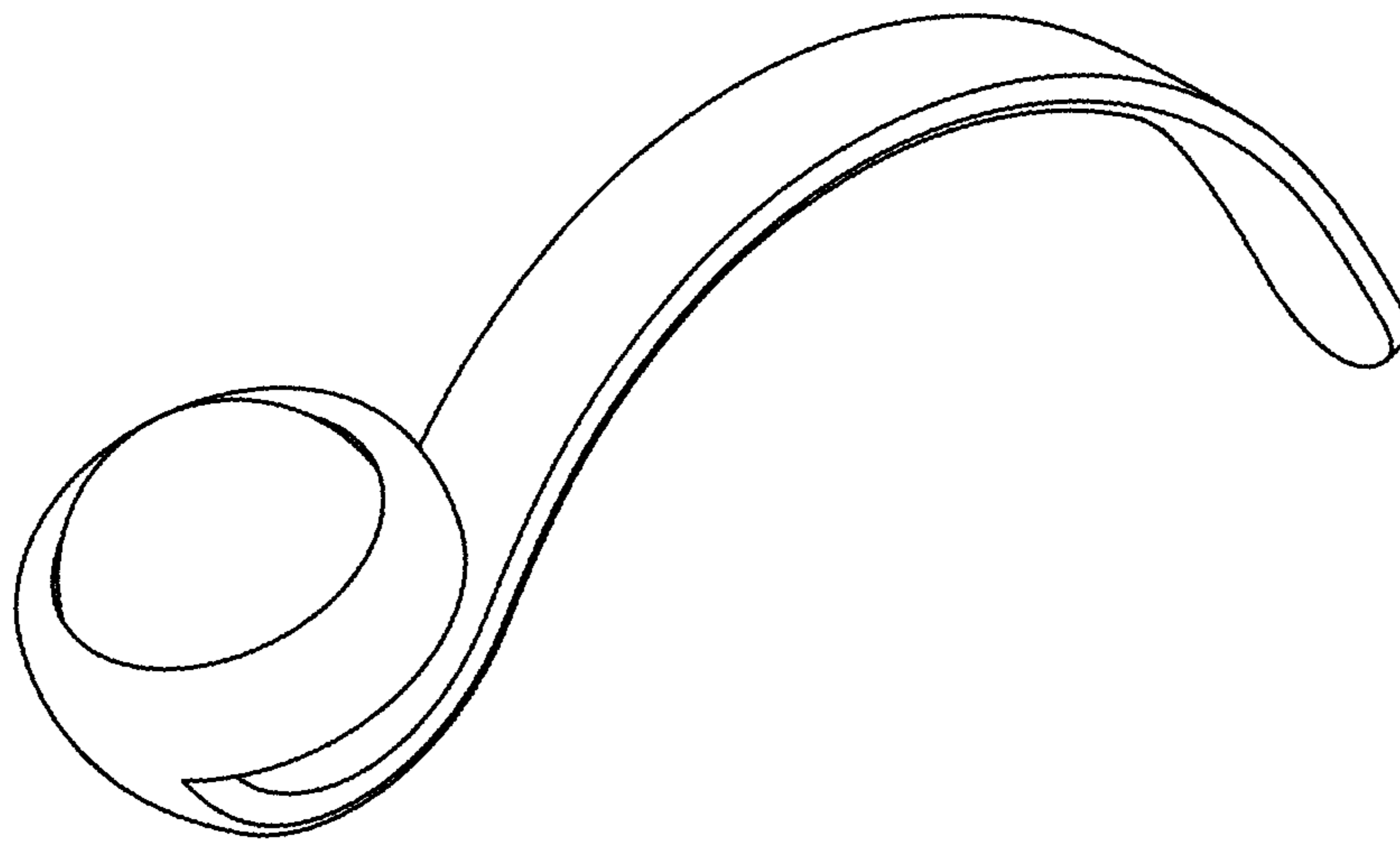

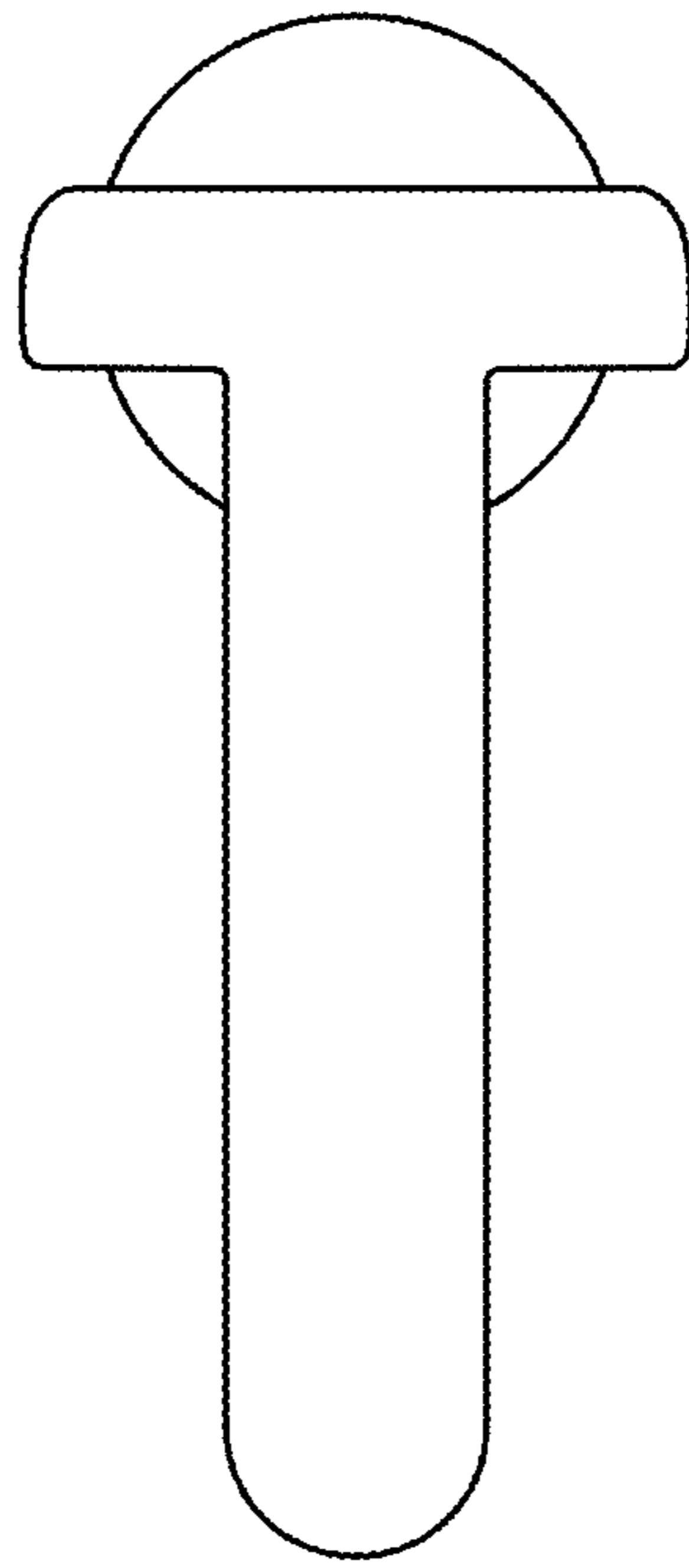

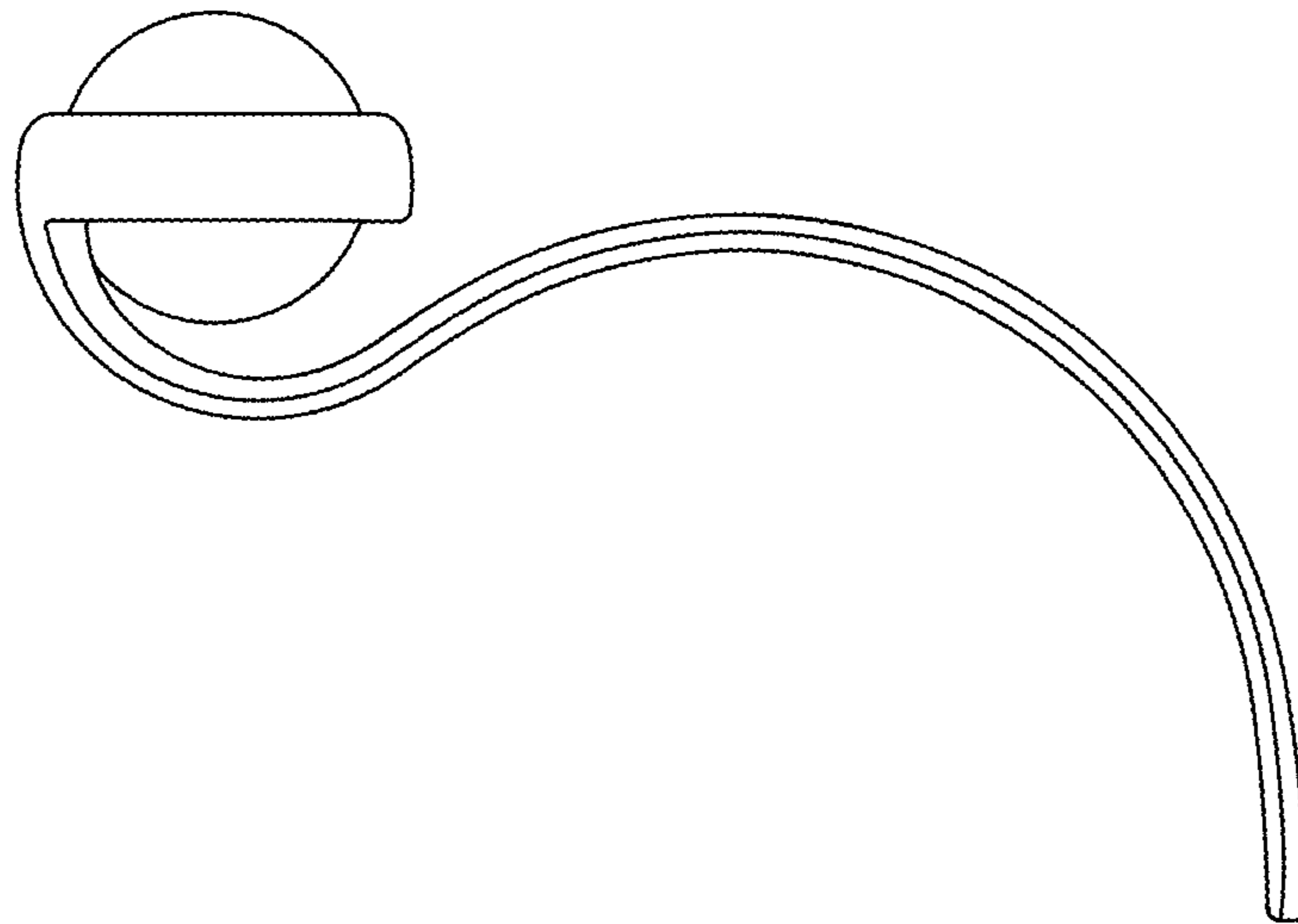

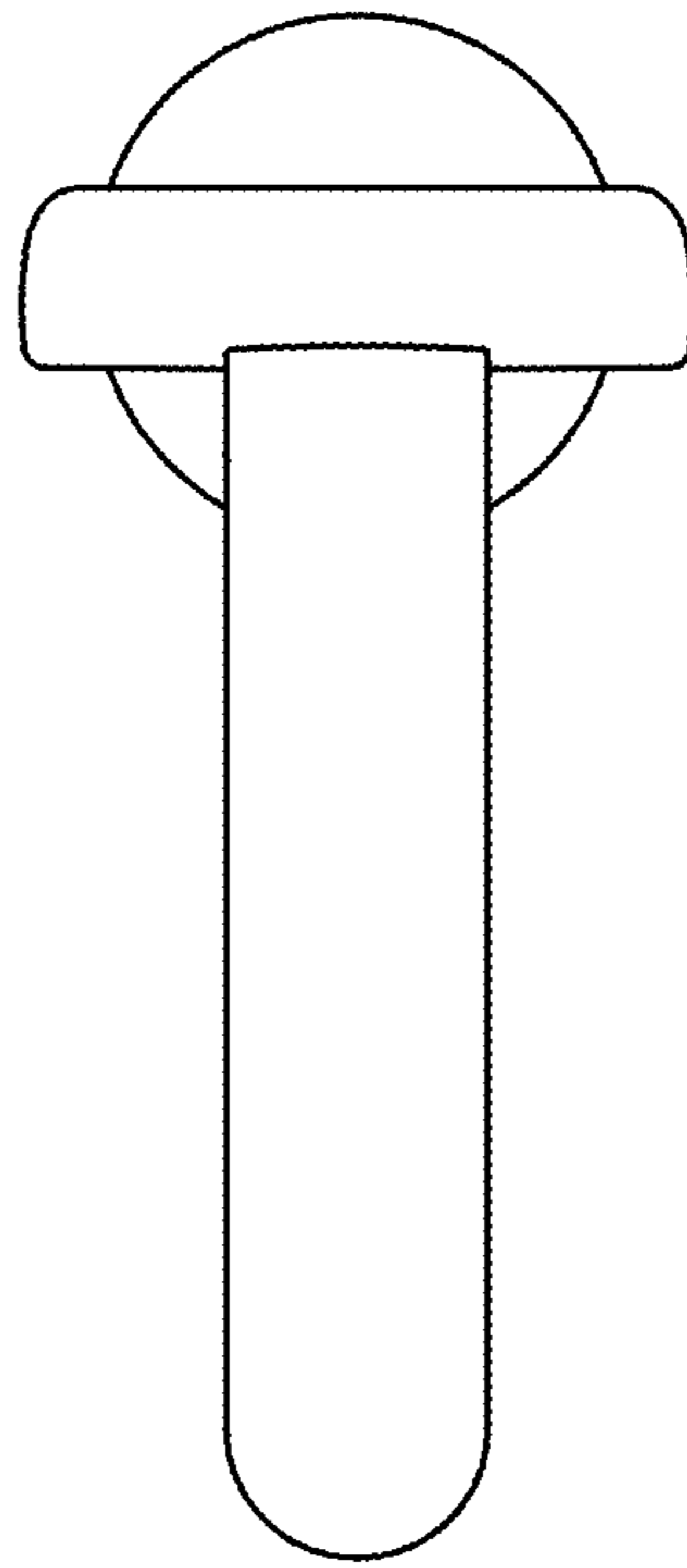

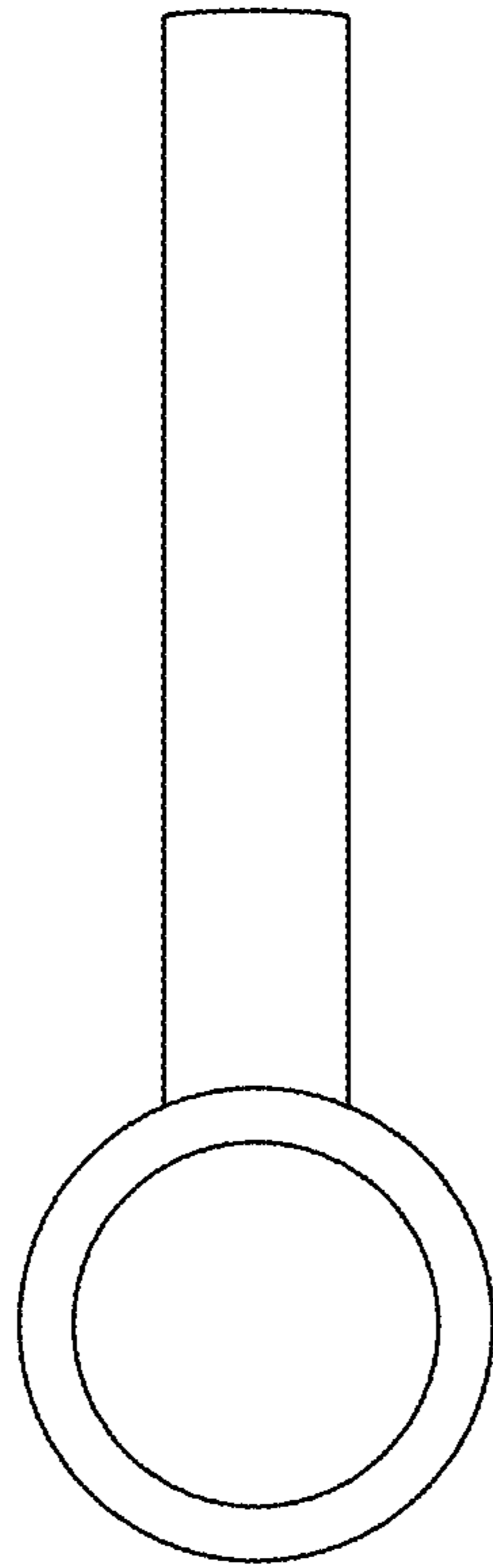

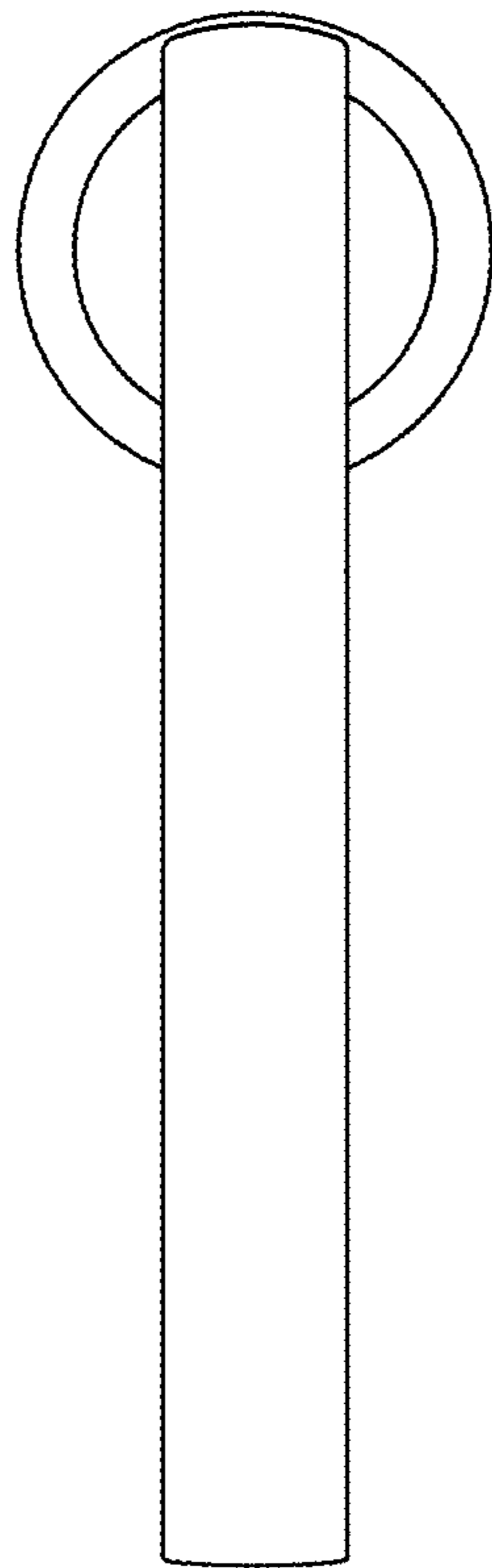
