FIG. 8 is a perspective view of the adjustable angle curling iron shown in a position of use.

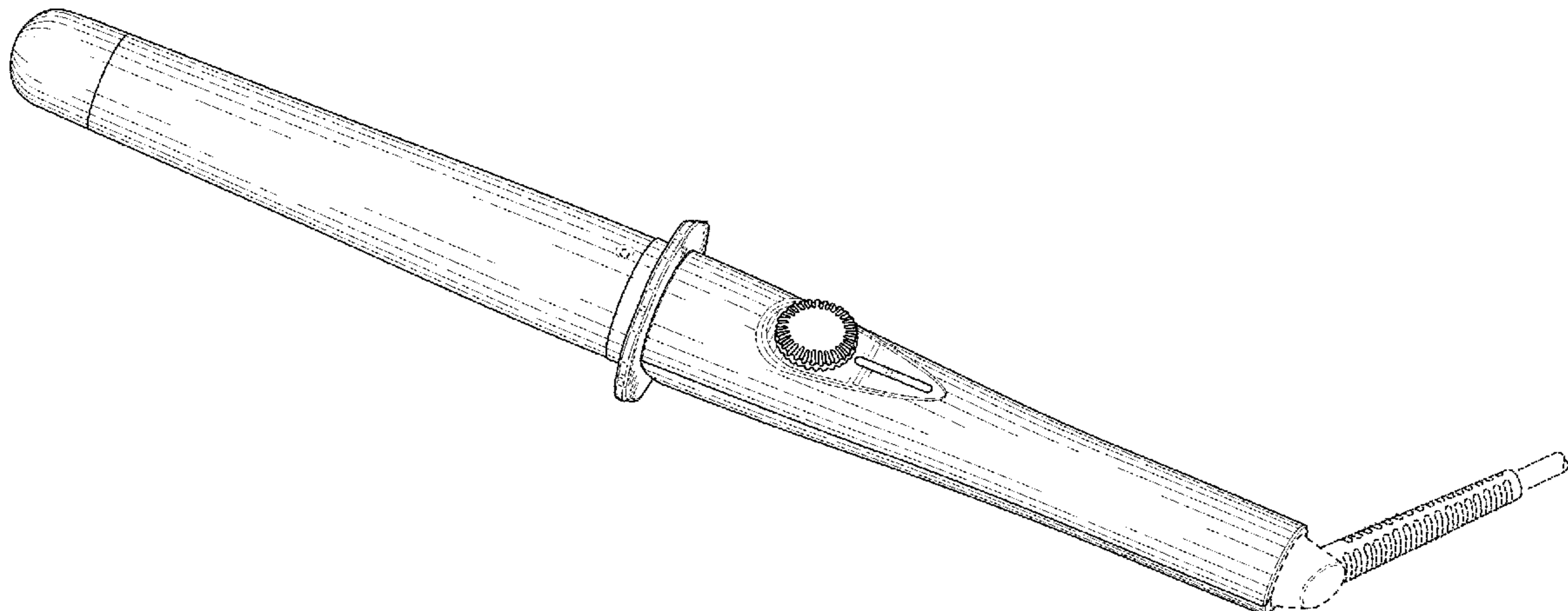

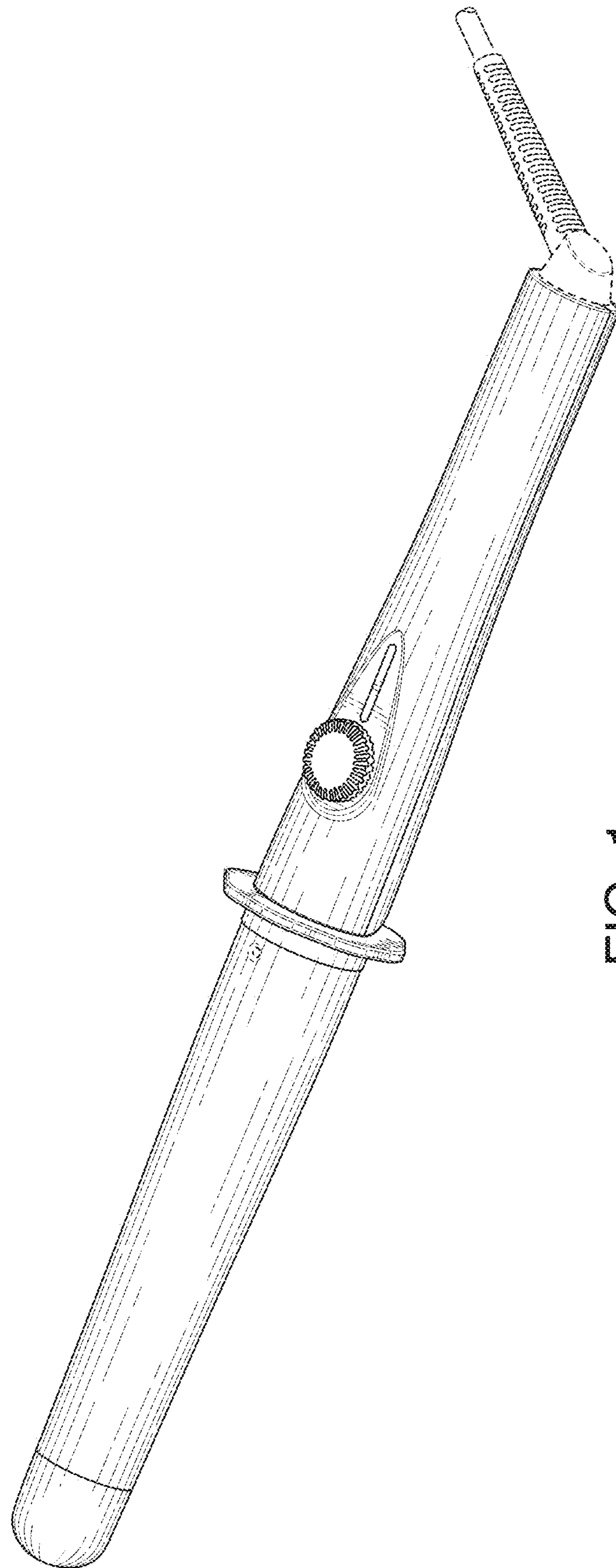

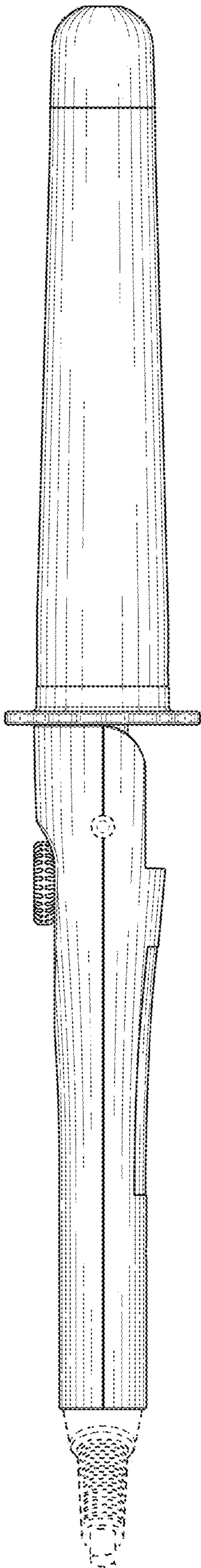

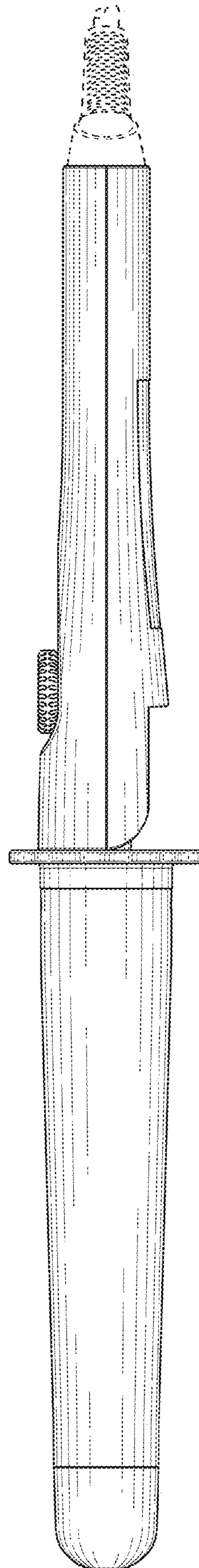

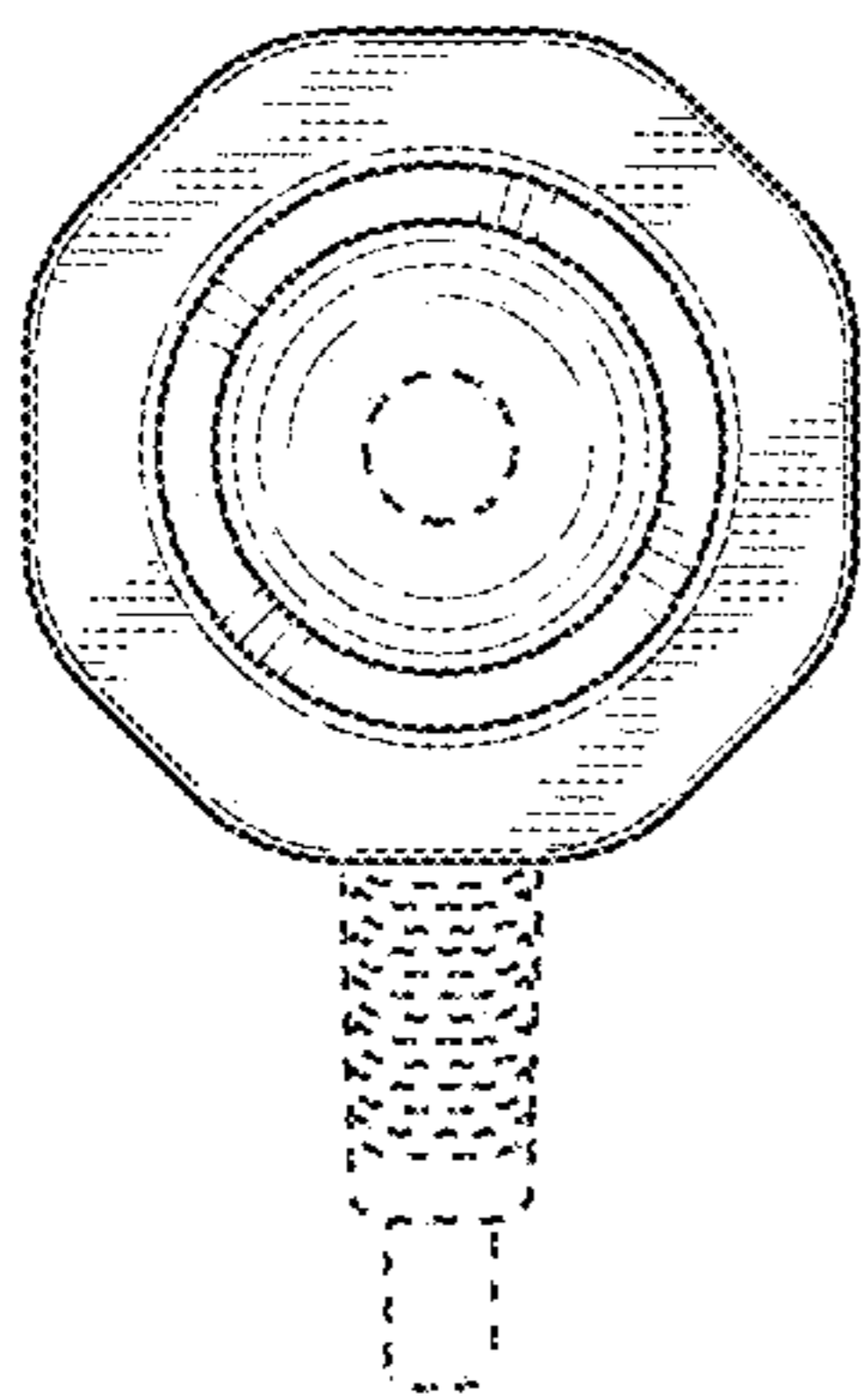

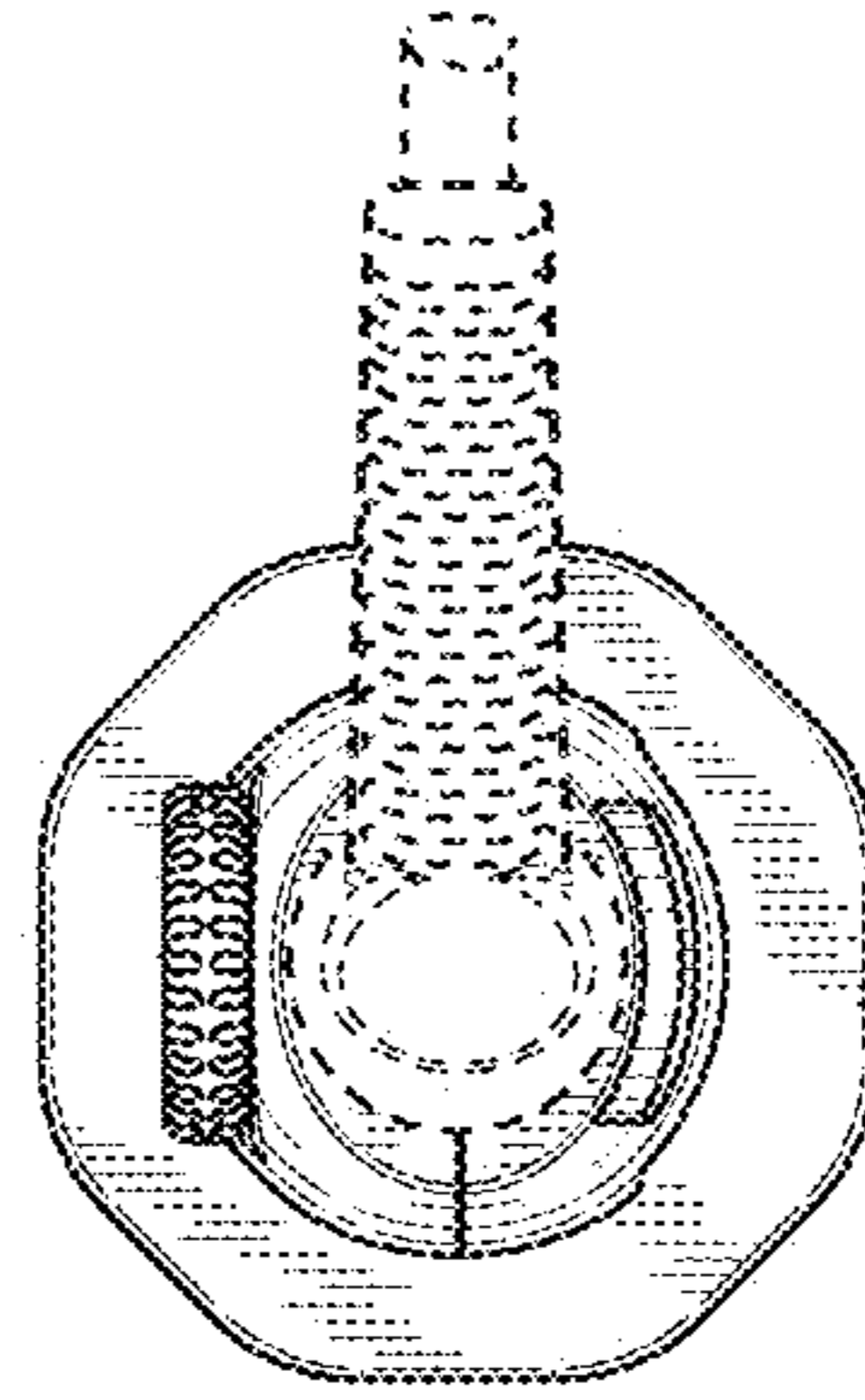

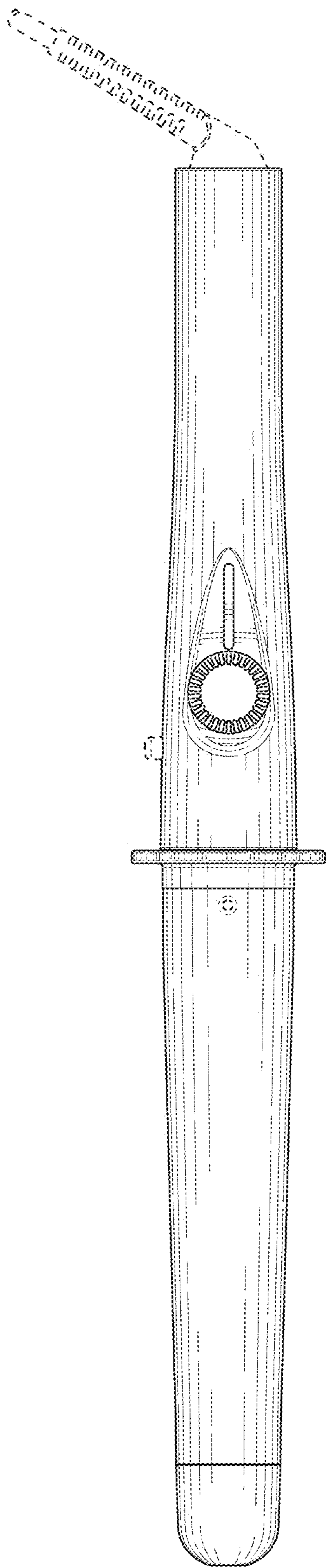

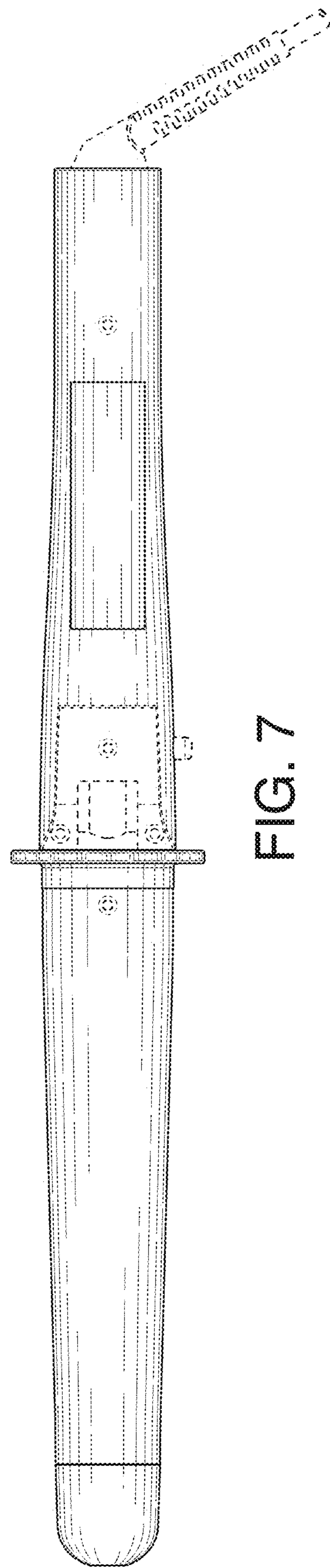

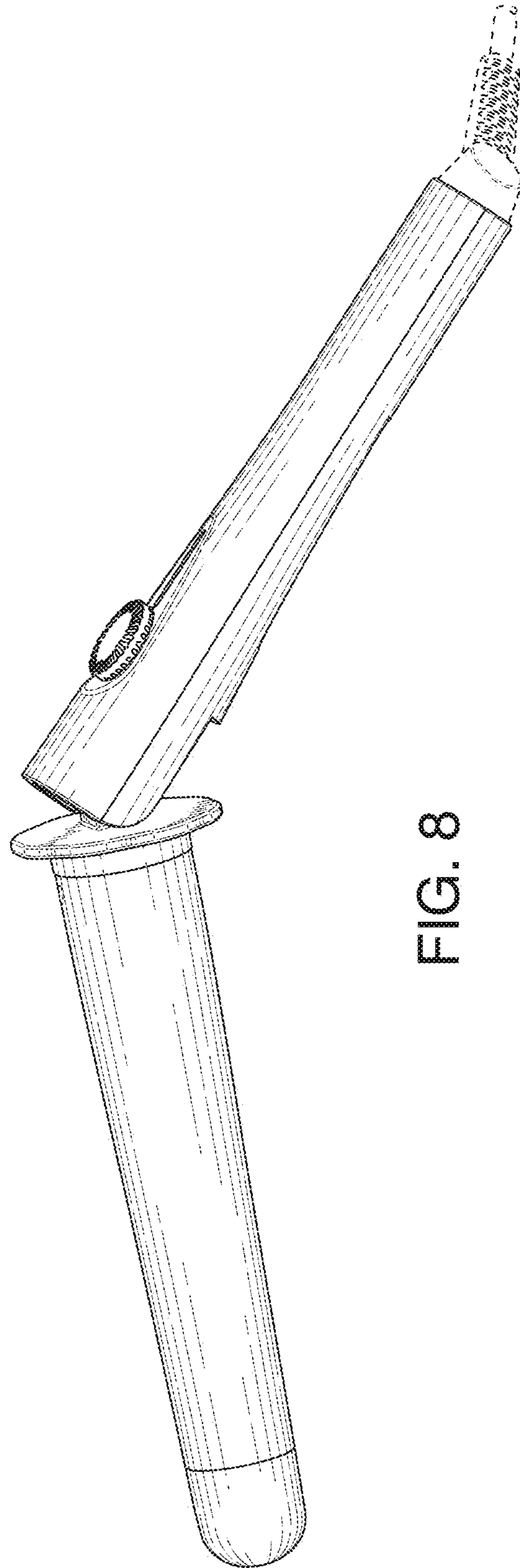
