The ornamental design for a vacuum cleaner head, as shown
and described.

DESCRIPTION

FIG. 1 is a front, top and right-side perspective view of a
vacuum cleaner head showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a right-side view thereof, with the left-side view
being a mirror image thereof; and,

4, in which the internal mechanism is omitted.

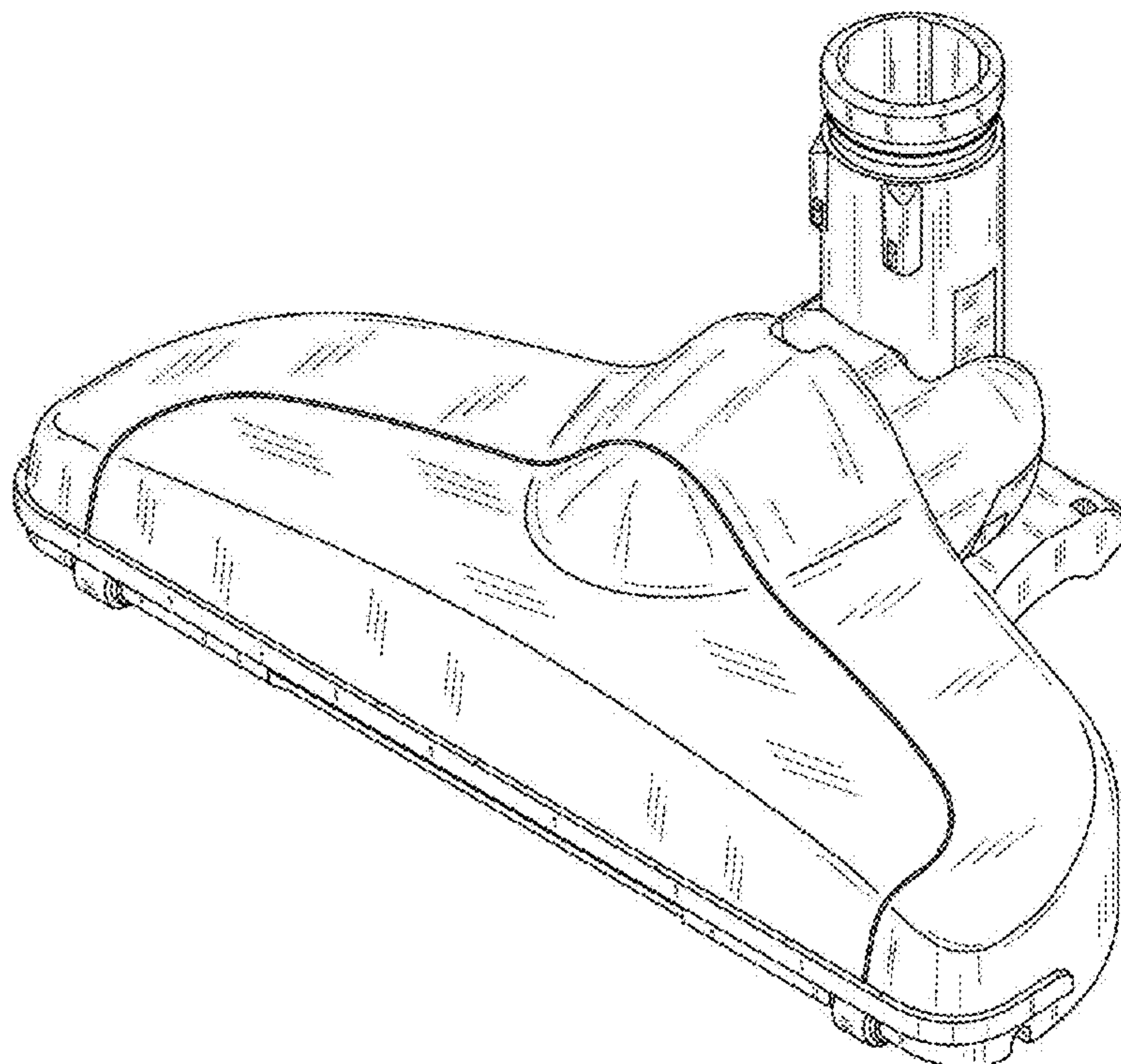

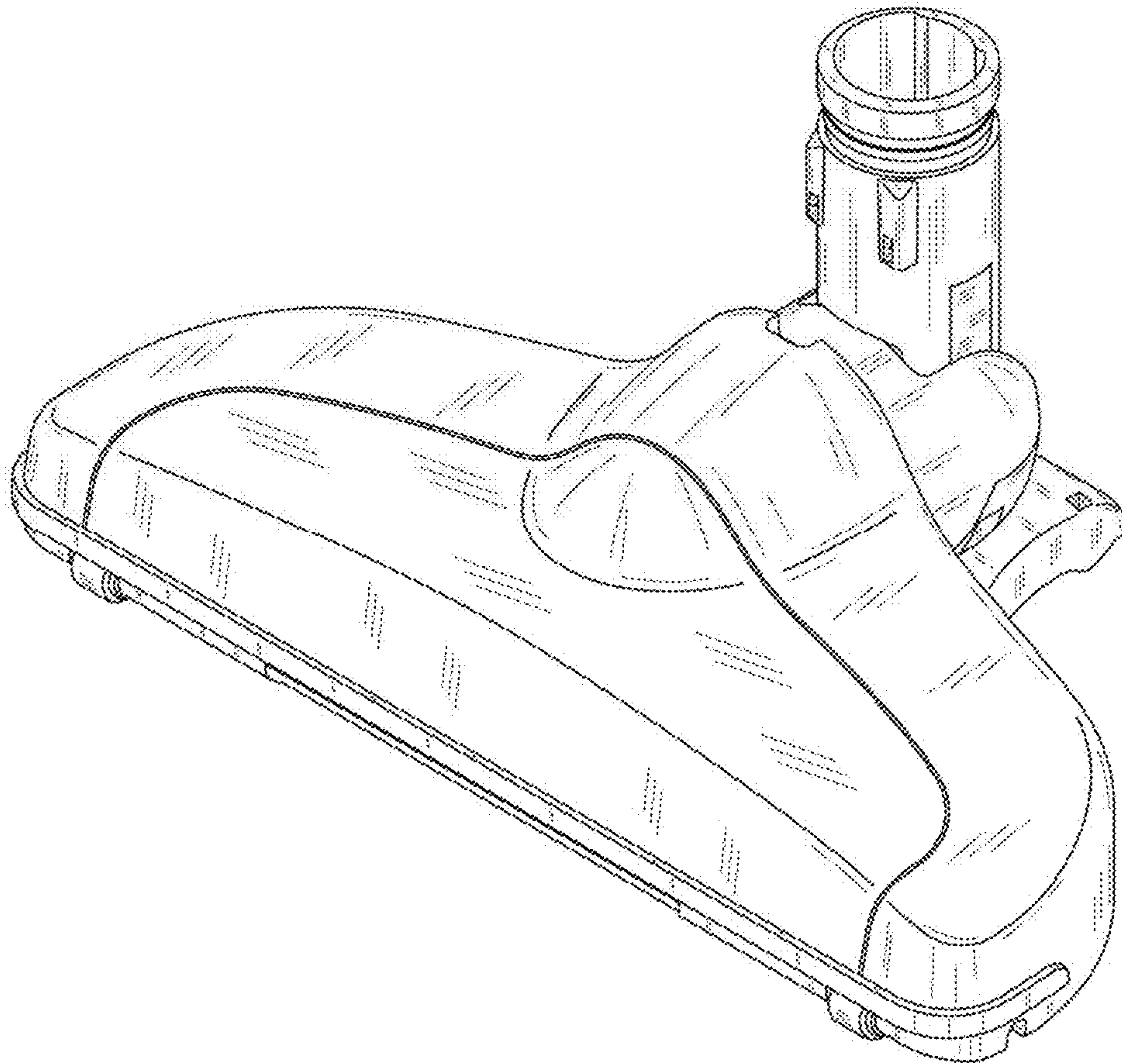

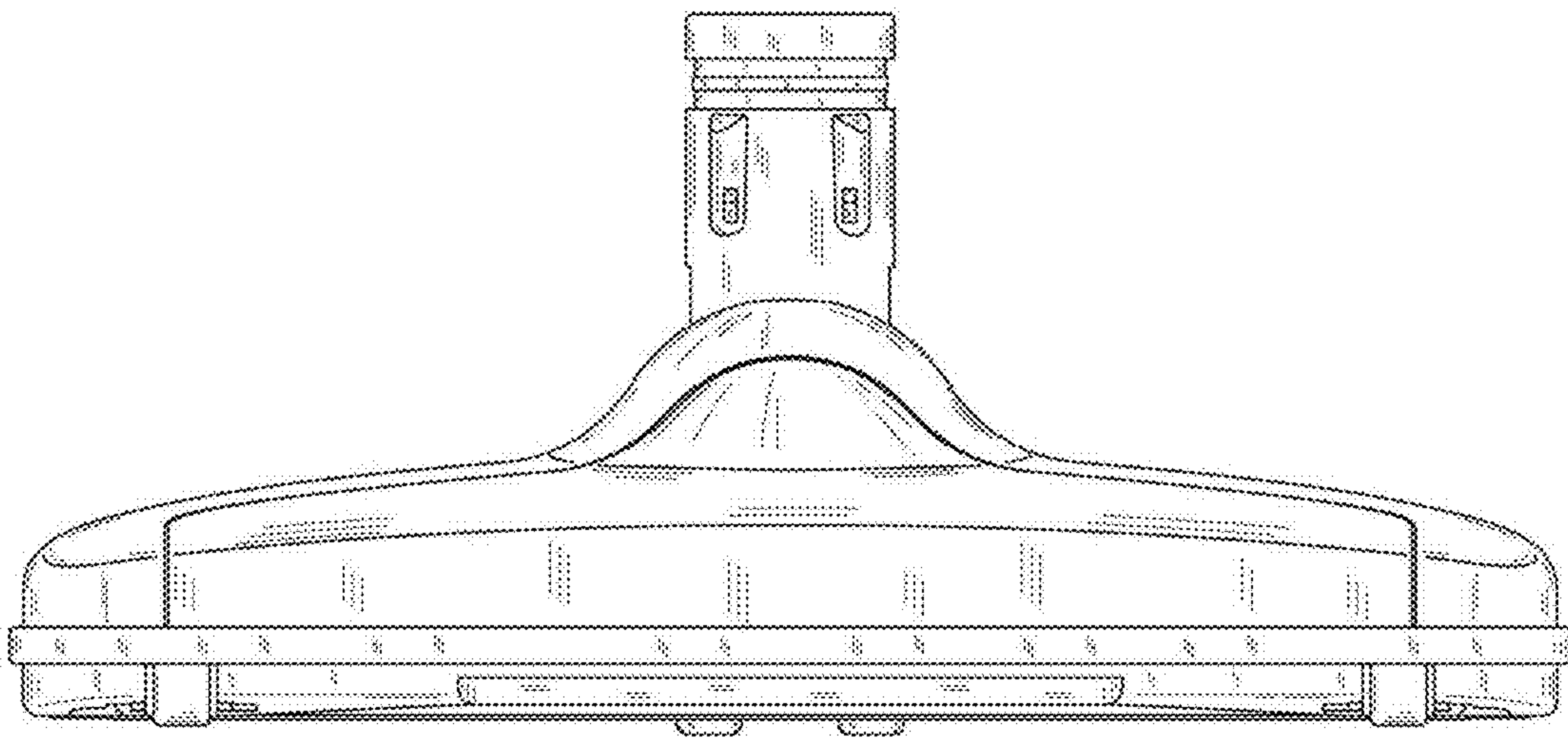

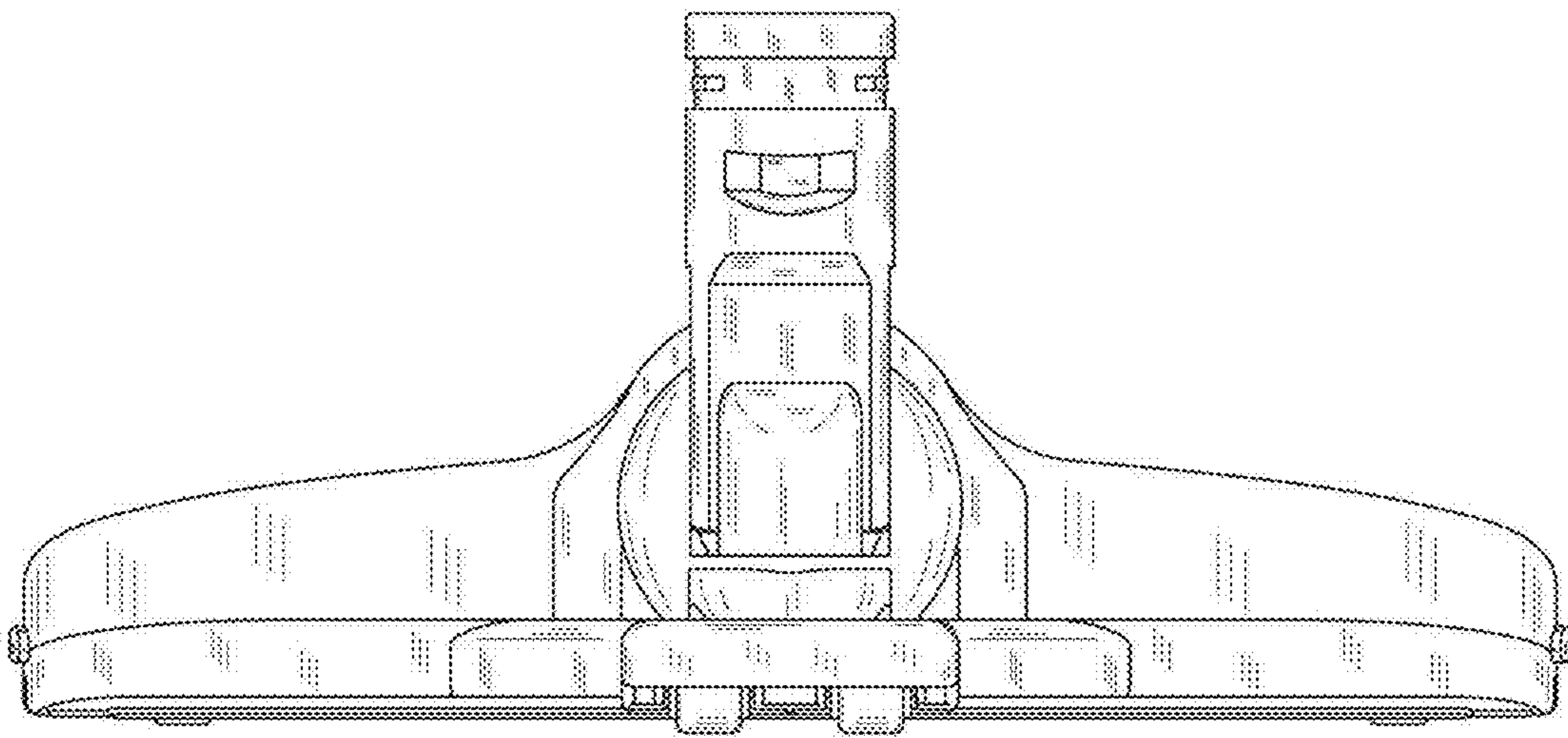

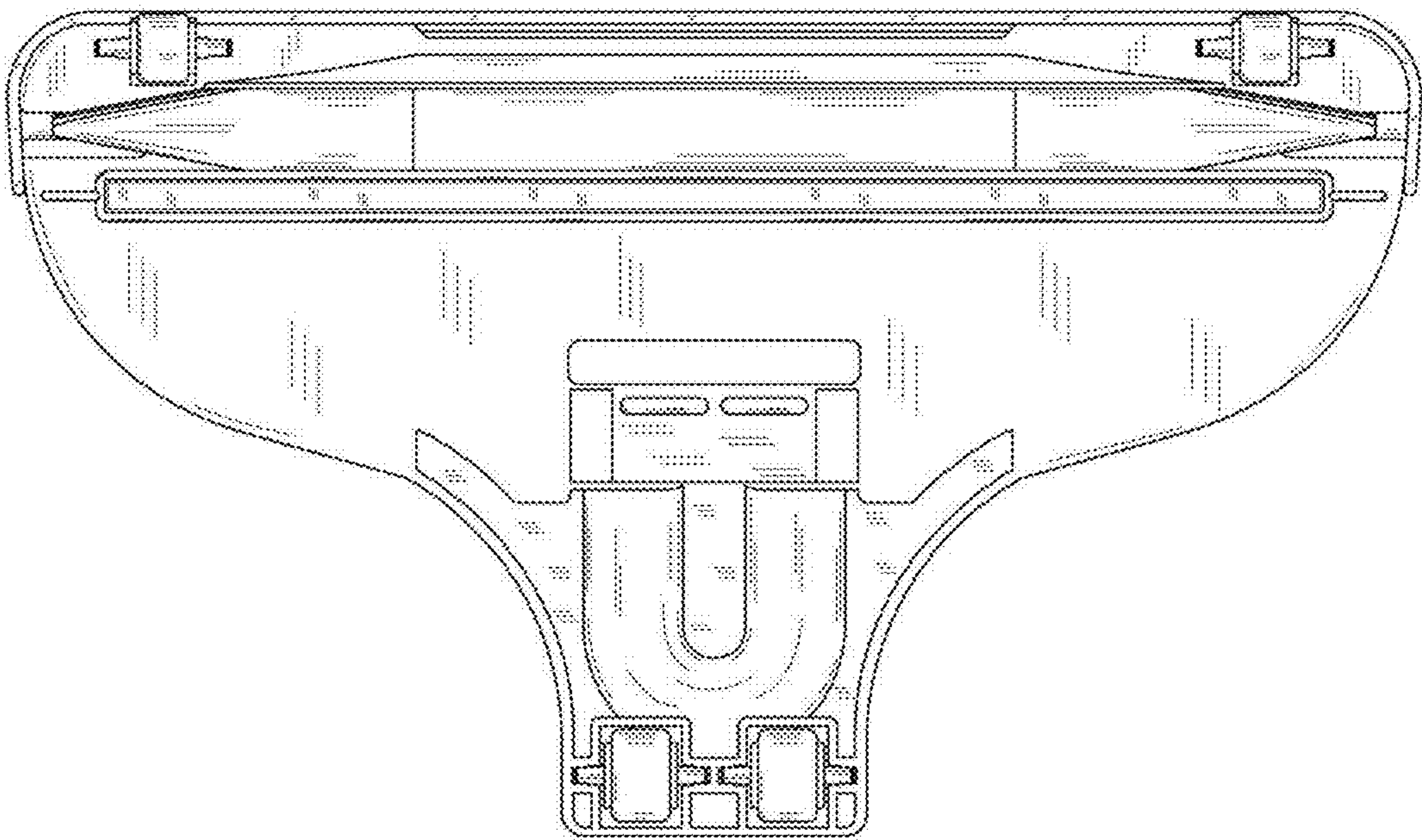

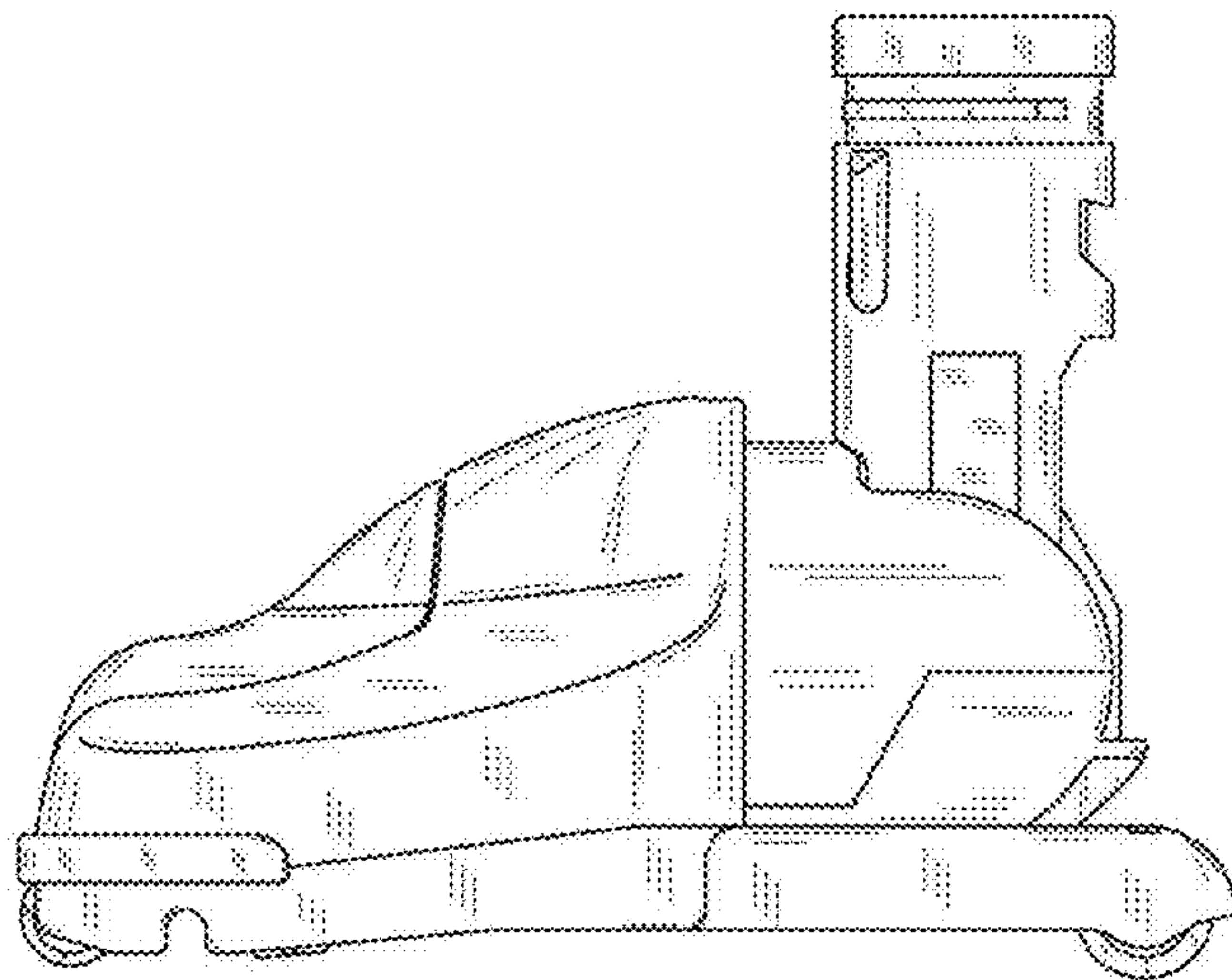
