DESCRIPTION

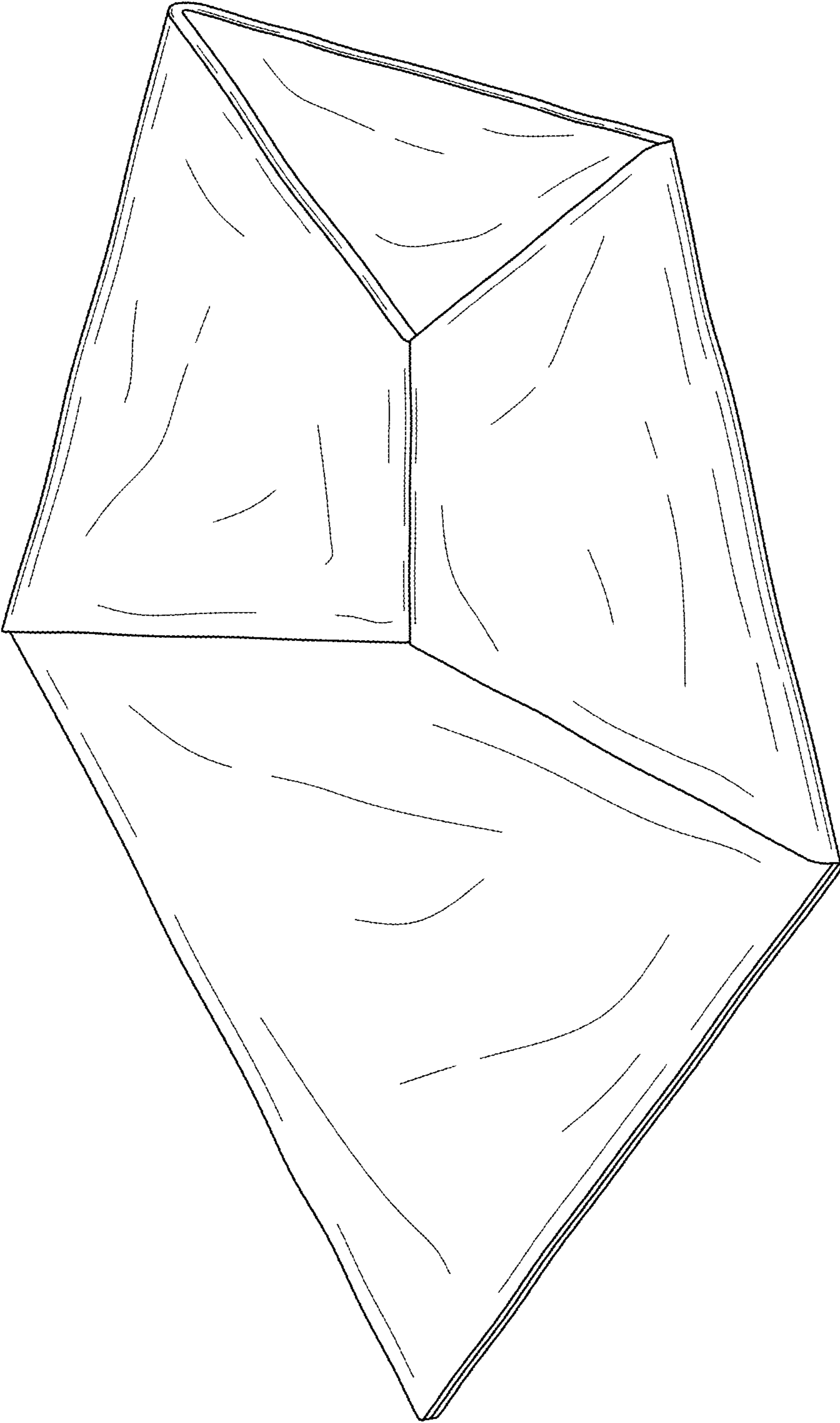

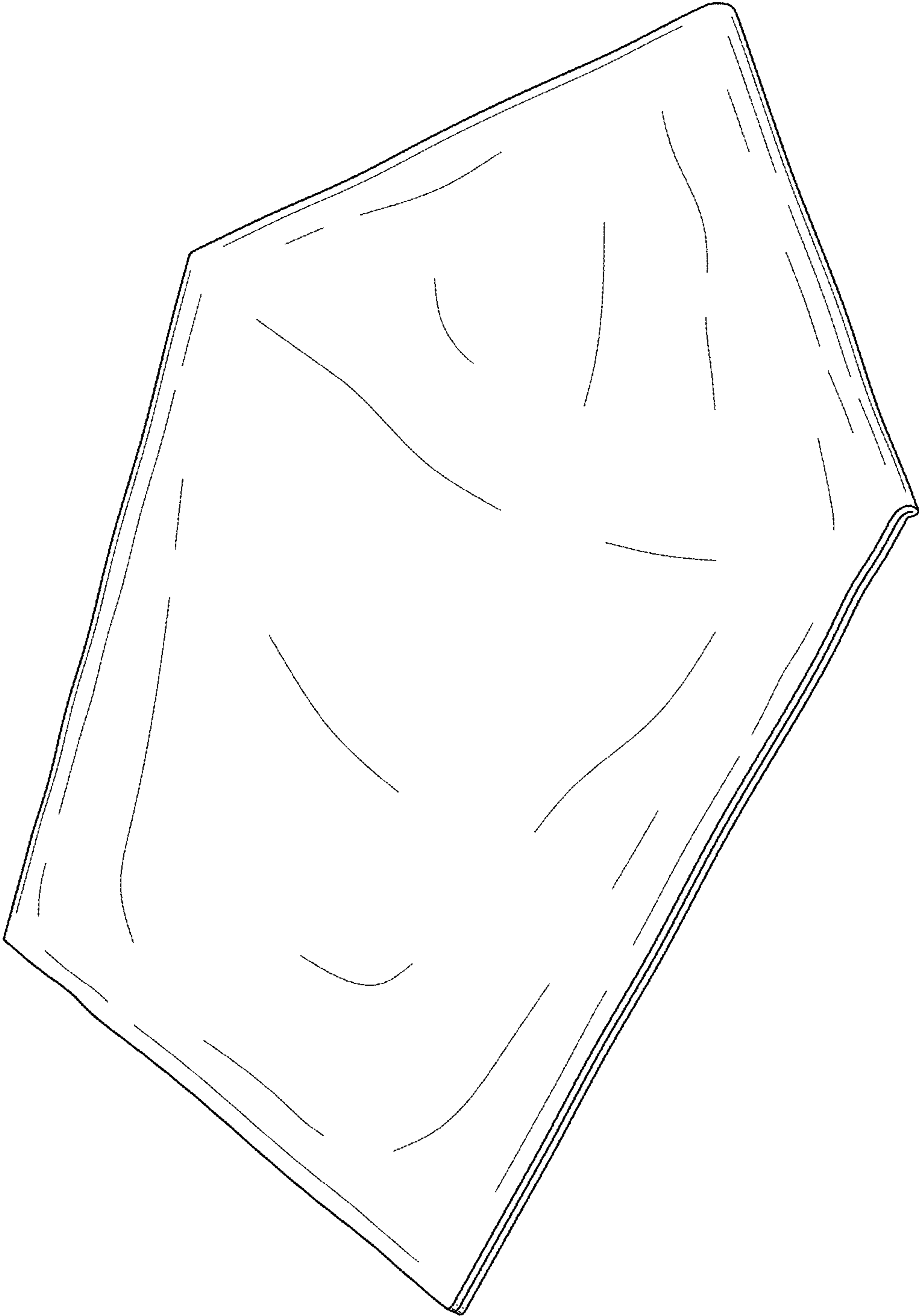

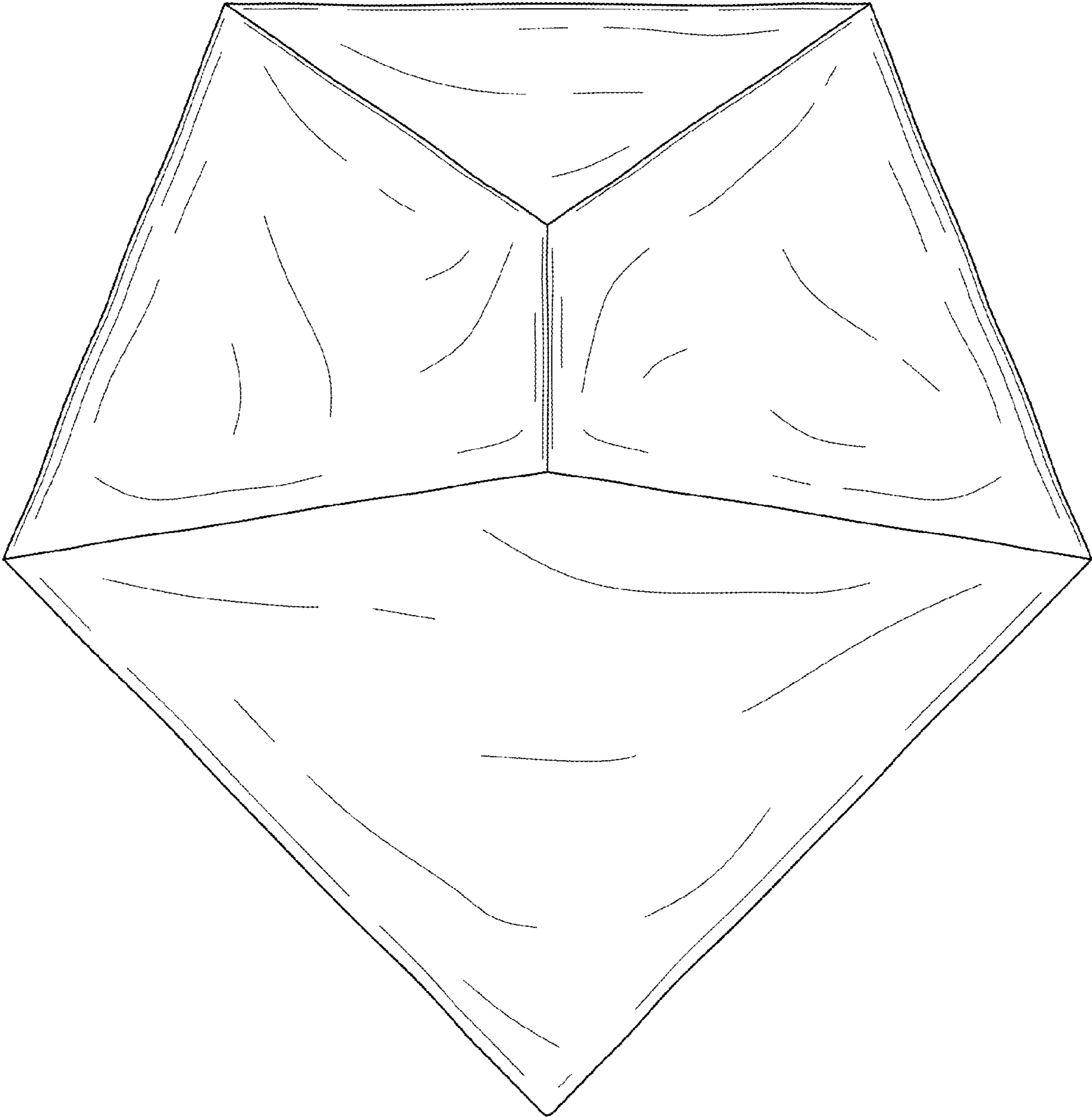

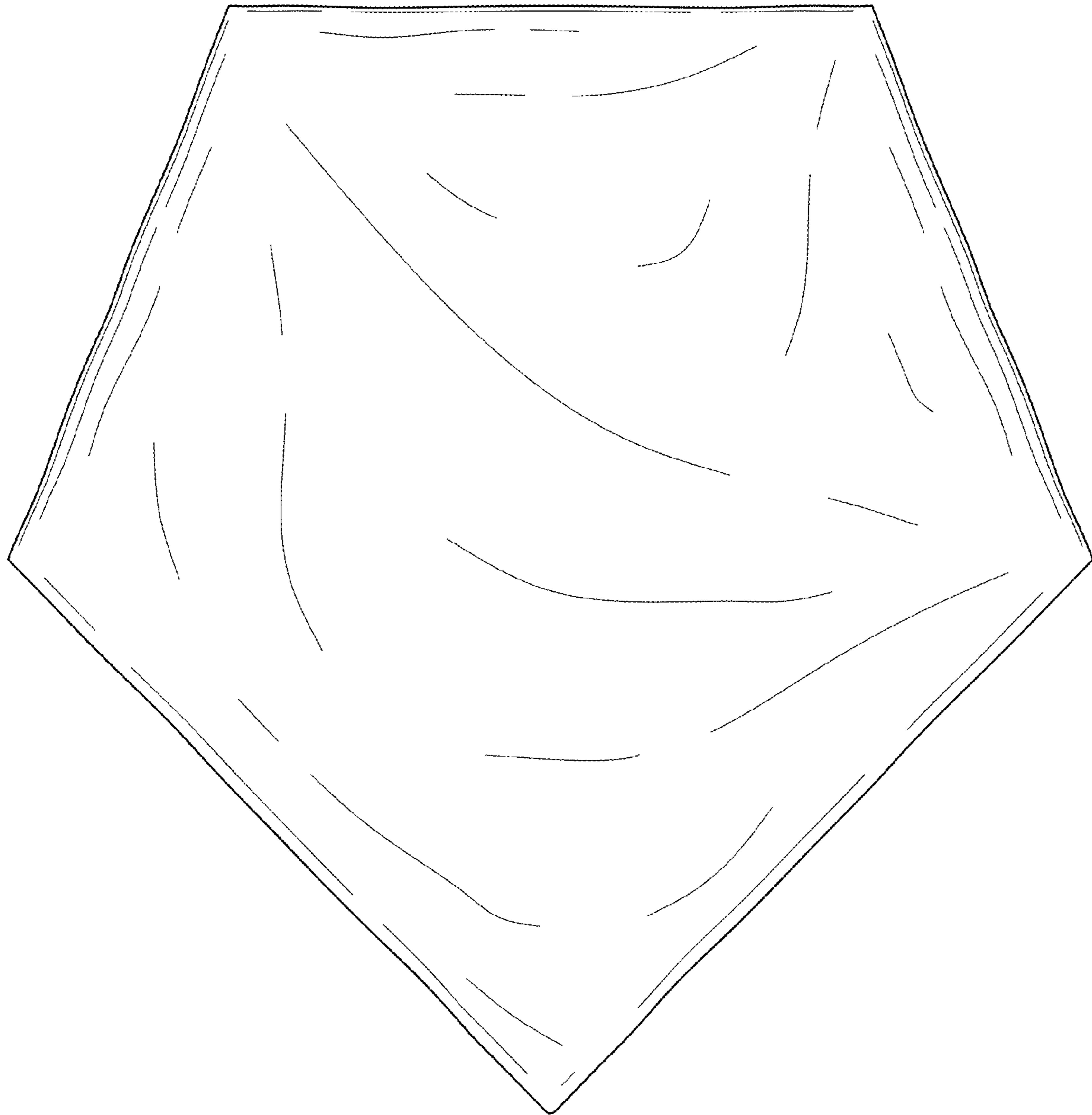

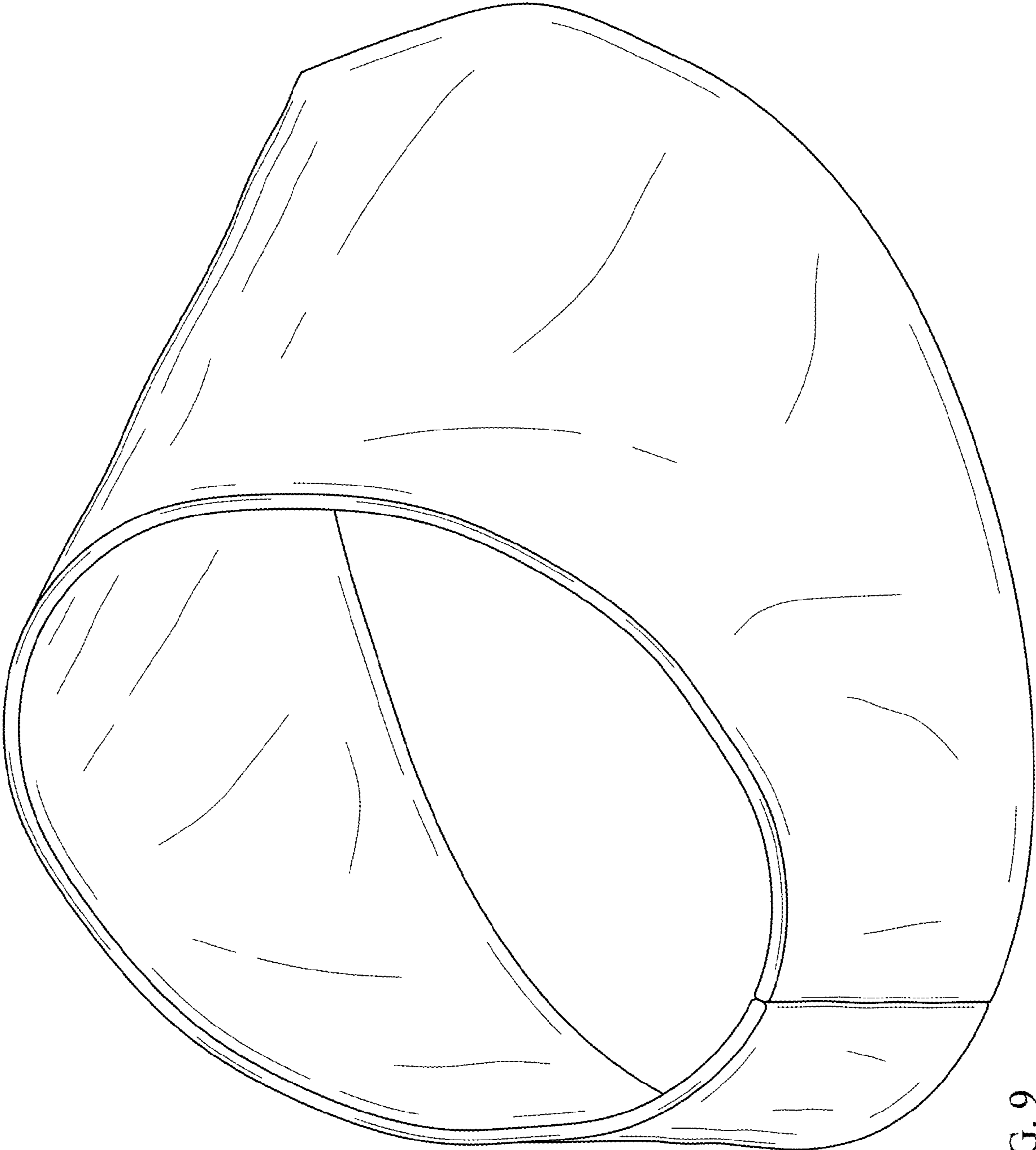

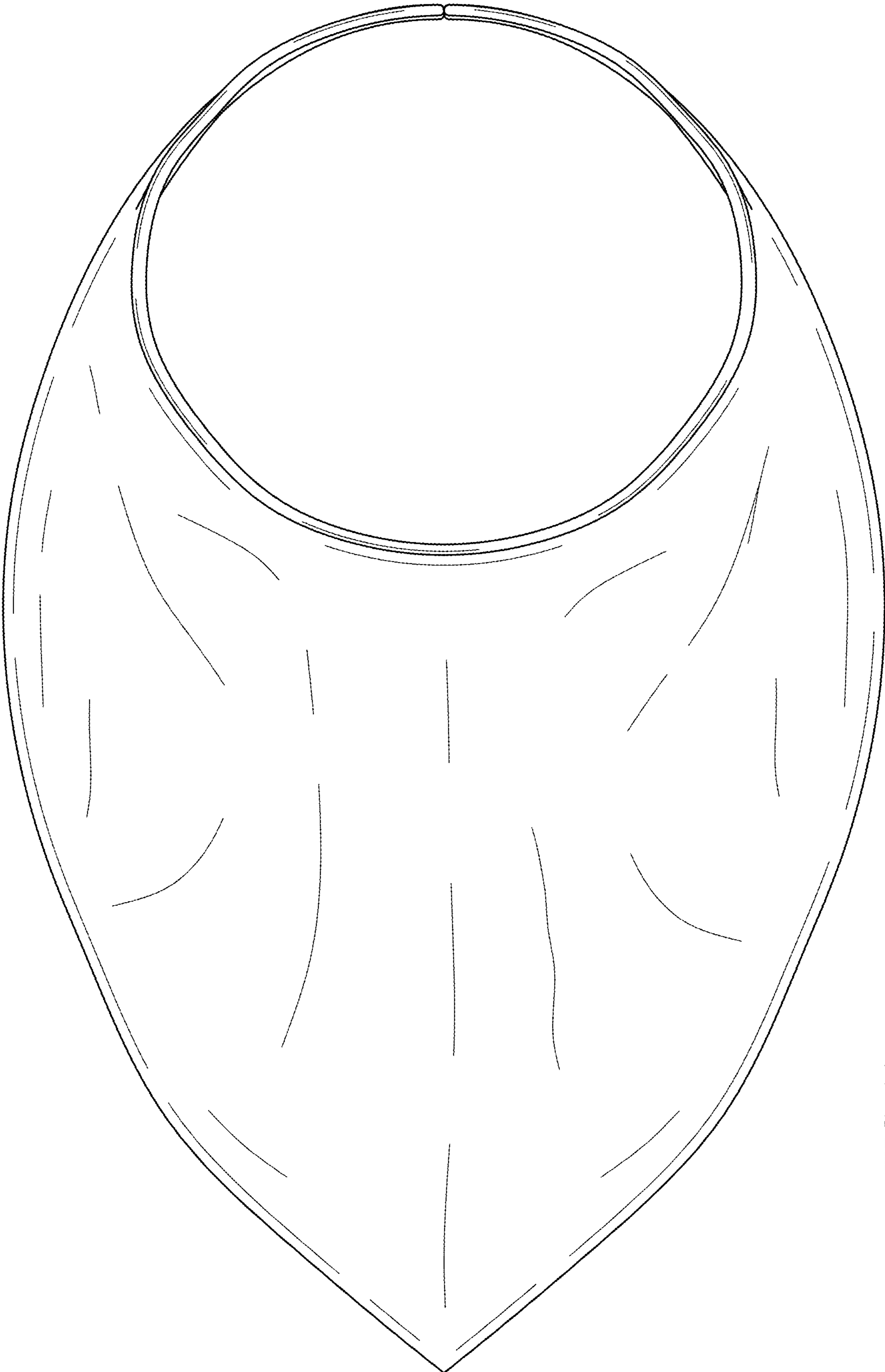

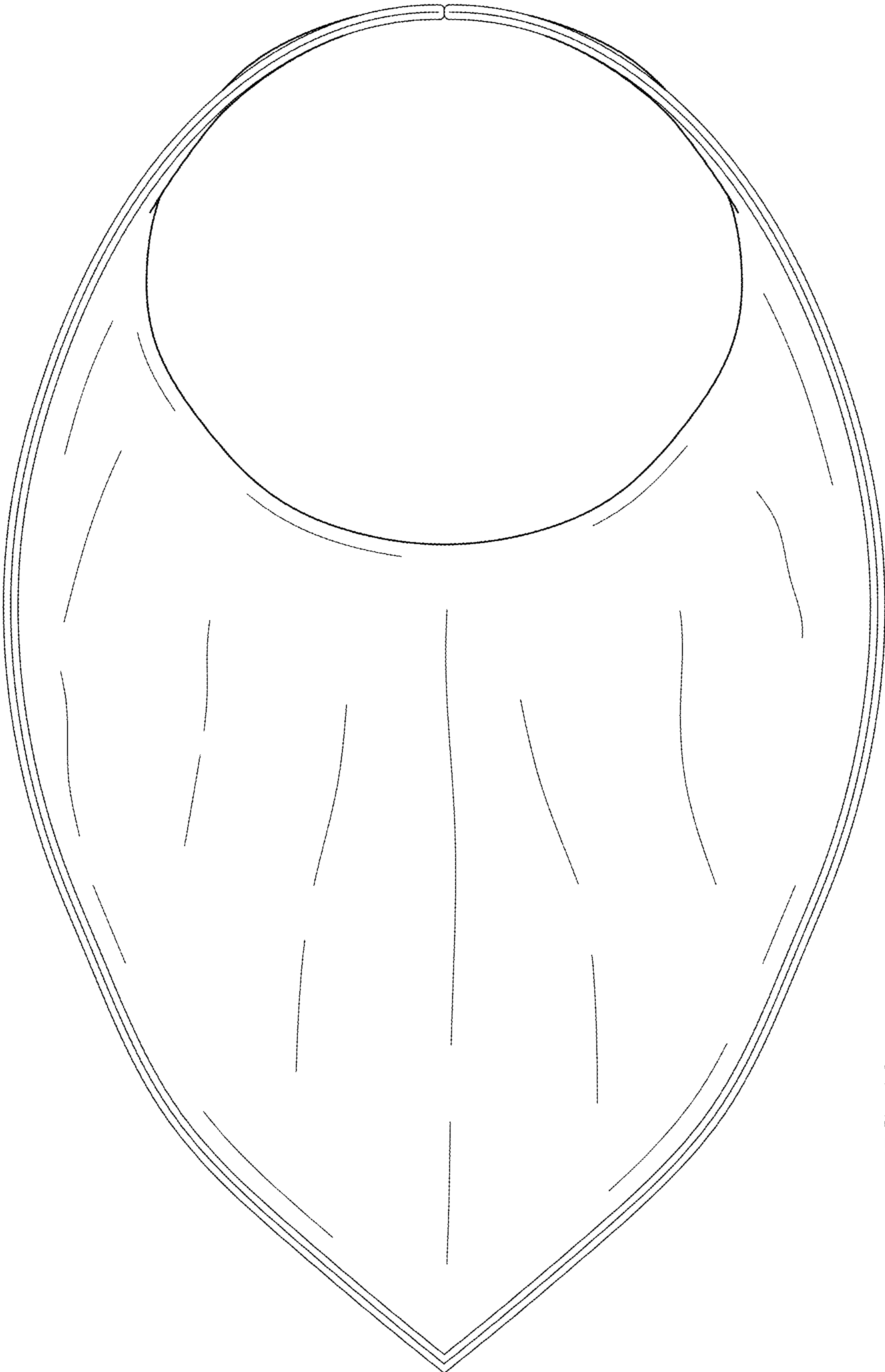

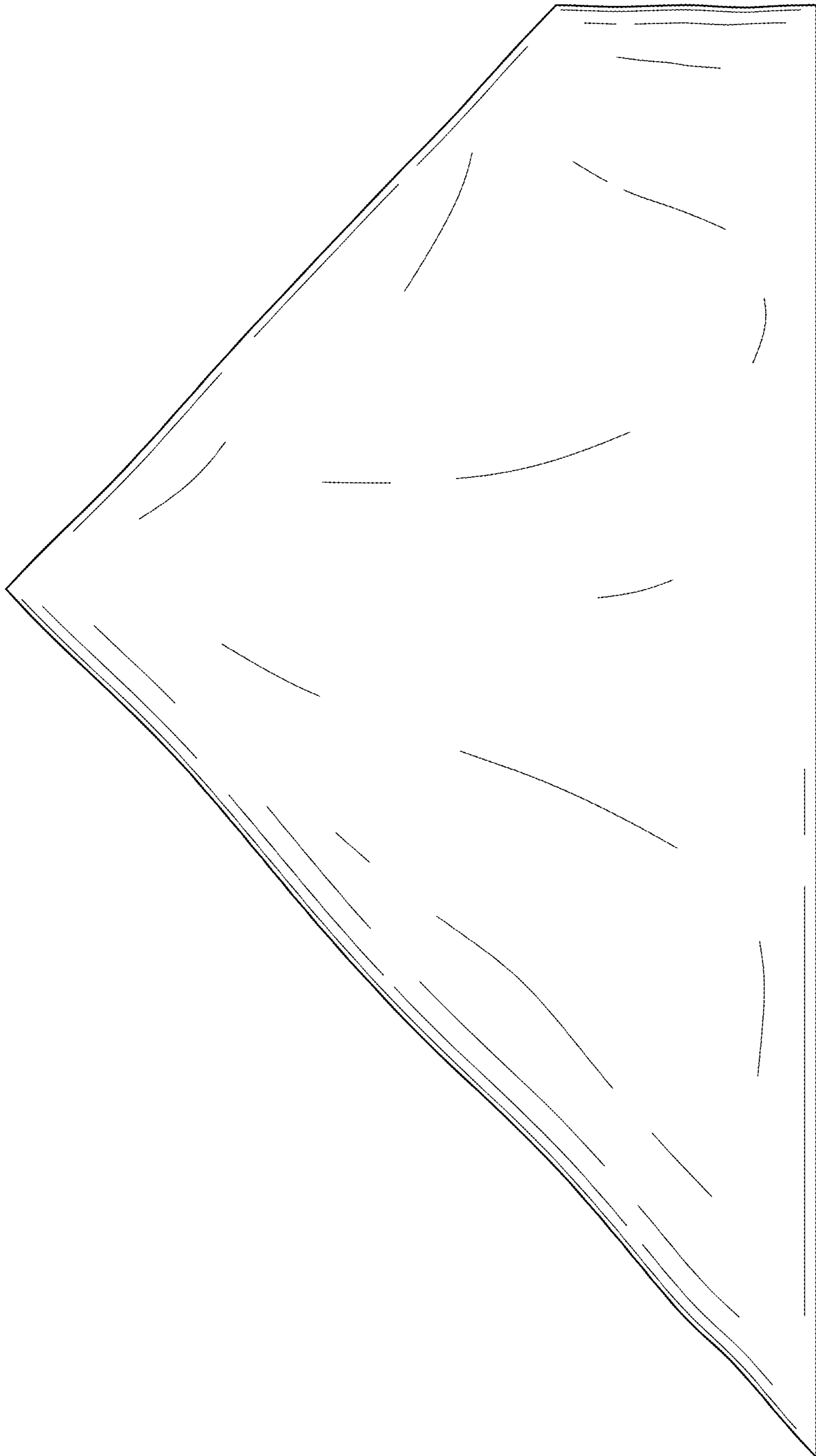

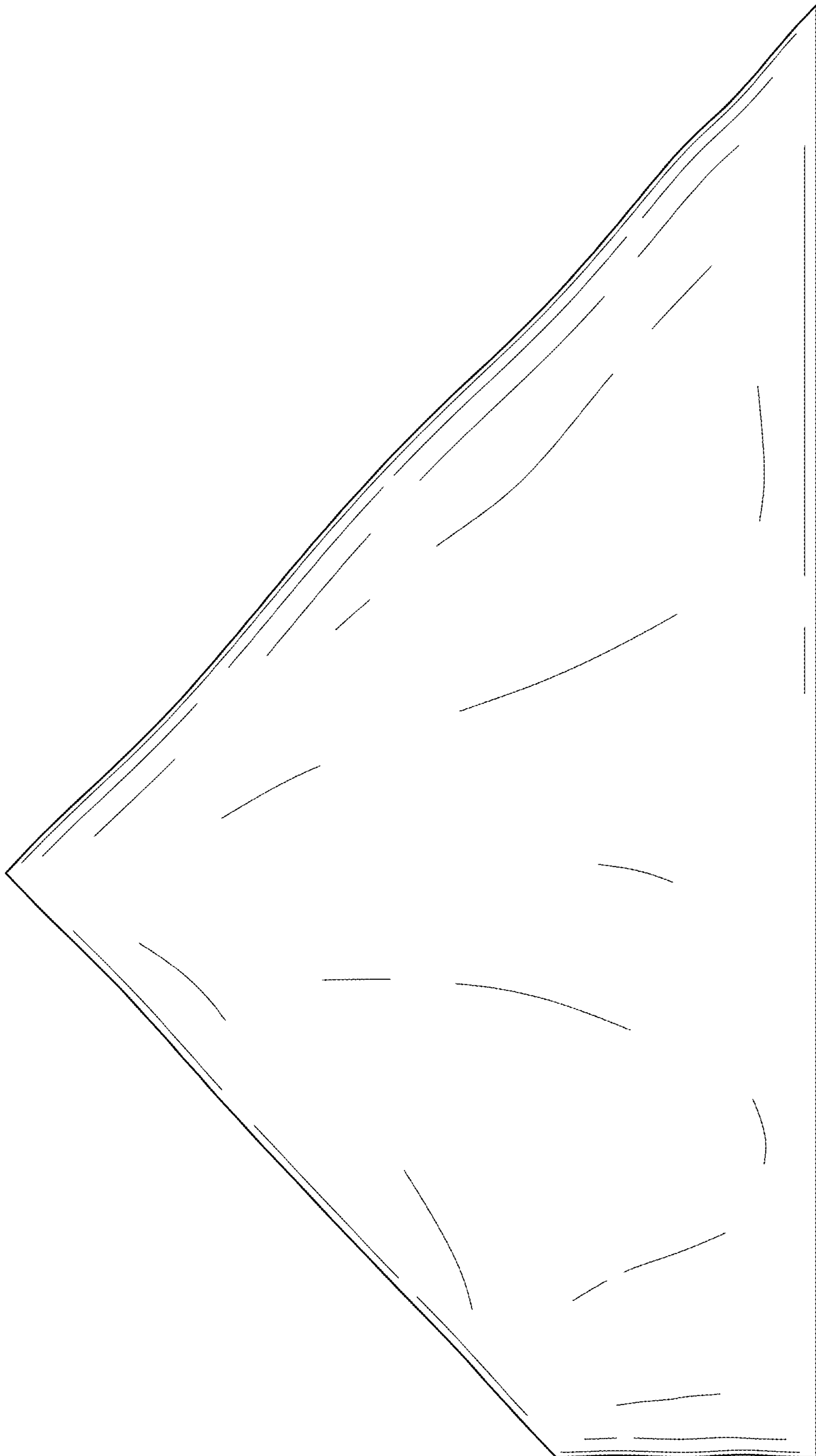

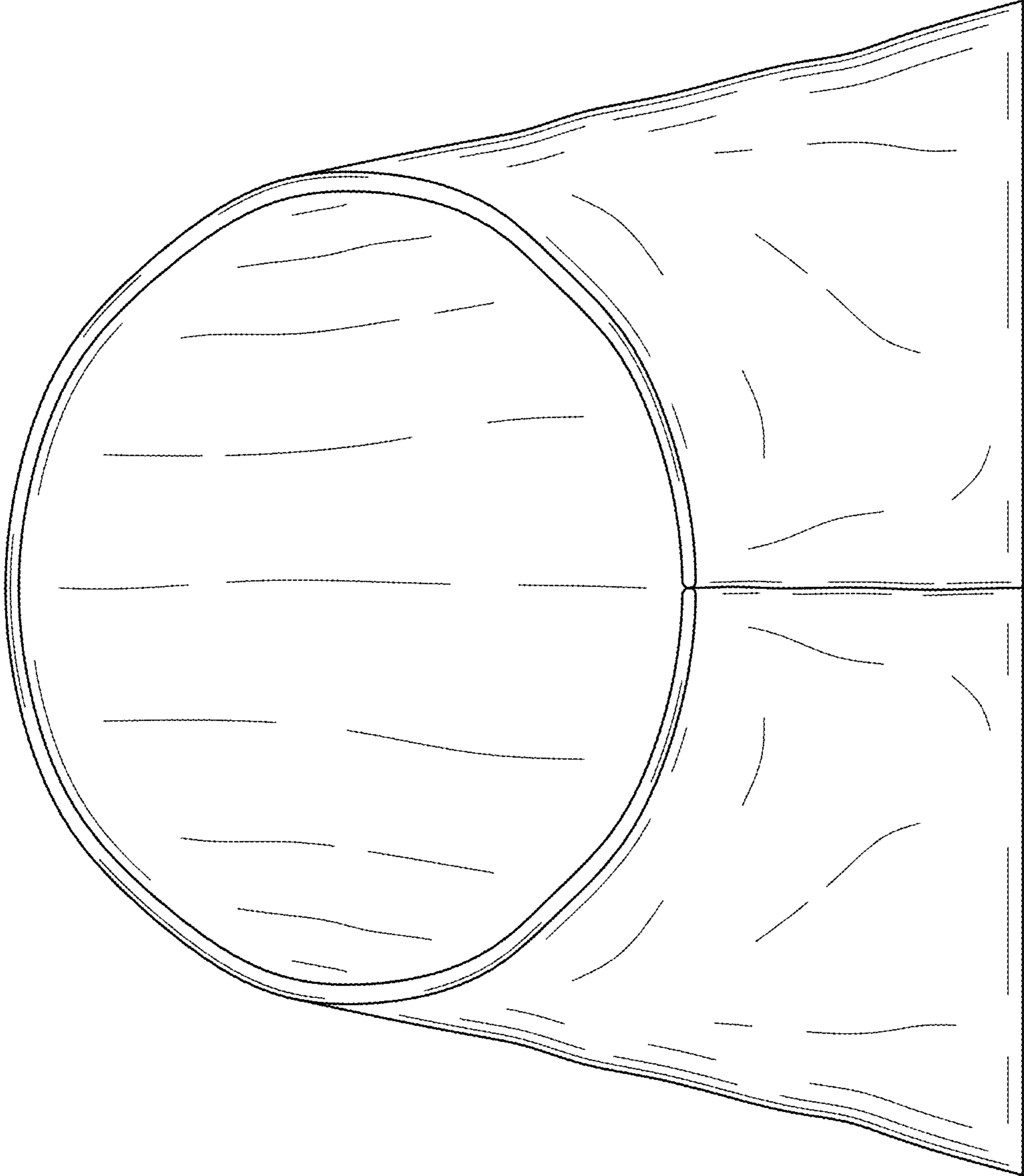

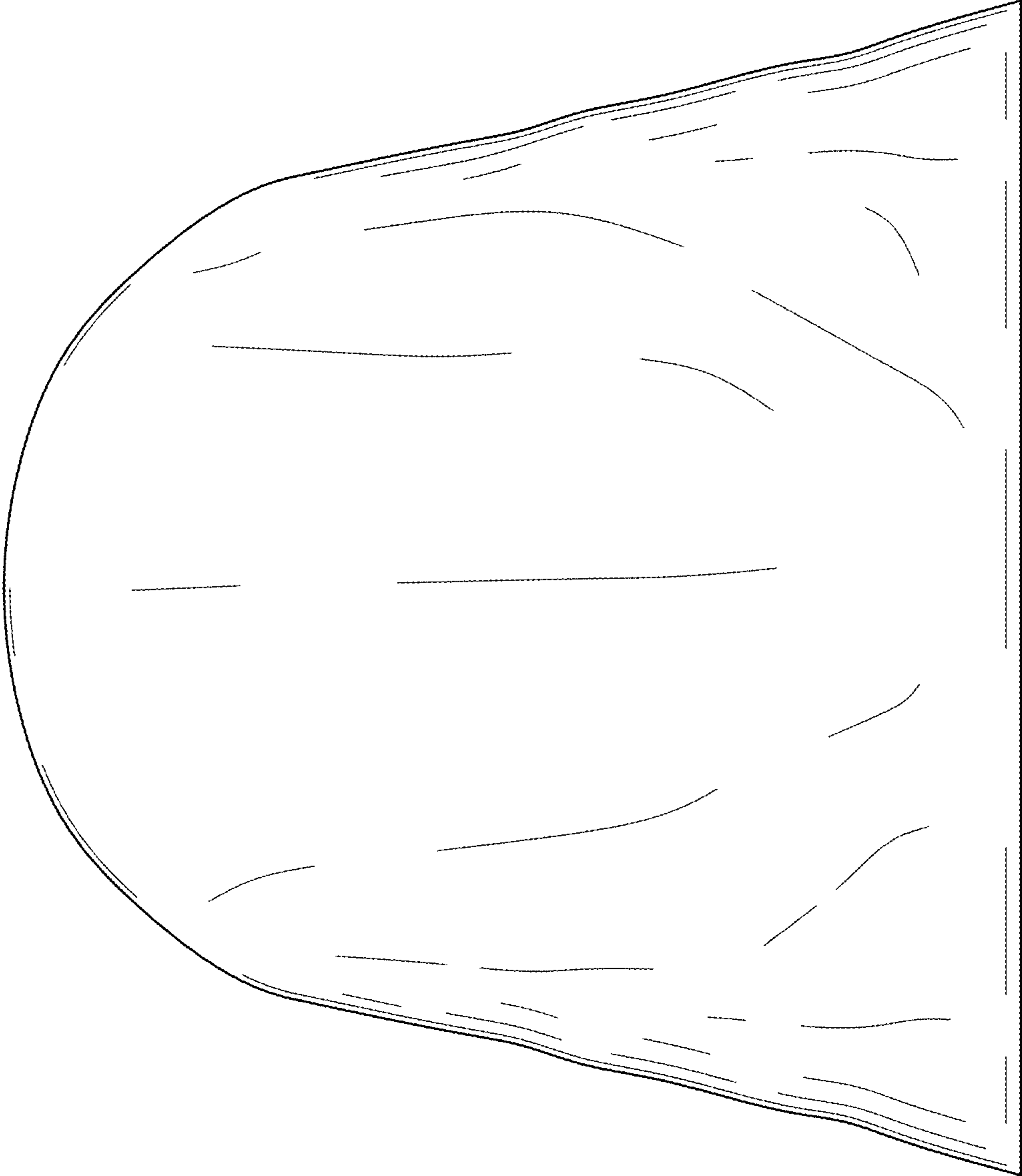

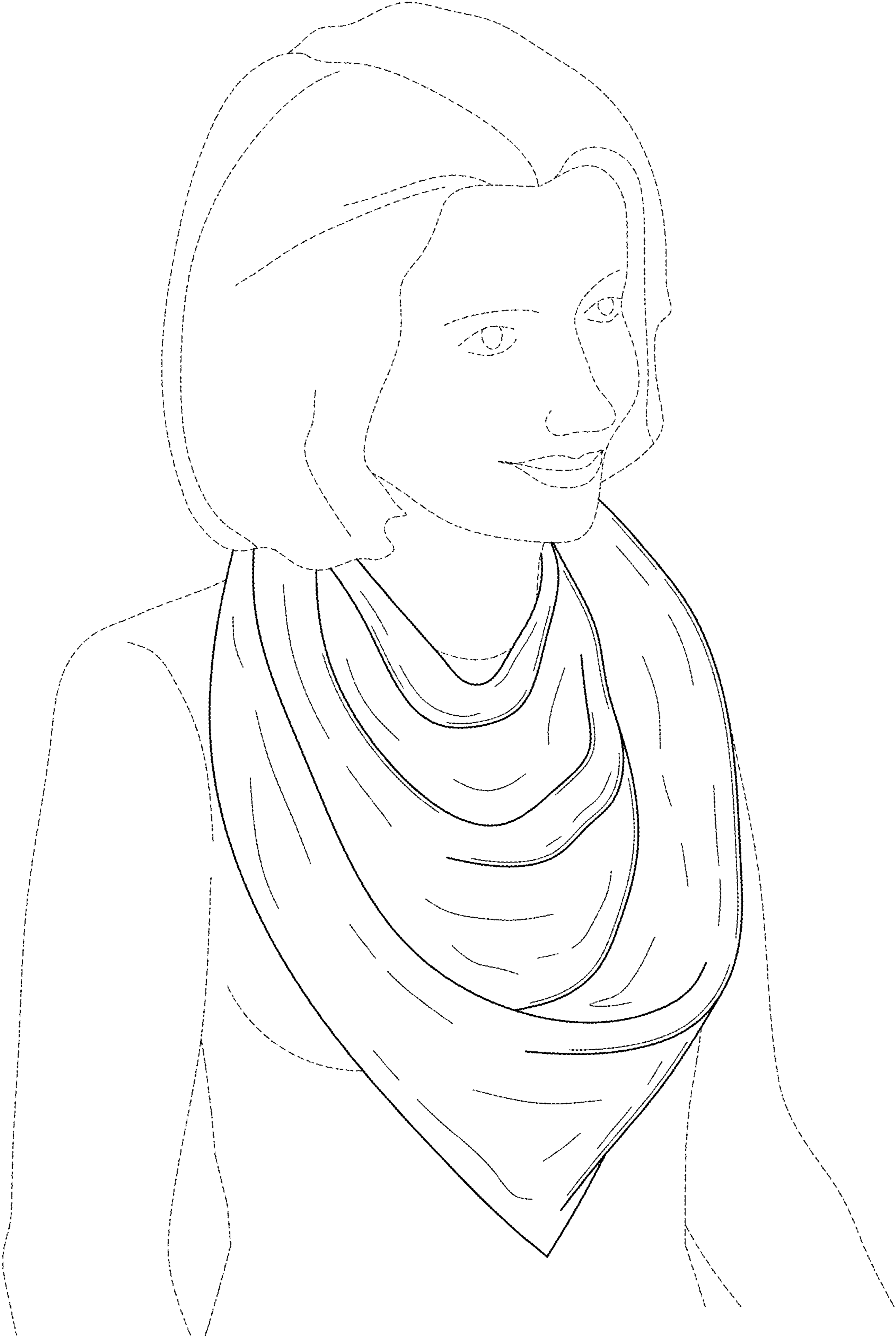

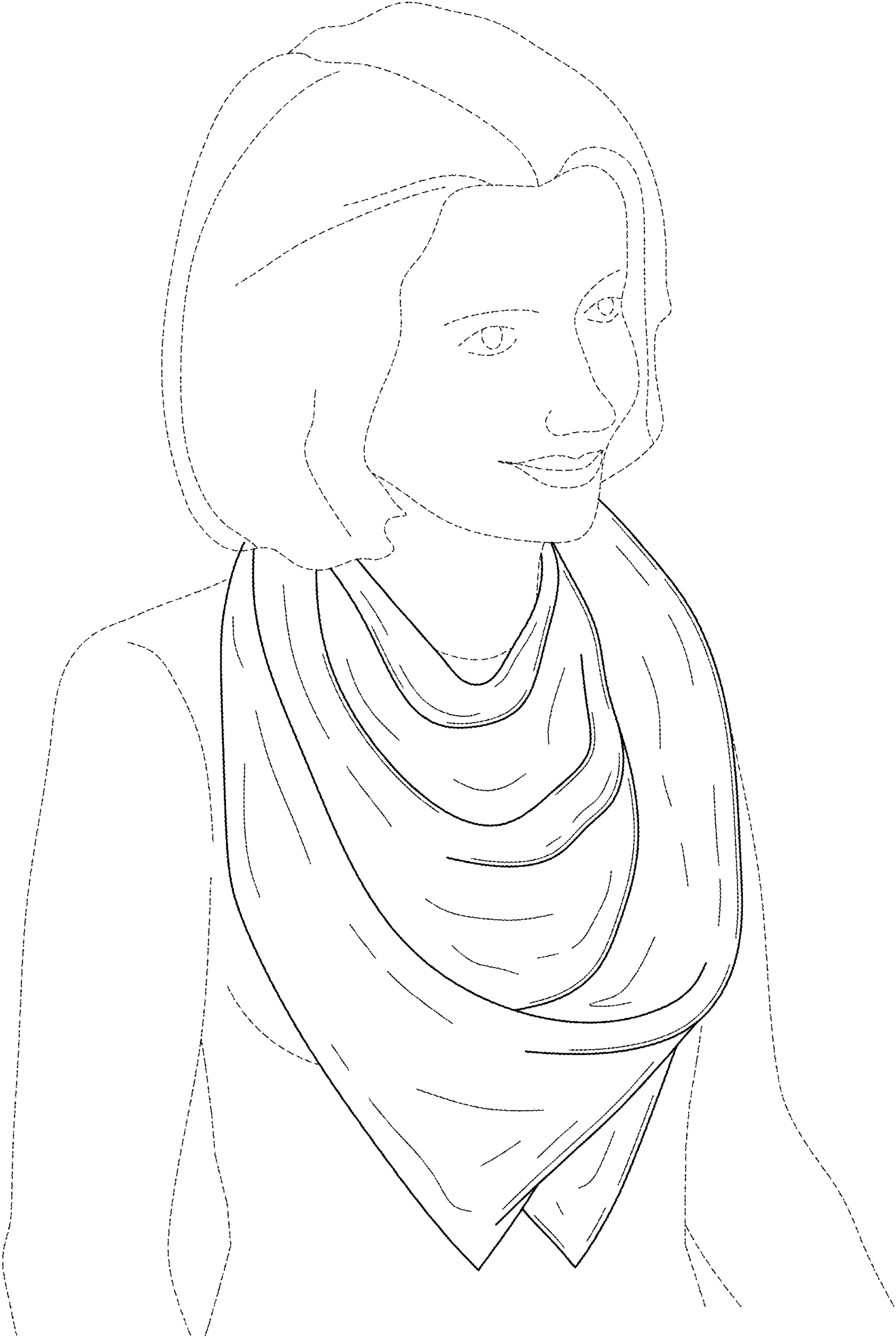
