(57) **CLAIM**

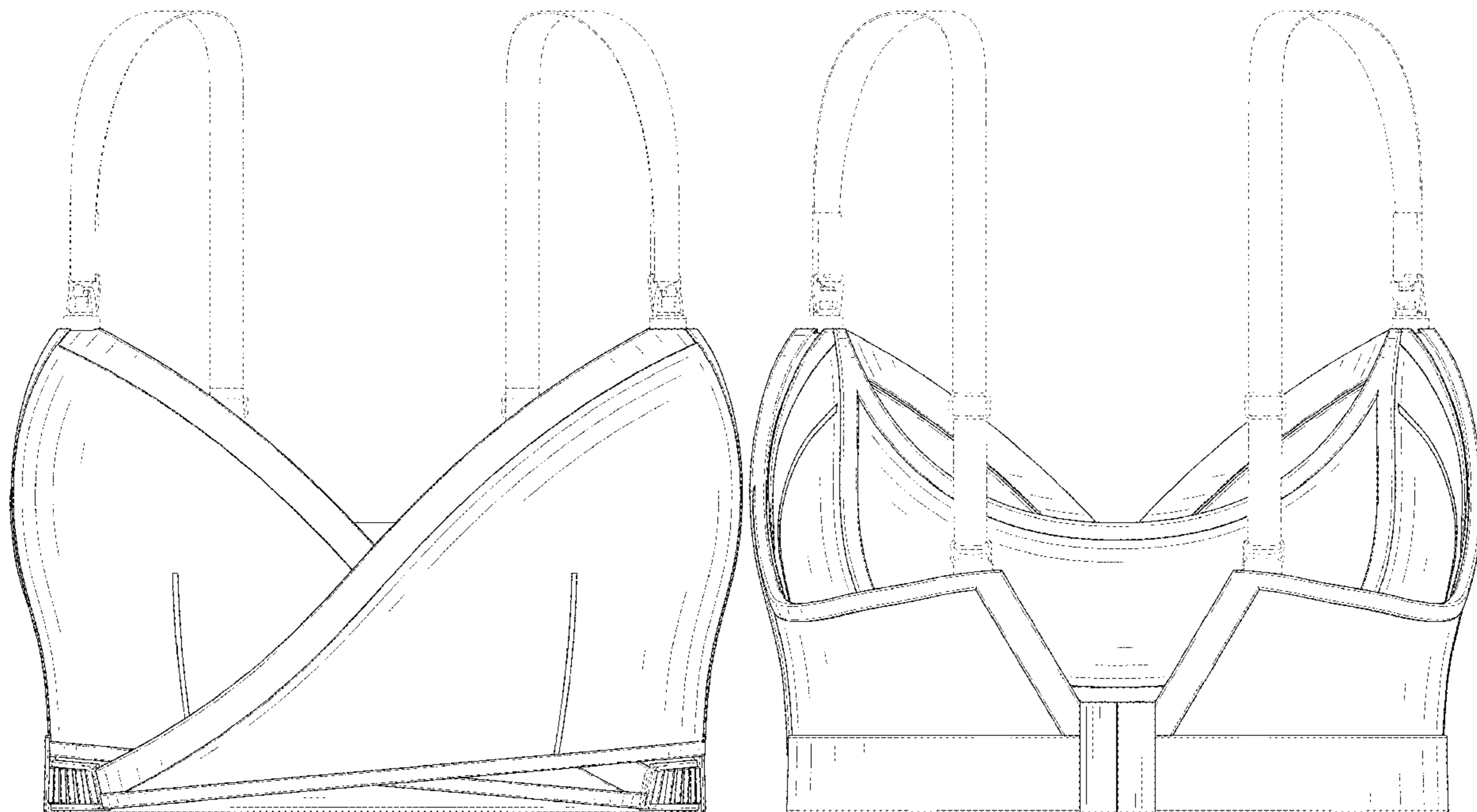
The ornamental design for a pumping and nursing bra, as shown and described.

**DESCRIPTION**

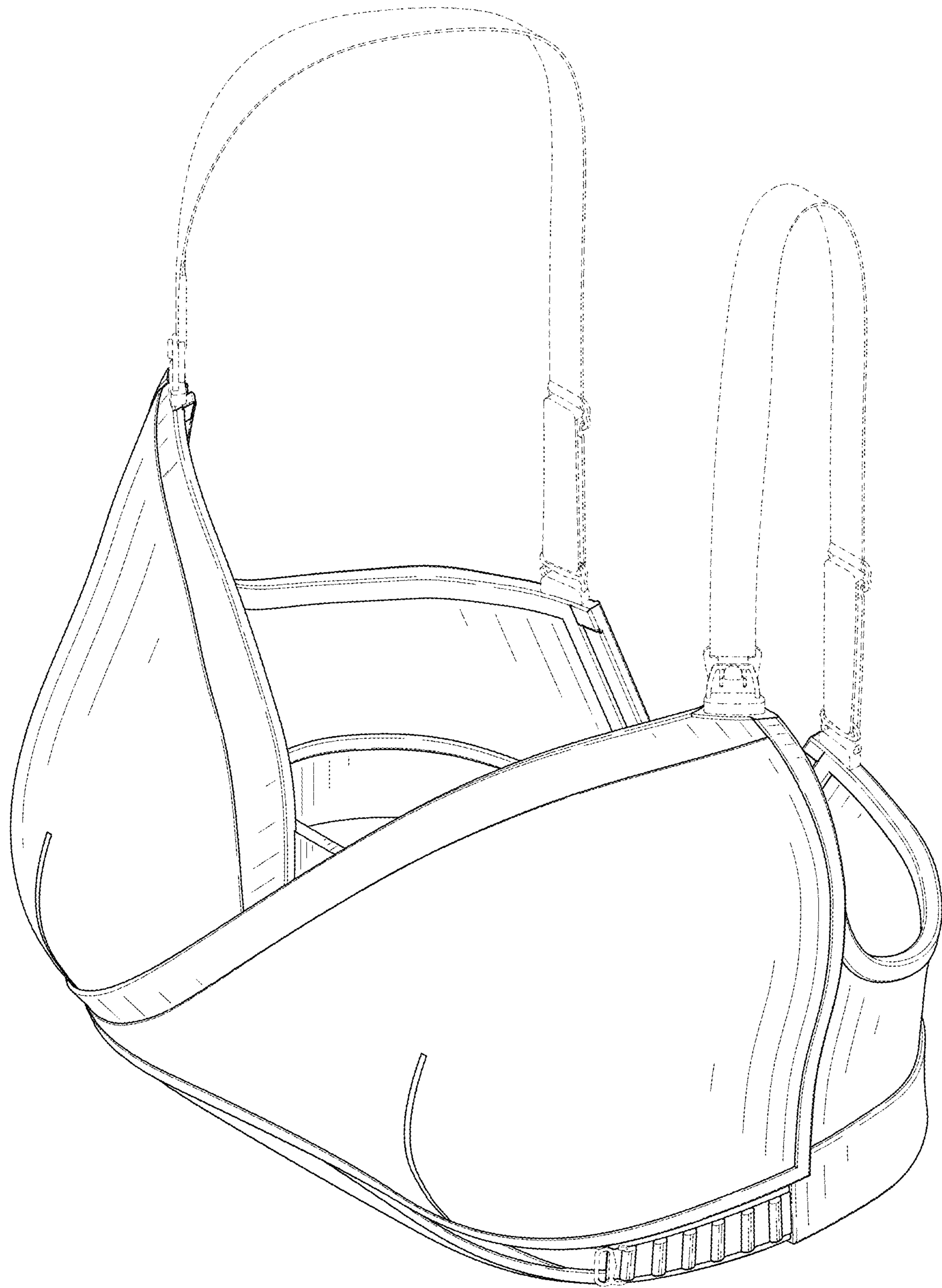

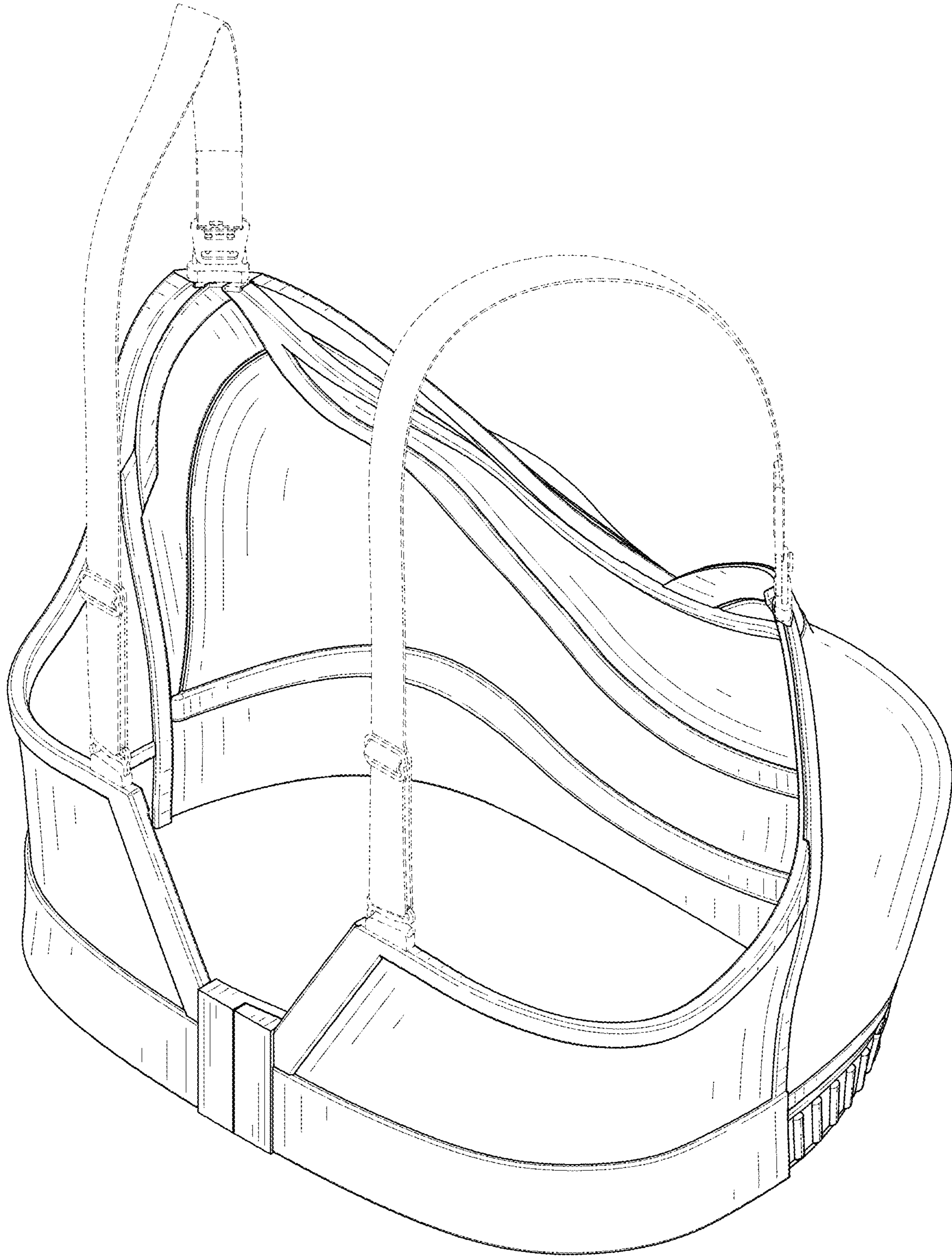

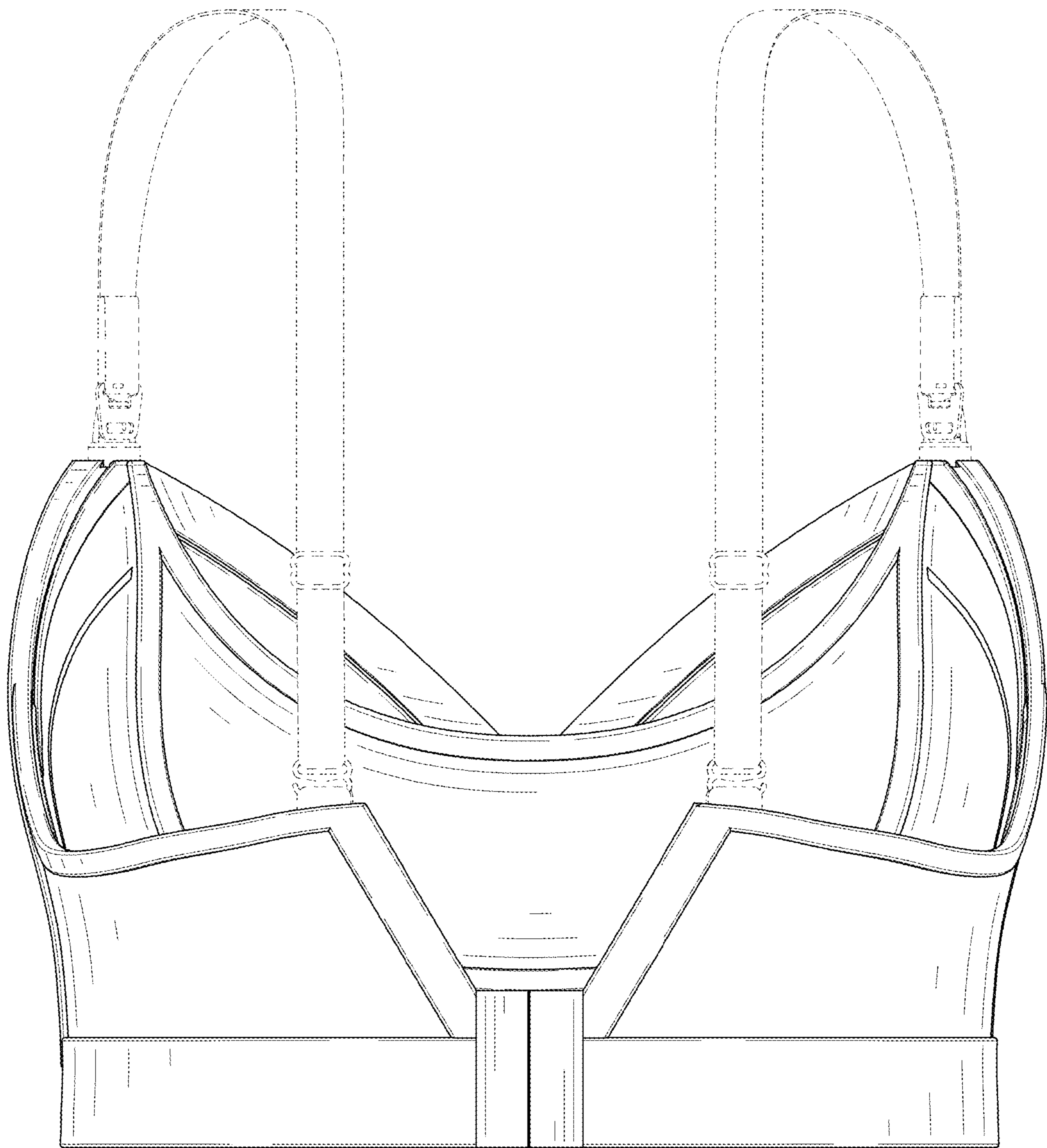

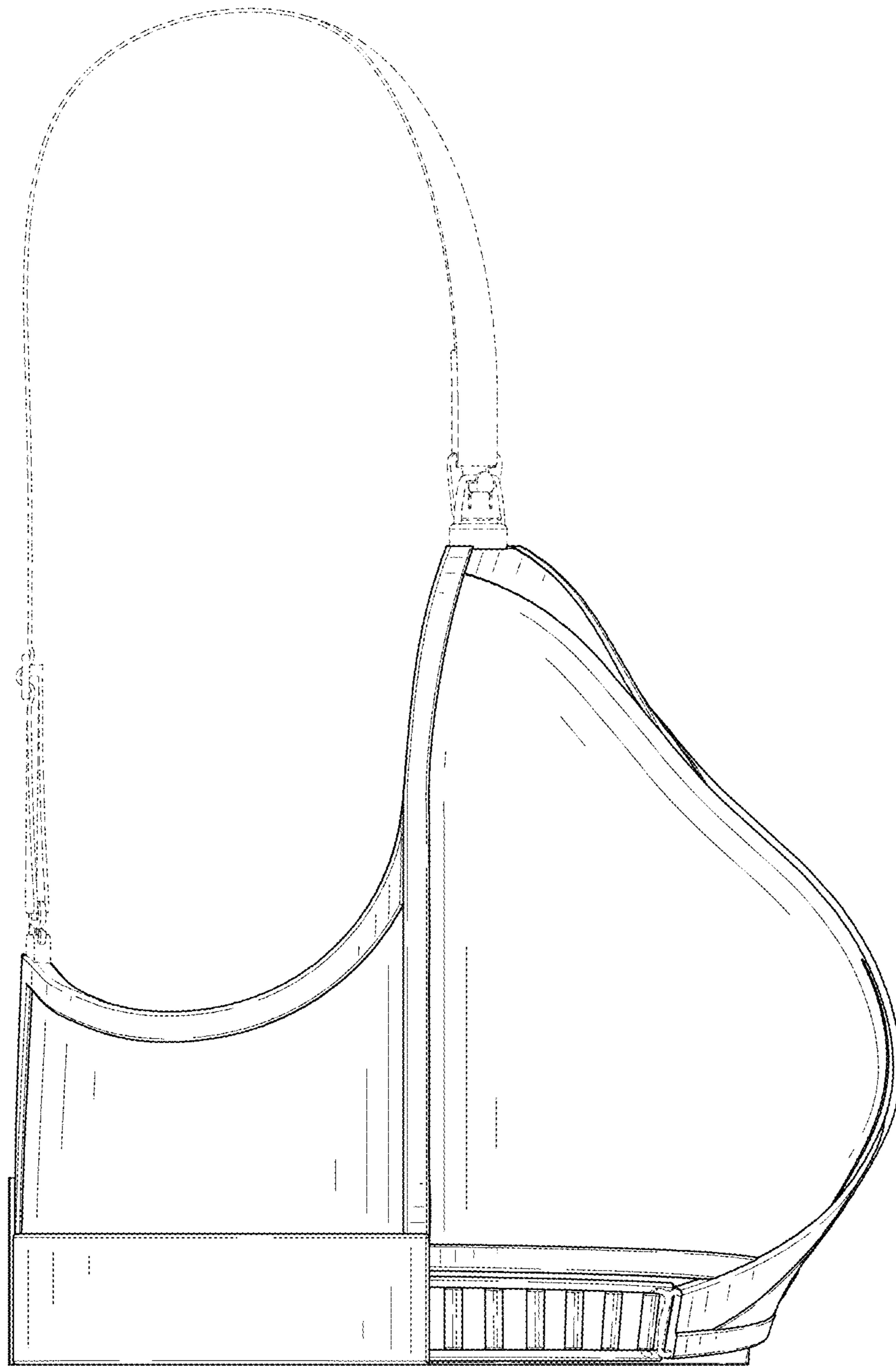

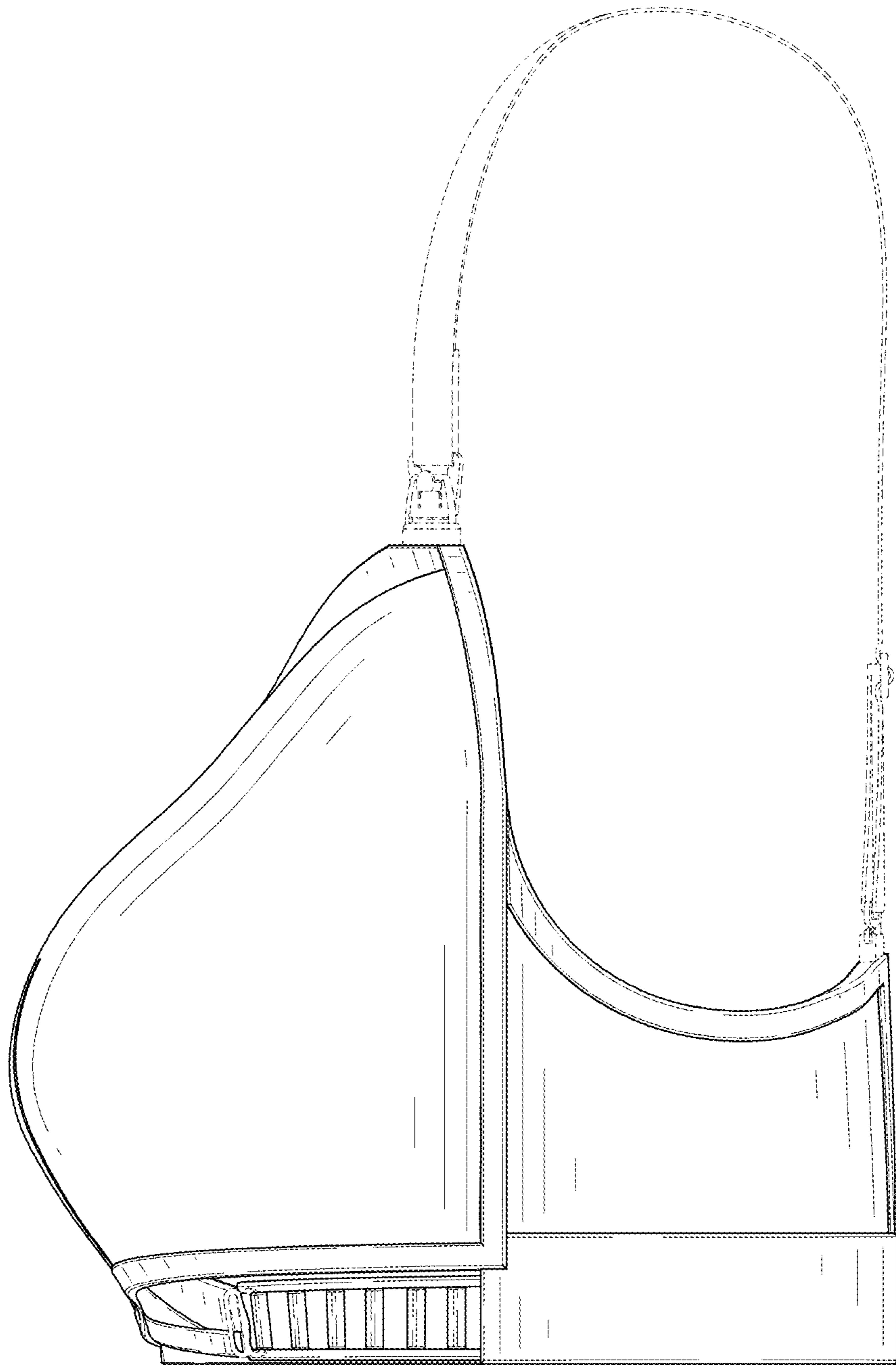

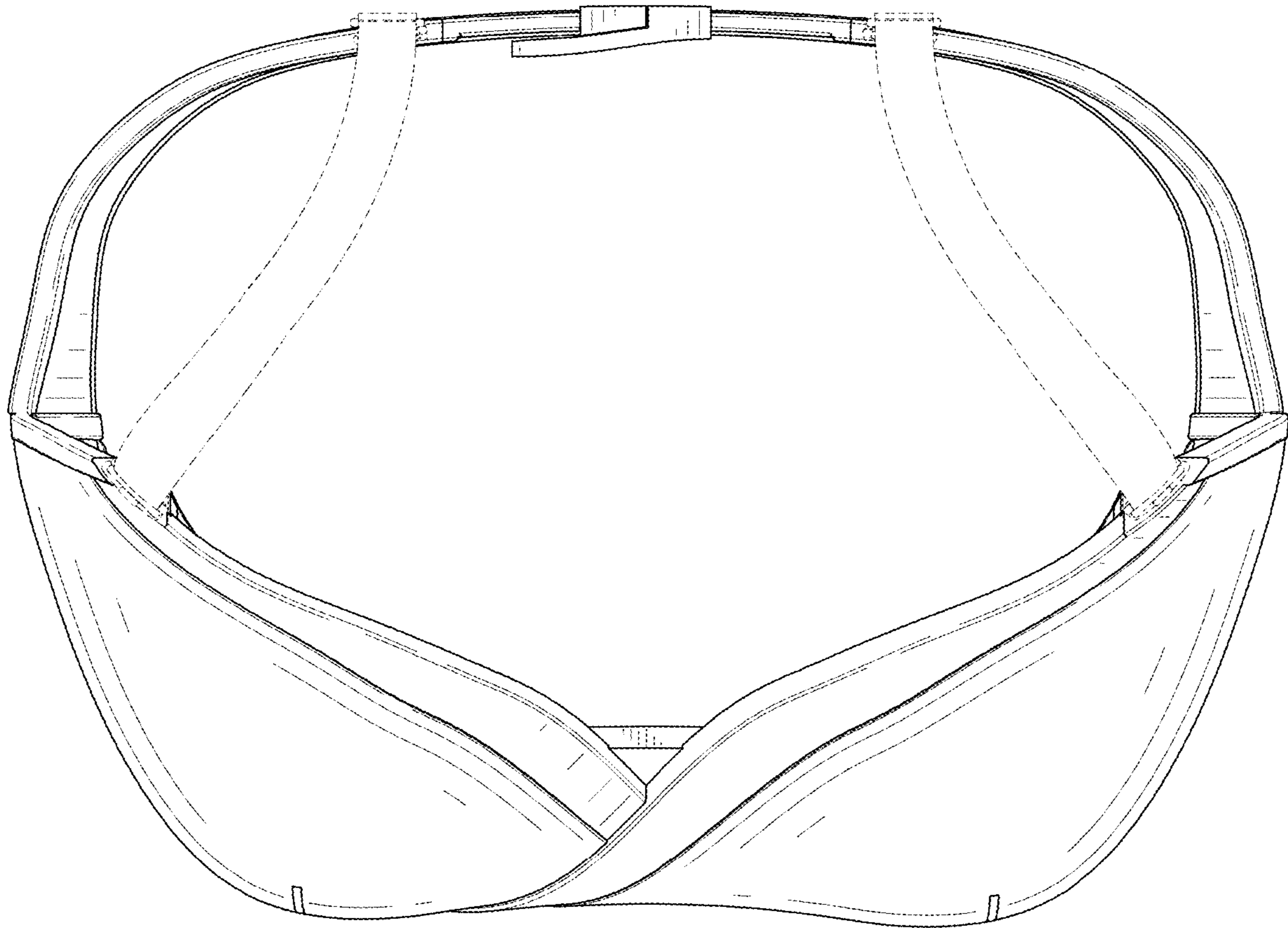

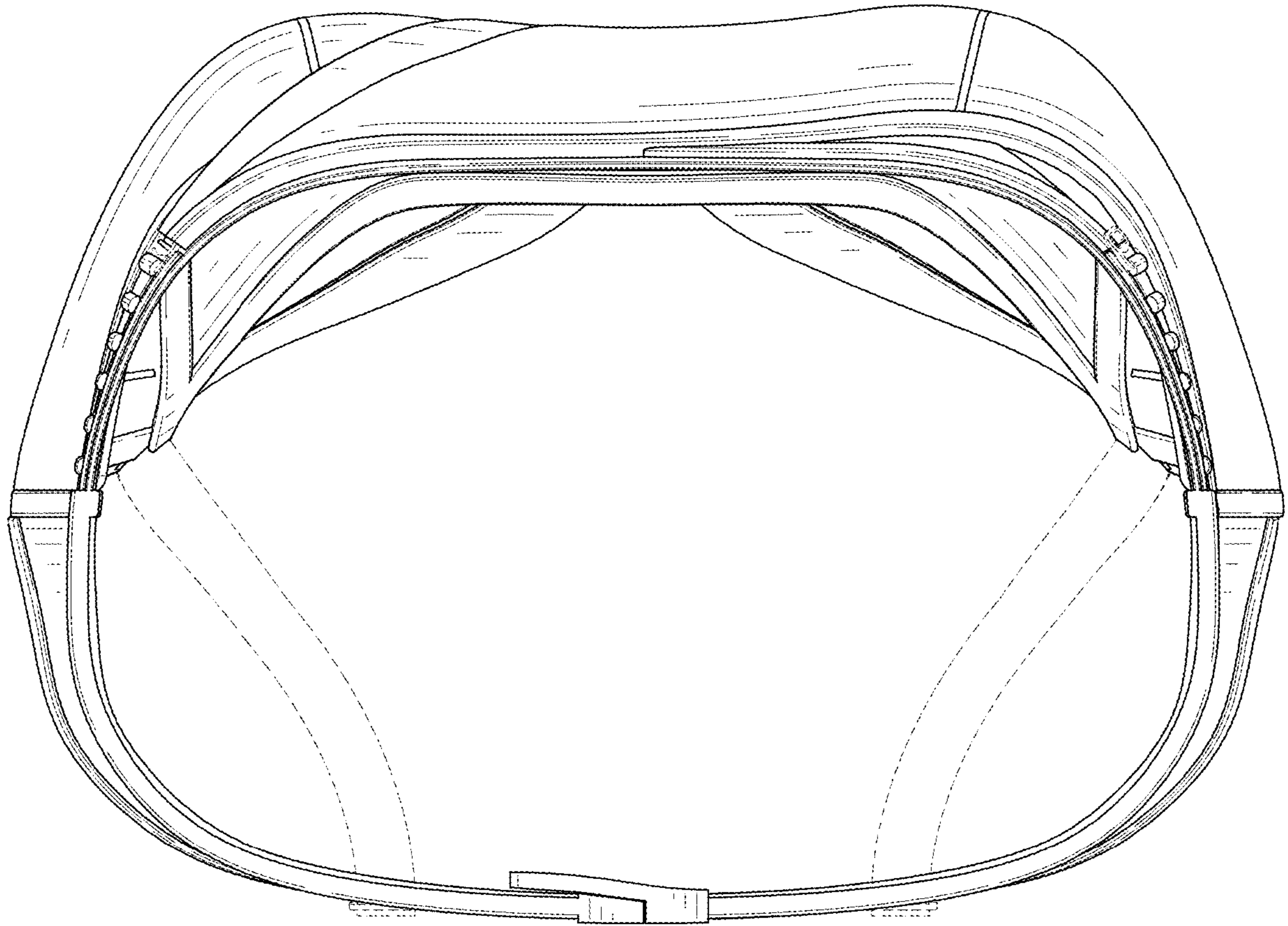
