The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing my new design;

FIG. 8 is an enlarged view of FIG. 3 with environment removed for clarity.

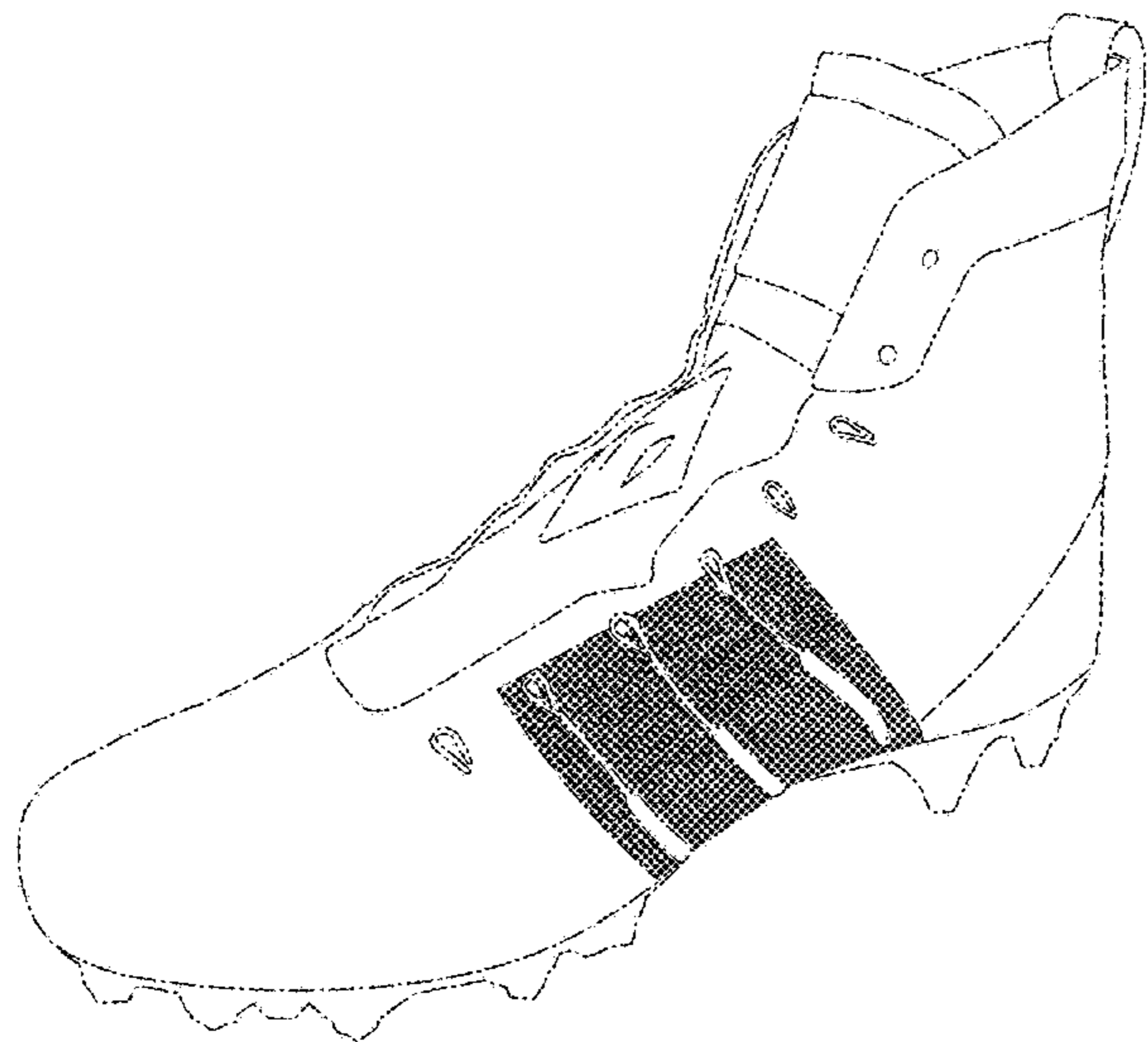

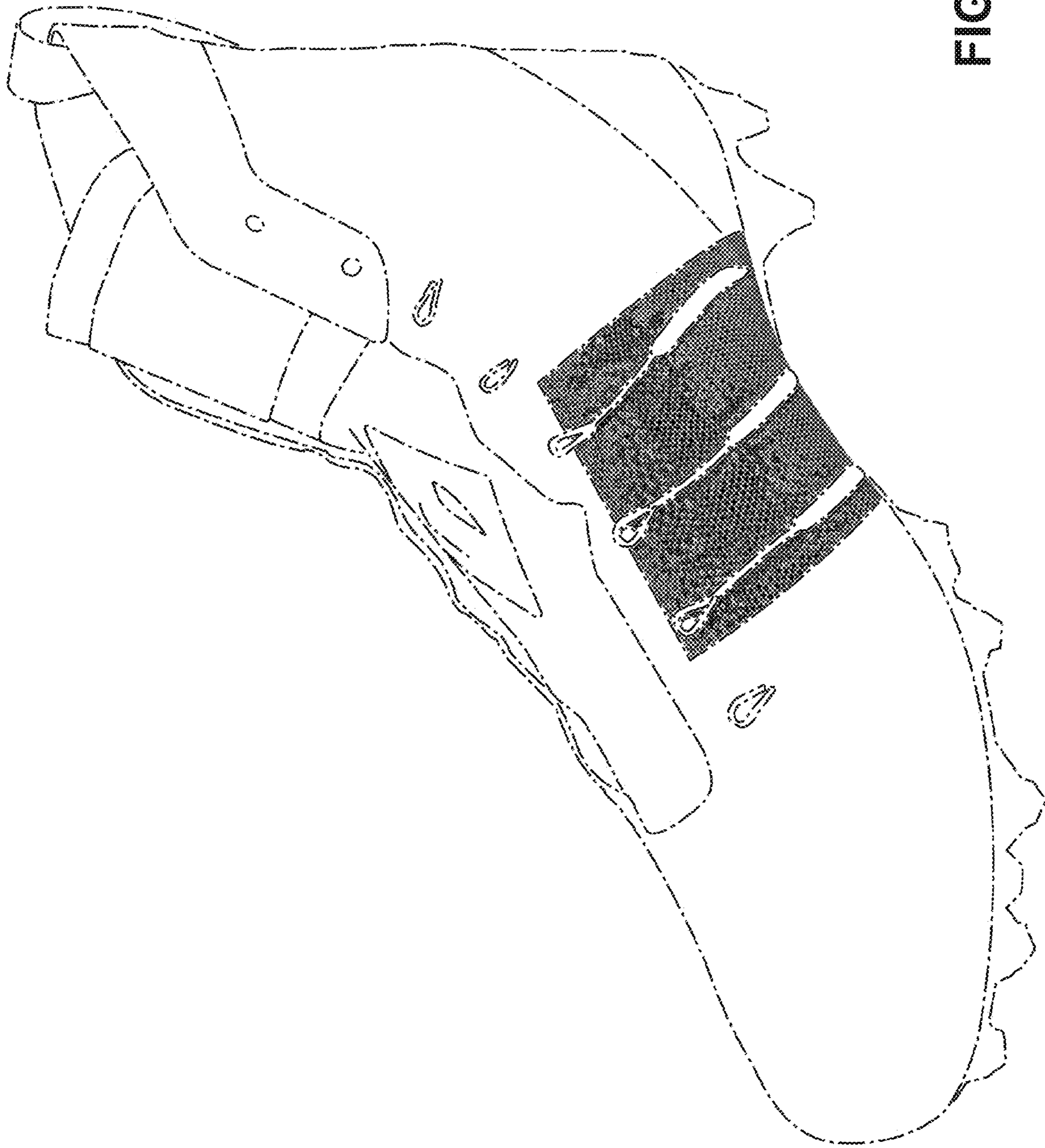

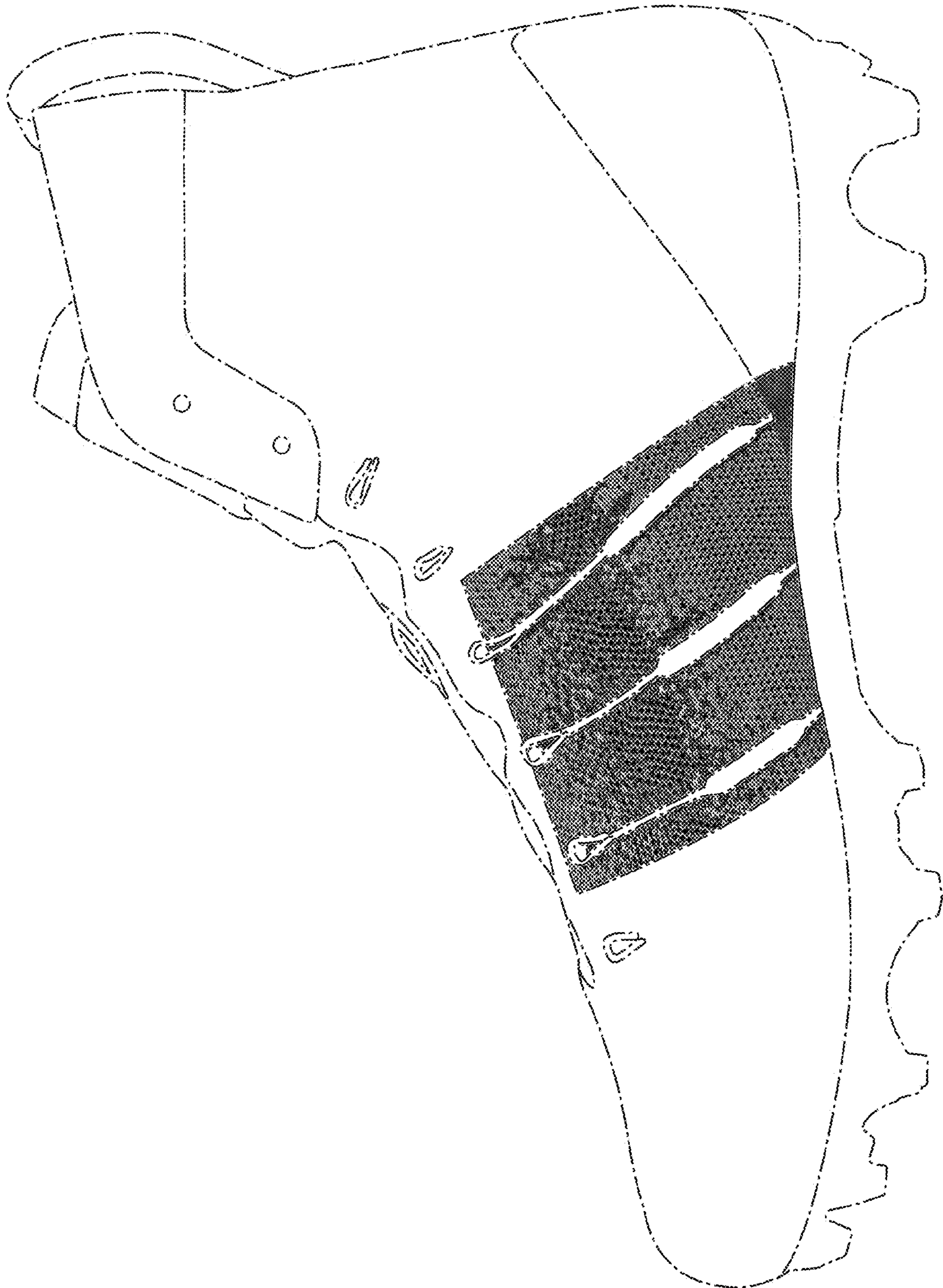
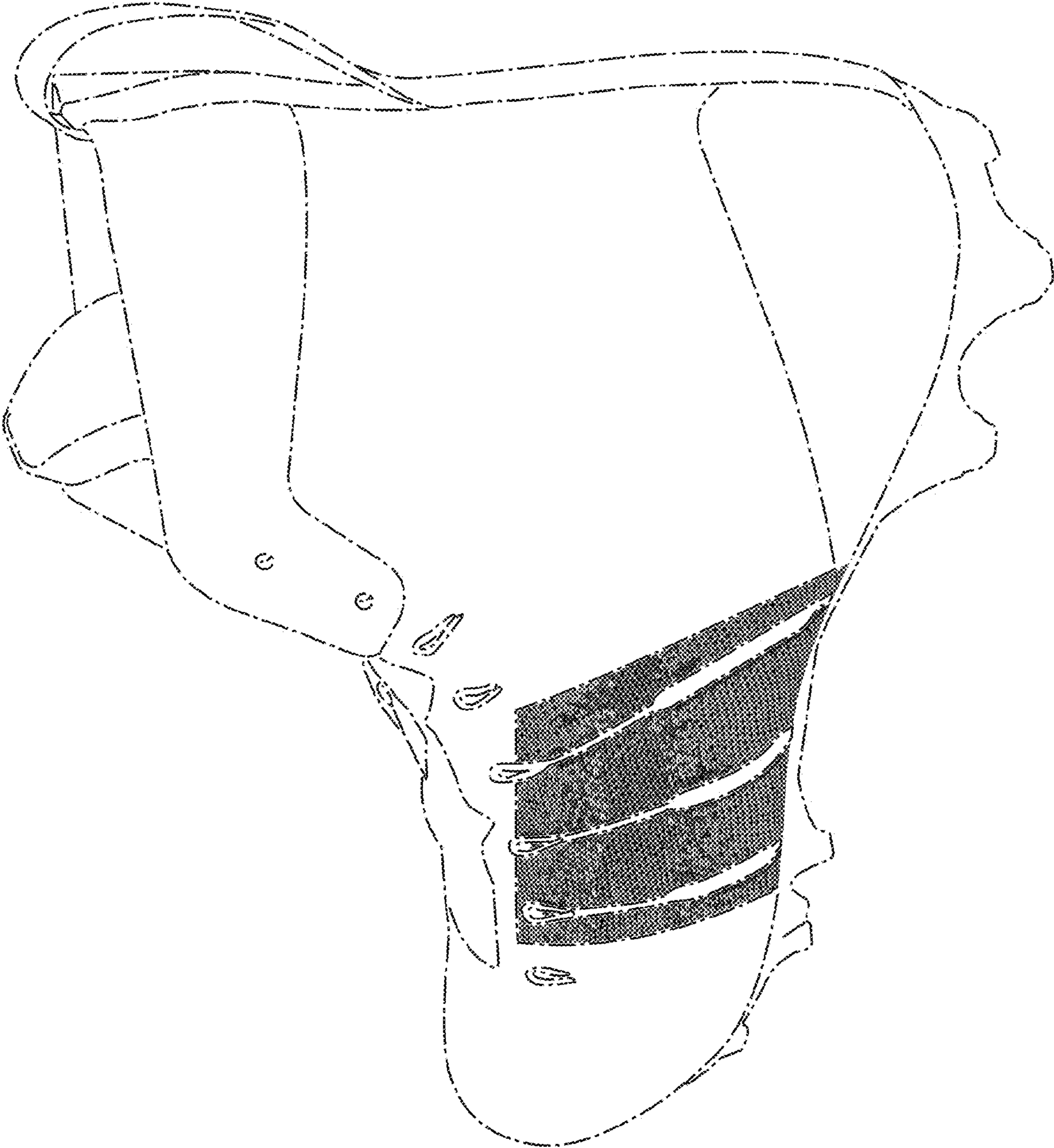

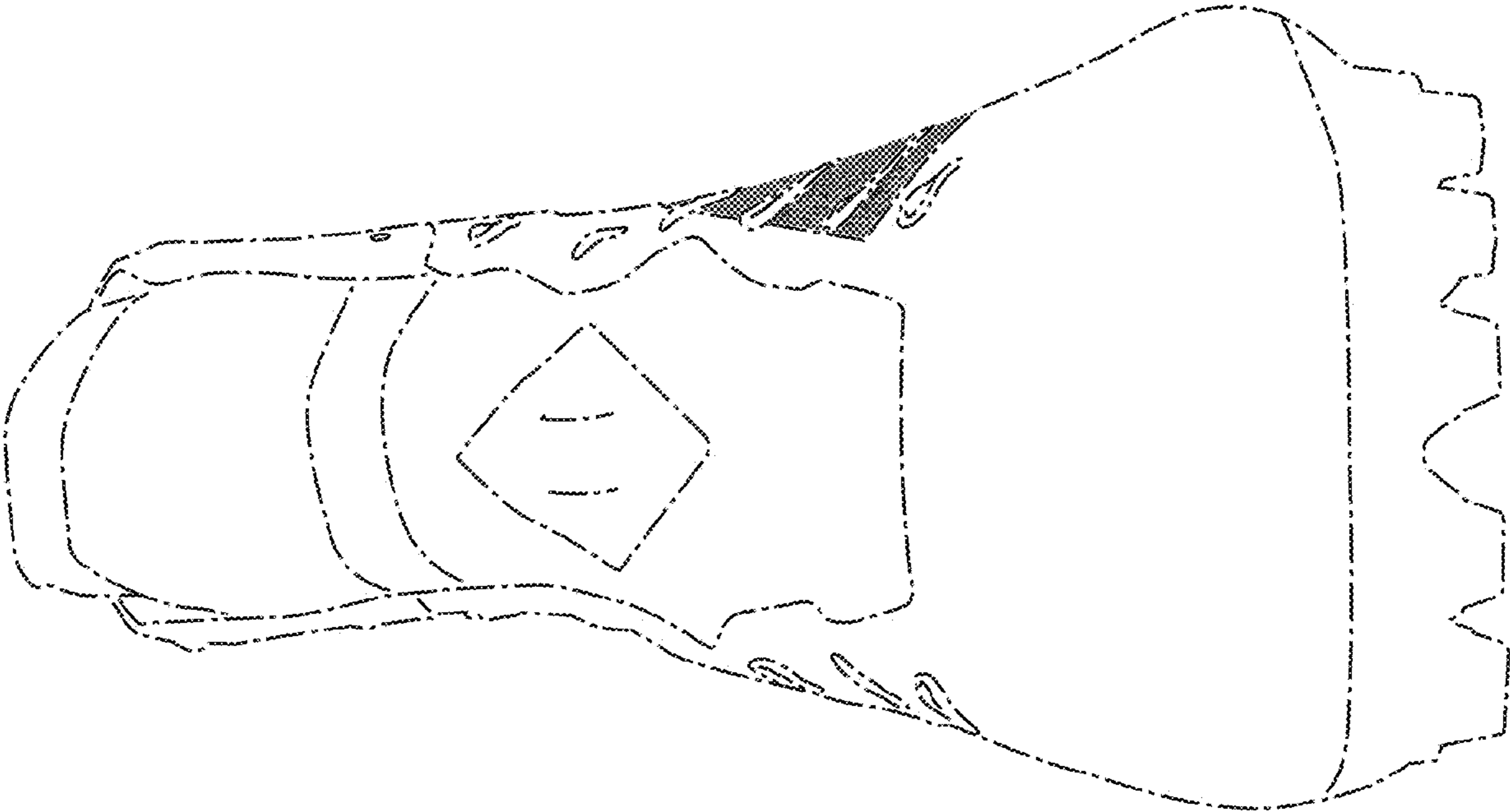

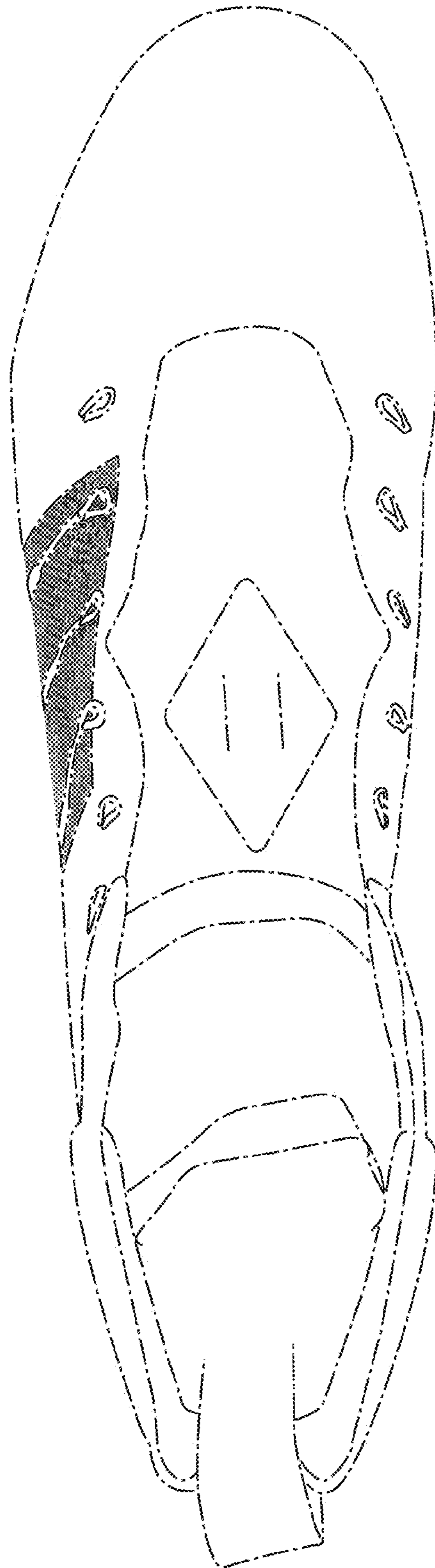

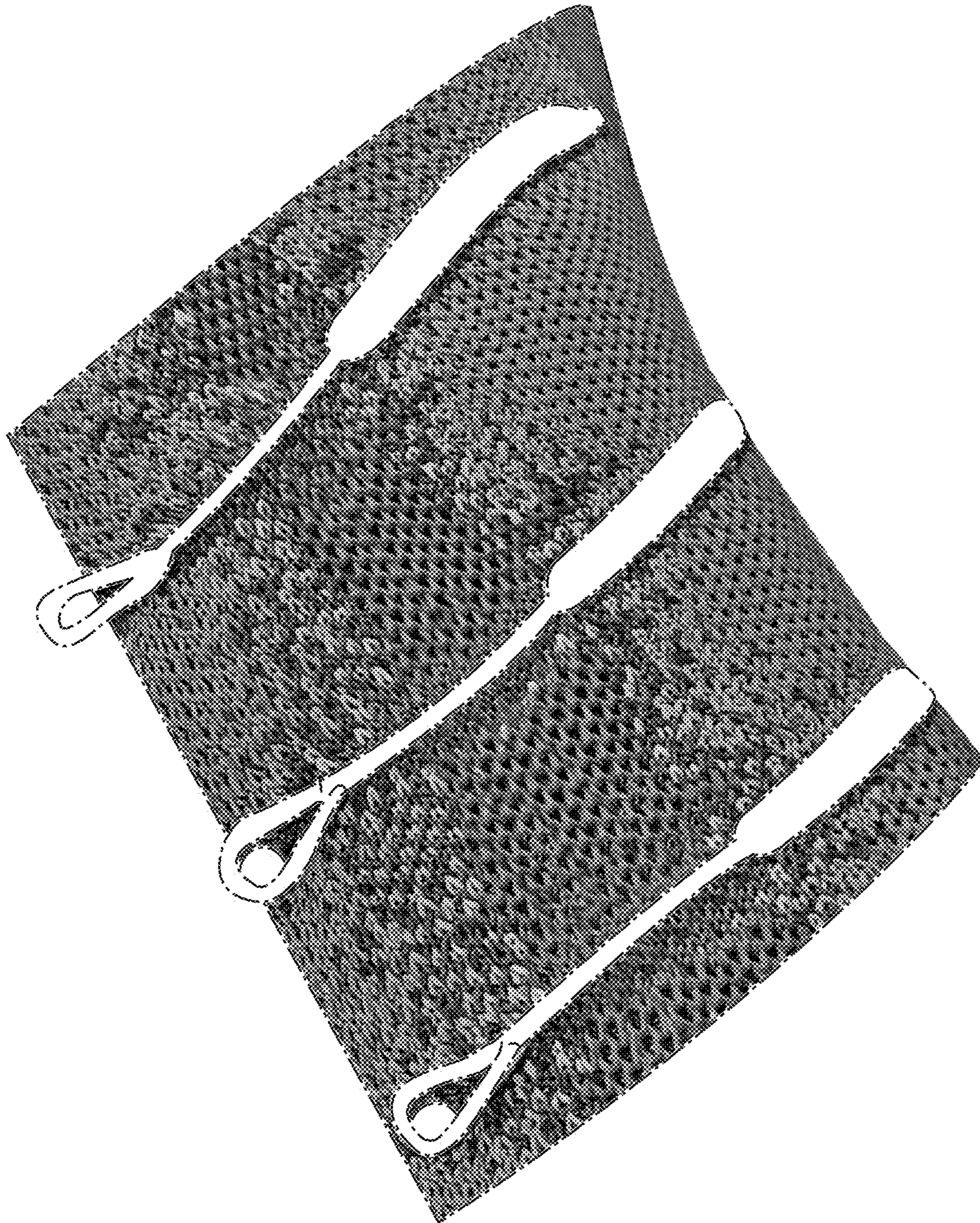

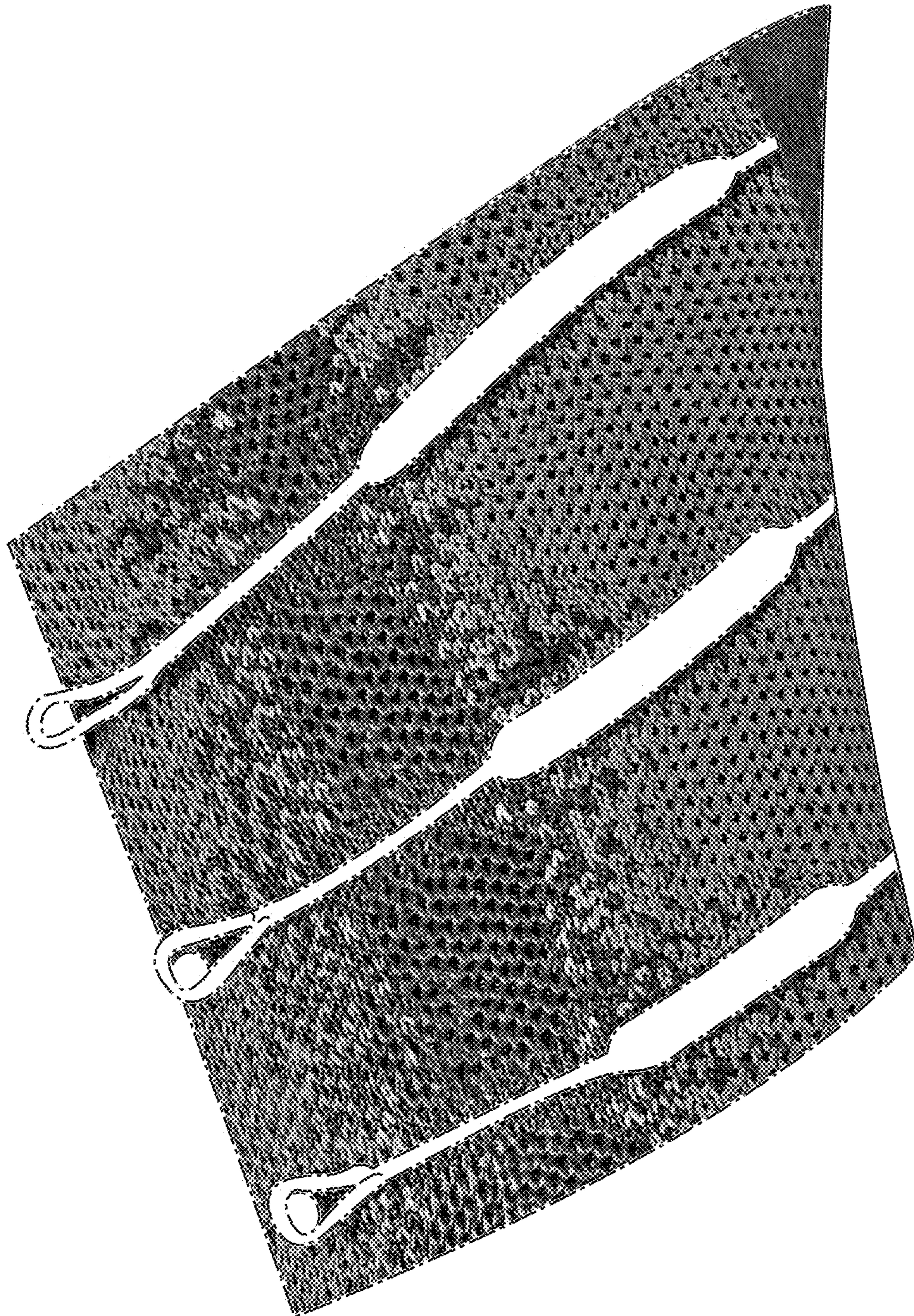

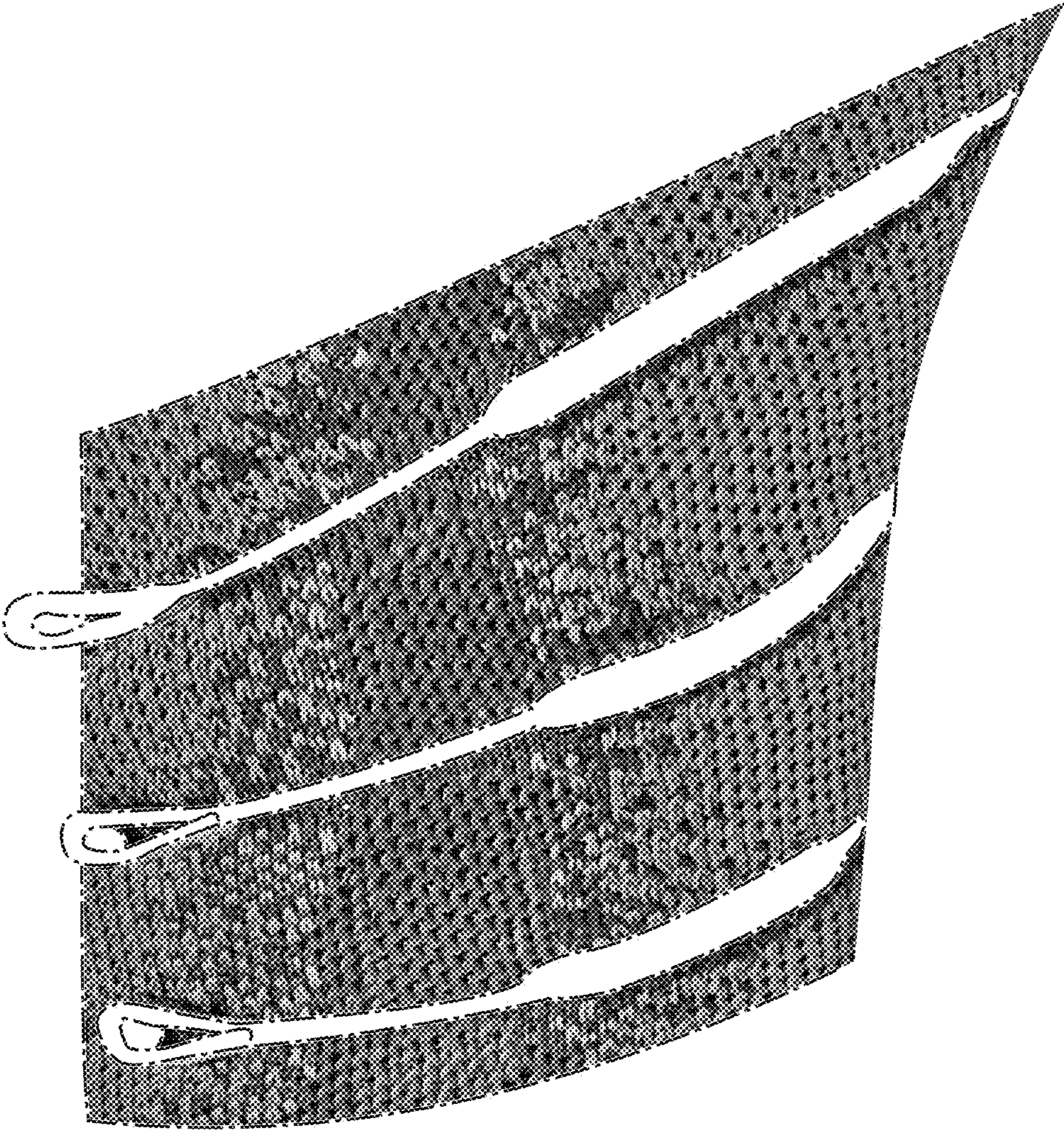
