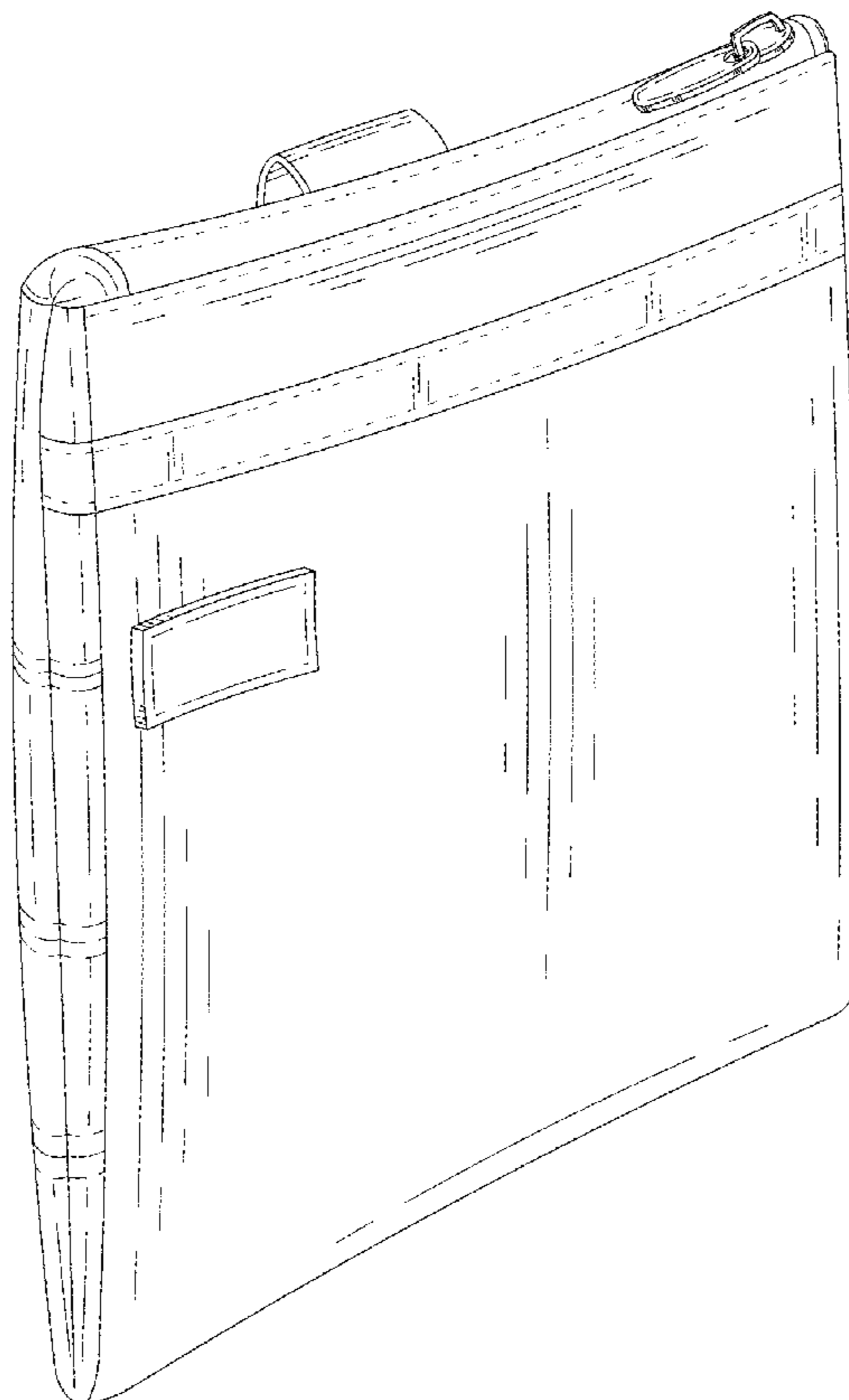
(57) **CLAIM**

I claim the ornamental design for a bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bag showing my new design;
FIG. 2 is top plan view of the bag shown open;
FIG. 3 is another top plan view thereof;
FIG. 4 is a front elevation view;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a left-side view of the bag as shown in FIG. 1;
FIG. 7 is a right-side view of the bag as shown in FIG. 1;

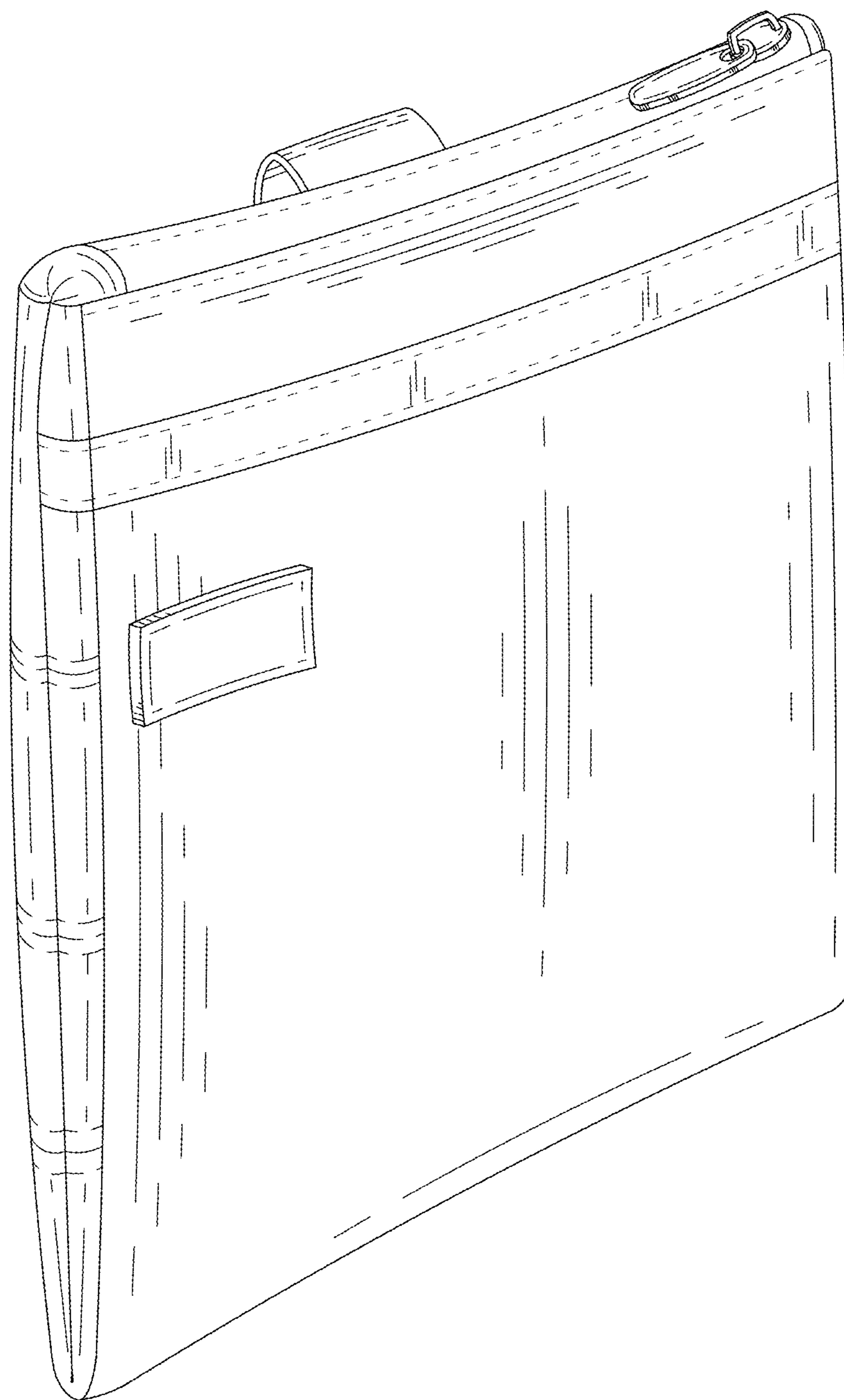

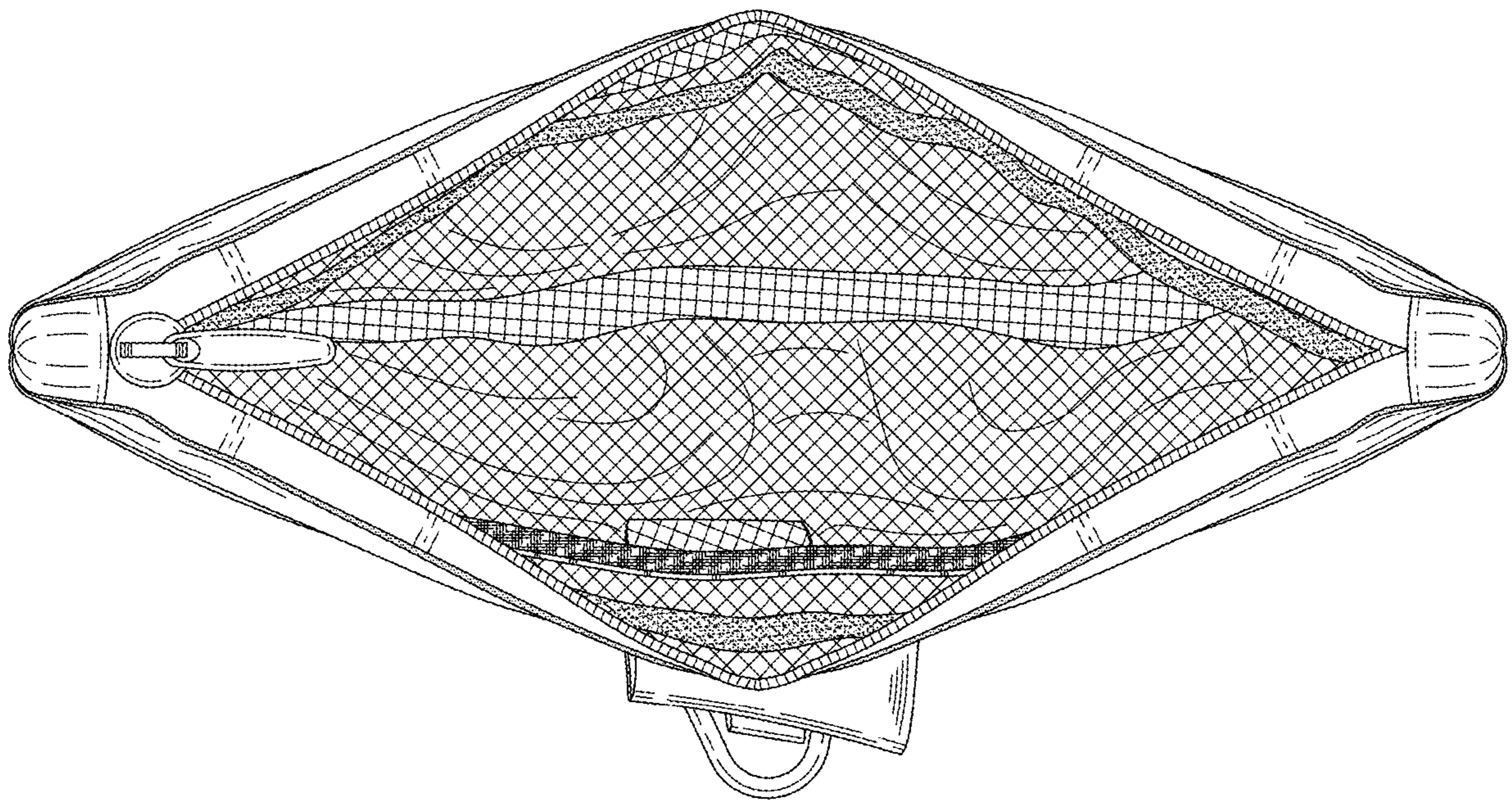

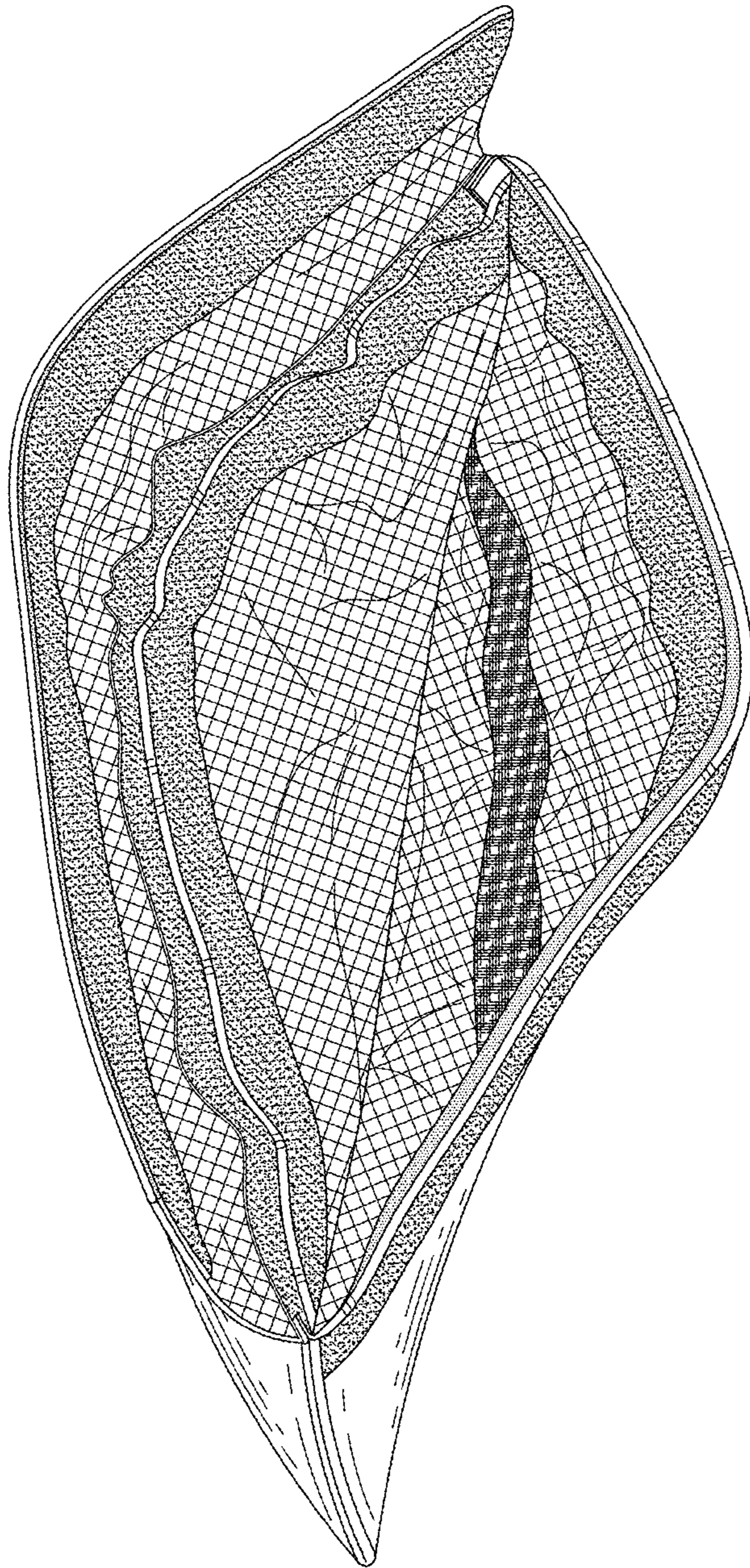

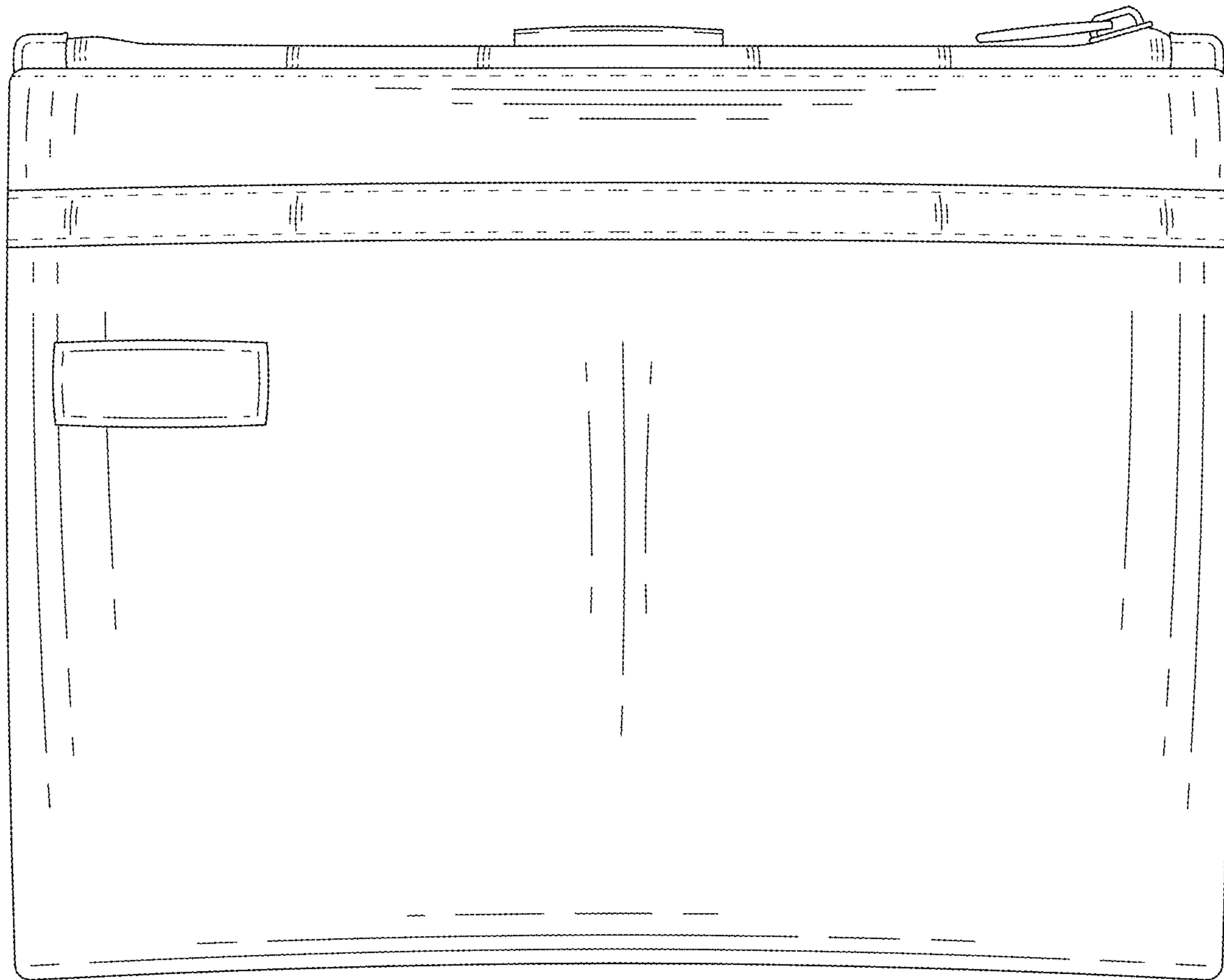

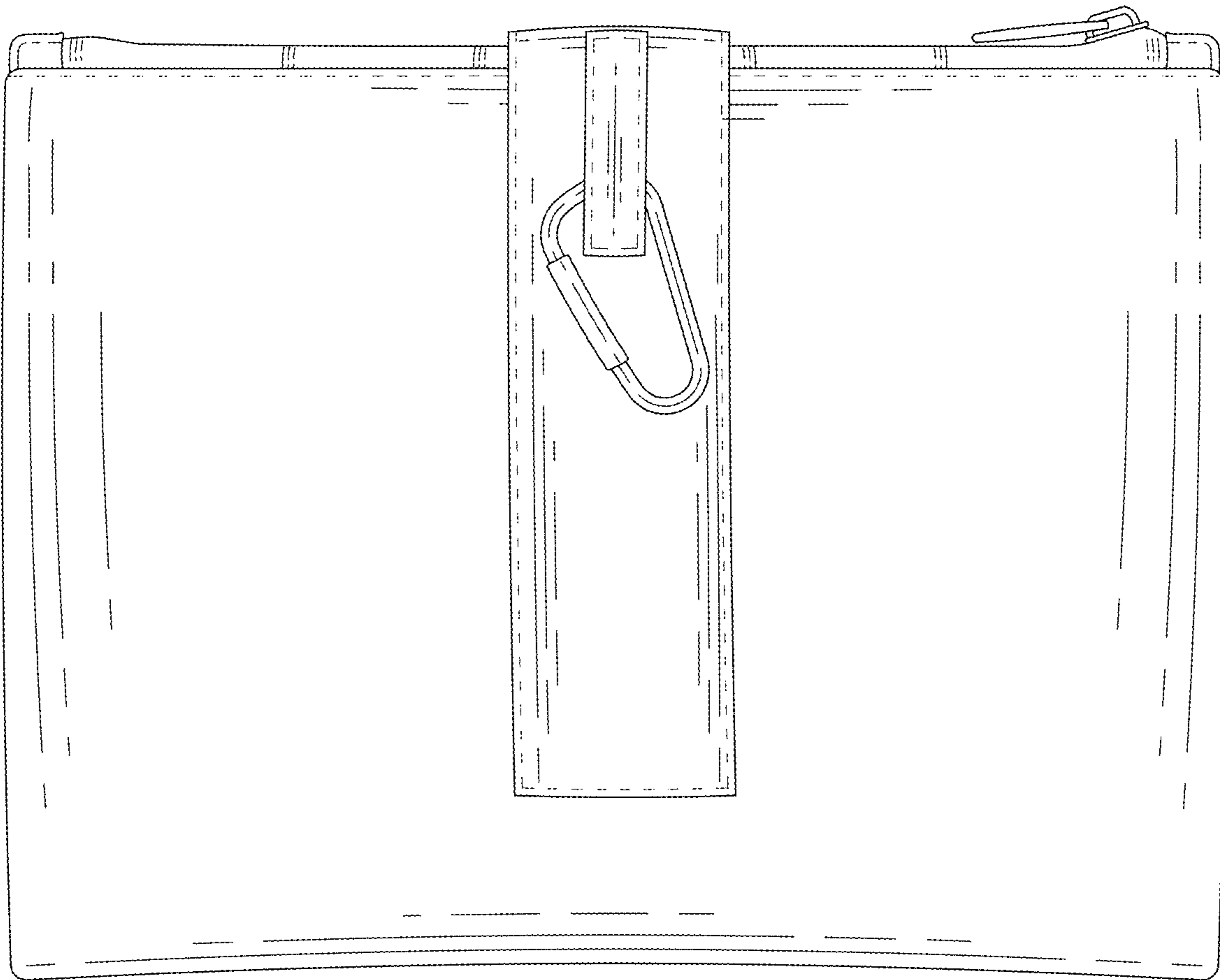

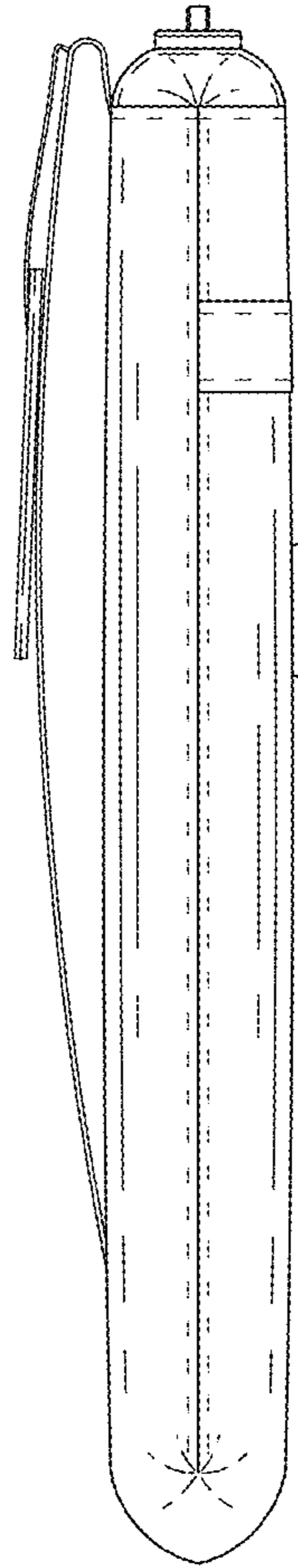

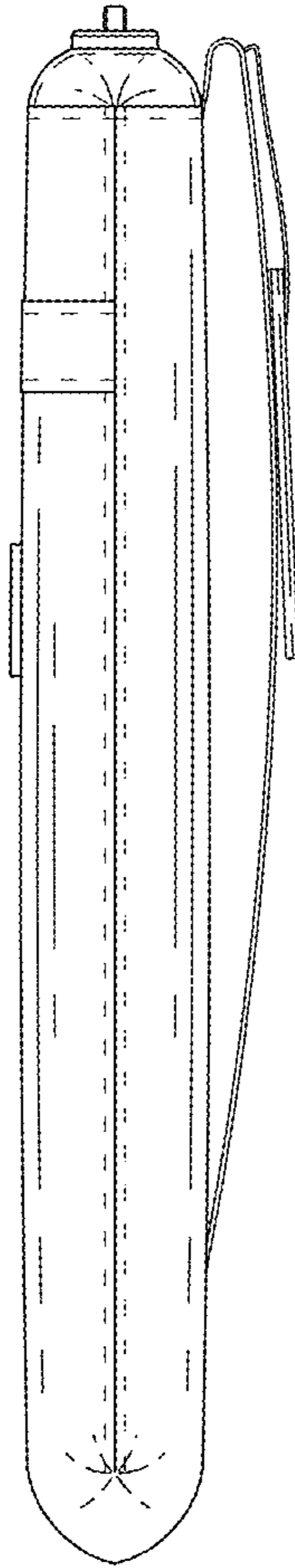

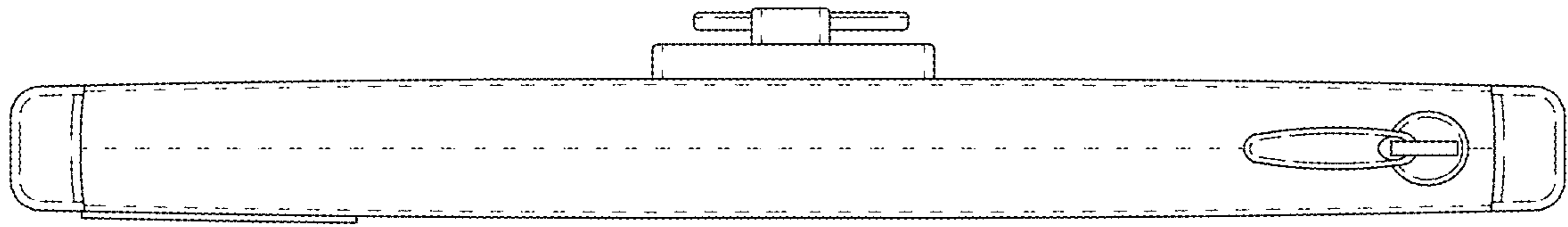

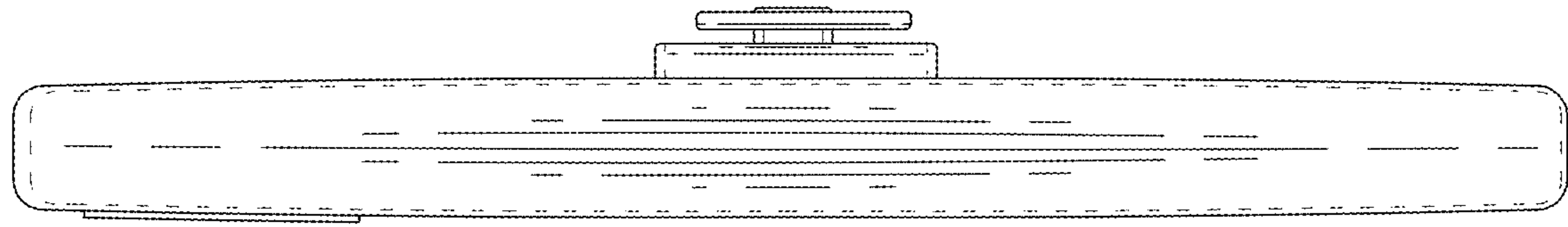
