(57) **CLAIM**

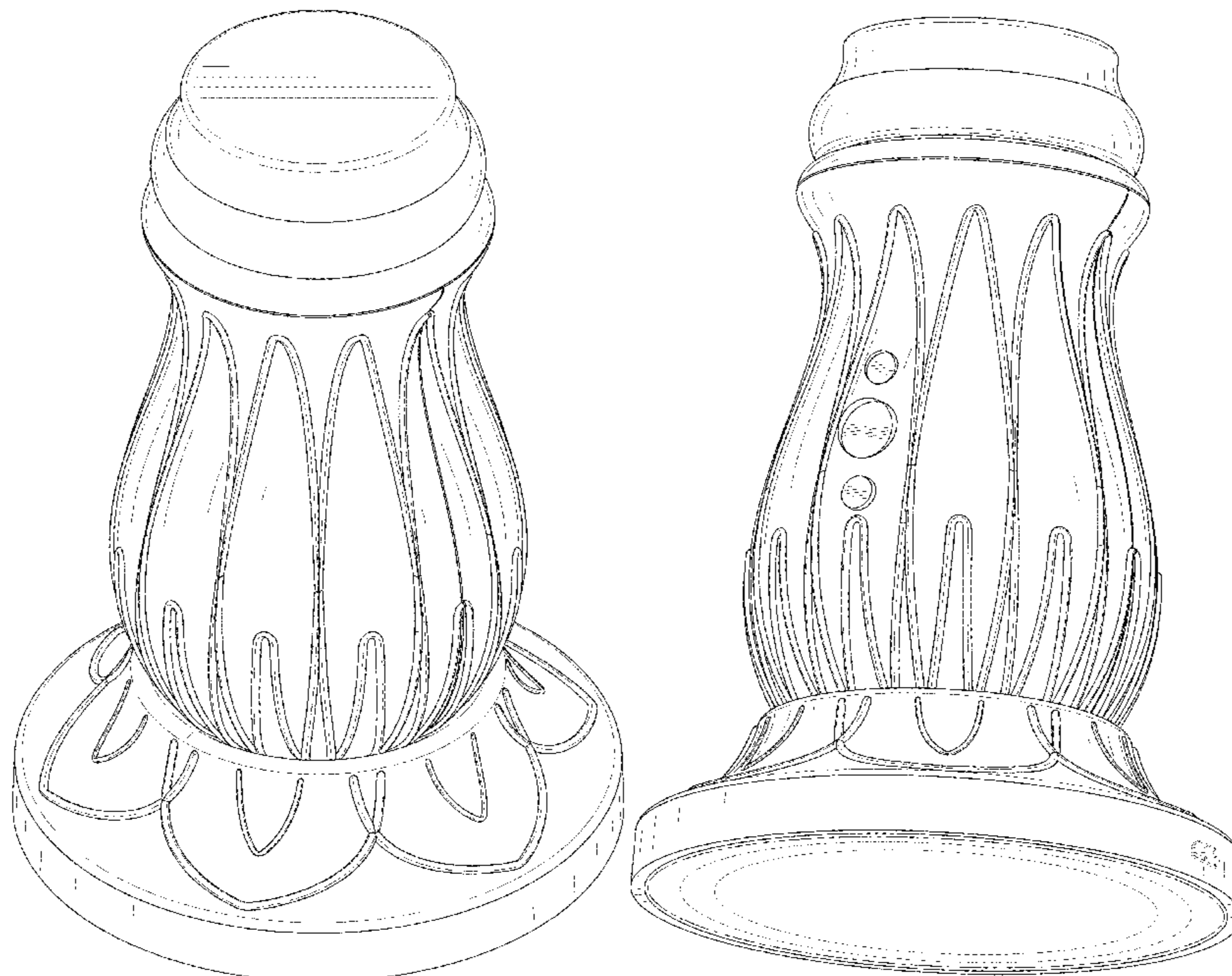
The ornamental design for a facial cleansing brush, as shown and described.

DESCRIPTION

FIG. 1 is a back and top perspective view of a facial cleansing brush, showing my new design;
FIG. 2 is a front and bottom perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

The broken lines in the figures illustrate portions of the facial cleansing brush that form no part of the claimed design. The dot-dash-dot line shown in FIGS. 2 and 8 illustrates the bound of the claimed design and forms no part thereof.

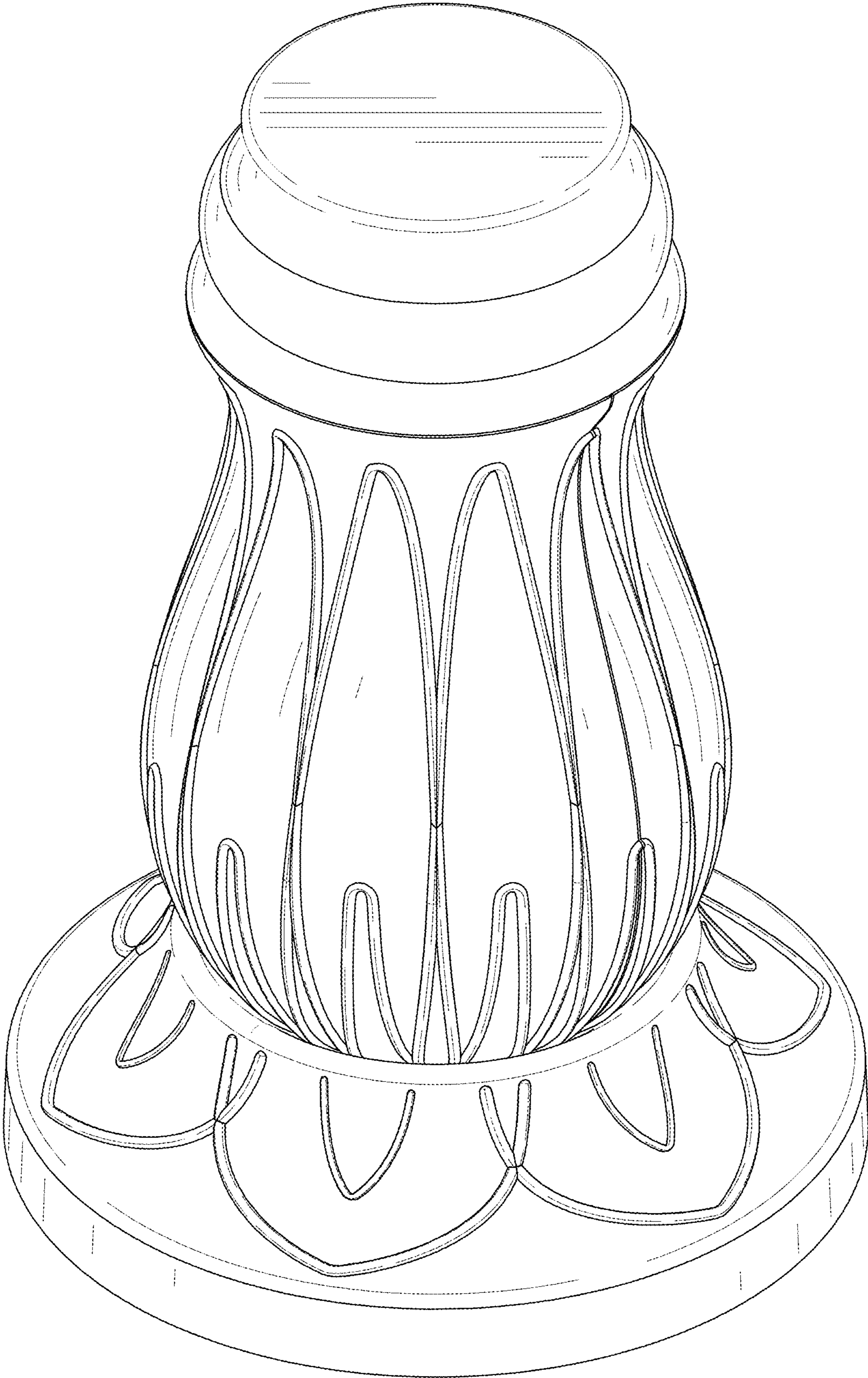

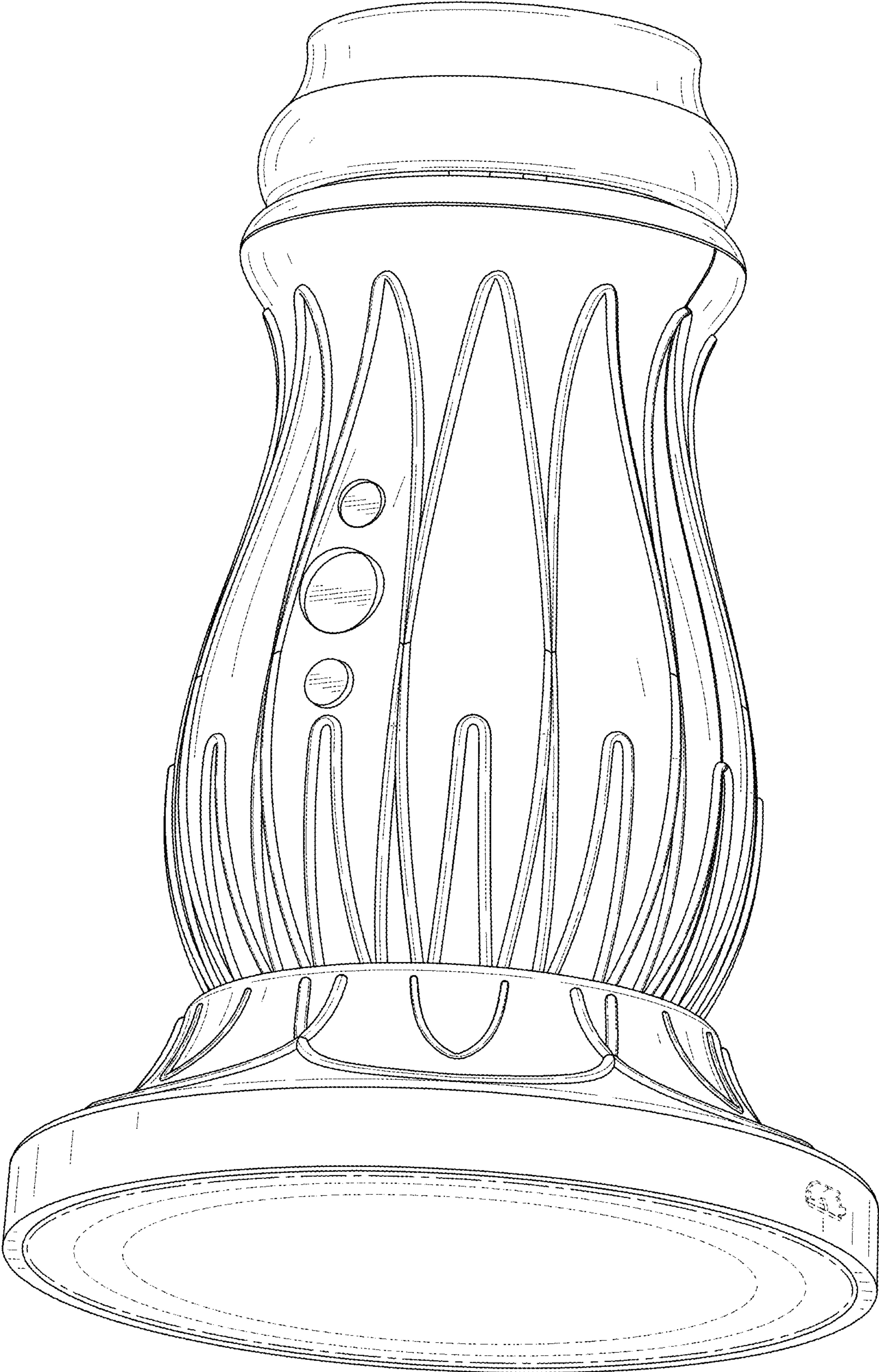

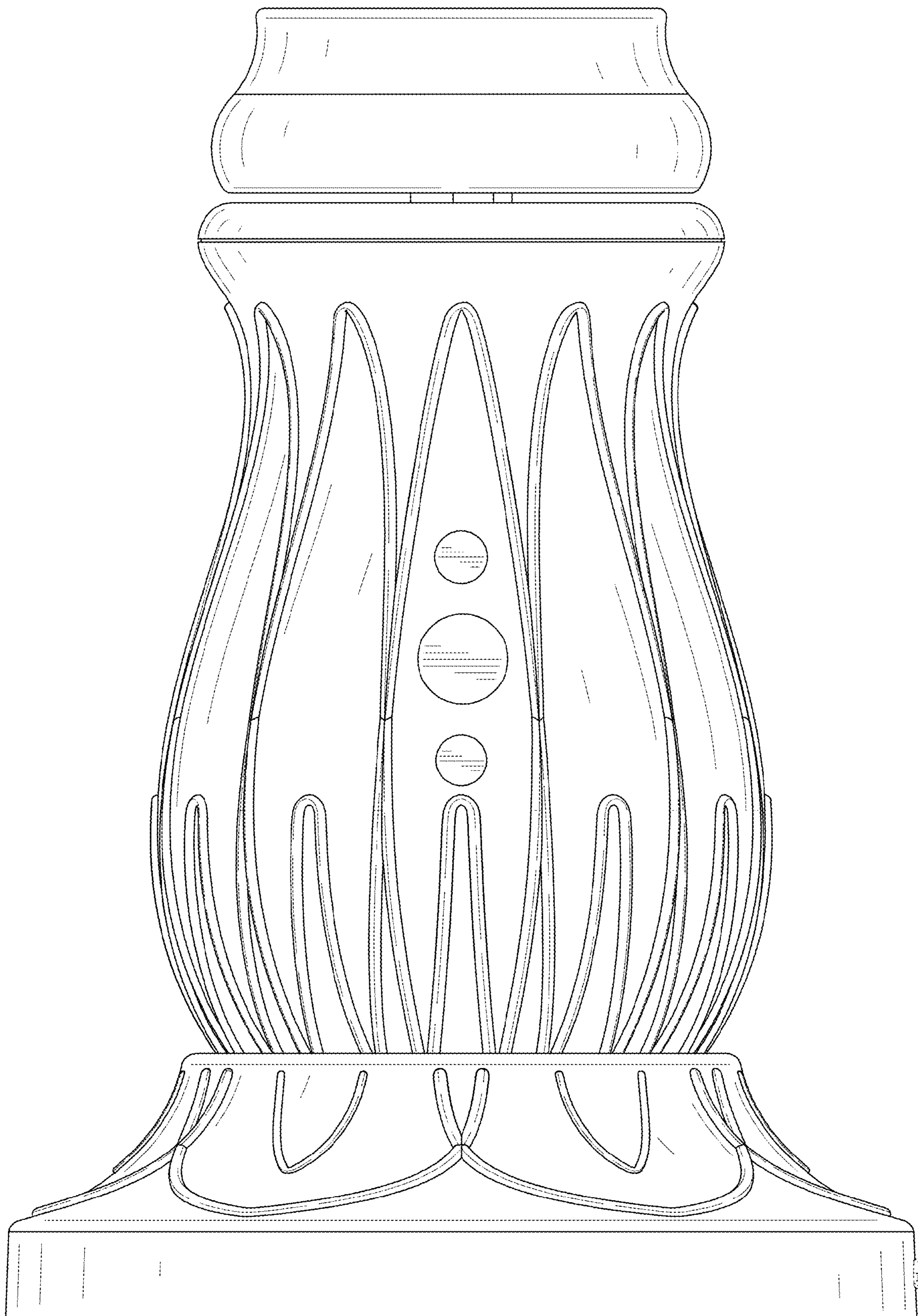

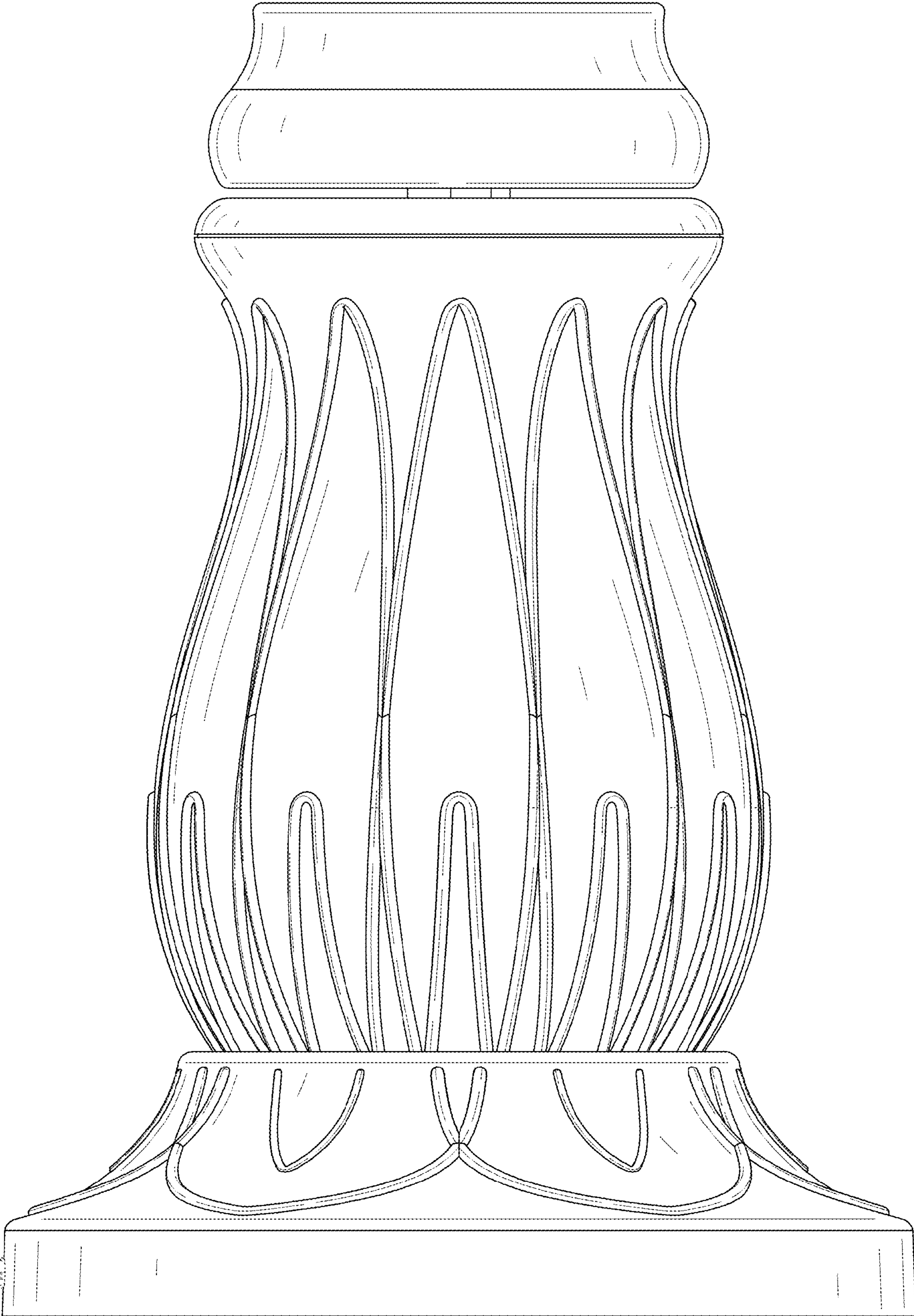

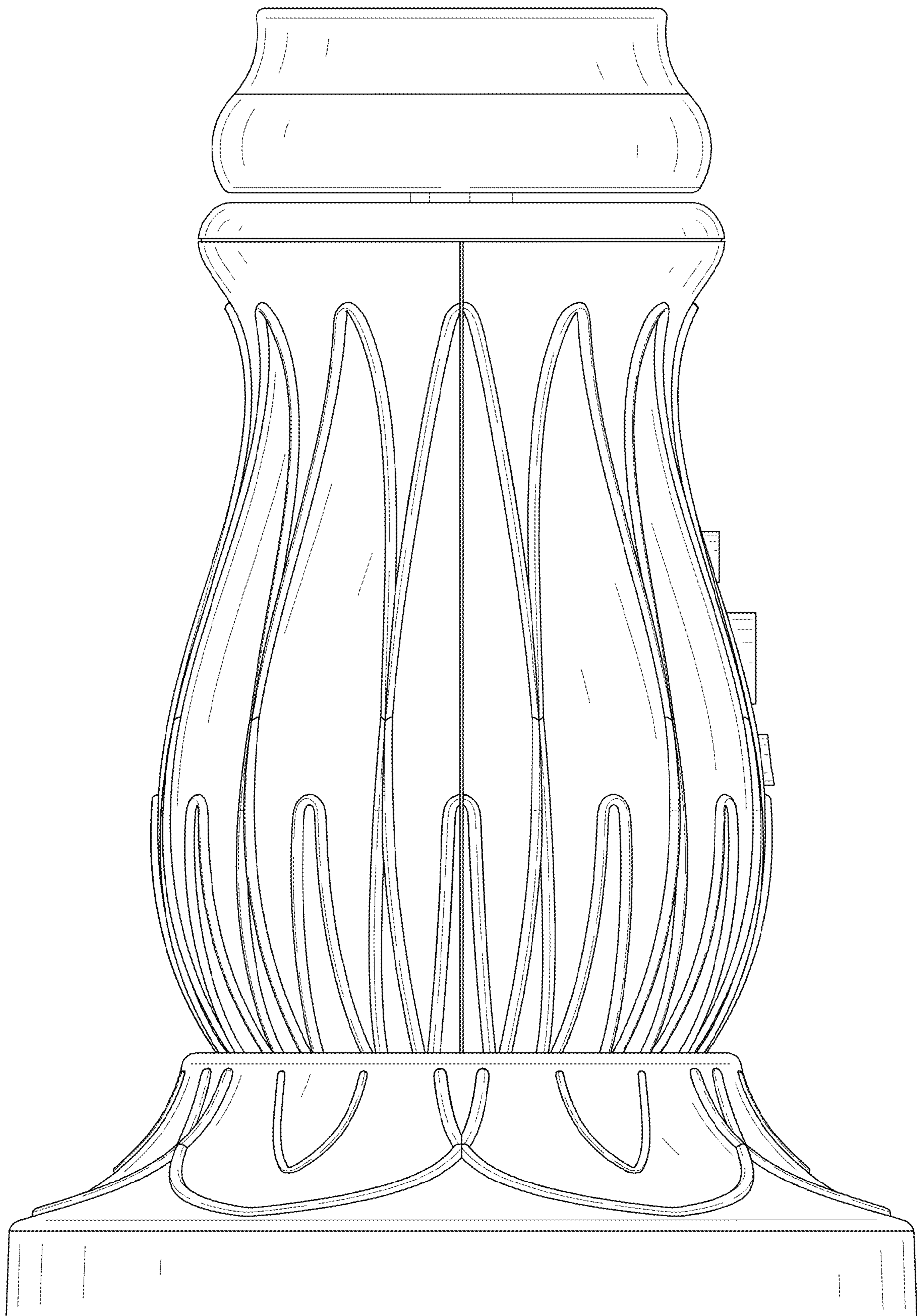

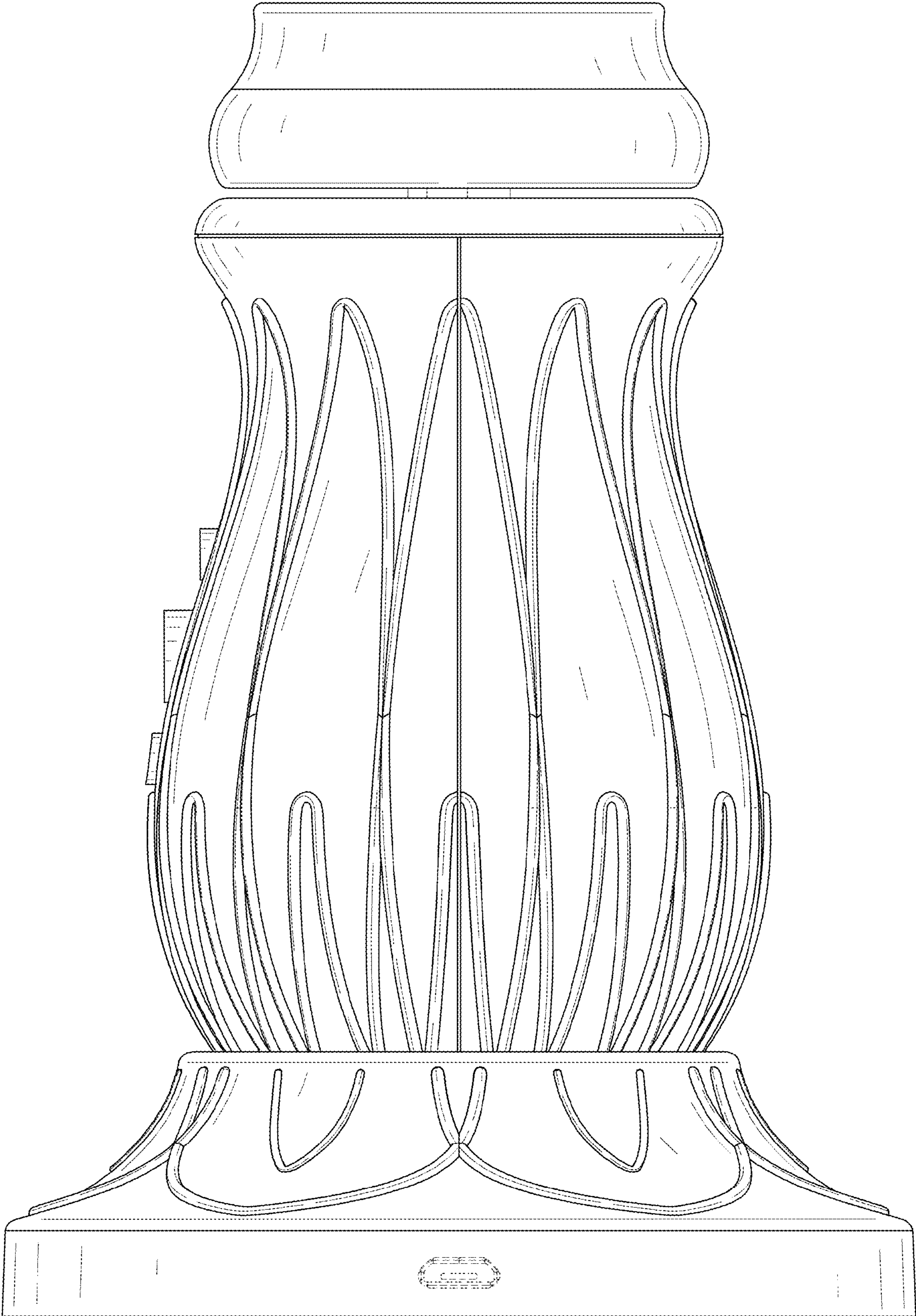

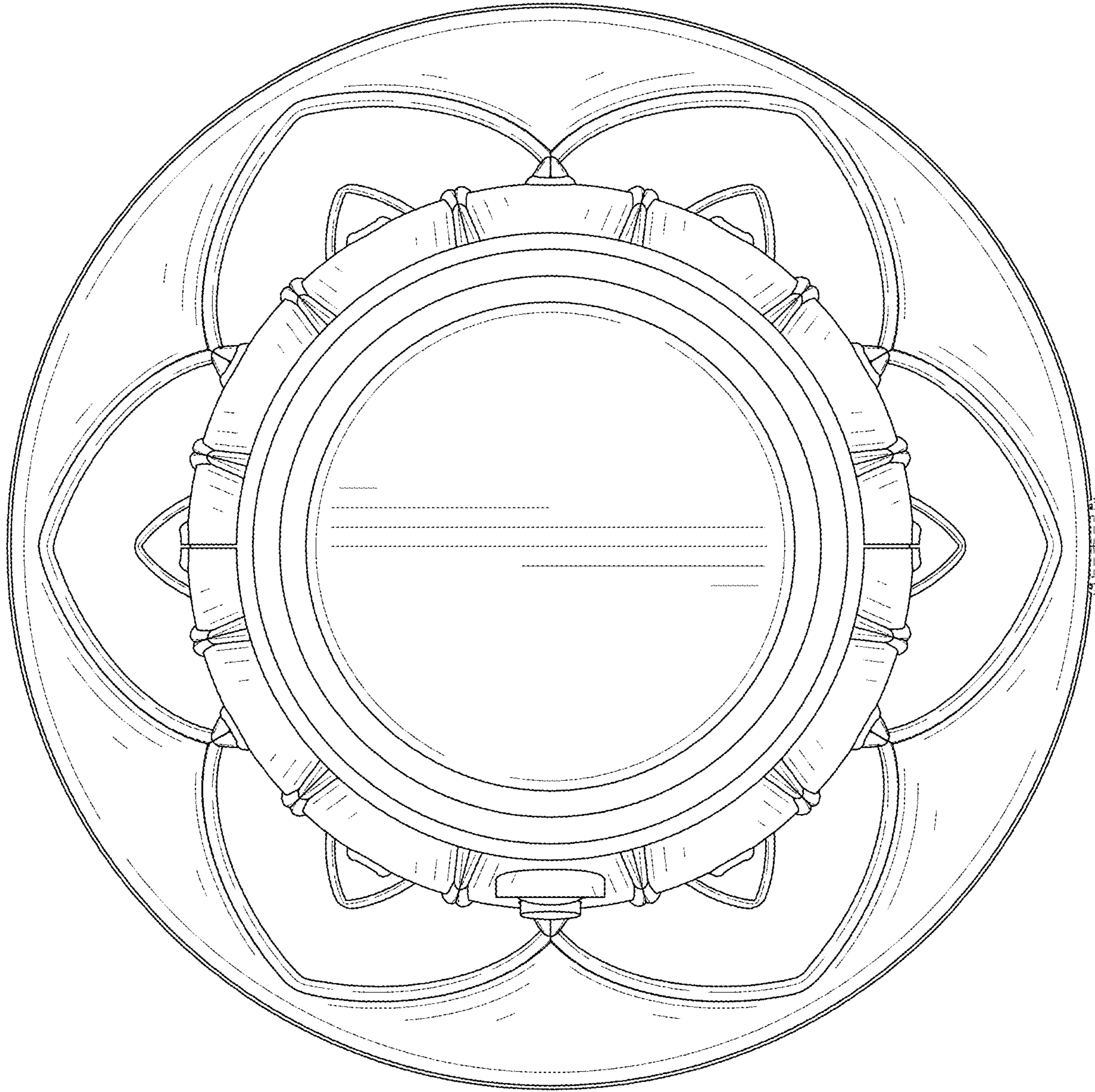
