(57) **CLAIM**

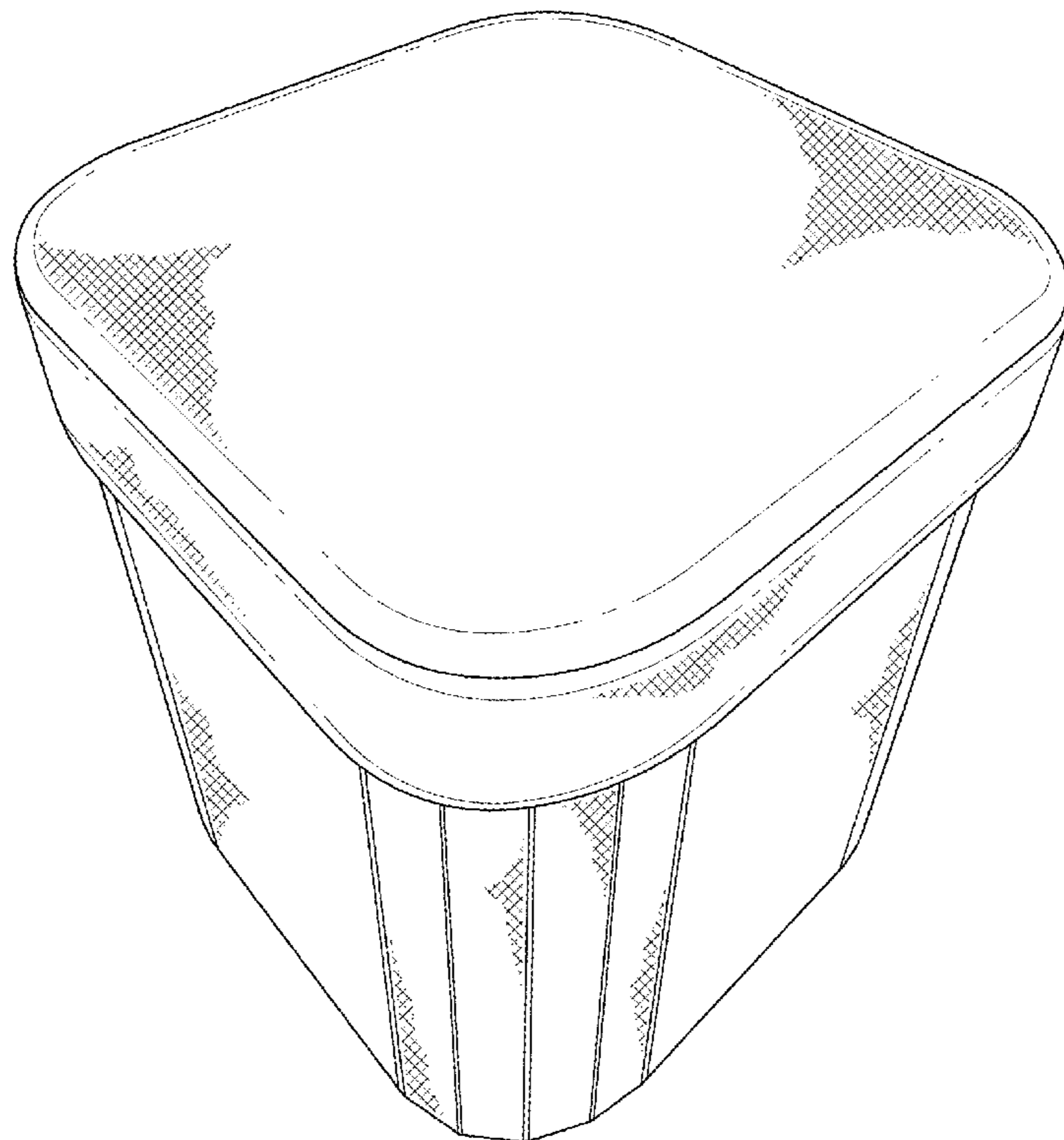
The ornamental design for an ottoman, as shown and described.

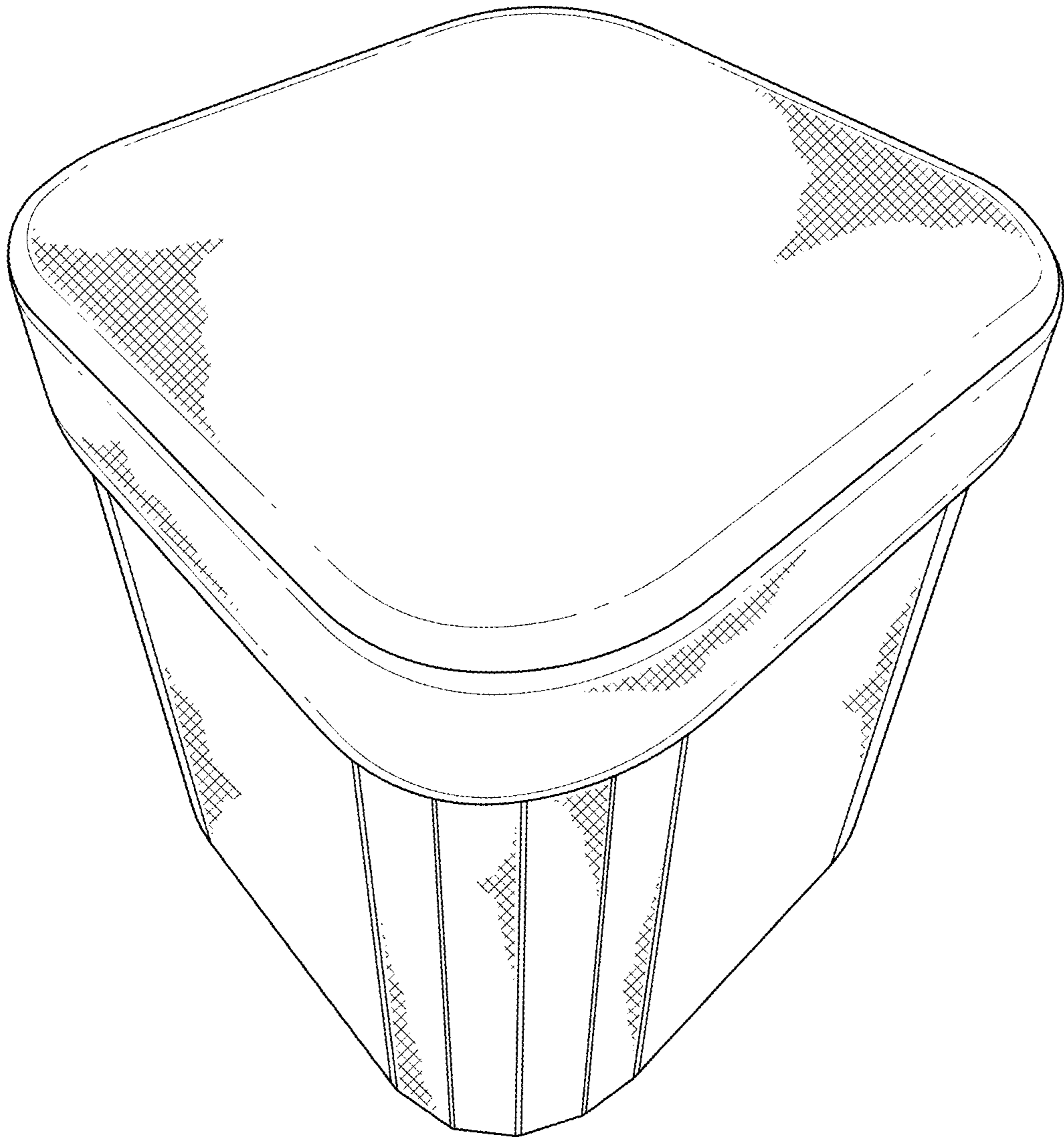

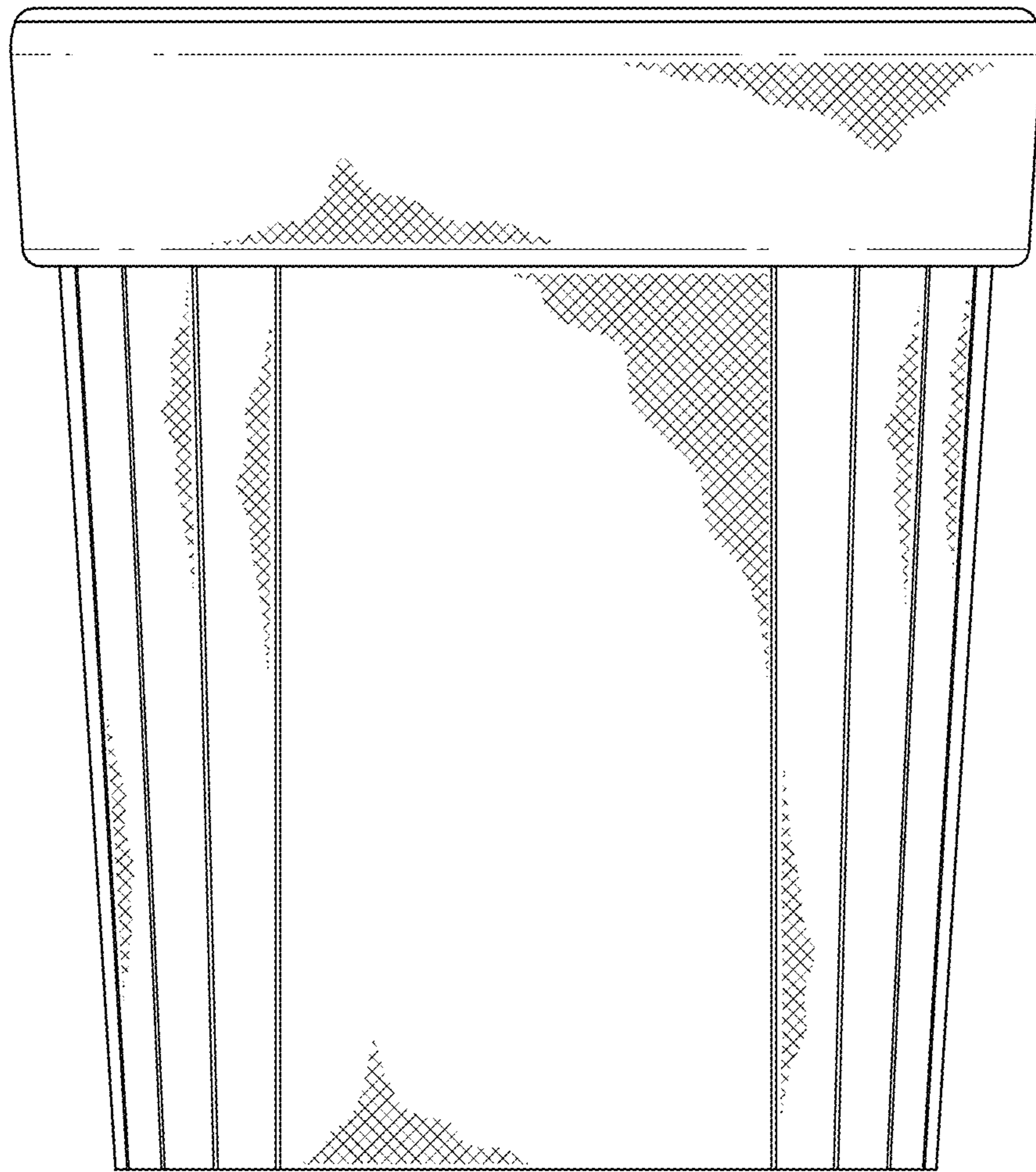

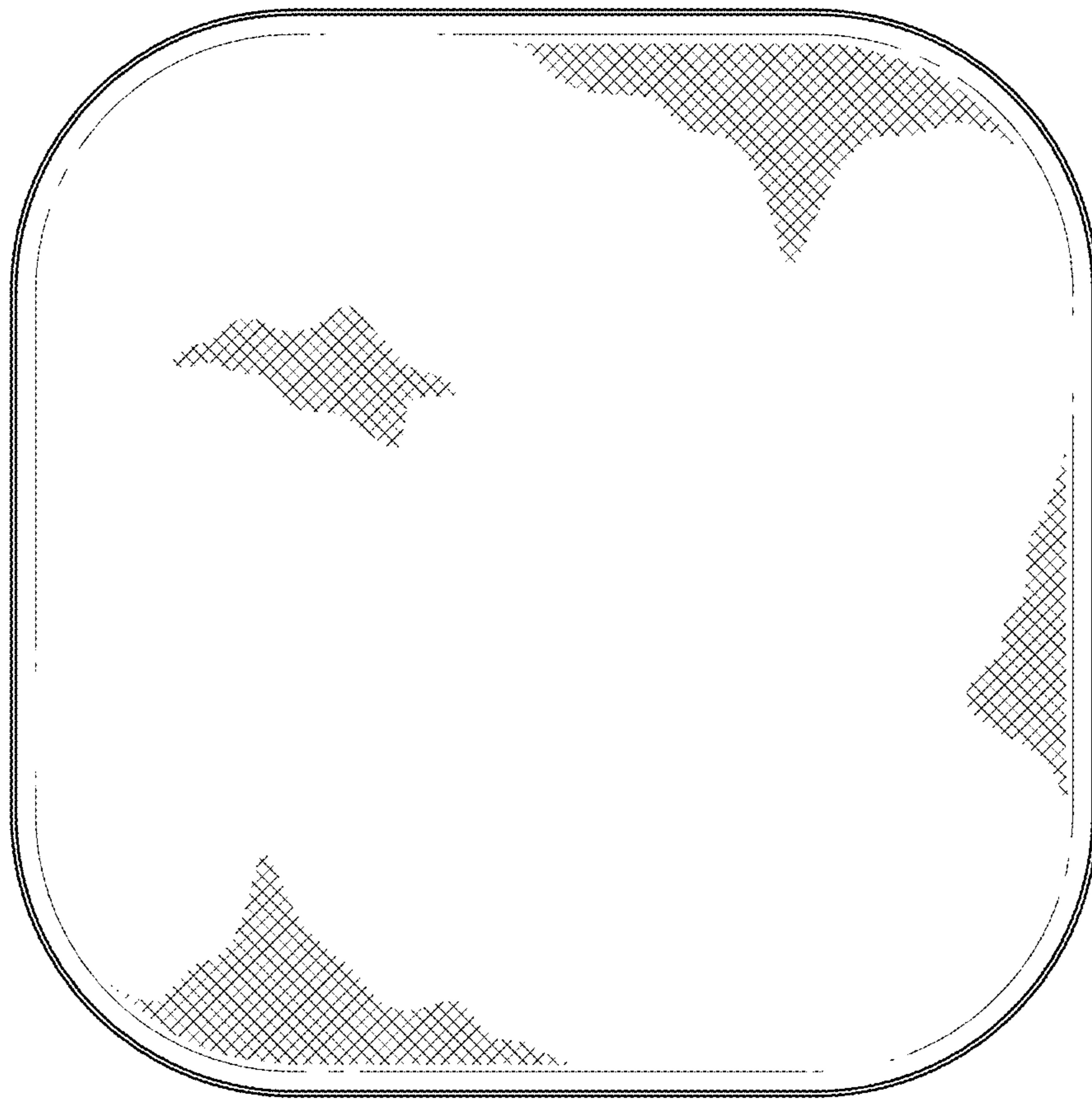

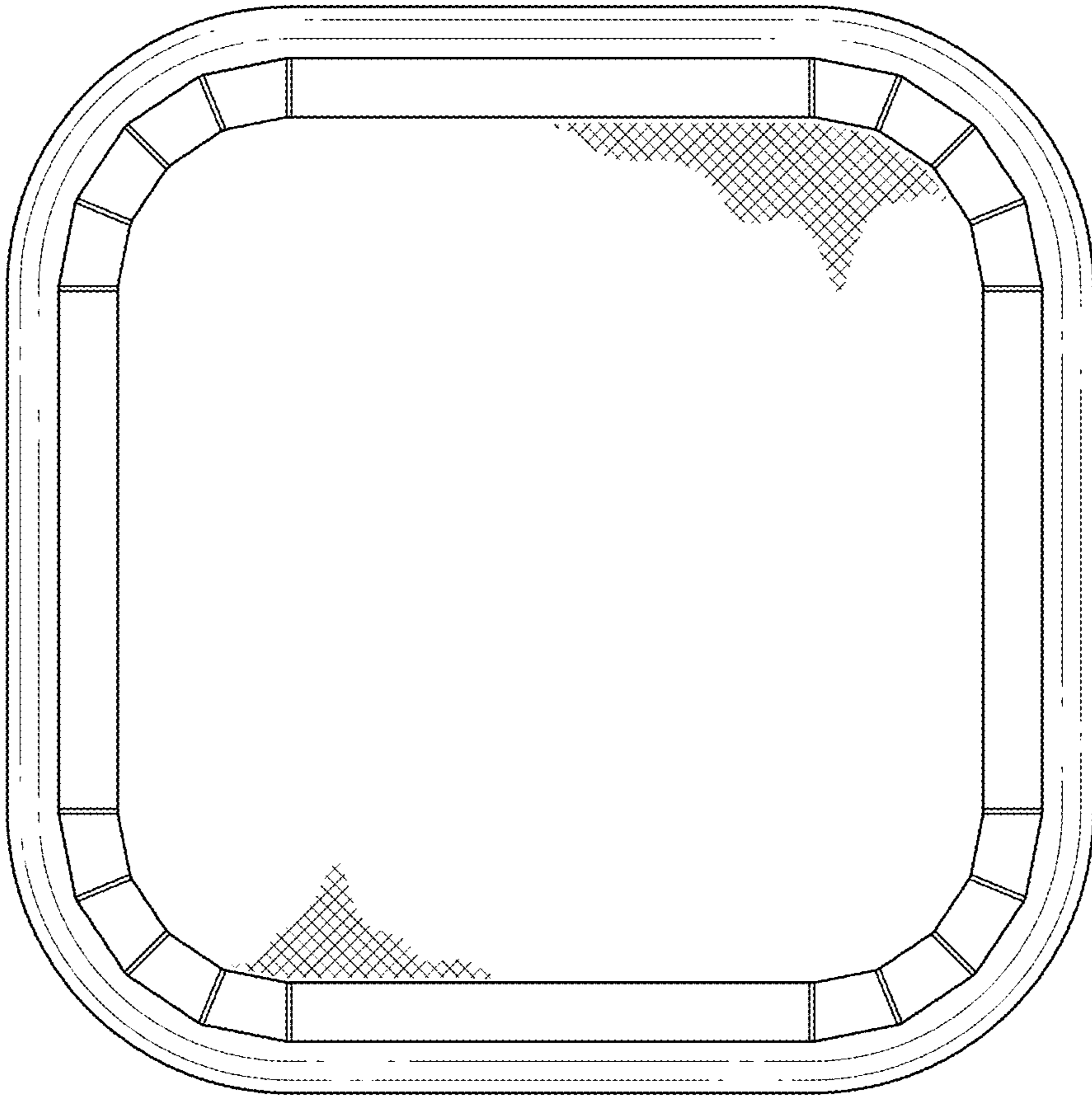
