(57) **CLAIM**

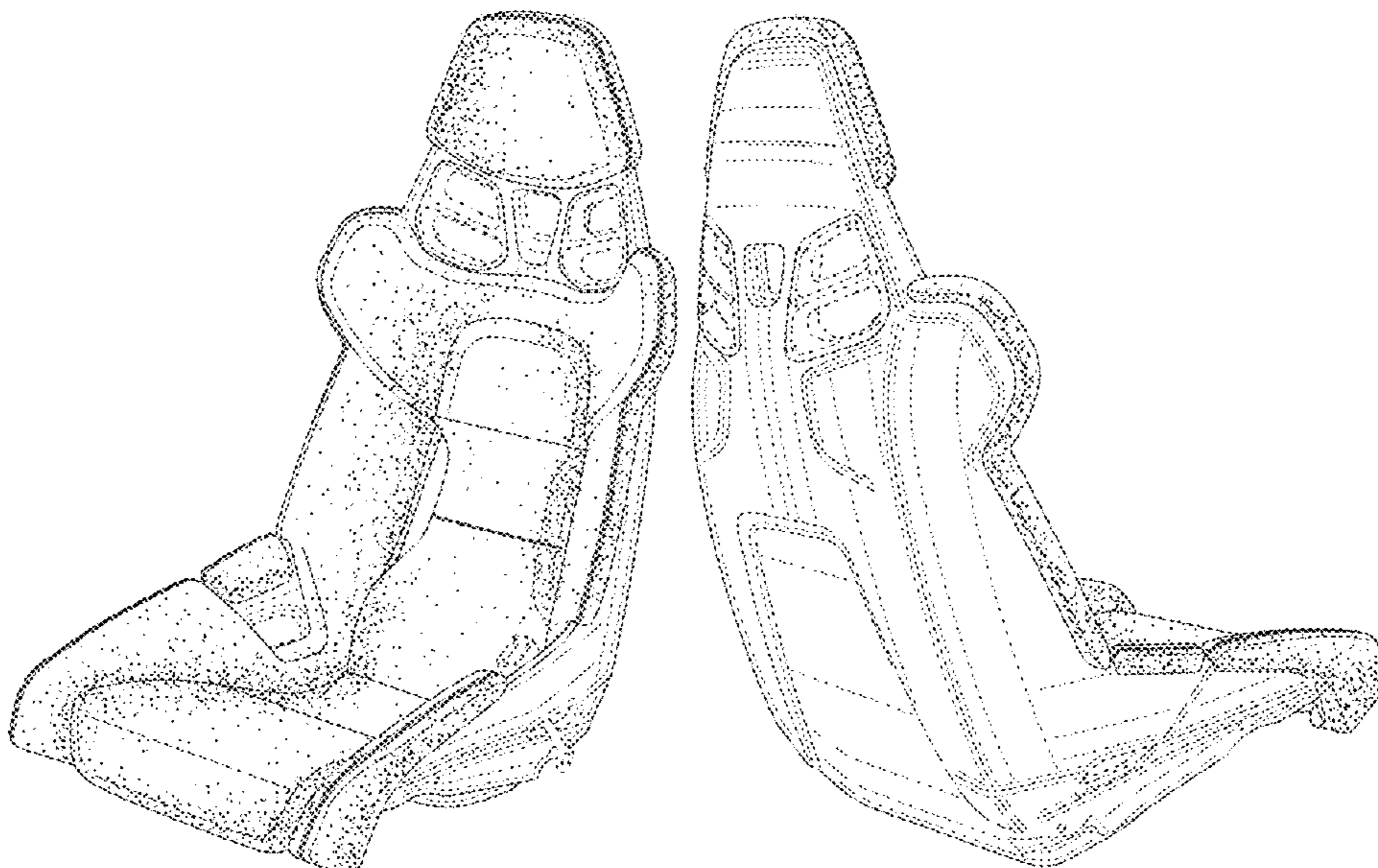
The ornamental design for a seat for motor vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a seat for motor vehicle;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front elevation view thereof;

FIG. 5 is a left side elevation view thereof;

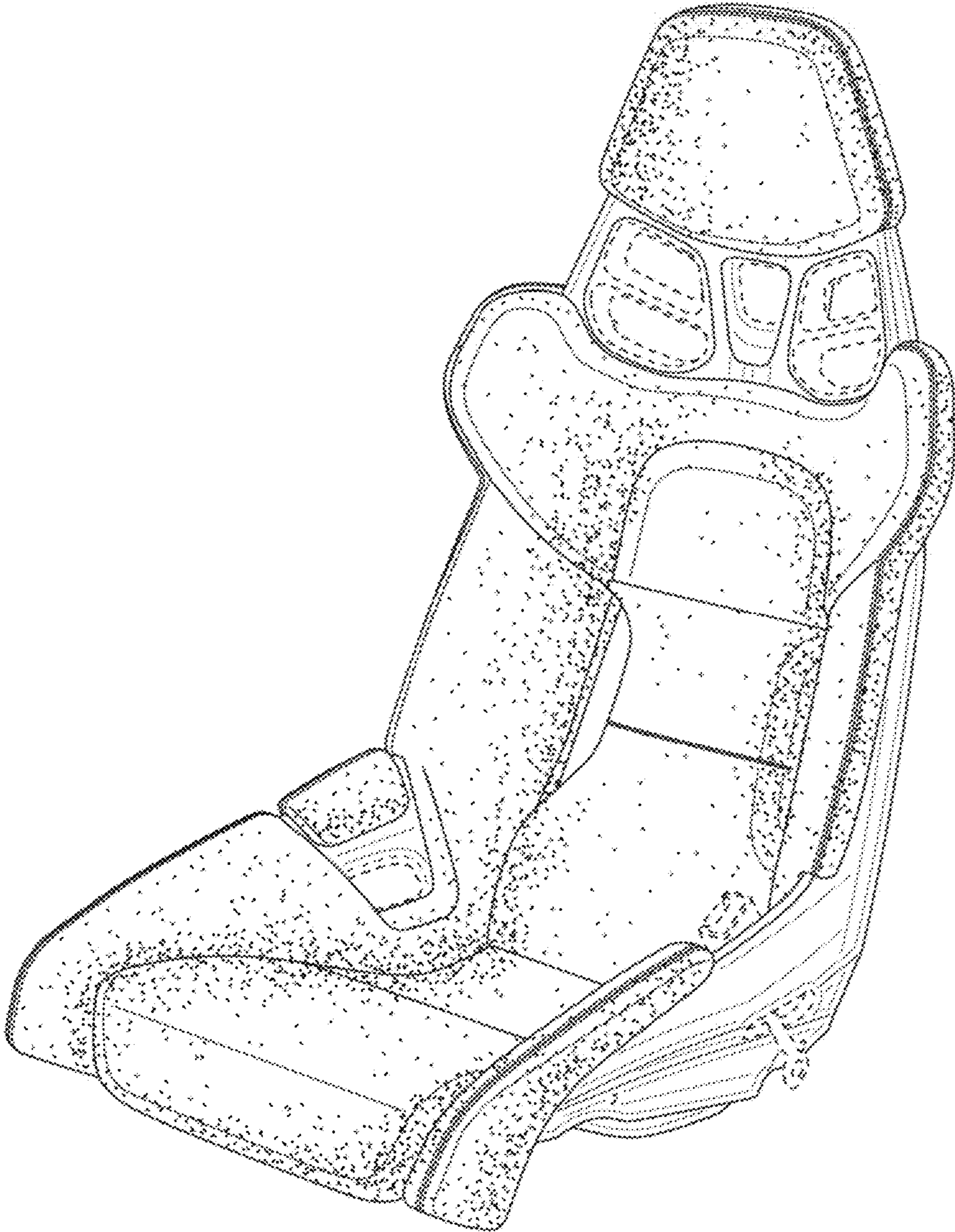

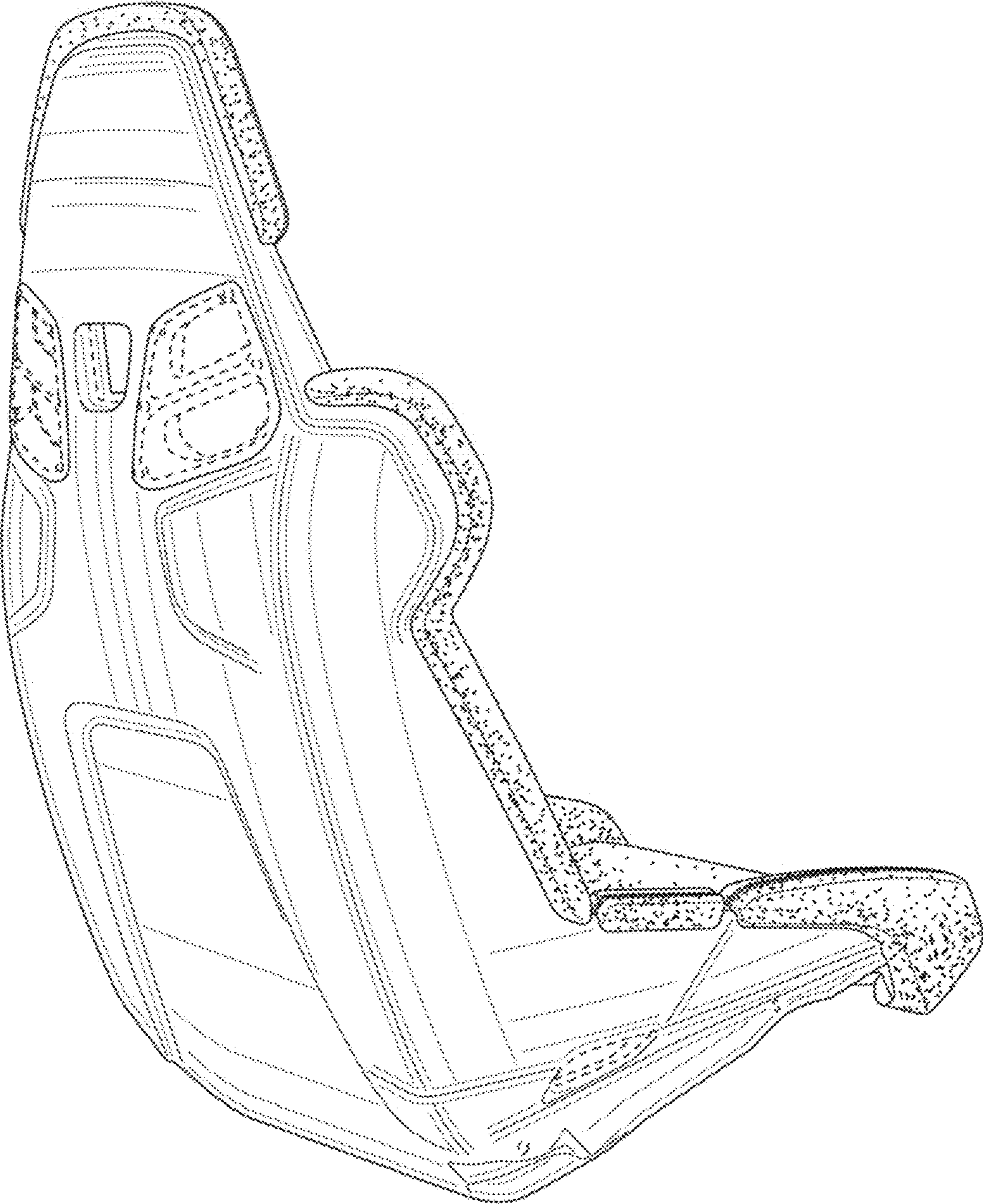

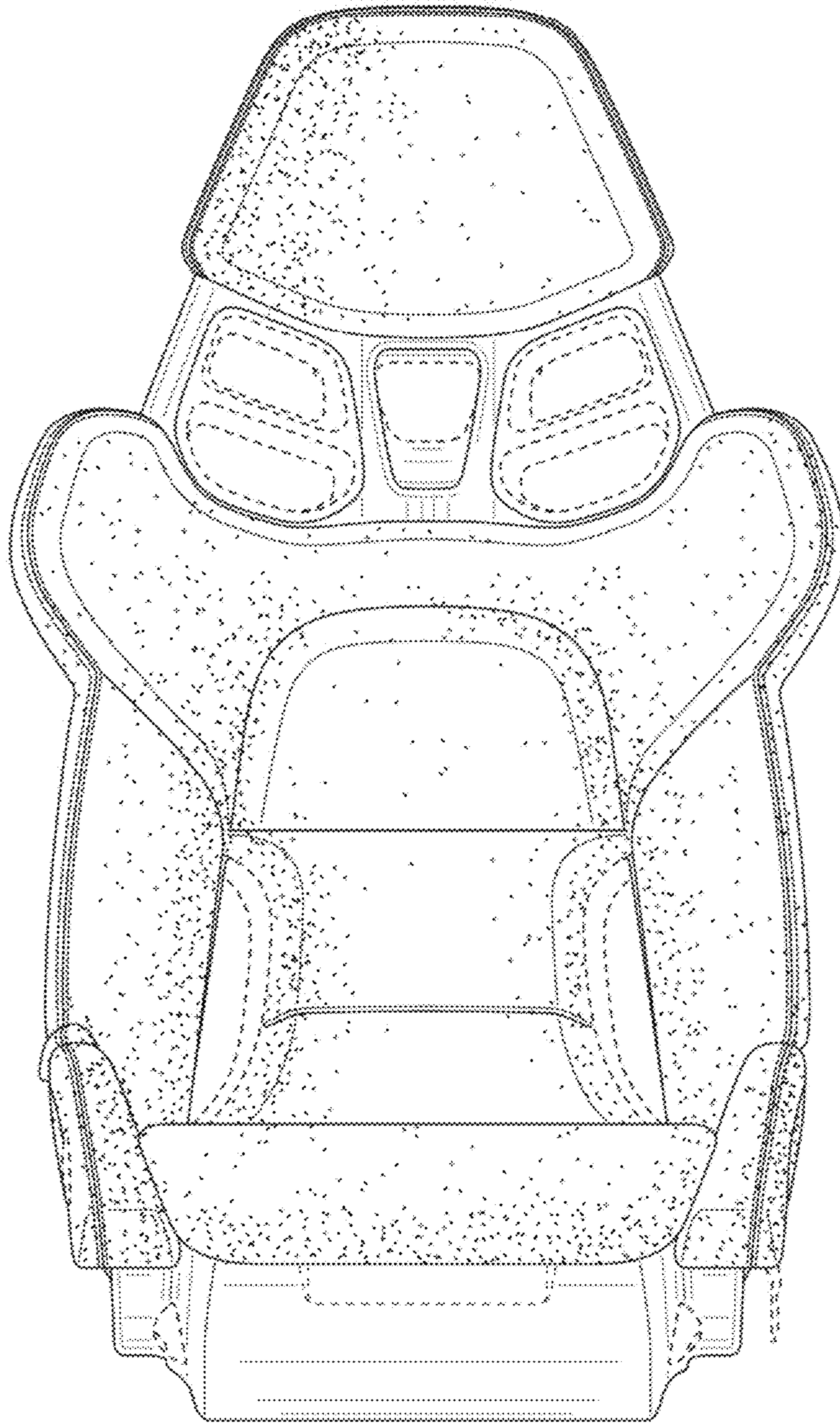

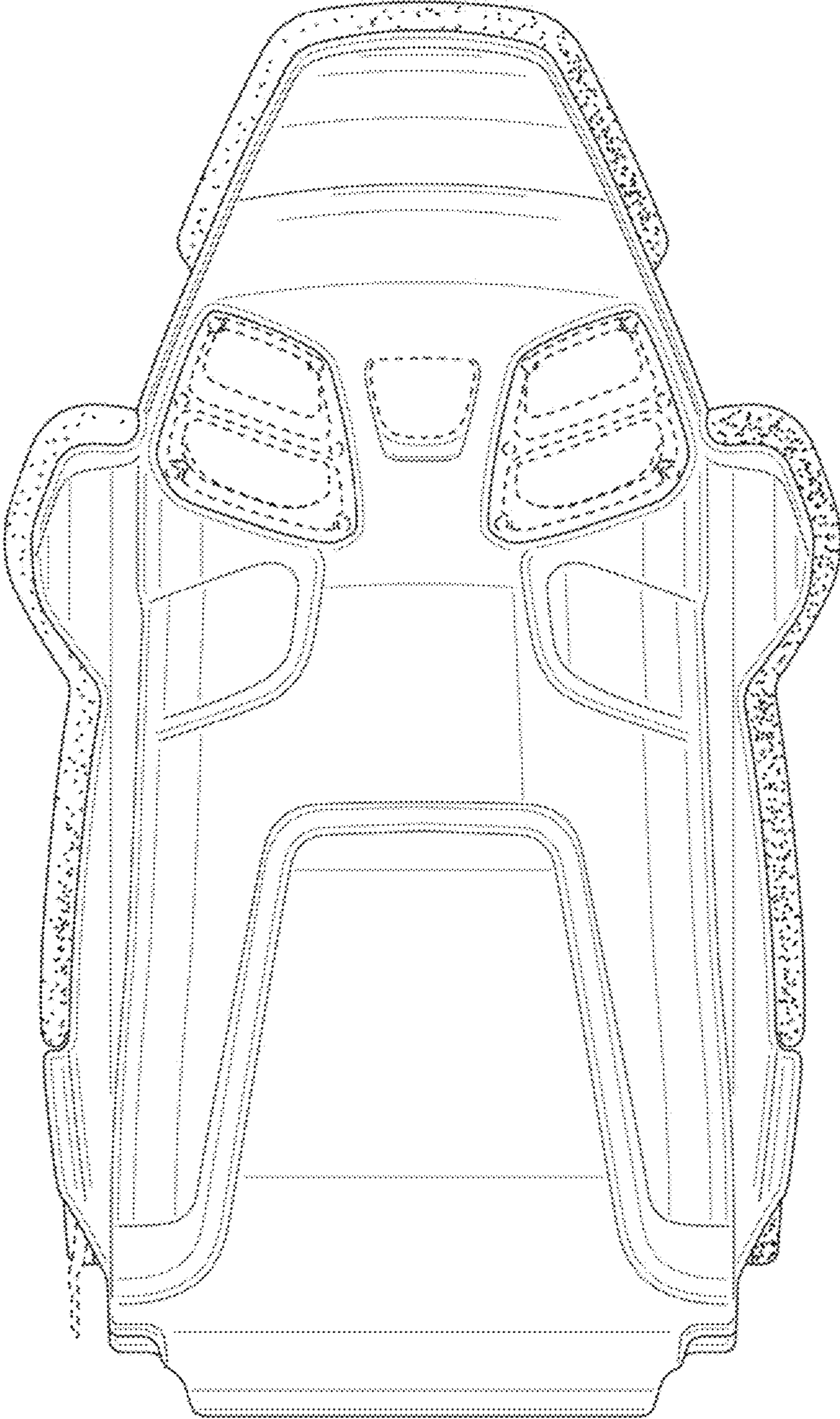

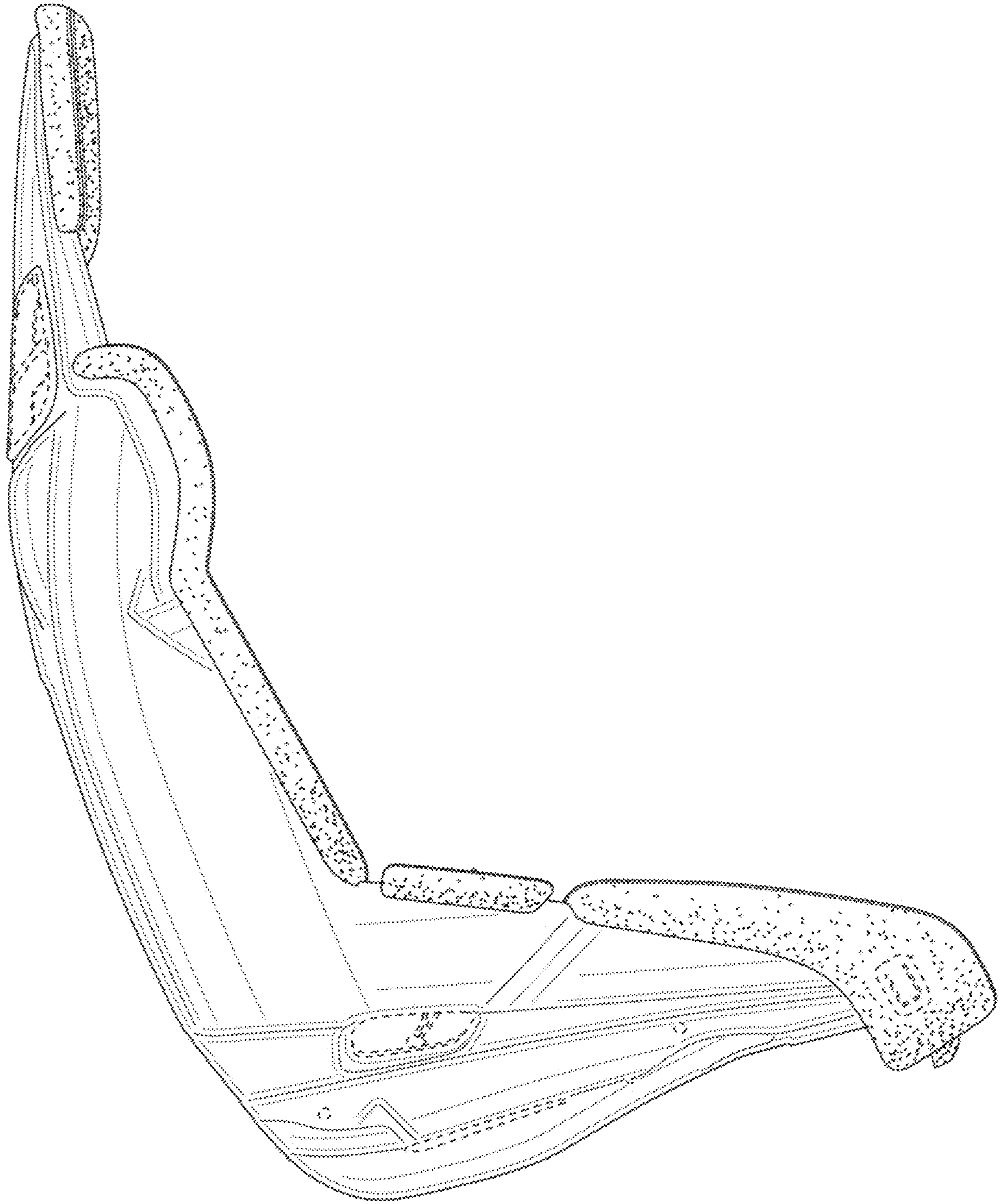

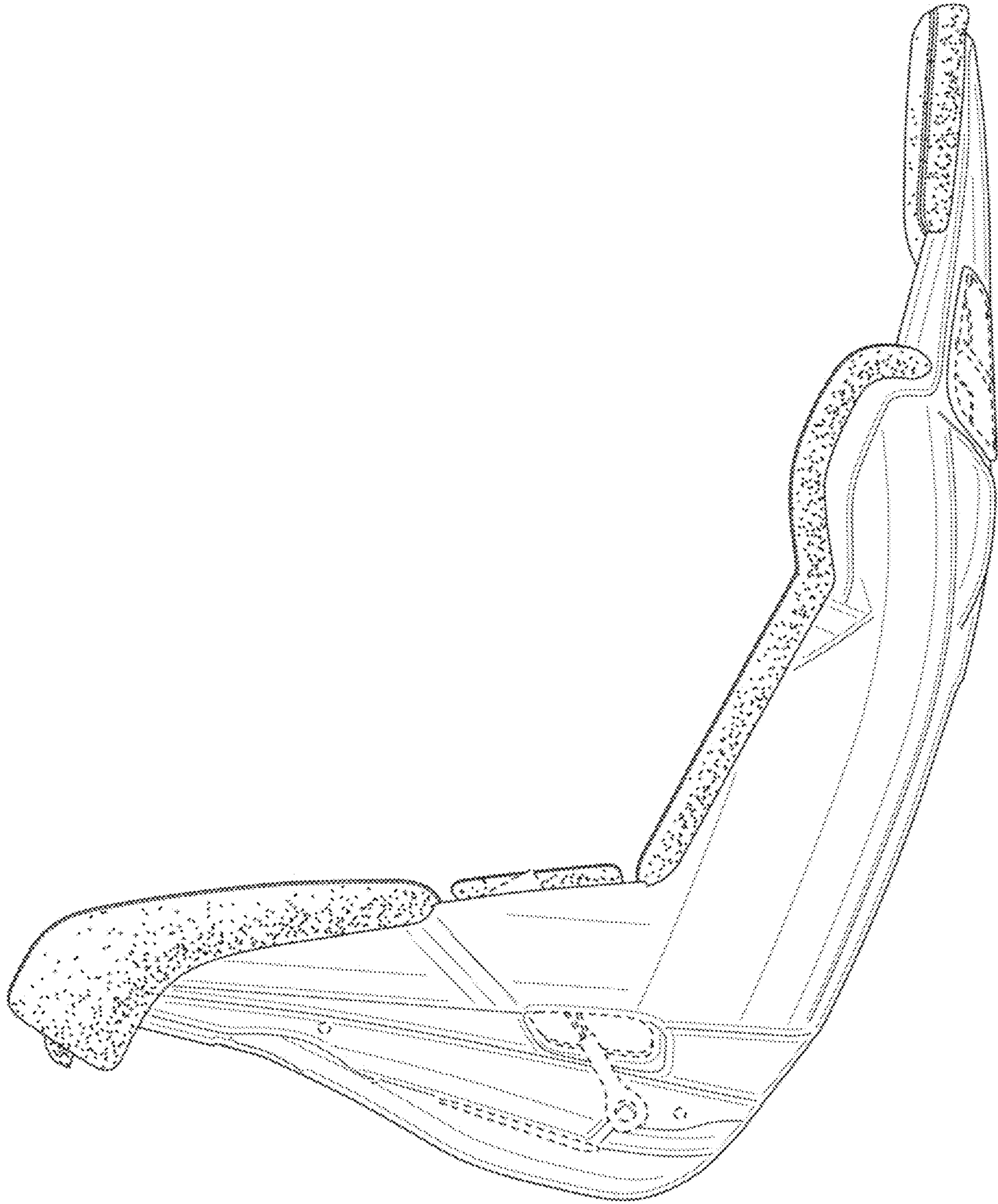

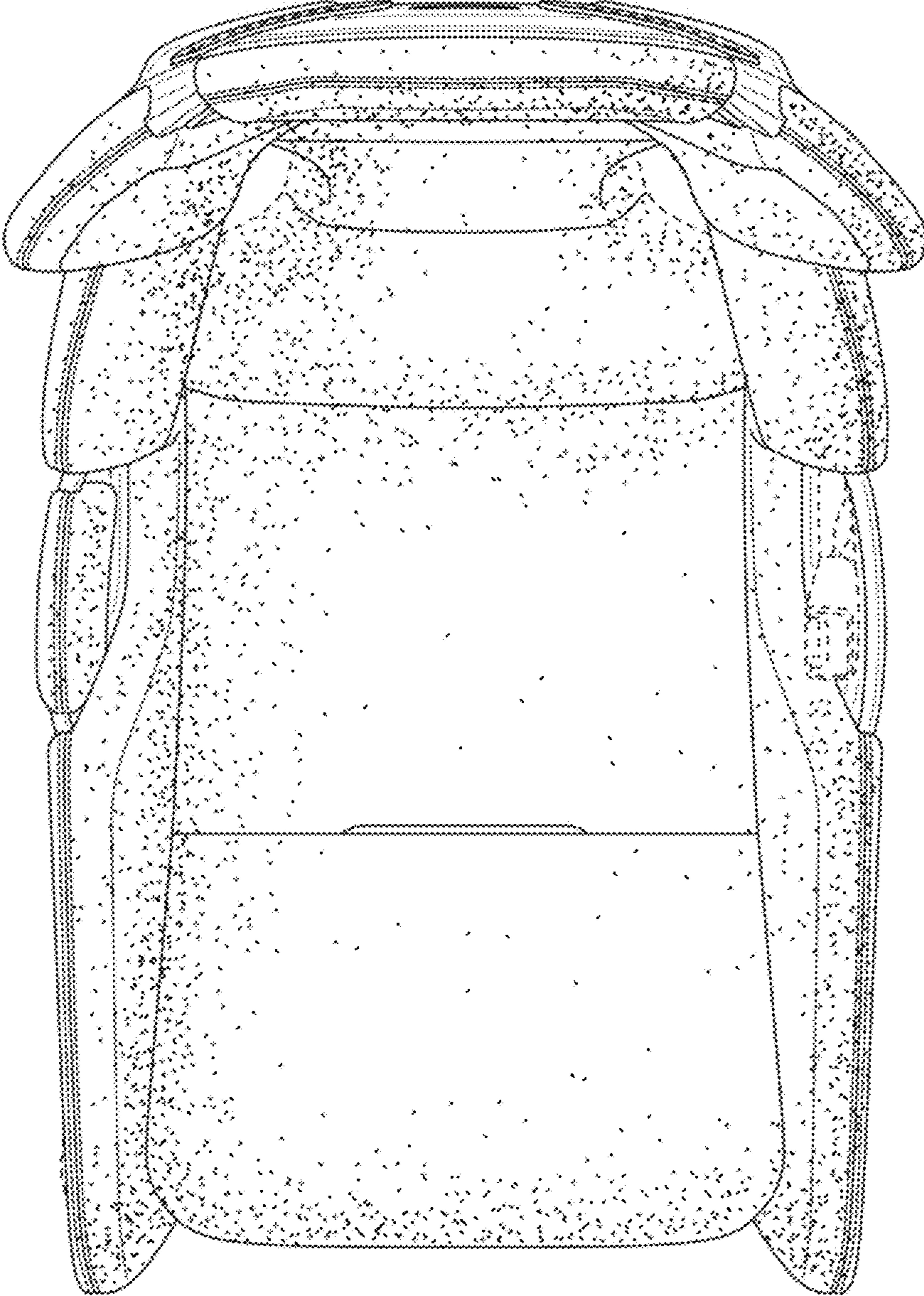

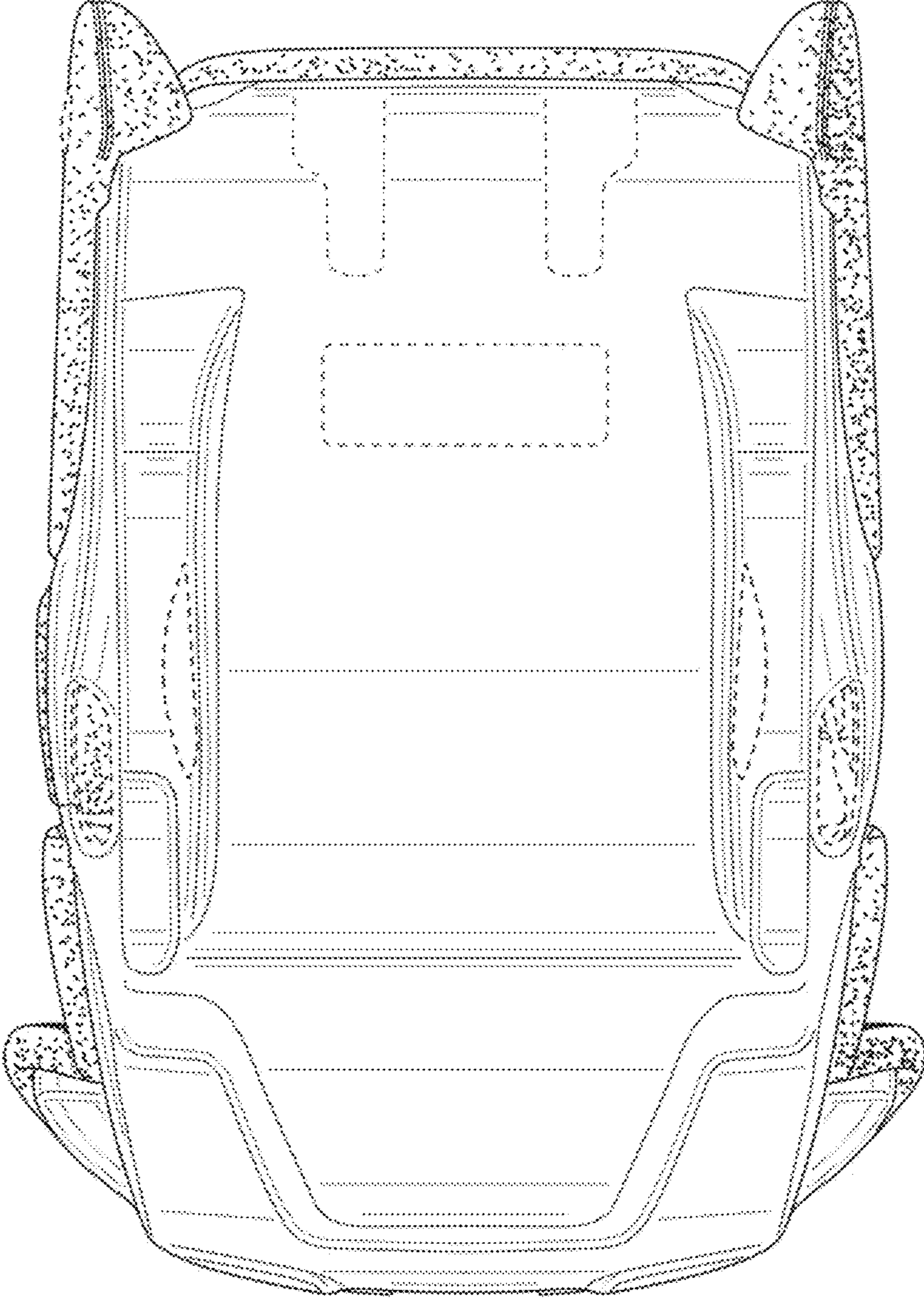
