**DESCRIPTION**

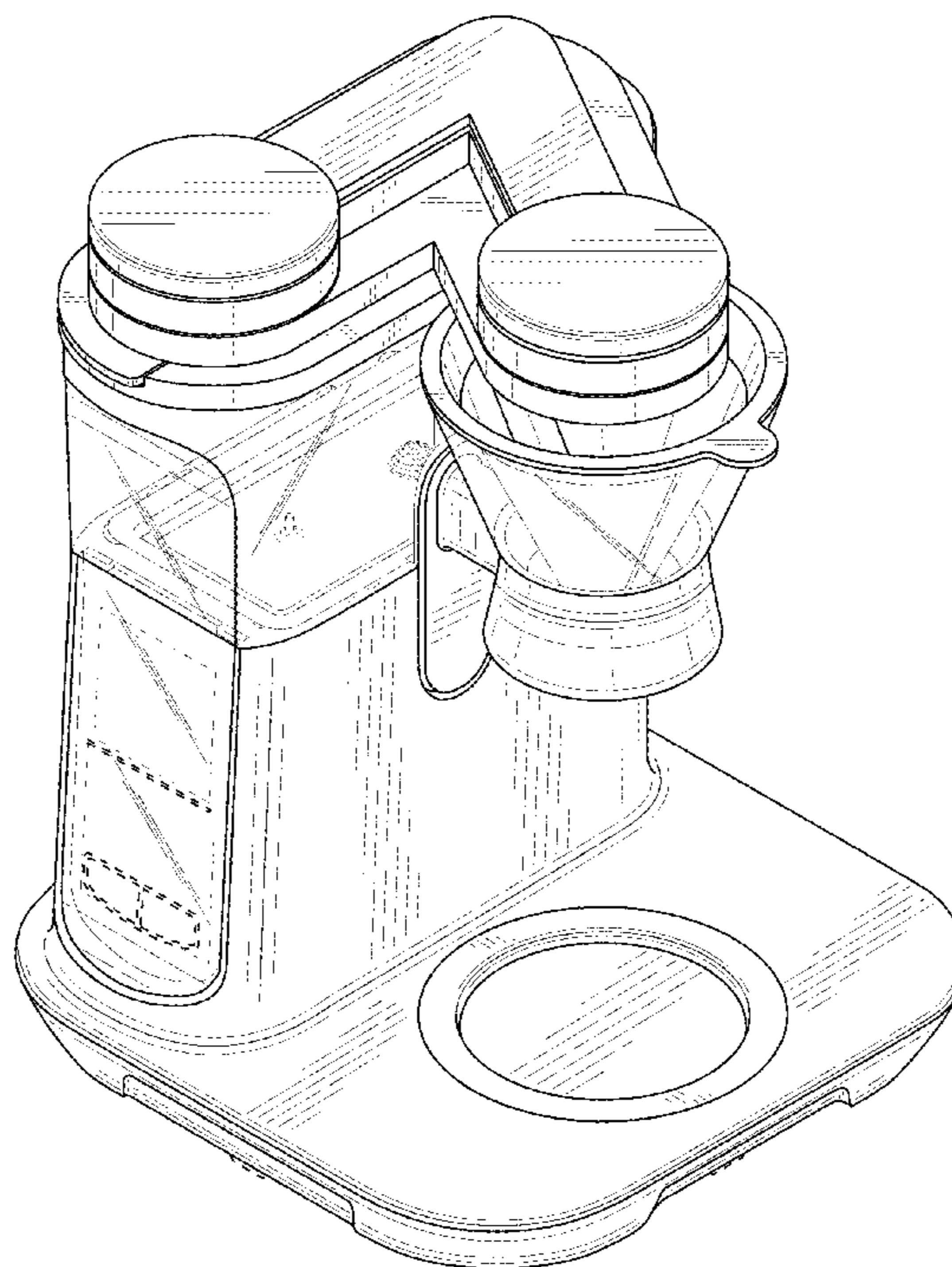
FIG. 1 is a perspective view of coffeemaker showing my new design;

The broken lines in the drawing depict environmental subject matter only and form no part of the claimed design.

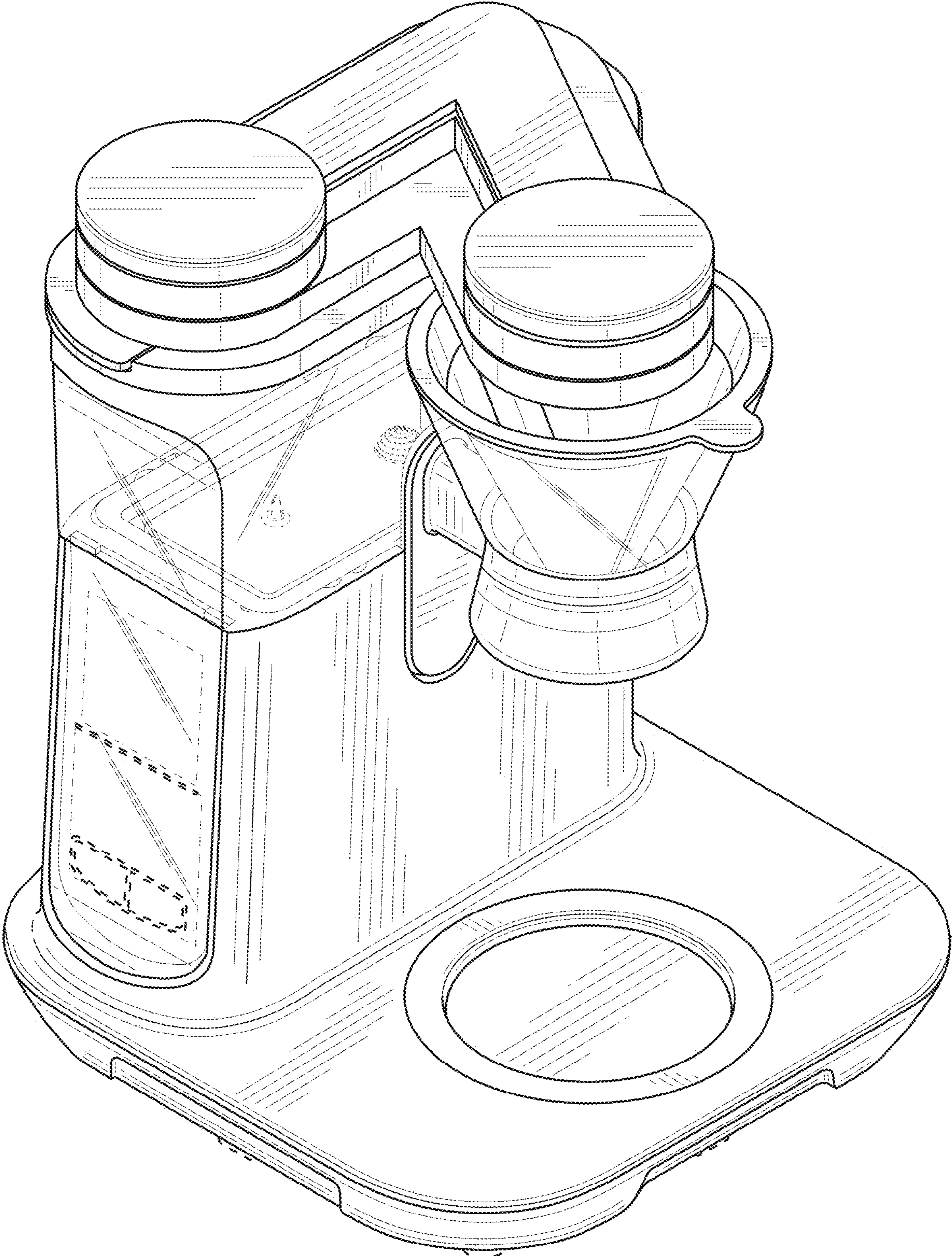

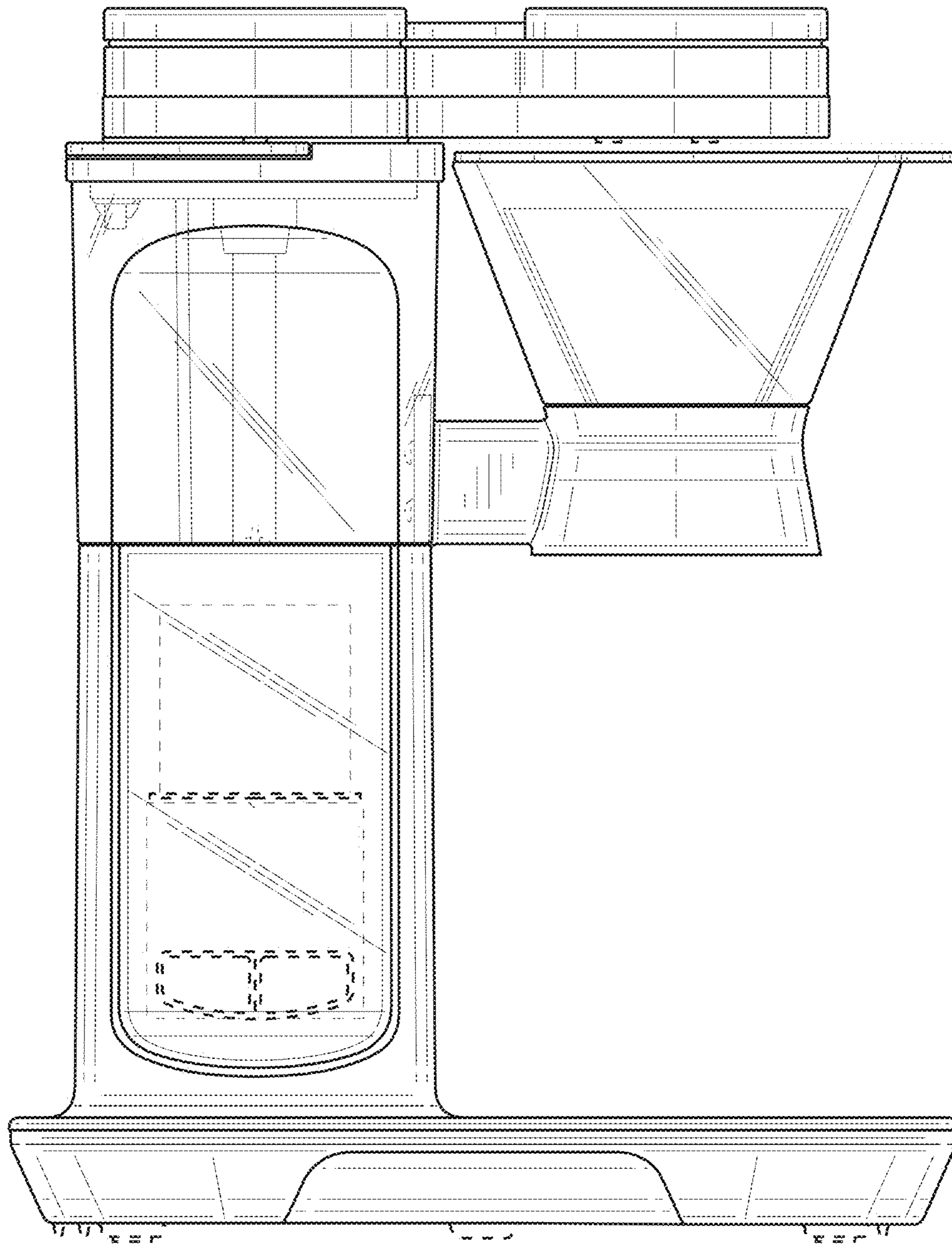

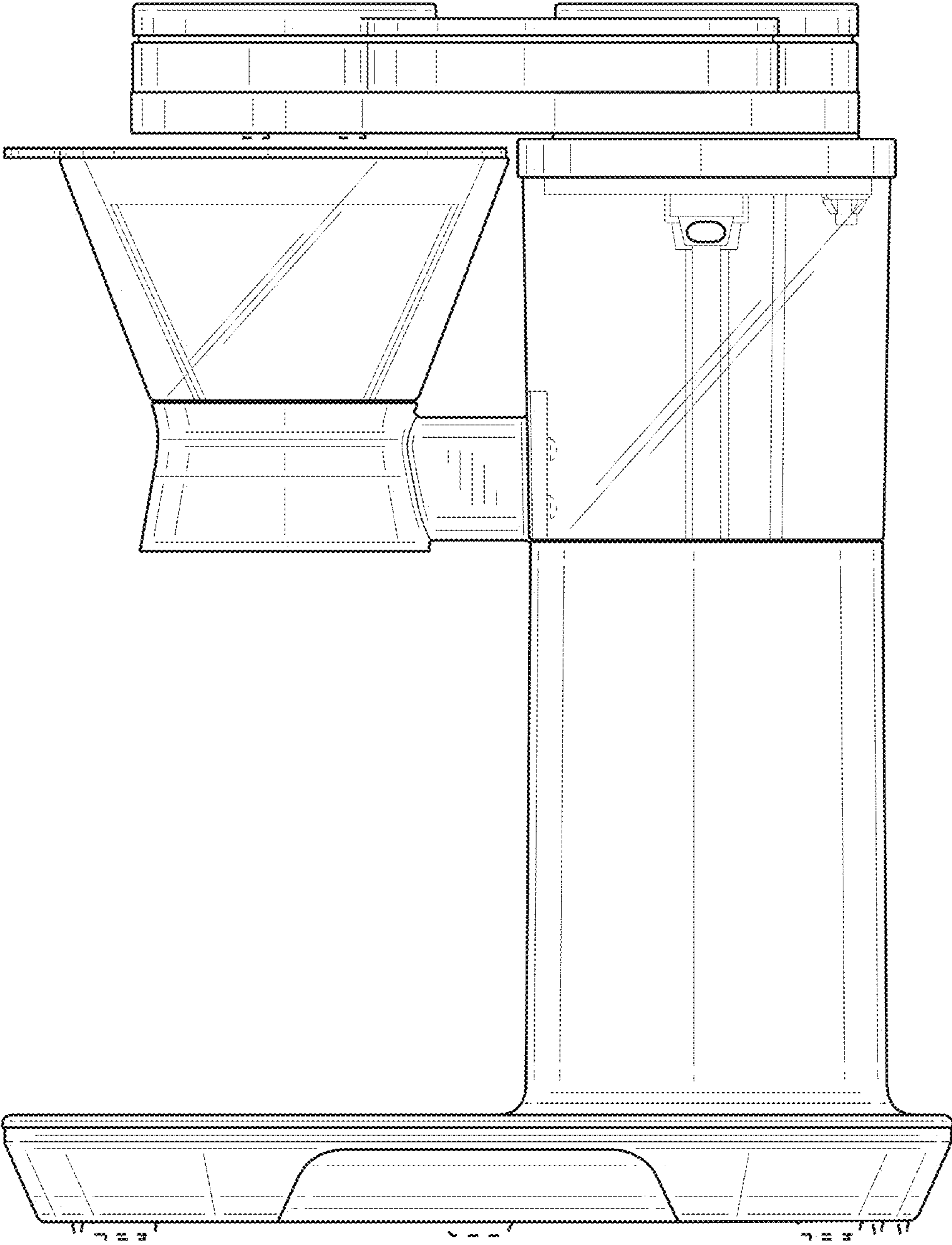




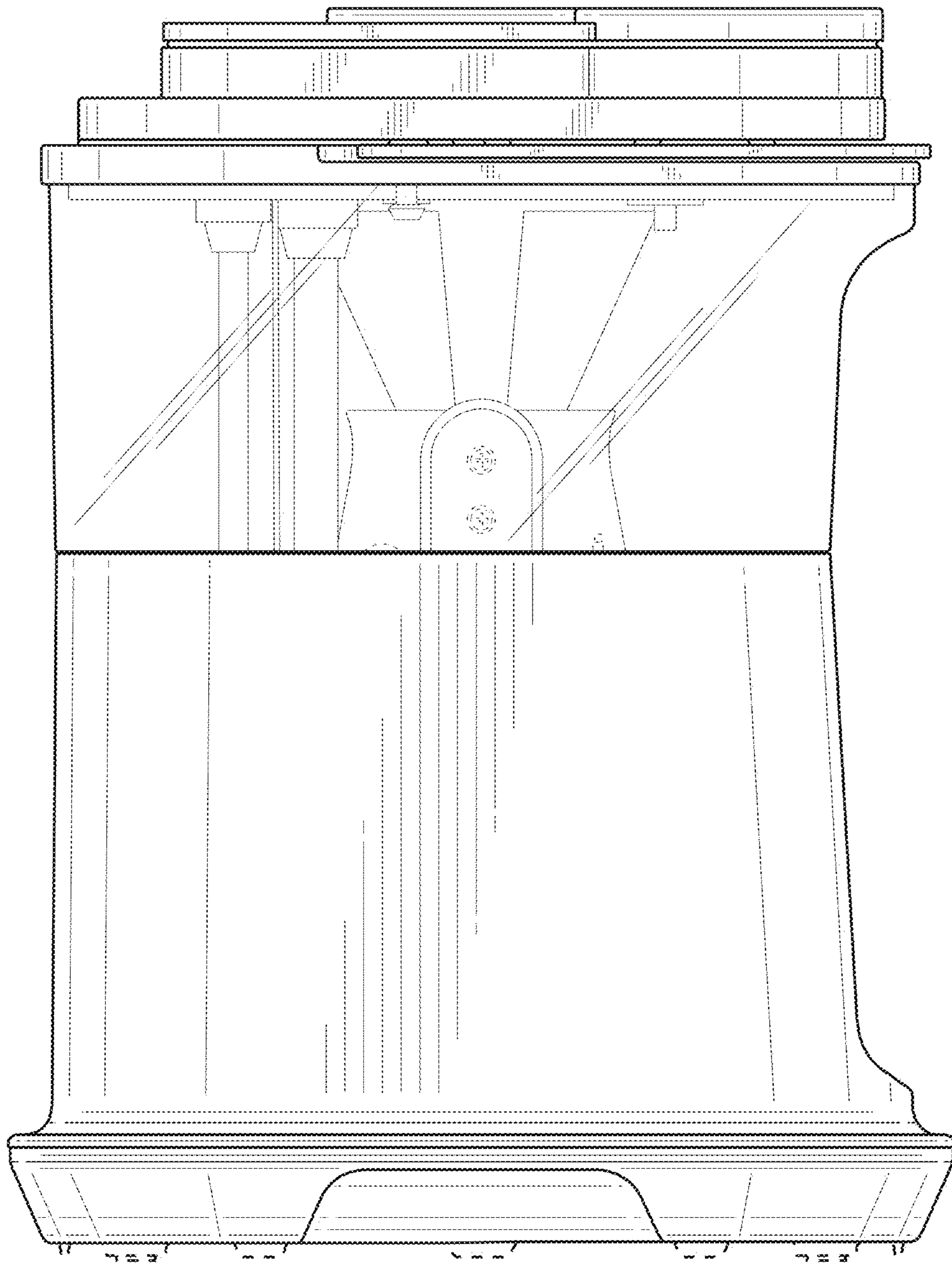

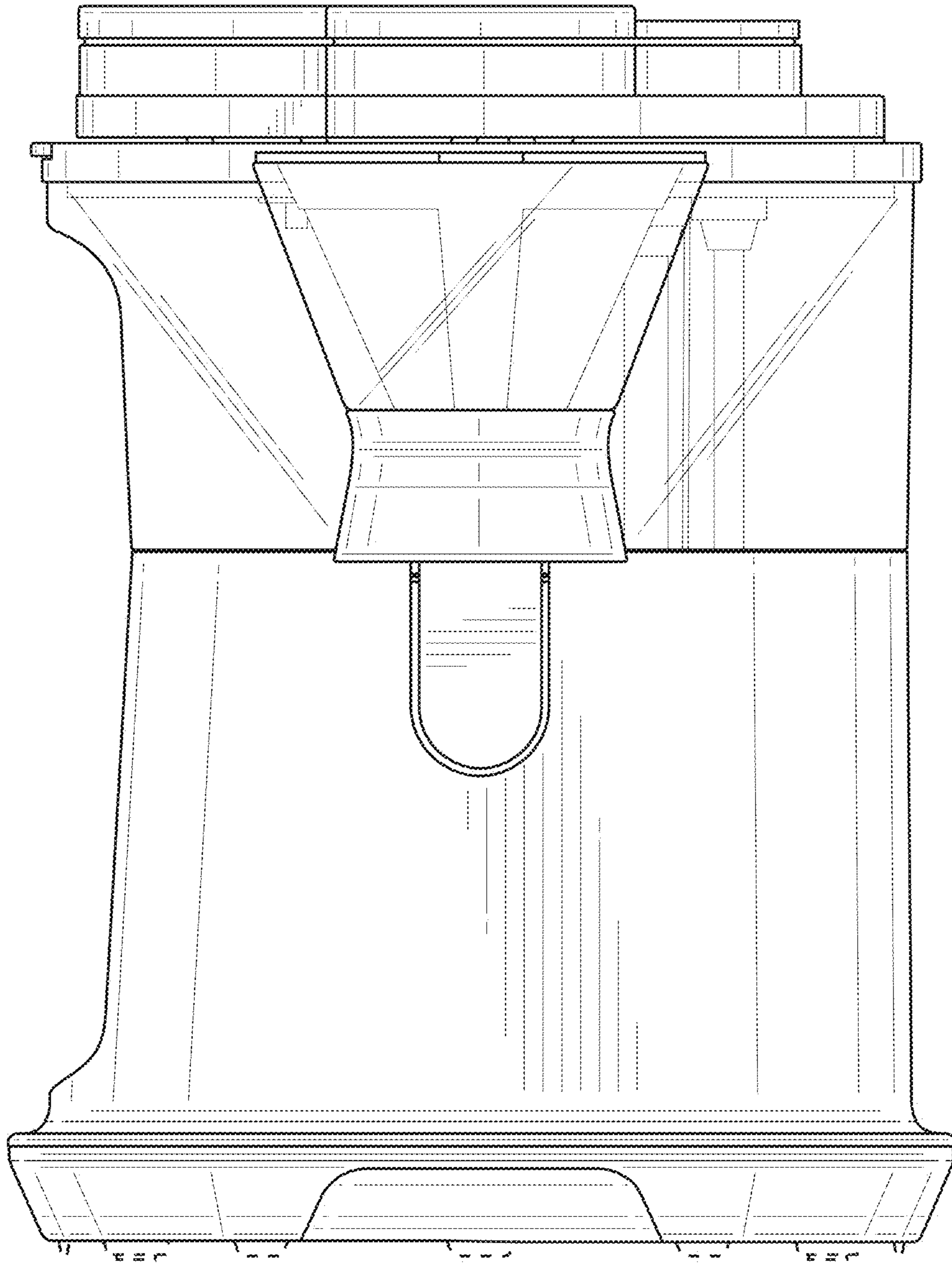

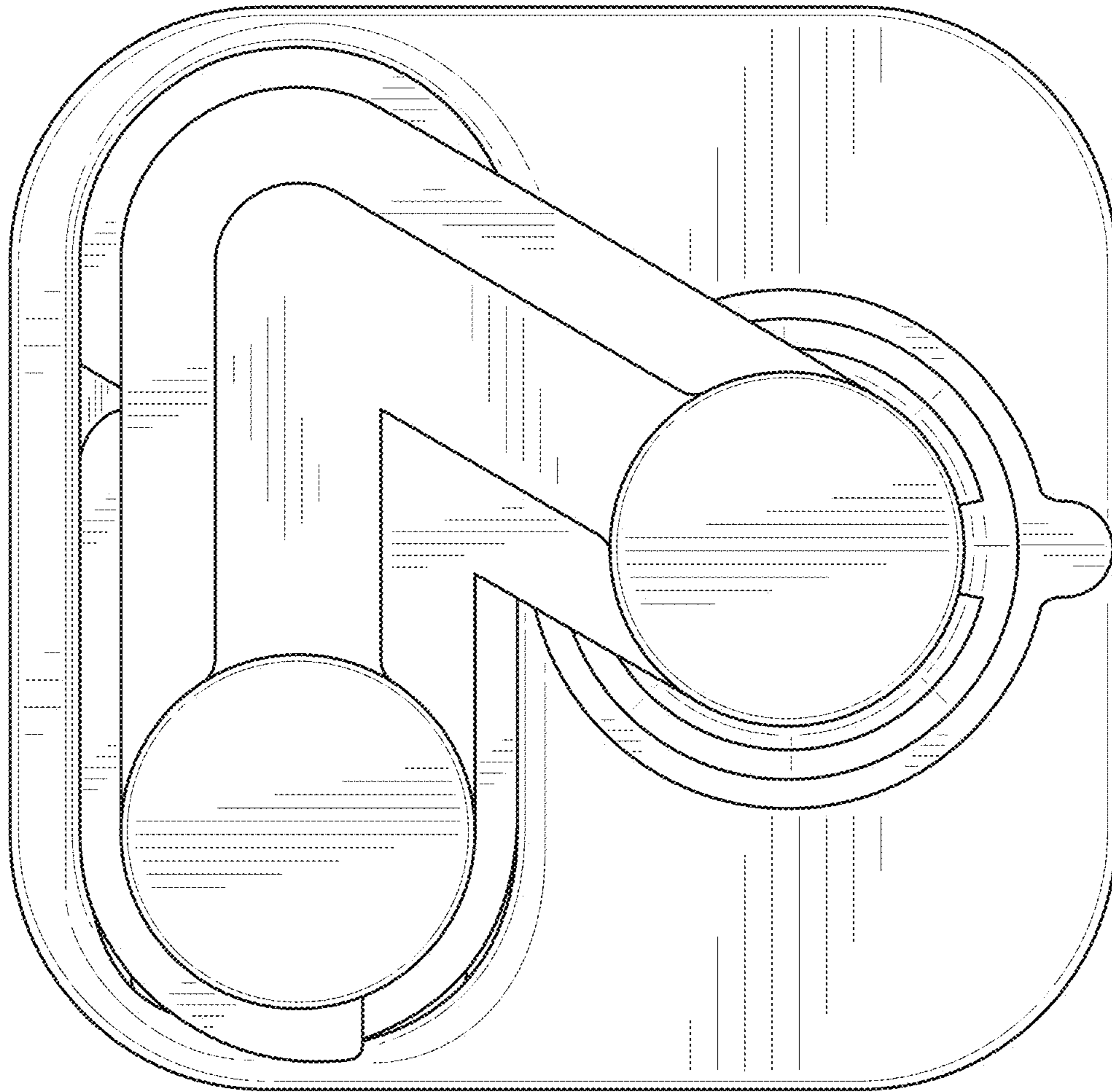

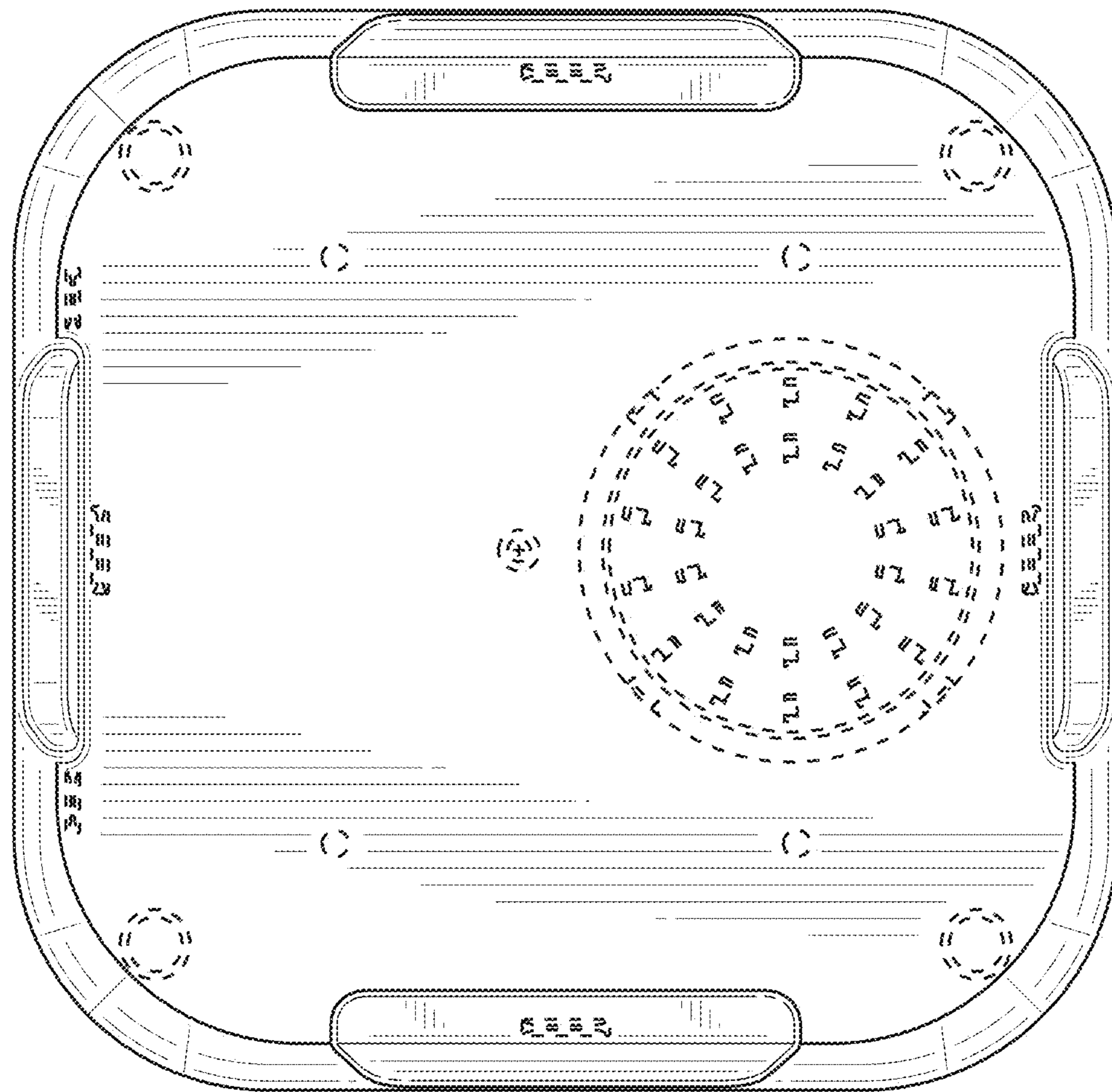
