FIG. 7 is a left side view of the tumbler with lid of FIG. 1;

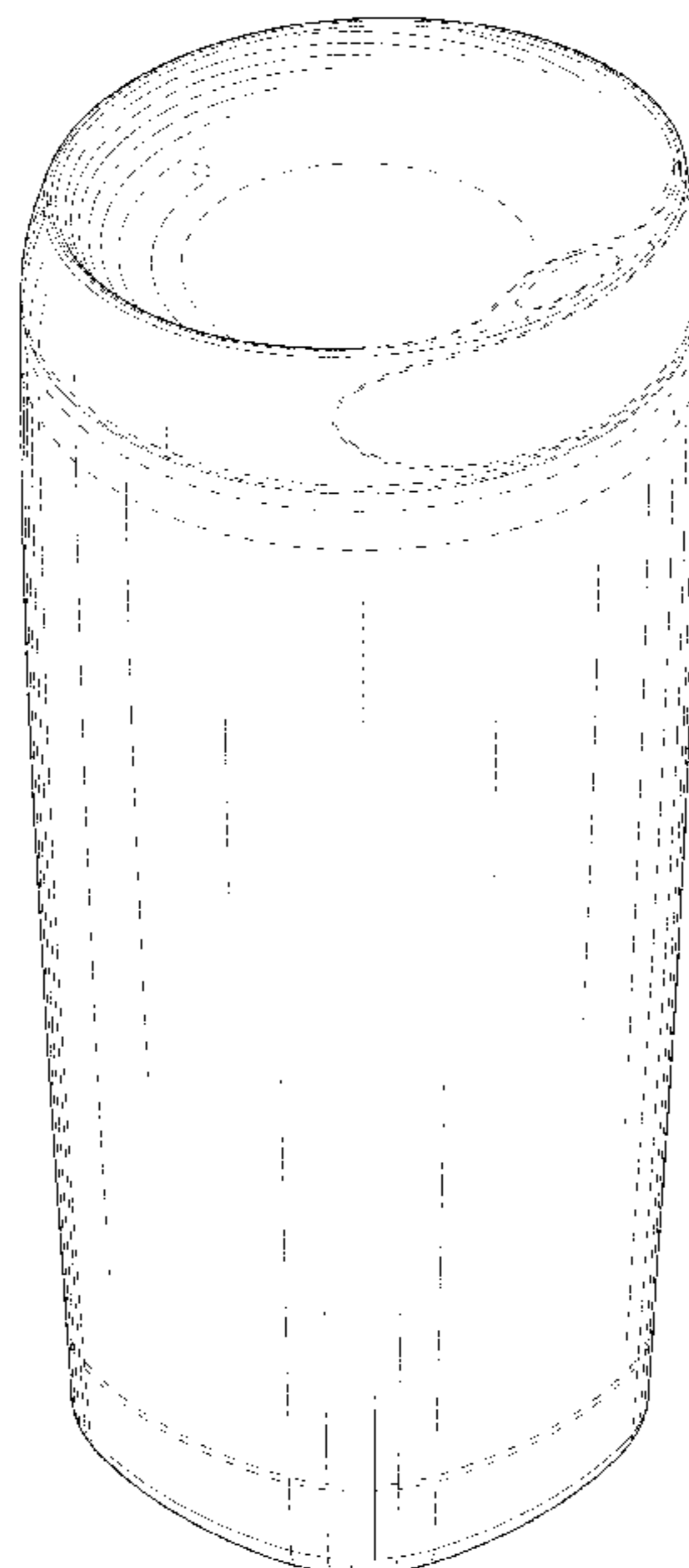
FIG. 8 is a front view of the tumbler with lid of FIG. 1; and,

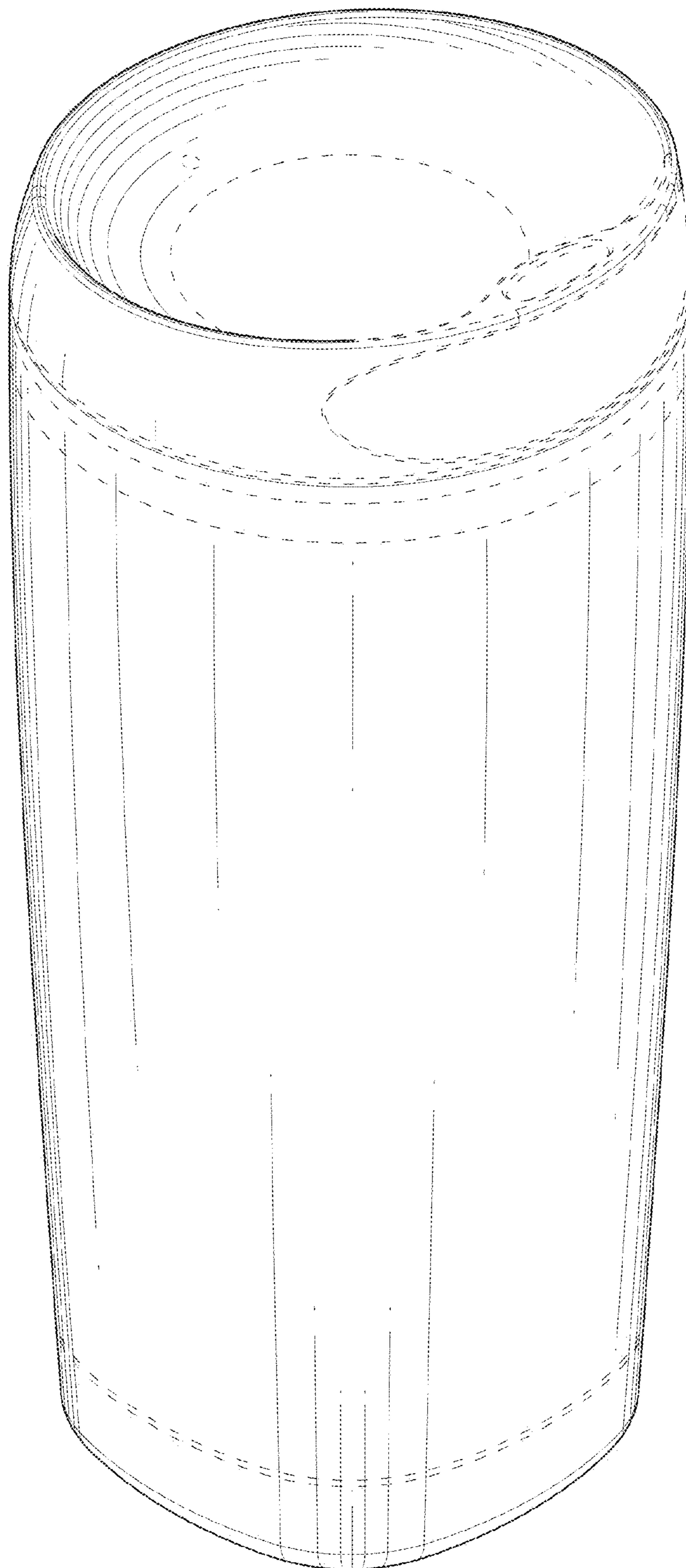

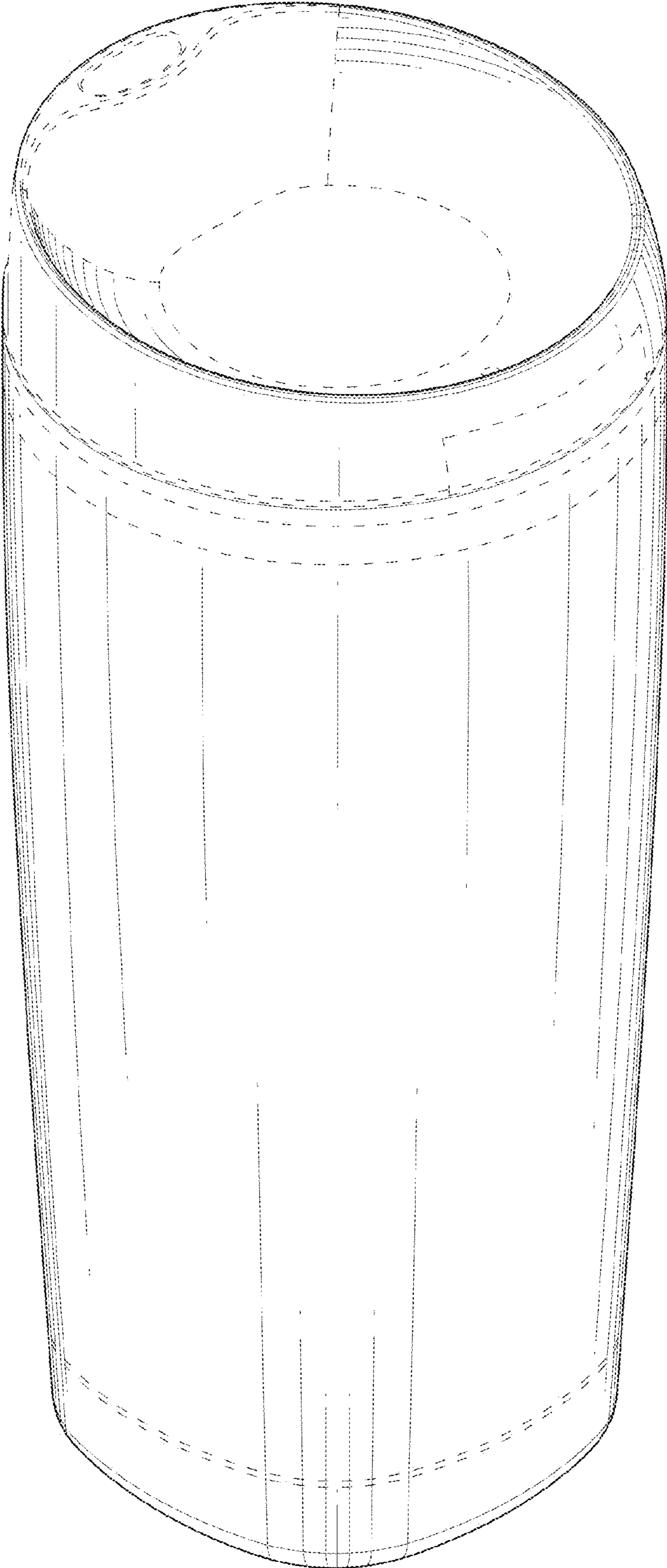

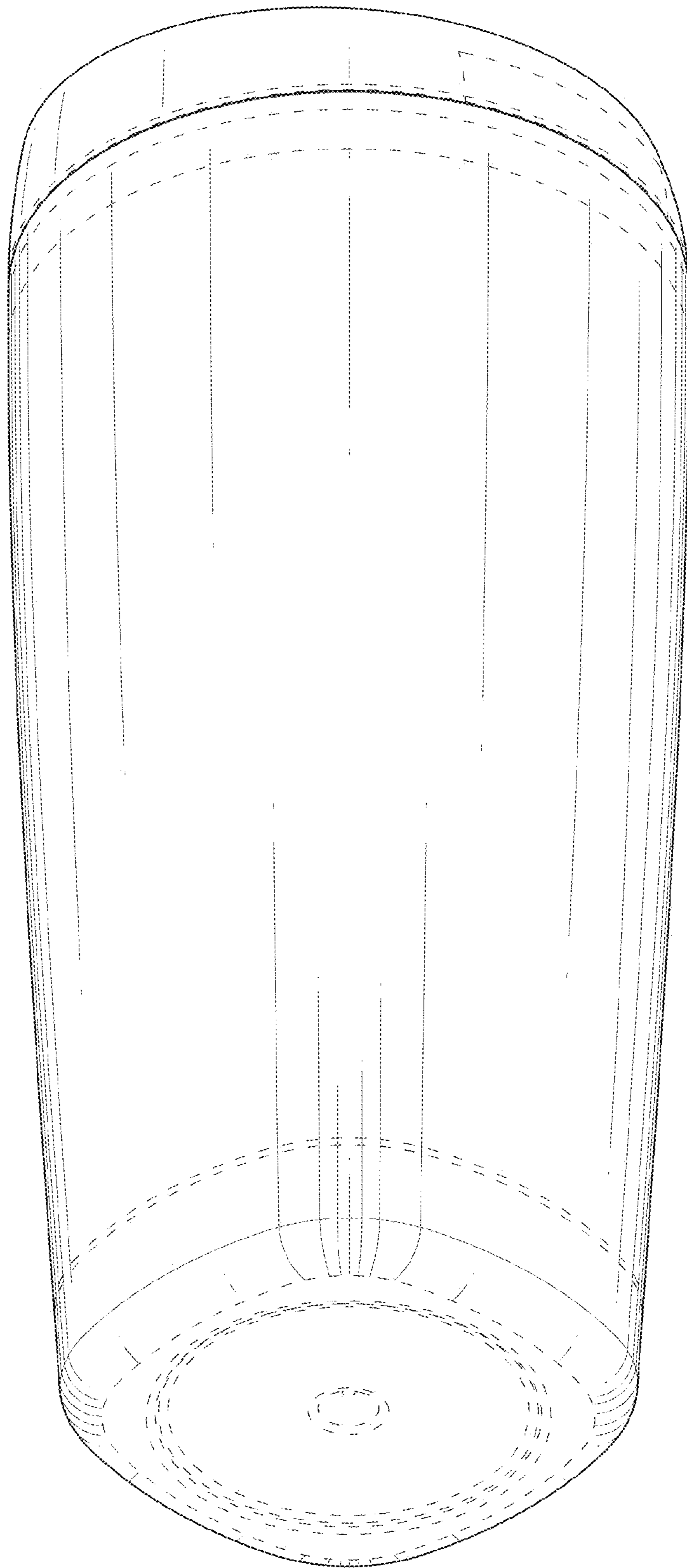

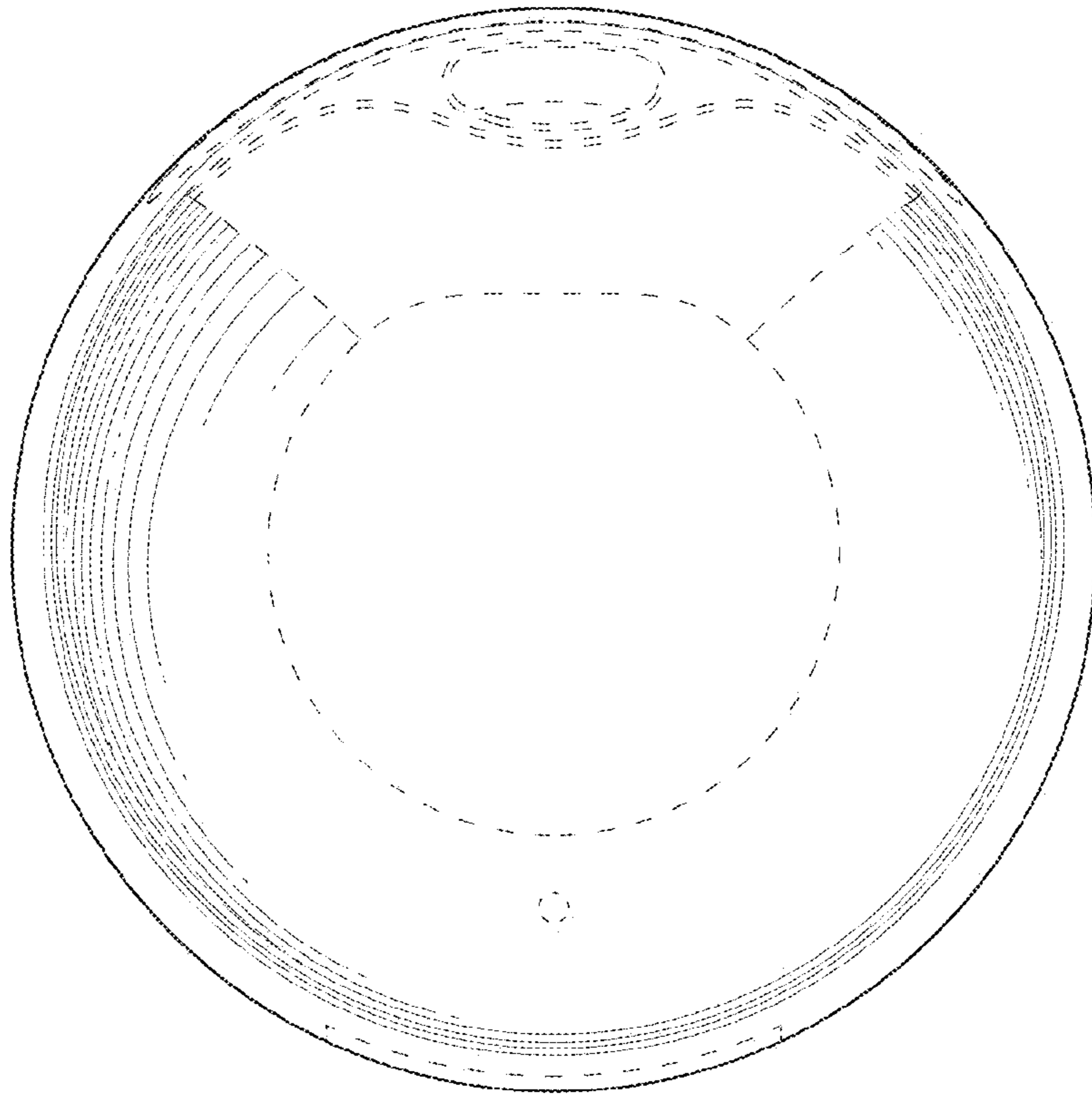

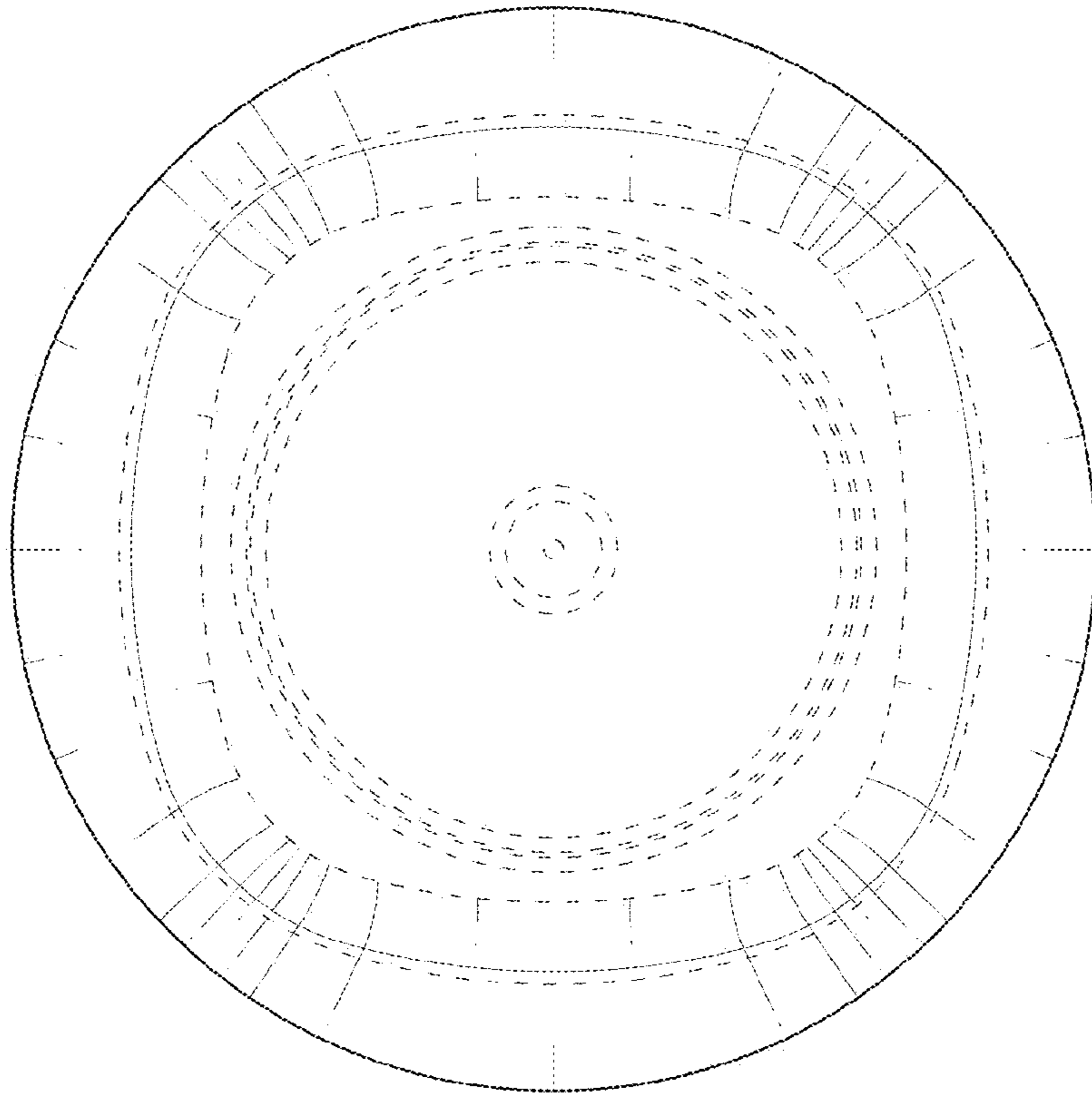

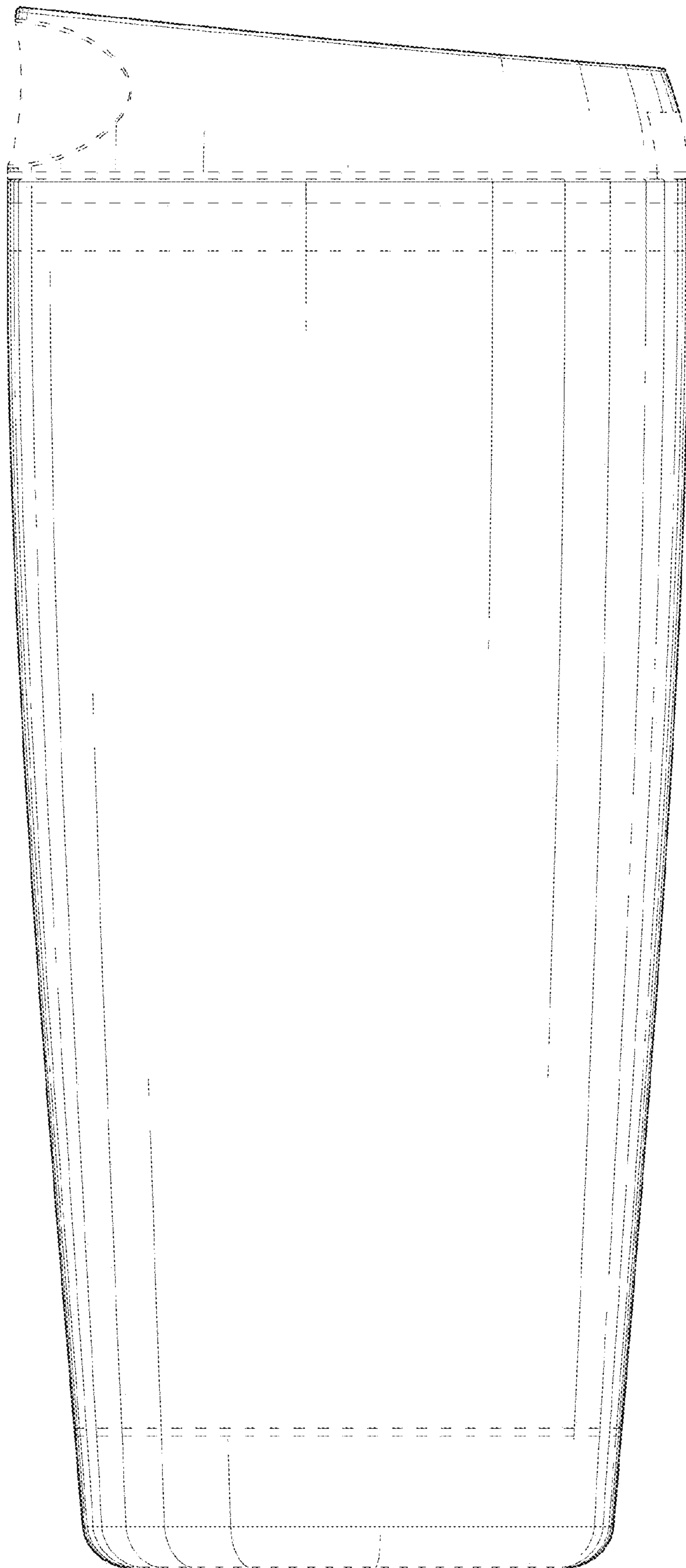

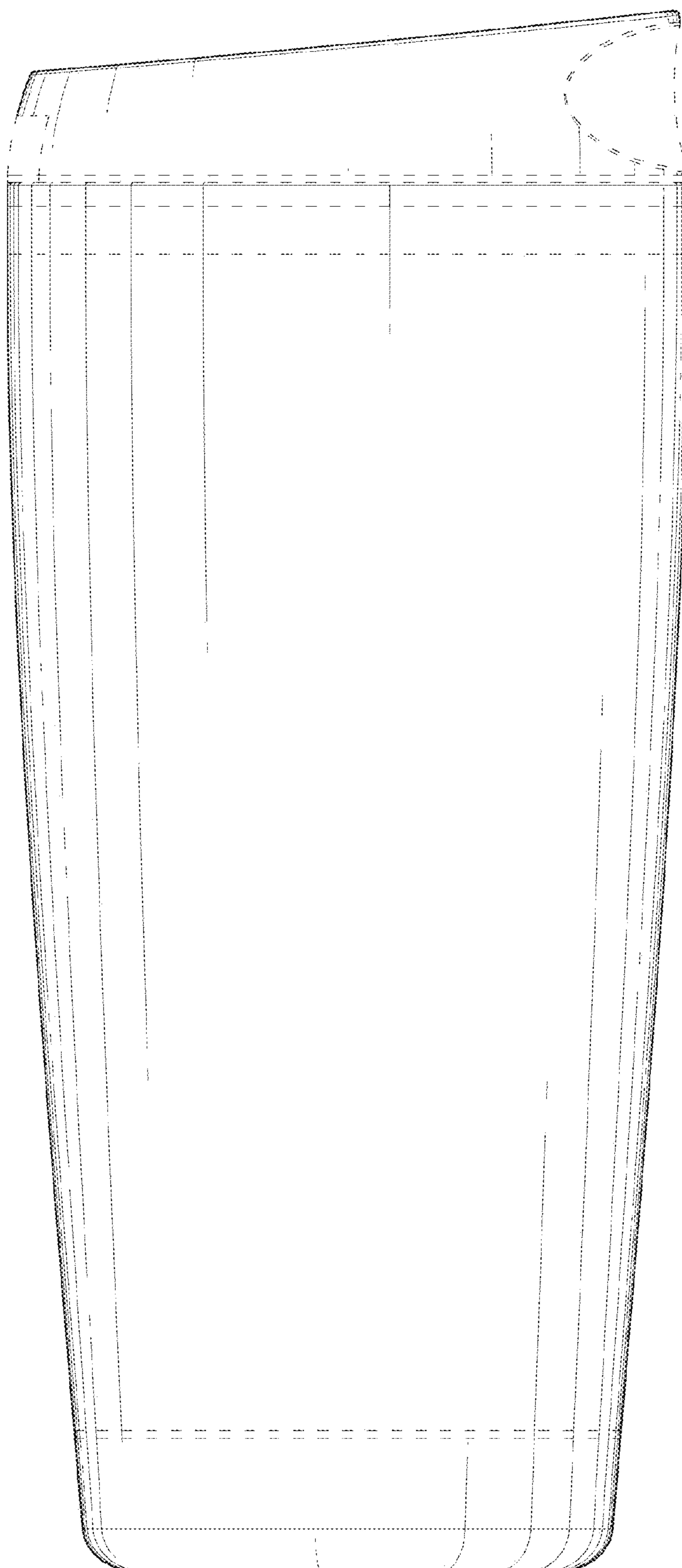

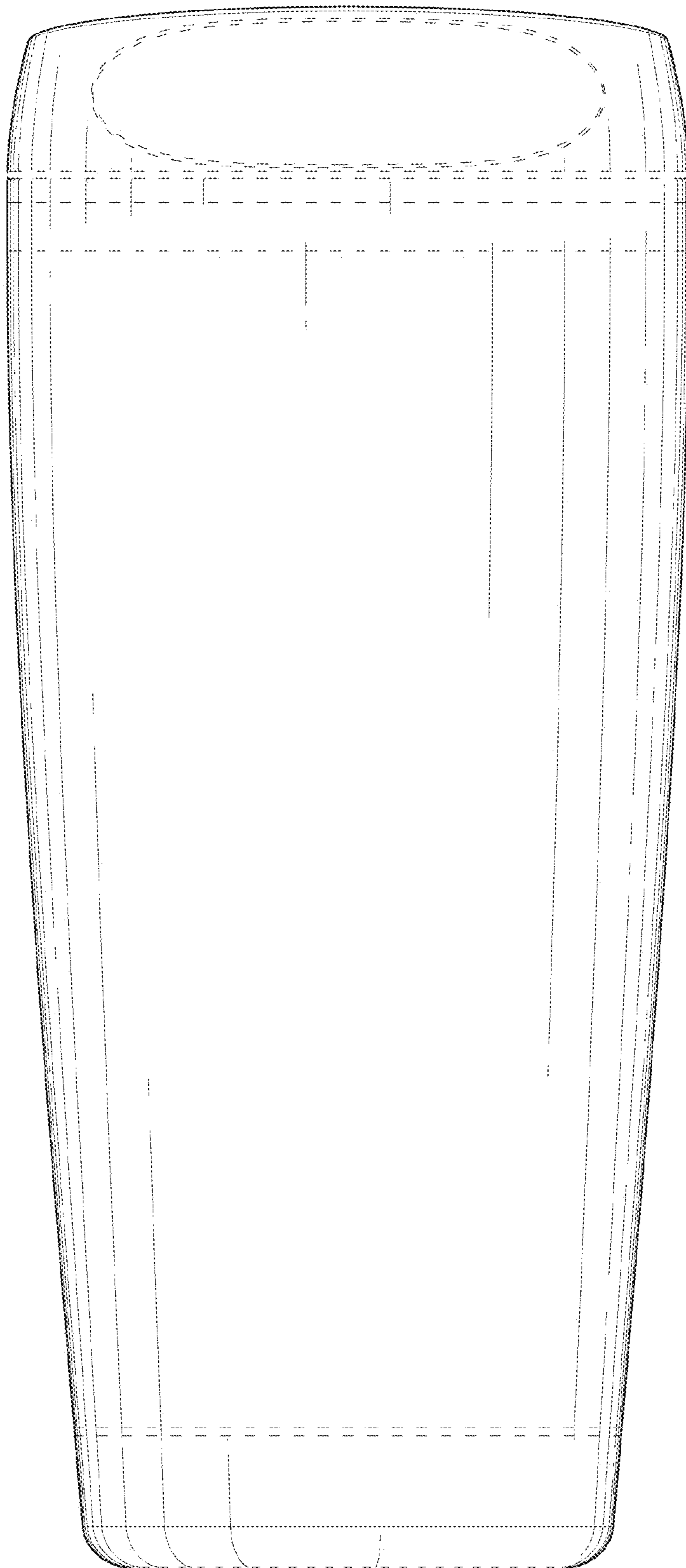

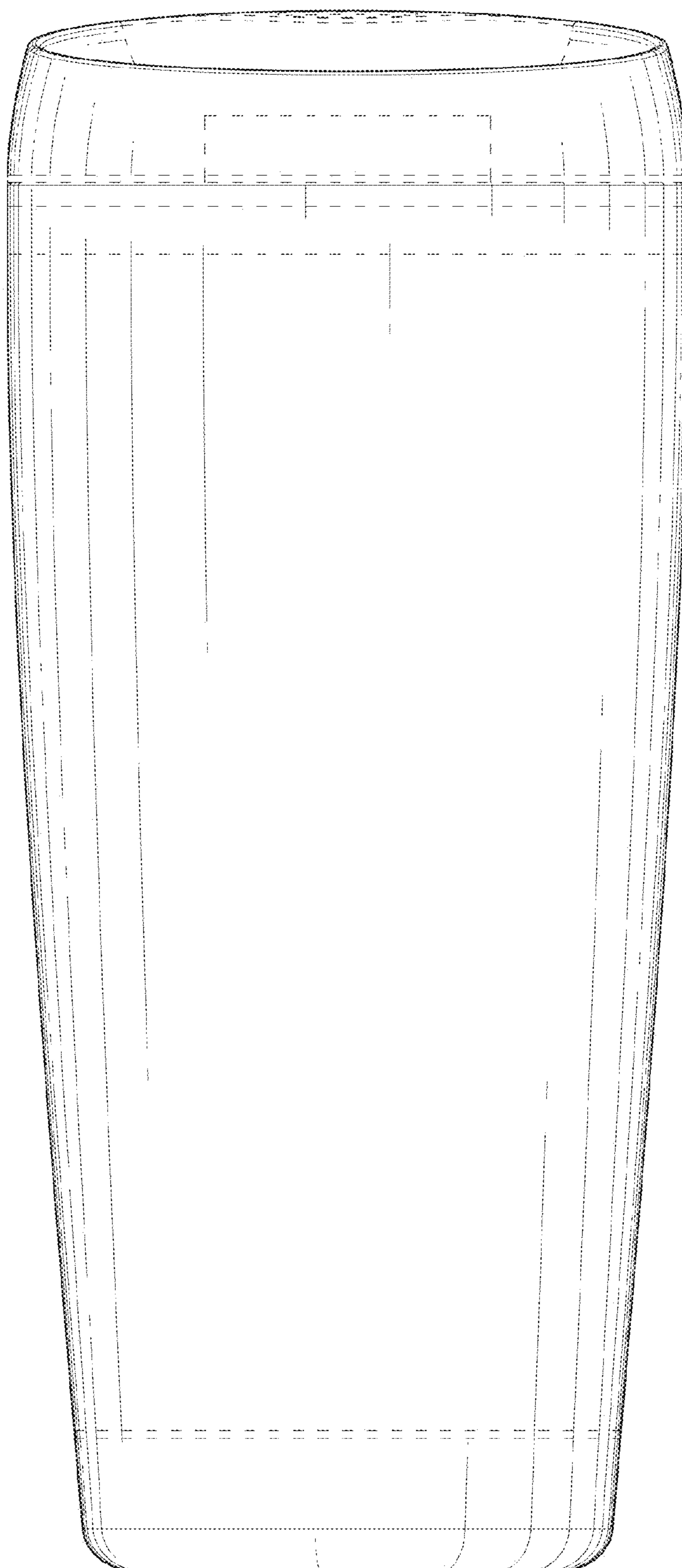
