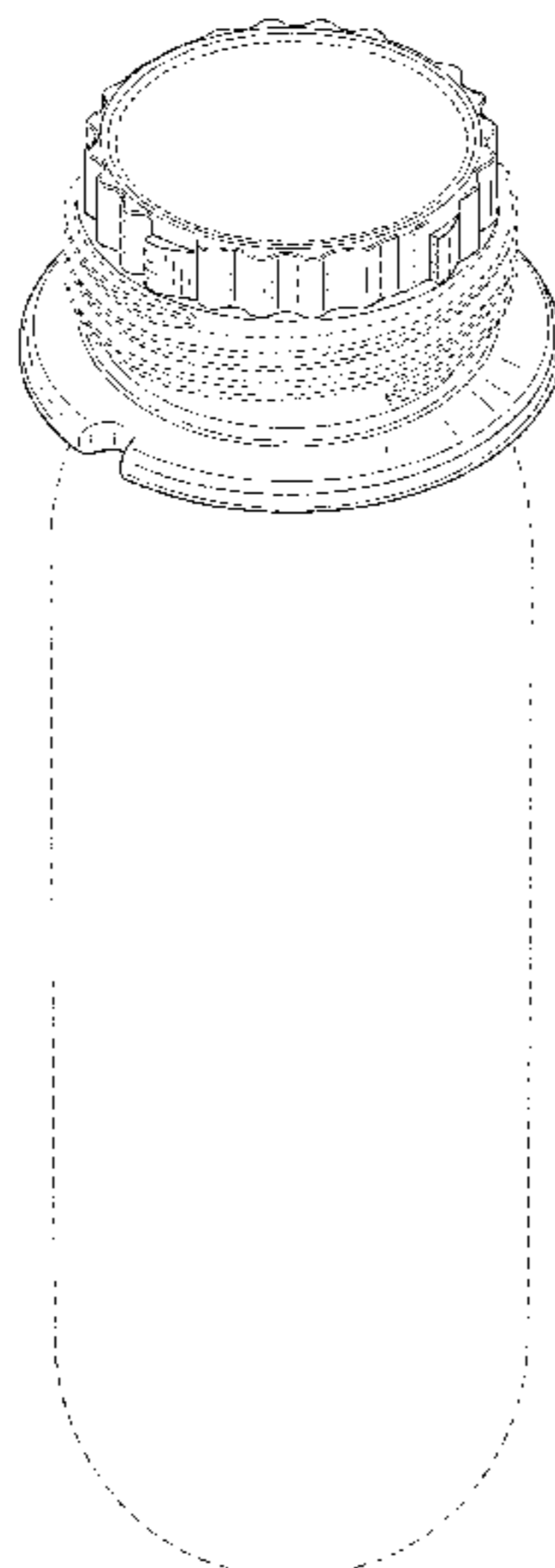
We claim the ornamental design for a container with ribbed neck, as shown and described.

DESCRIPTION

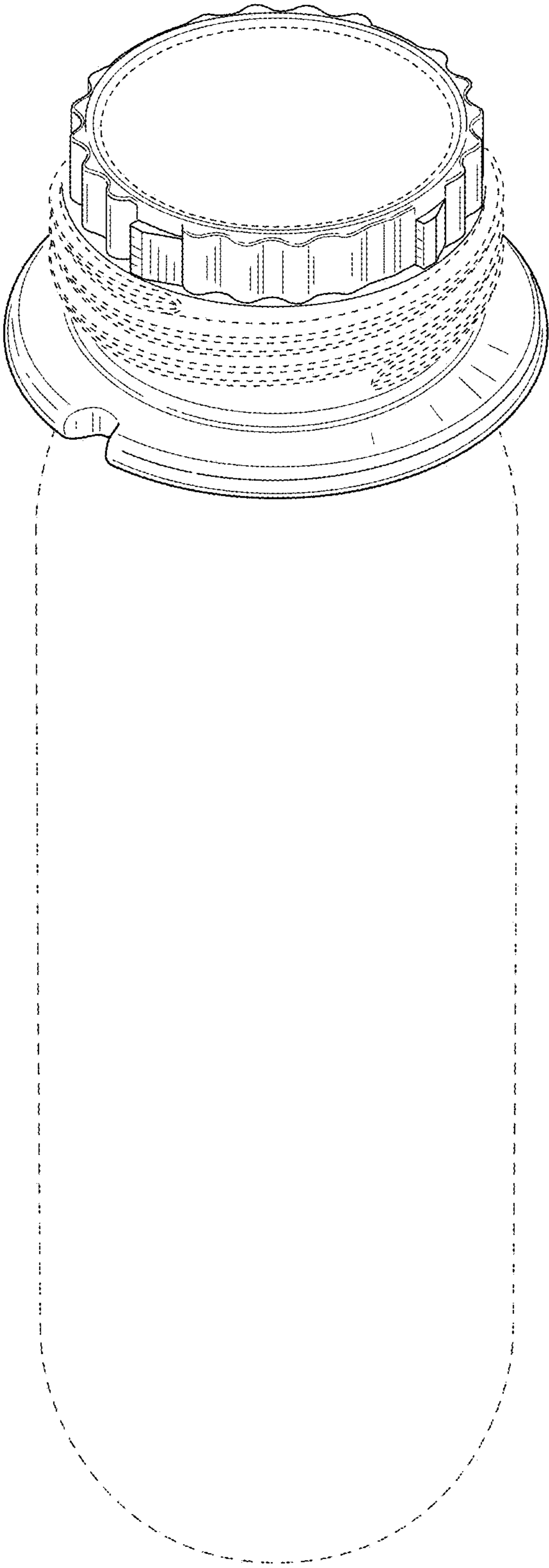

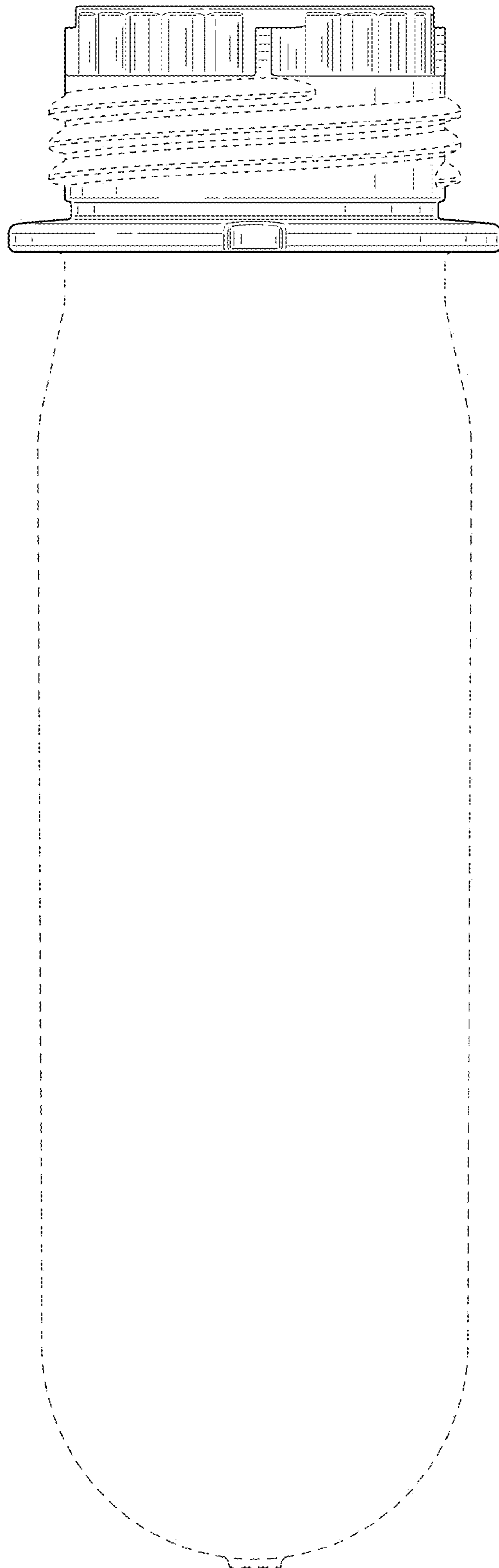

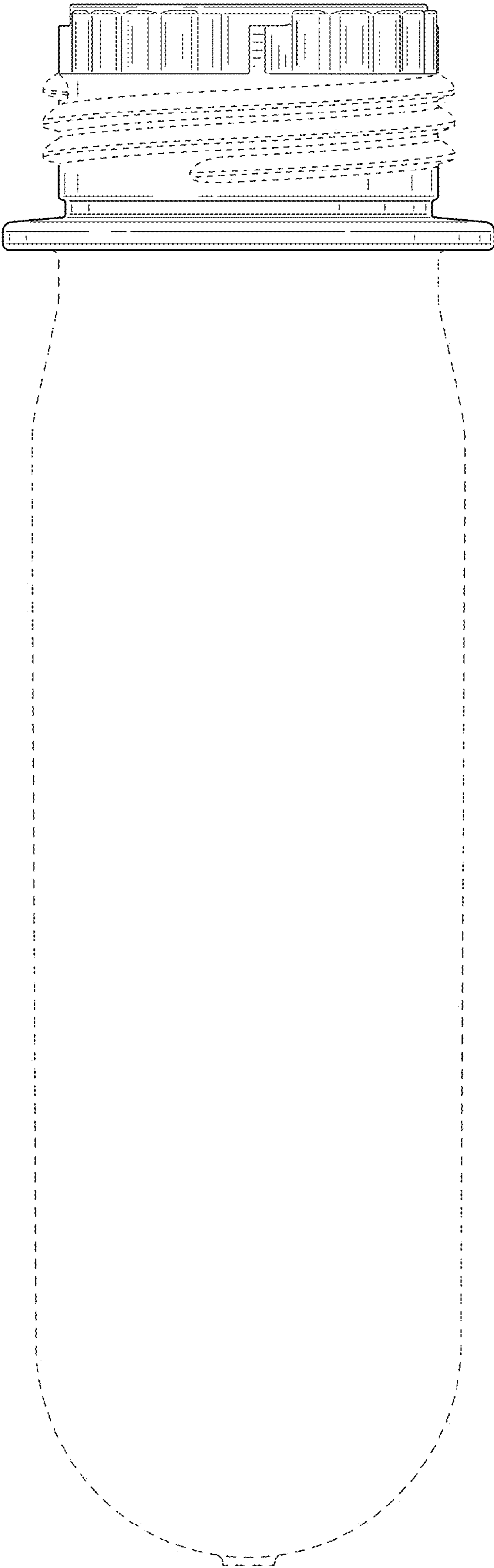

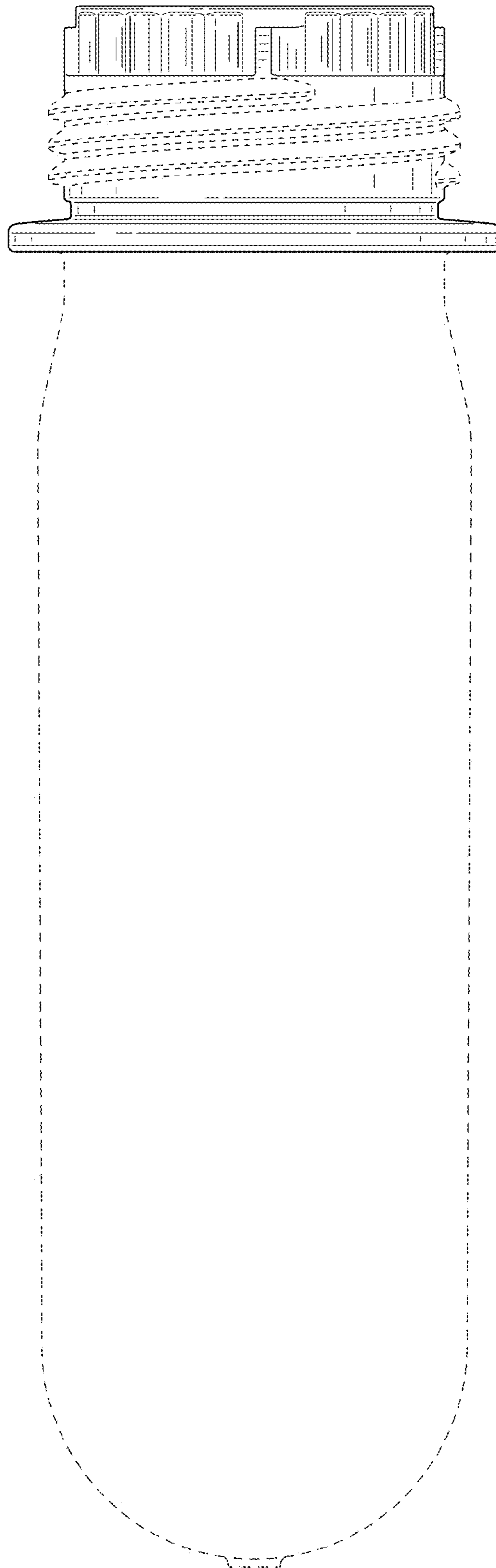

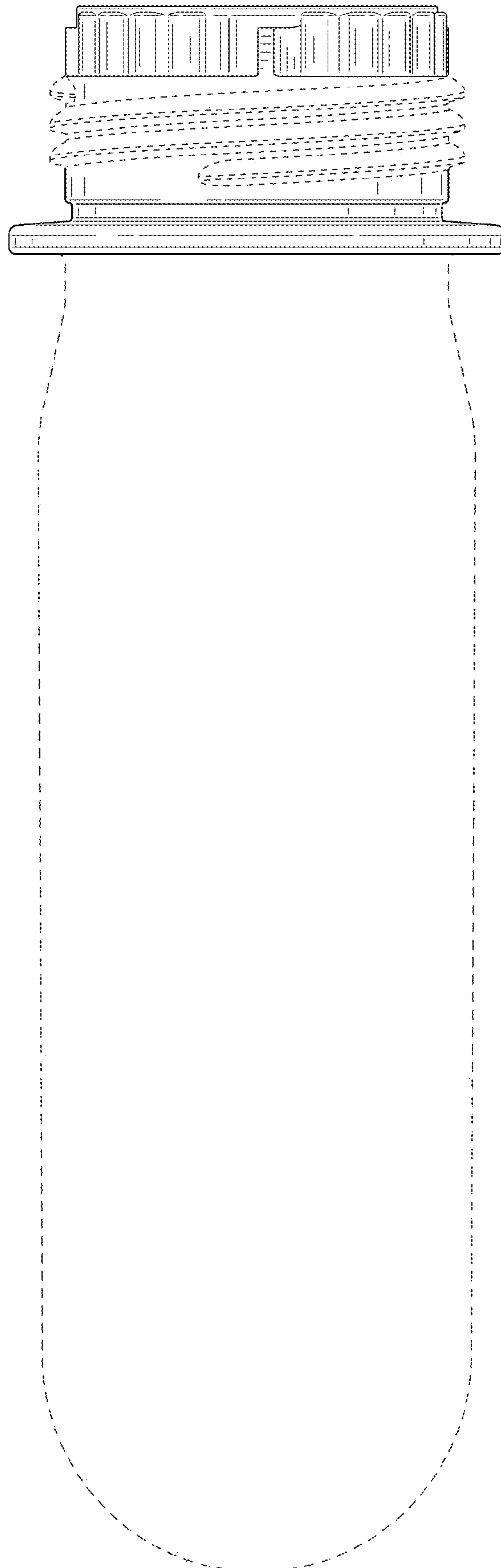

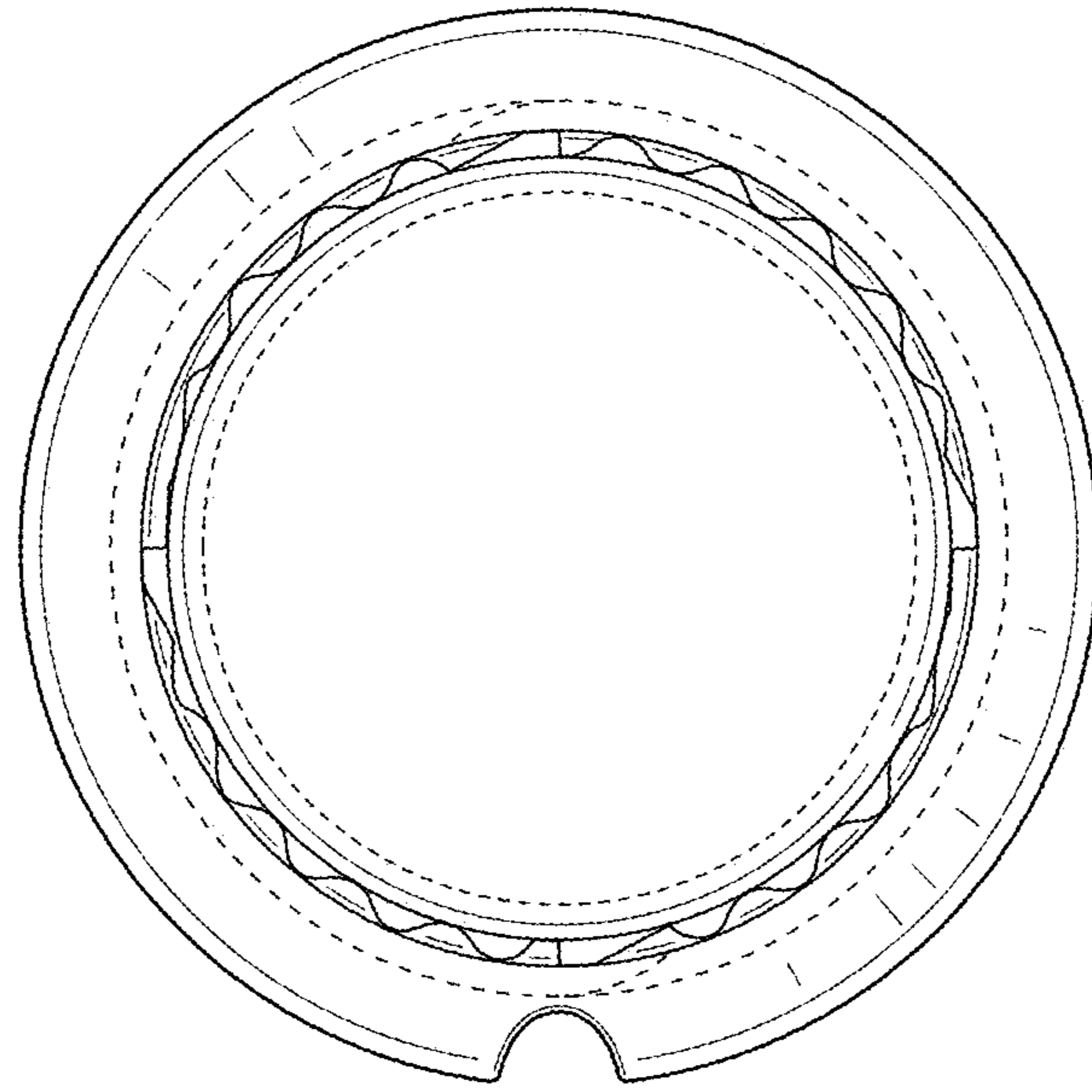

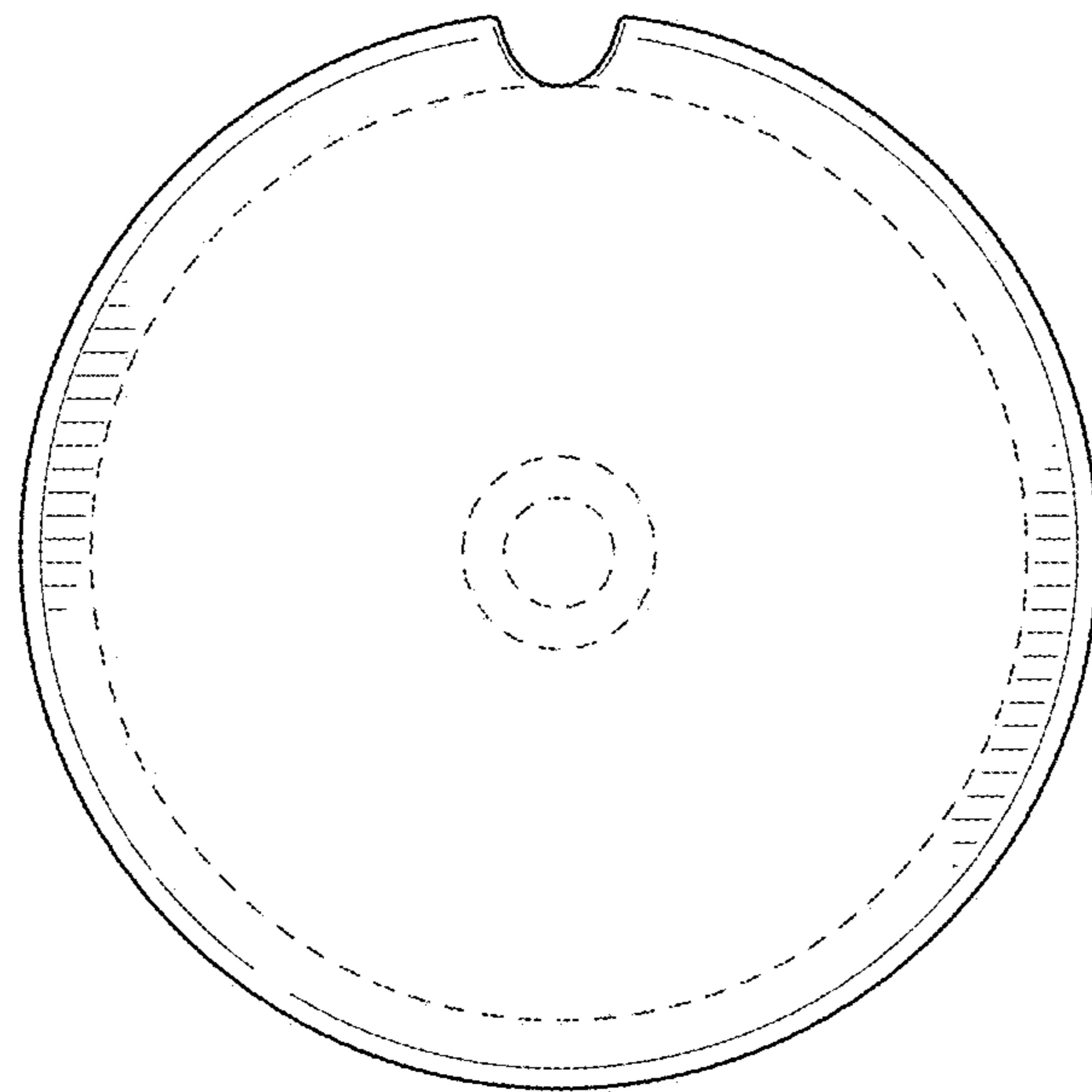
