(57) **CLAIM**

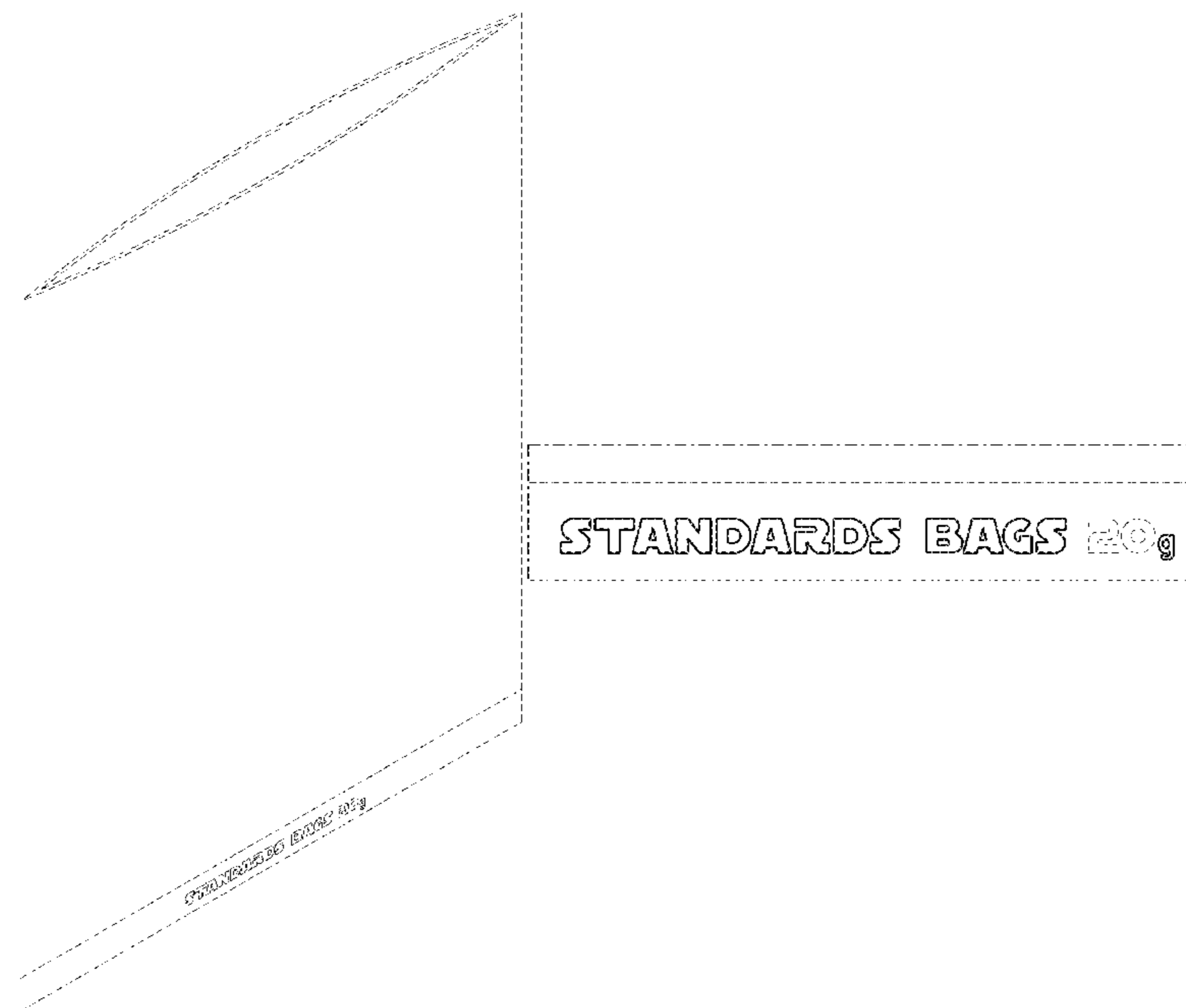
The ornamental design for a bag with surface ornamentation, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the bag with surface ornamentation, embodying my new design;

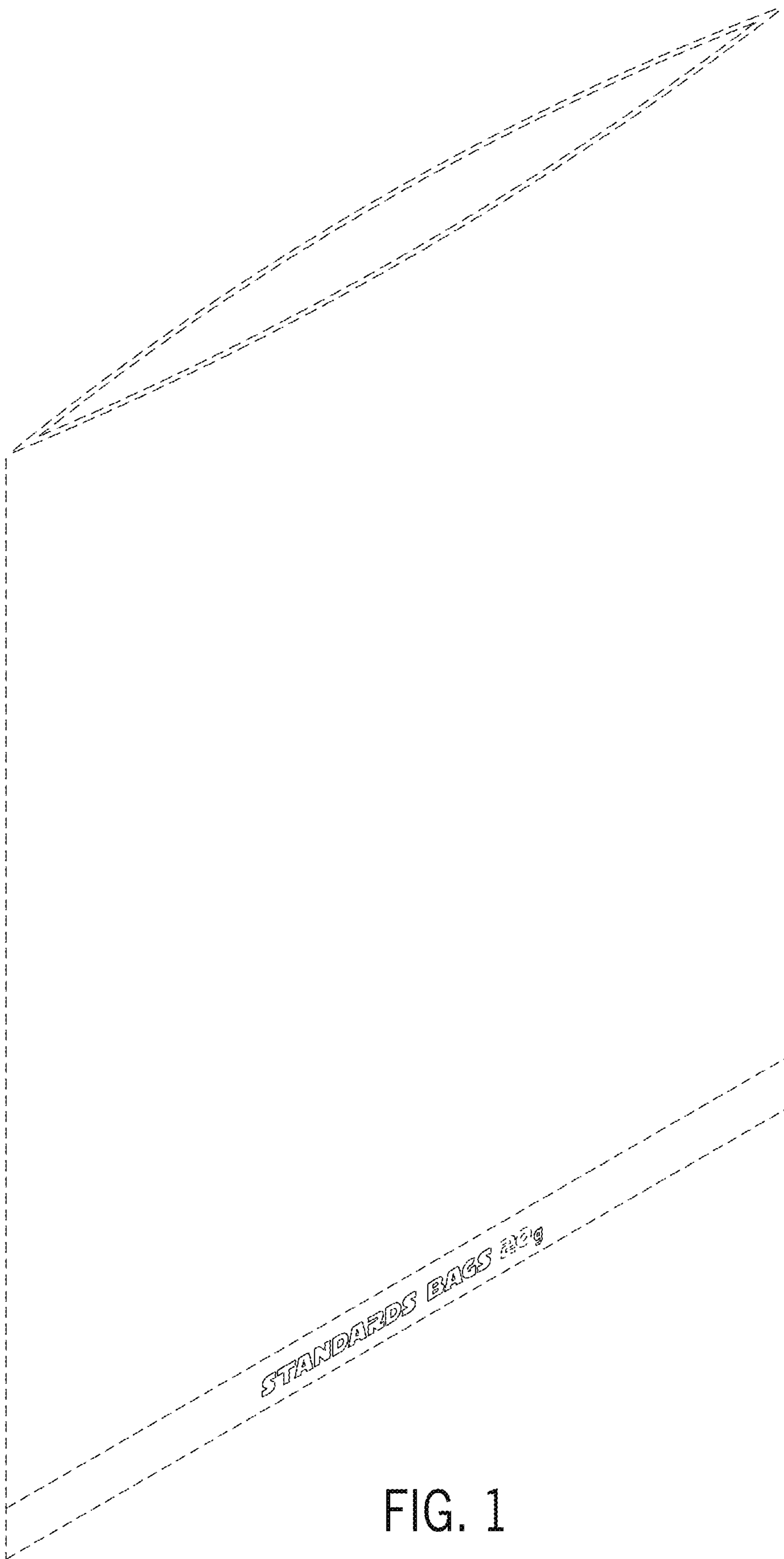

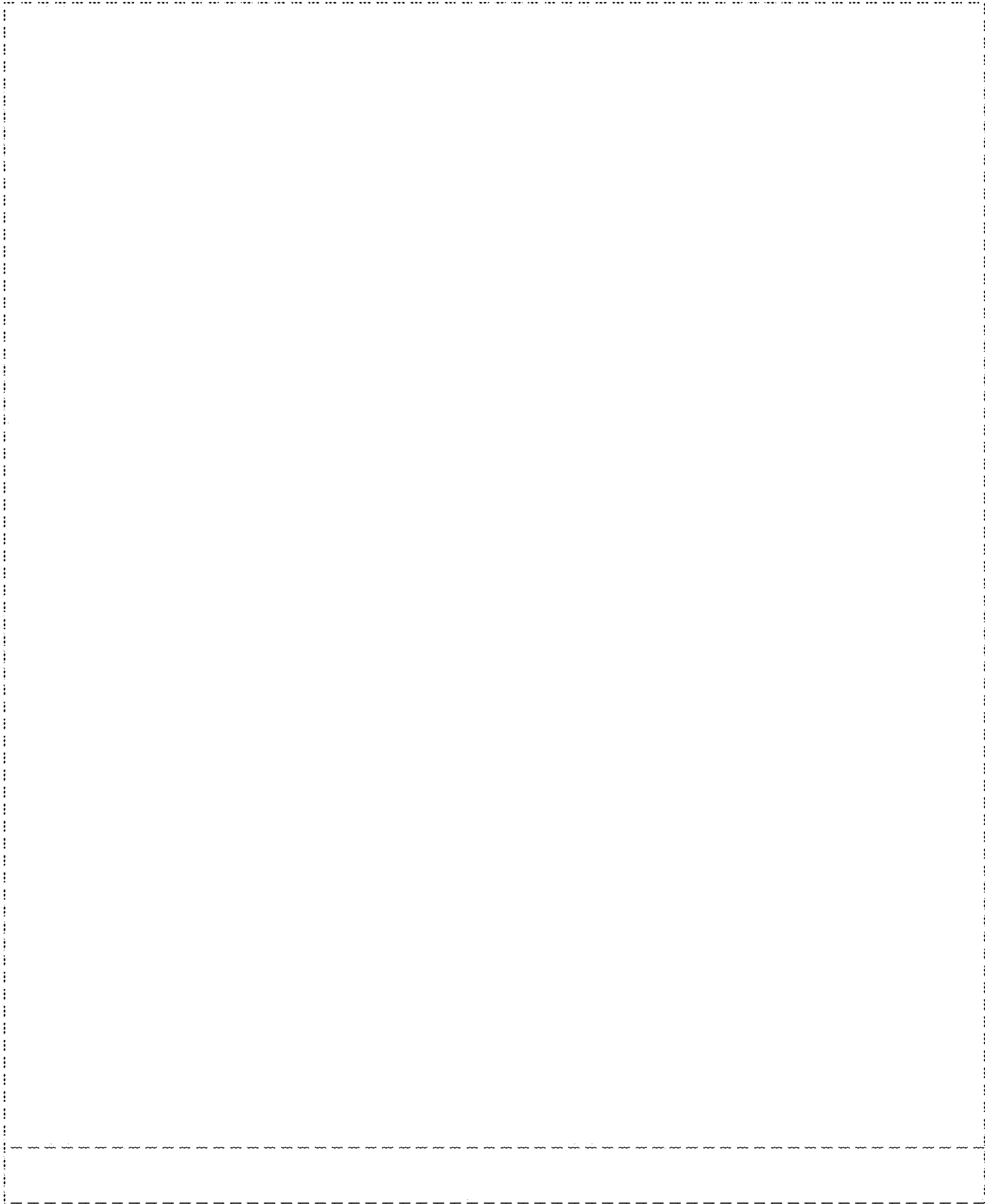

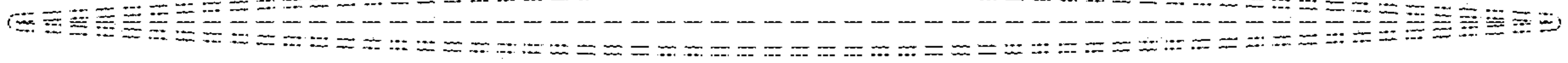

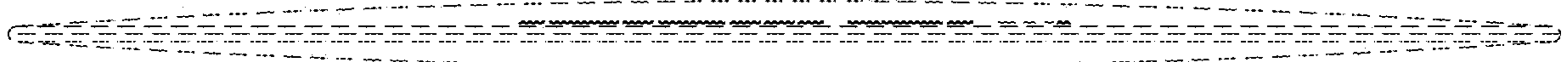
