(57) **CLAIM**

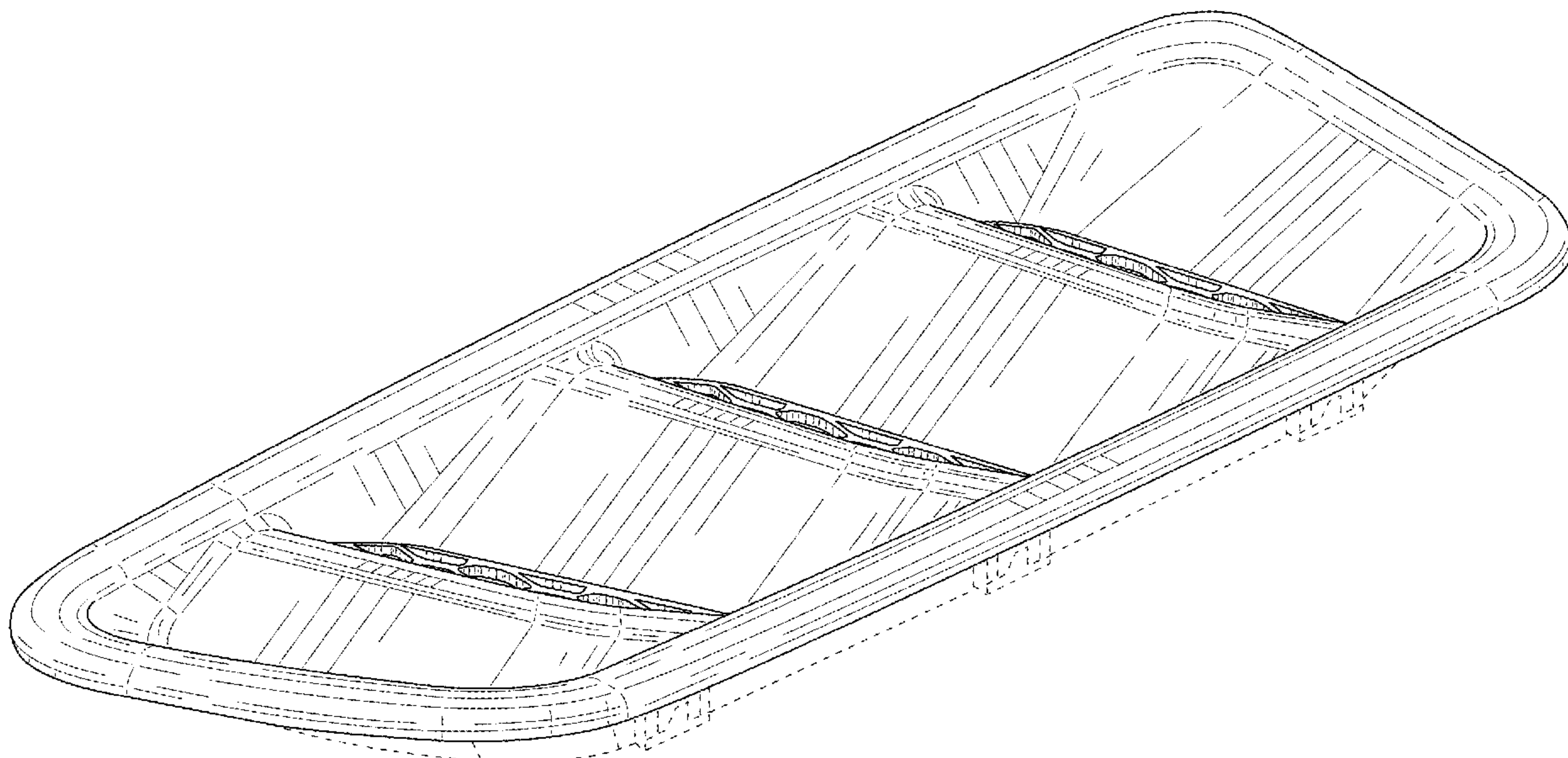
The ornamental design for an air inlet bezel, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an air inlet bezel showing our new design;

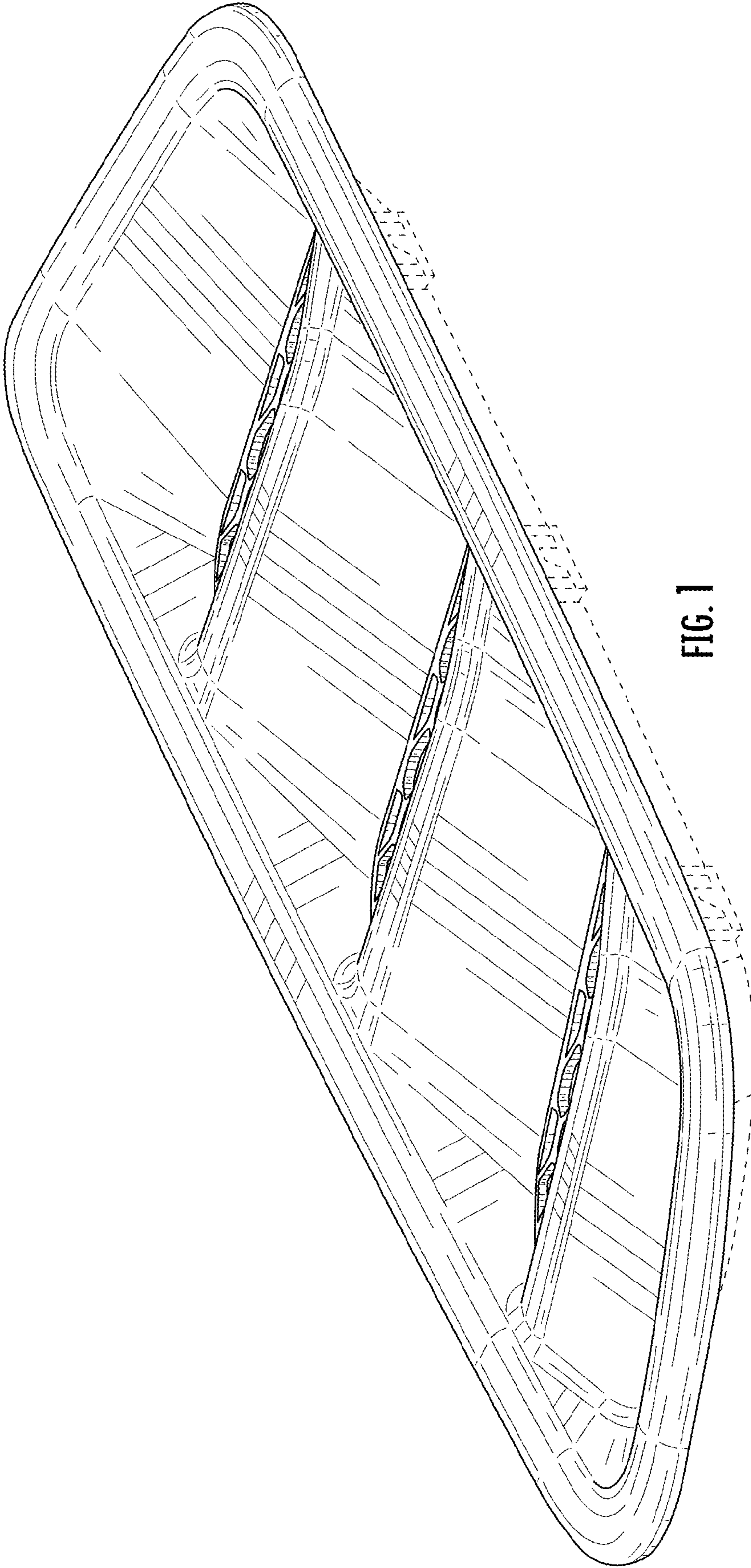

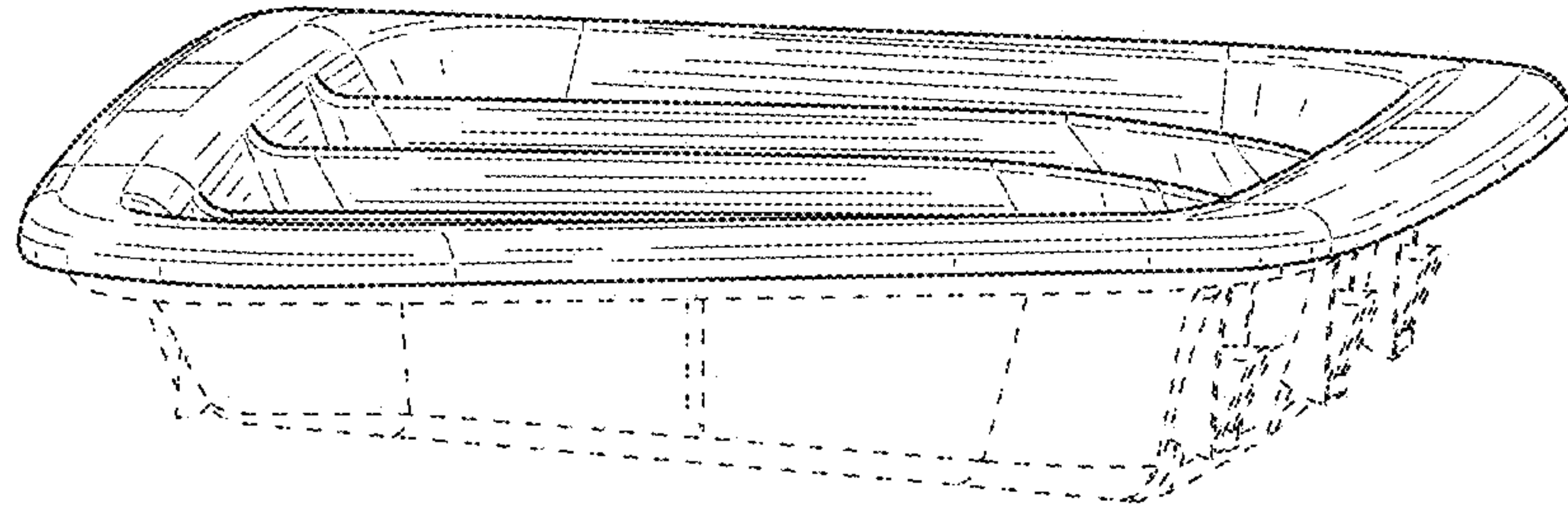

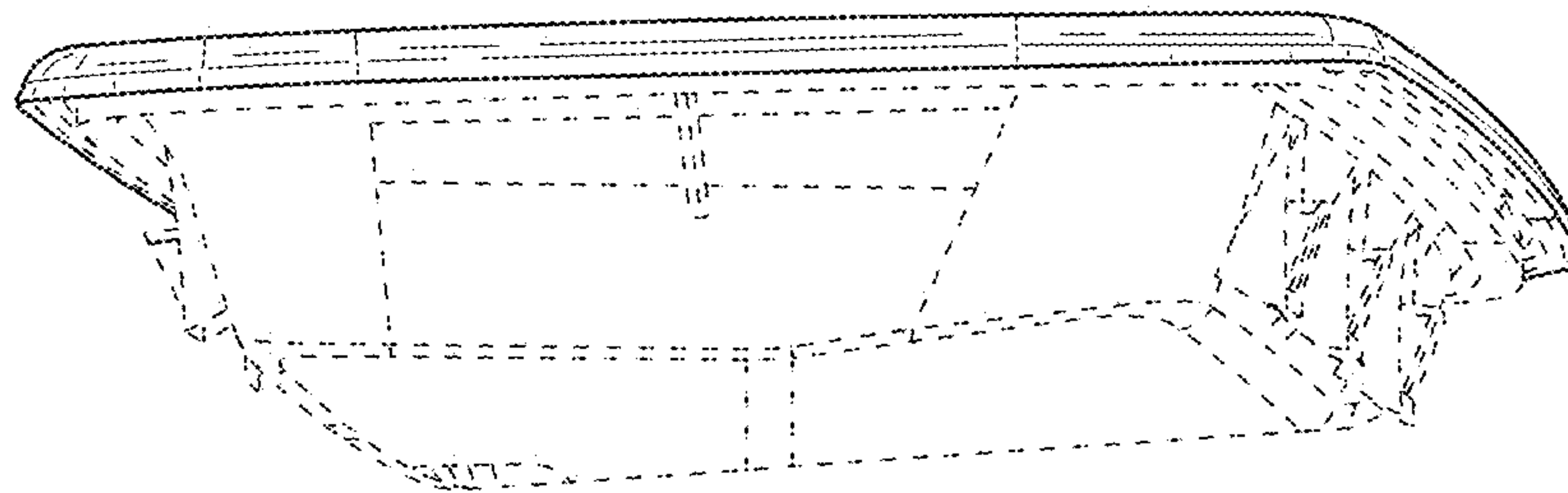

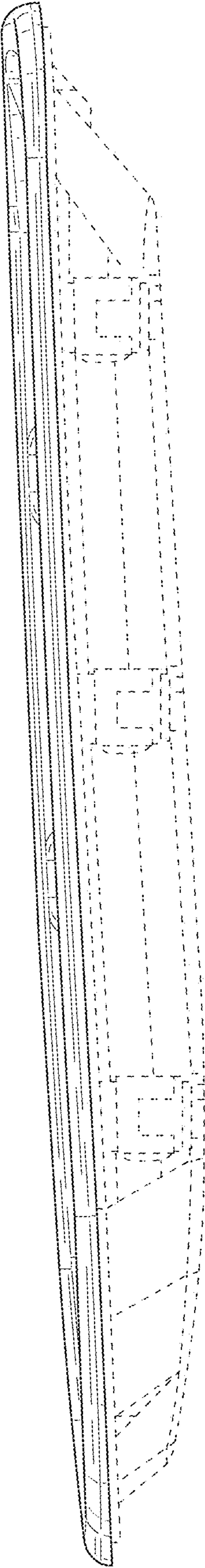

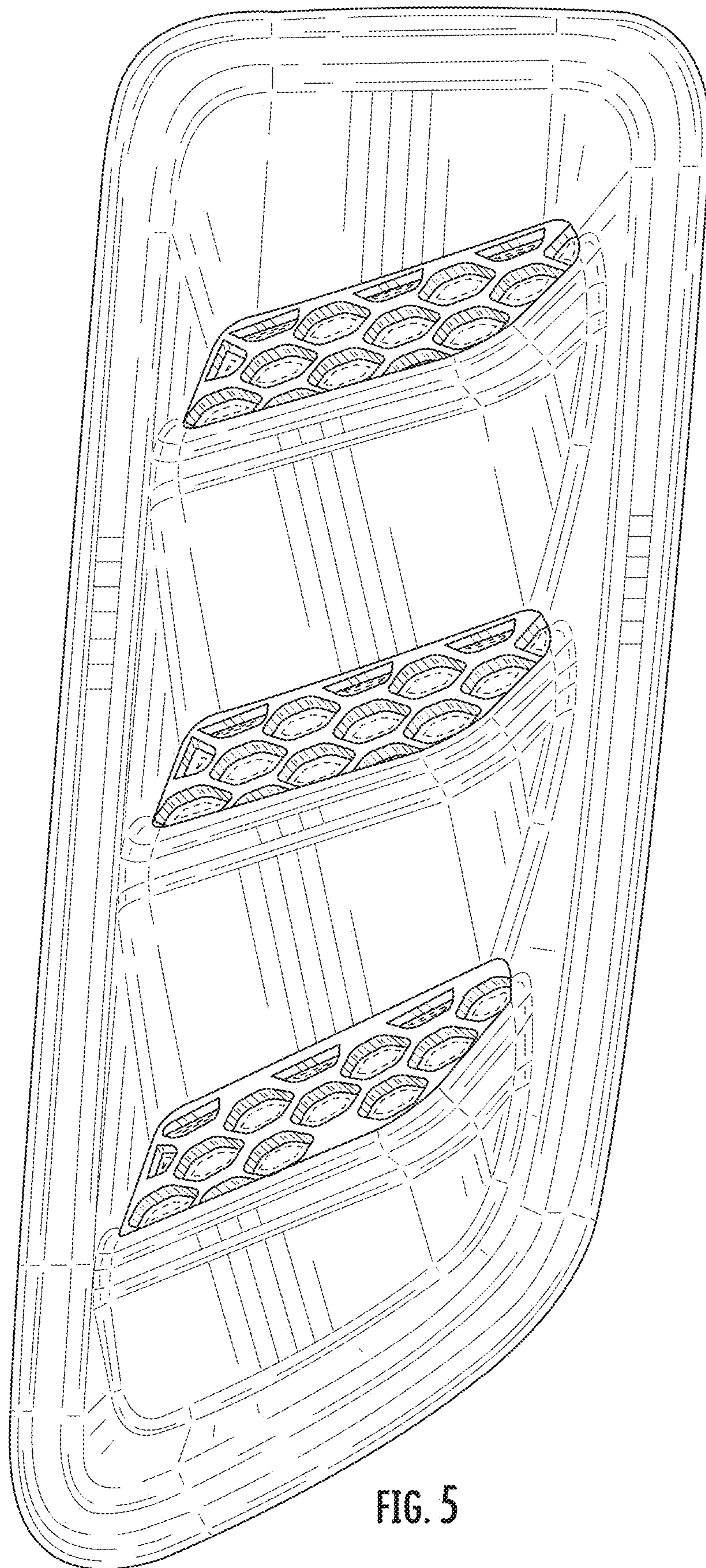

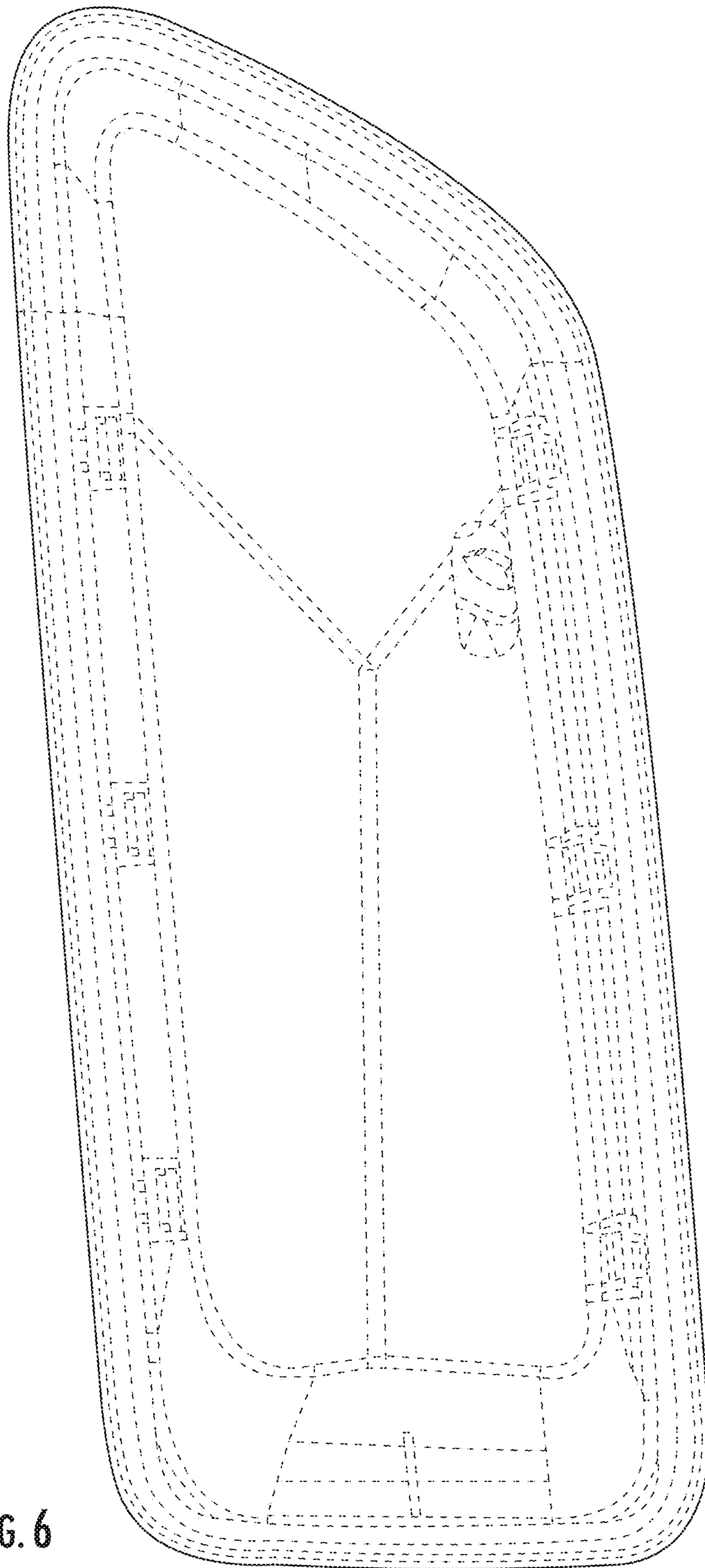
