**DESCRIPTION**

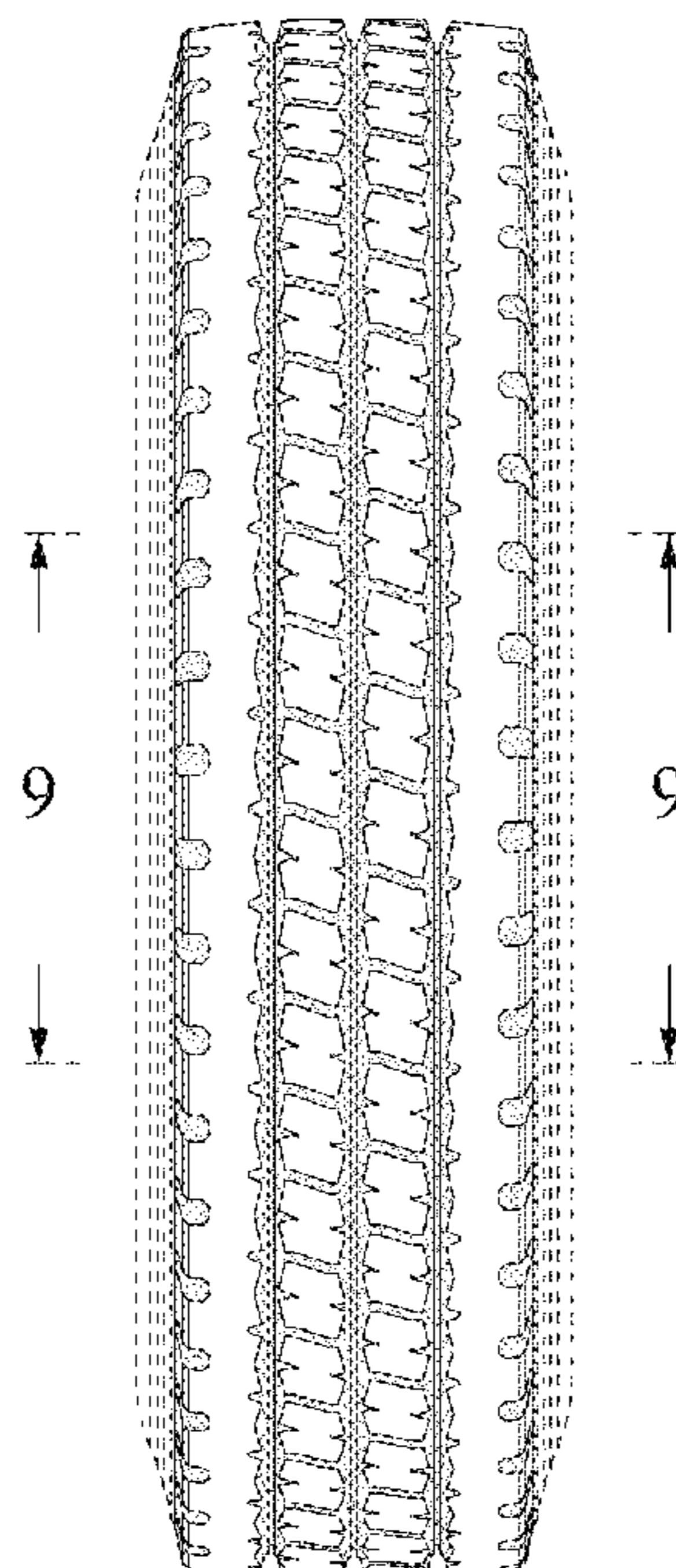
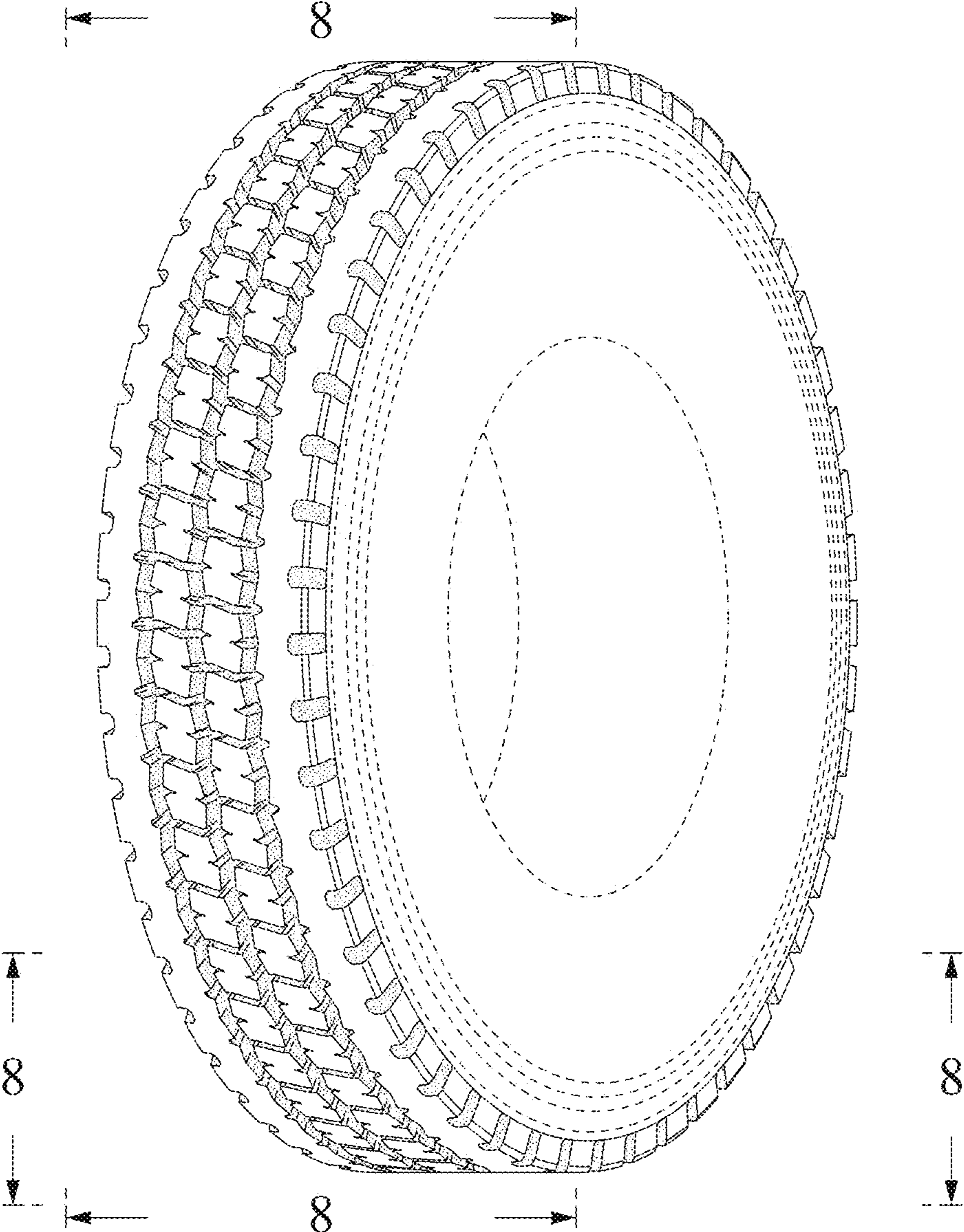
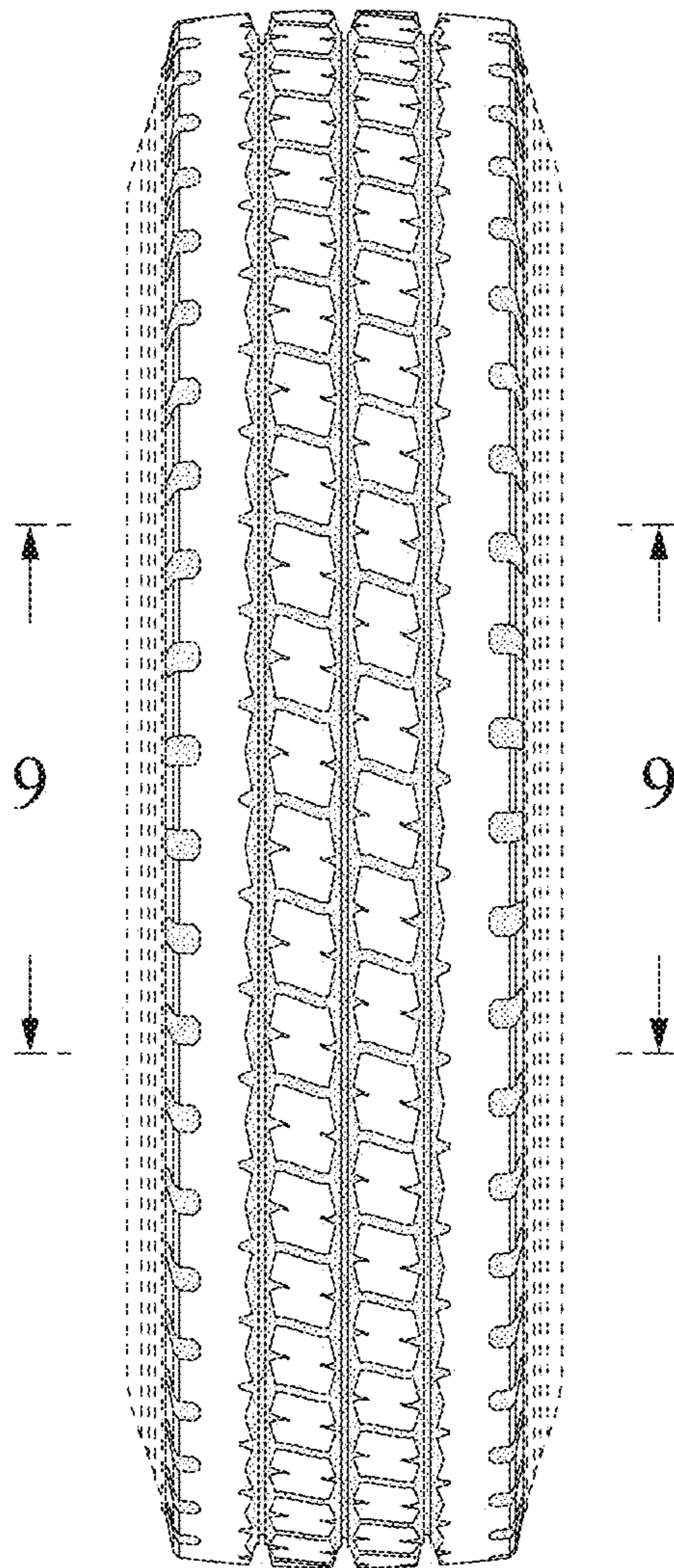


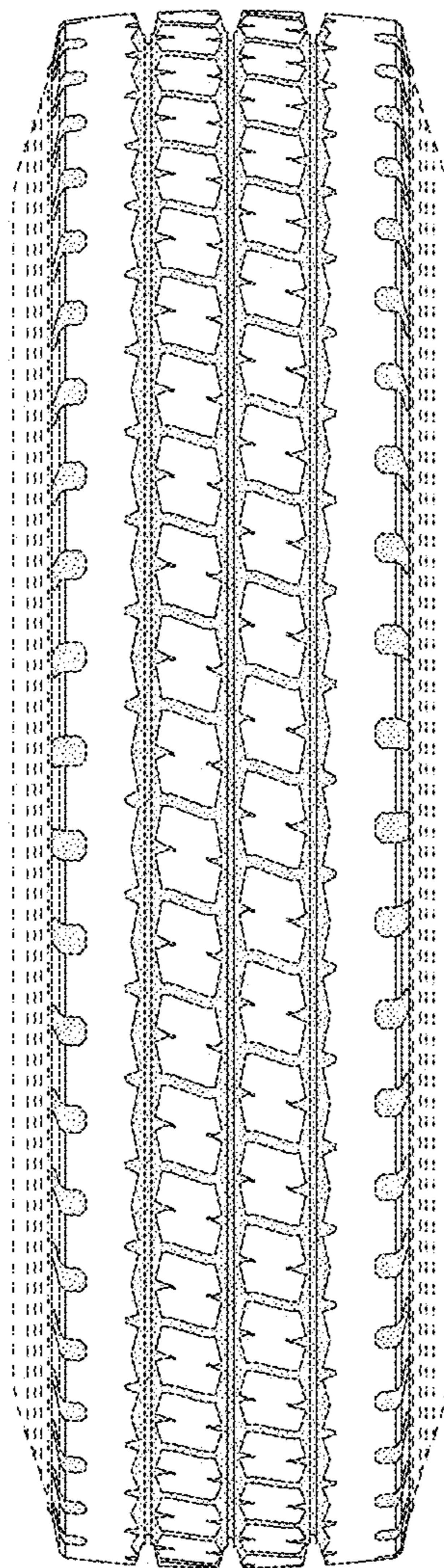

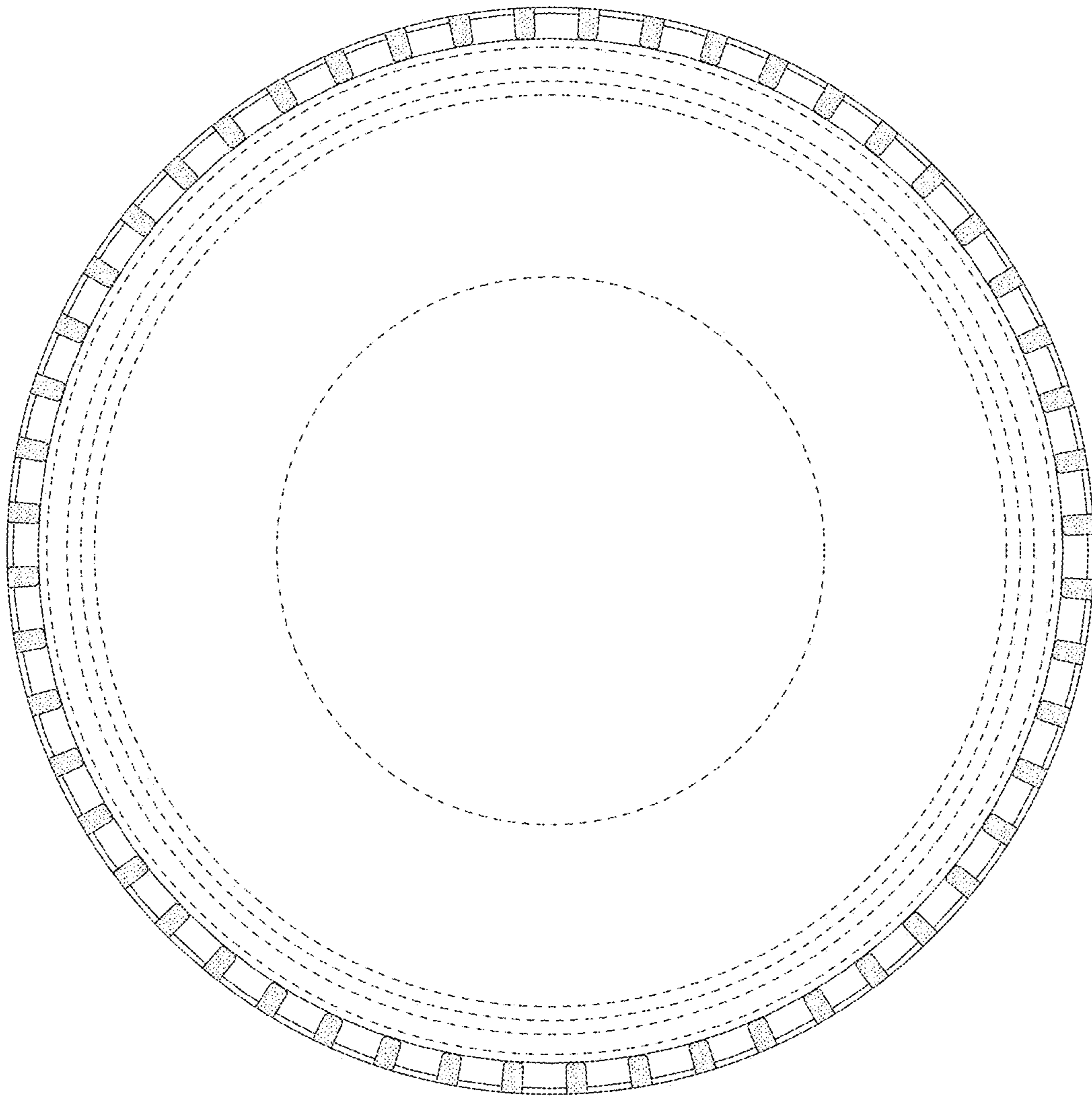

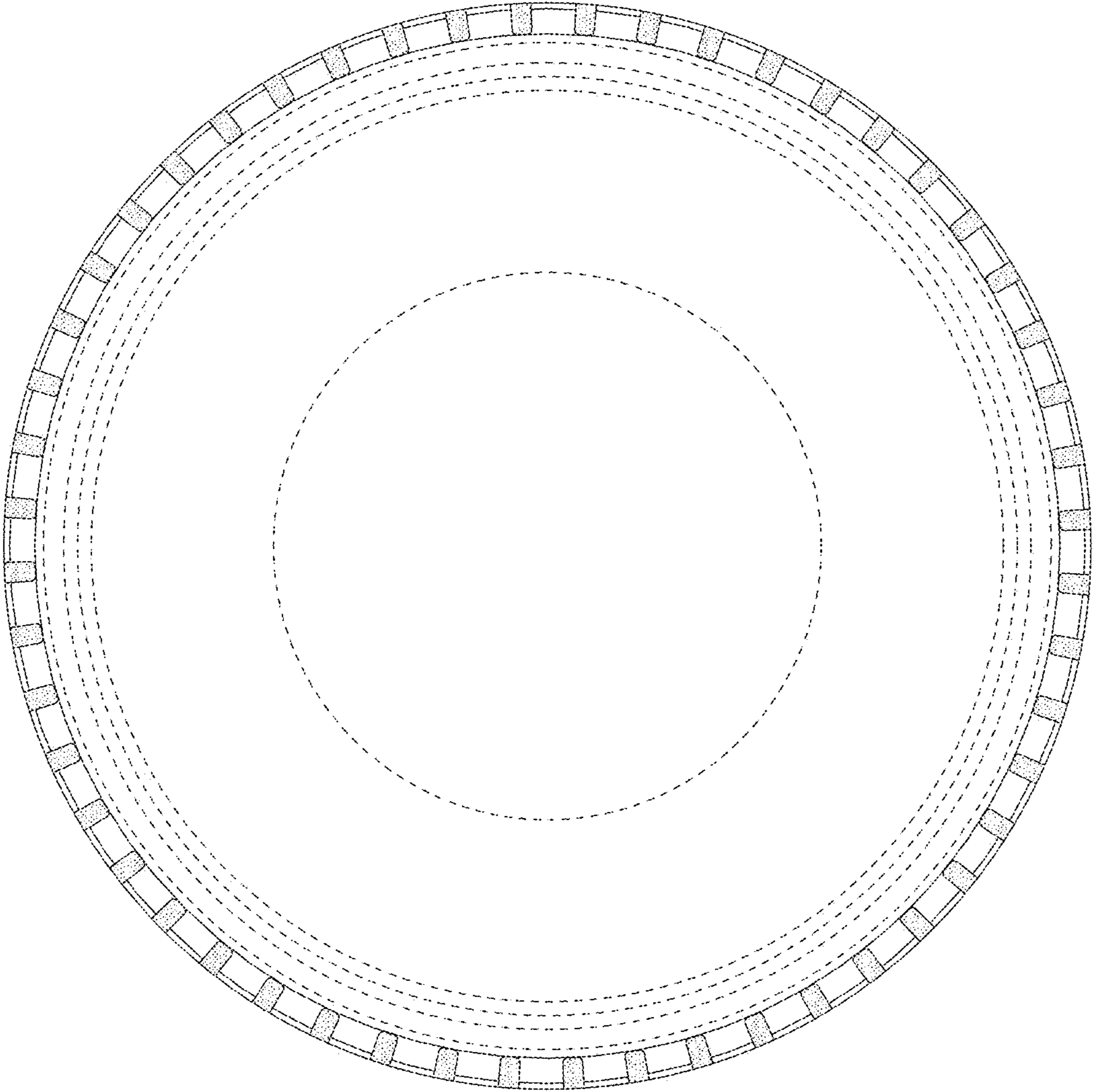

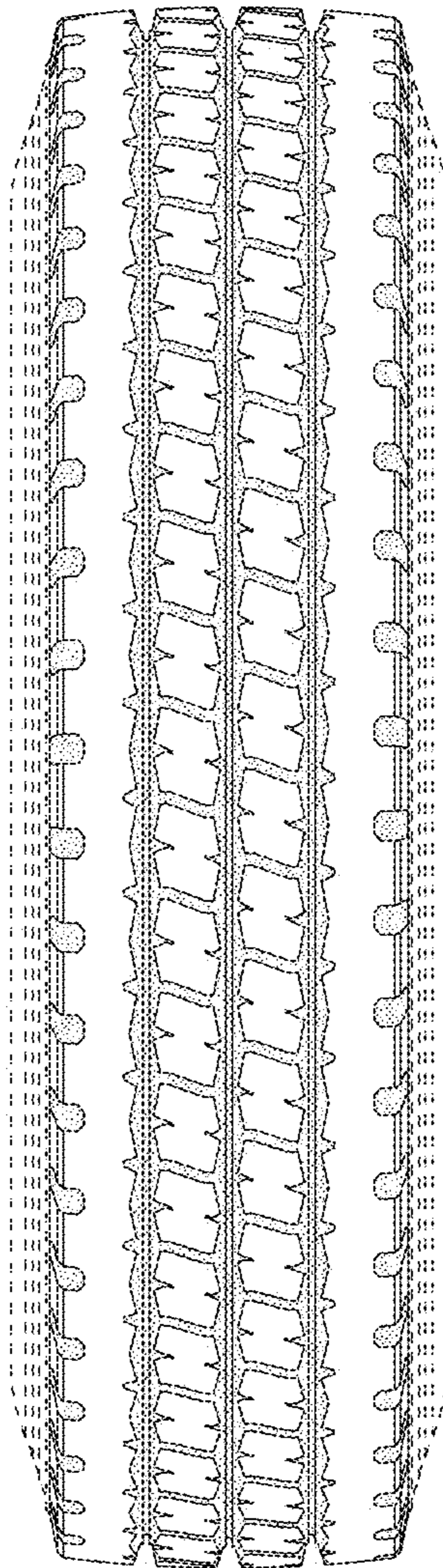

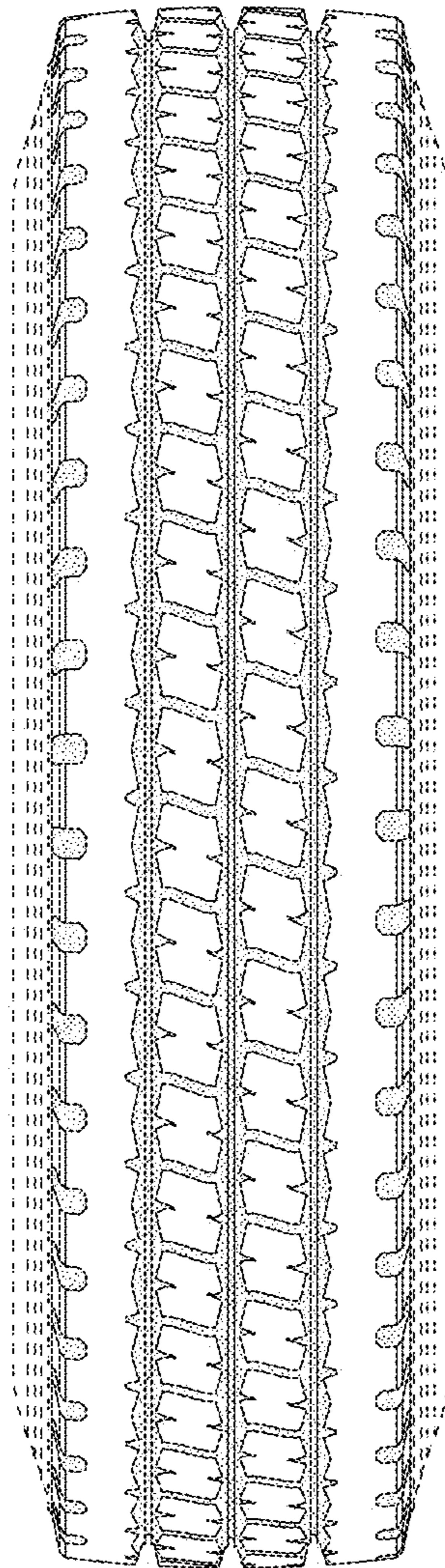

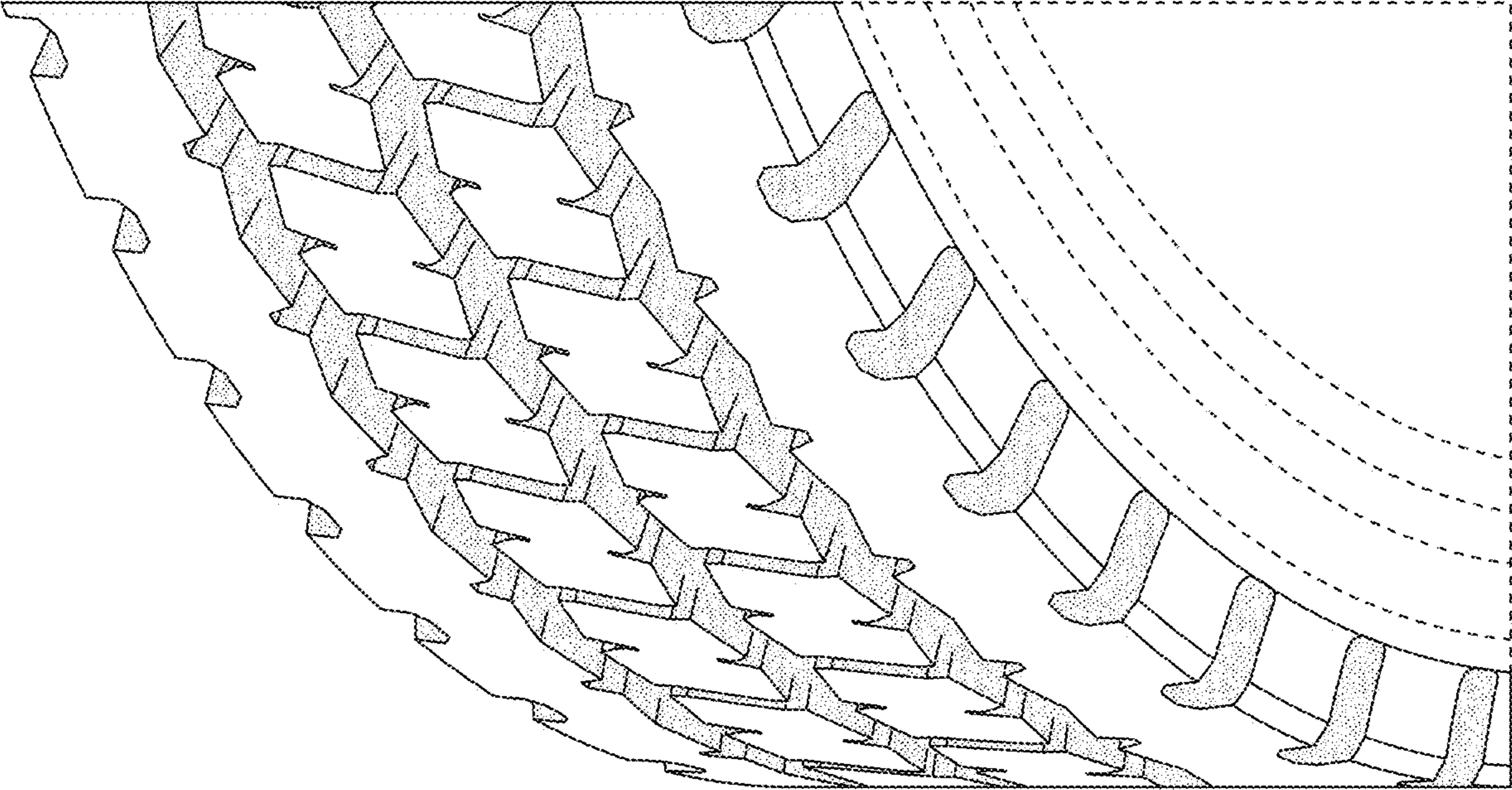
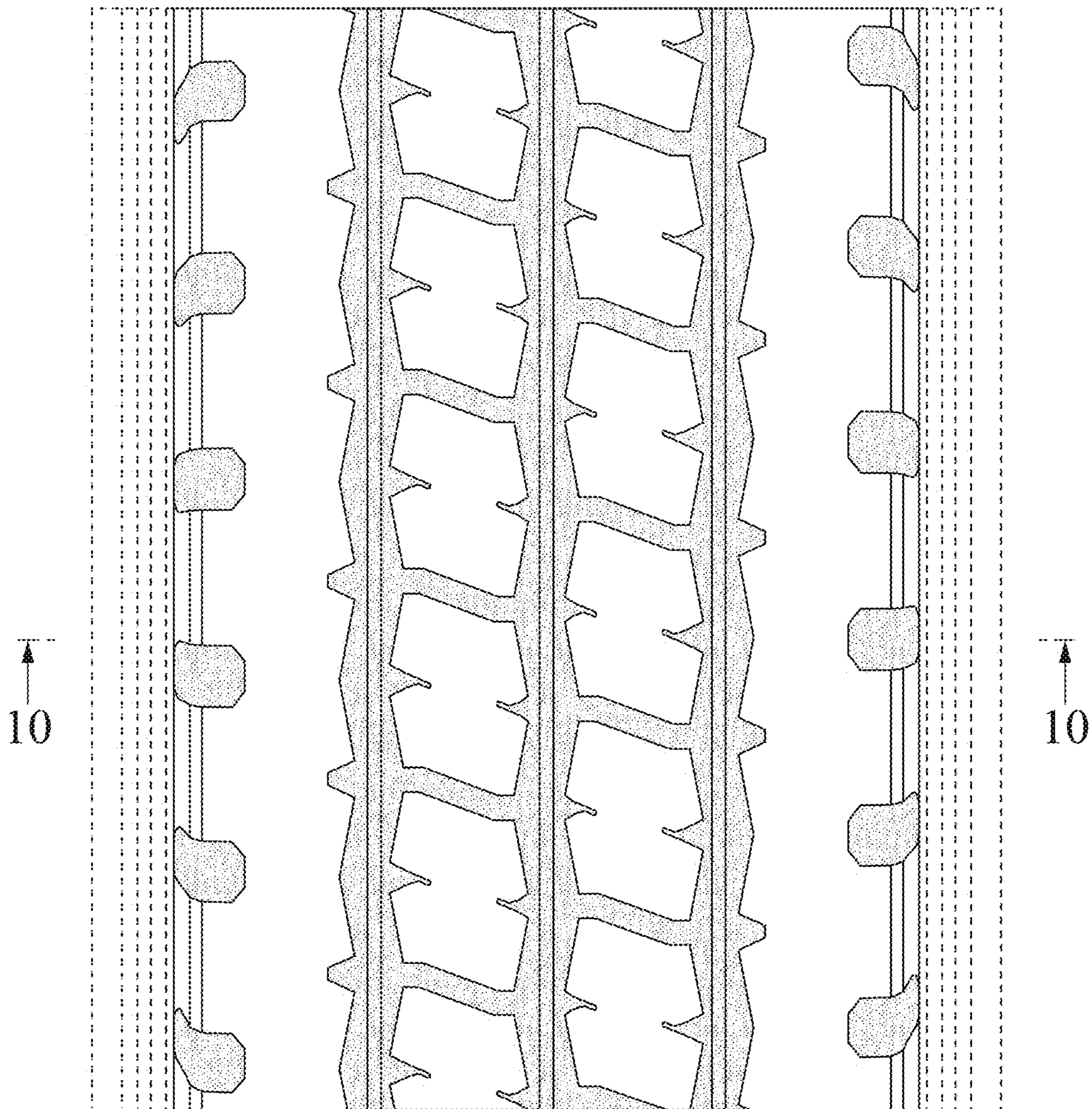
