**DESCRIPTION**

FIG. 1 is a top, front, right side isometric view of a loudspeaker, showing my new design;

FIG. 13 is a top, rear, left side isometric view thereof;

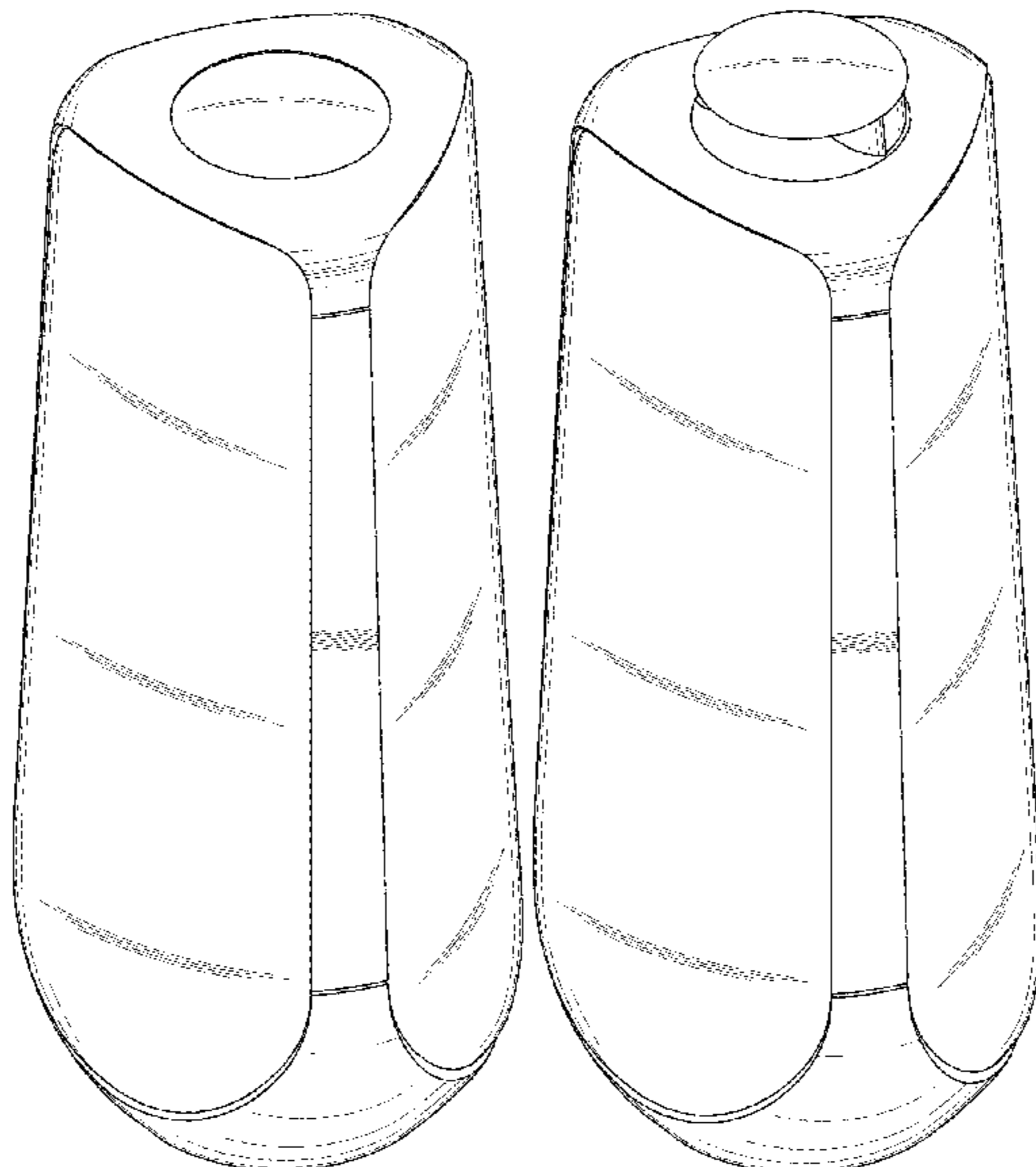
FIG. 14 is a front view thereof;

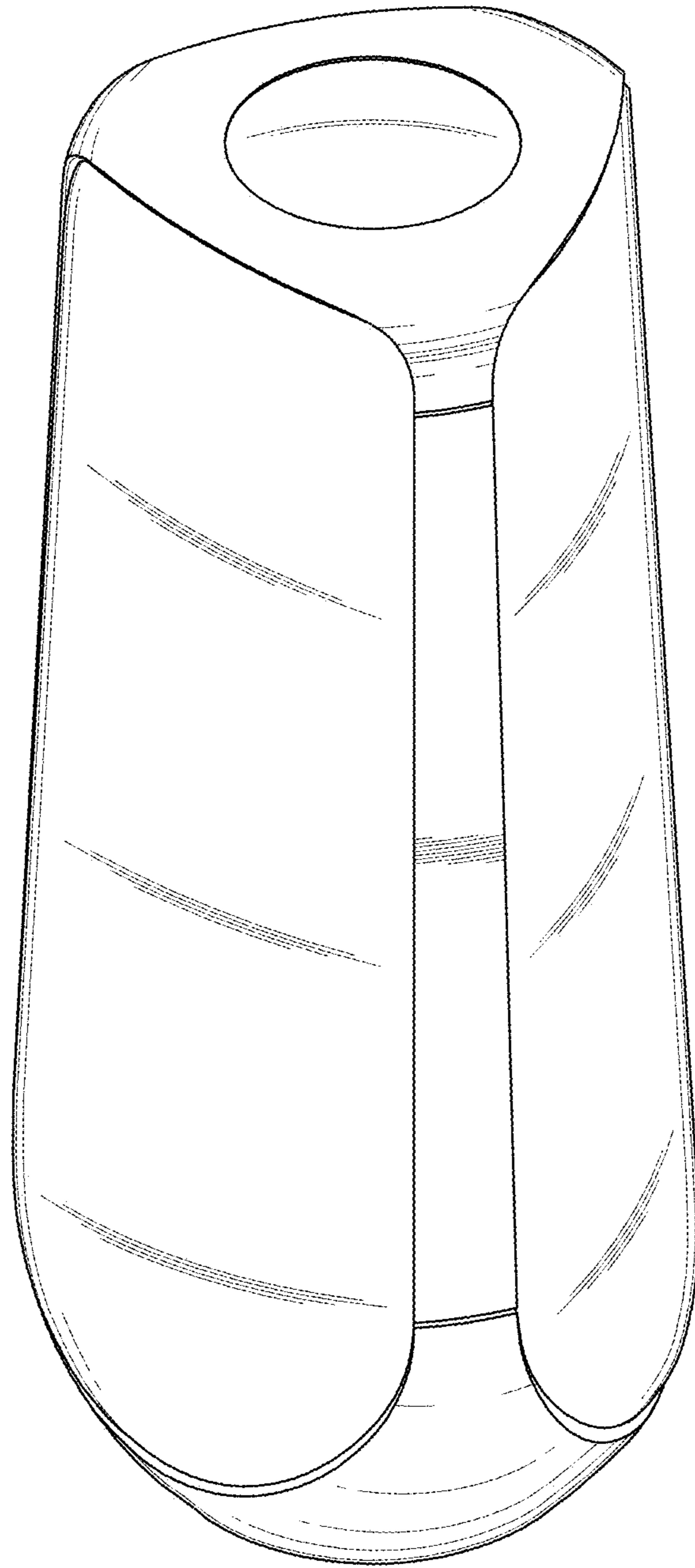

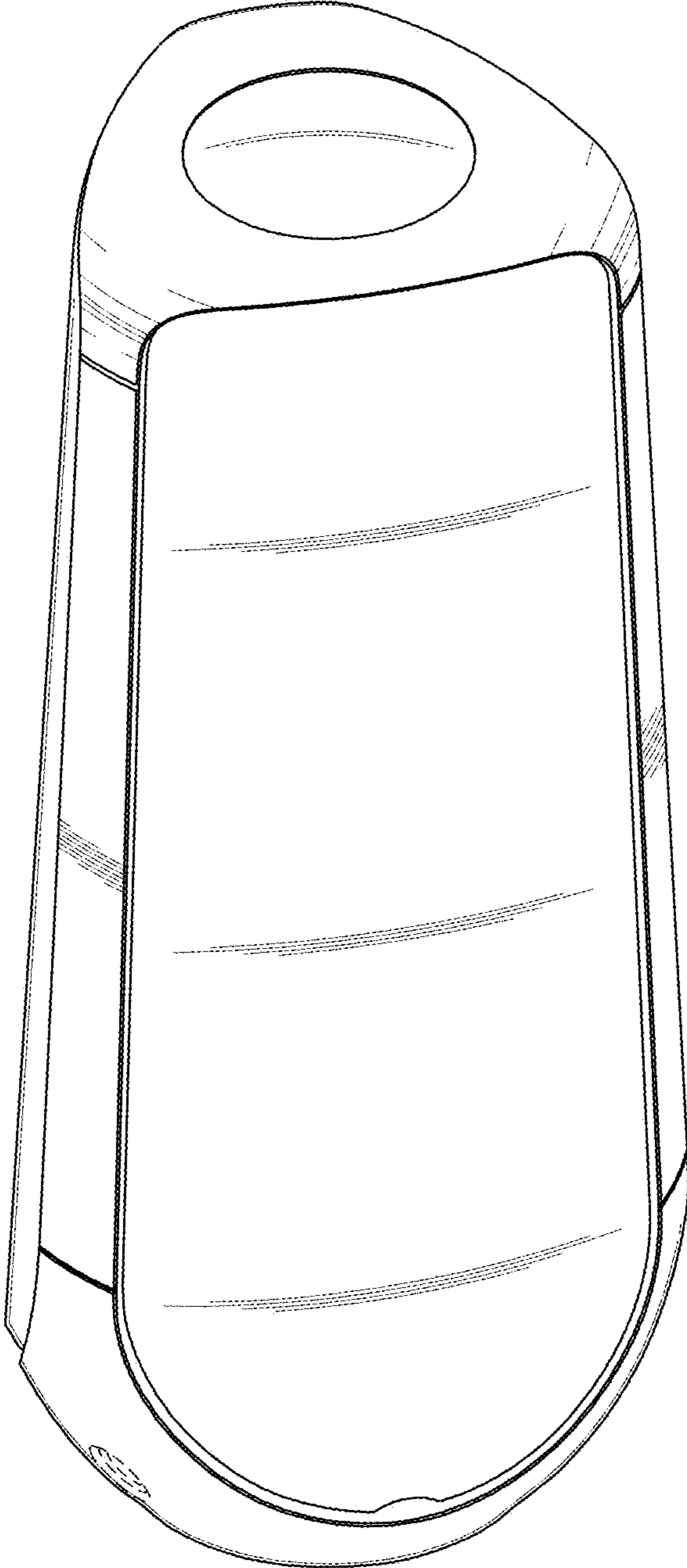

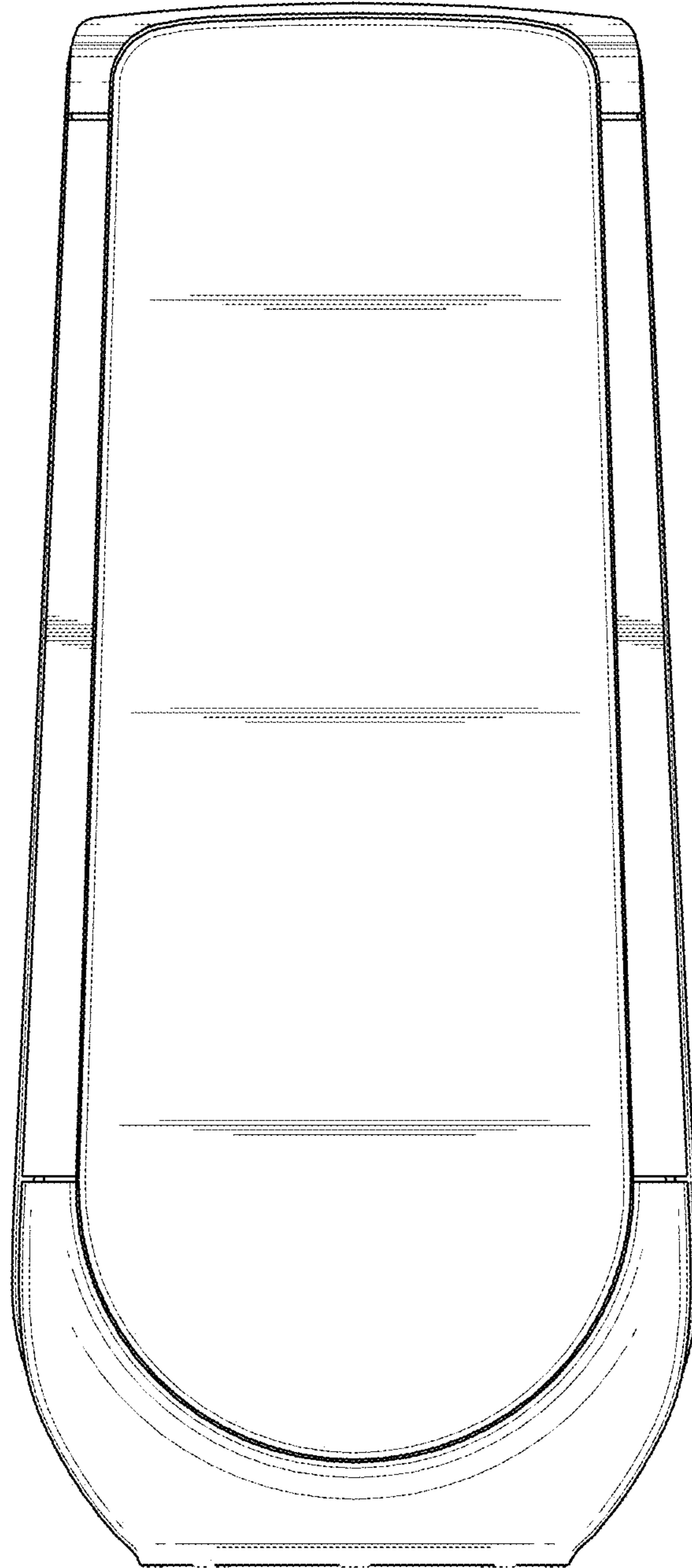

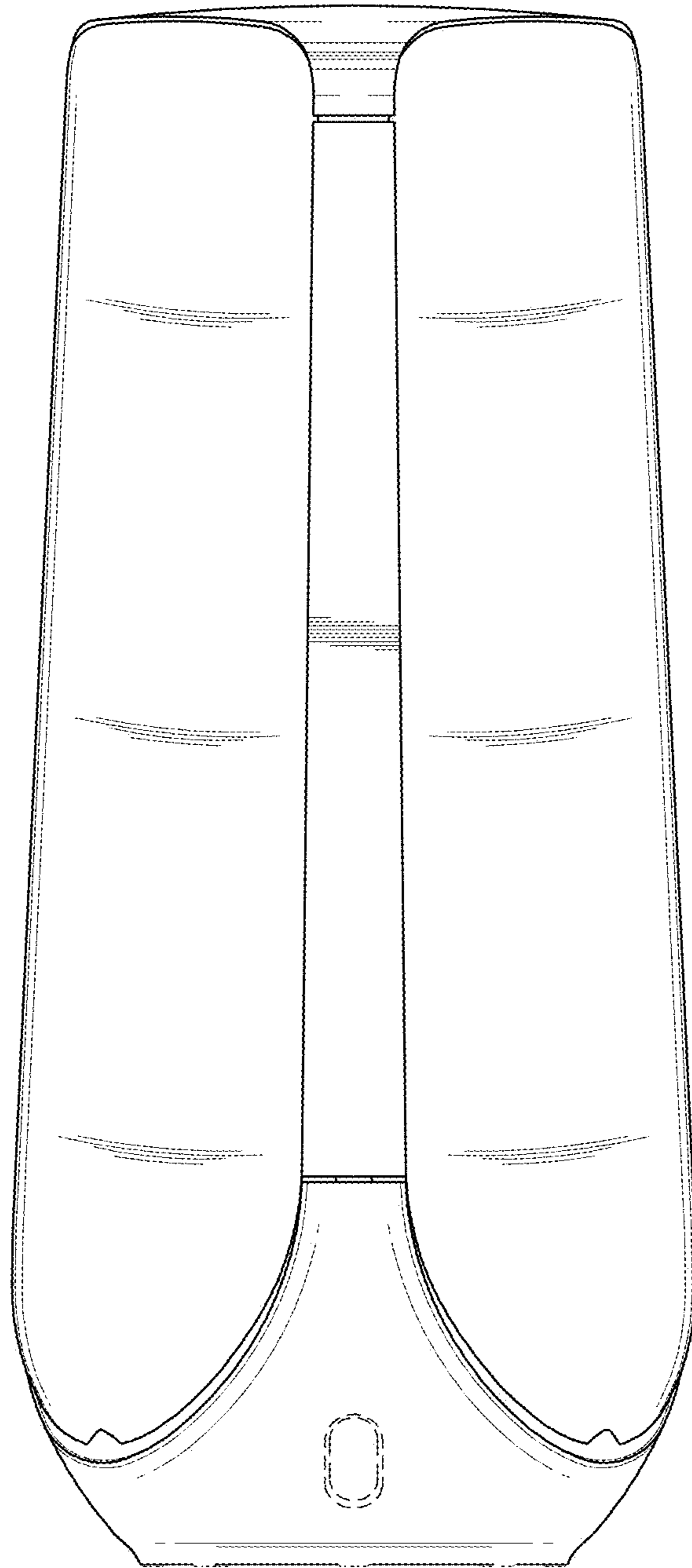

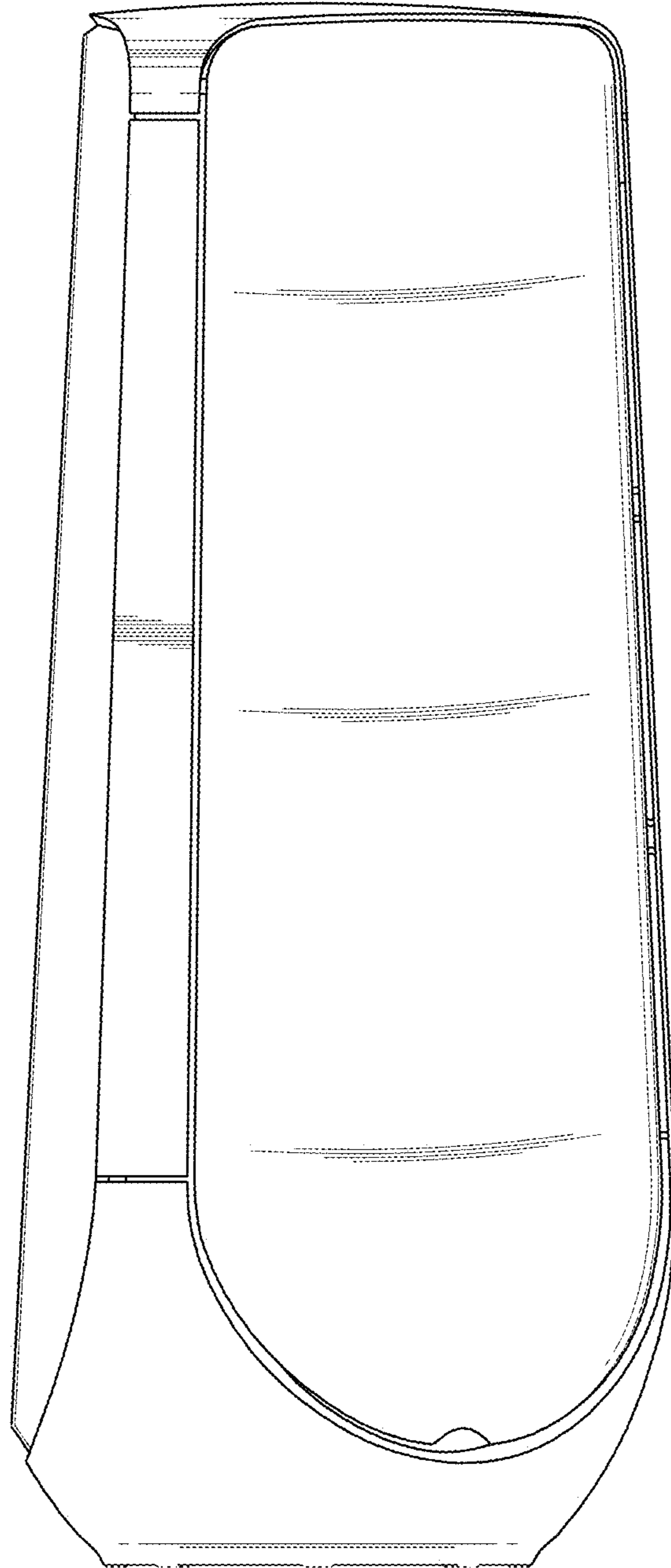

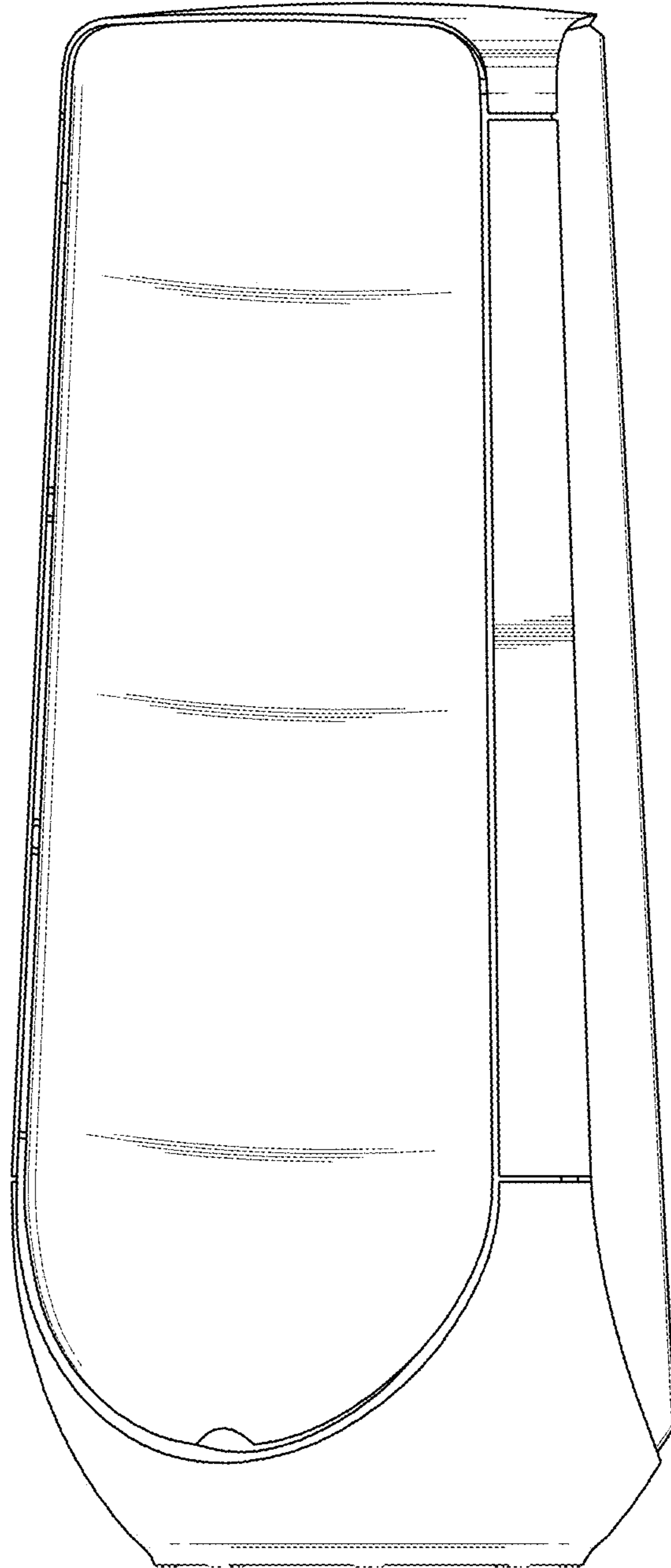

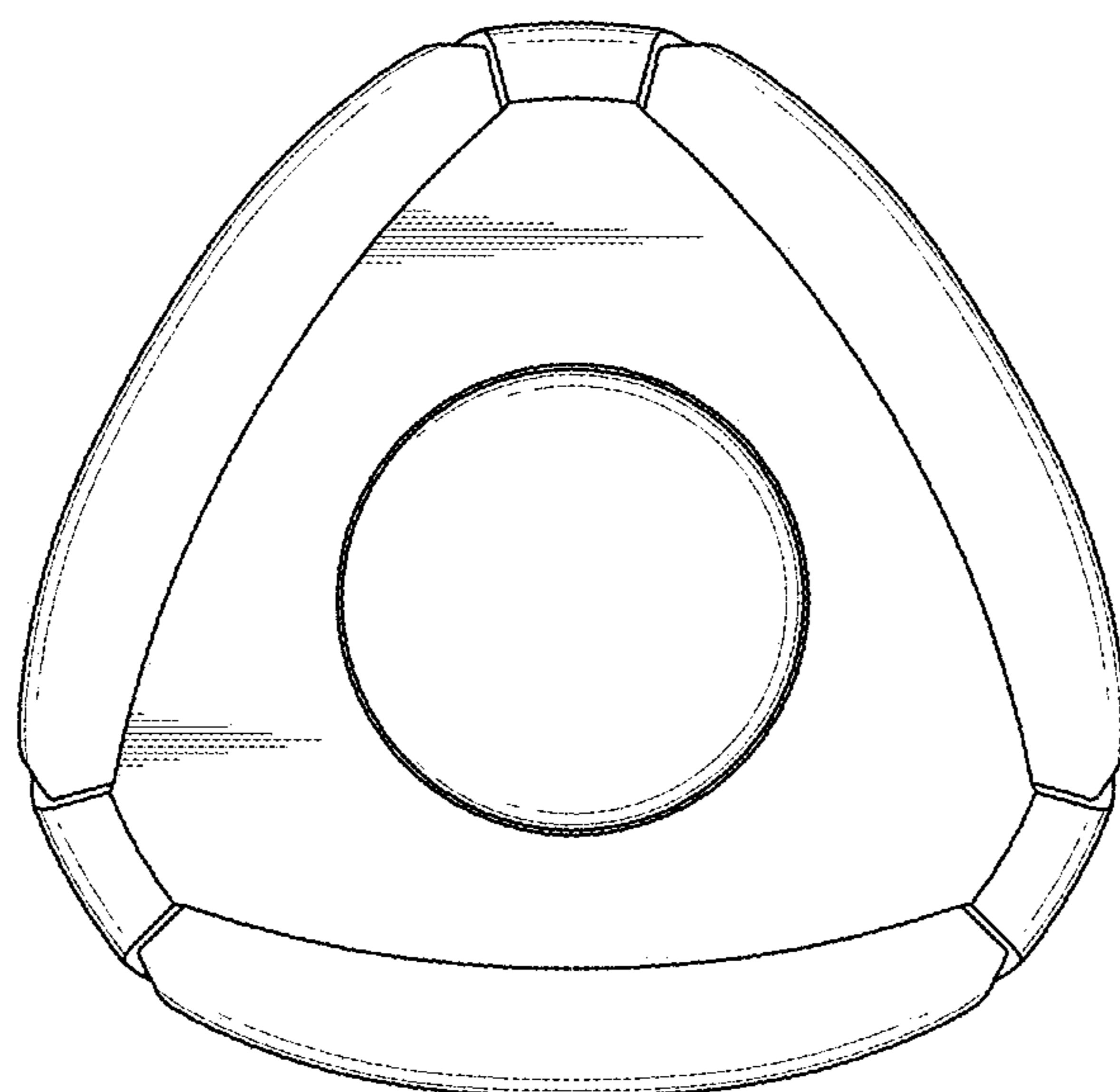

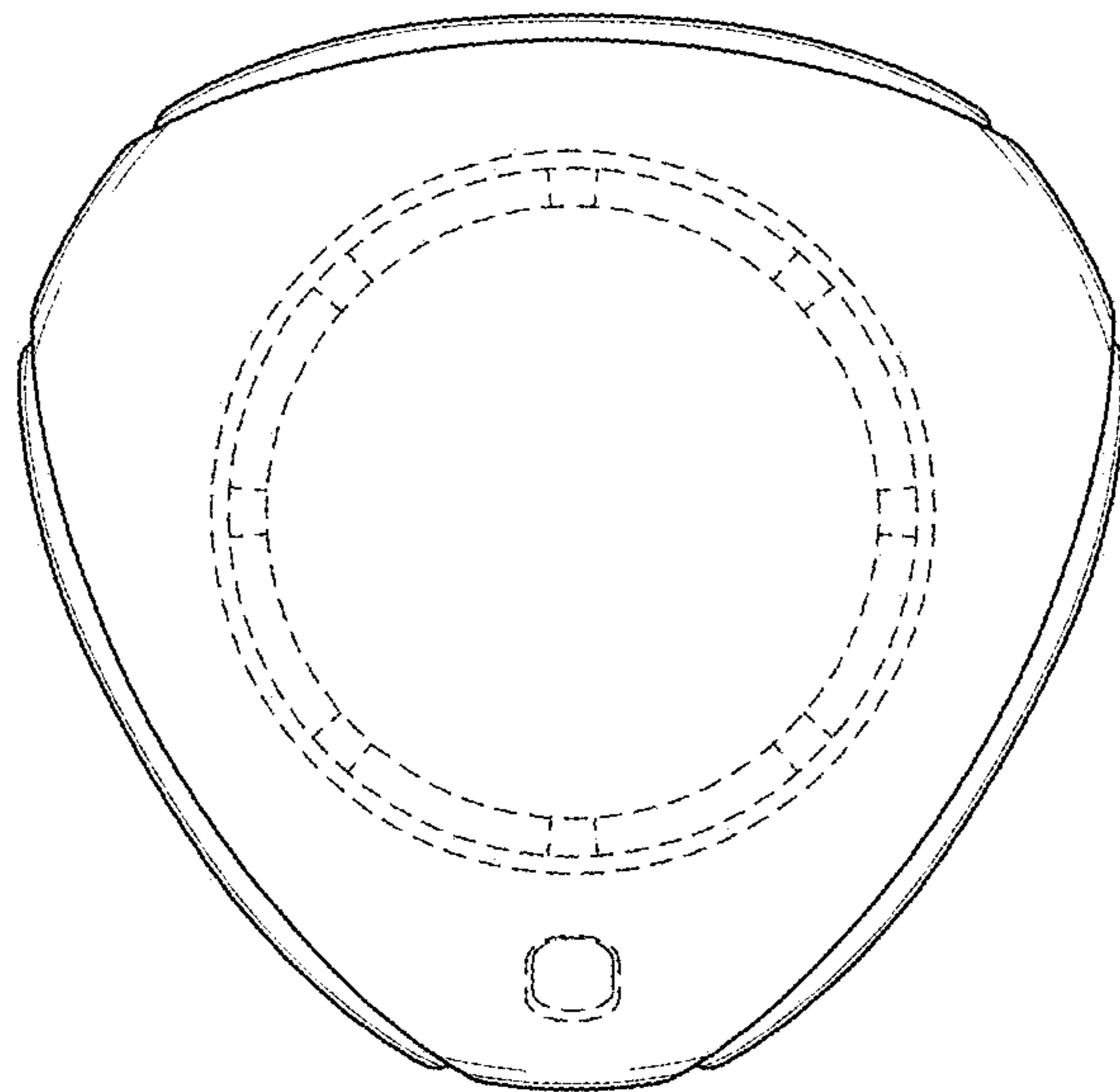

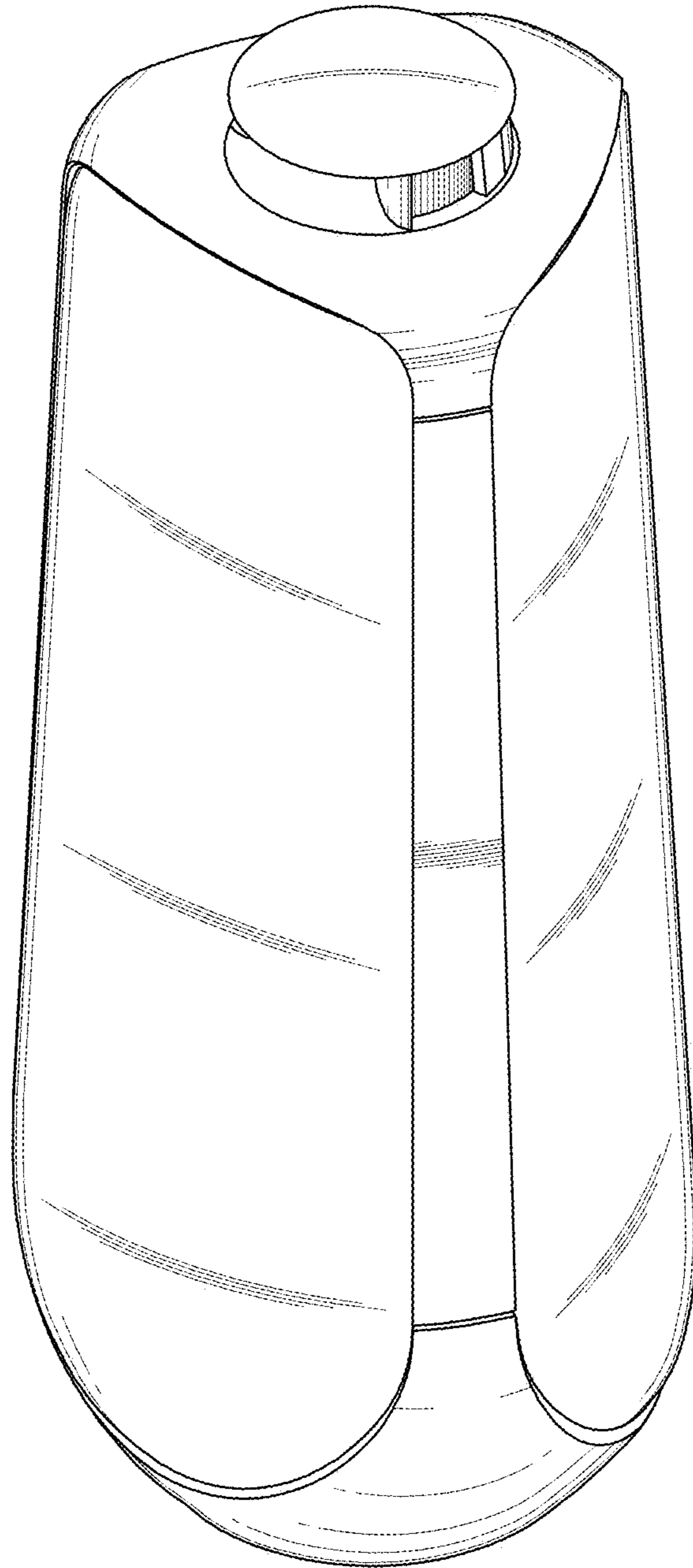




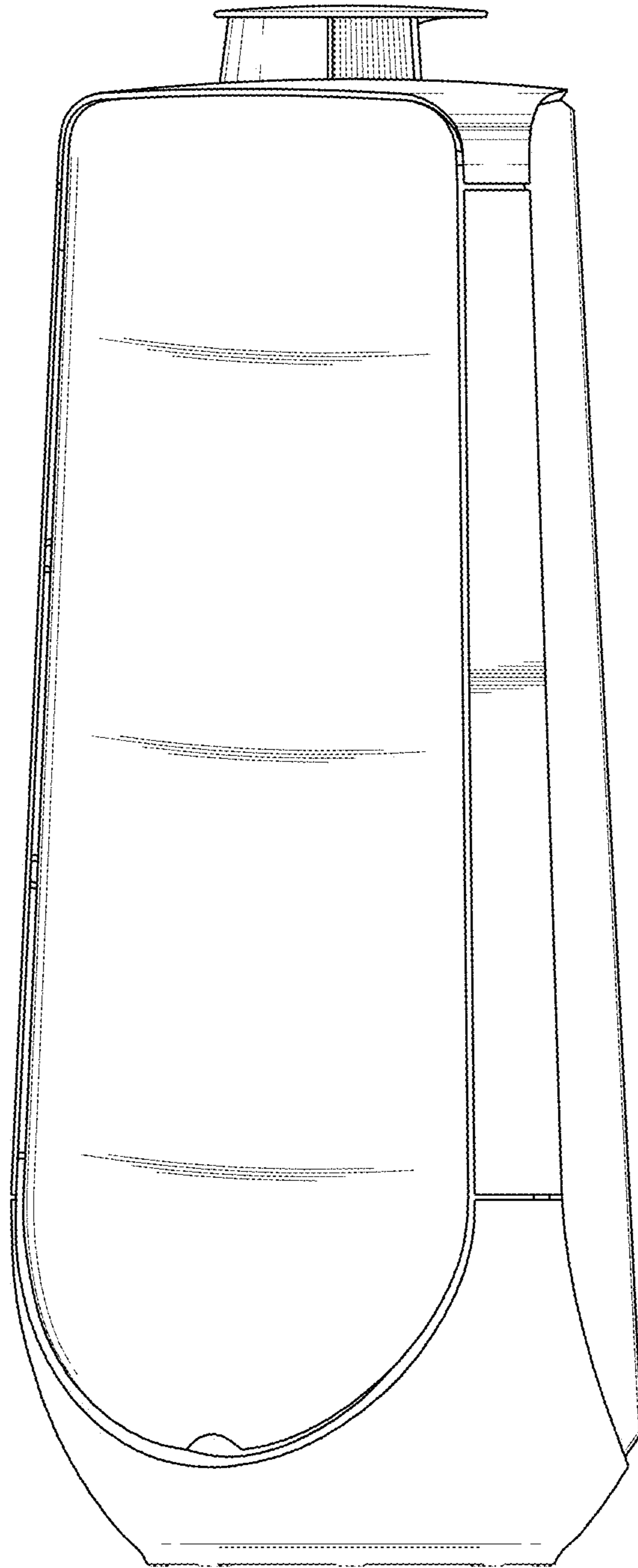

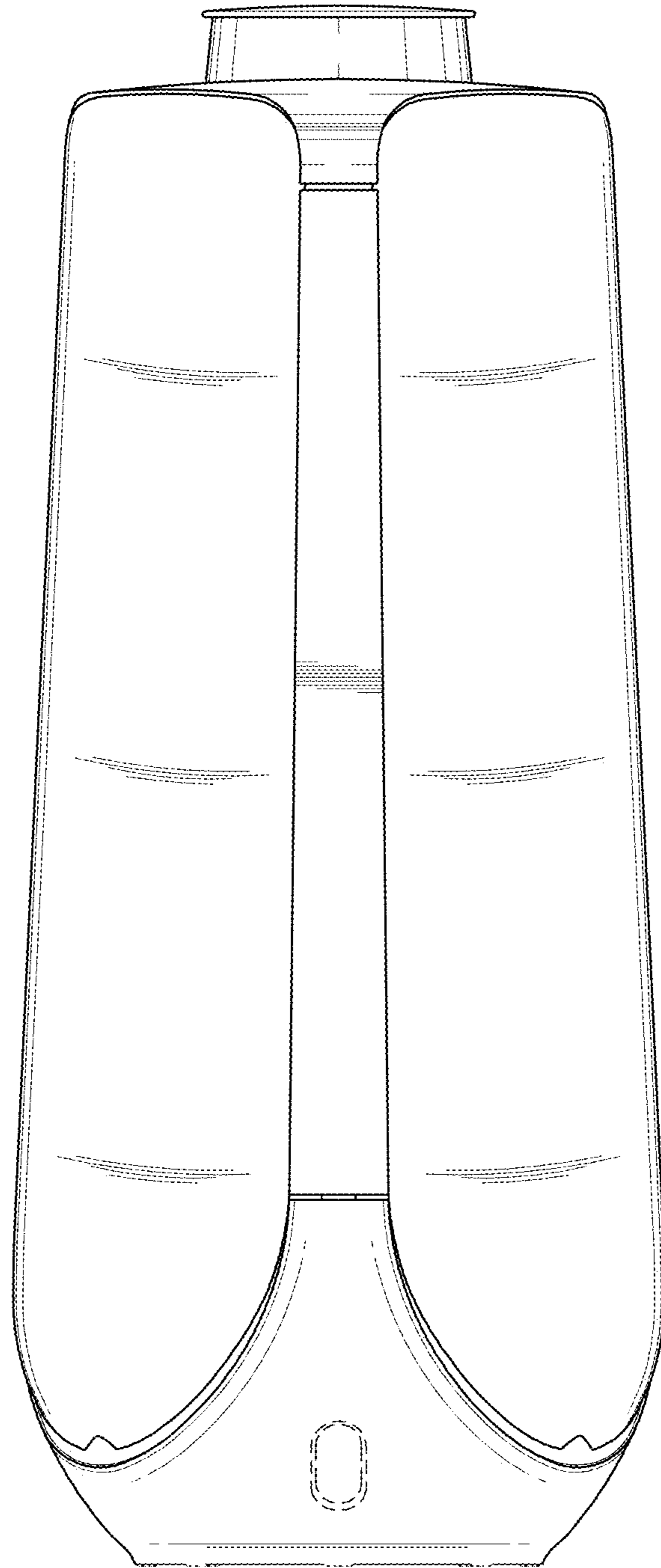

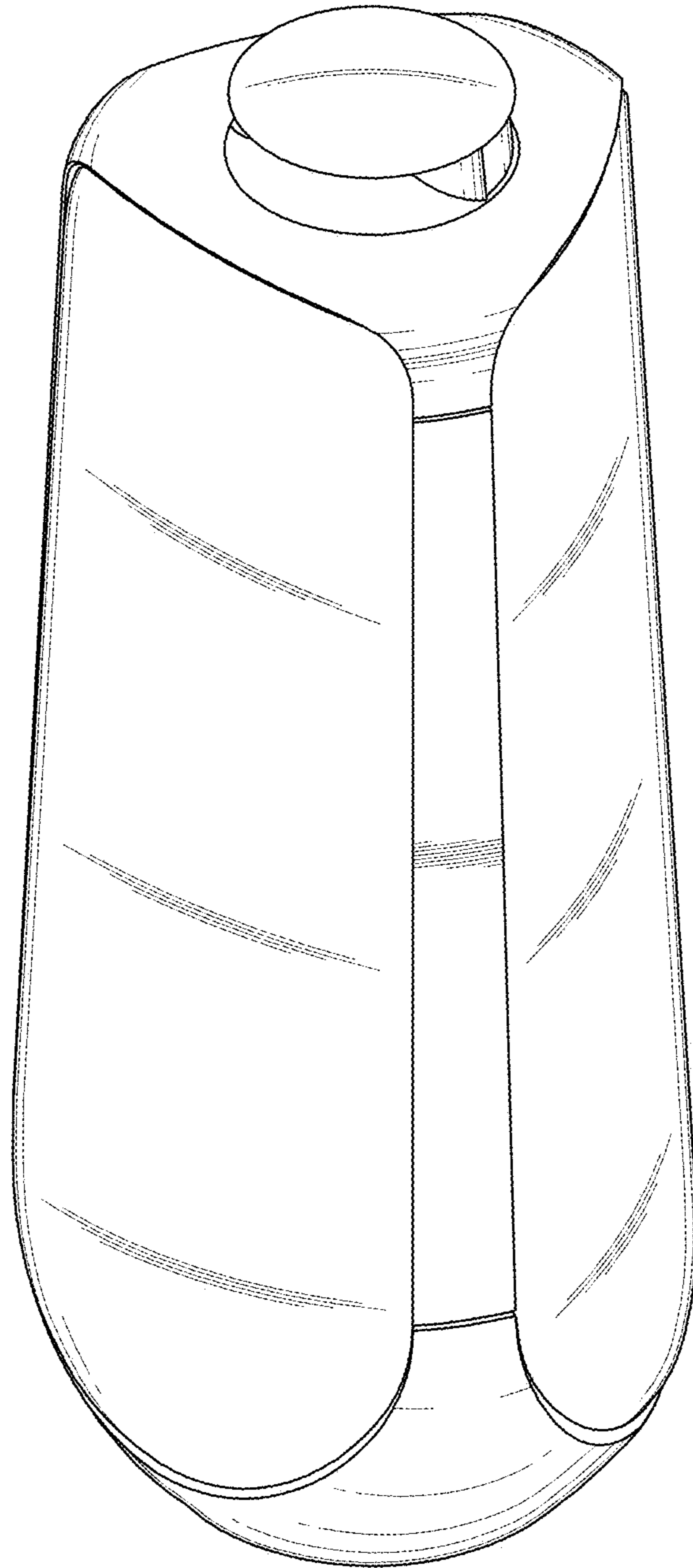

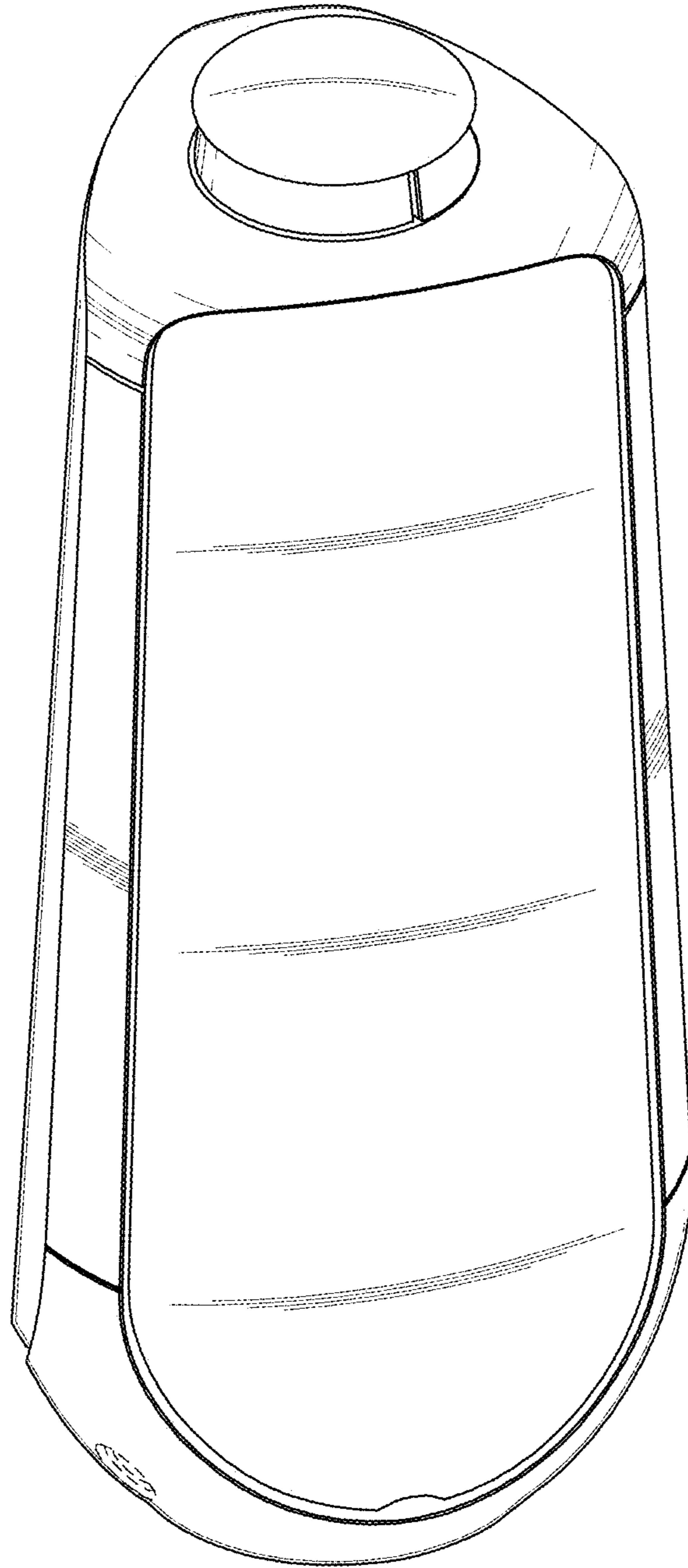

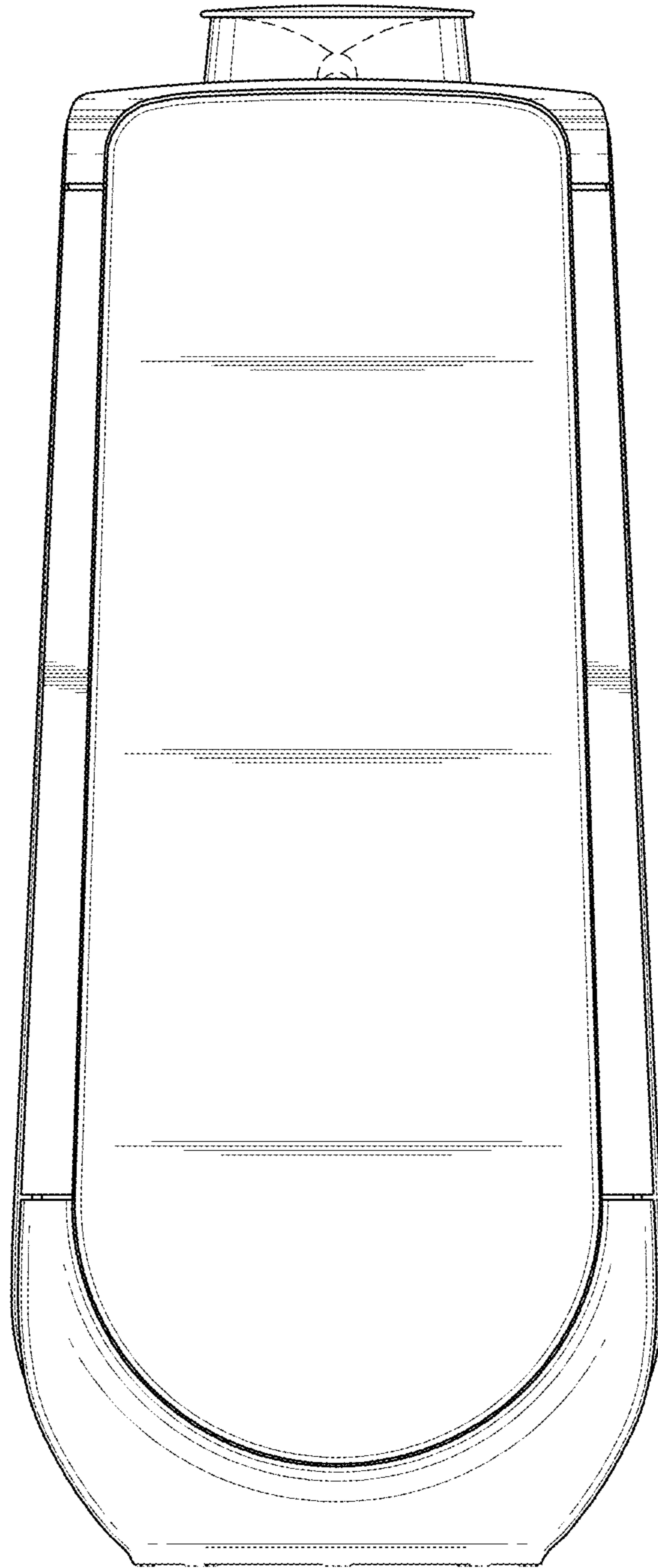

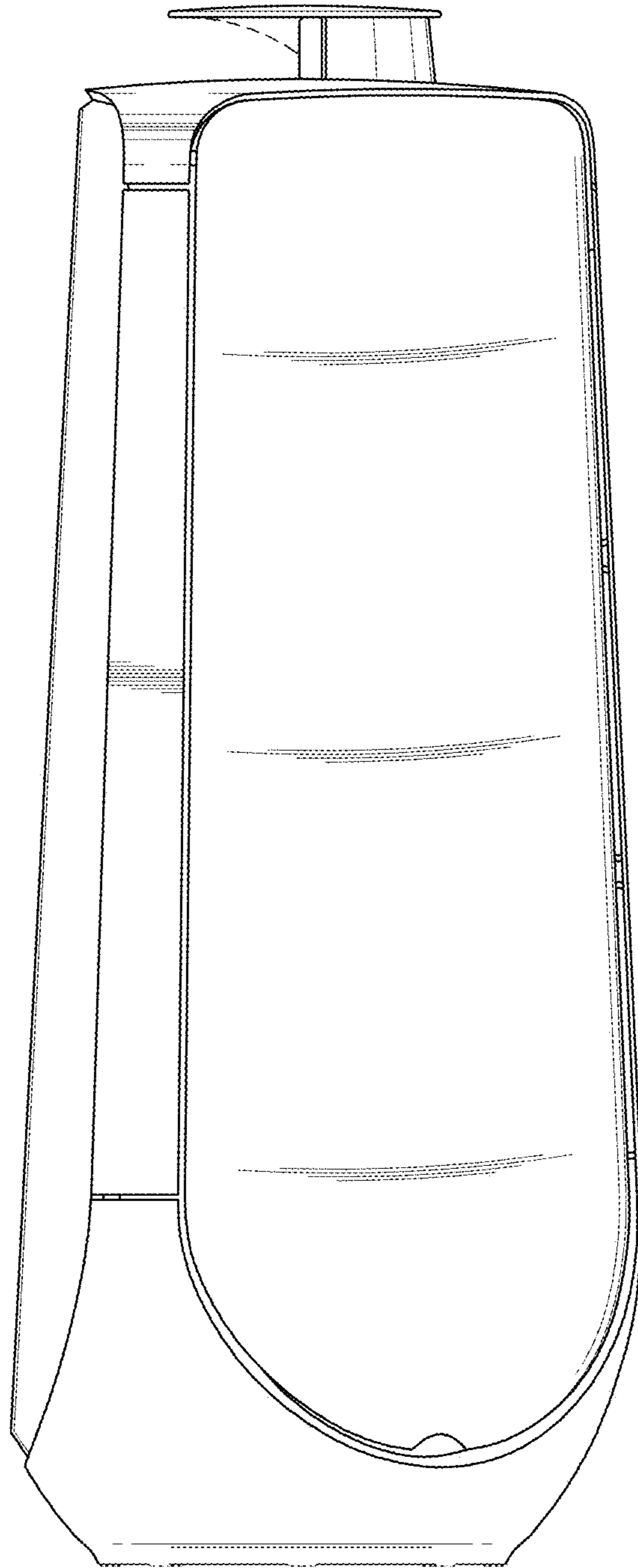

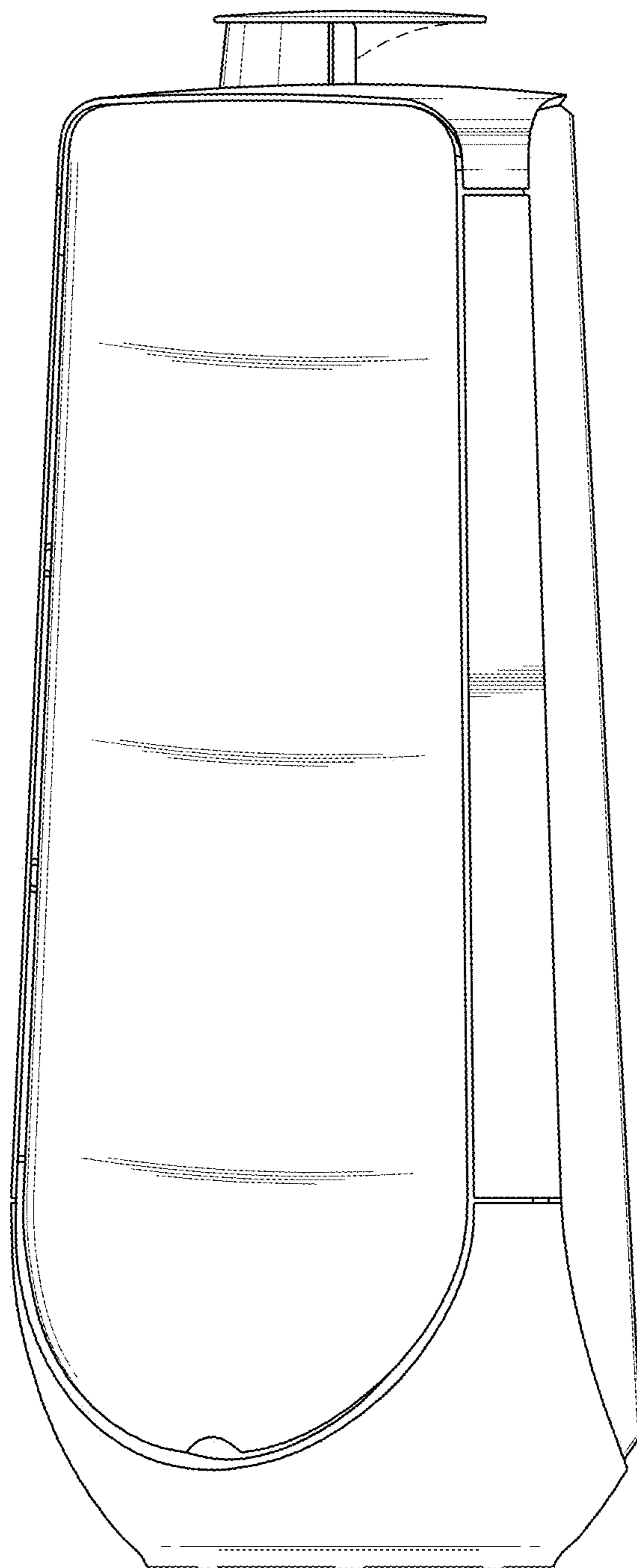
