**DESCRIPTION**

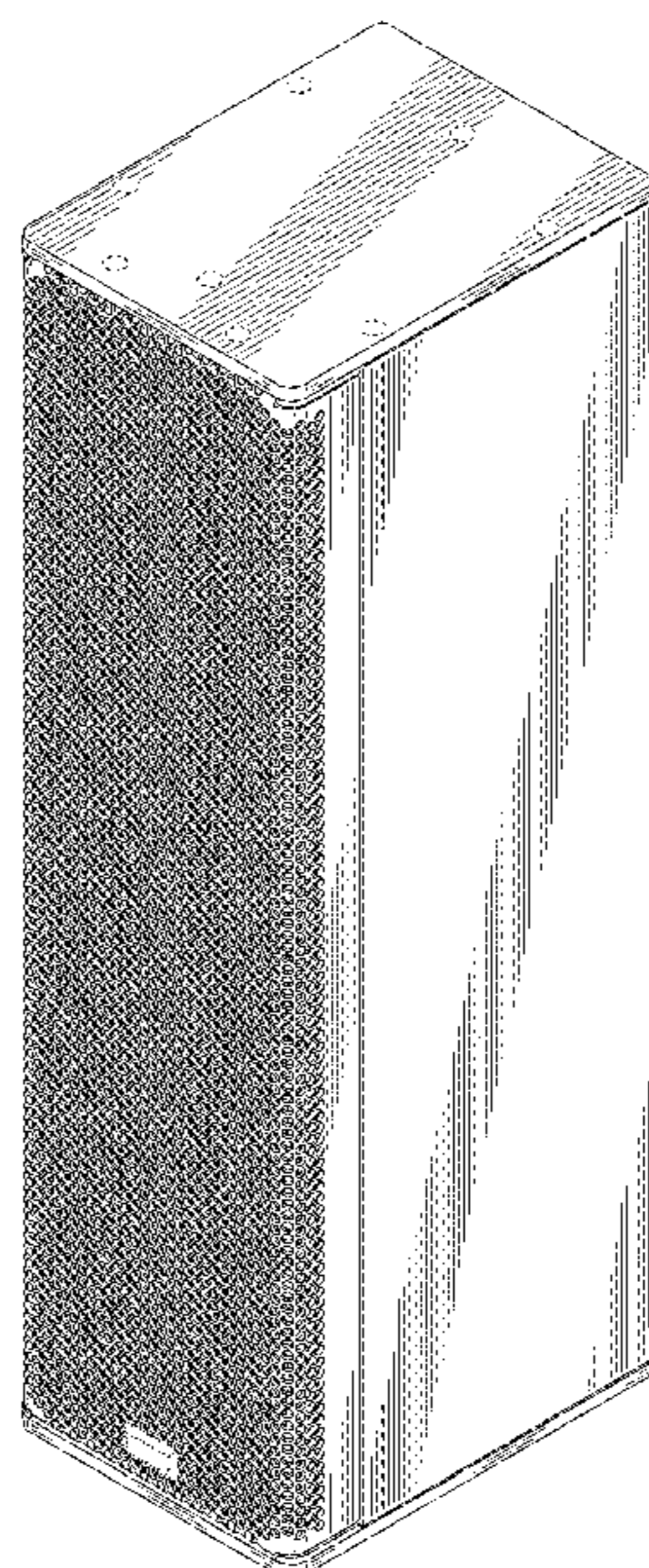
FIG. 1 is a top front perspective view of a loudspeaker showing our new design;

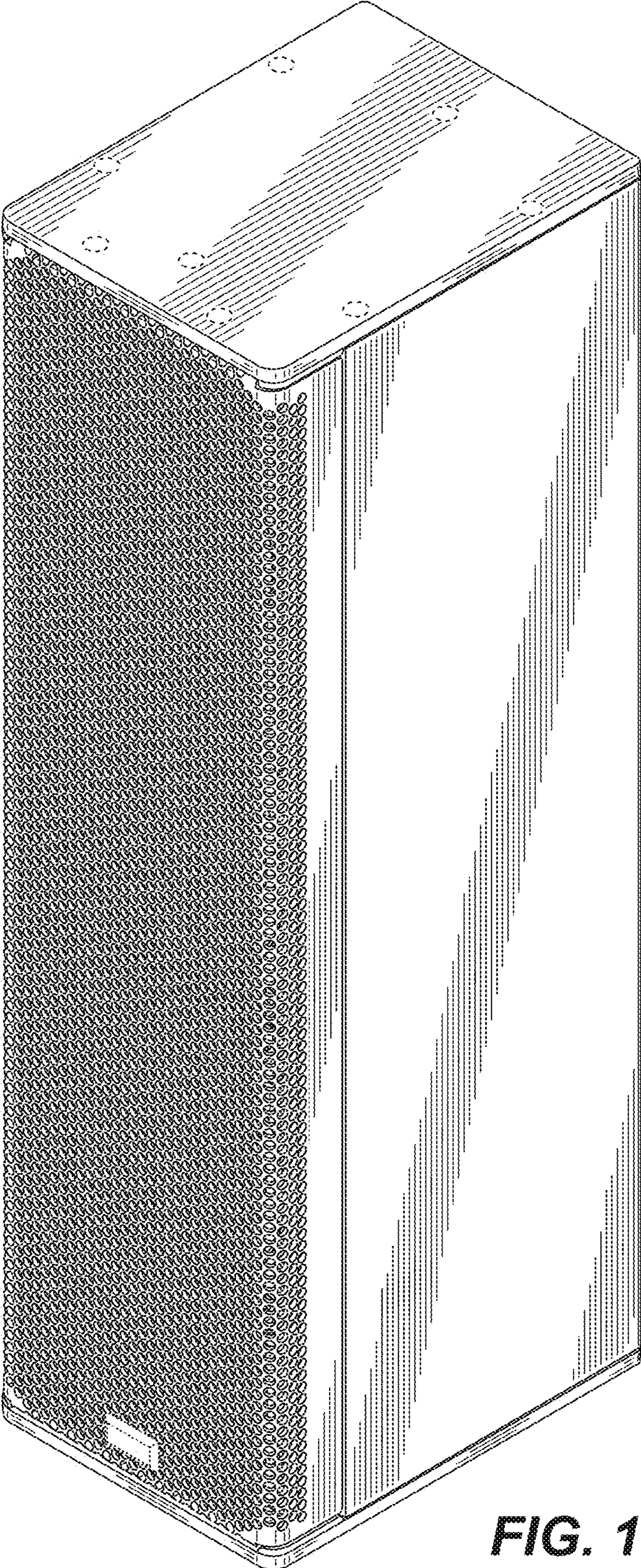

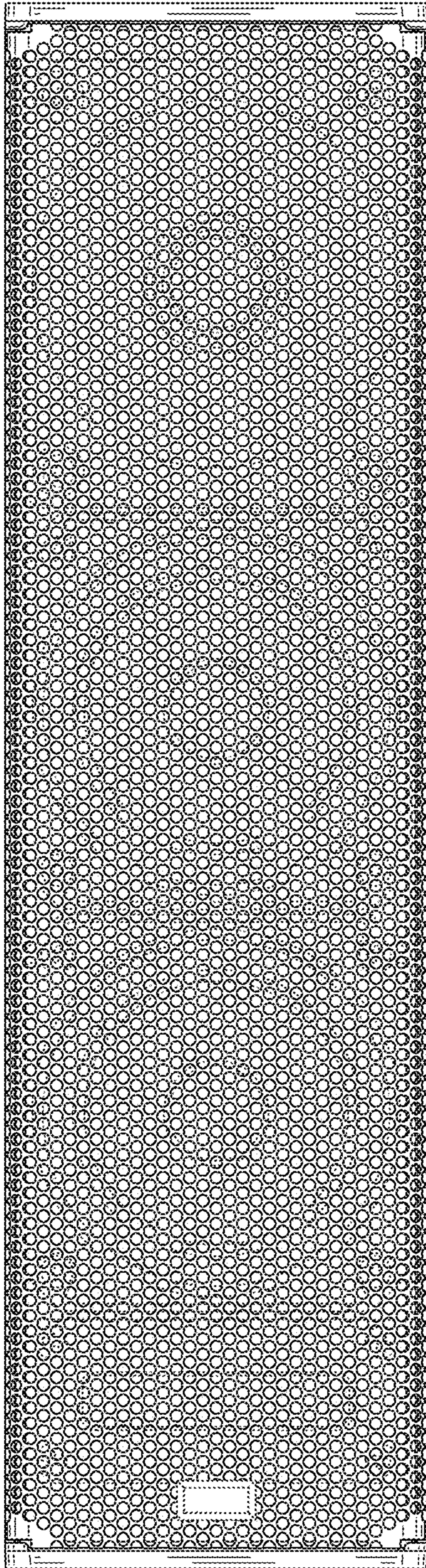

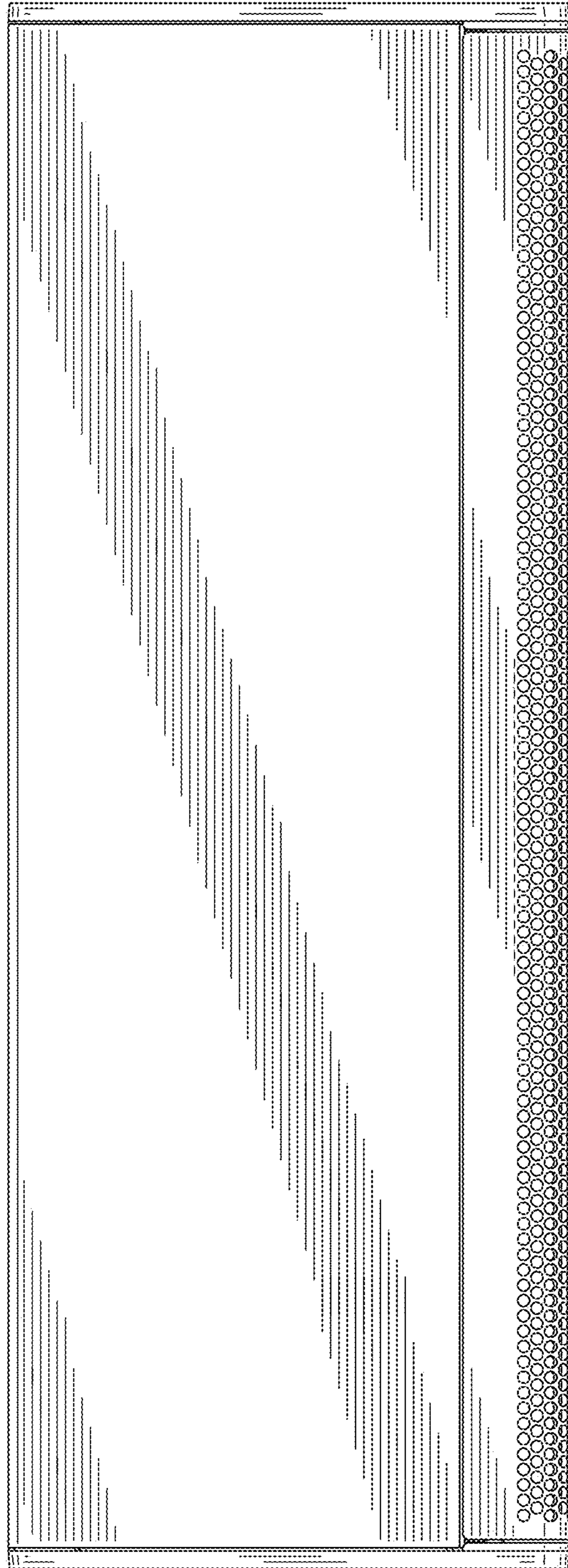

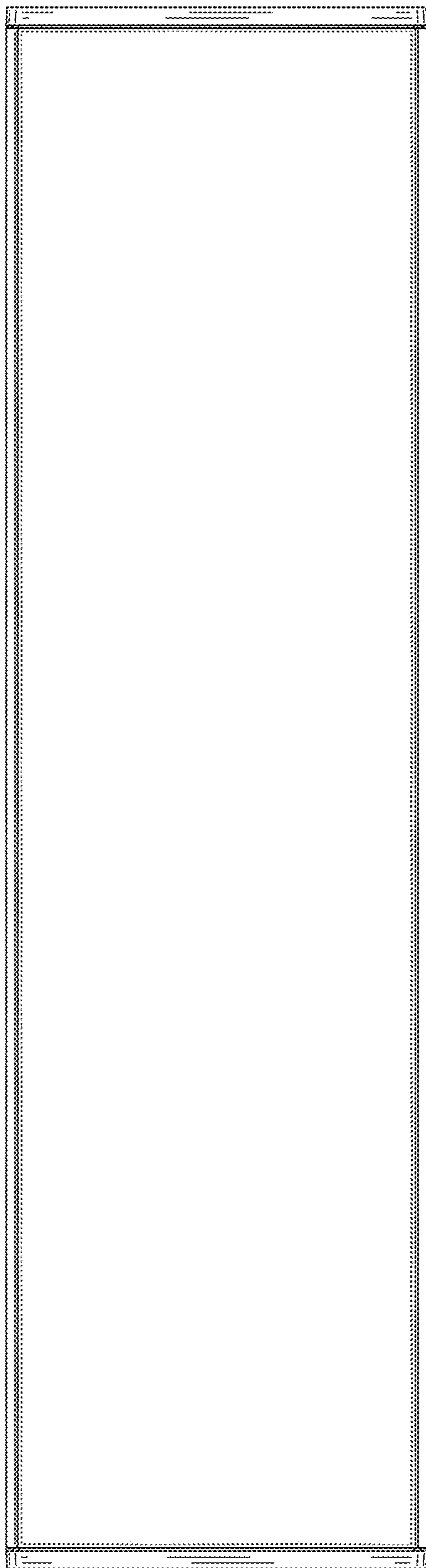

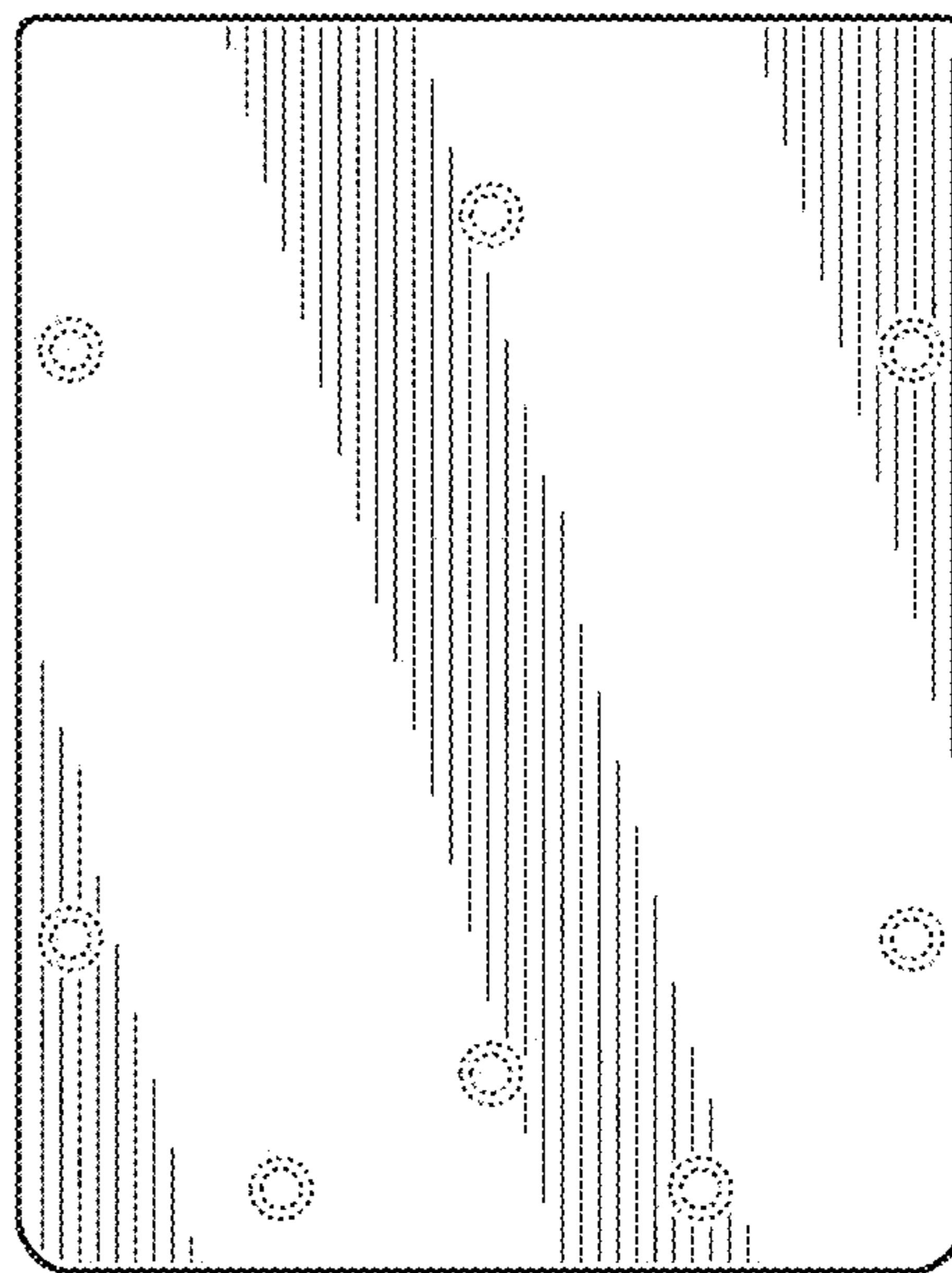
