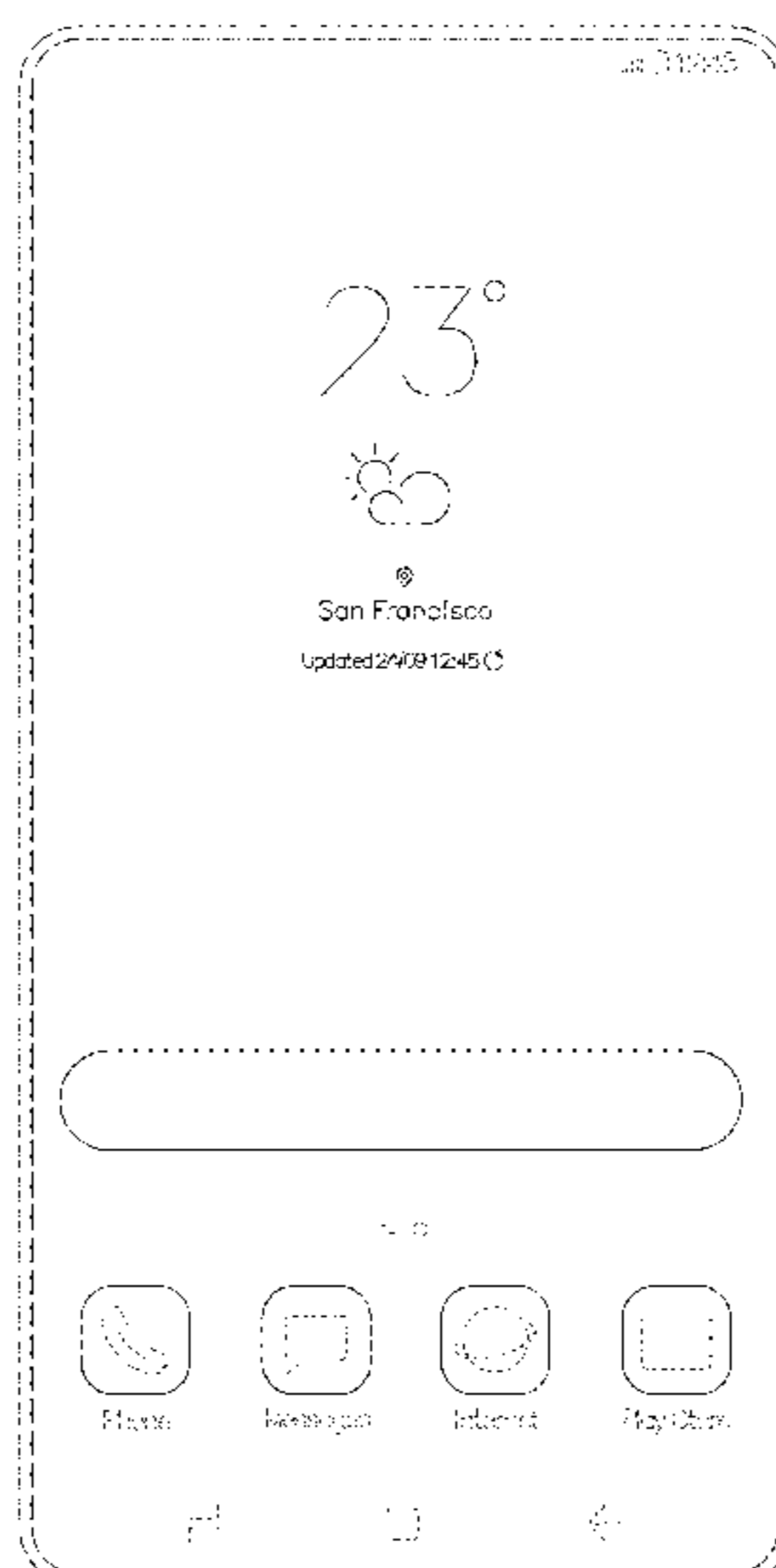
FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing our new design according to a first embodiment; and,
