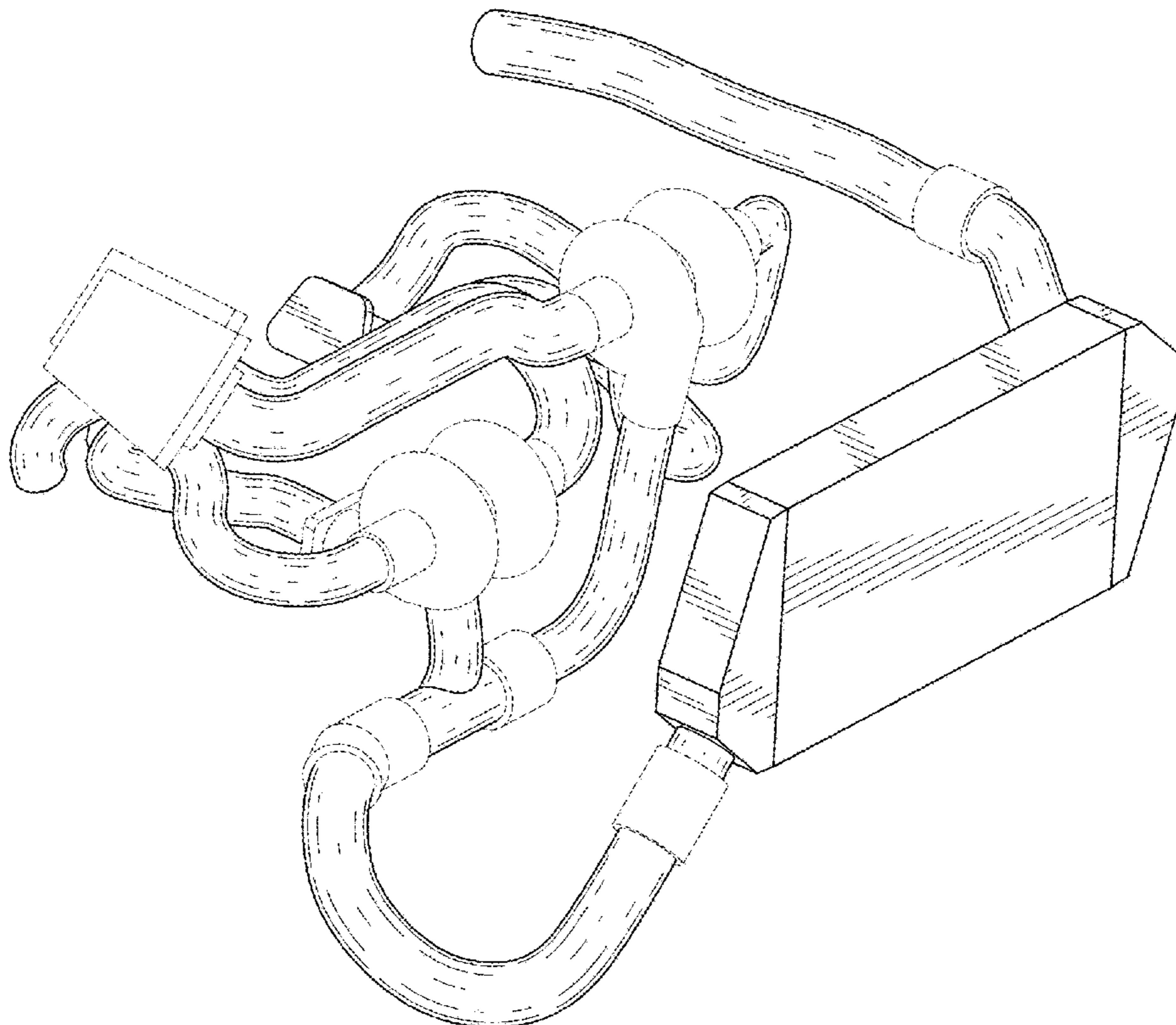
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevational view of the dual turbo charger kit showing my new design;

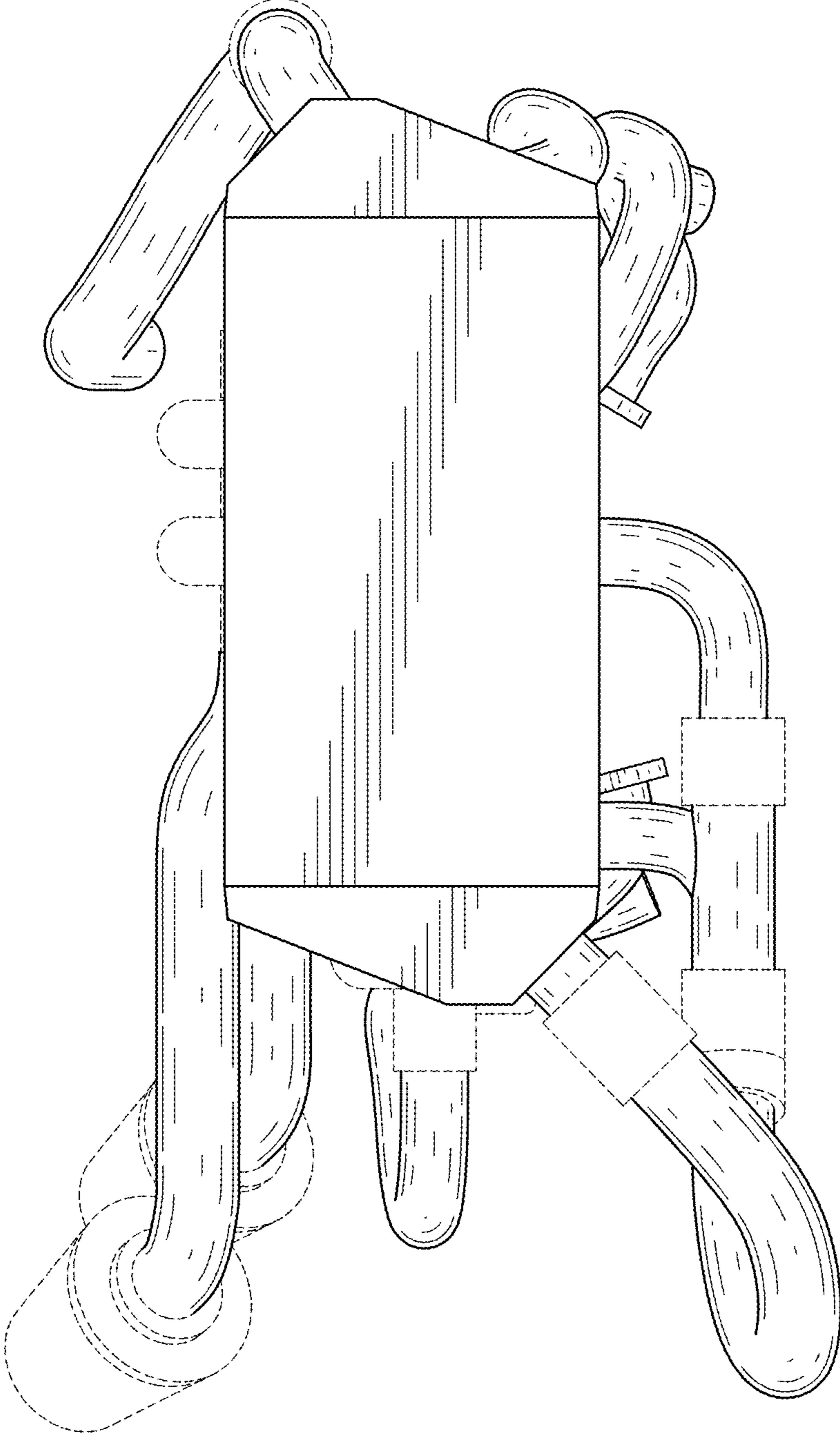

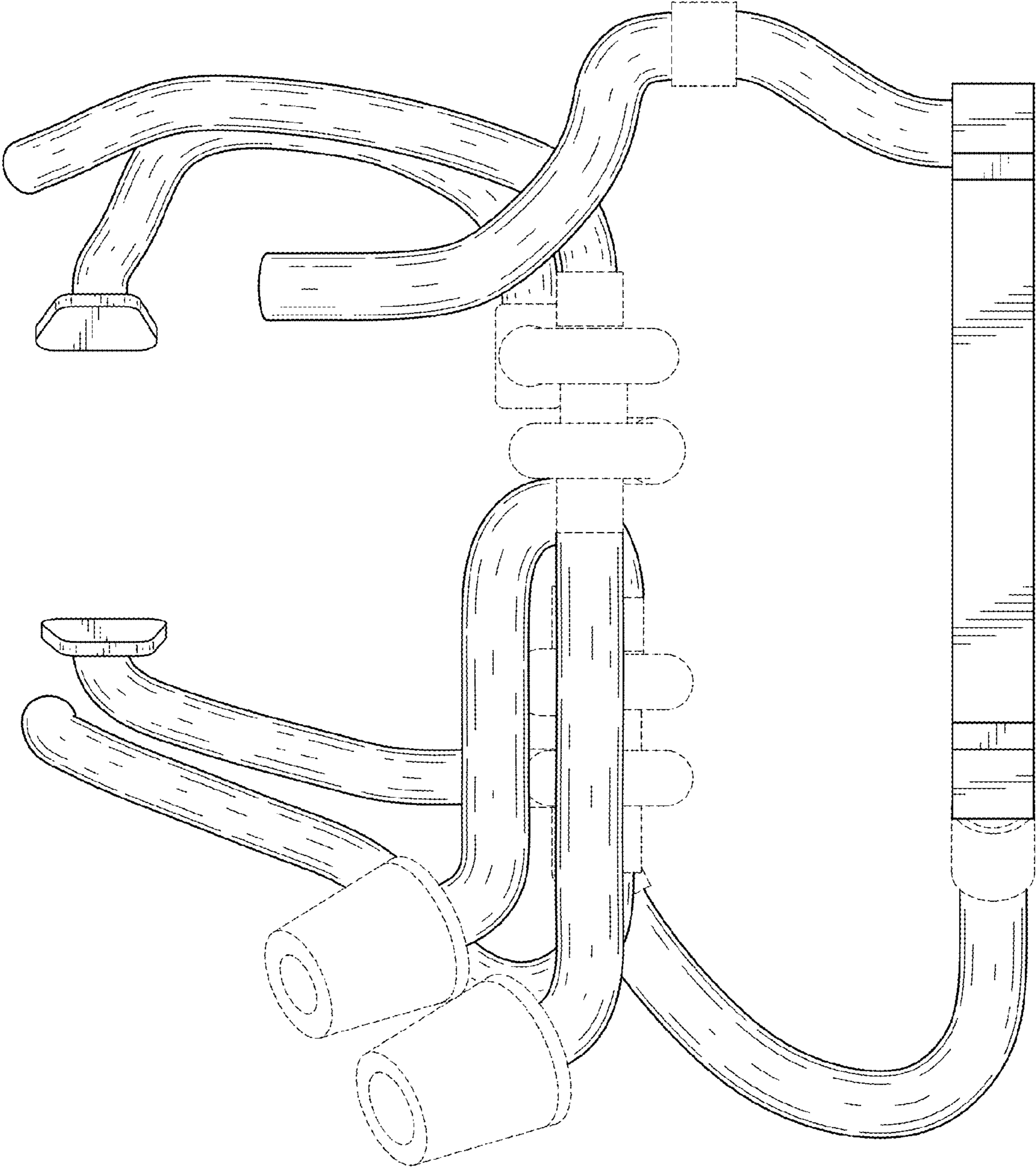

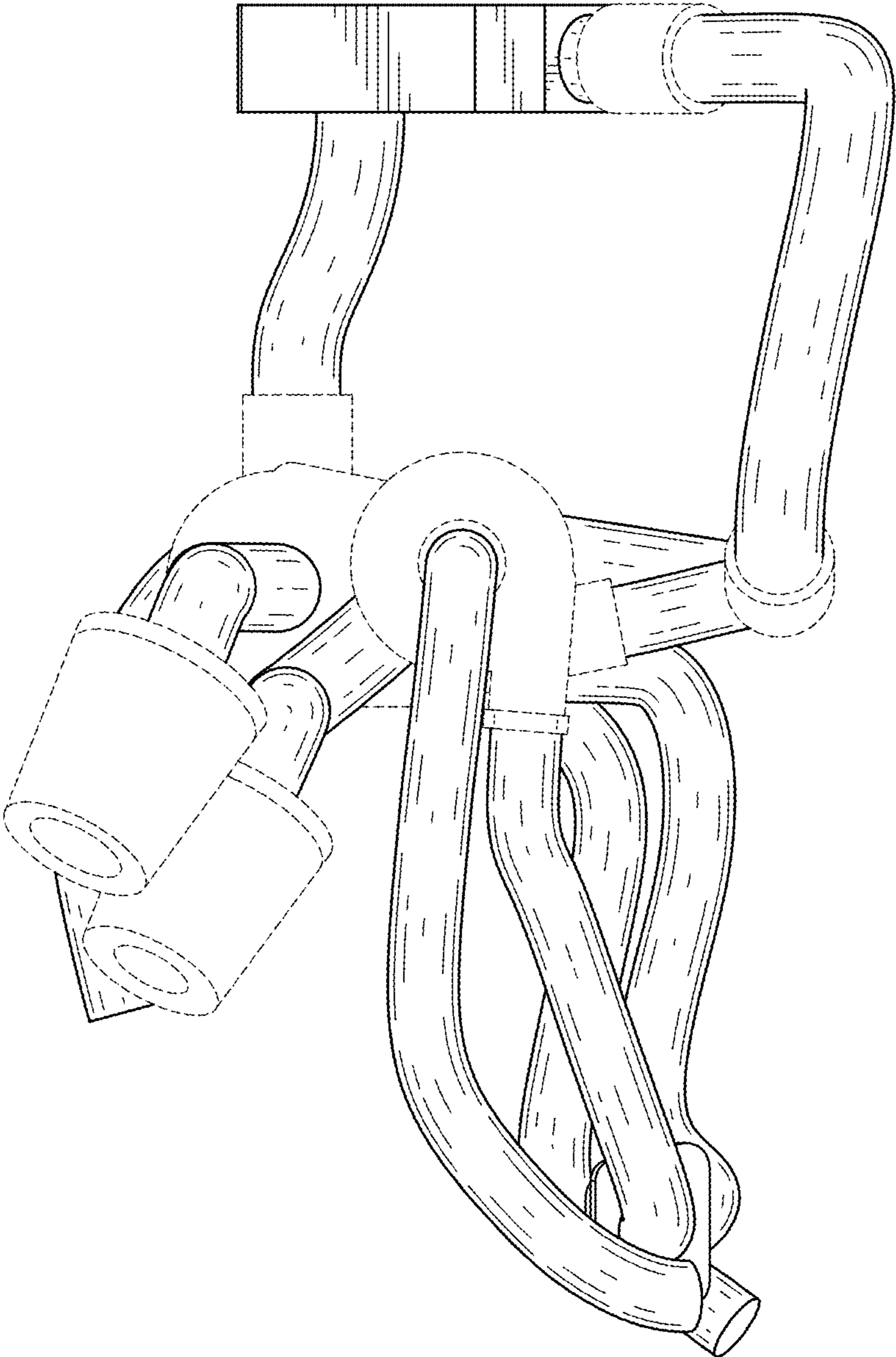

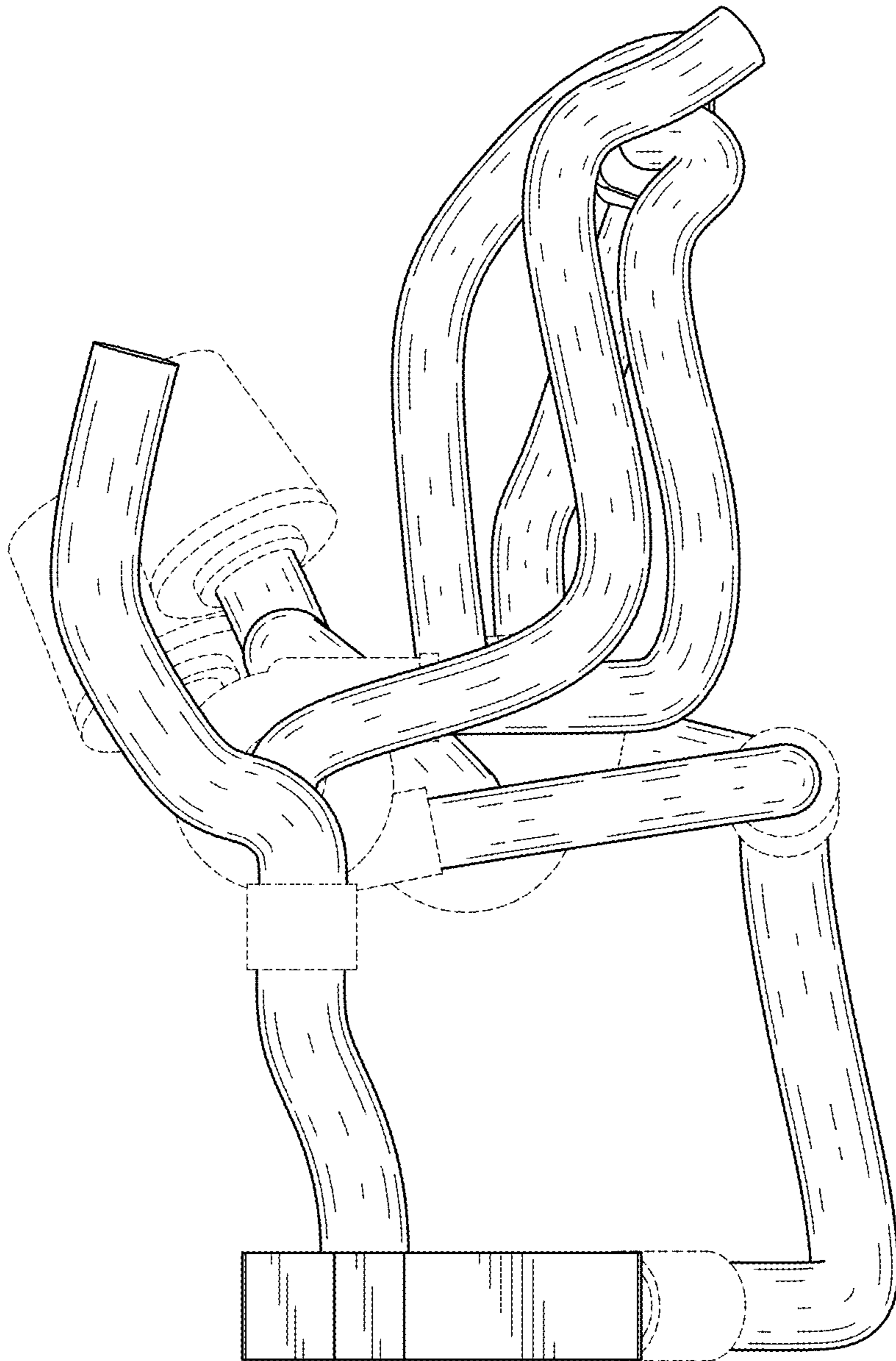

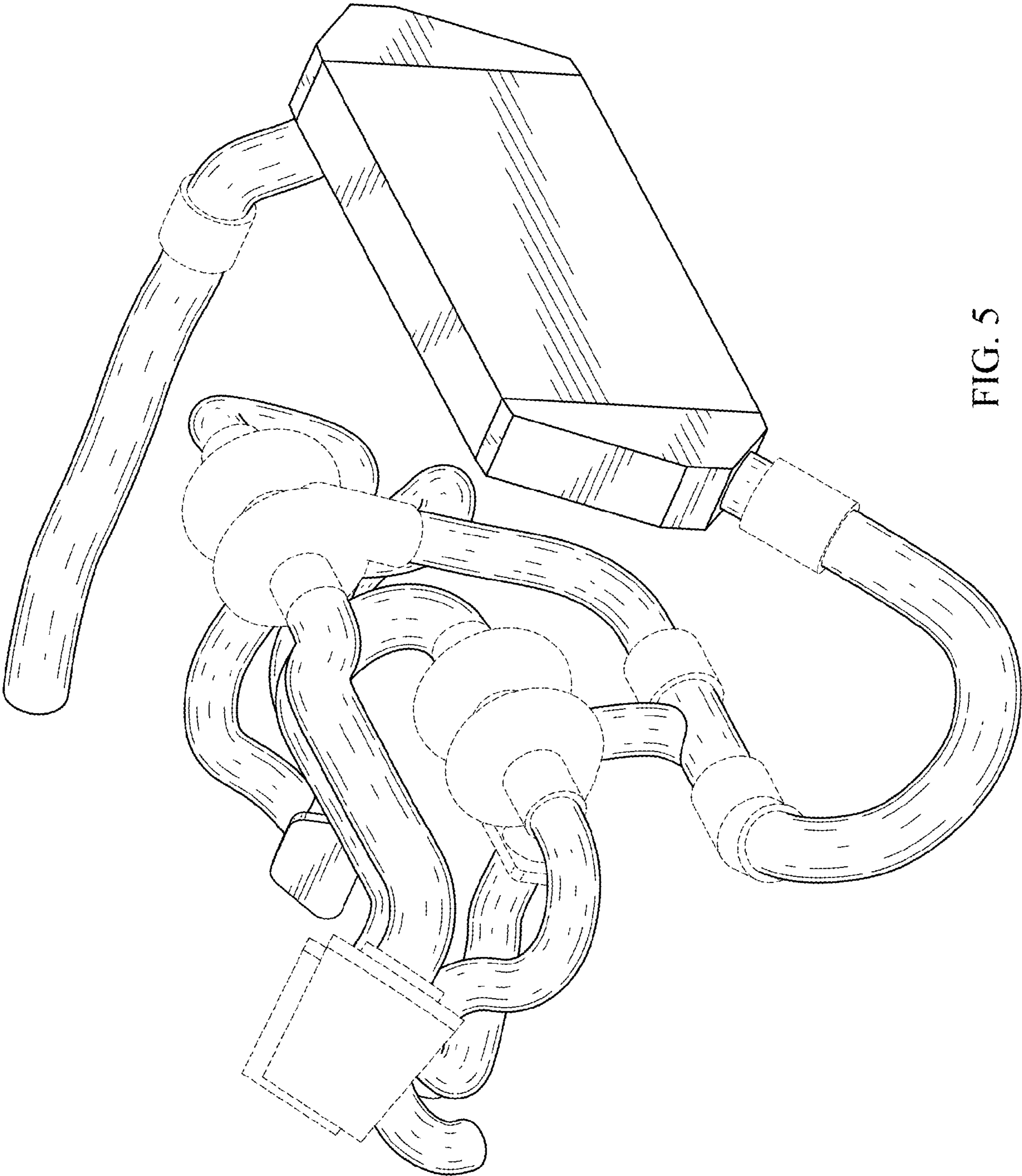

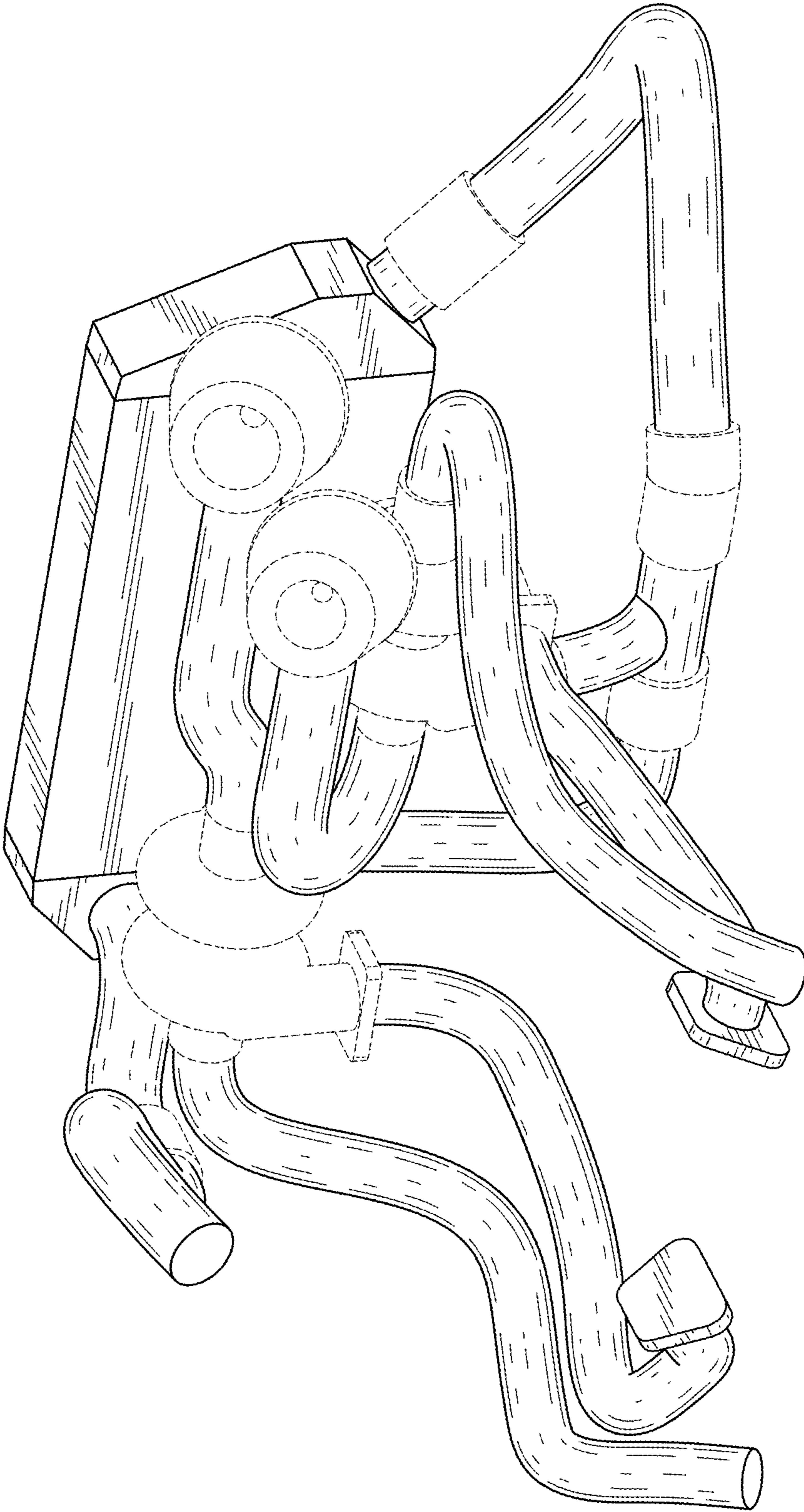

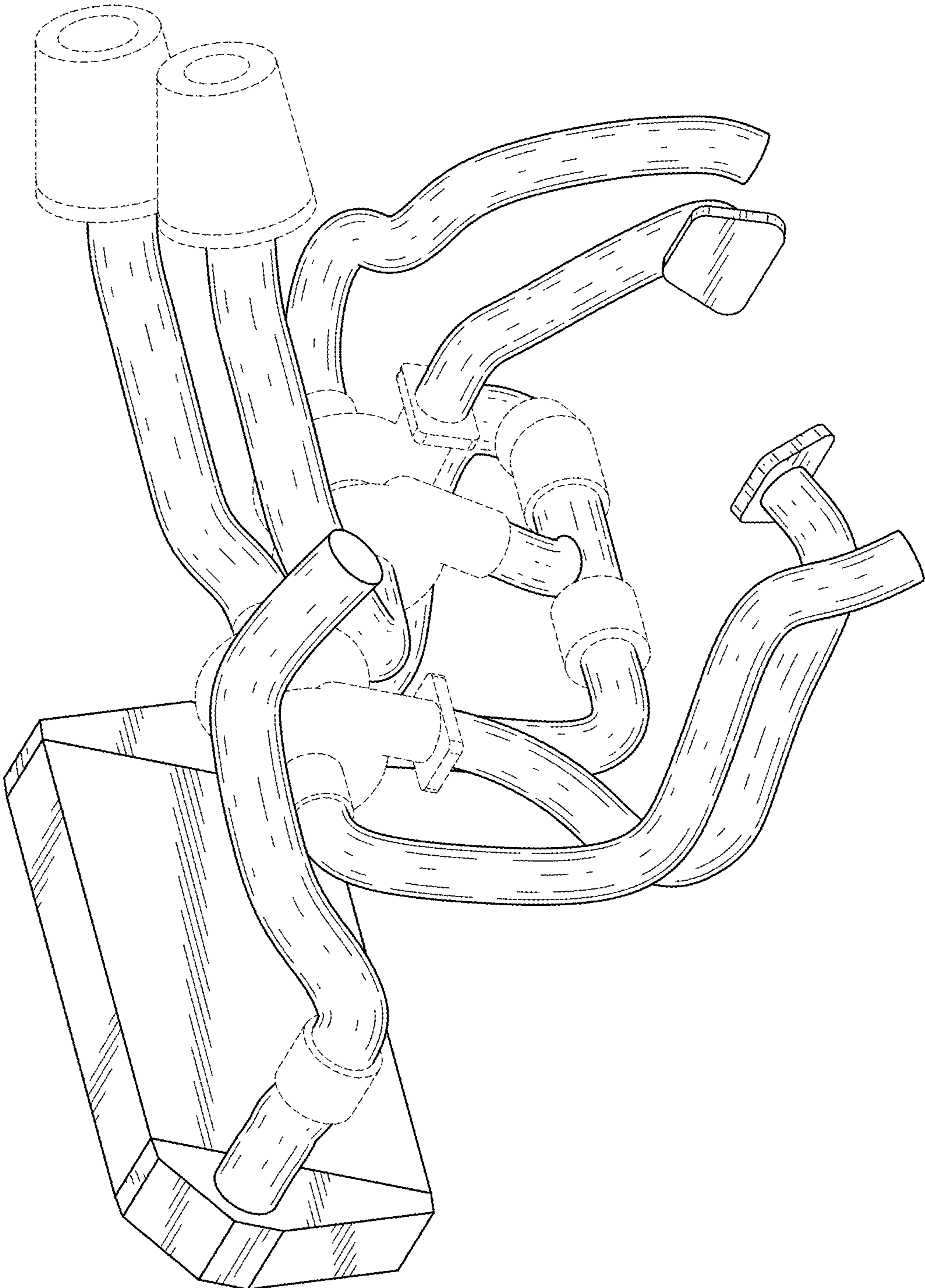

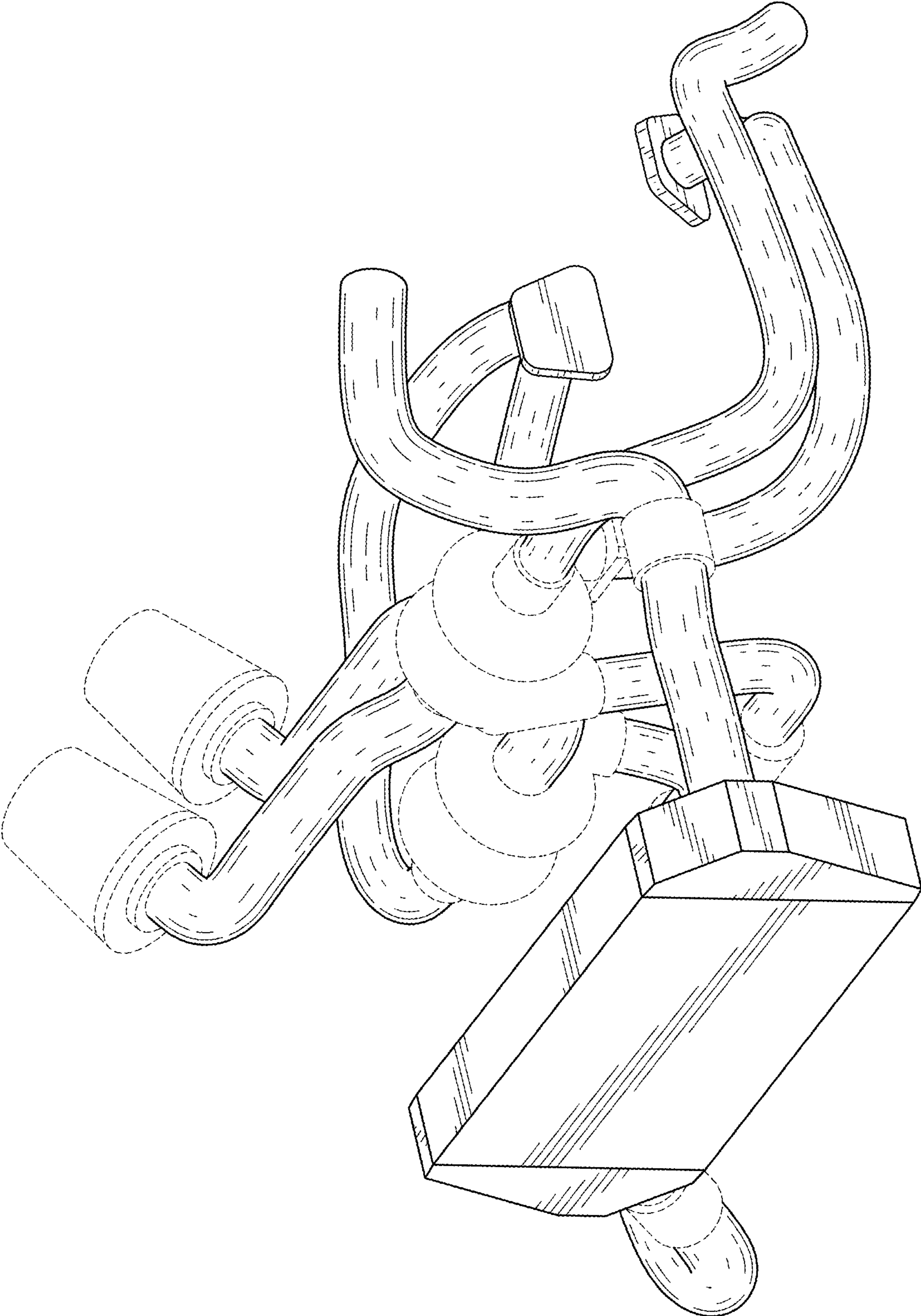
